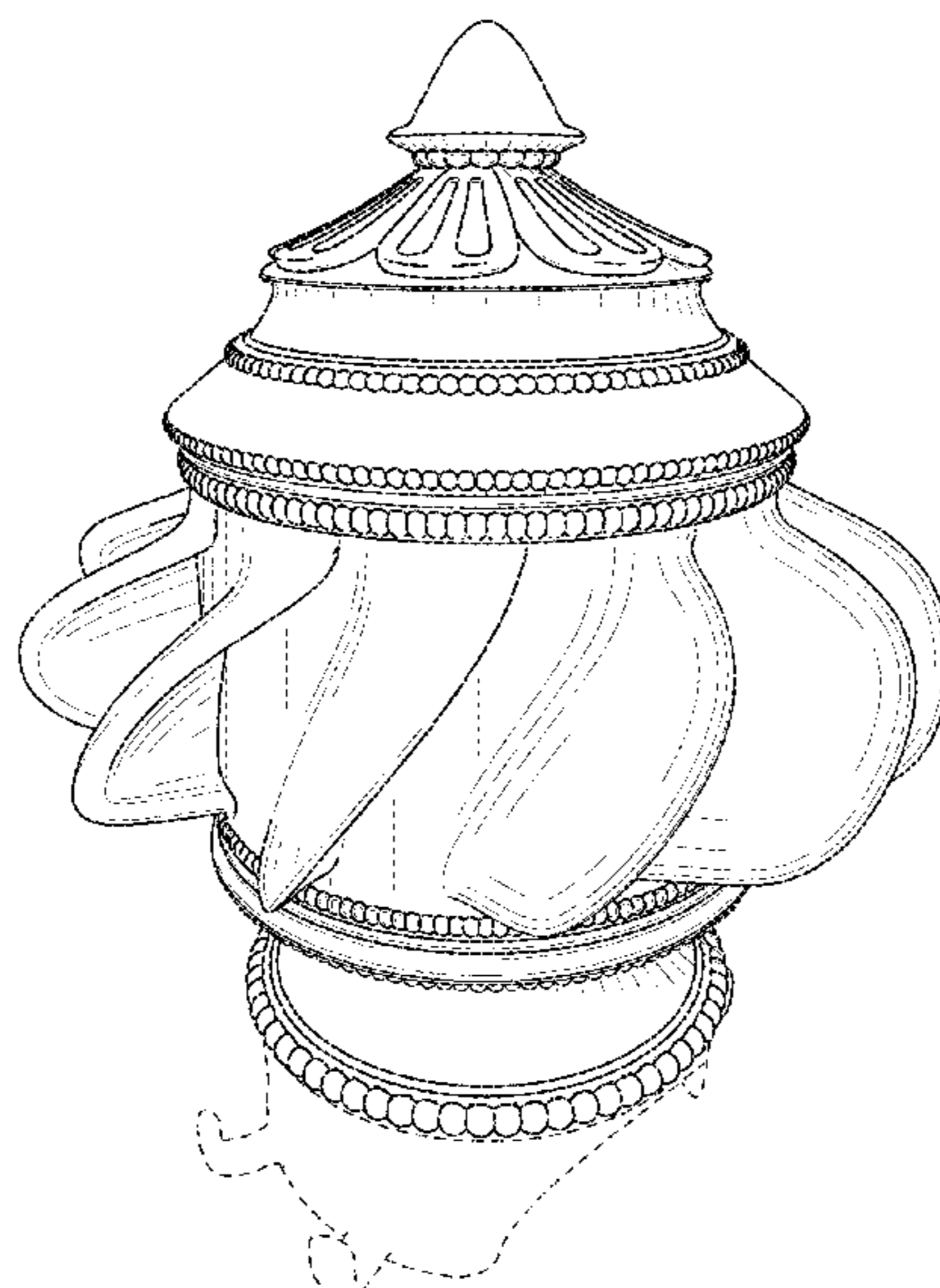
(57) **CLAIM**

The ornamental design for a prayer wheel, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the prayer wheel showing my new design;  
FIG. 2 is an alternative perspective view thereof;  
FIG. 3 is a front view, with the rear view being identical, thereof;  
FIG. 4 is a right side view, with the left side view being a mirror image, thereof;  
FIG. 5 is a top plan view thereof; and,  
FIG. 6 is a bottom plan view thereof.  
The broken lines depict portions of the prayer wheel that form no part of the claimed design.

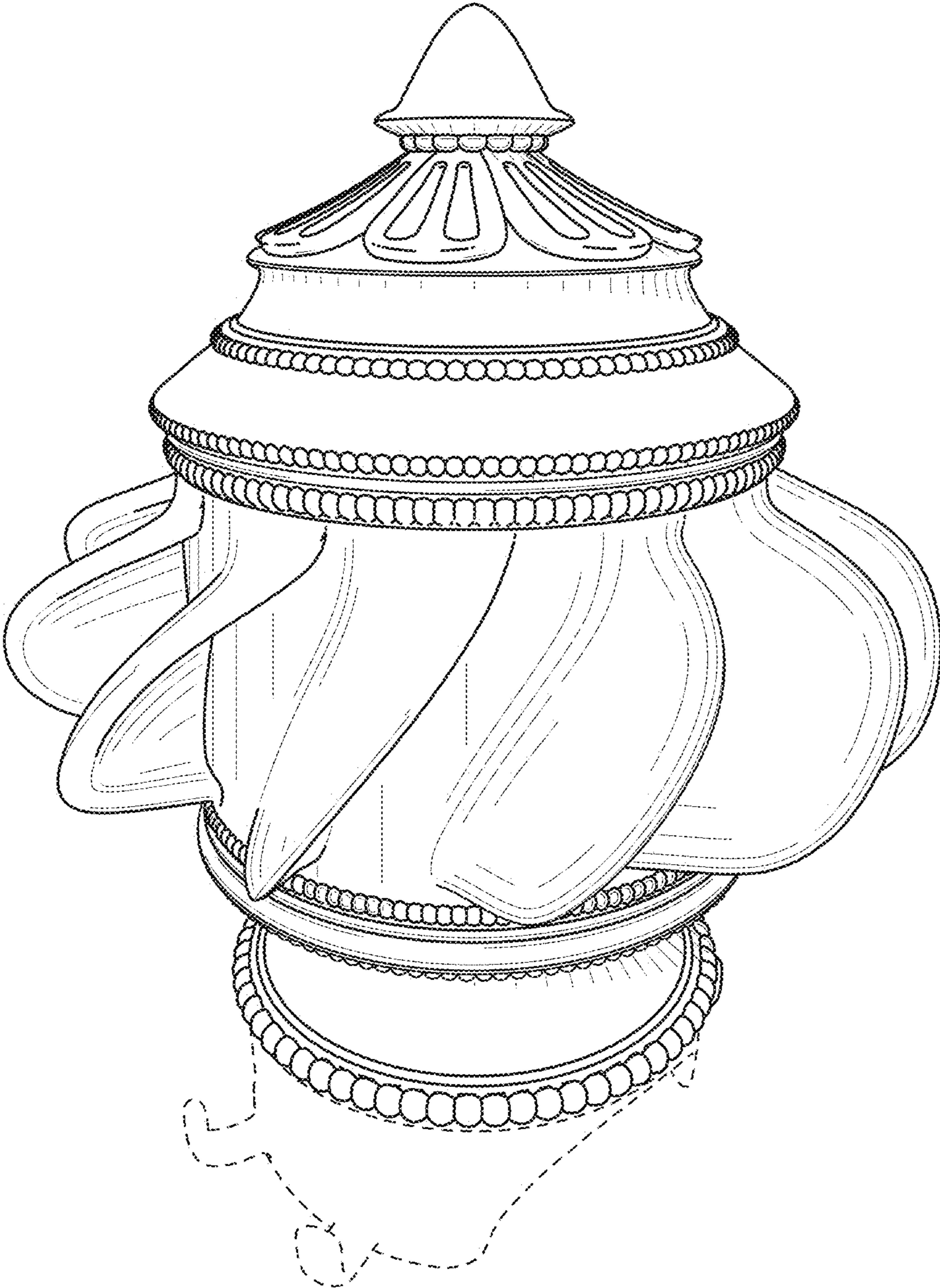

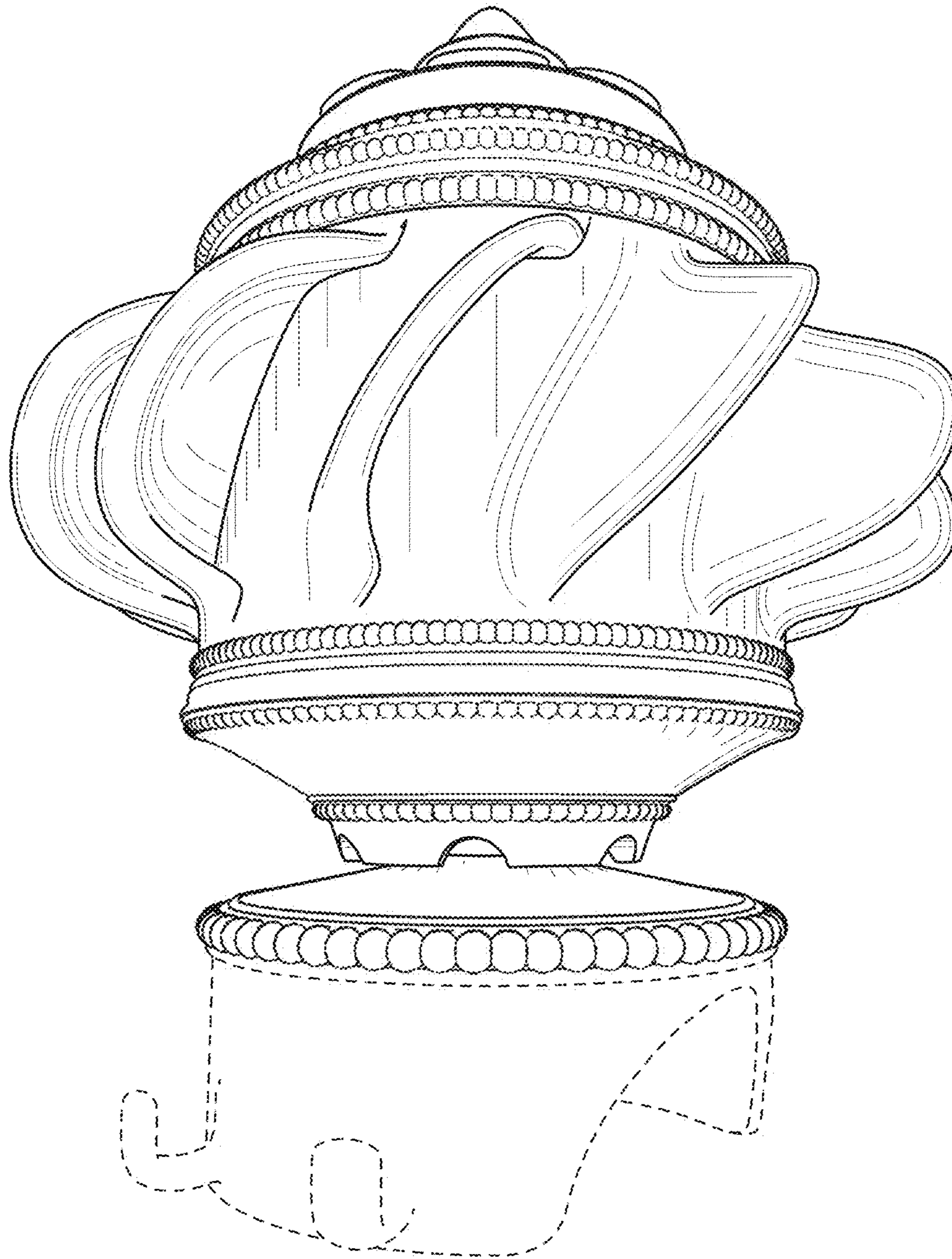

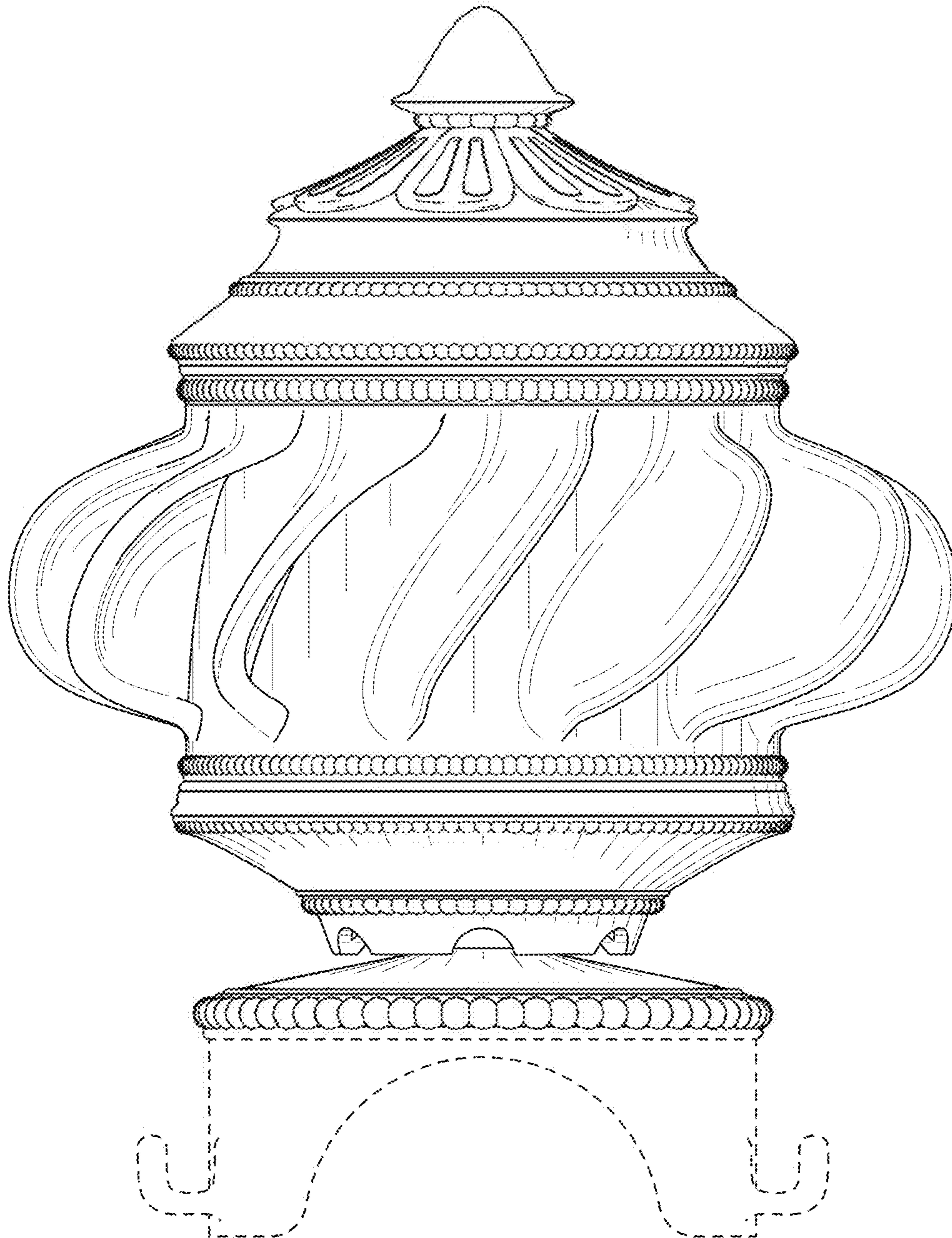

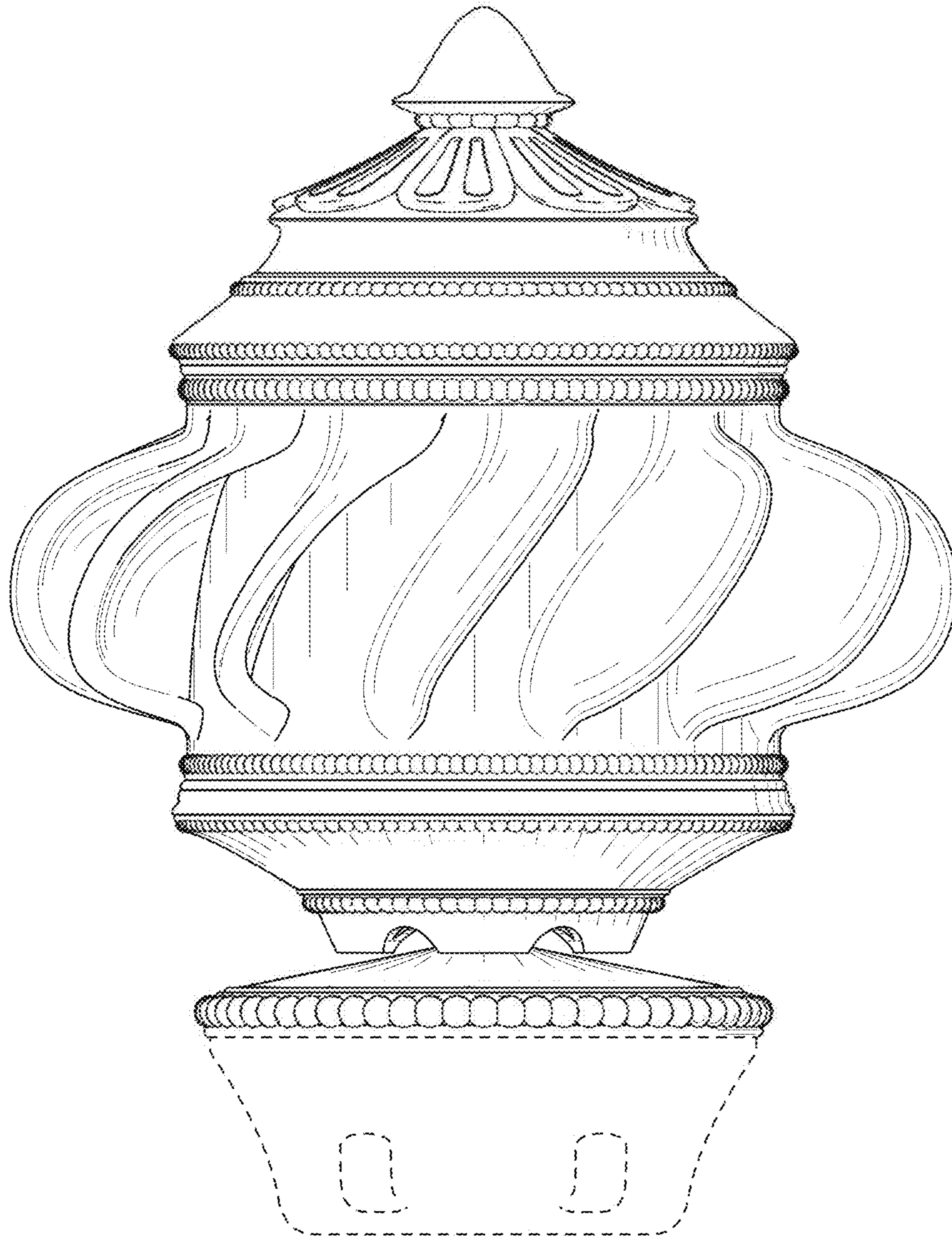

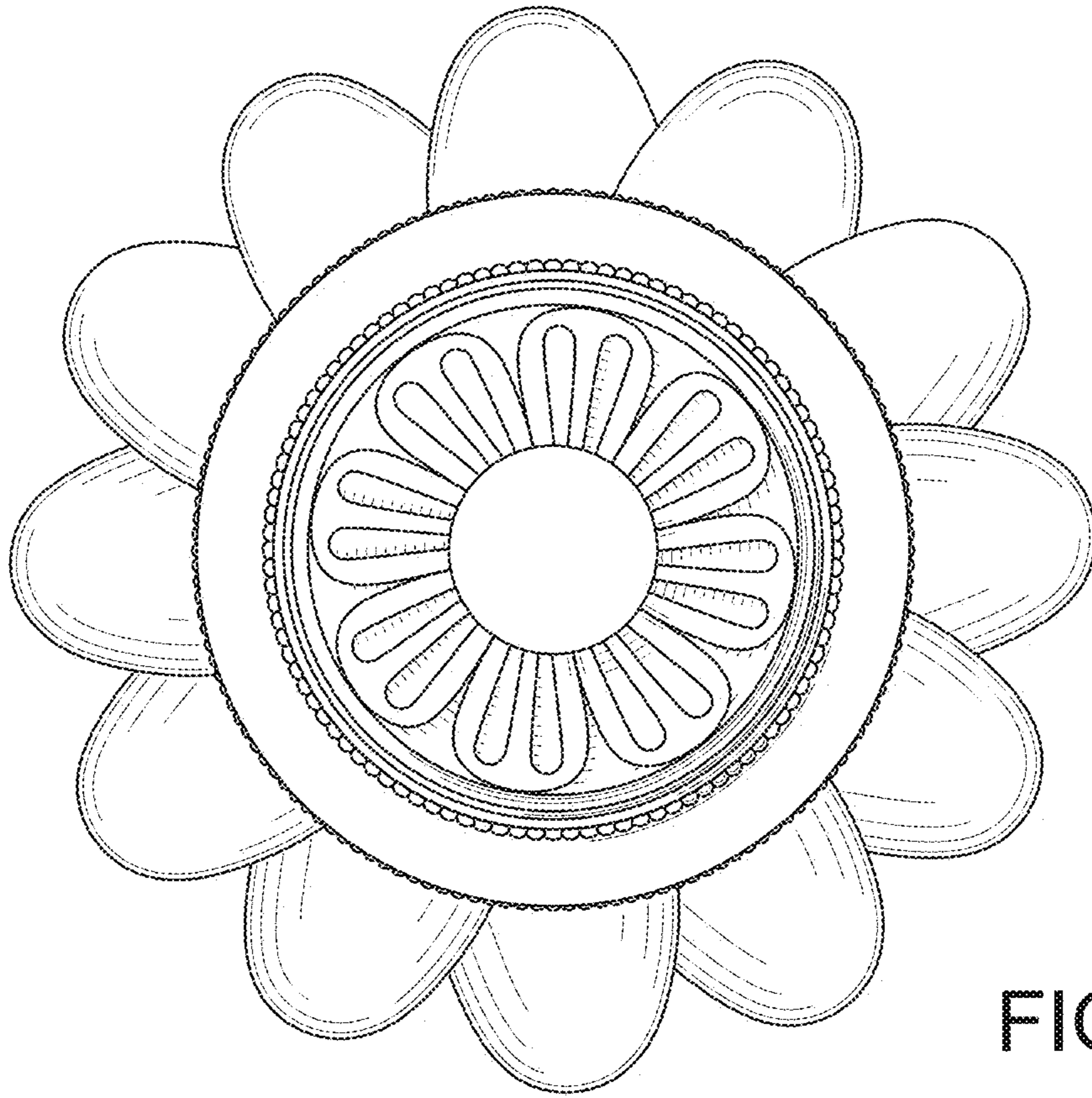

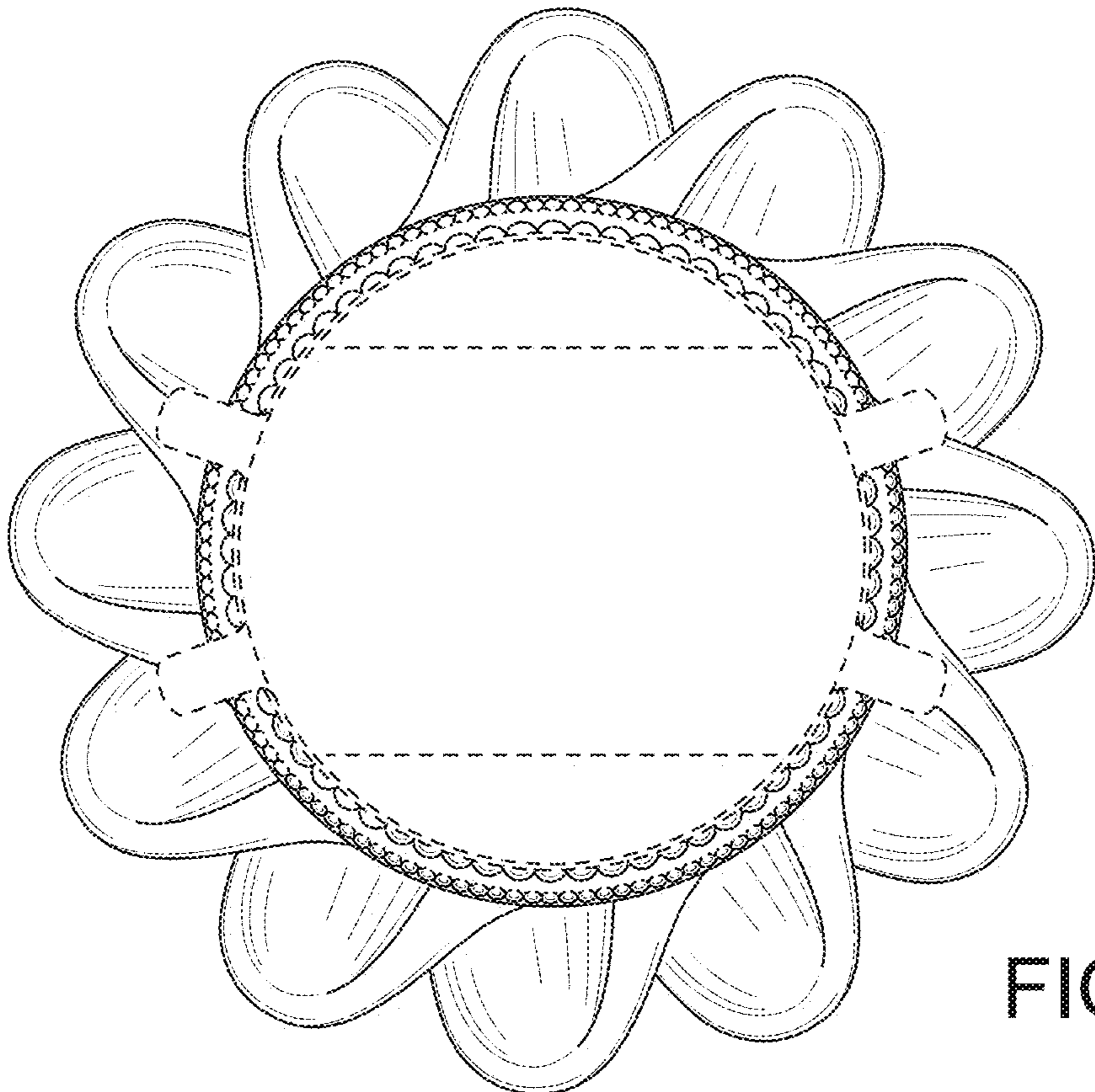
