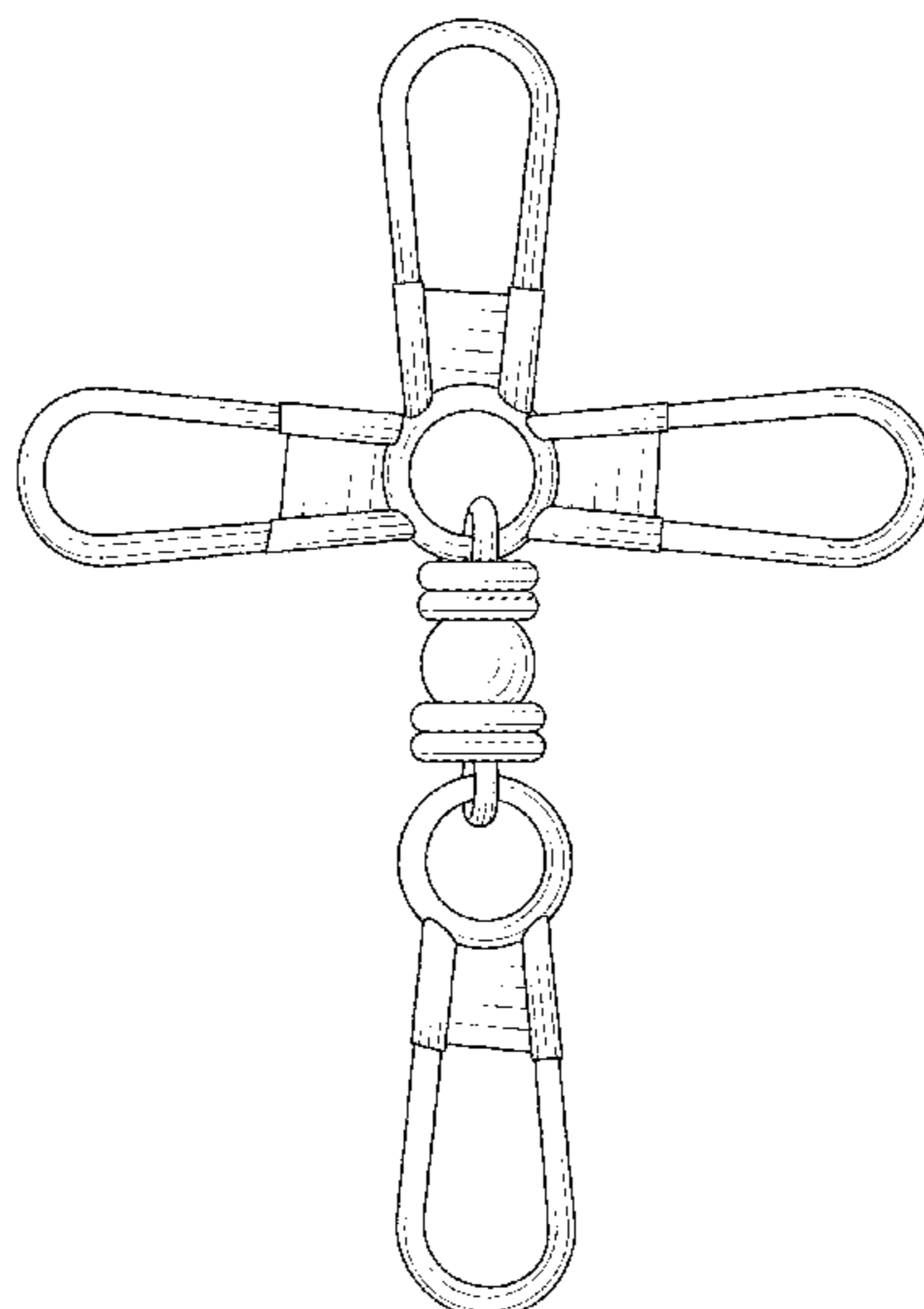
(57) **CLAIM**

I claim the ornamental design of a cross with rounded fish swivel ends, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a cross with rounded fish swivel ends;  
FIG. 2 is a top view of the cross with rounded fish swivel ends;  
FIG. 3 is a side view of the cross with rounded fish swivel ends; and,

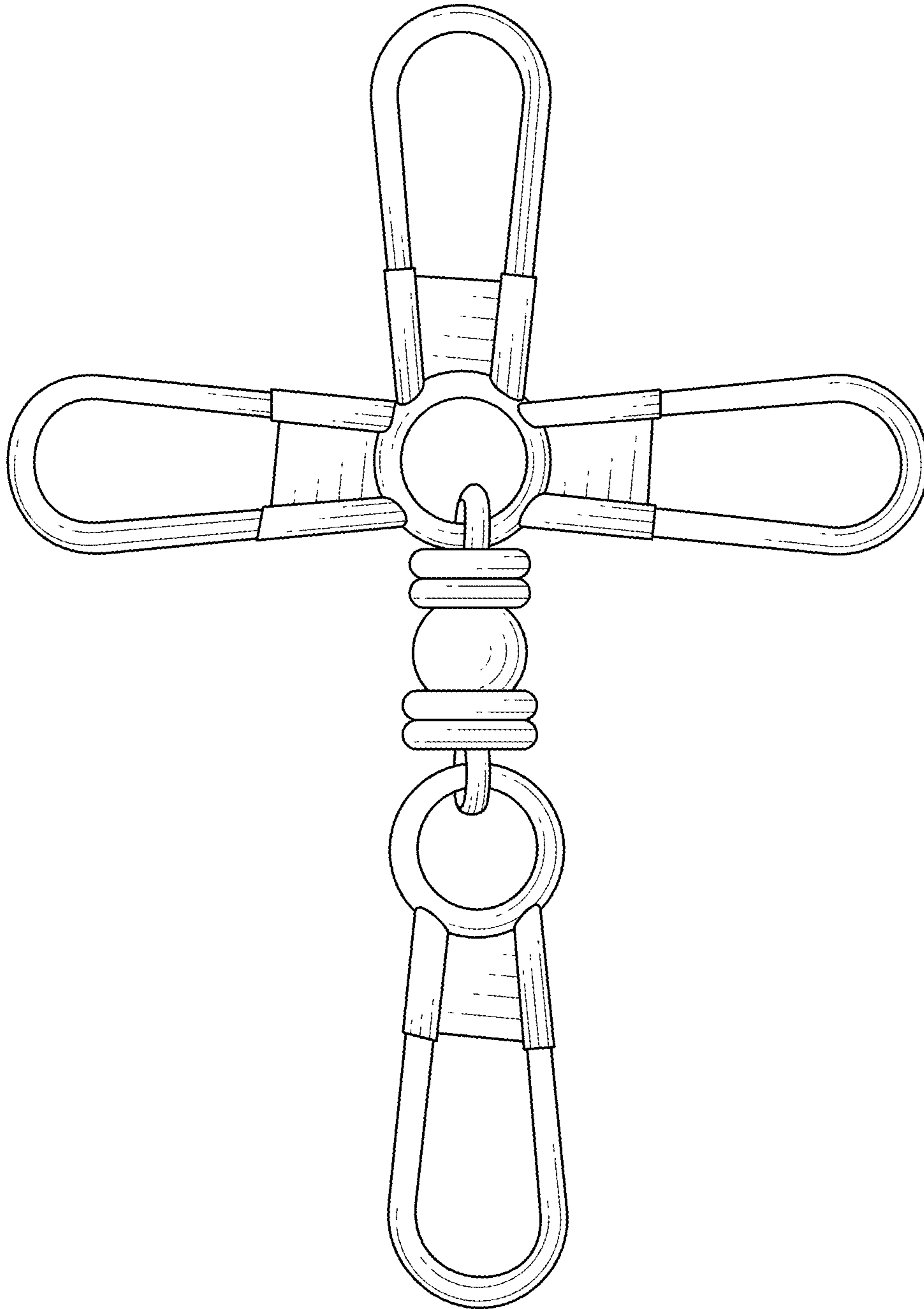

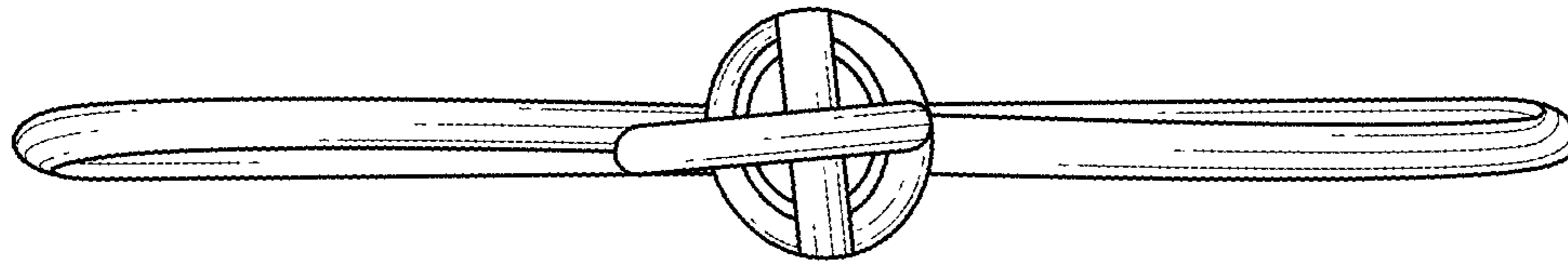

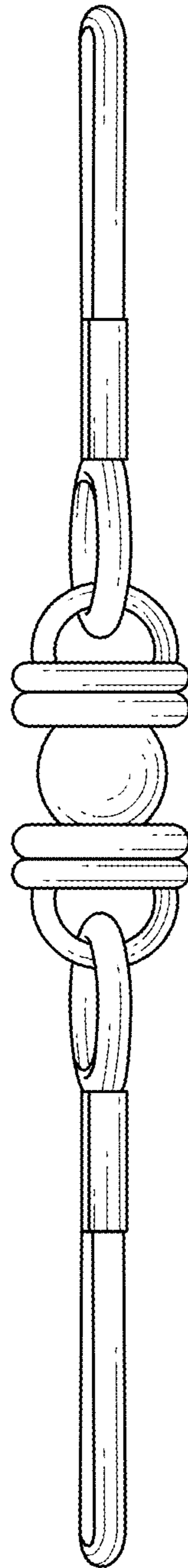

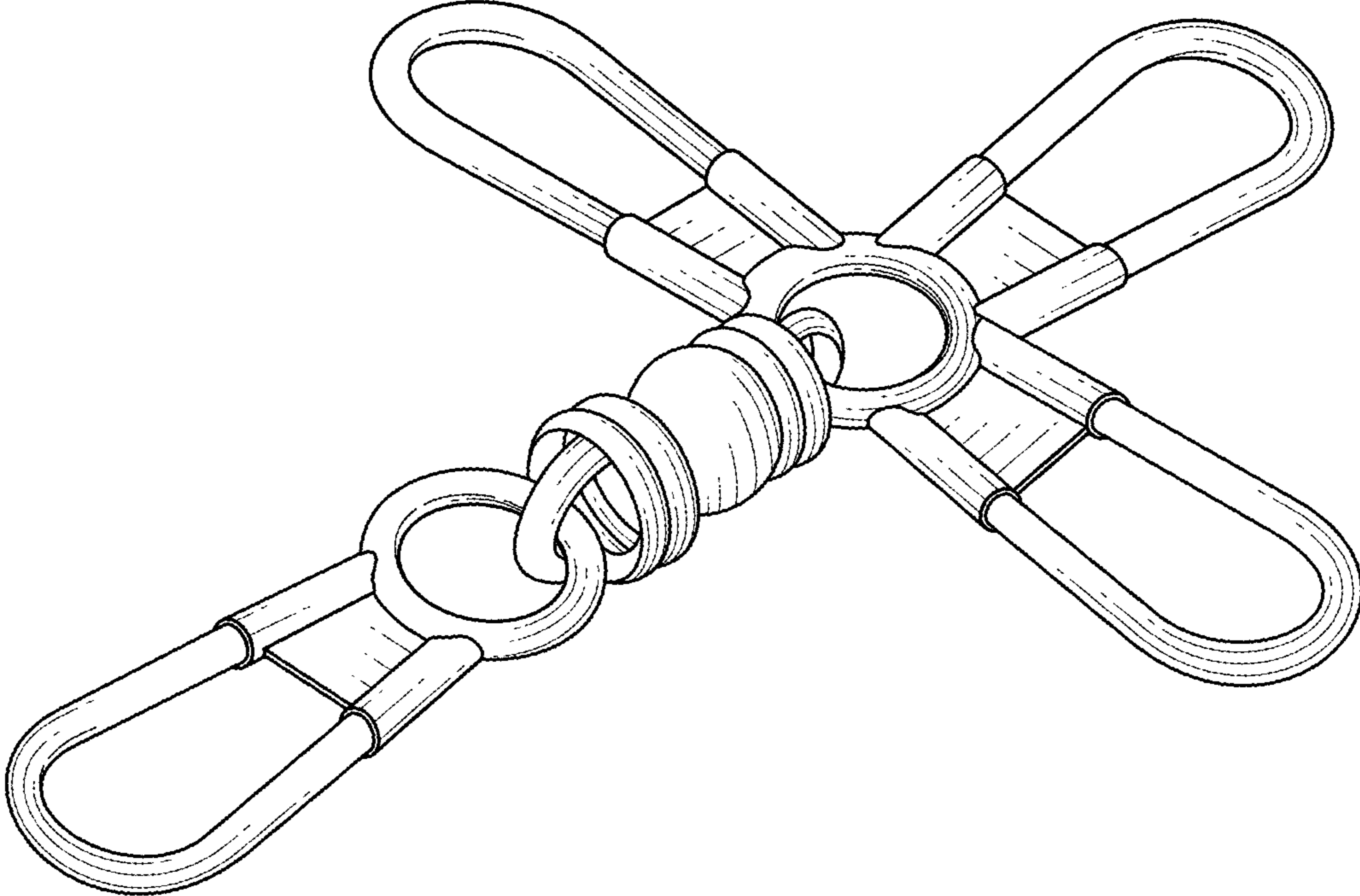
