The ornamental design for a decorative bra strap, as shown and described.

**DESCRIPTION**

FIG. 1 is a front isometric view of a decorative bra strap, showing my new design;

FIG. 2 is a top plan view thereof;

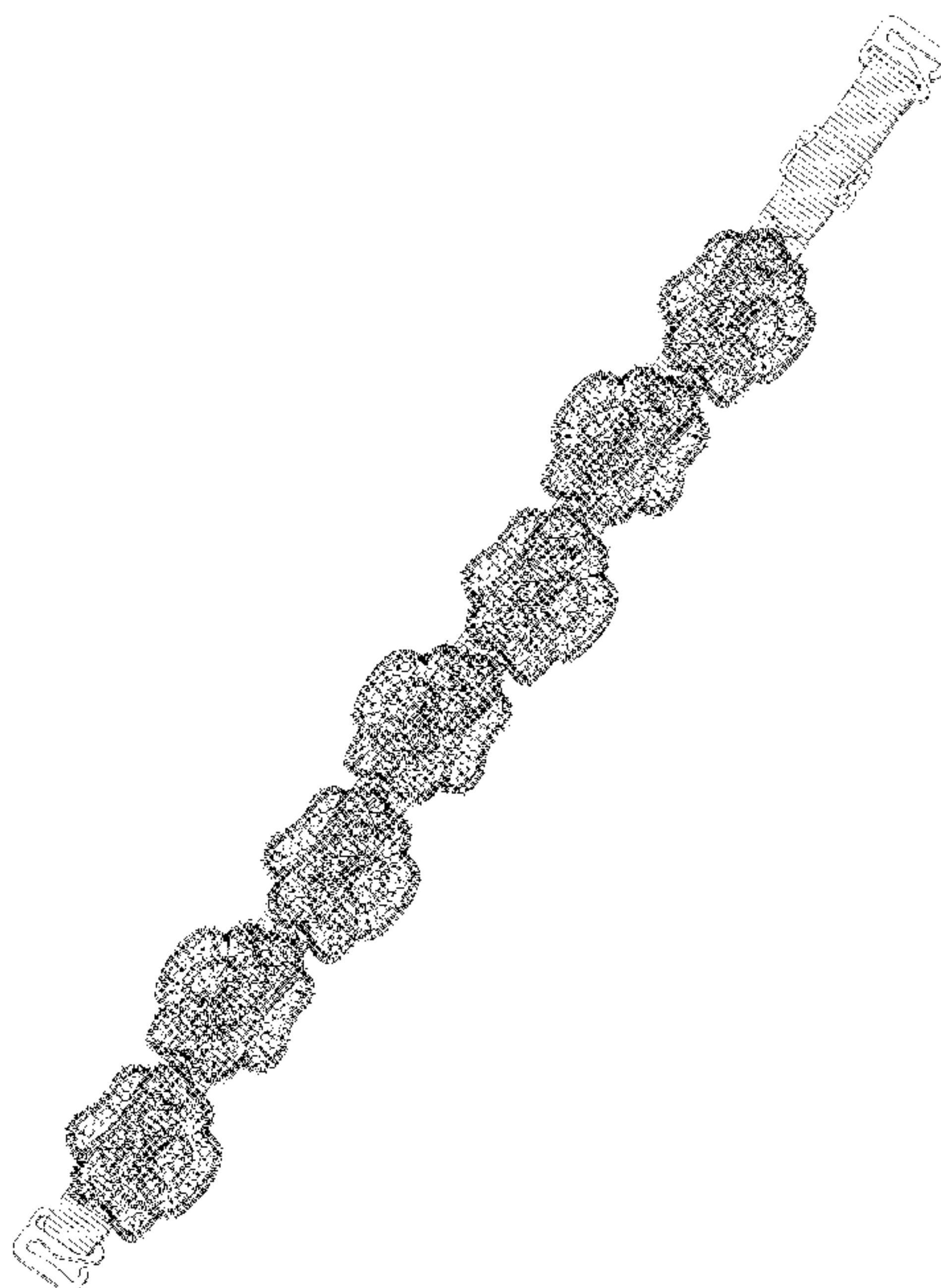
FIG. 3 is a bottom plan view thereof;

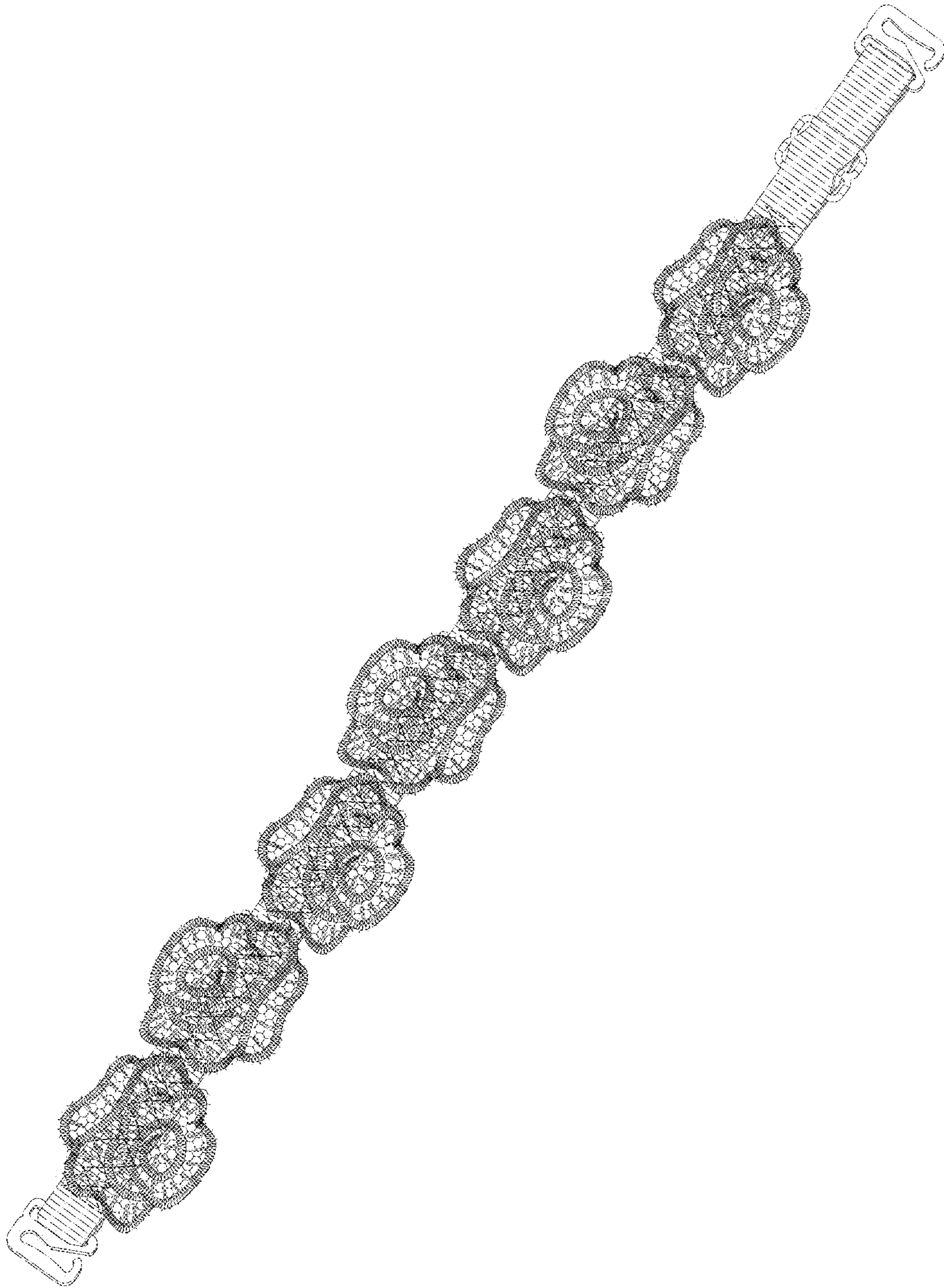

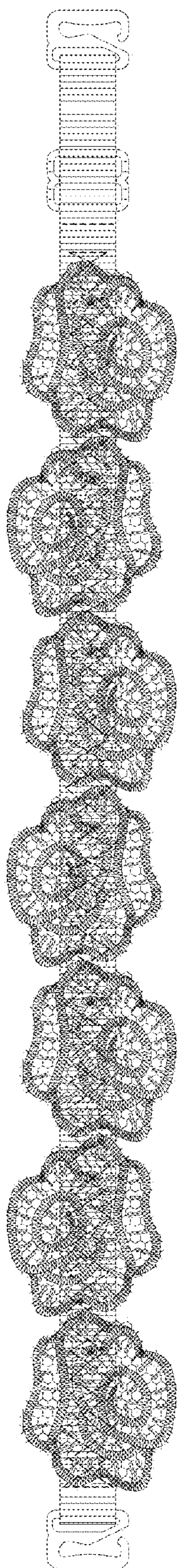

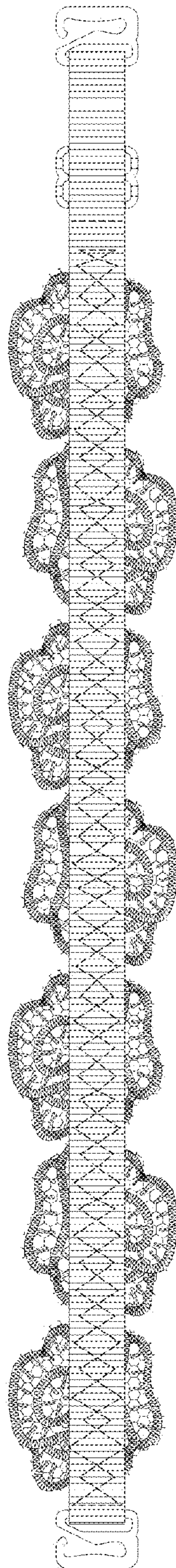

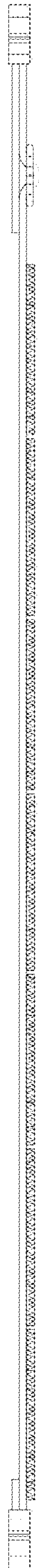

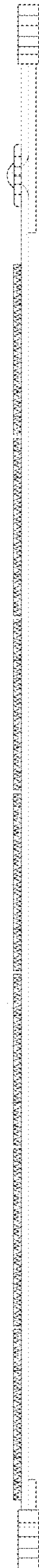
