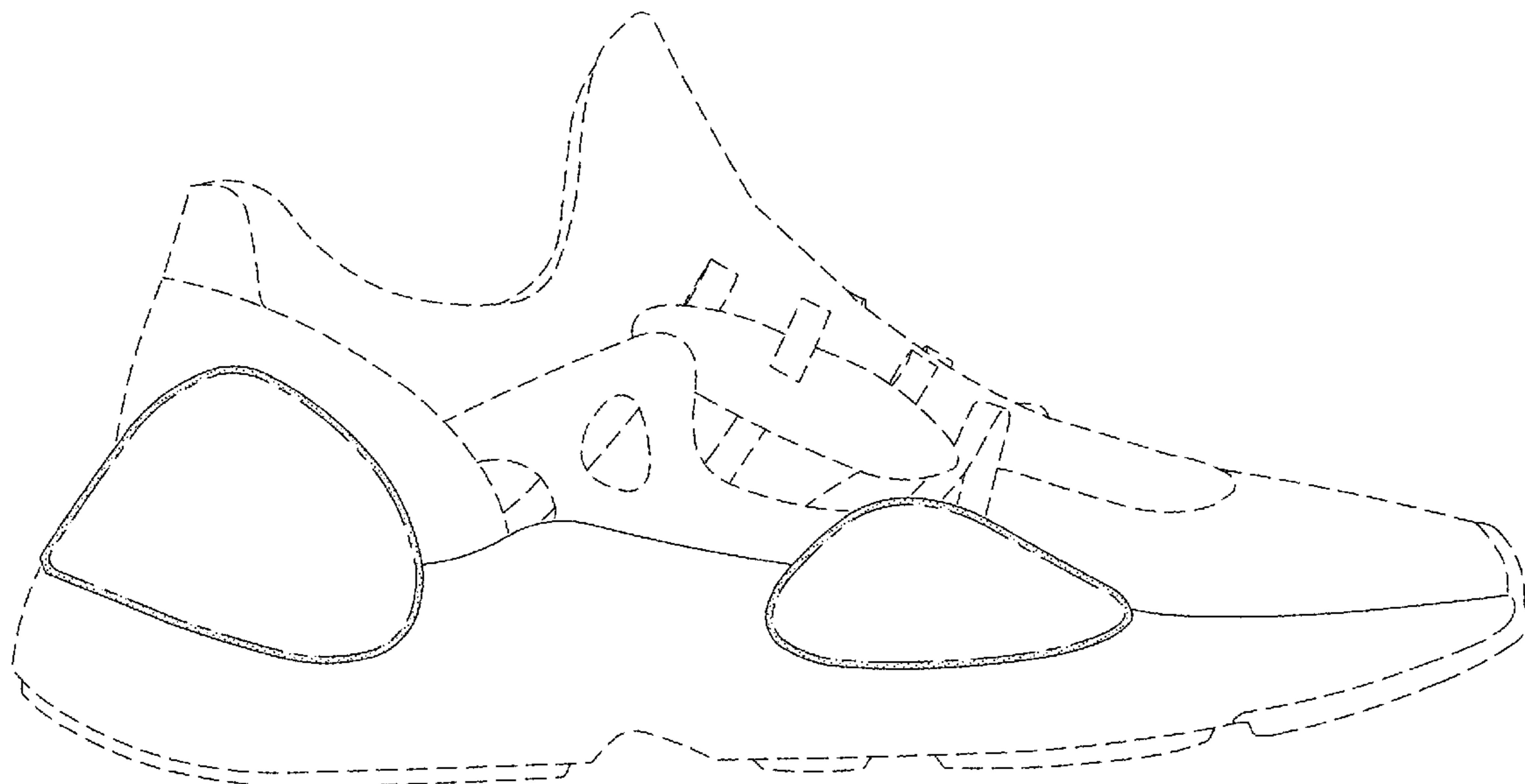
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a side view of a shoe showing my design;

The even-length broken lines are directed to environment  
that forms no part of the claimed design. The long and short  
broken lines represent the claim boundary and form no part

surfaces. All other surfaces not shaded form no part of the  
claimed design.

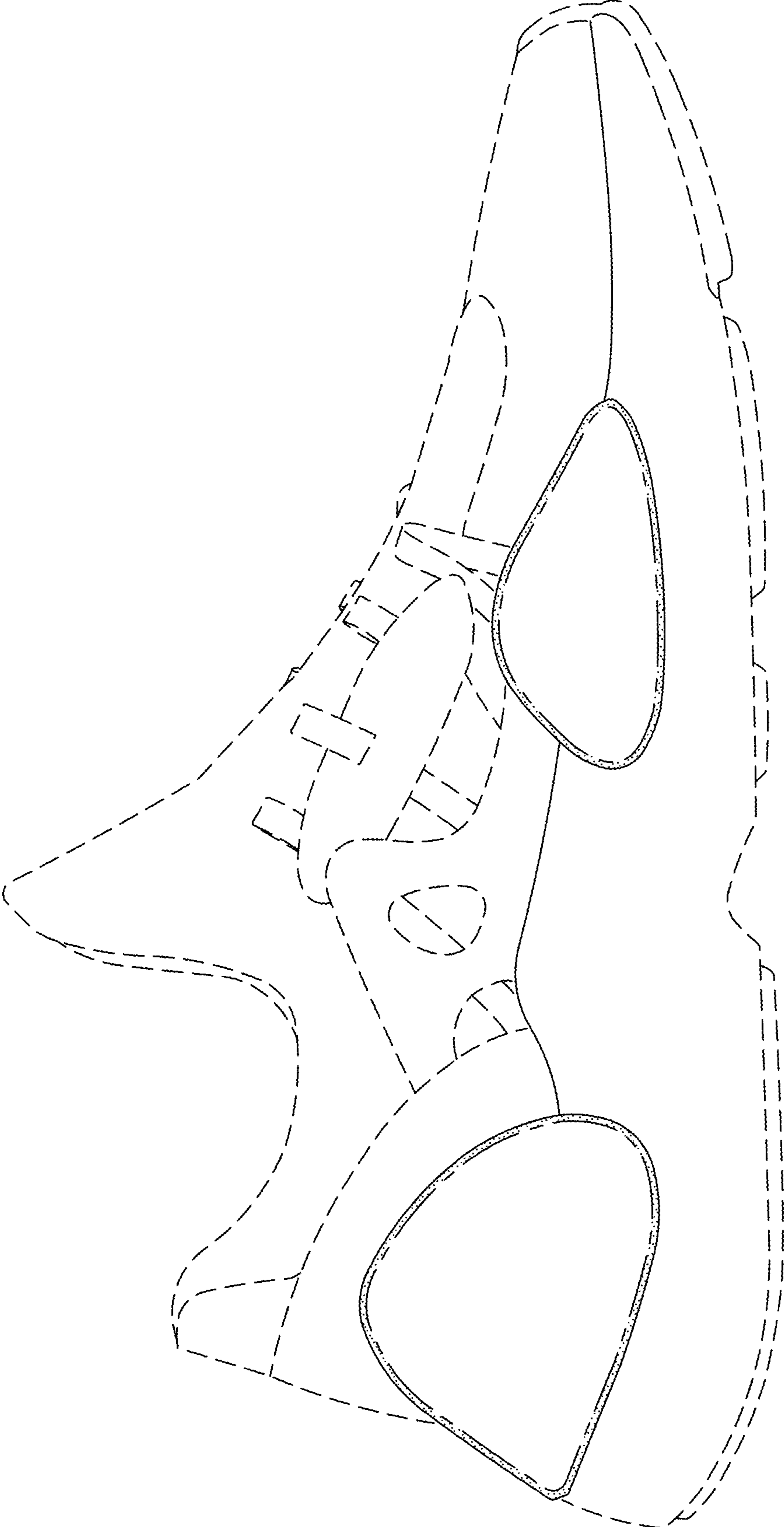

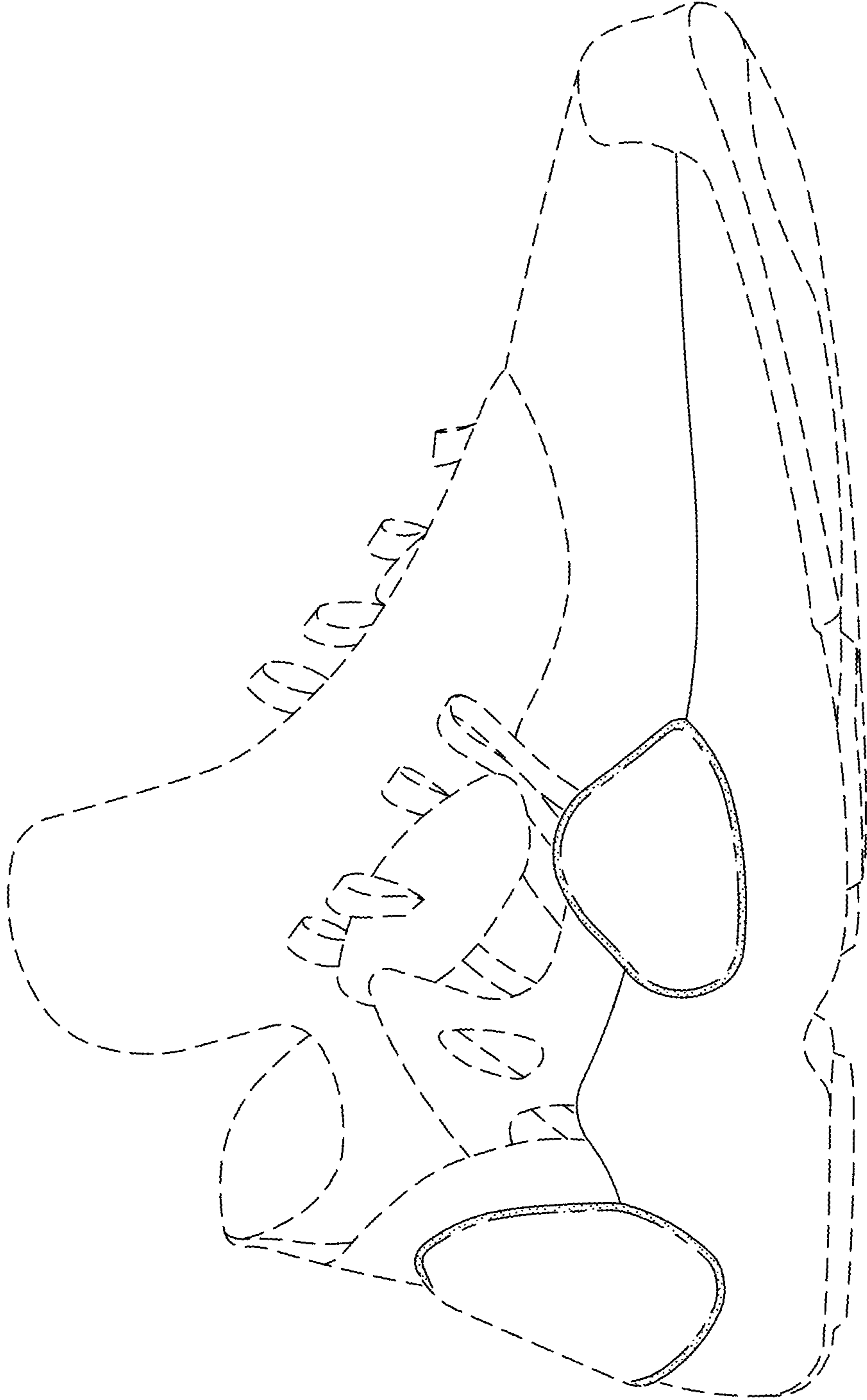

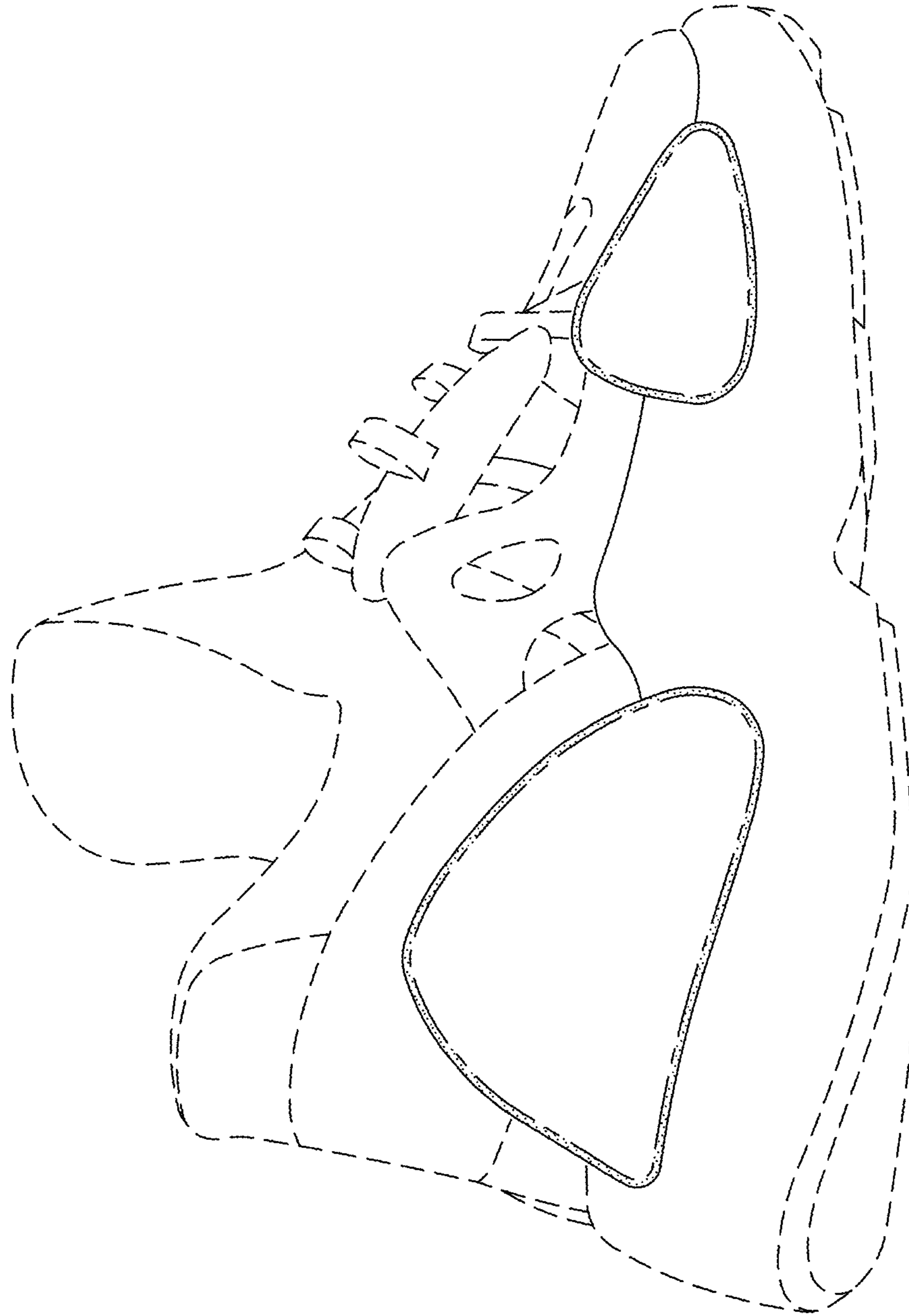
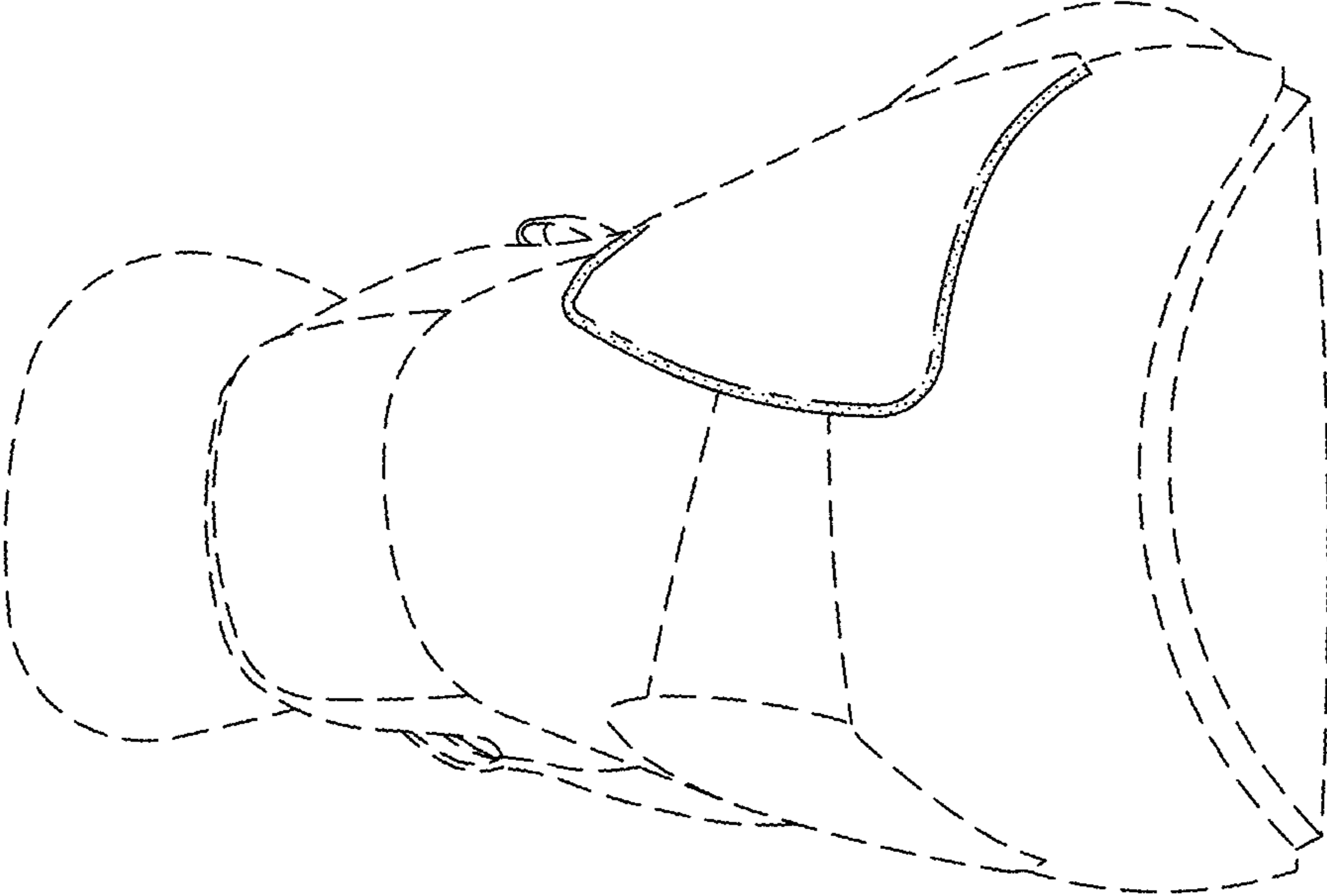
