The ornamental design for a shoe, as shown and described.

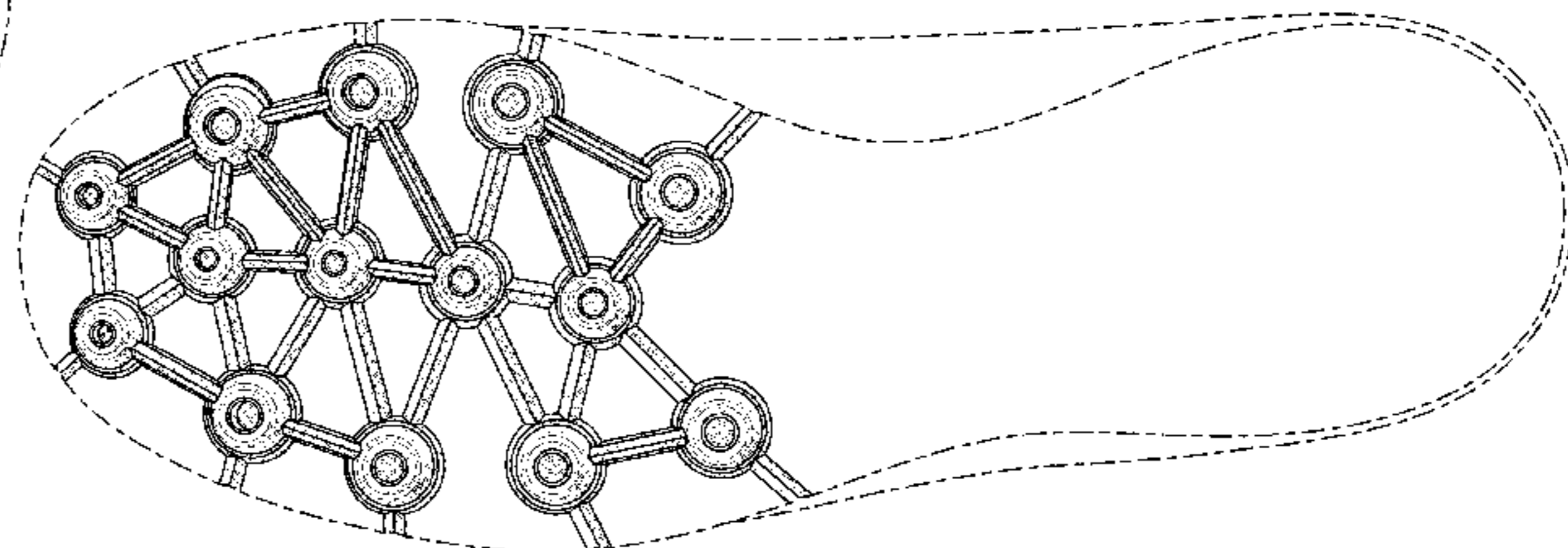
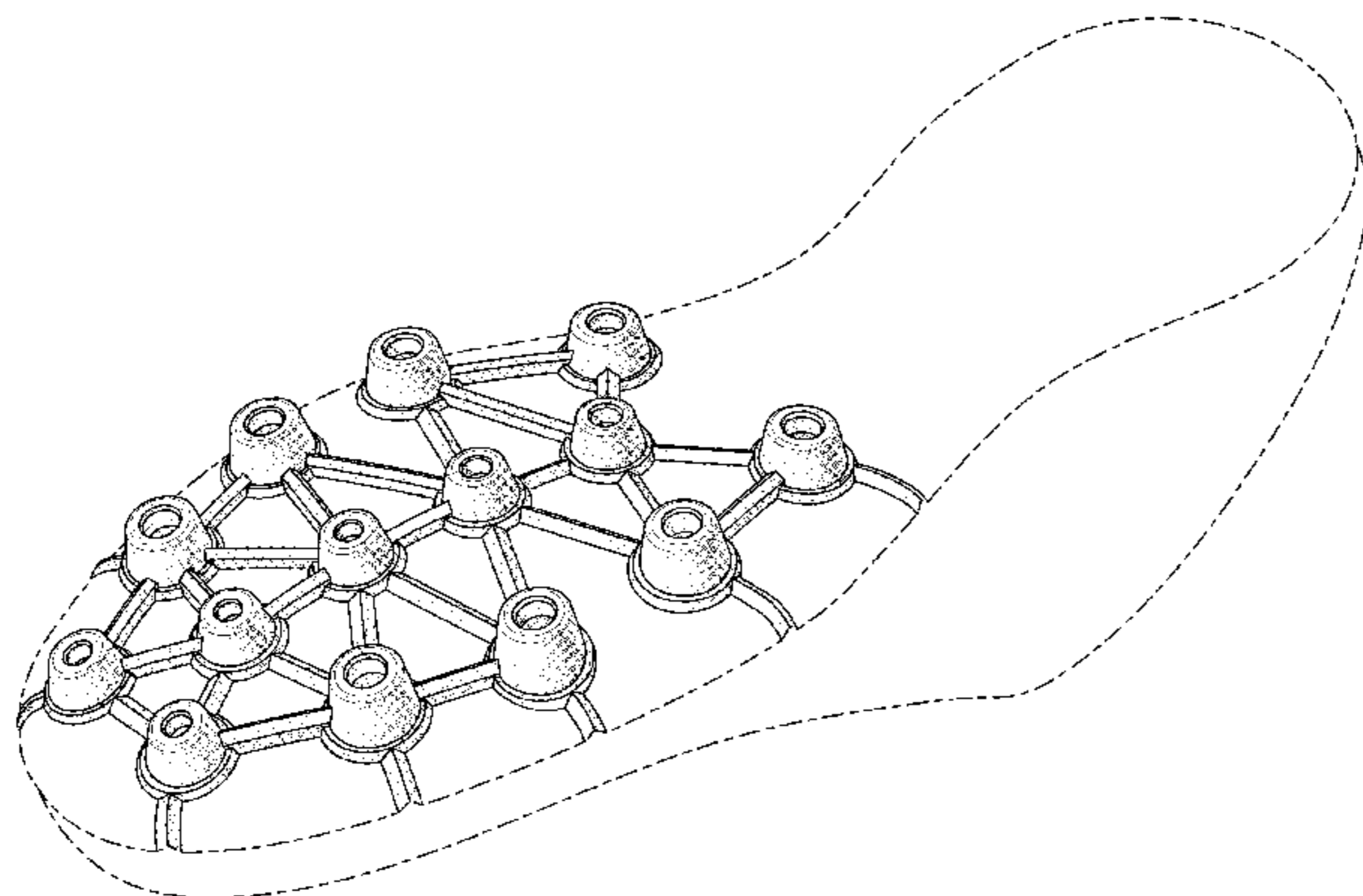
DESCRIPTION

FIG. 1 is a front bottom perspective view of a shoe showing my new design;
FIG. 2 is a bottom view thereof; and,
FIG. 3 is a rear bottom perspective view thereof.
The broken lines depicting the peripheral ends of the bar elements define the bounds of the claimed design and form no part thereof. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

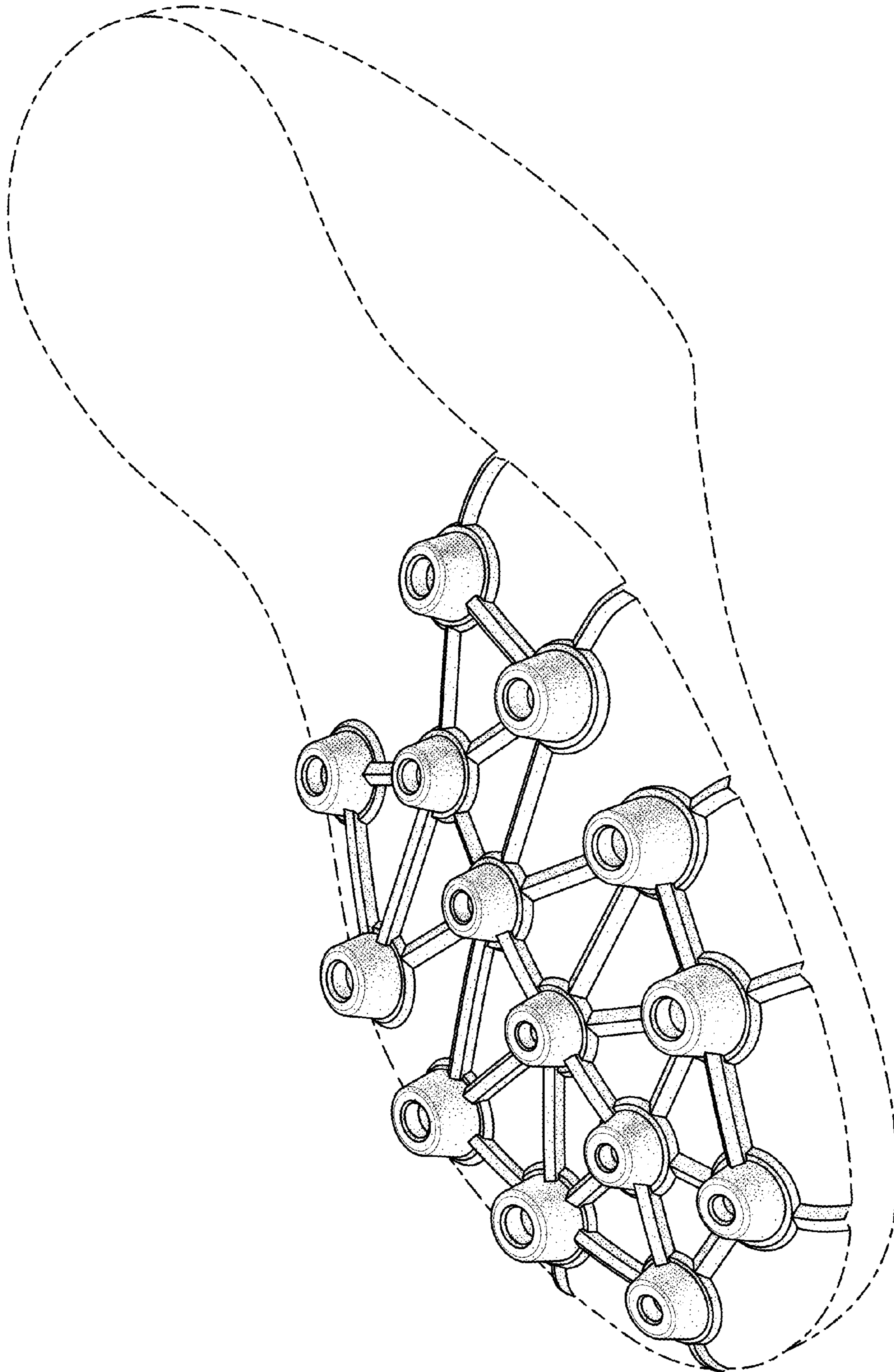

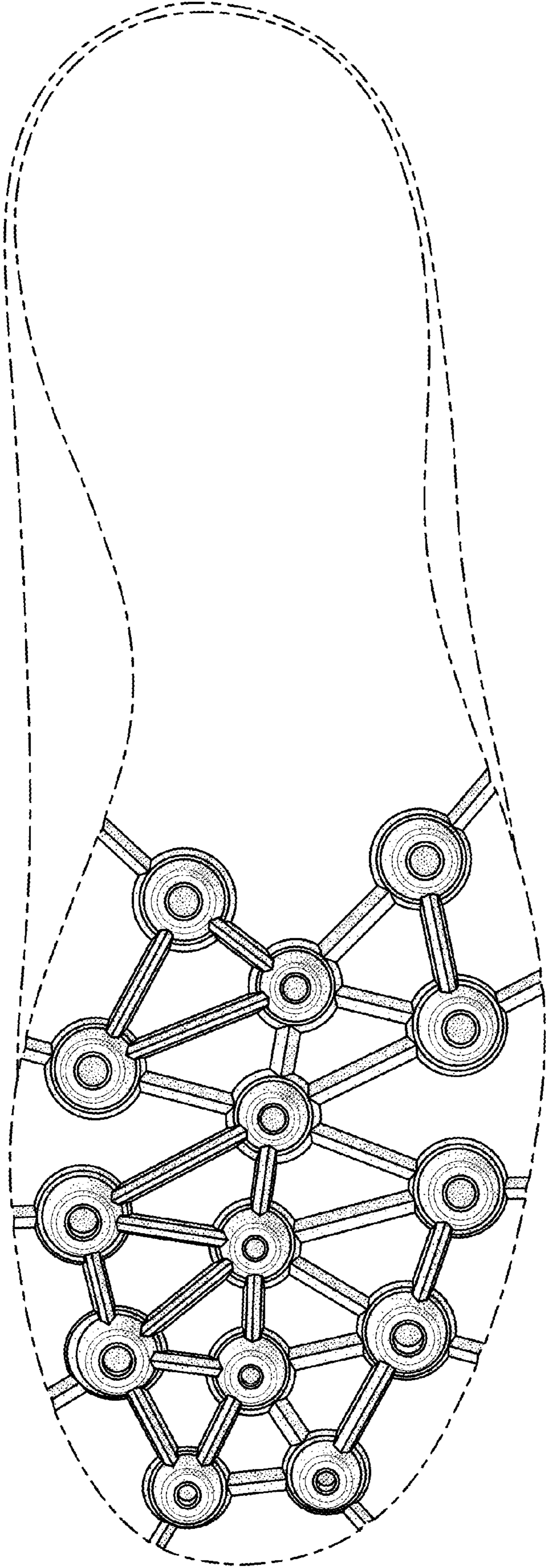

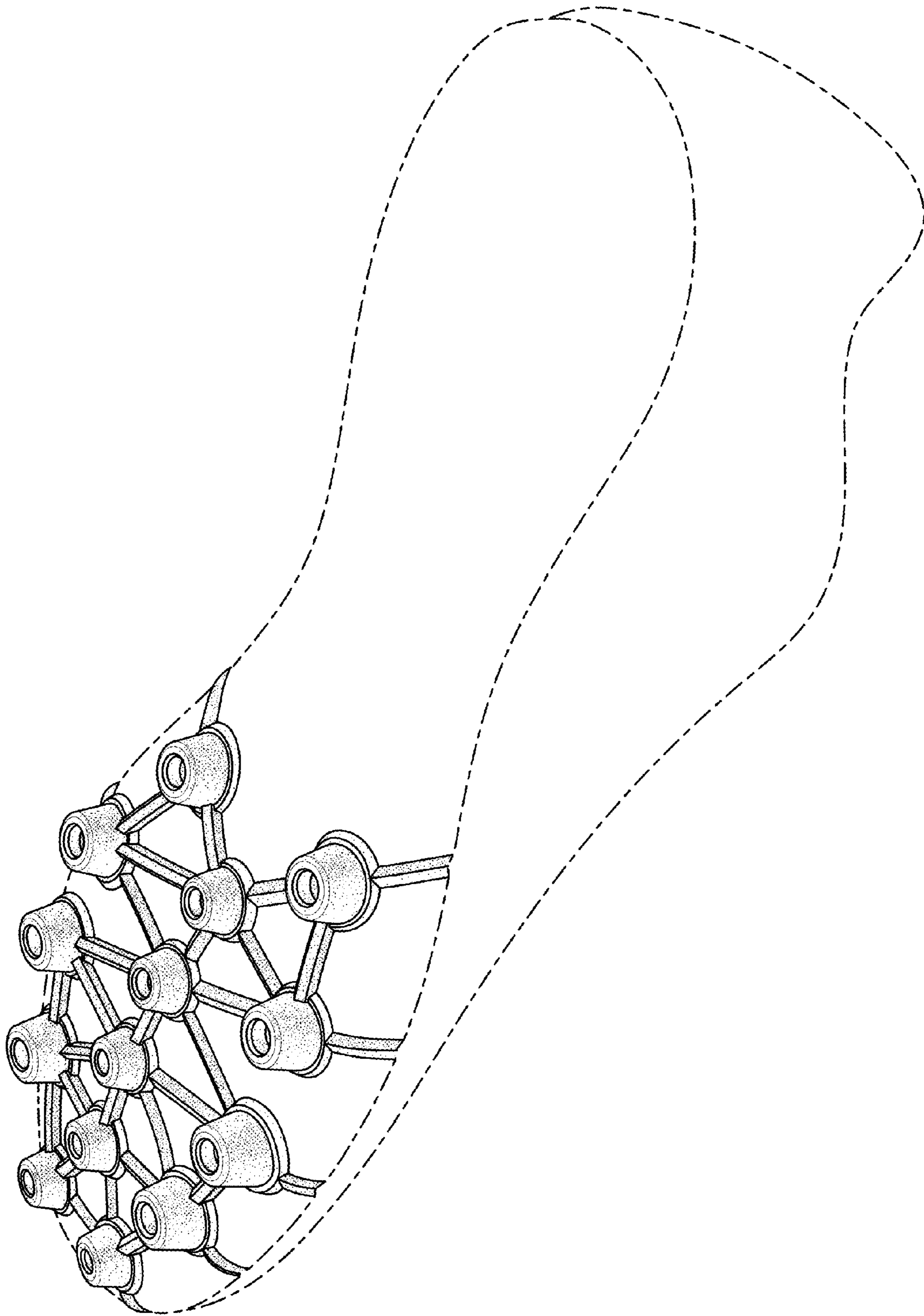
