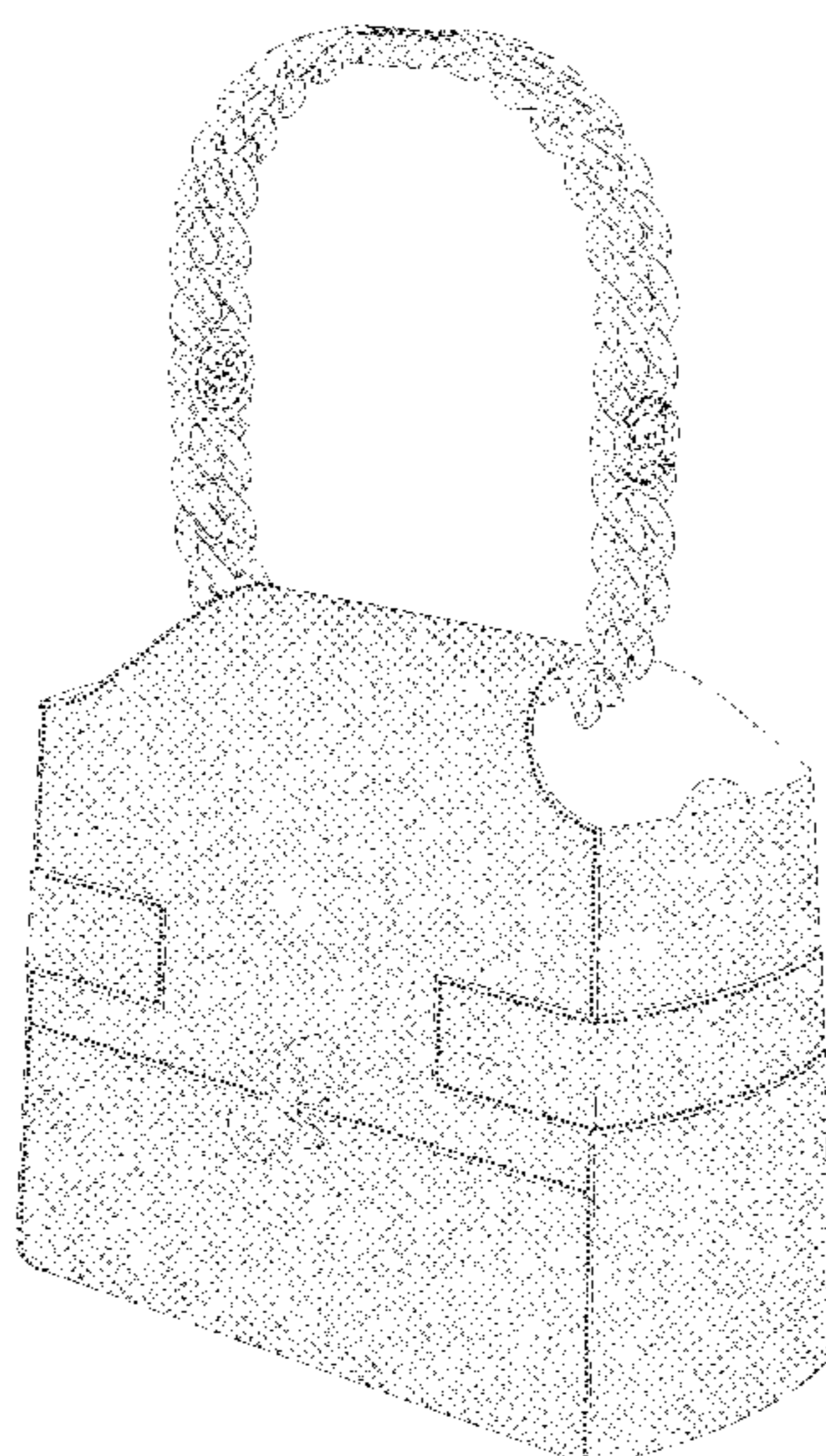
(57) **CLAIM**

The ornamental design for a handbag, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a handbag;  
FIG. 2 is a back perspective view;  
FIG. 3 is a front view;  
FIG. 4 is a back view;  
FIG. 5 is a left side view;  
FIG. 6 is a right side view;  
FIG. 7 is a top view; and,  
FIG. 8 is a bottom view.  
The broken lines in the figures form no part of the claimed design. The lines formed by the evenly spaced small solid black squares indicate stitching.  
It will be appreciated that there are openings through which an observer may see the interior of the handbag; the interior of the handbag is unclaimed.

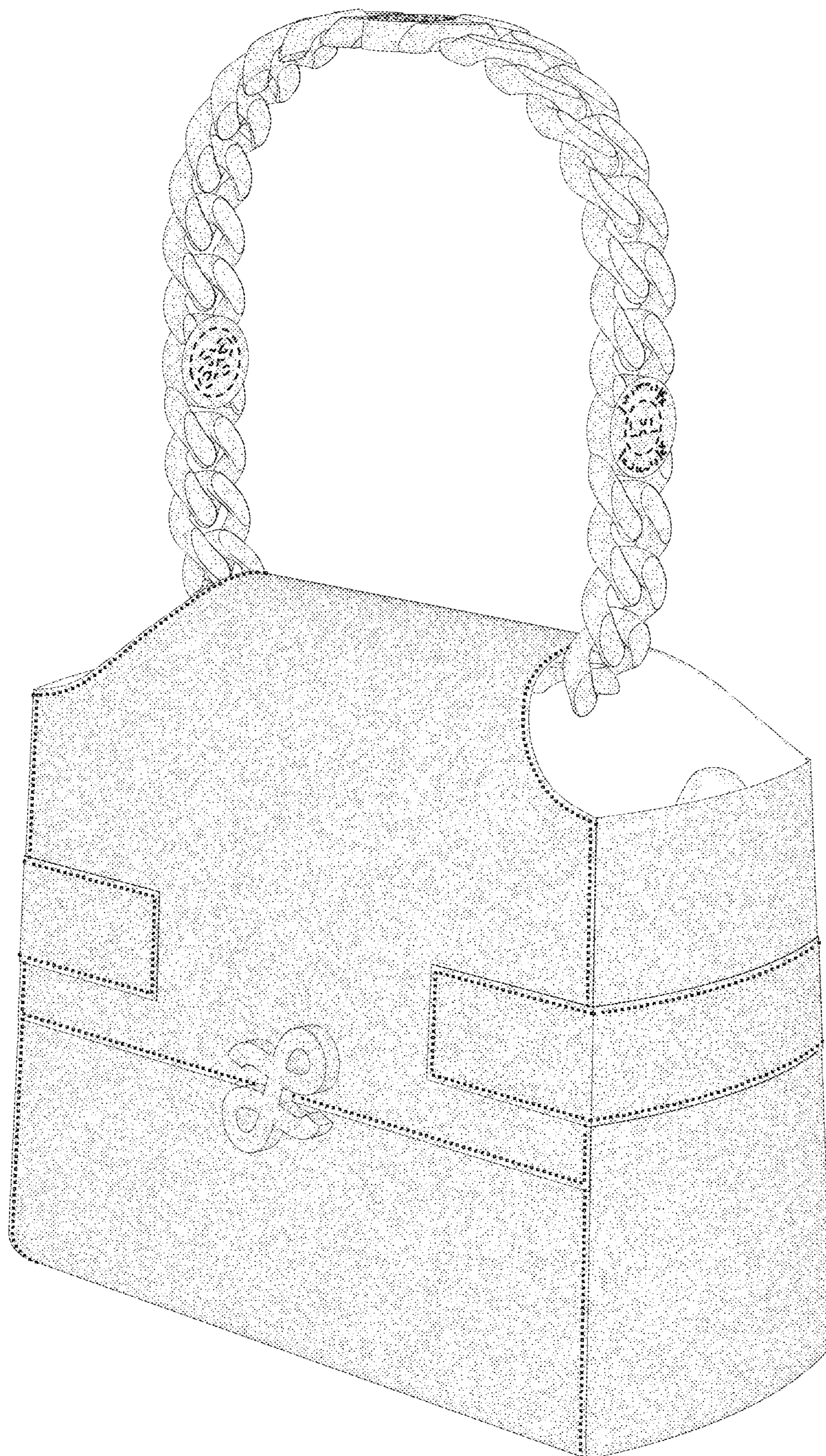

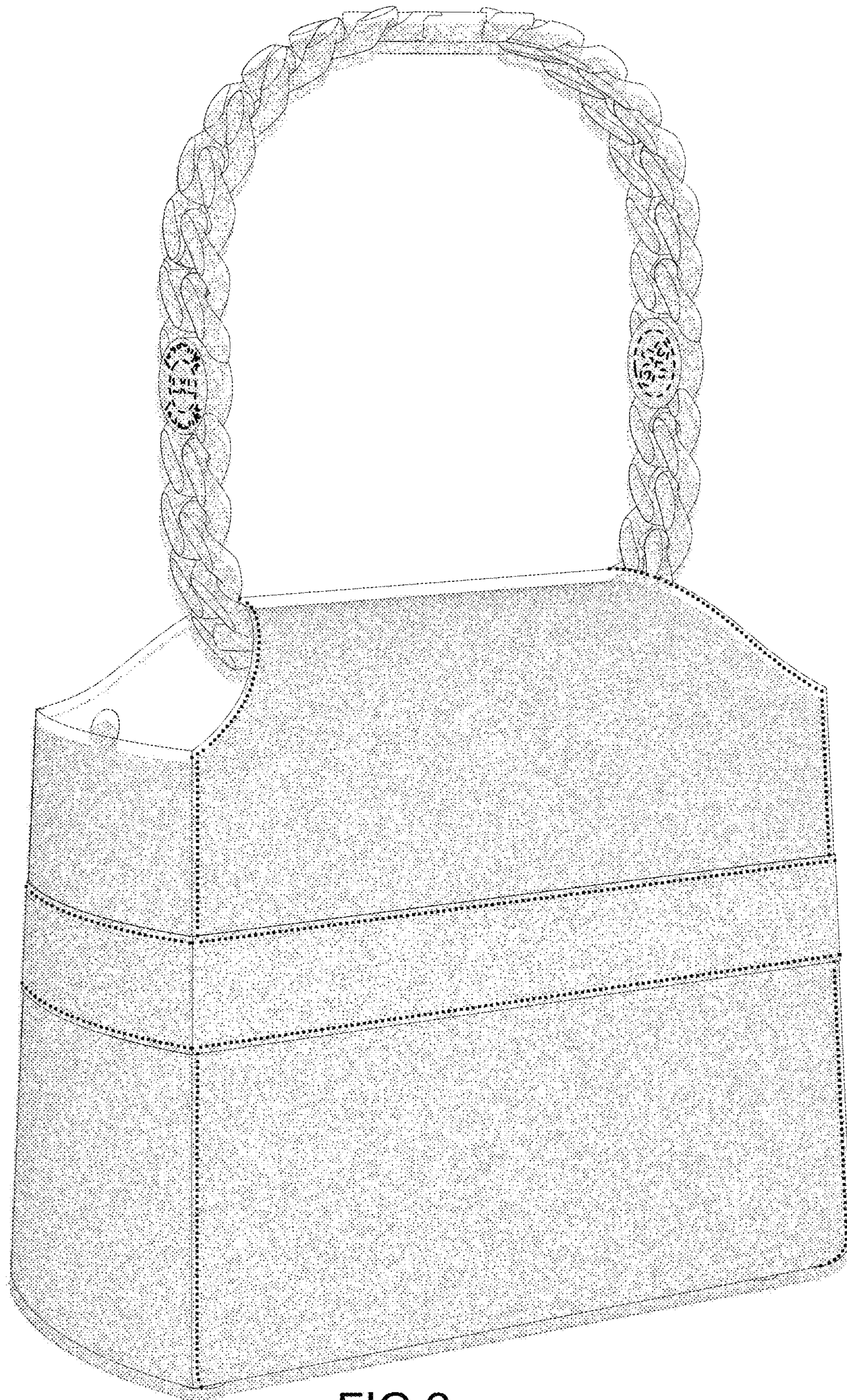

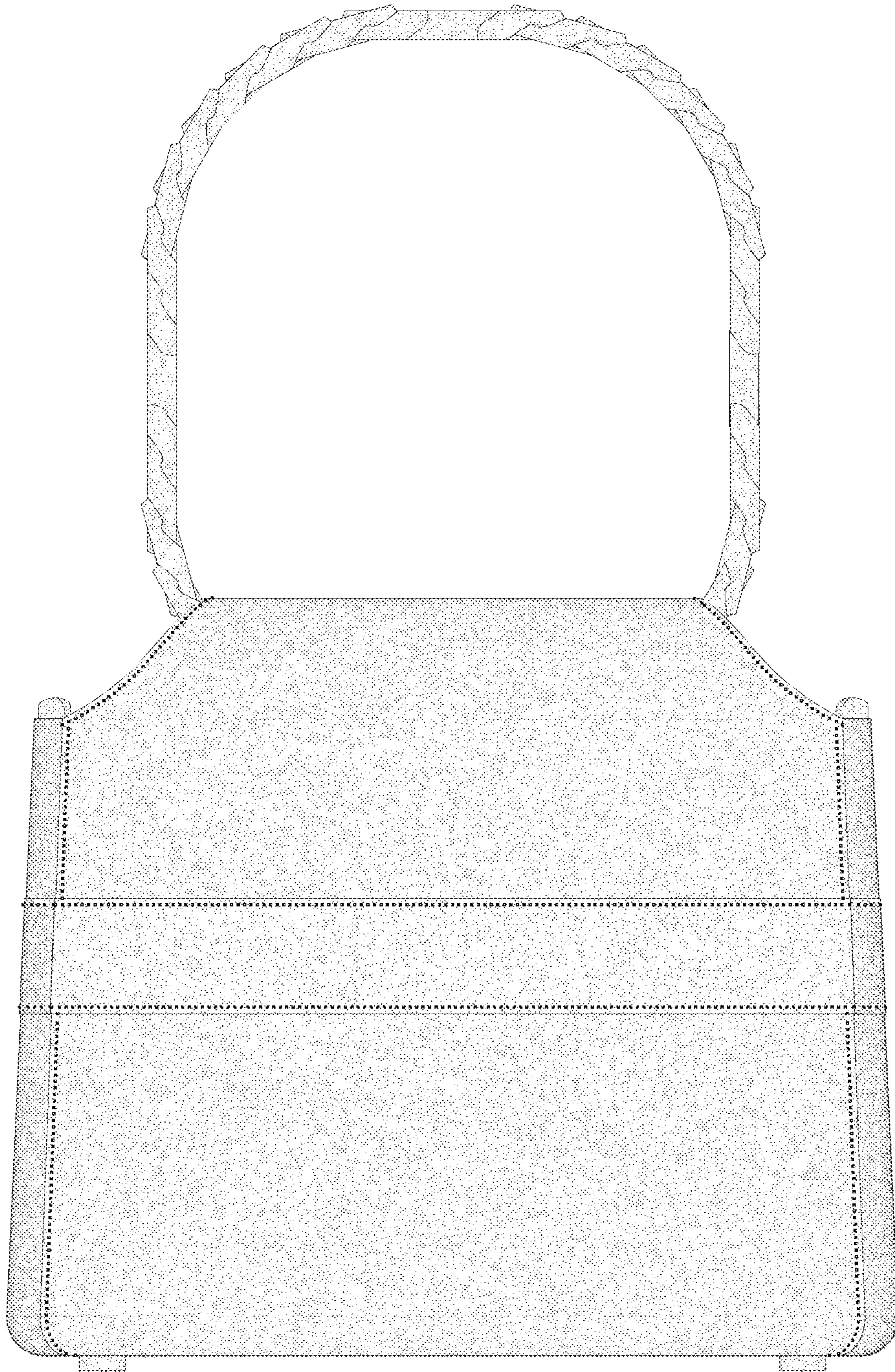

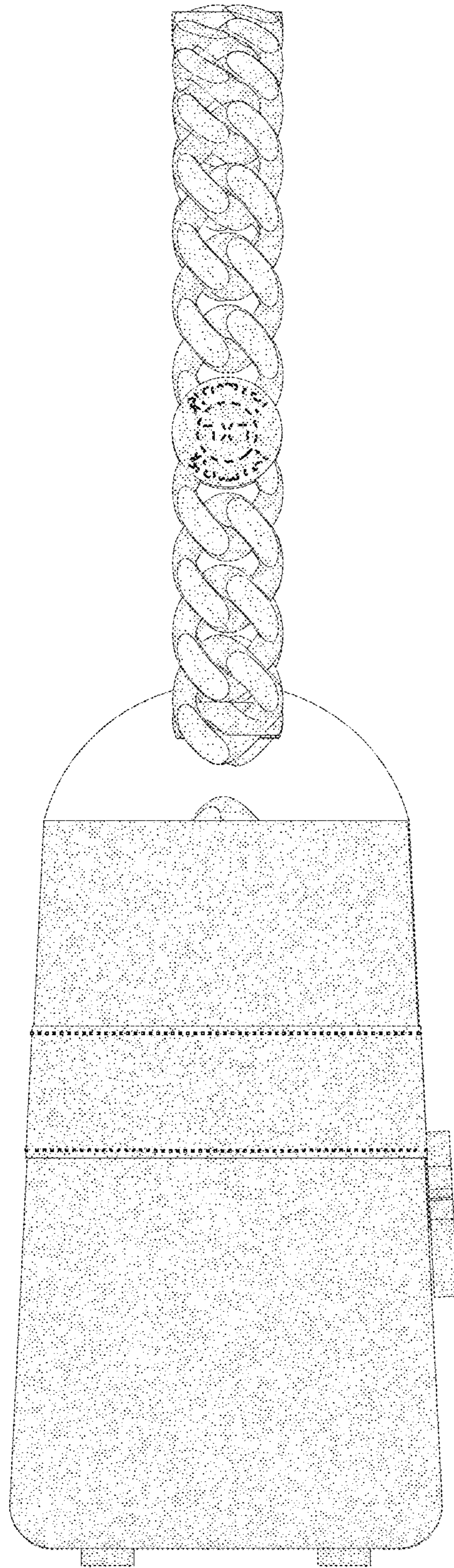

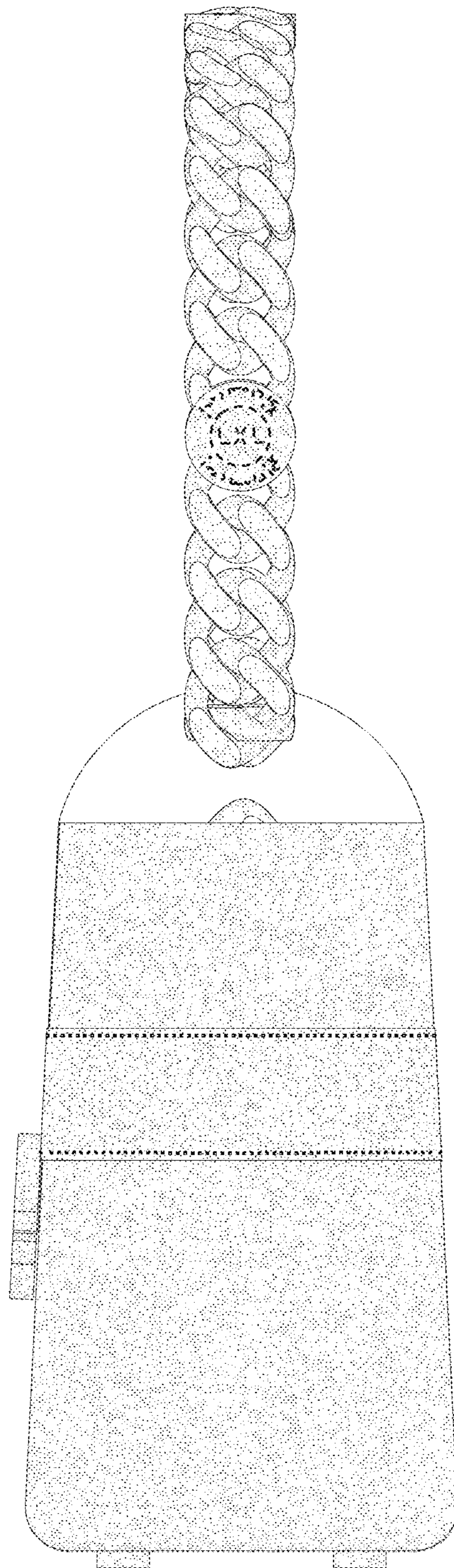

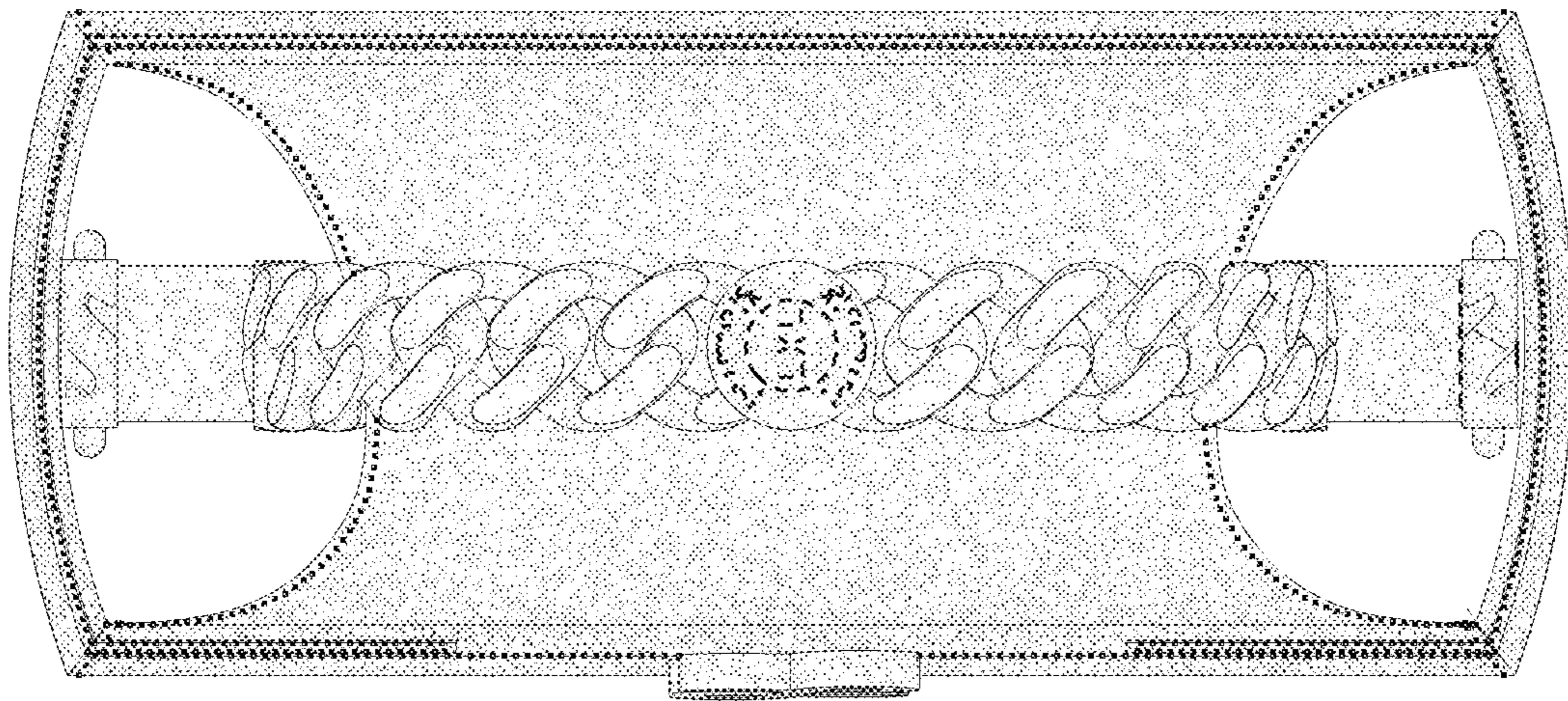

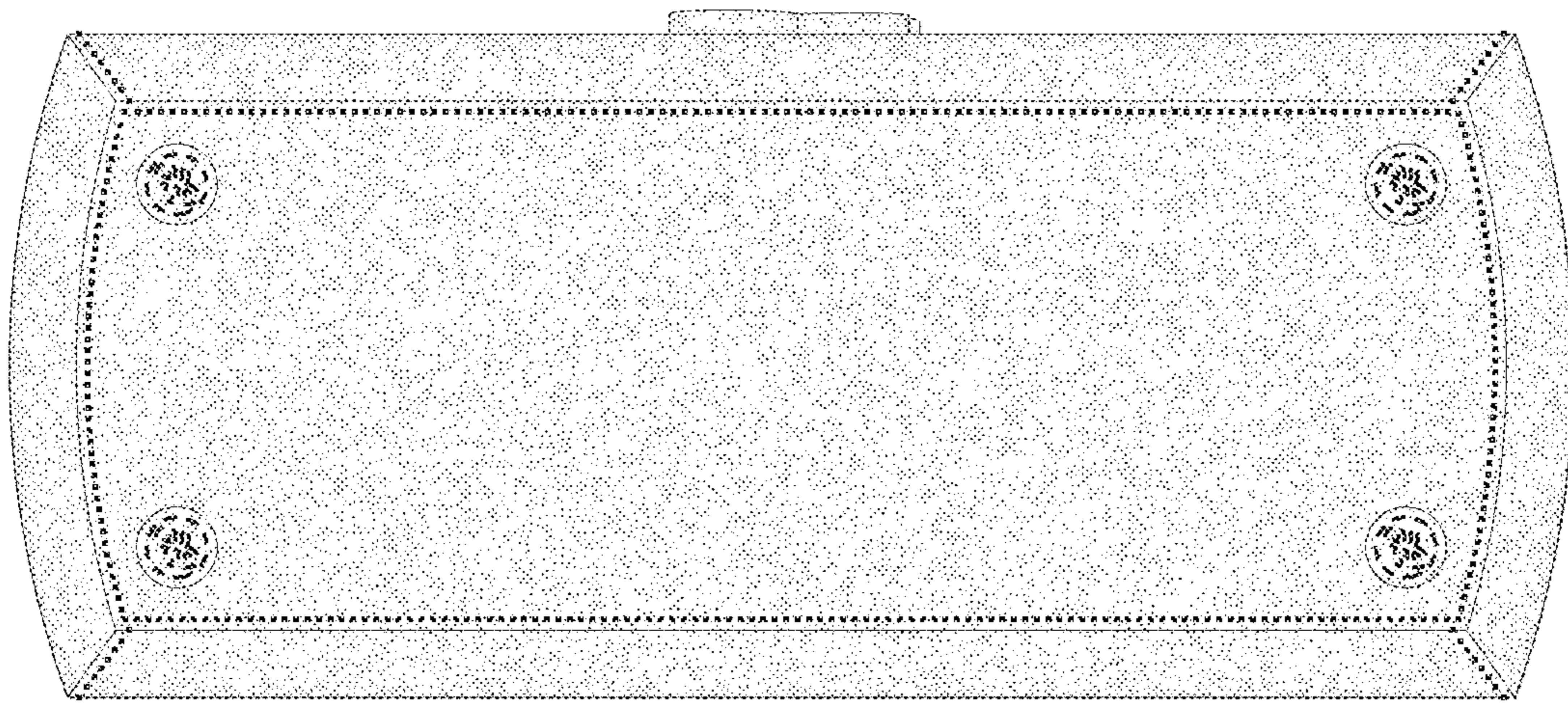
