(57) **CLAIM**

I claim the ornamental design for a combined blanket and pillow, substantially as shown and described.

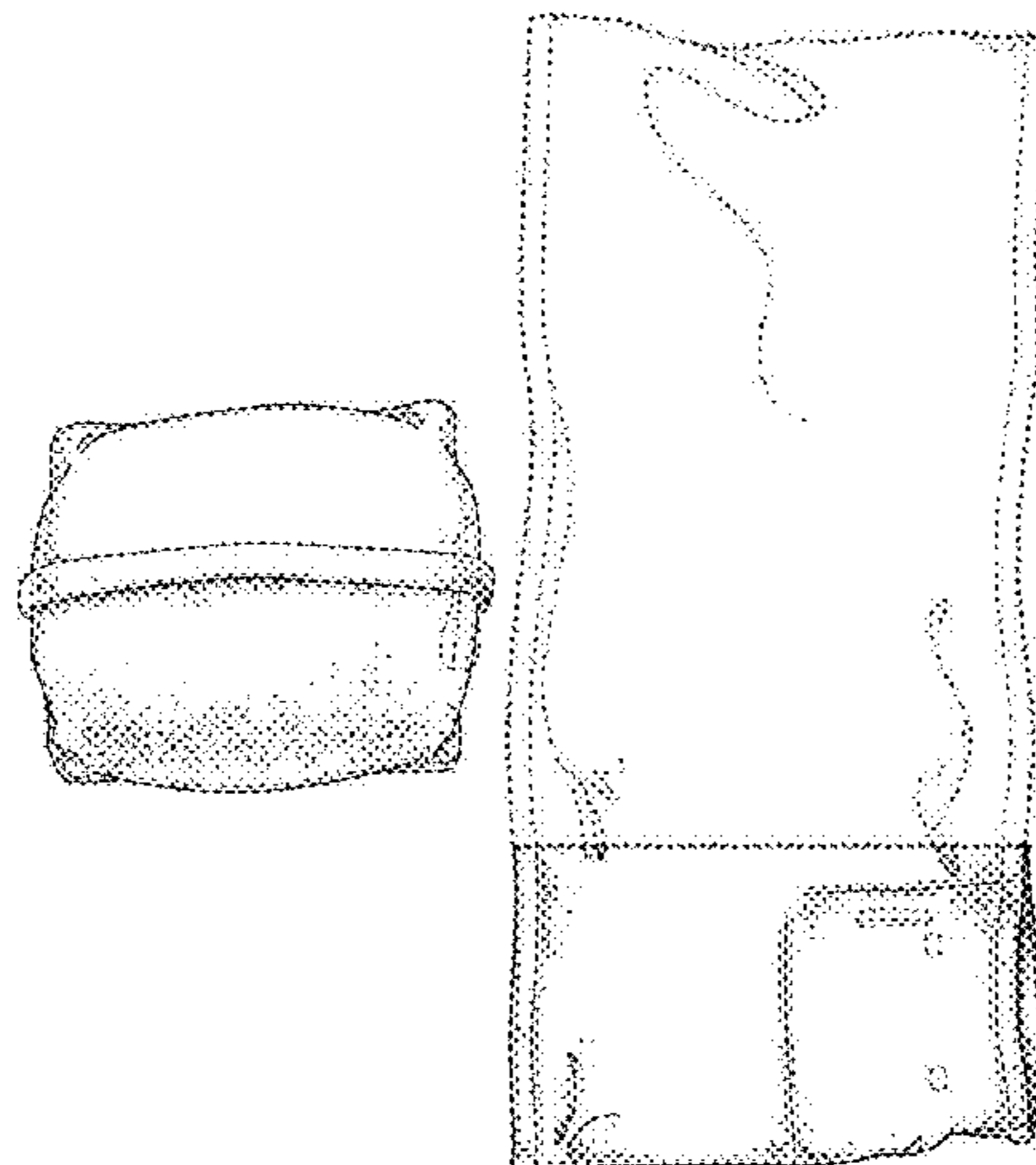
**DESCRIPTION**

FIG. 1 is a back view of a combined blanket and pillow in the pillow form;  
FIG. 2 is a side view of FIG. 1;  
FIG. 3 is a front view of FIG. 1;  
FIG. 4 is a back view the combined blanket and pillow of FIG. 1 with a slightly opened front flap;  
FIG. 5 is a top view of the combined blanket and pillow of FIG. 1 with a completely opened front flap flipped over to the back;  
FIG. 6 is a front view of the combined blanket and pillow of FIG. 1 in a first configuration thereof;  
FIG. 7 is a front, left perspective view of combined blanket and pillow of FIG. 1 in a second configuration thereof;  
FIG. 8 is a front, left perspective view of the combined blanket and pillow of FIG. 1 in a third configuration thereof;  
FIG. 9 is a perspective view of the combined blanket and pillow of FIG. 1 in a fourth configuration thereof;  
FIG. 10 is a front view of the combined blanket and pillow of FIG. 1 in the blanket form;  
FIG. 11 is a back view of FIG. 10; and,  
FIG. 12 is an enlarged partial front, right side perspective view of FIG. 10.

More generally, the invention pertains to an ornamental design for an article of manufacture. As indicated in the title, the article of manufacture to which the ornamental design has been applied is a combined blanket and pillow, a pillow, or a blanket.

The broken line, shown adjacent to the claimed subject matter in FIGS. 6-12, indicates a boundary which forms no part of the claimed design. Other broken lines depict portions of the combined blanket and pillow which form no part

of the claimed design. The shadings show contours, surfaces, or recesses of the present invention.

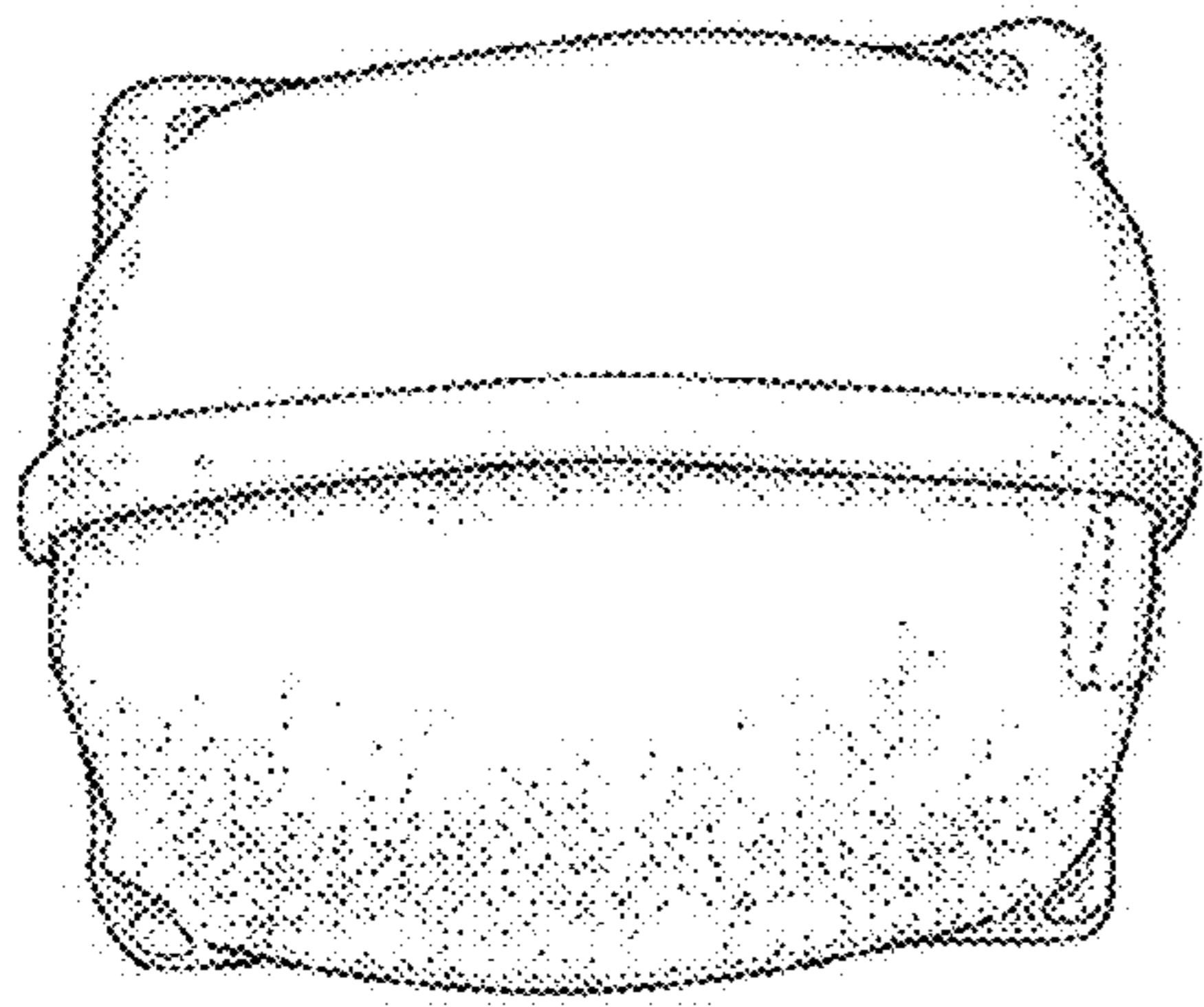

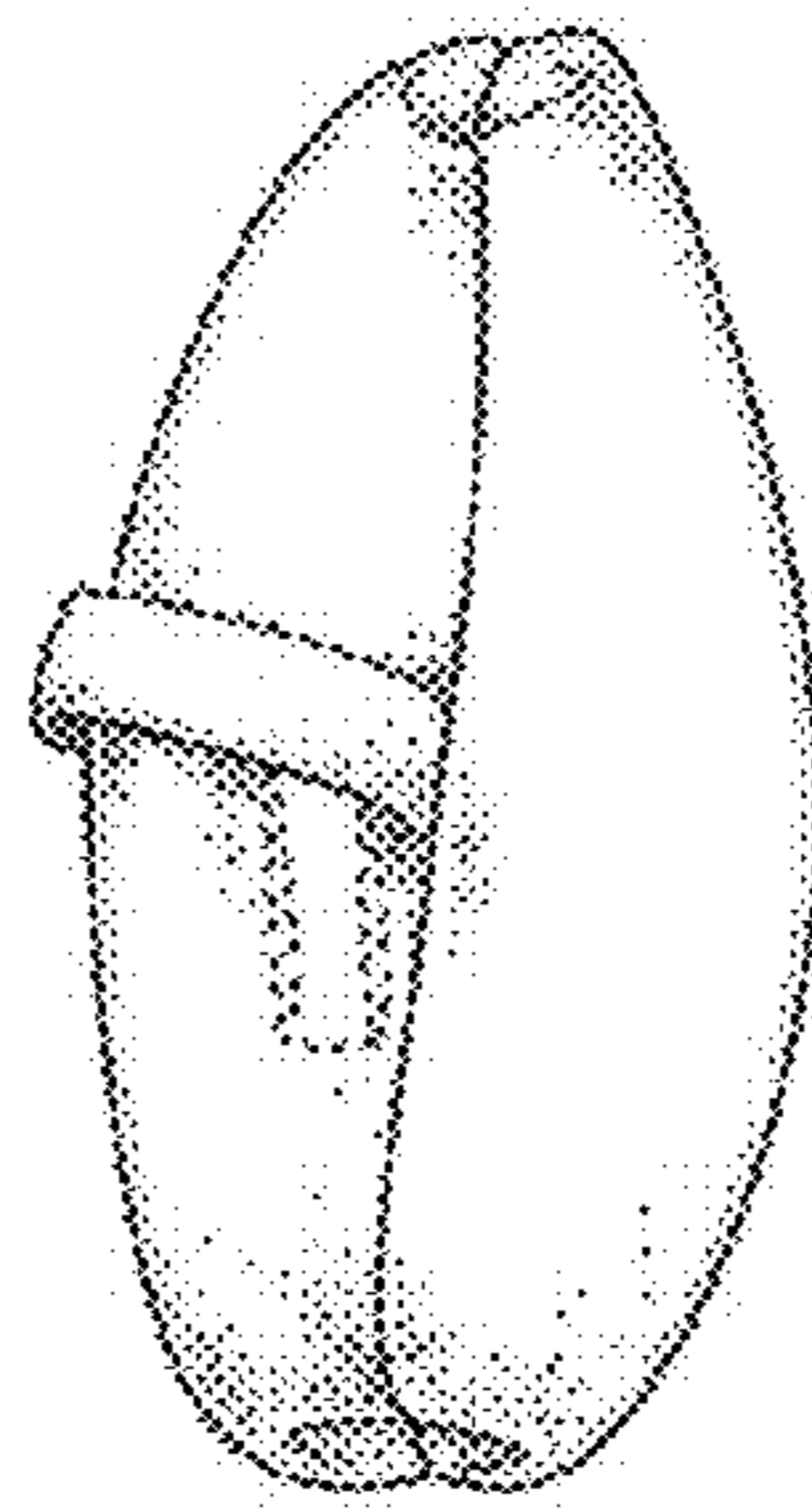

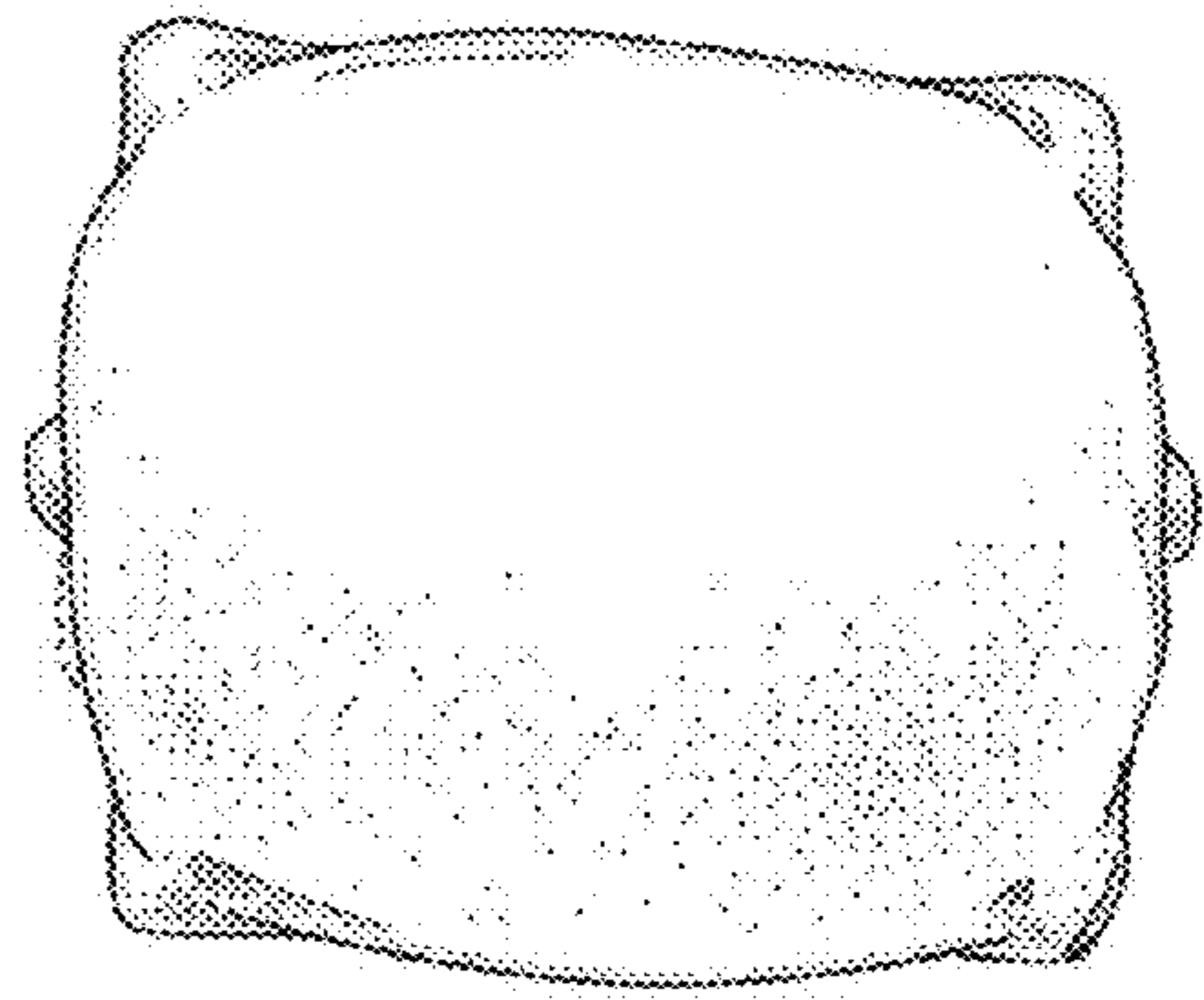

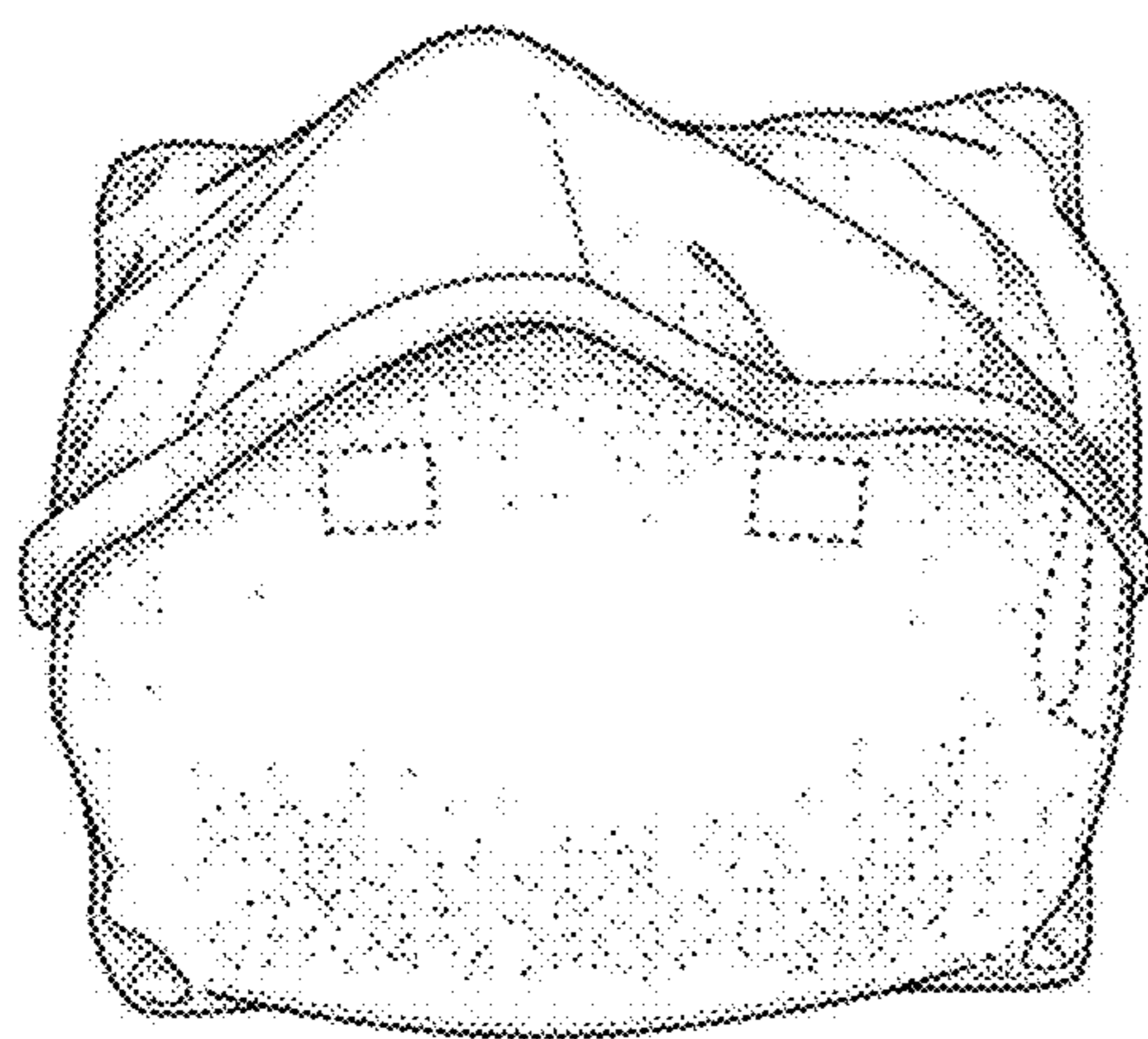

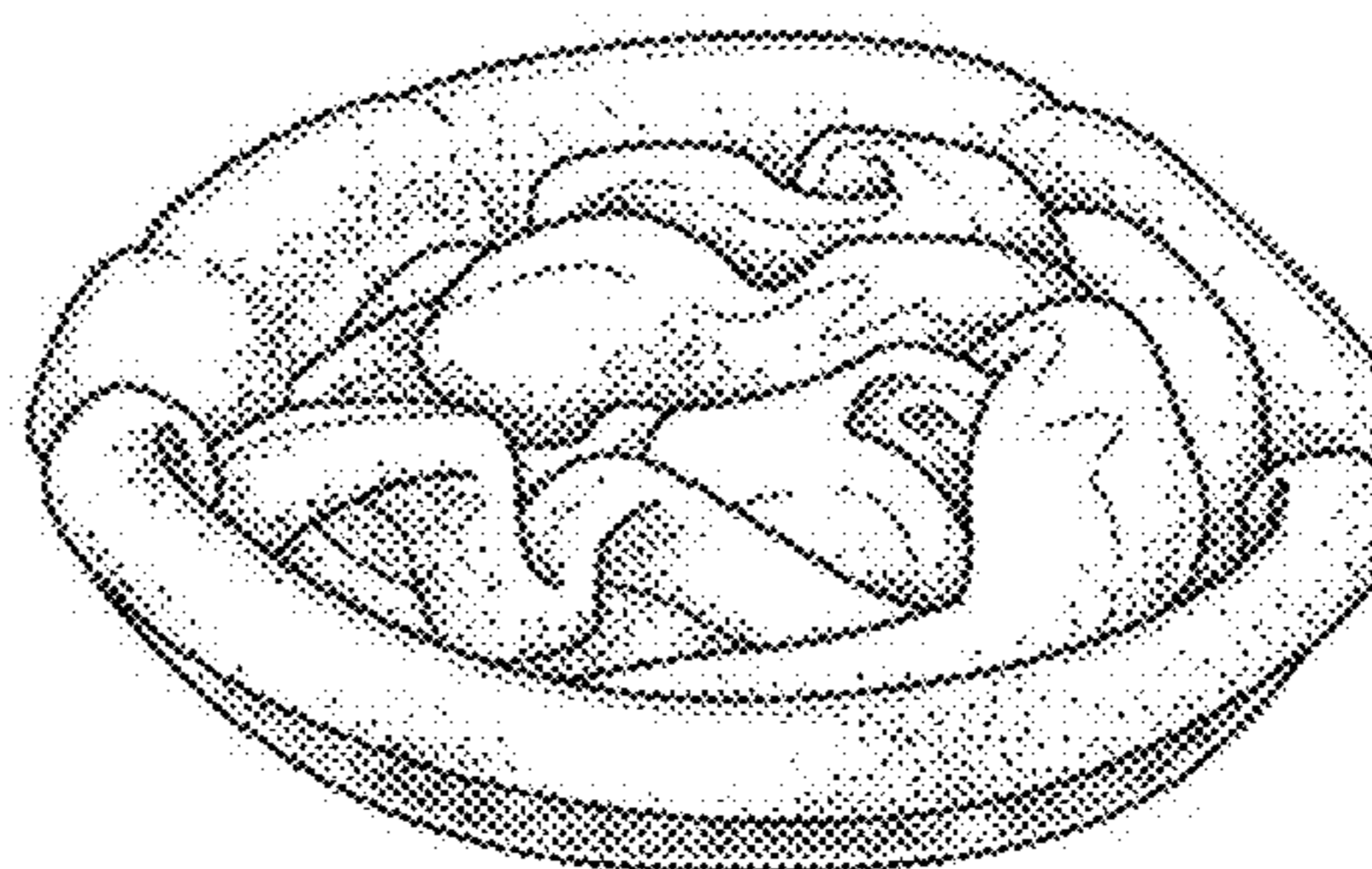
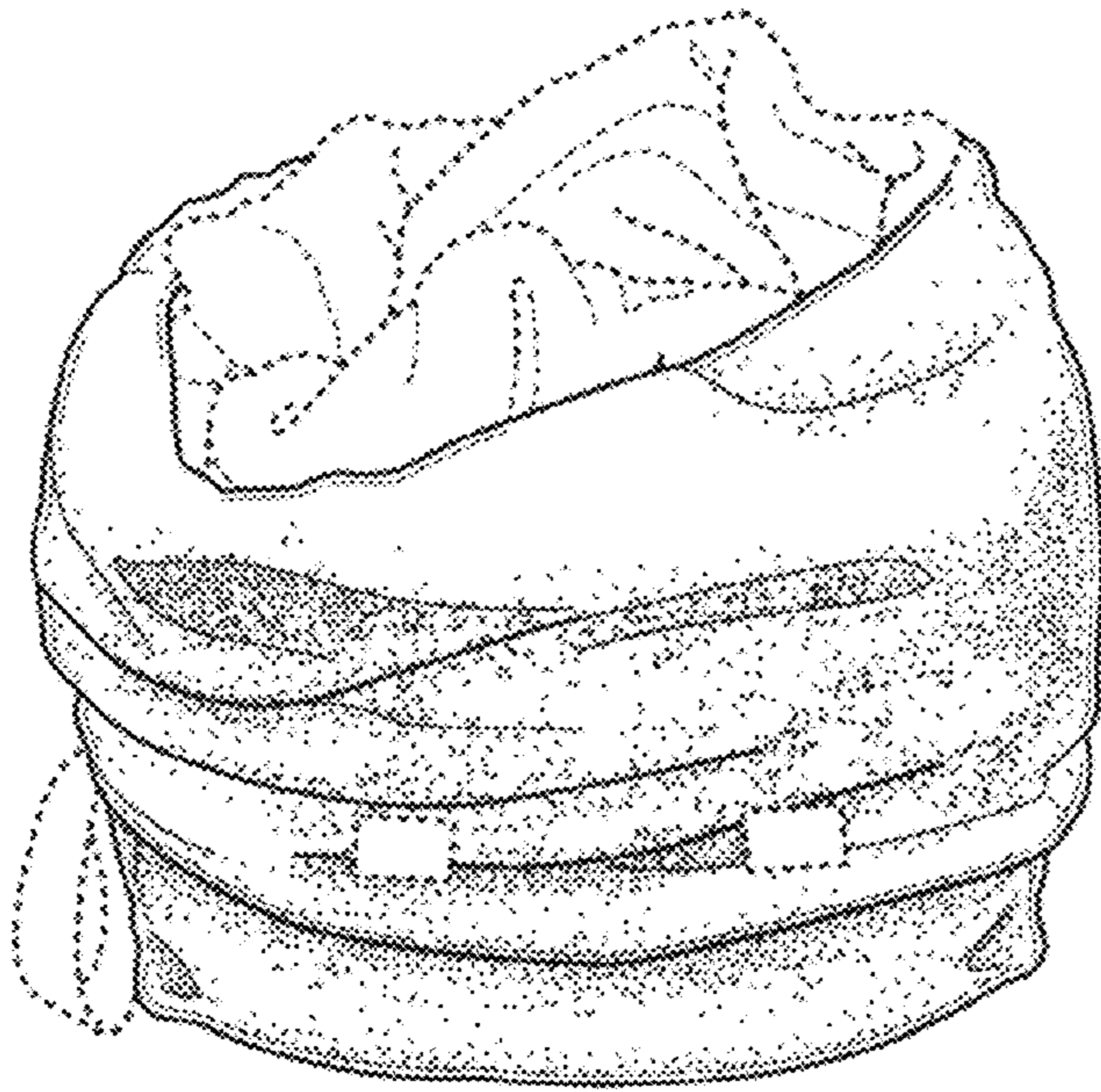
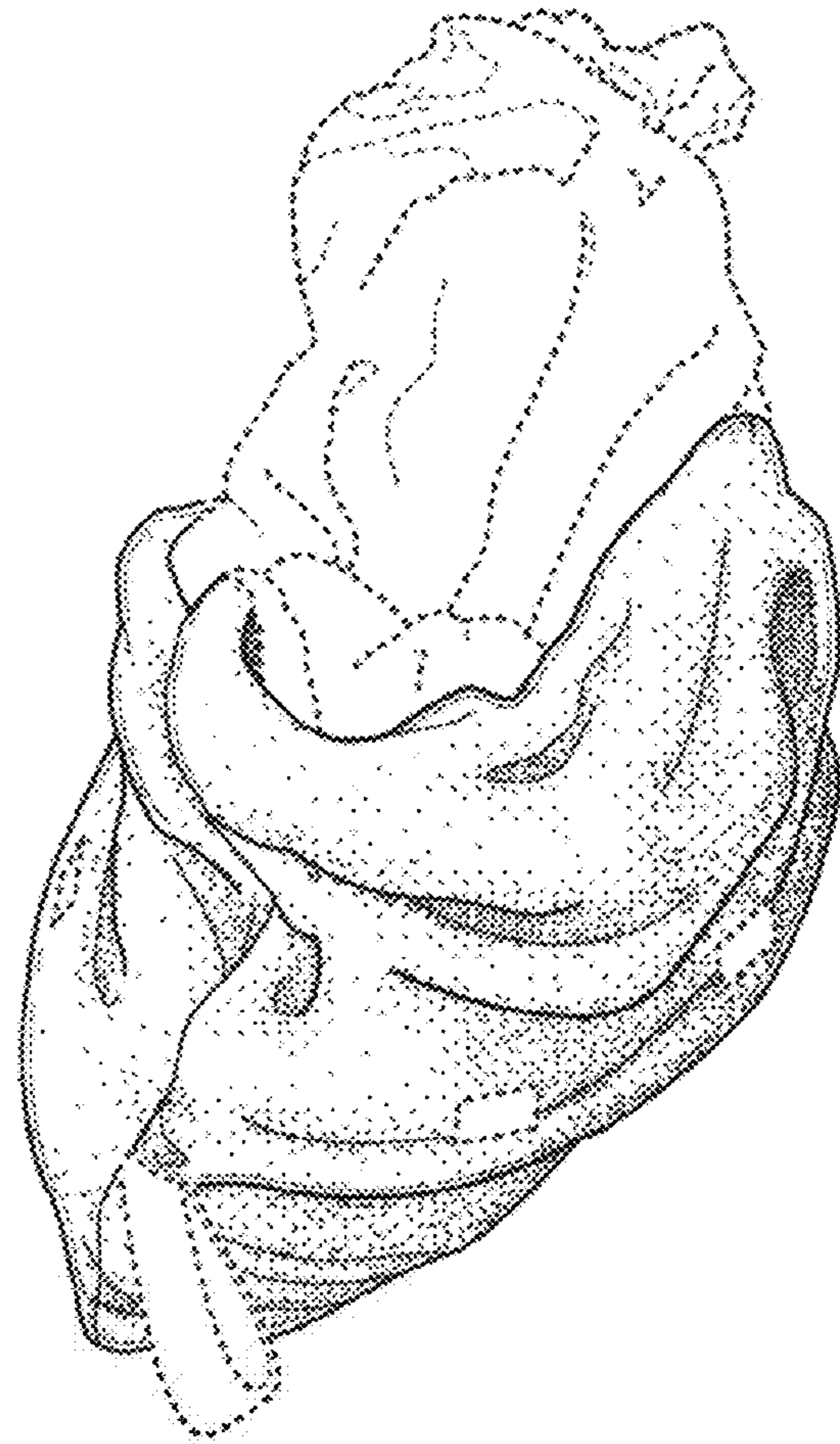

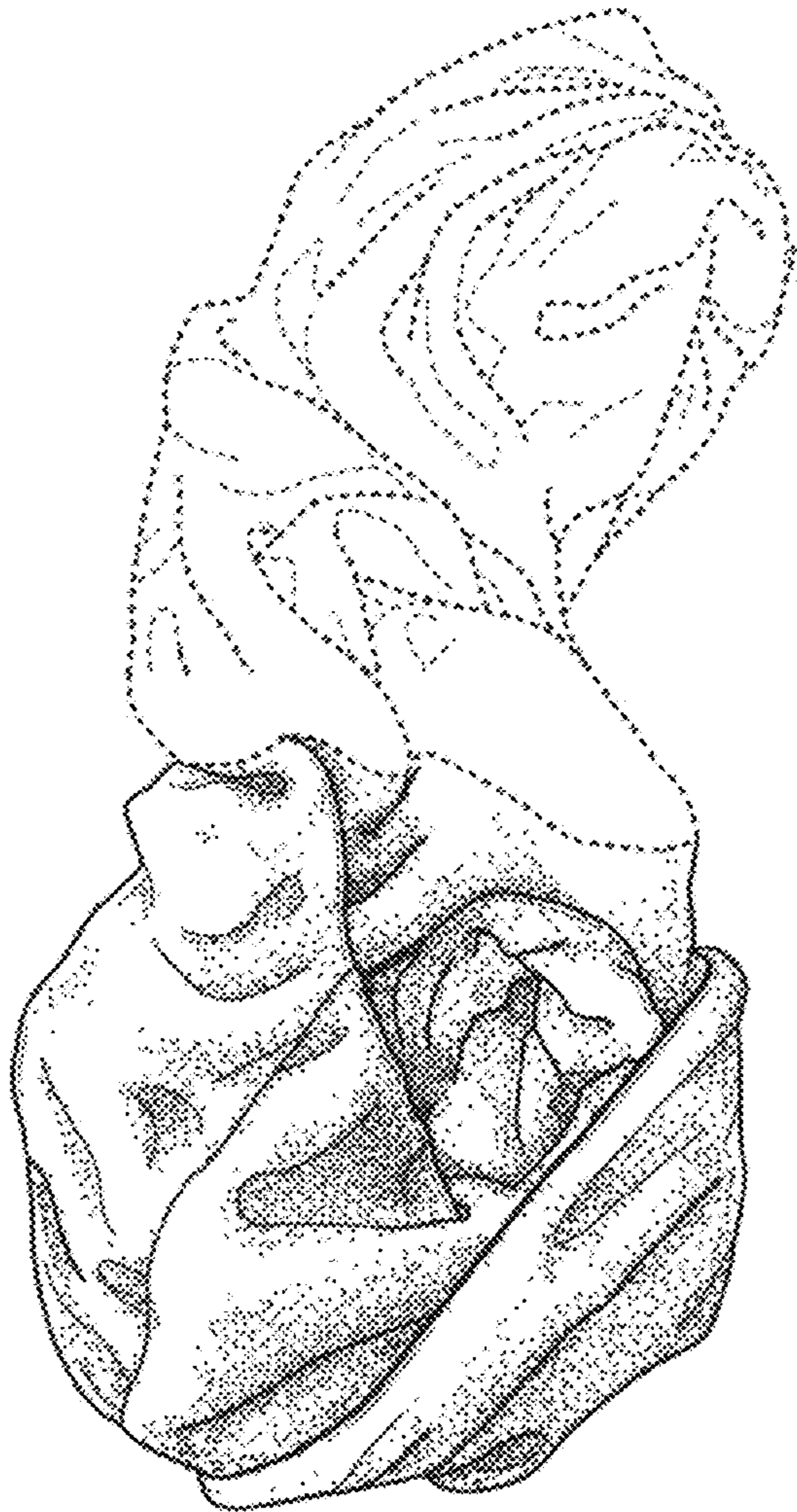

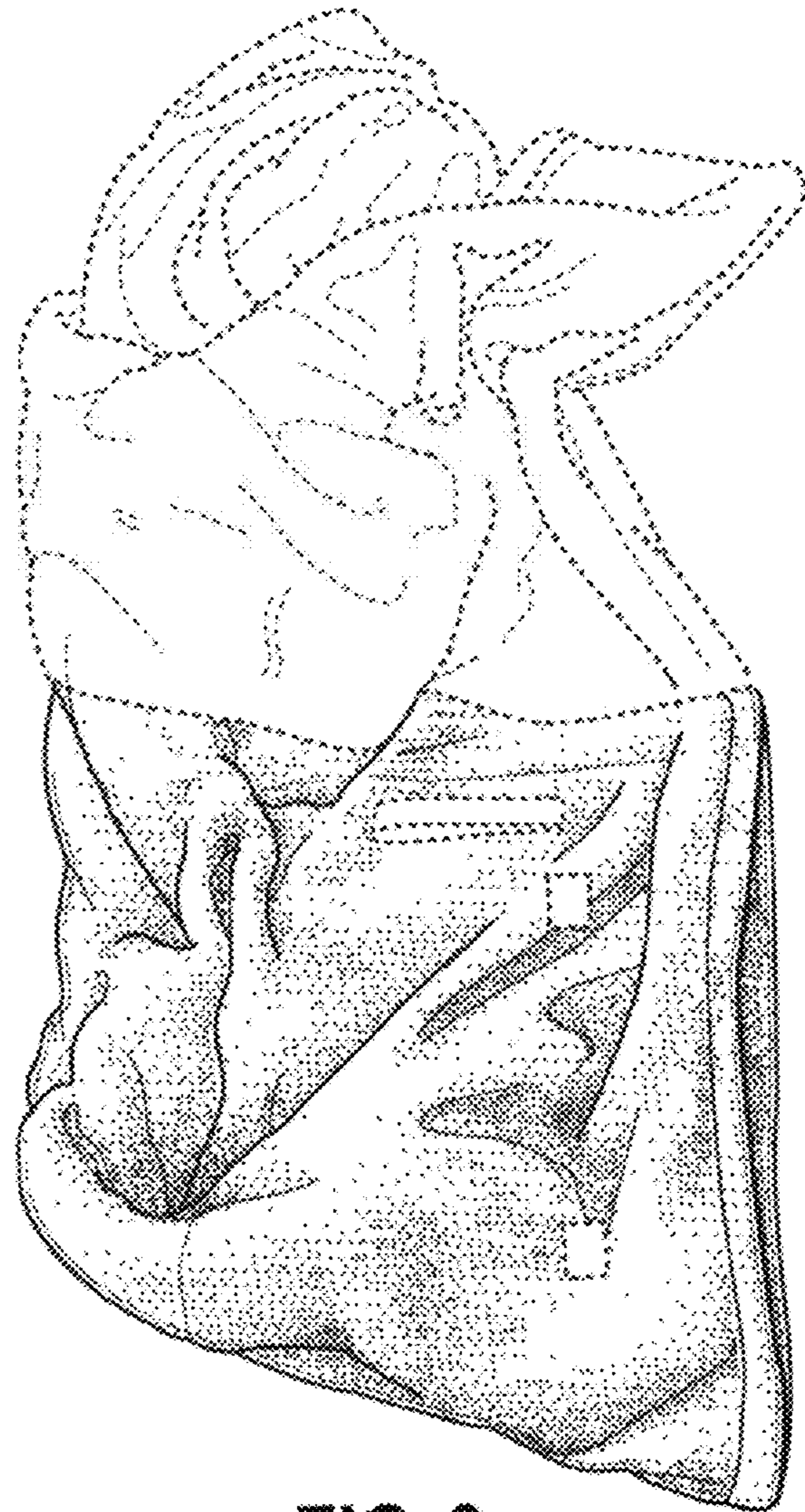

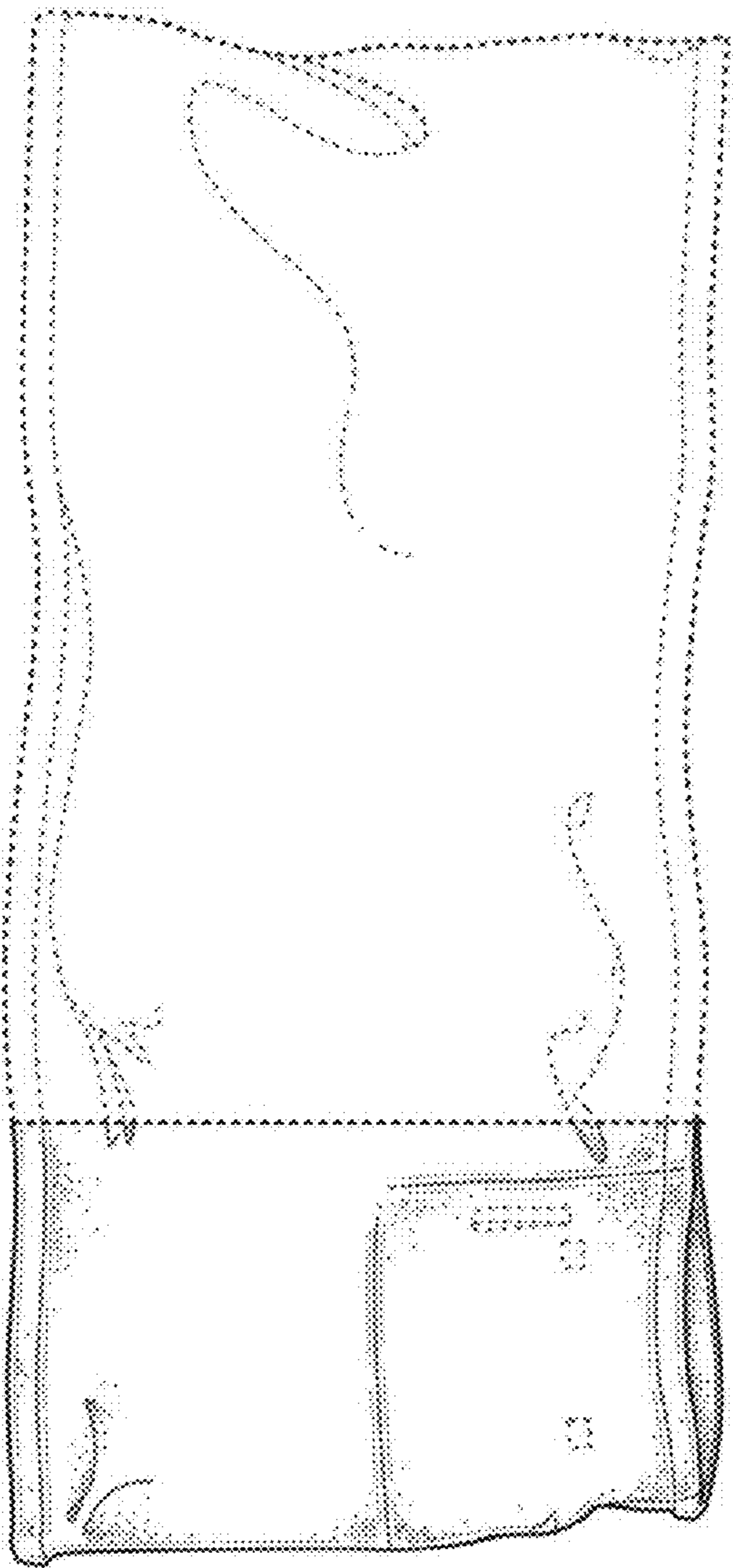

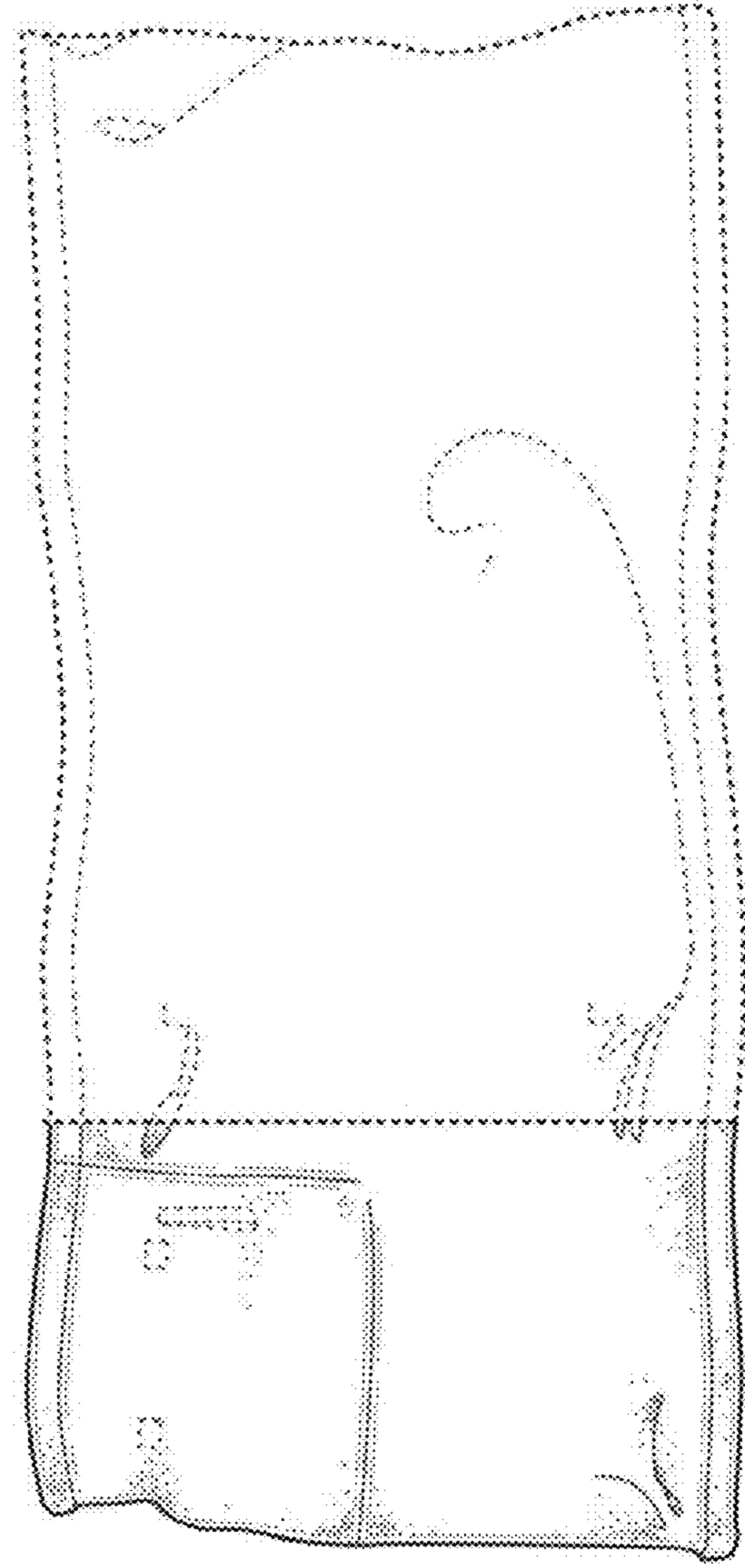

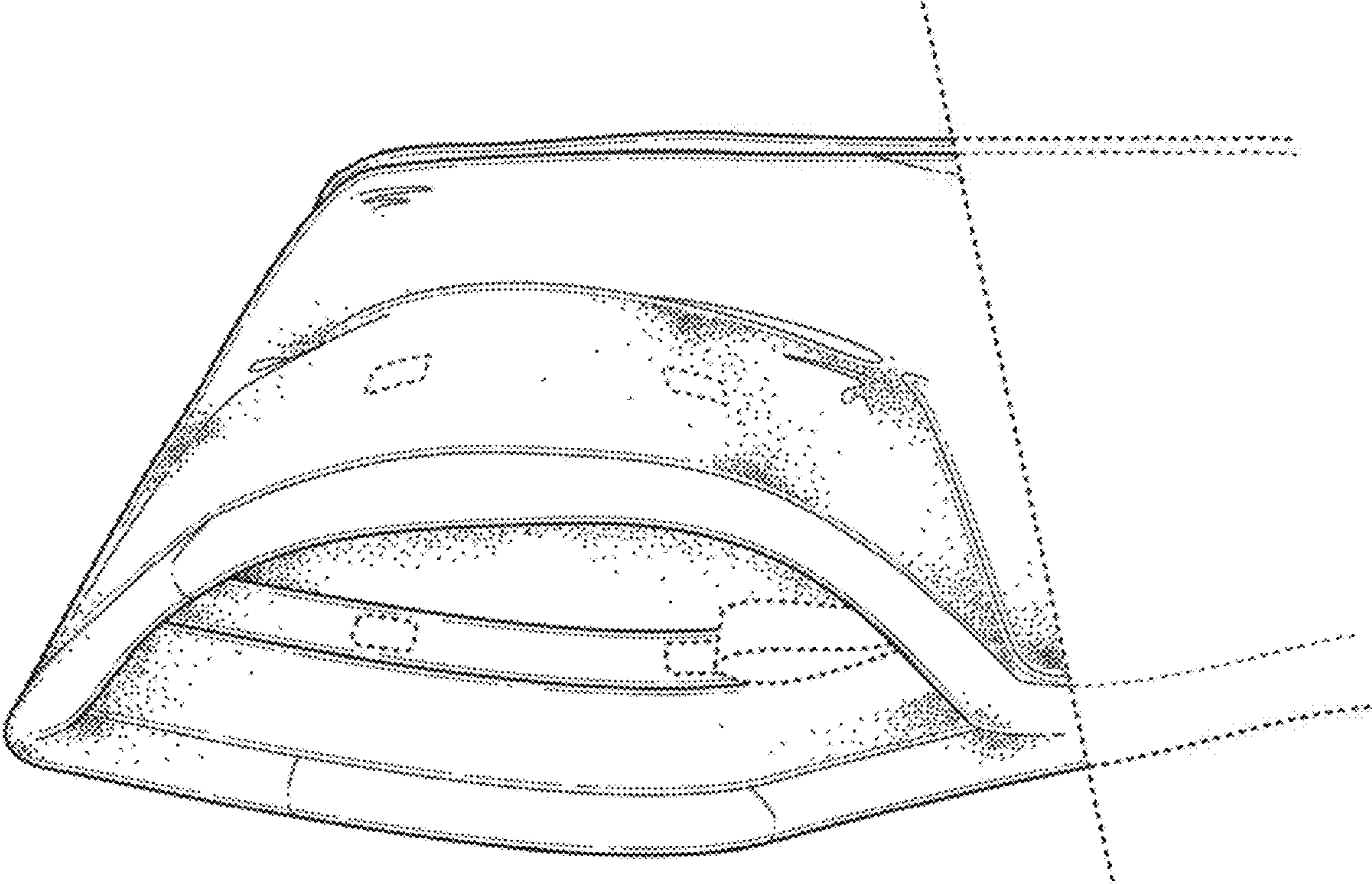
