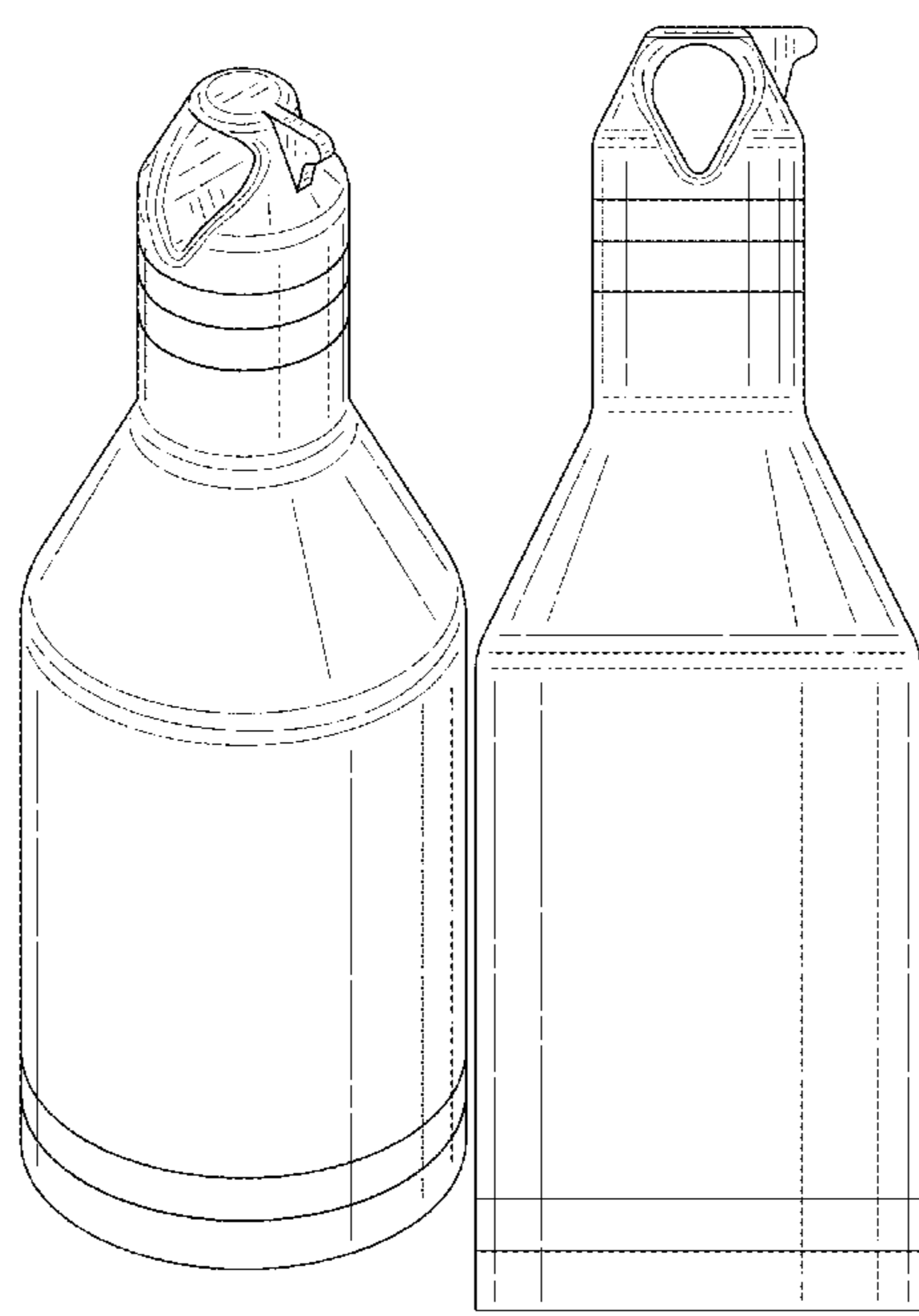

The ornamental design for a beverage container, as shown and described.

DESCRIPTION
FIG. 1 is a perspective view of a beverage container; FIG. 2 is a front view of the beverage container; FIG. 3 is a back view of the beverage container; FIG. 4 is a right side view of the beverage container; FIG. 5 is a left side view of the beverage container; FIG. 6 is a top view of the beverage container; FIG. 7 is a bottom view of the beverage container; and, FIG. 8 is a perspective exploded view of the beverage container.

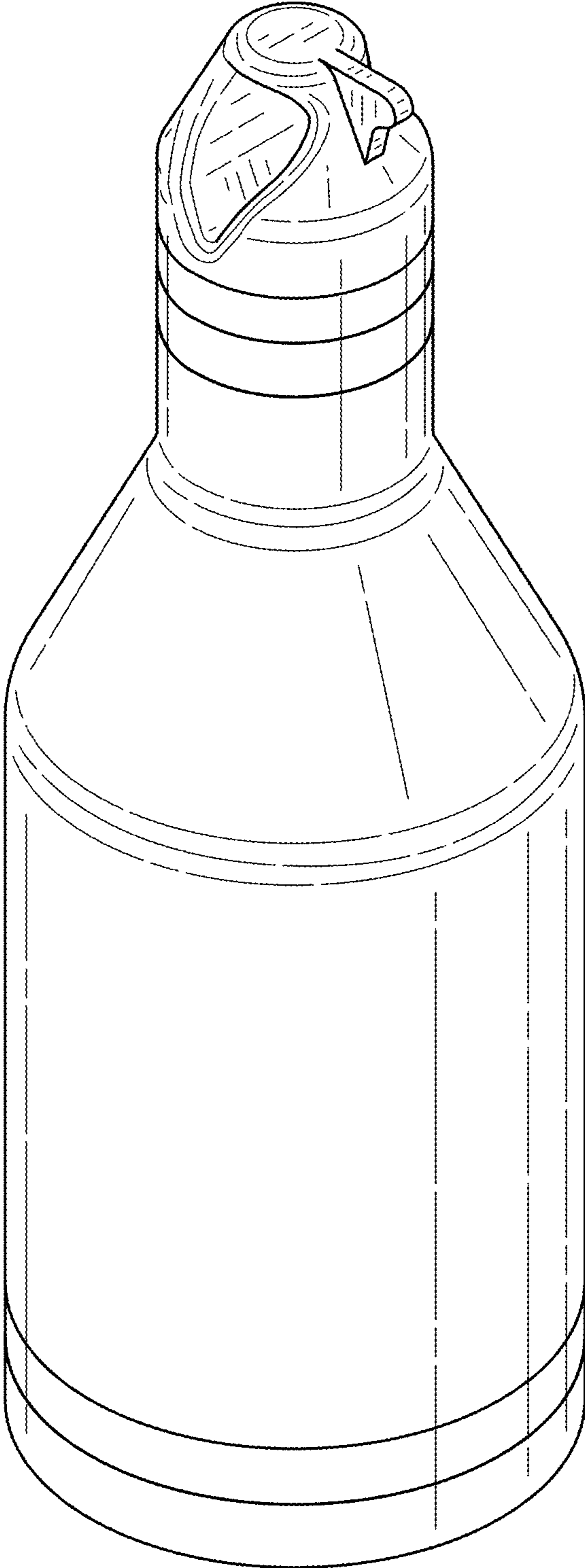

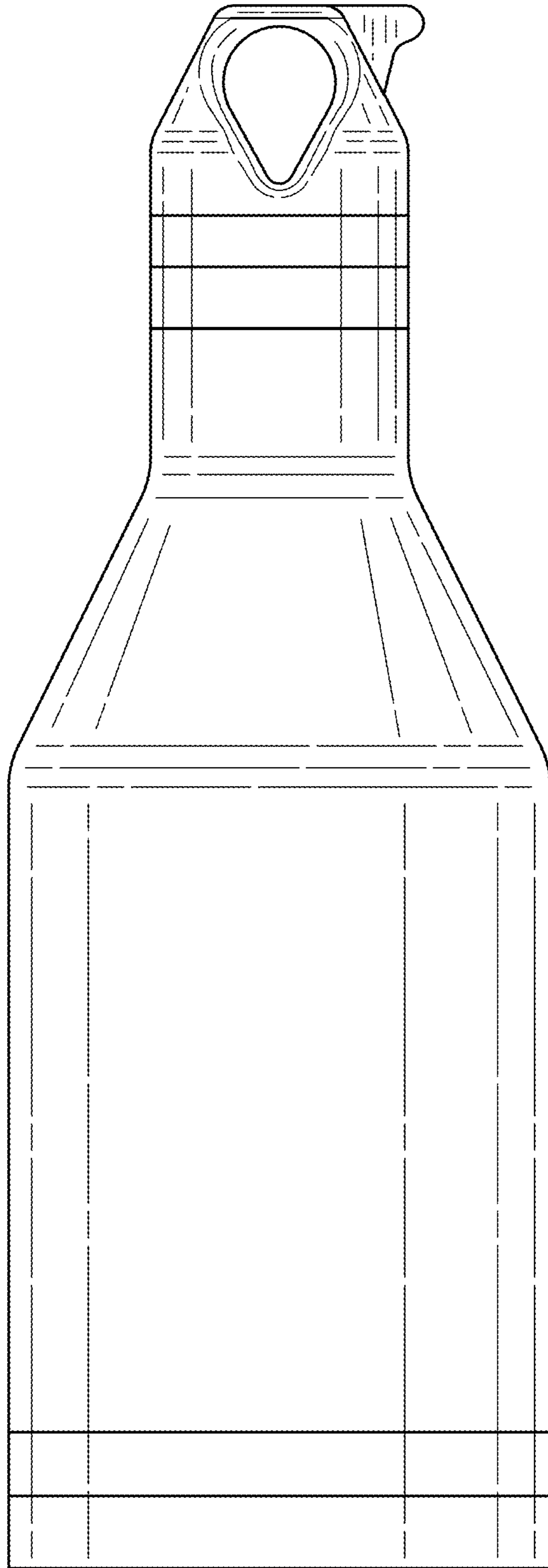

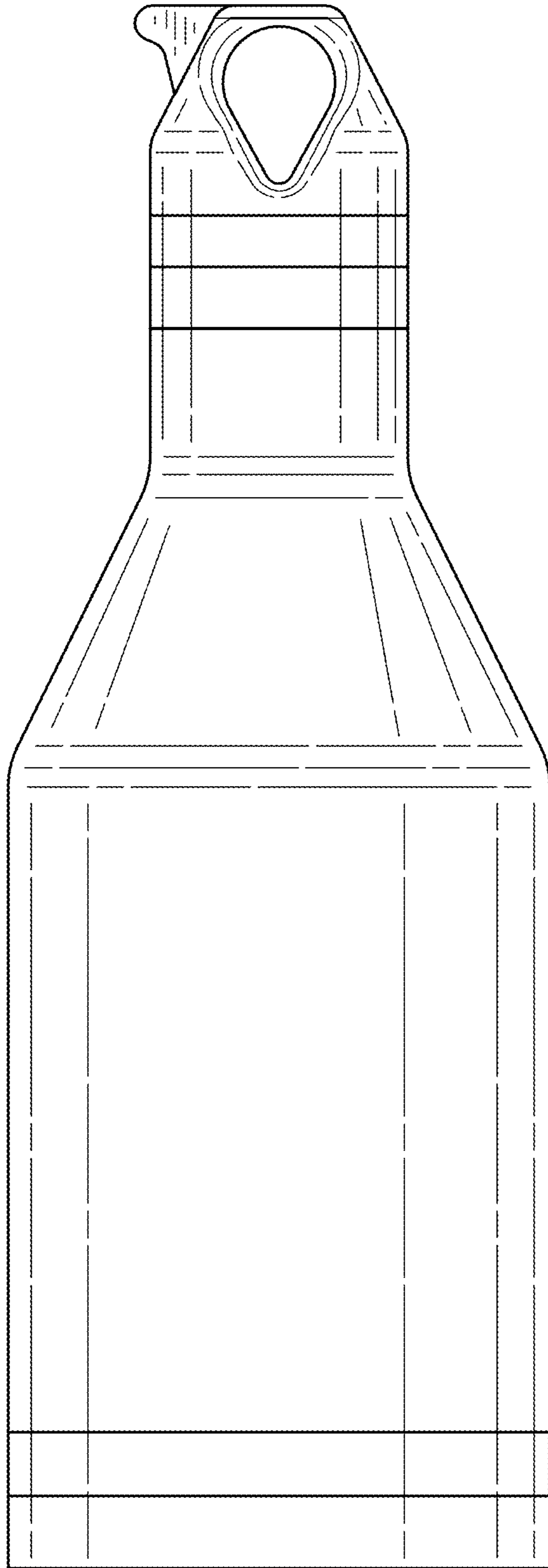

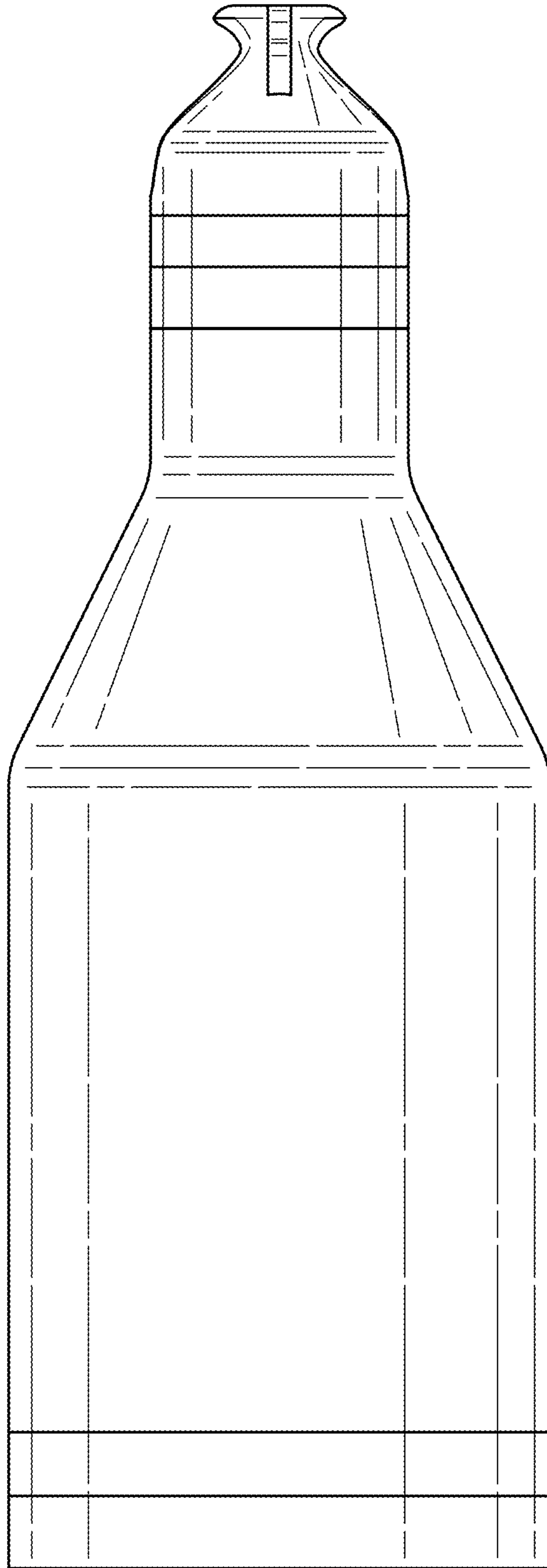

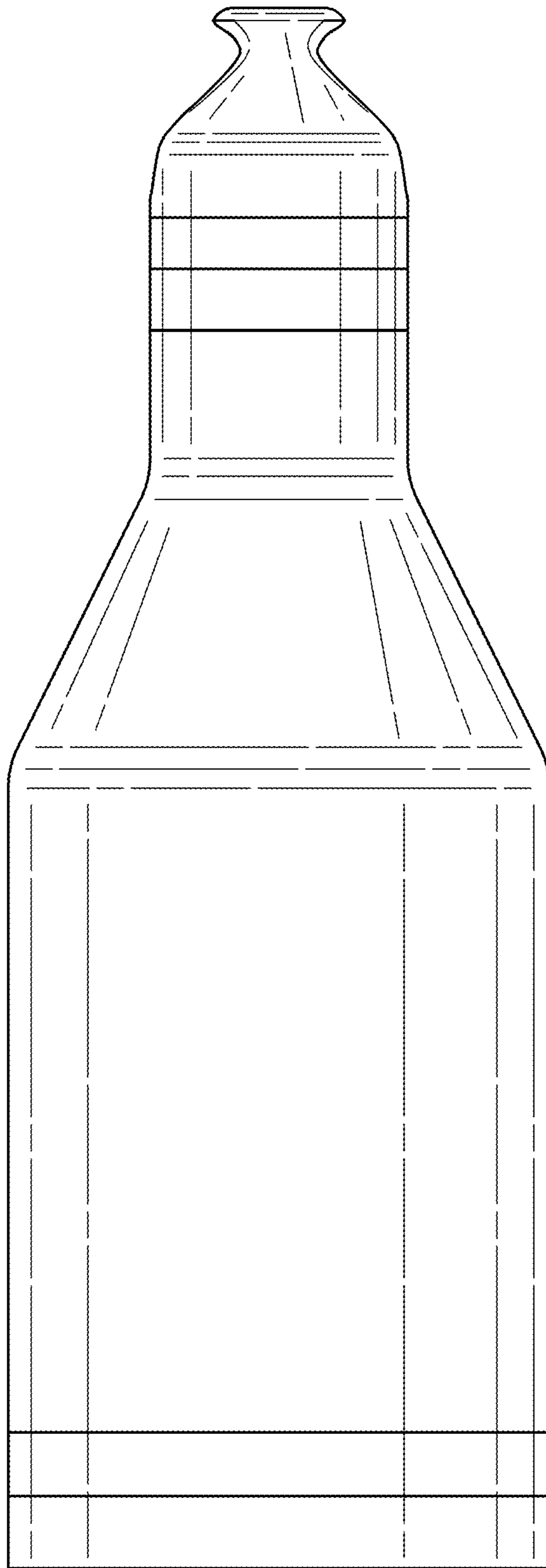

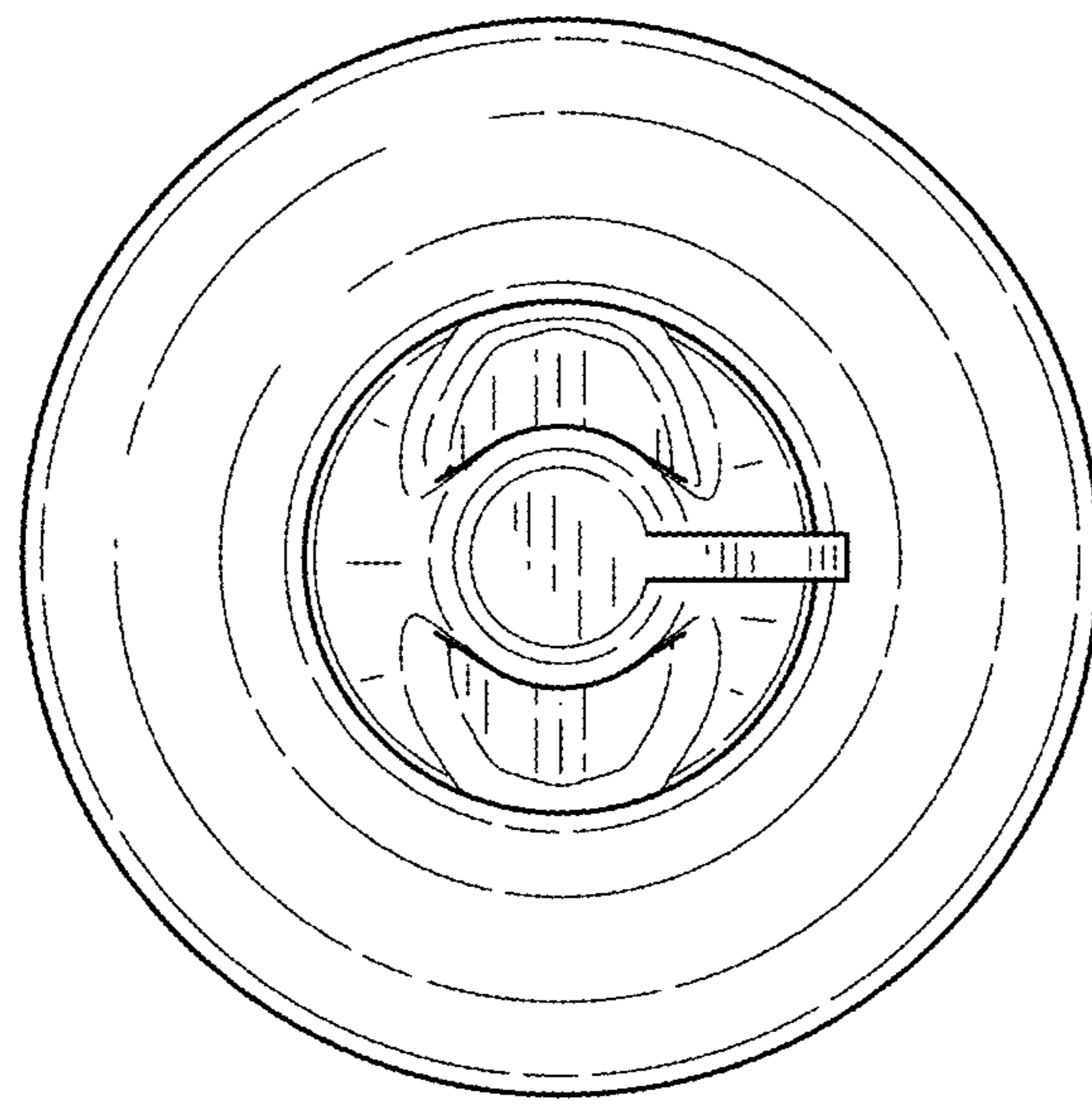

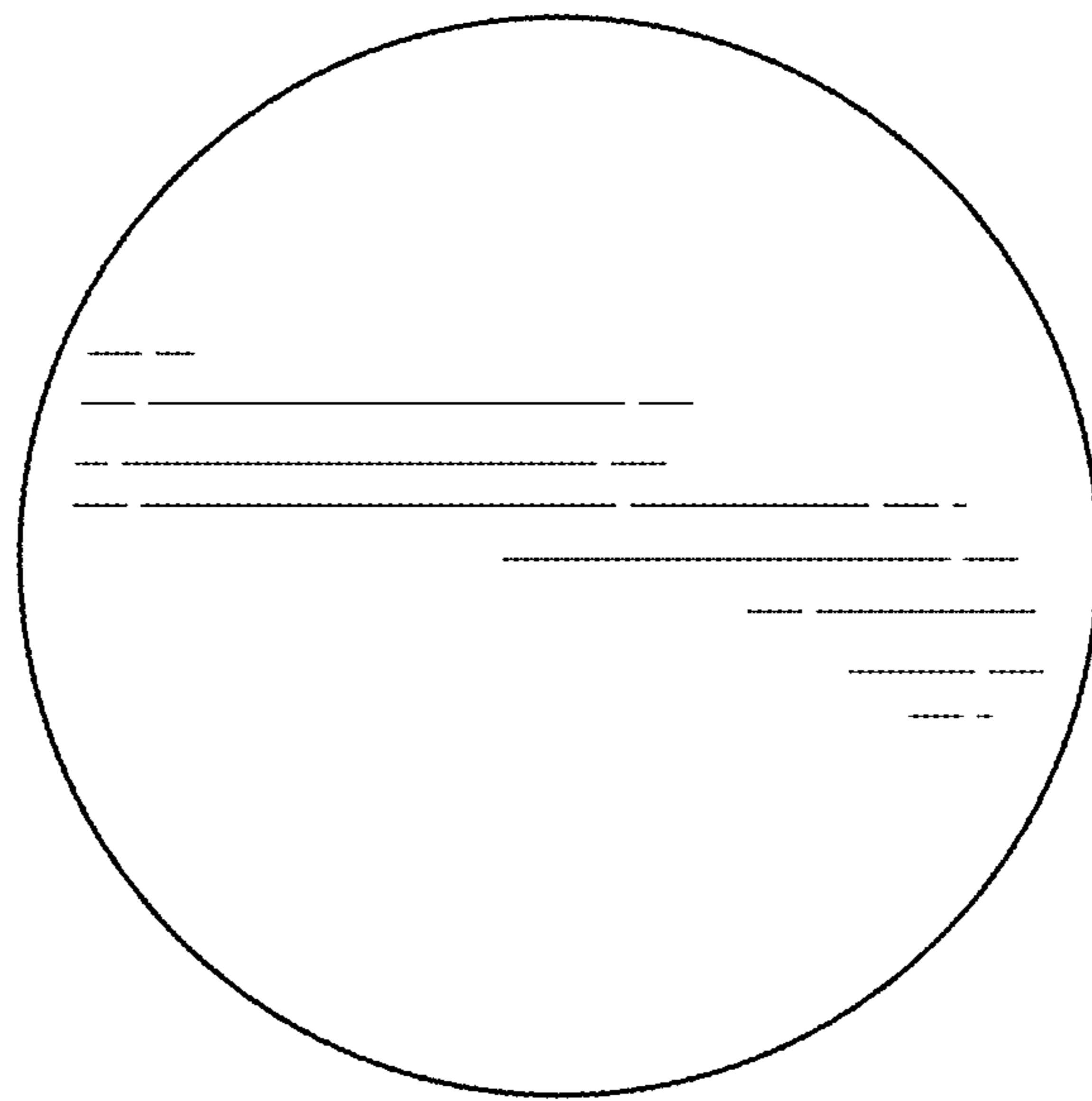

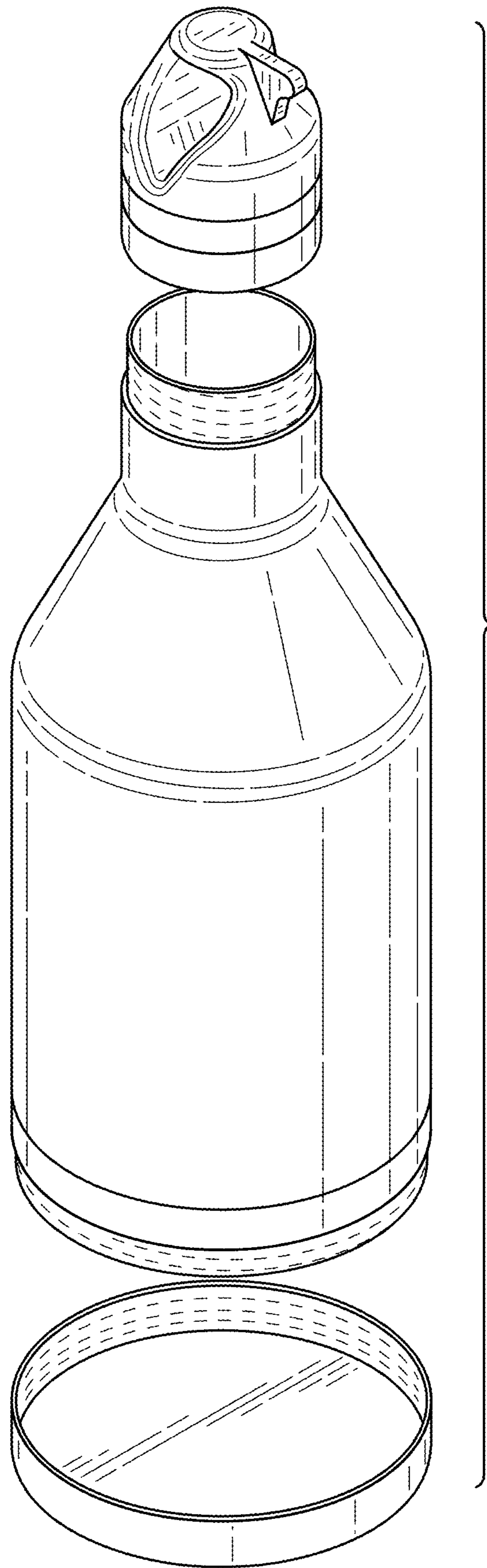
