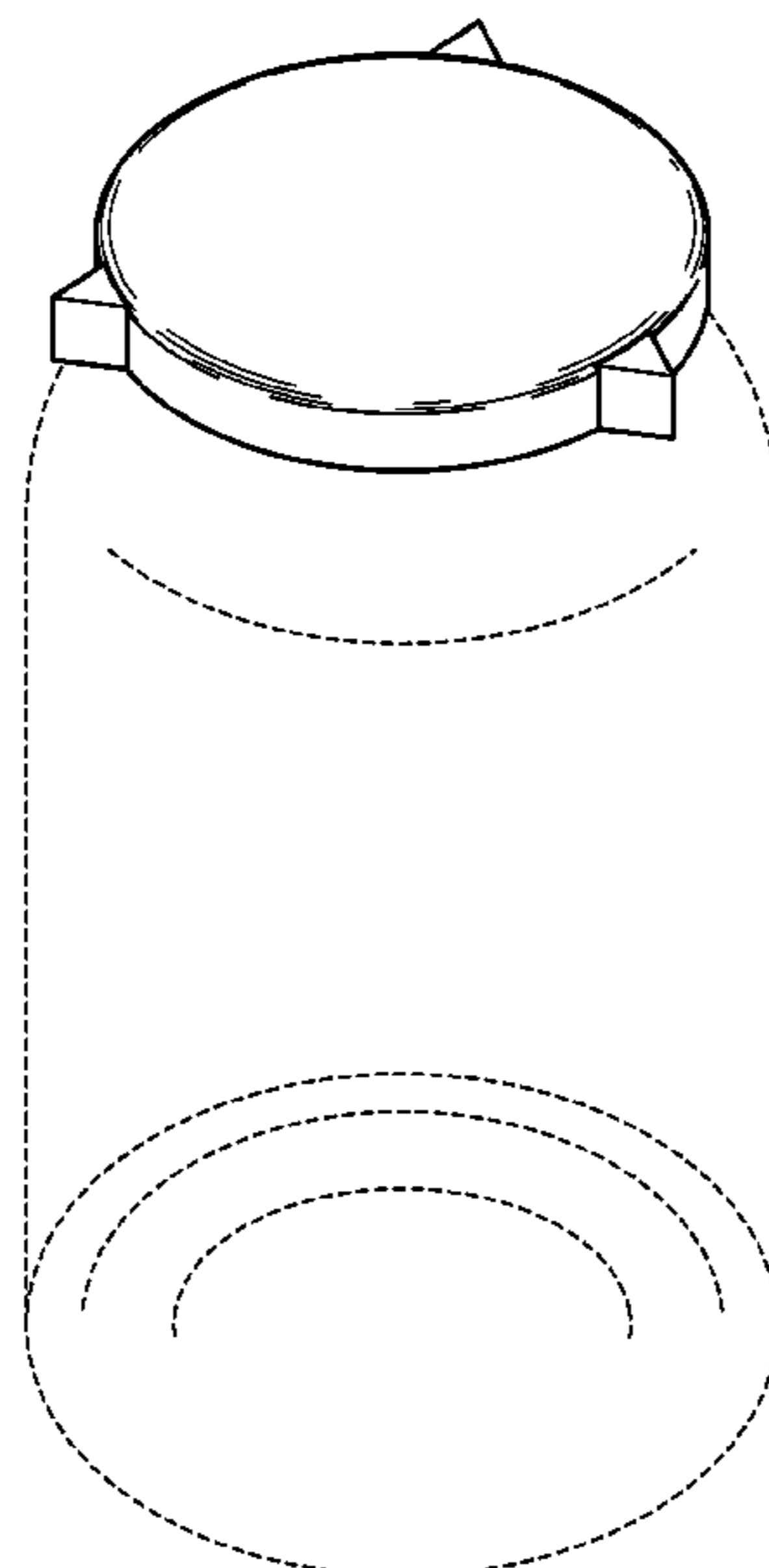
(57) **CLAIM**

The ornamental design for a jar lid, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the jar lid, shown in a position of use on a jar drawn in broken lines. FIG. 2 is a top view of the jar lid of FIG. 1, shown removed from the jar. FIG. 3 is a side view thereof; and, FIG. 4 is a front view thereof. The broken lines depict environment and form no part of the claimed design.

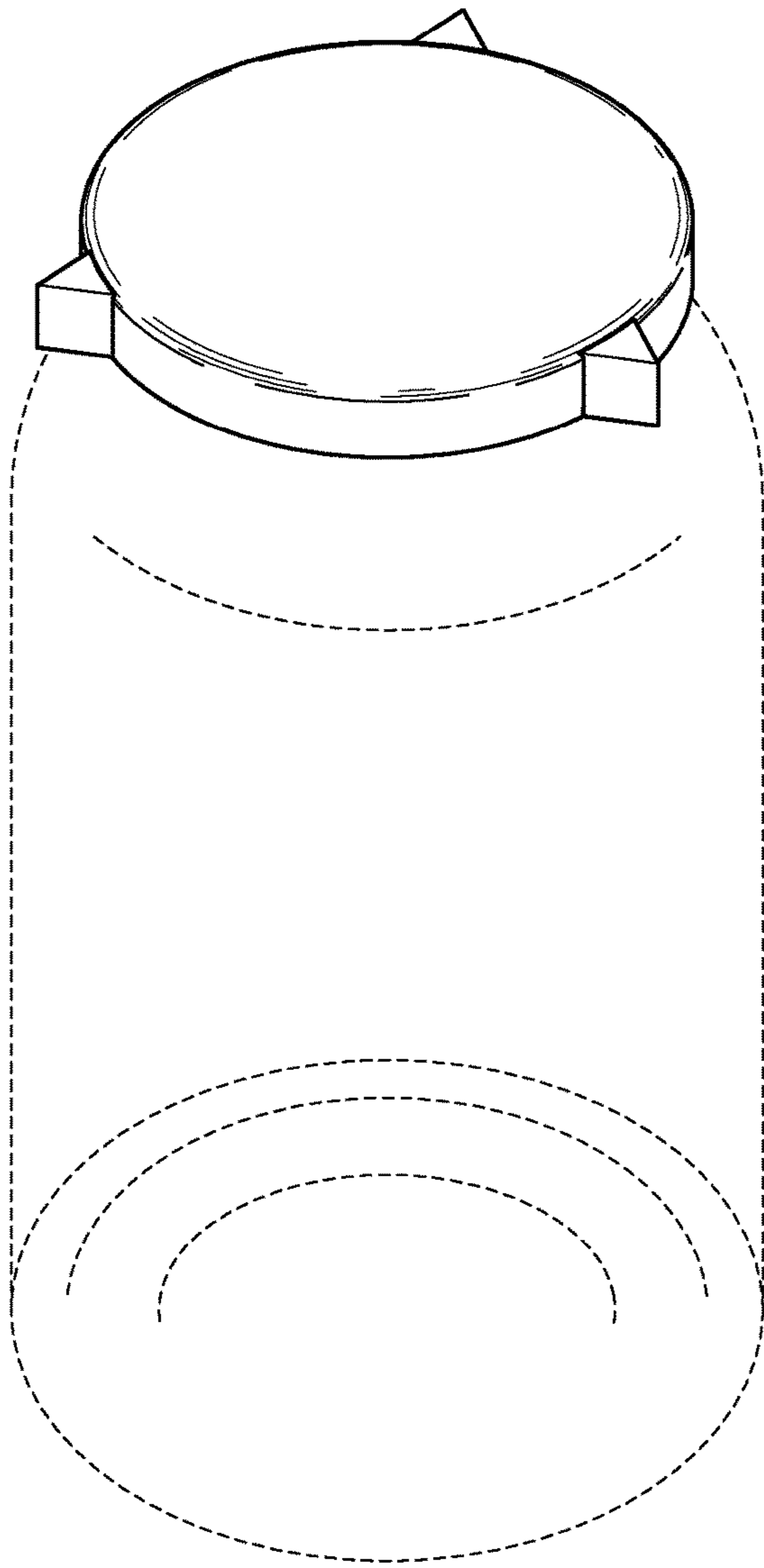

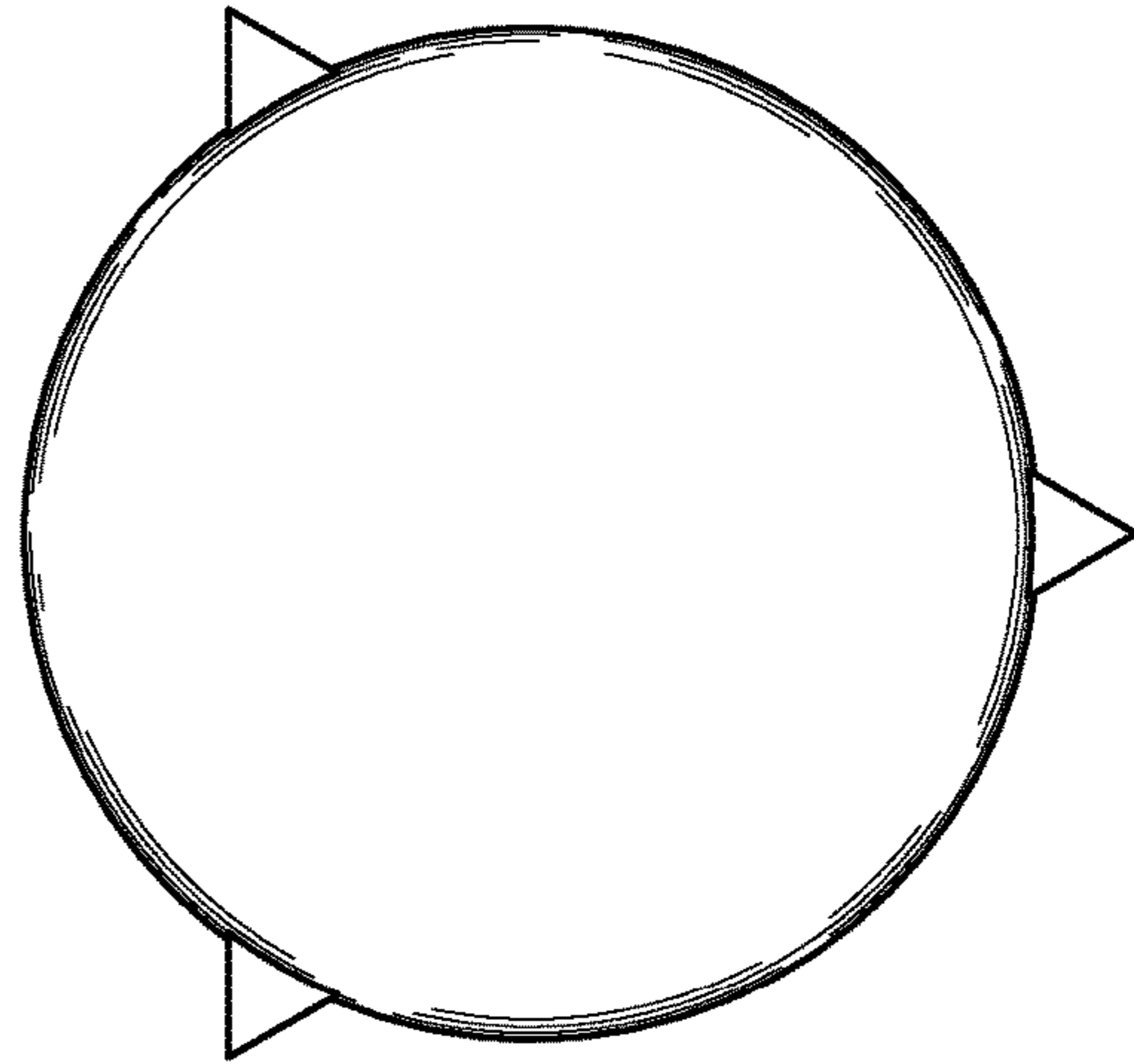

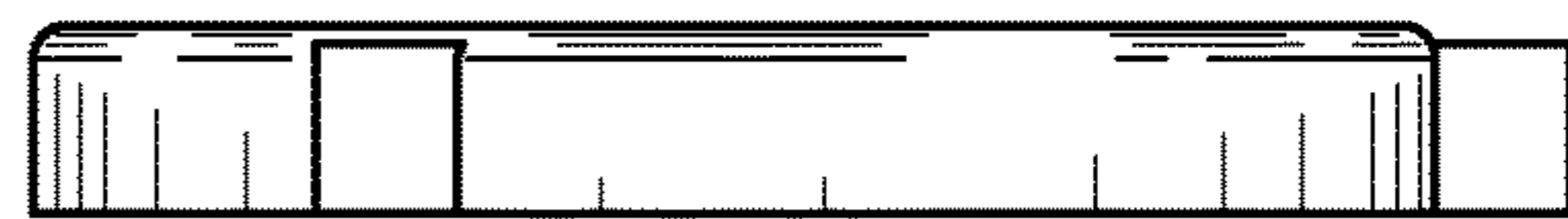

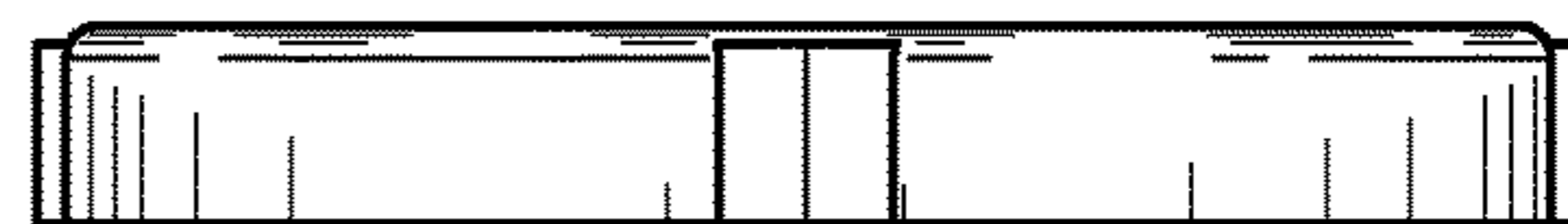
