The ornamental design for a vial with a hook, as shown and described.

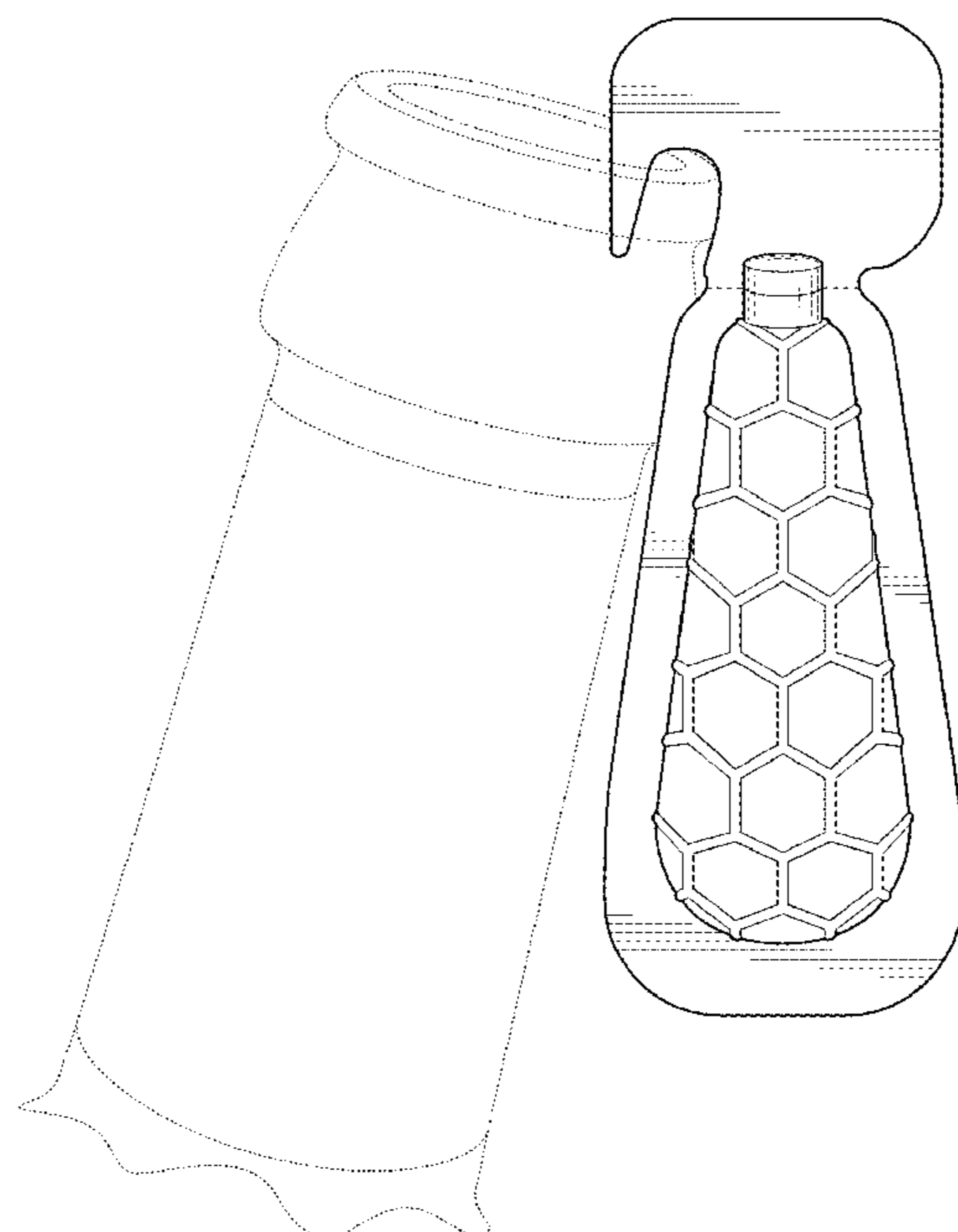

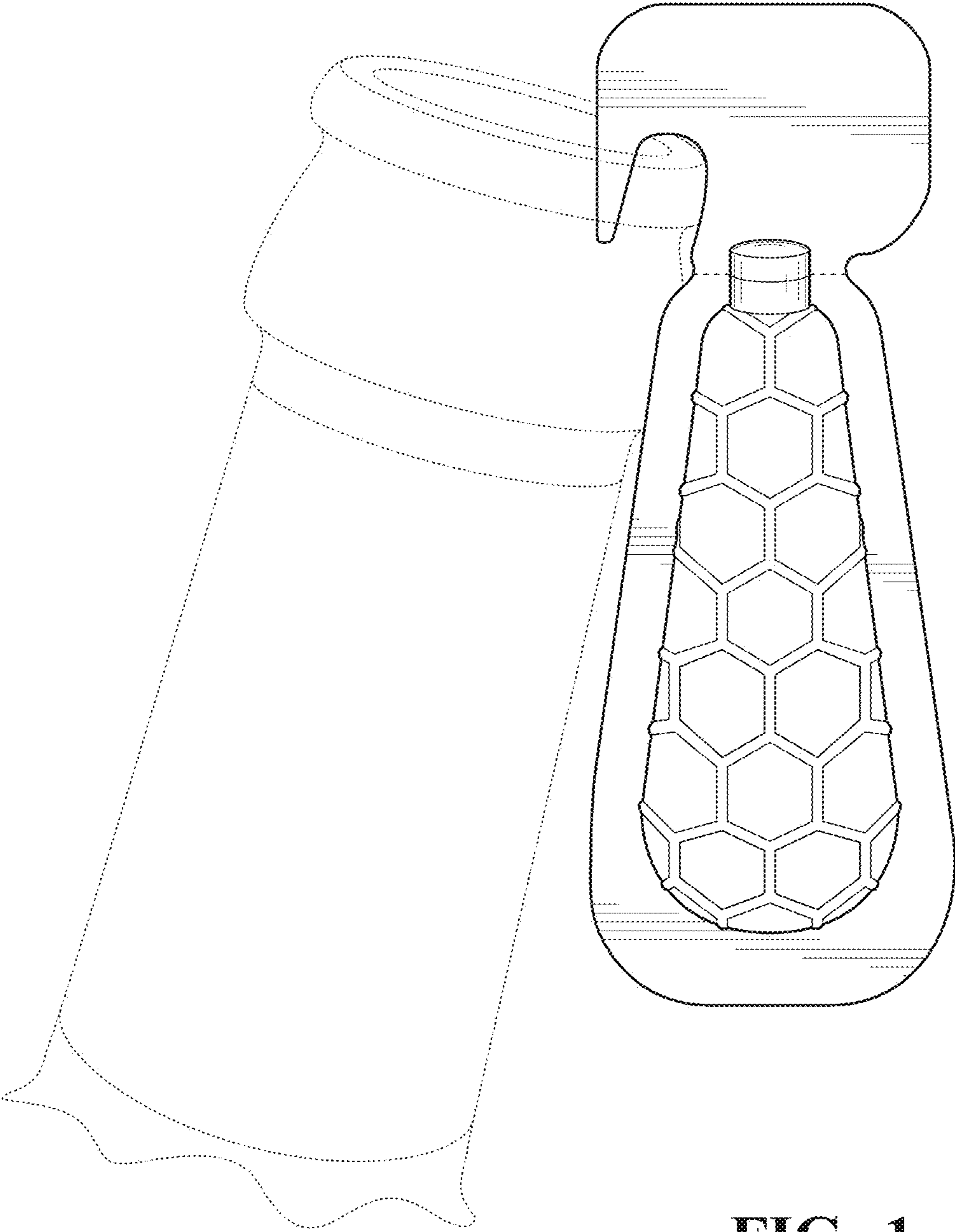

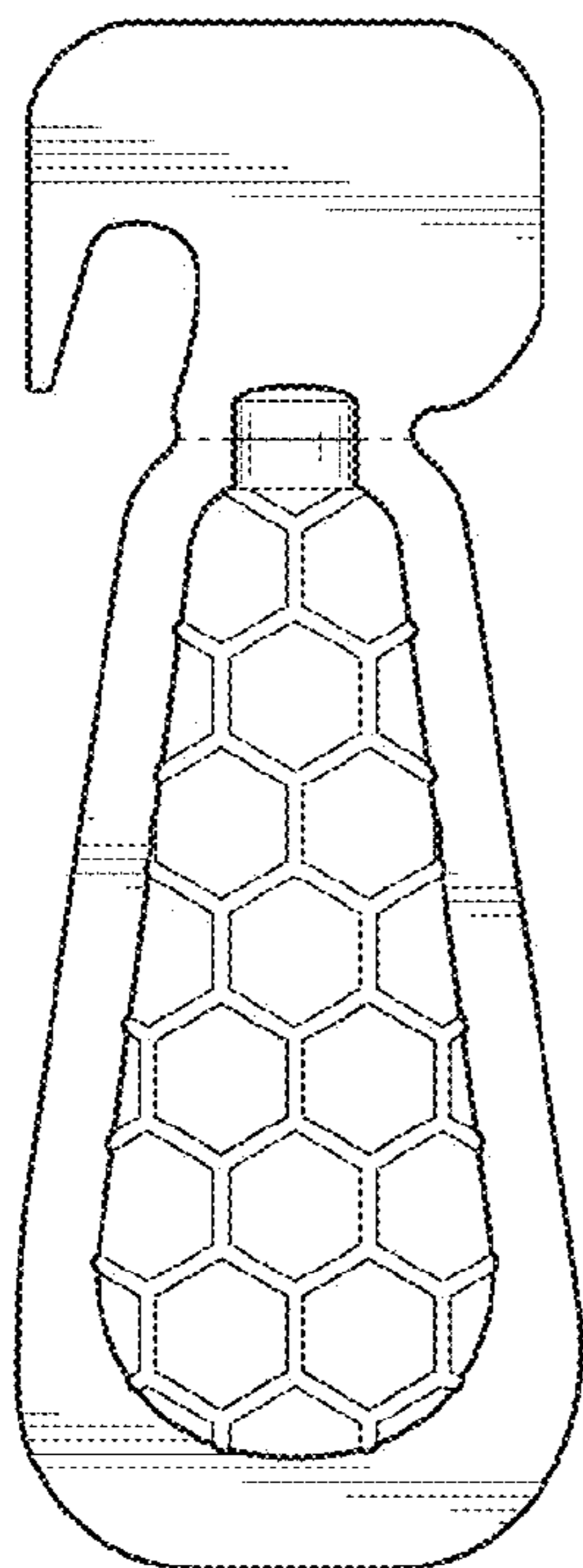

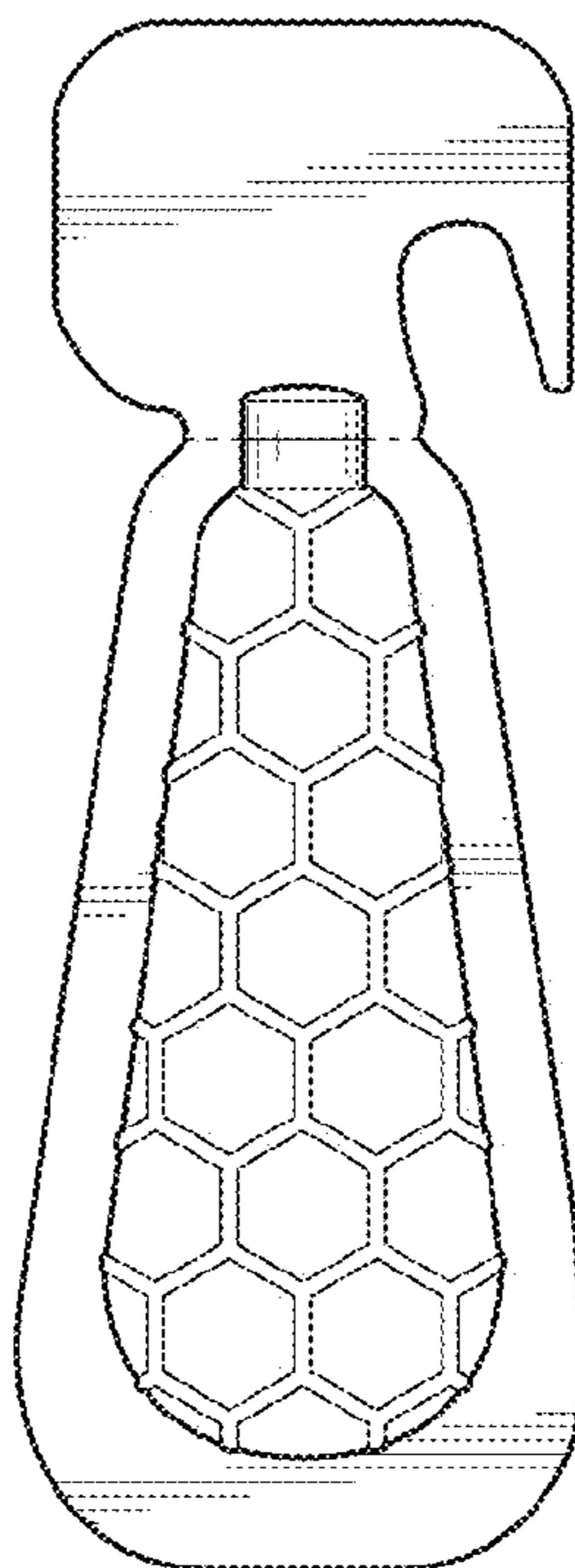

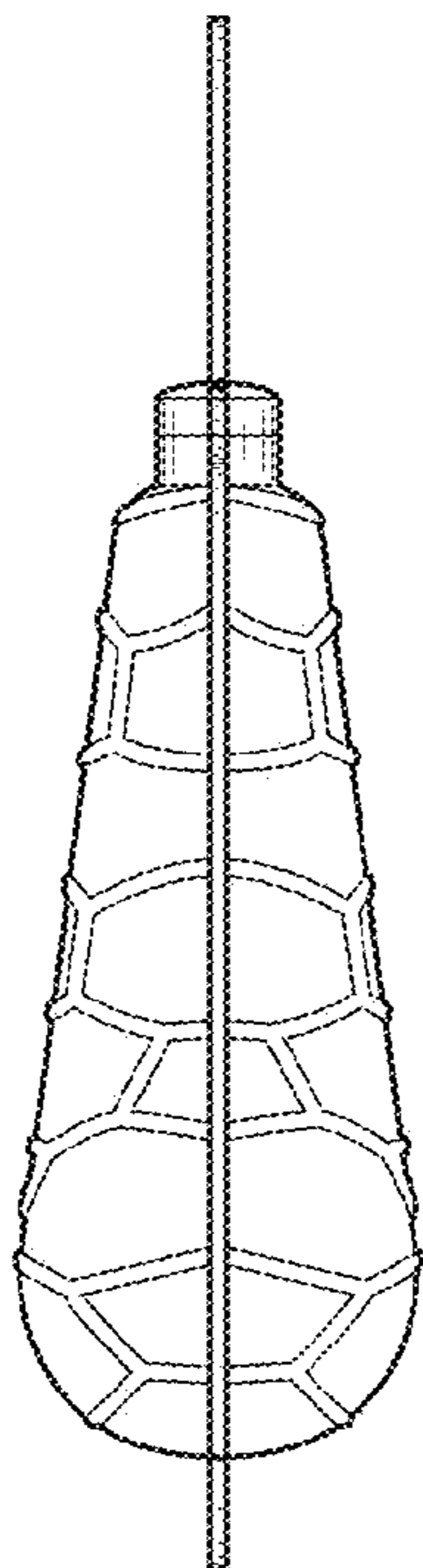

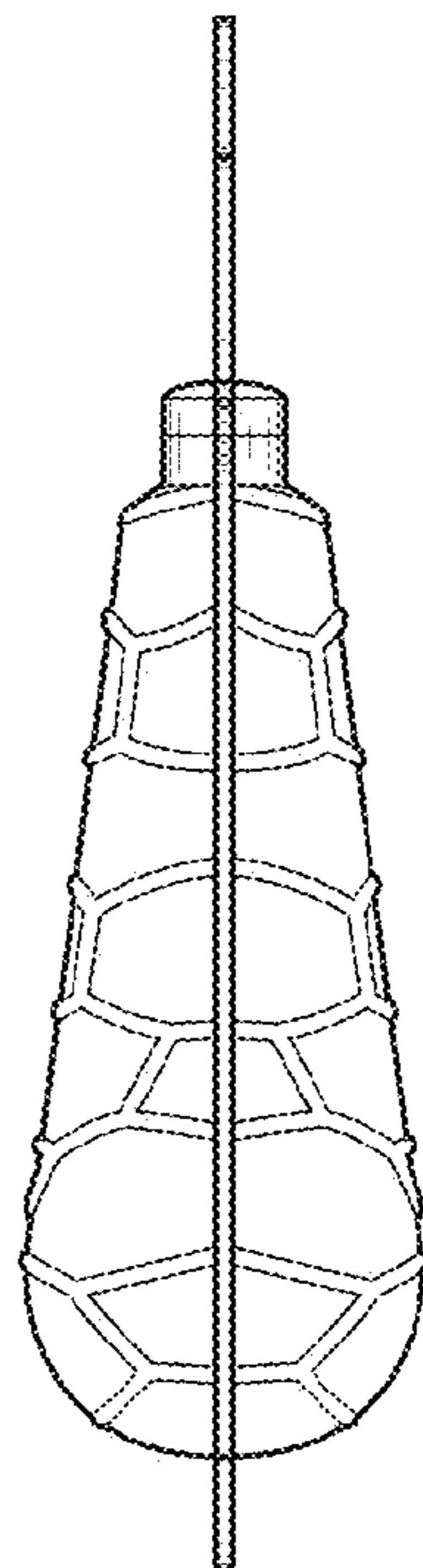
