FIG. 4 is a rear perspective view thereof;

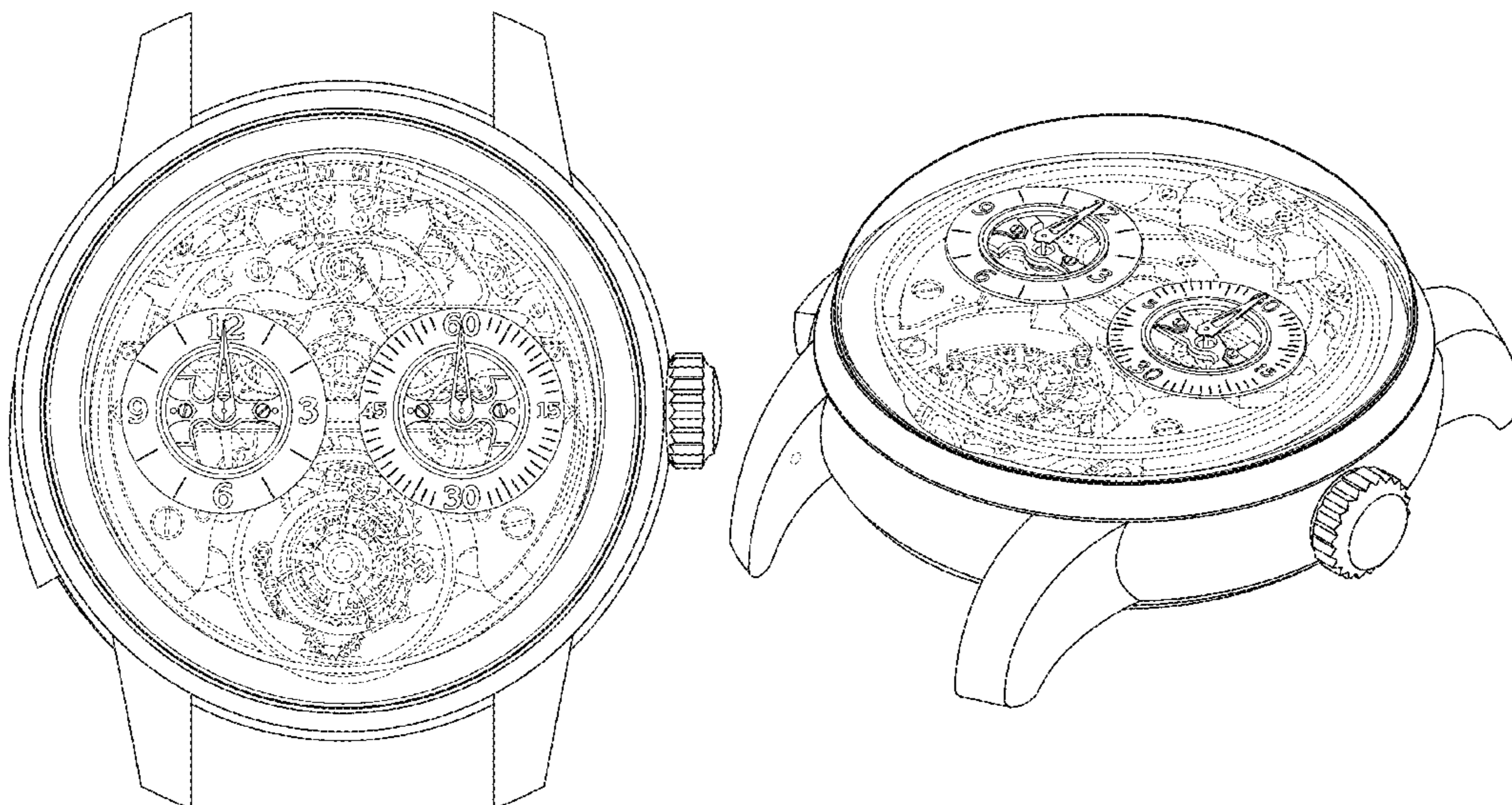
FIG. 5 is a rear view thereof;

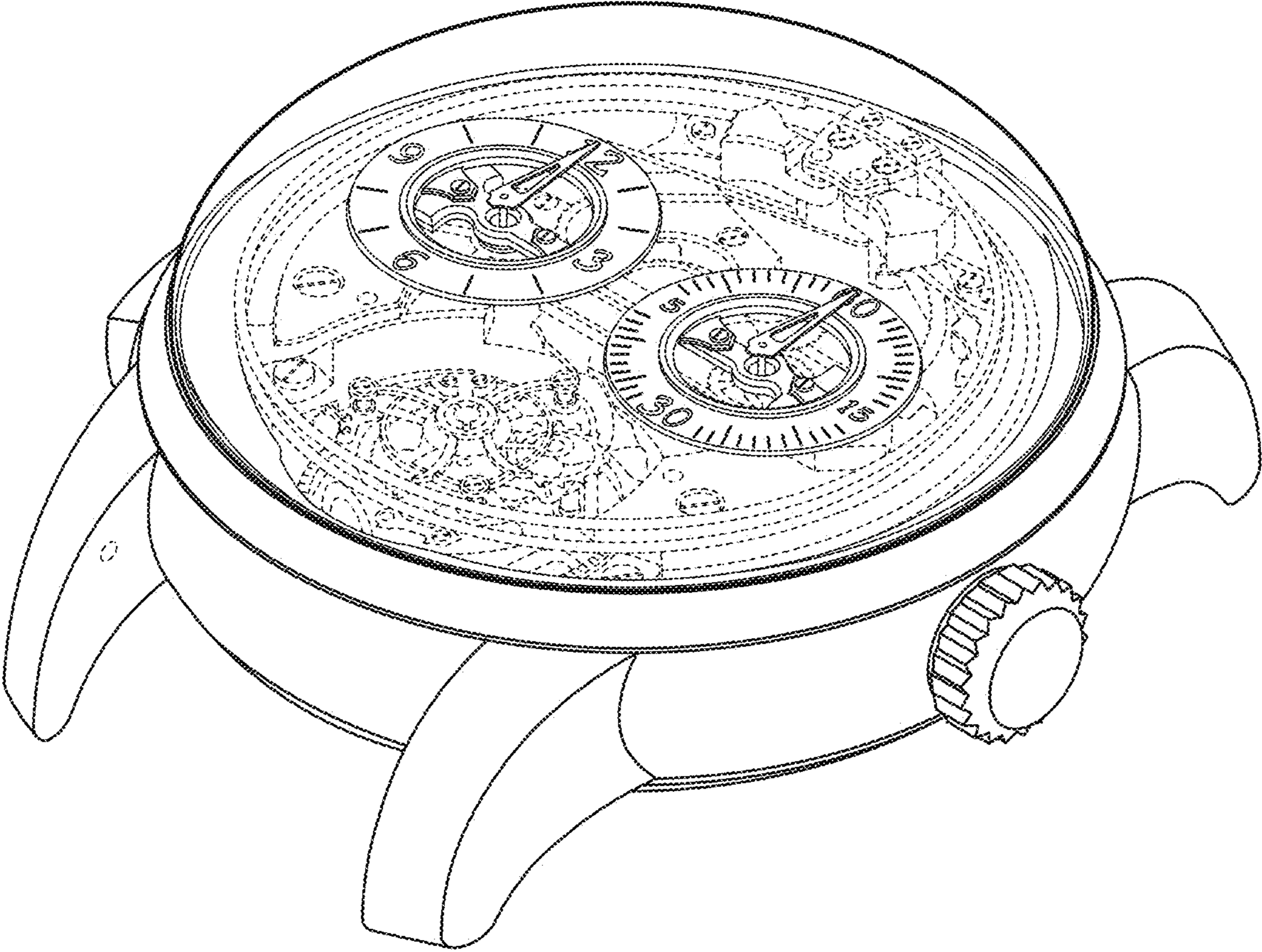

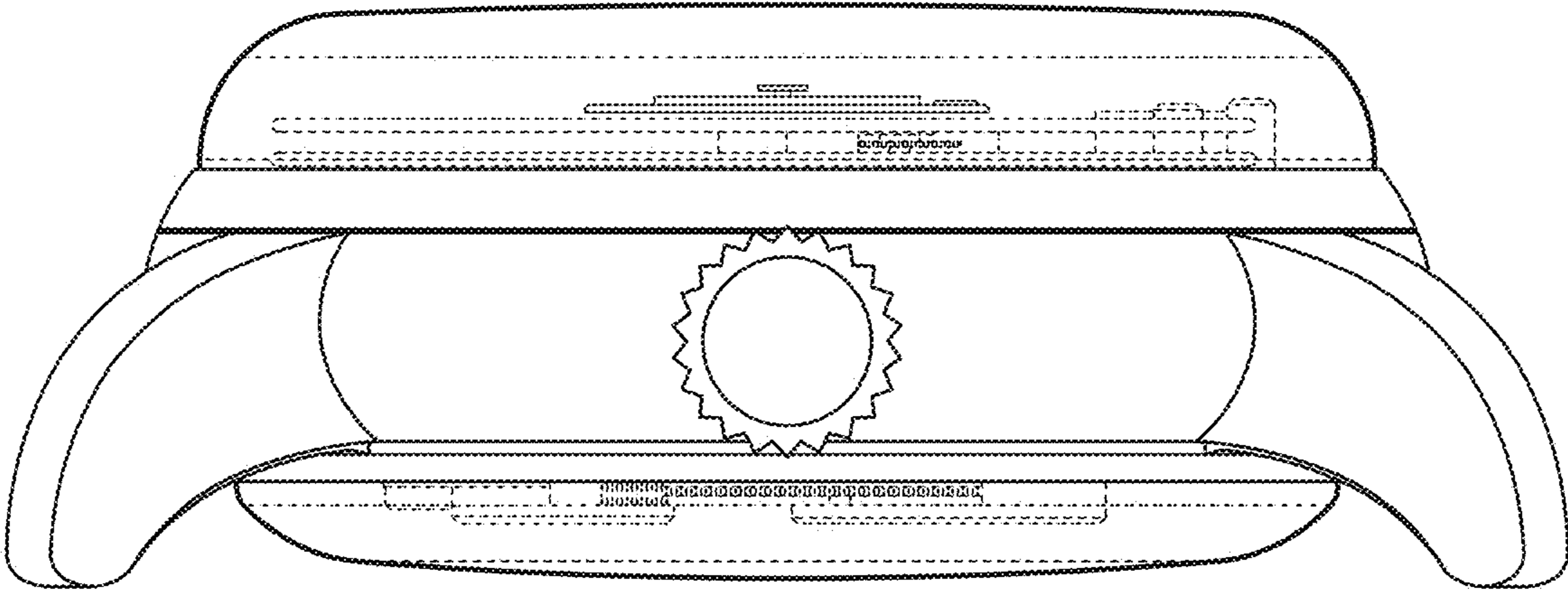

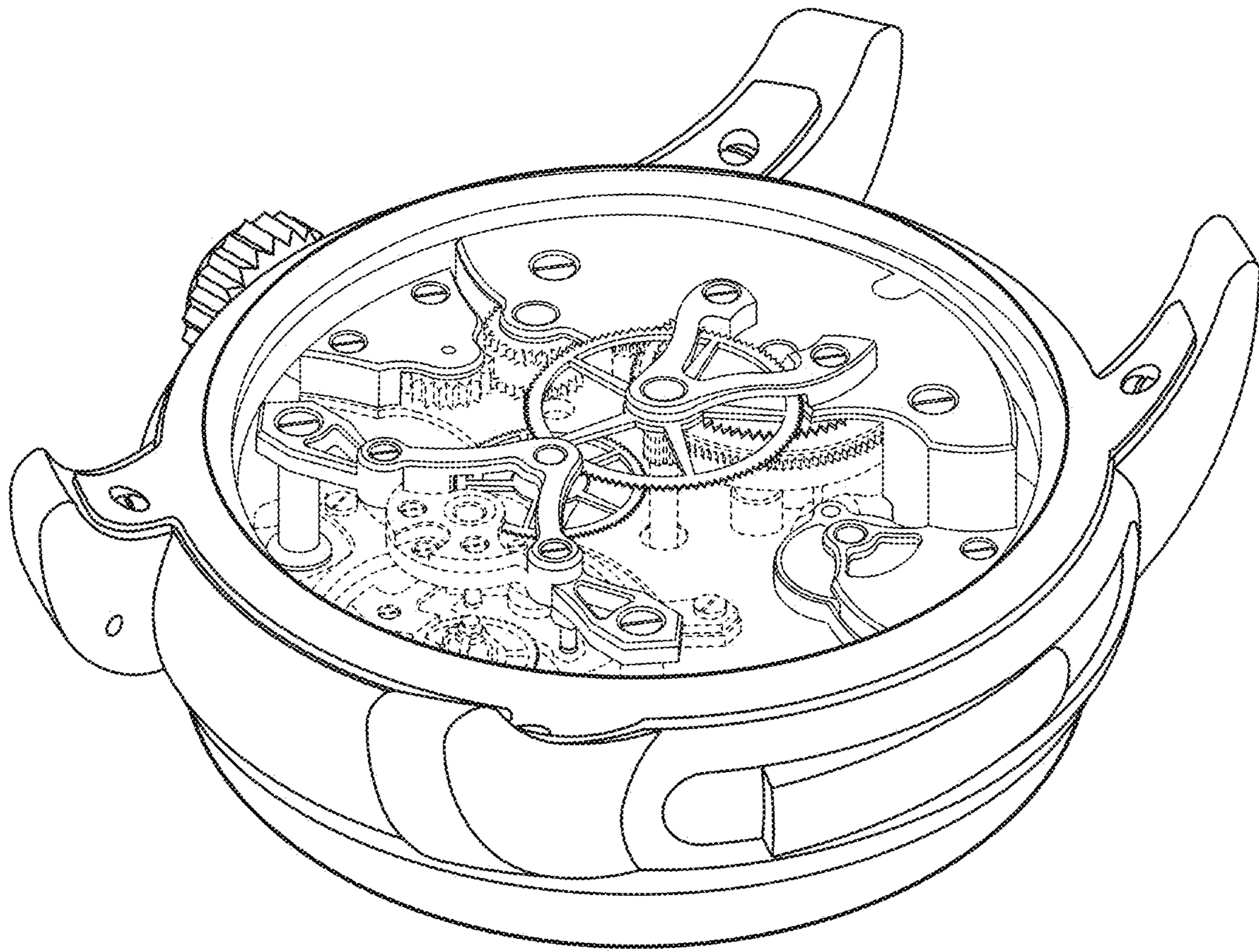

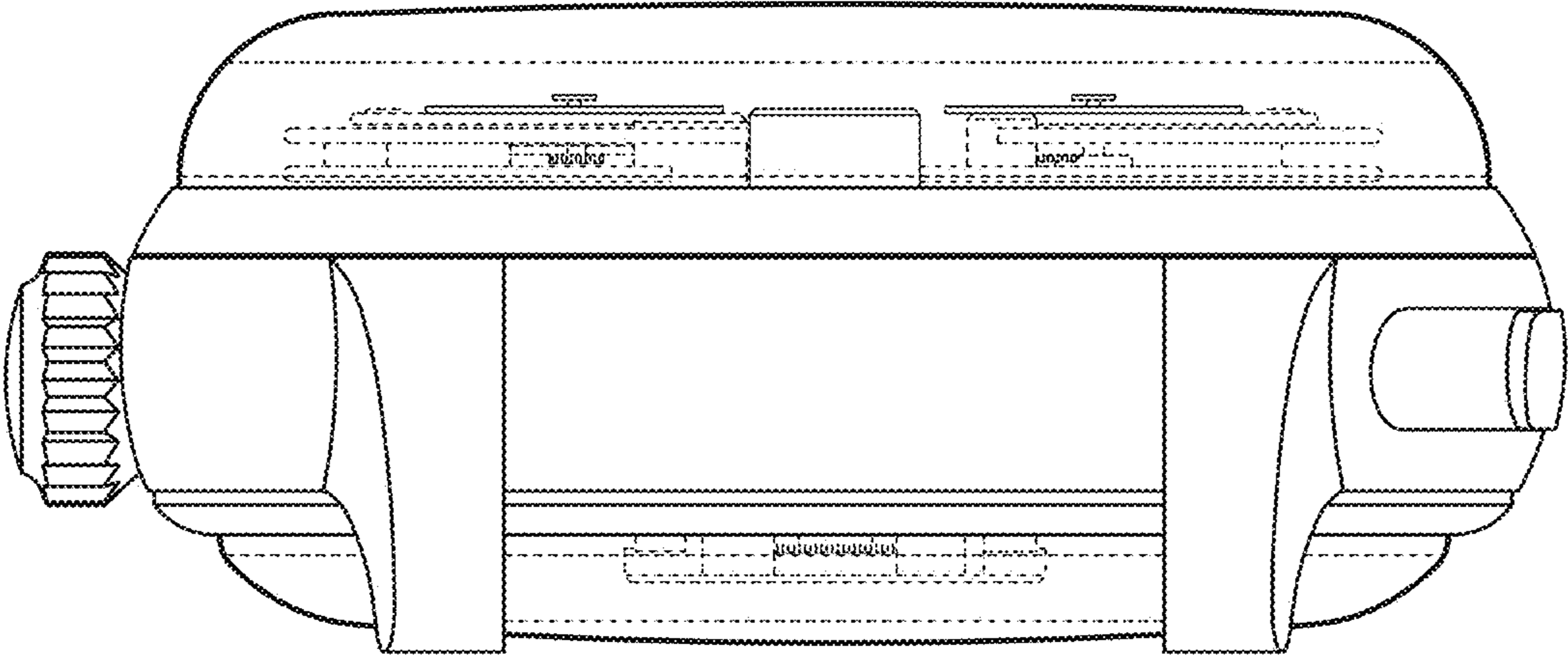

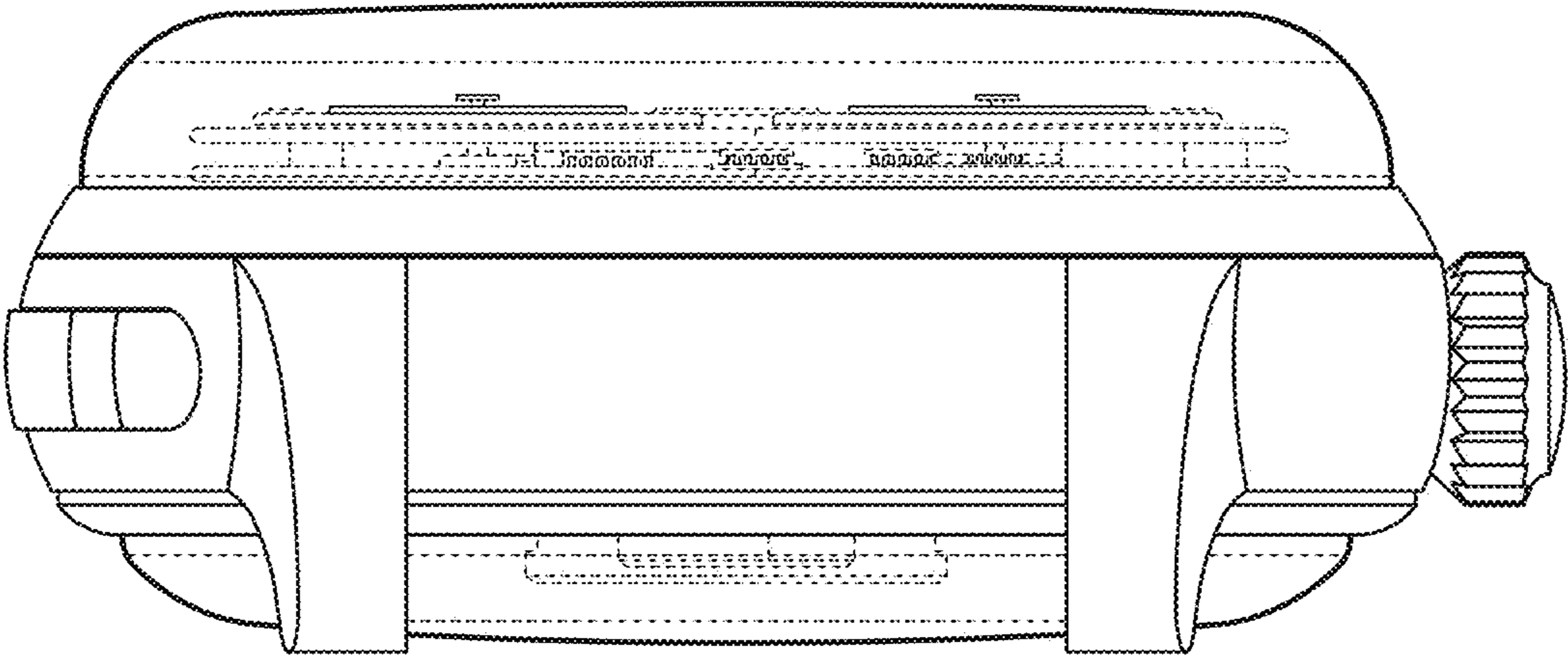
