FIG. 29 is a side view thereof.

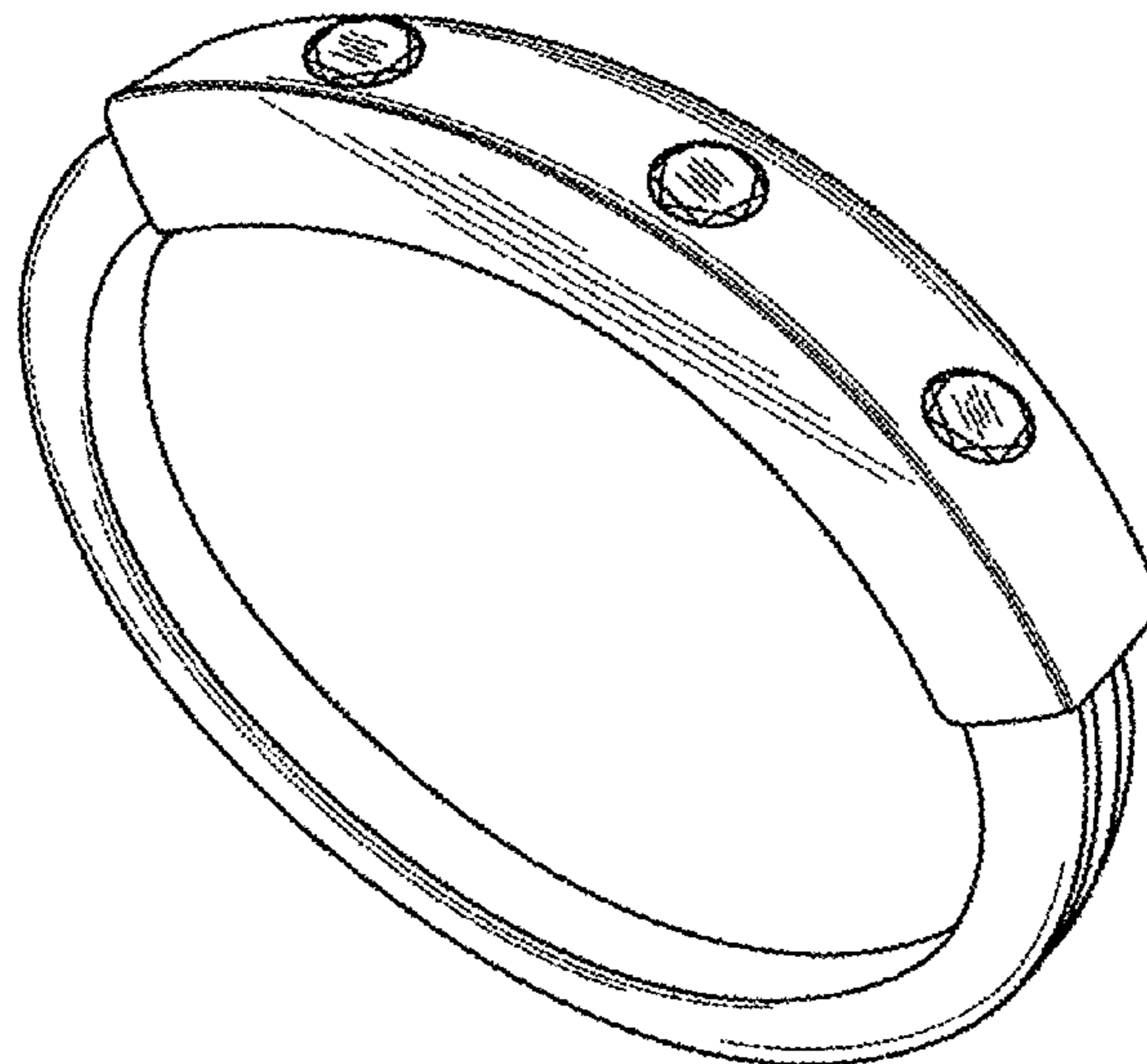

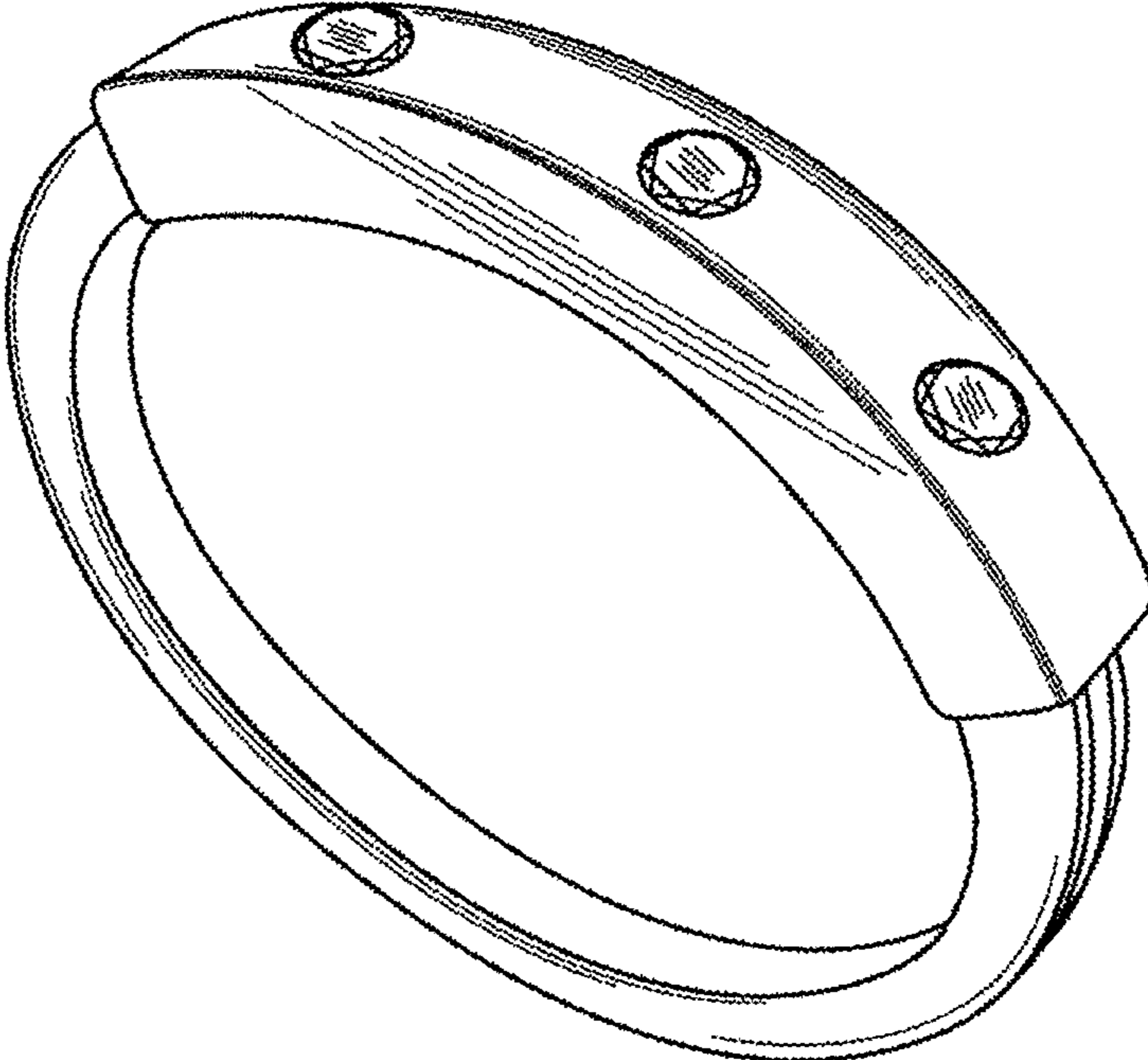

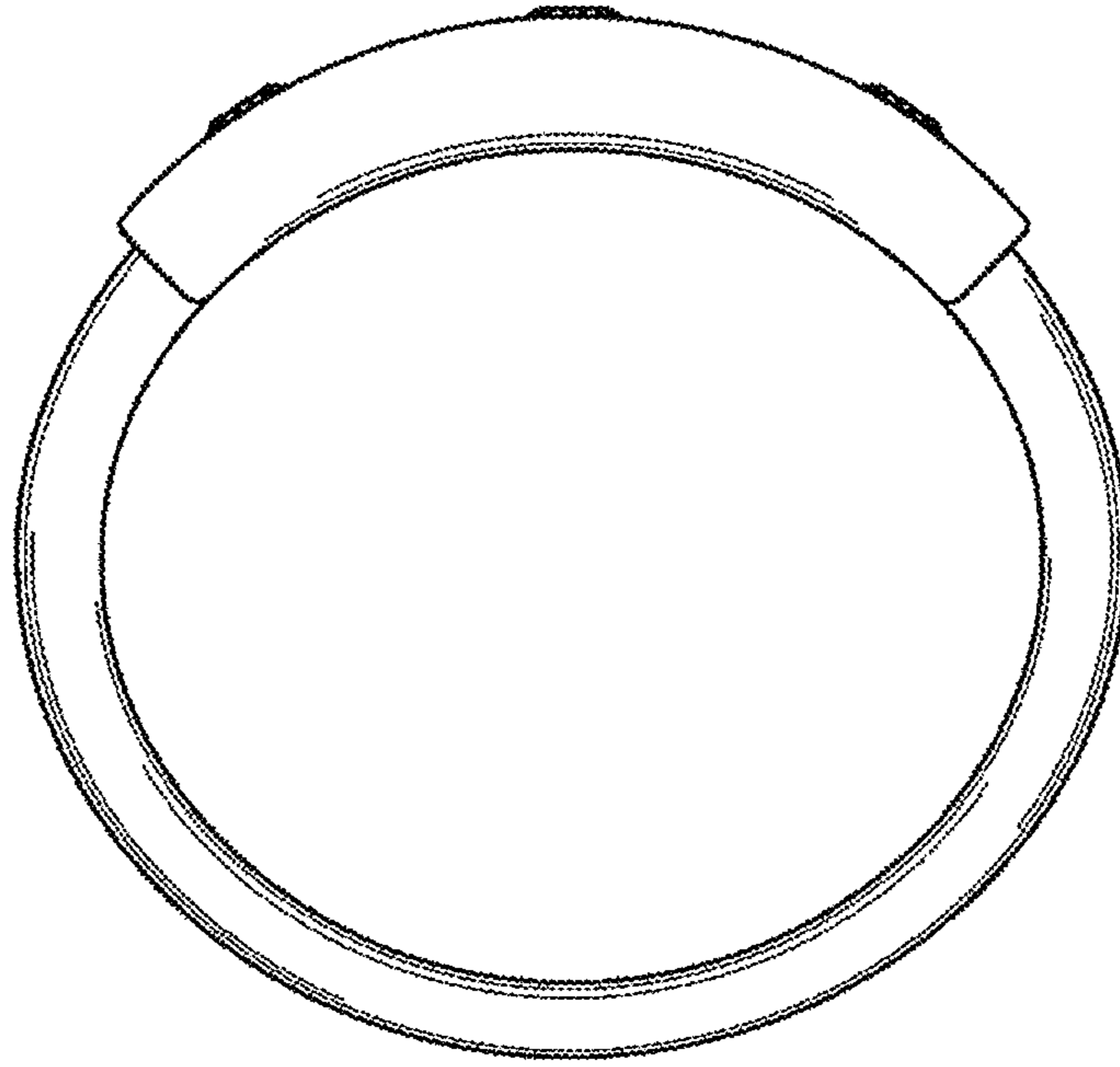

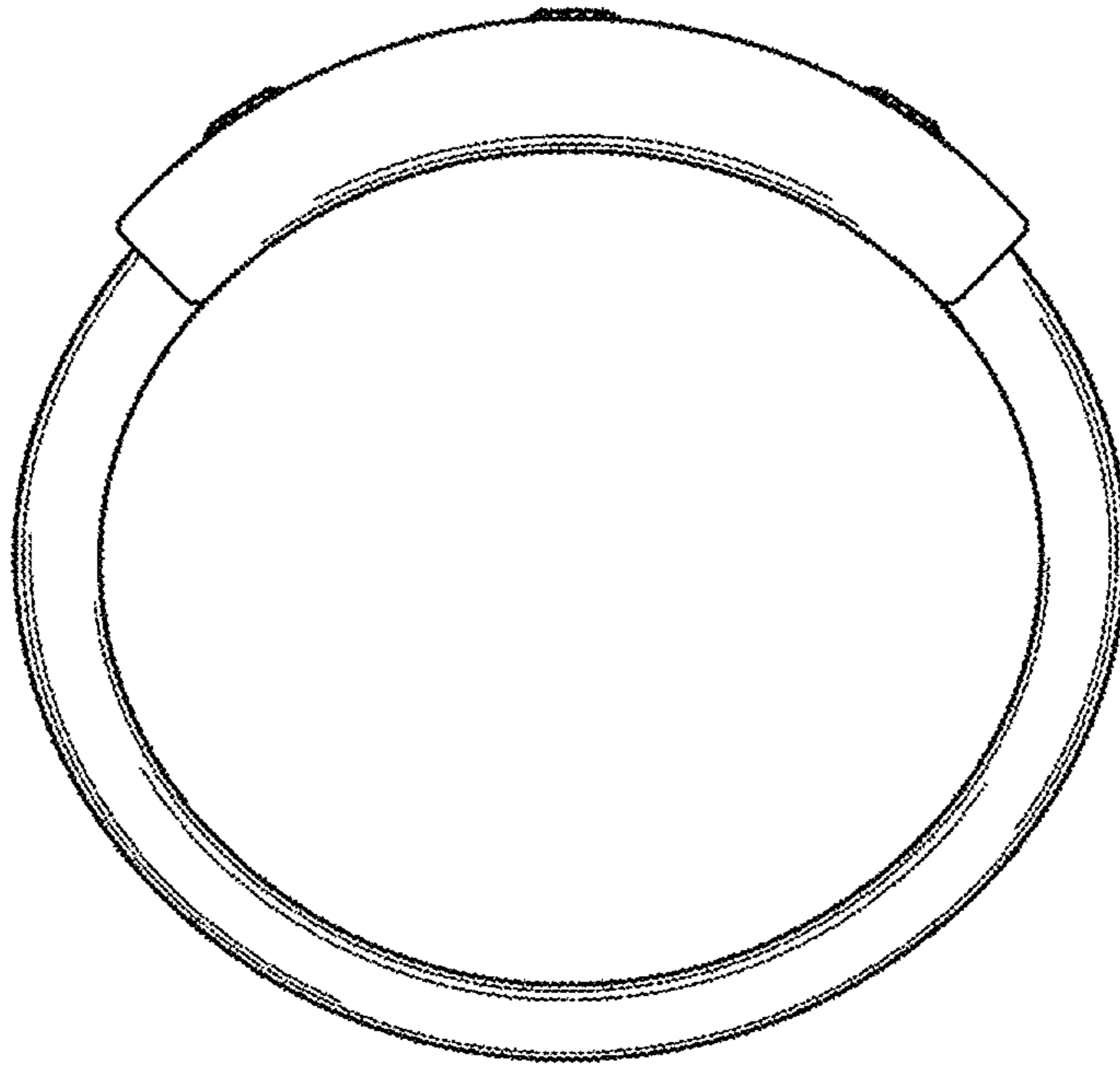

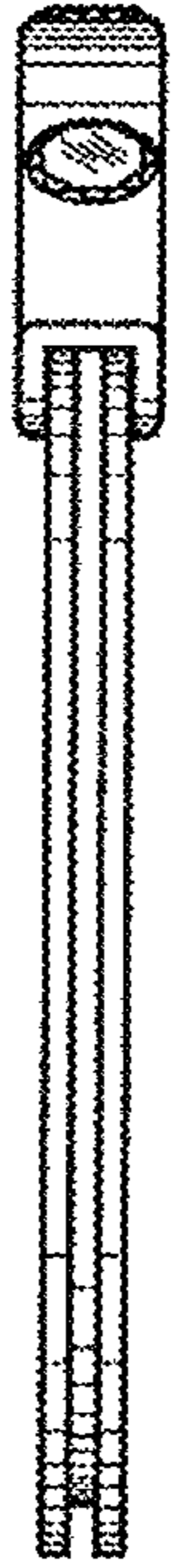

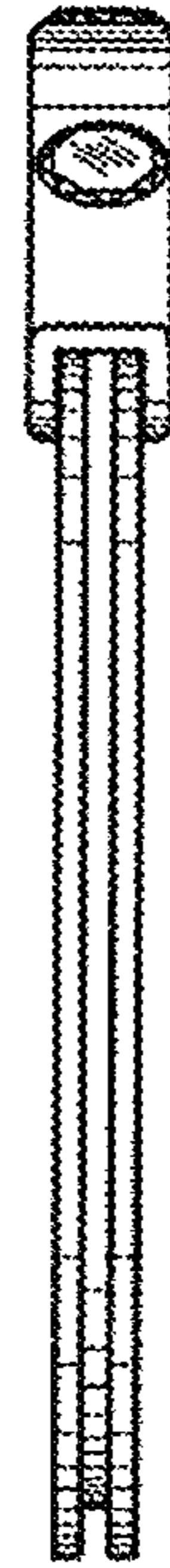

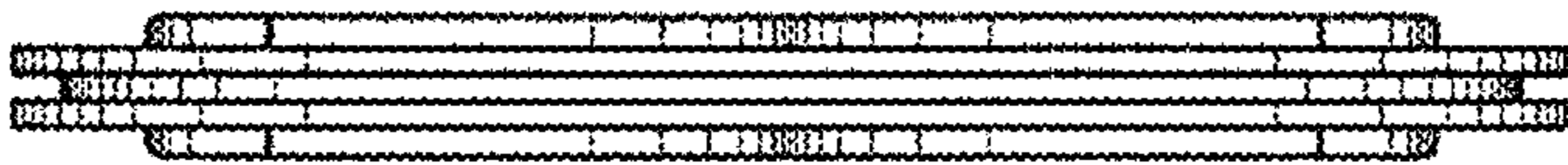

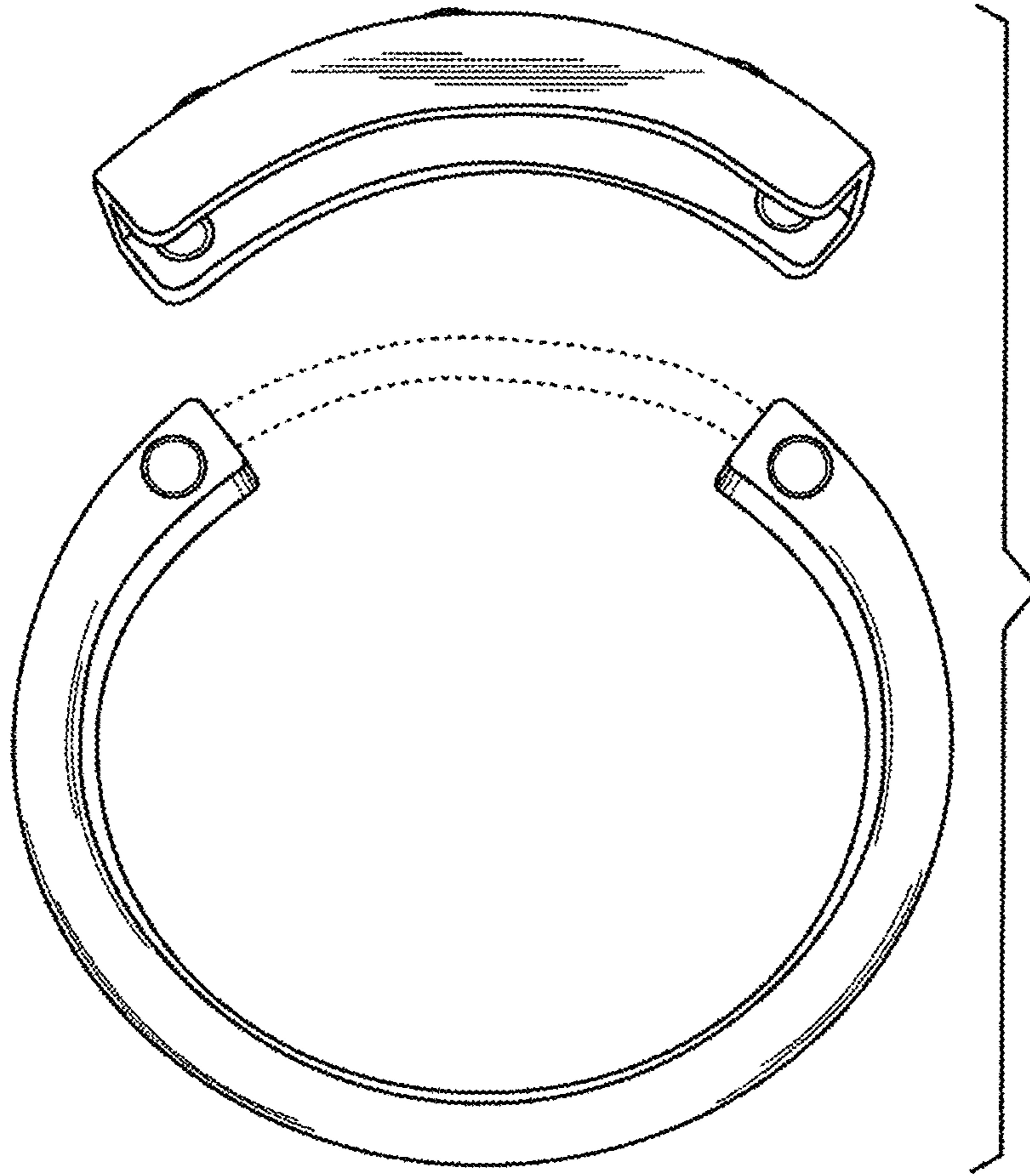

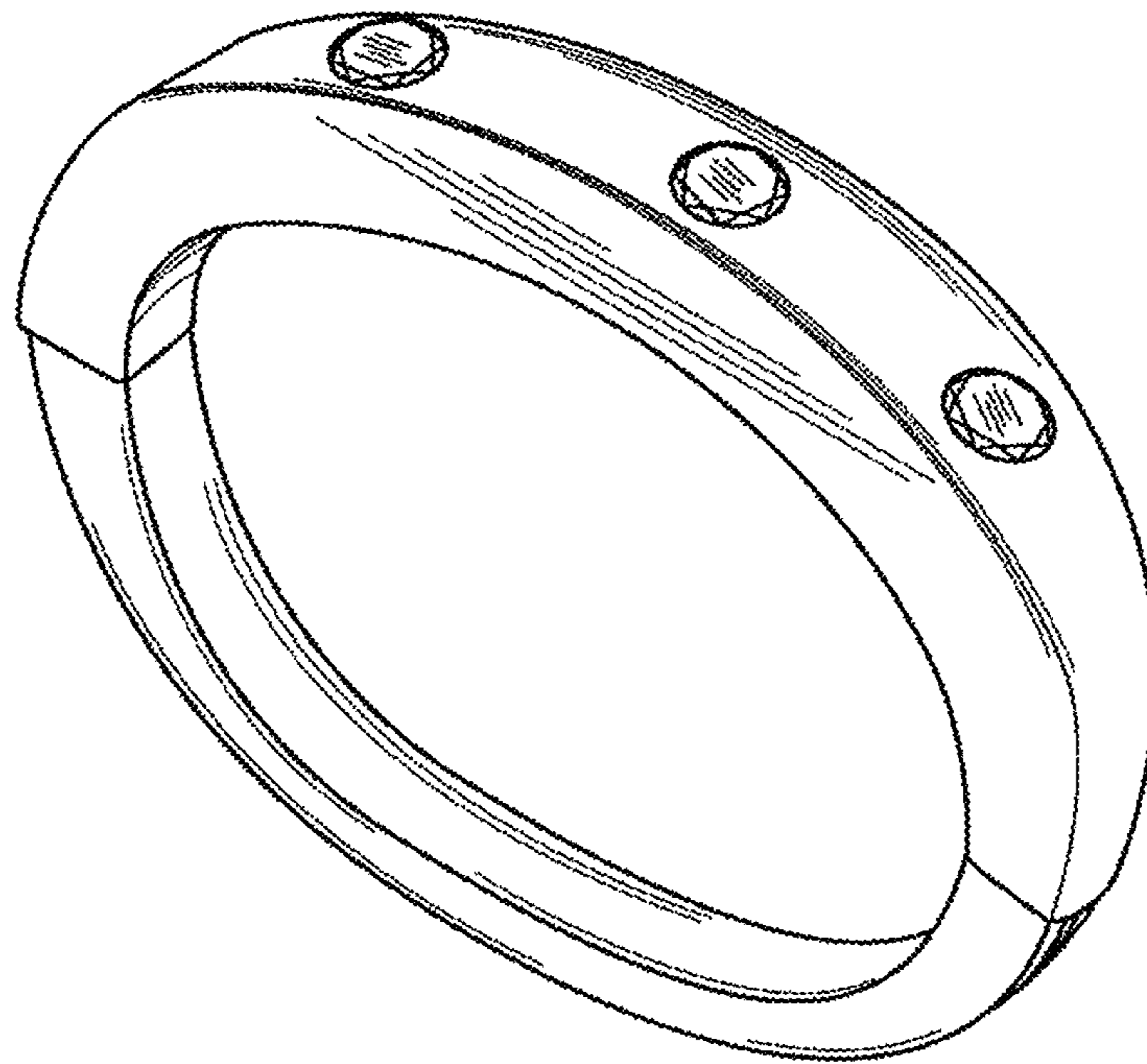

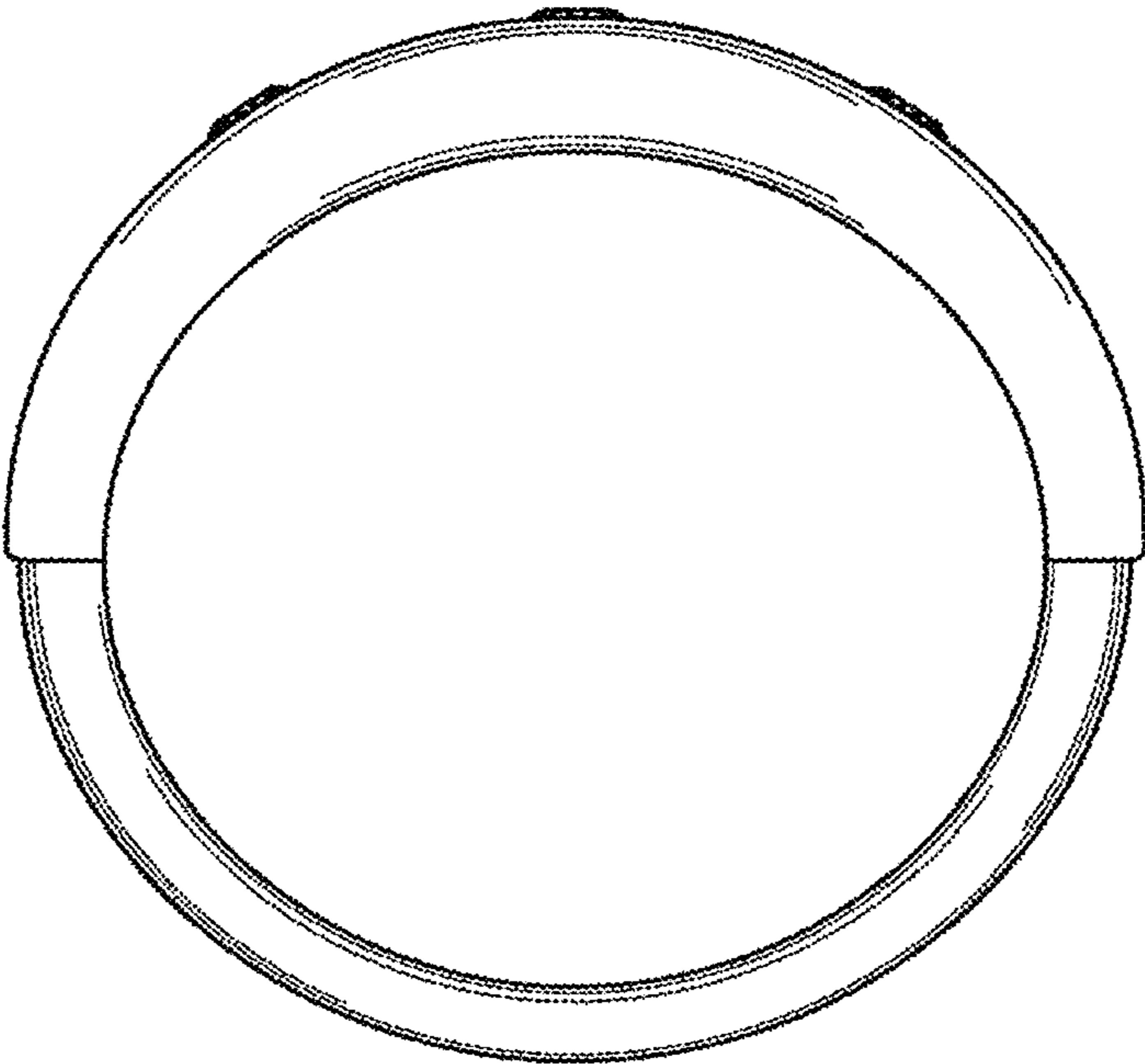

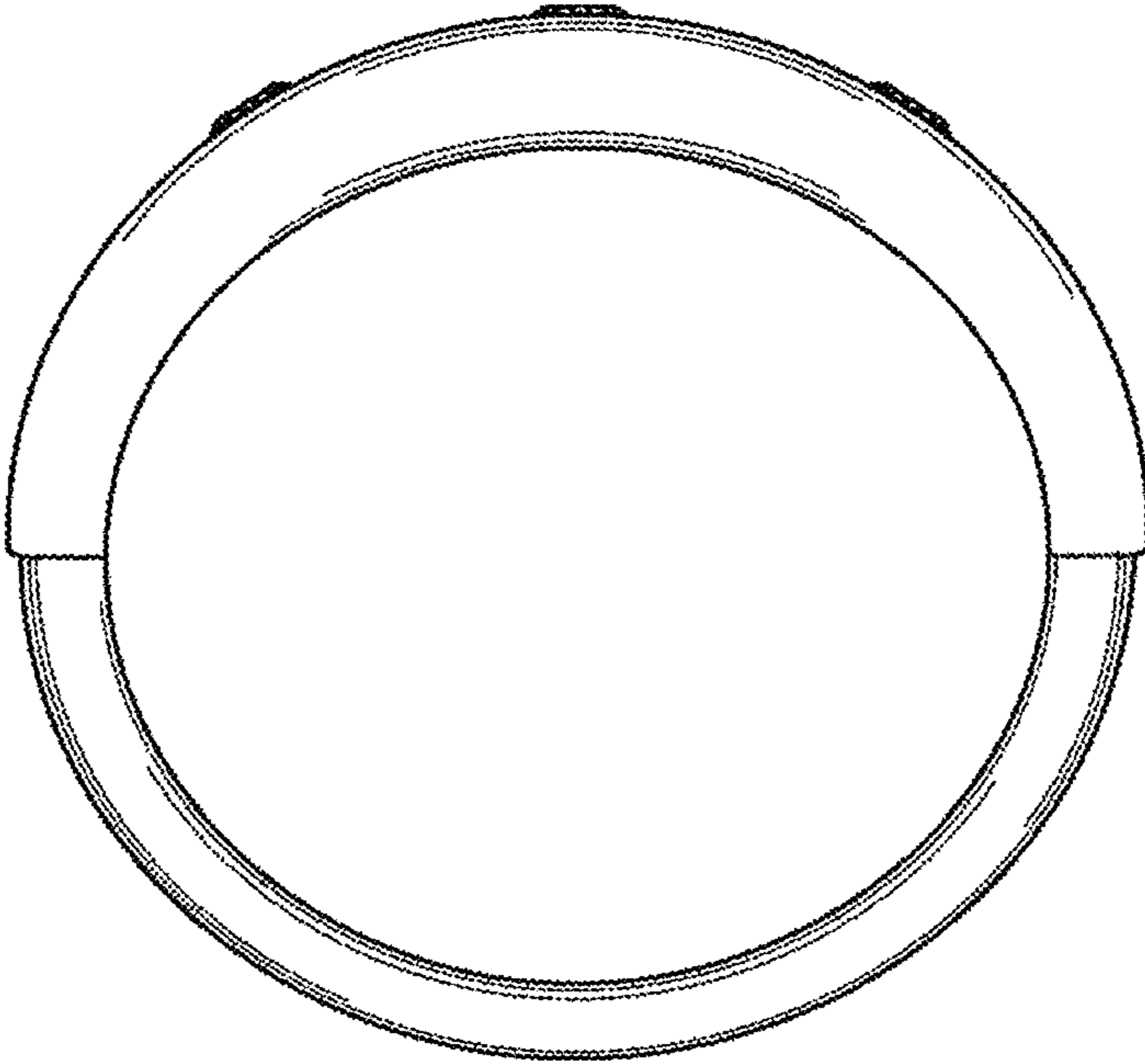

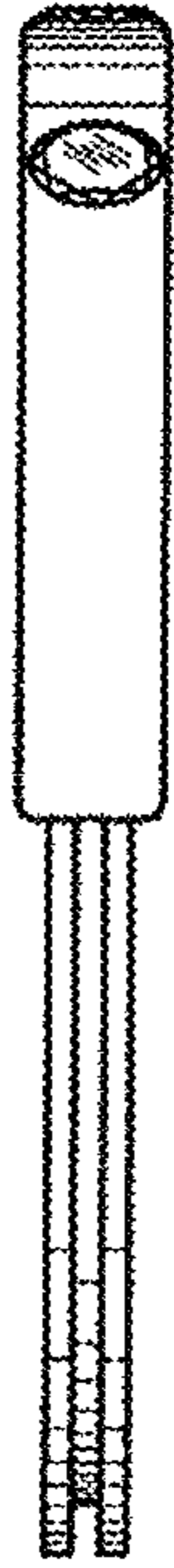

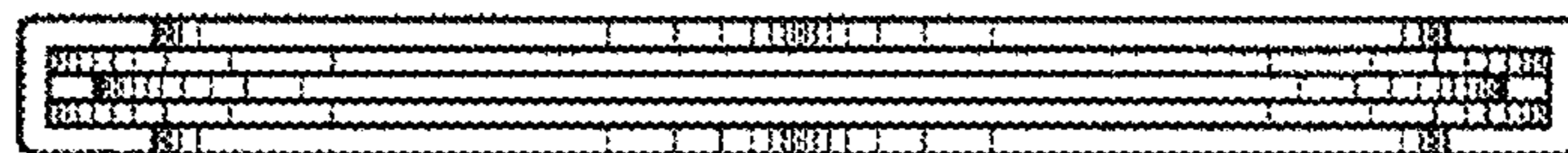

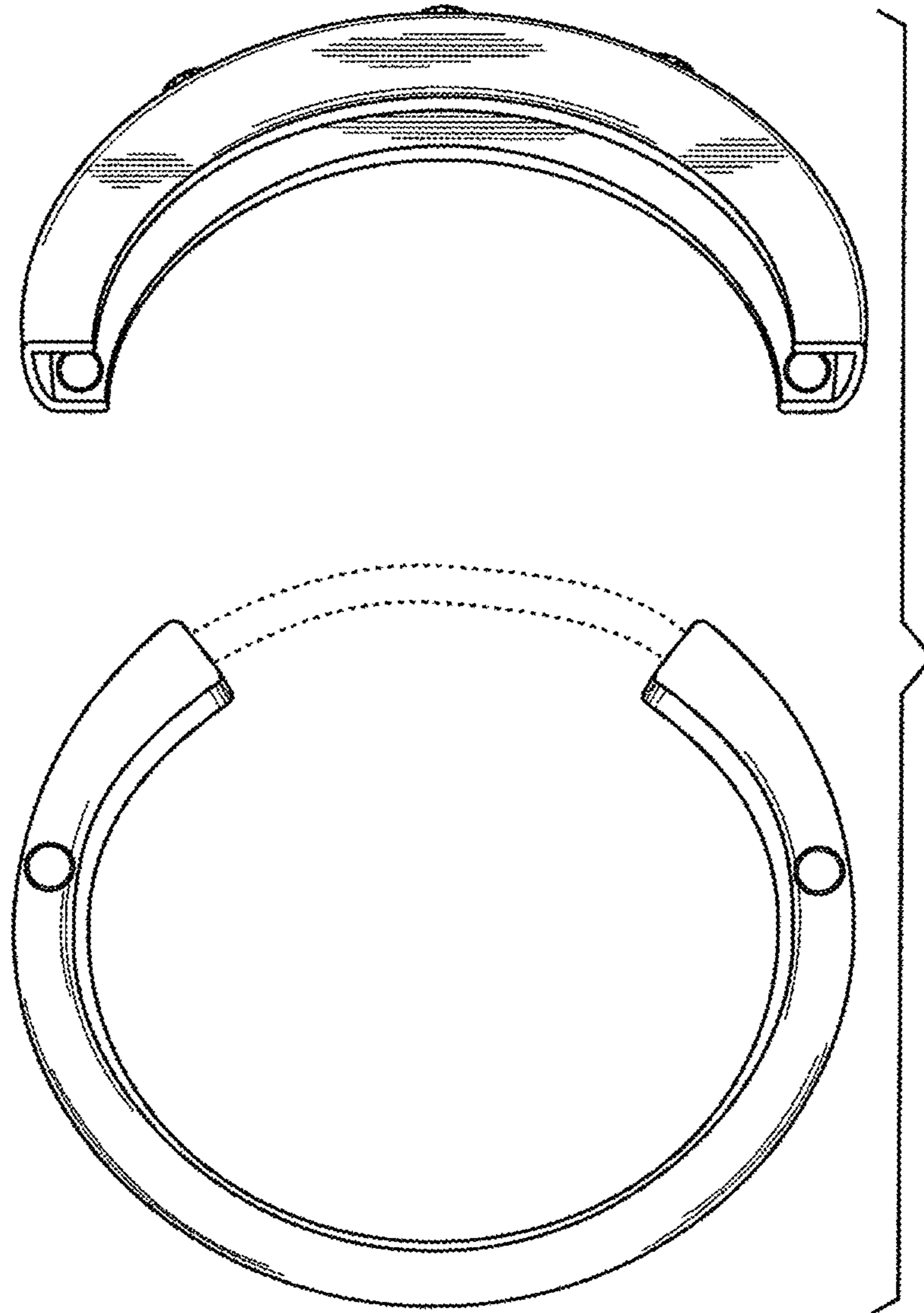

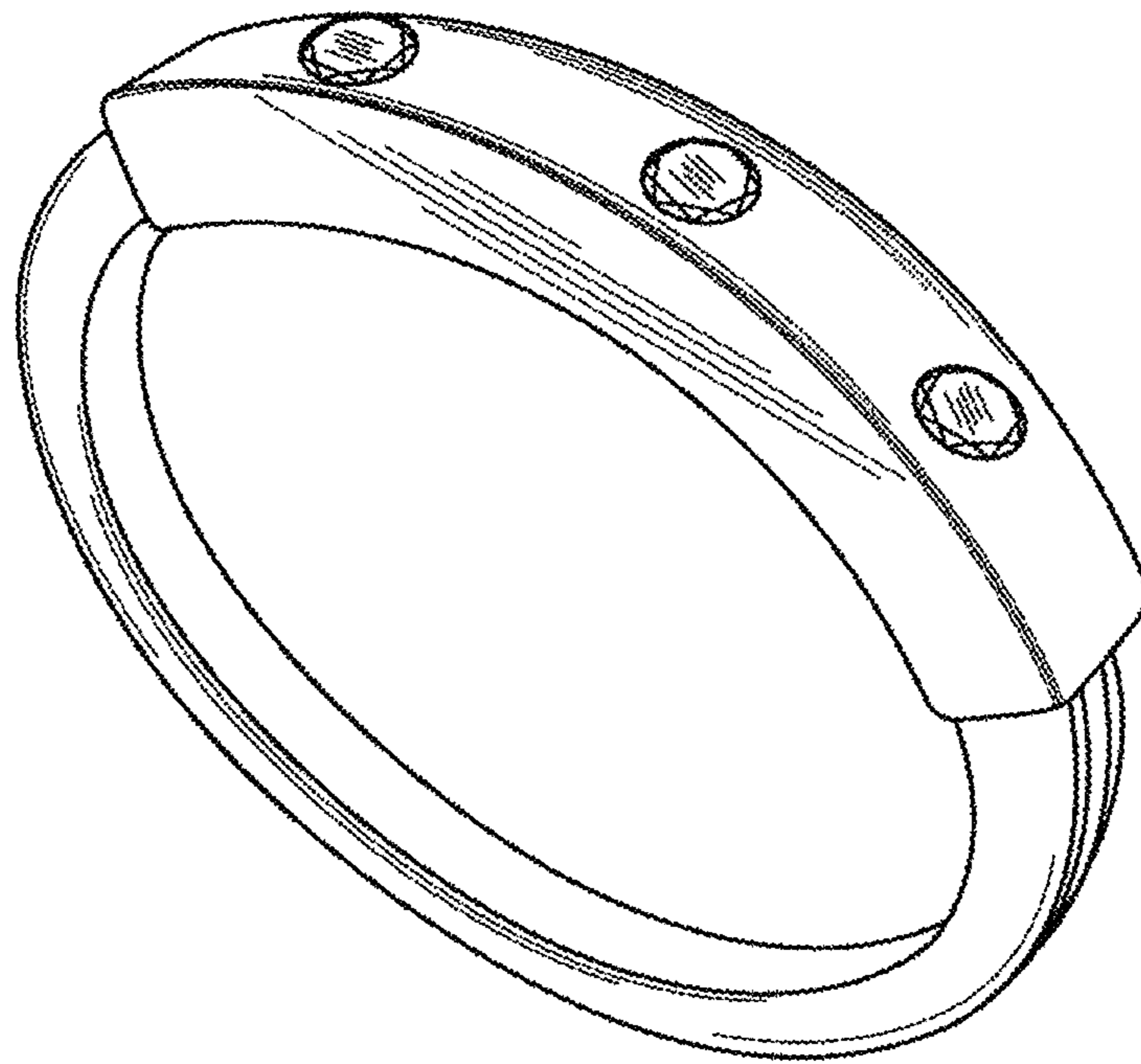

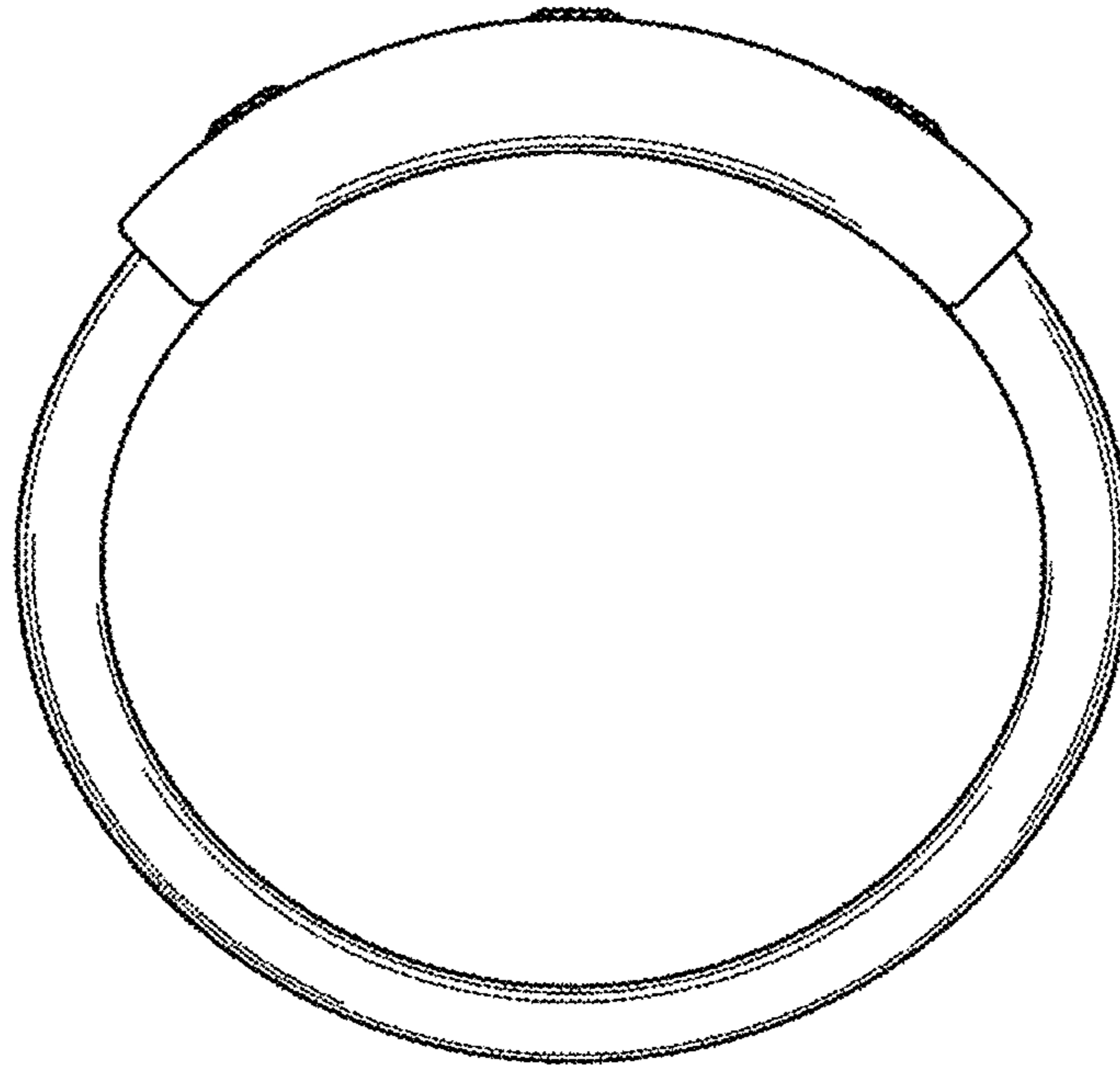

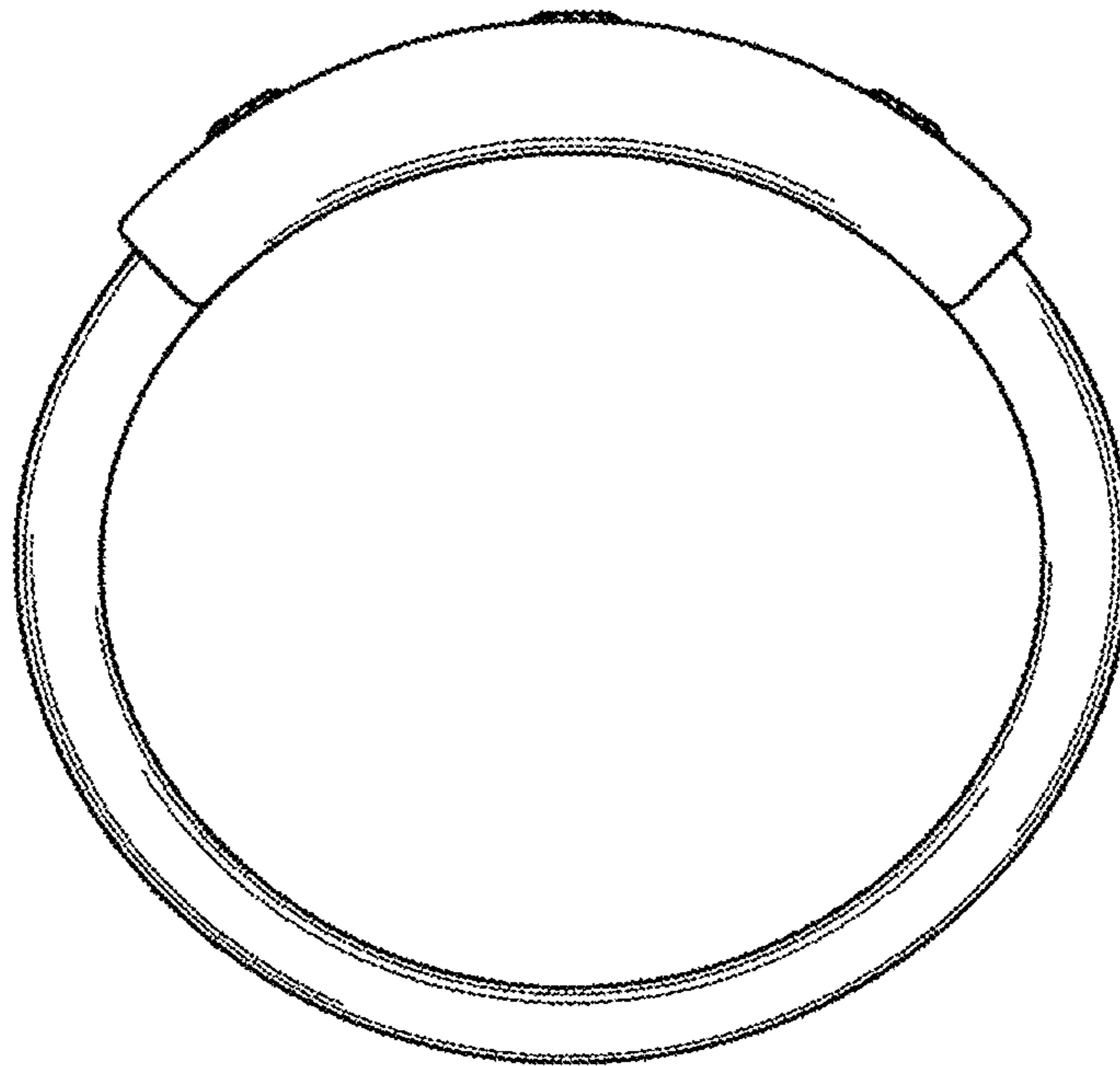

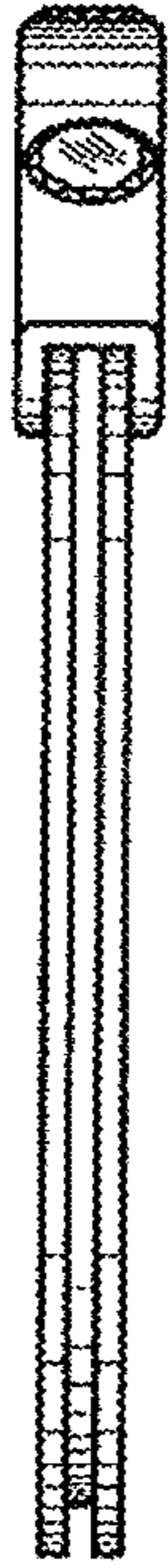

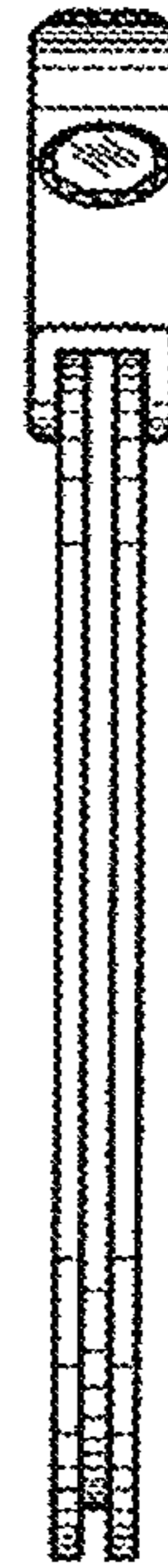

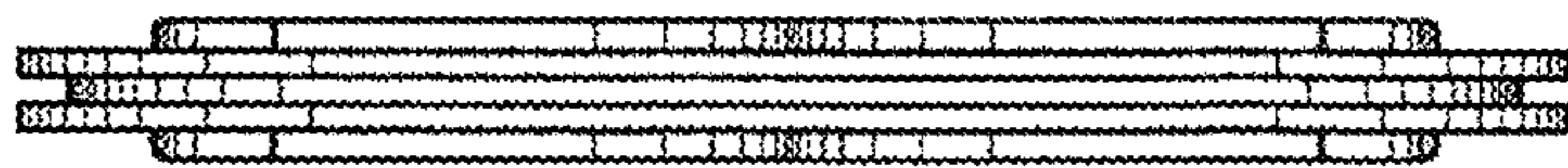

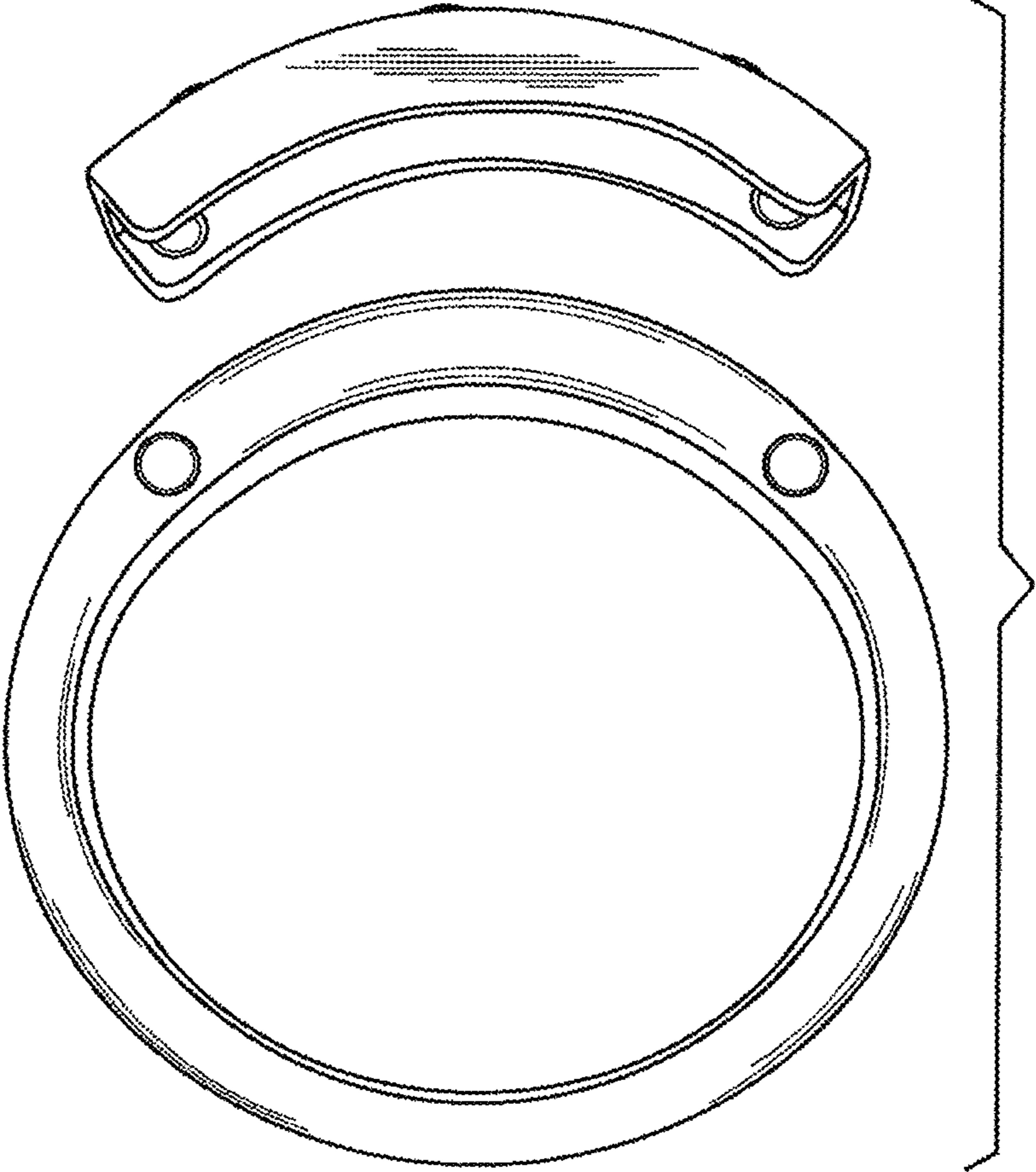

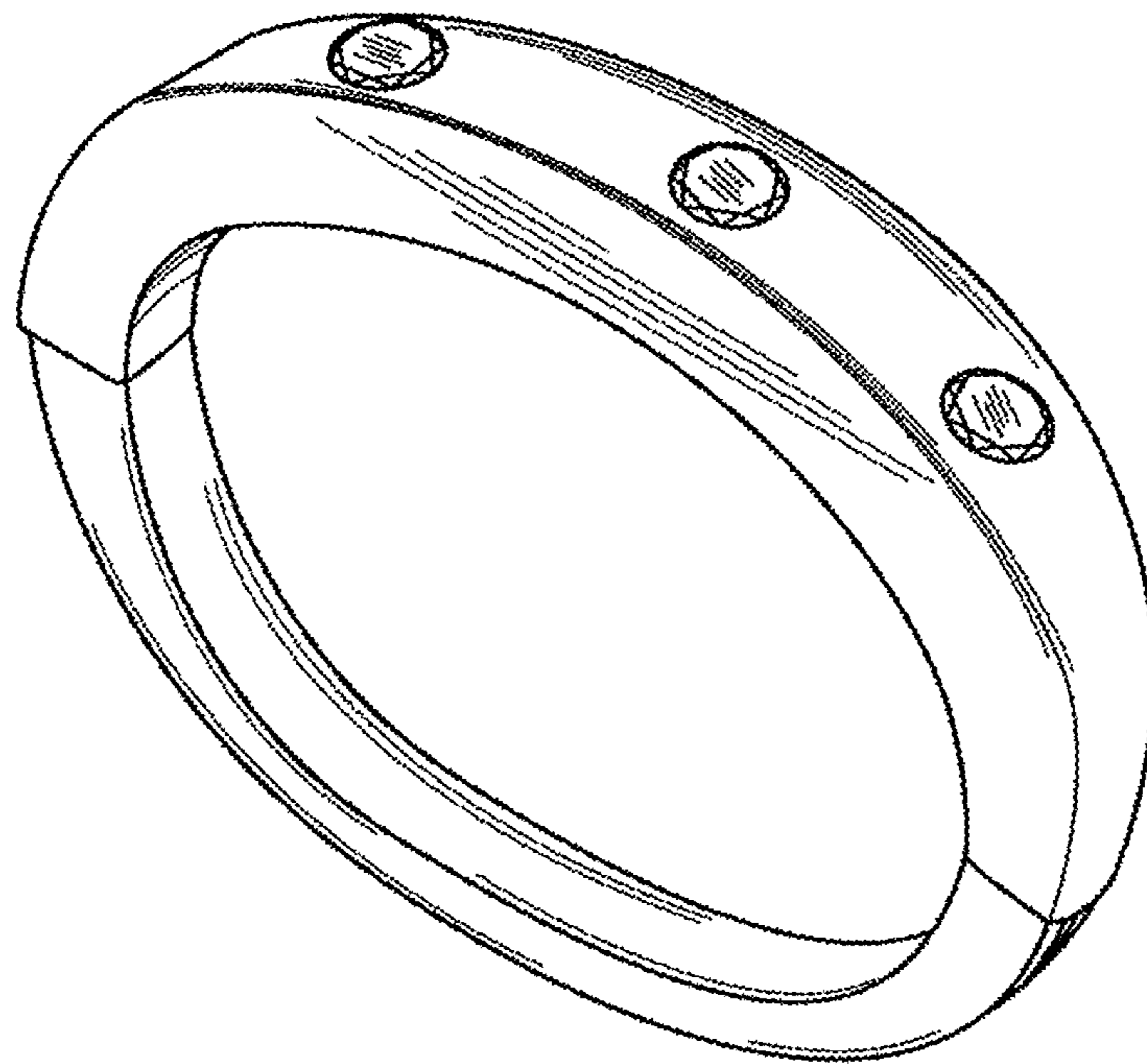

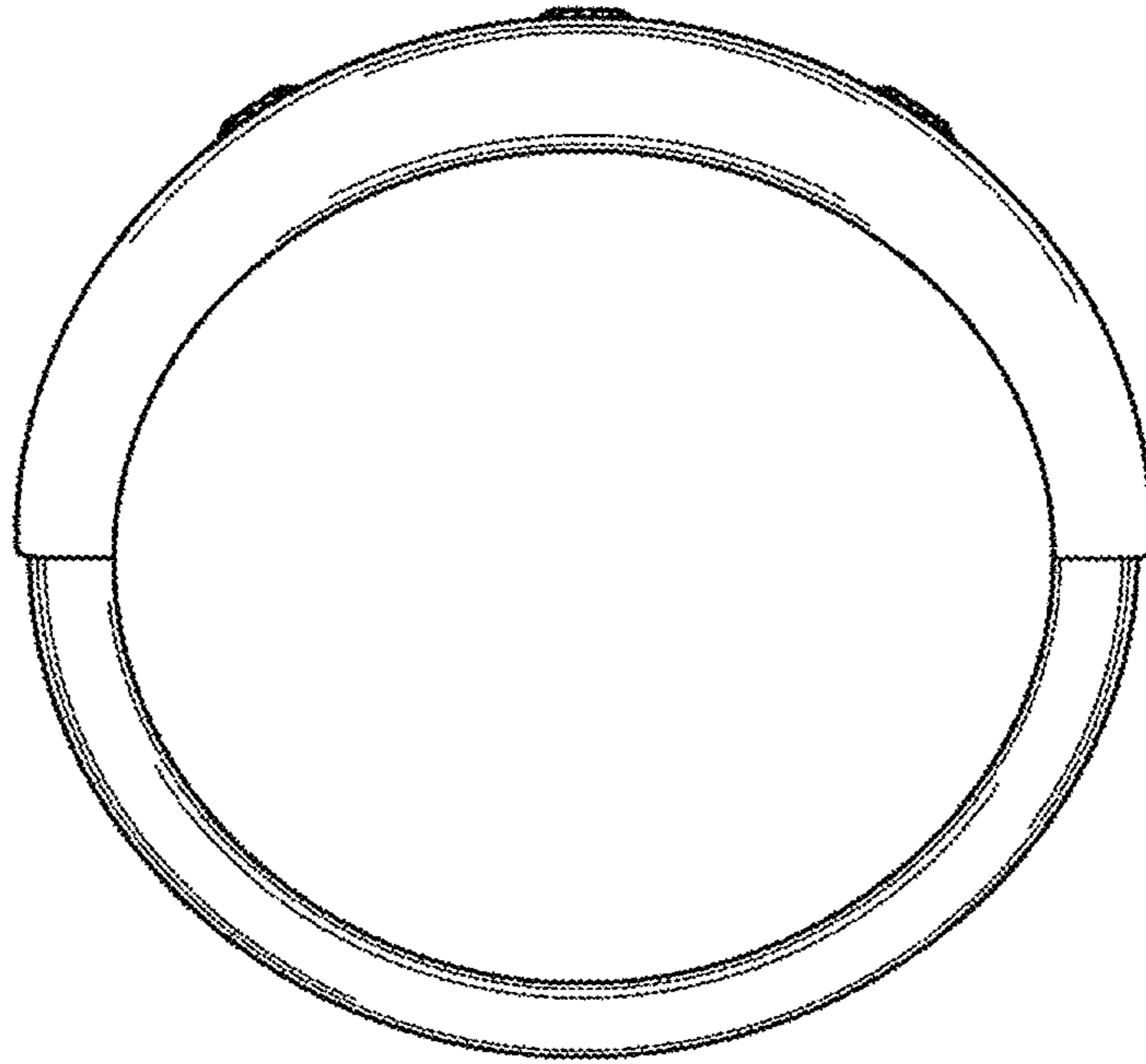

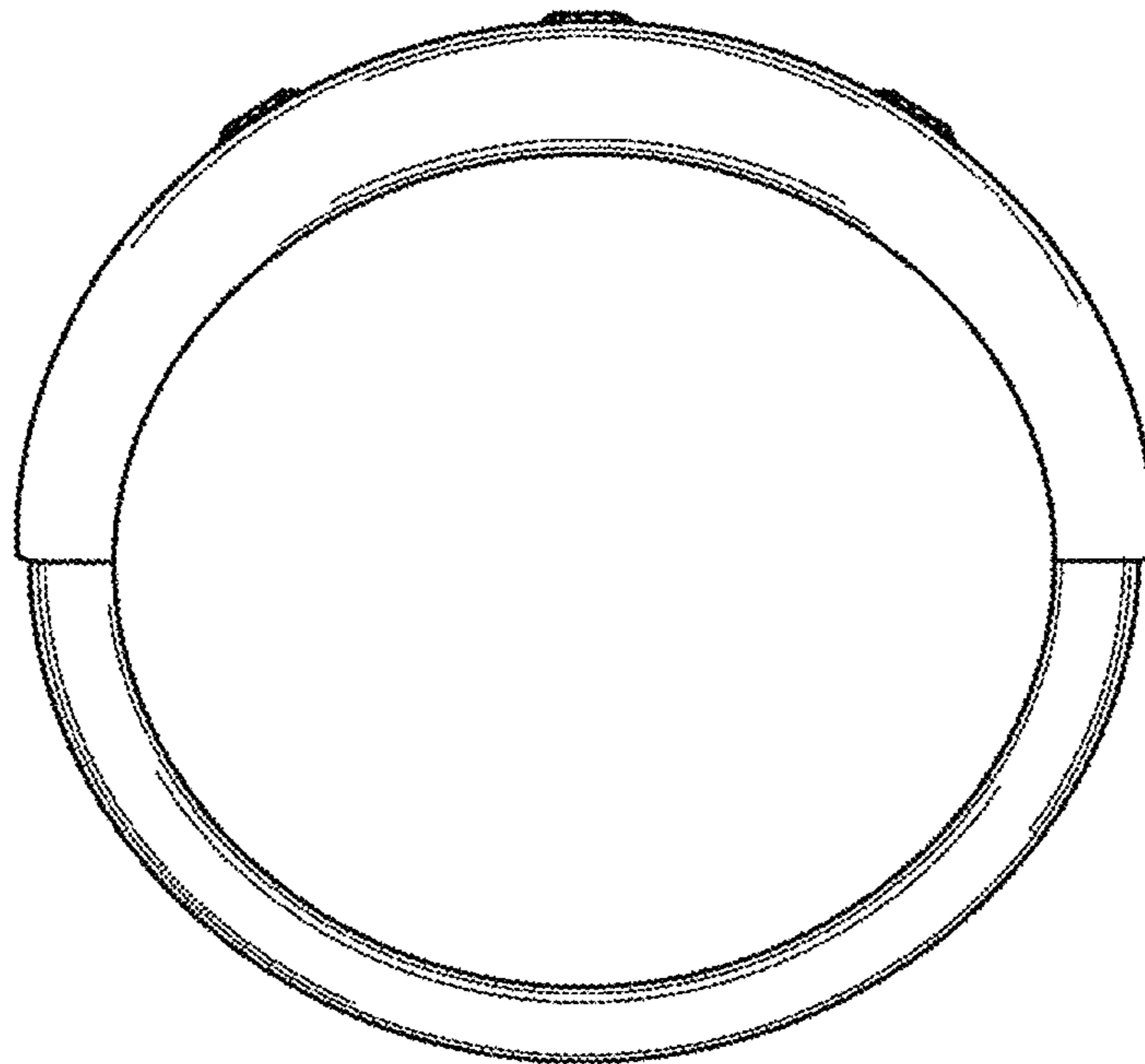

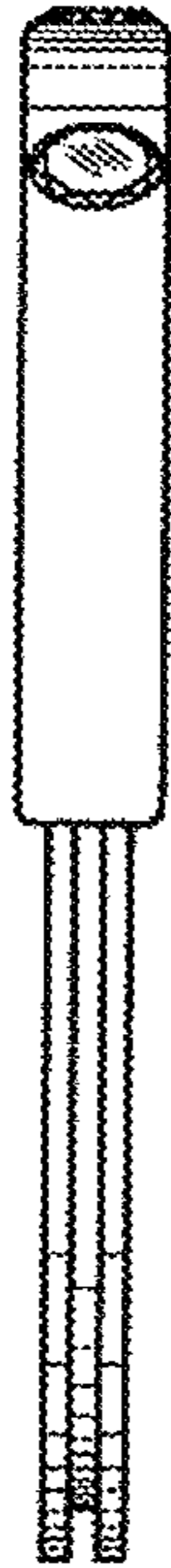

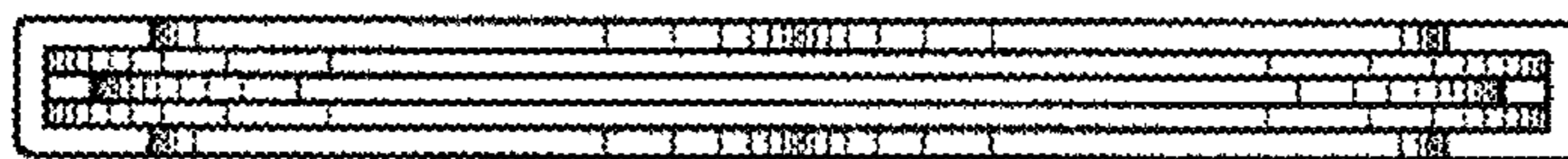

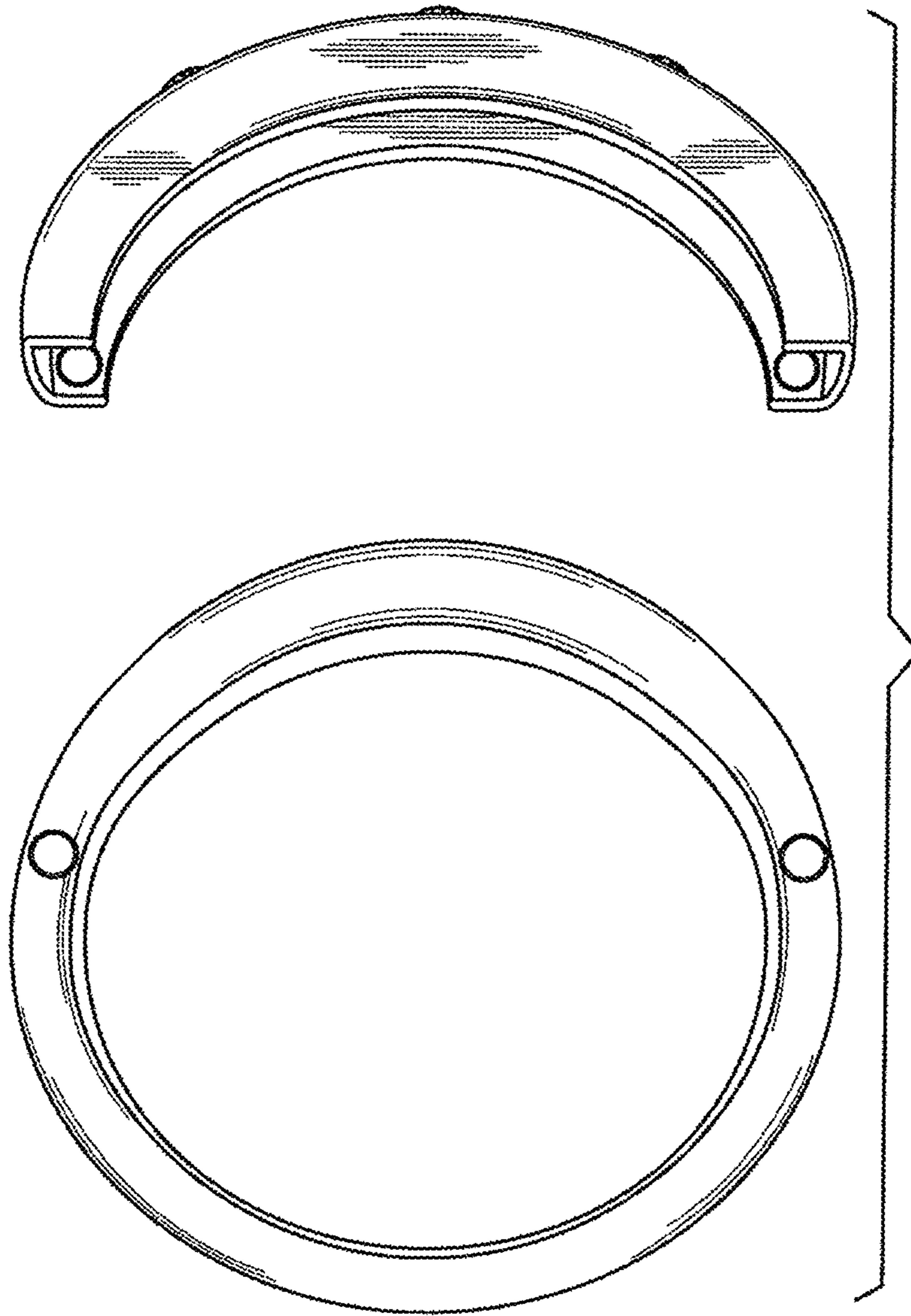
