1.4 : Left

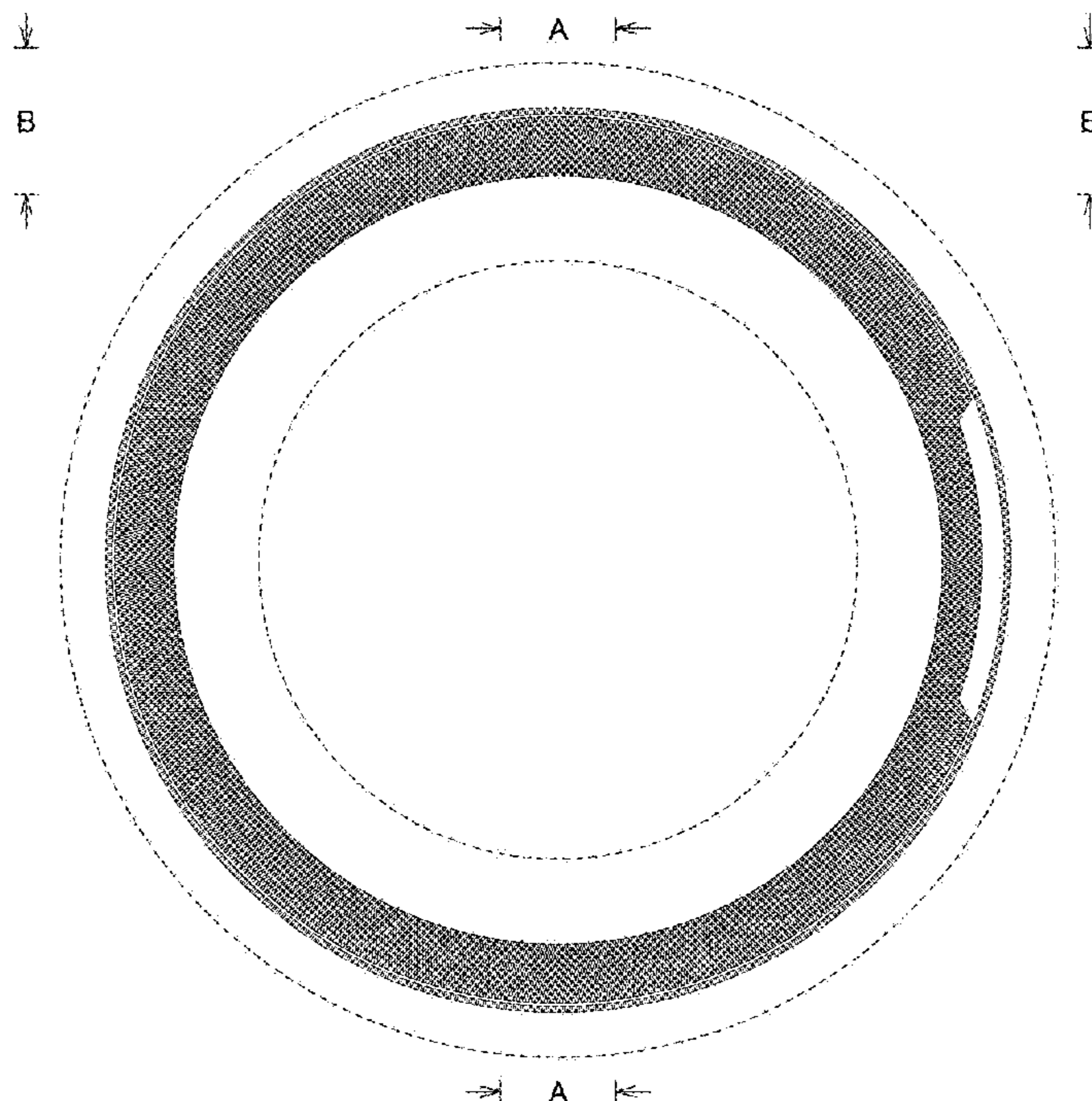
1.5 : Top

The broken lines shown in the drawings represent portions of a tire for automobile that form no part of the claimed design; fig. 1.1 is a front elevation view of the tire for automobile showing my new design; fig. 1.2 is a back elevation view thereof; fig. 1.3 is a right side elevation view thereof; fig. 1.4 is a left side elevation view thereof; fig. 1.5 is a top plan view thereof; fig. 1.6 is a bottom plan view thereof; and fig. 1.7 is a partial enlarged view thereof, taken along lines A-A and B-B in fig. 1.1.

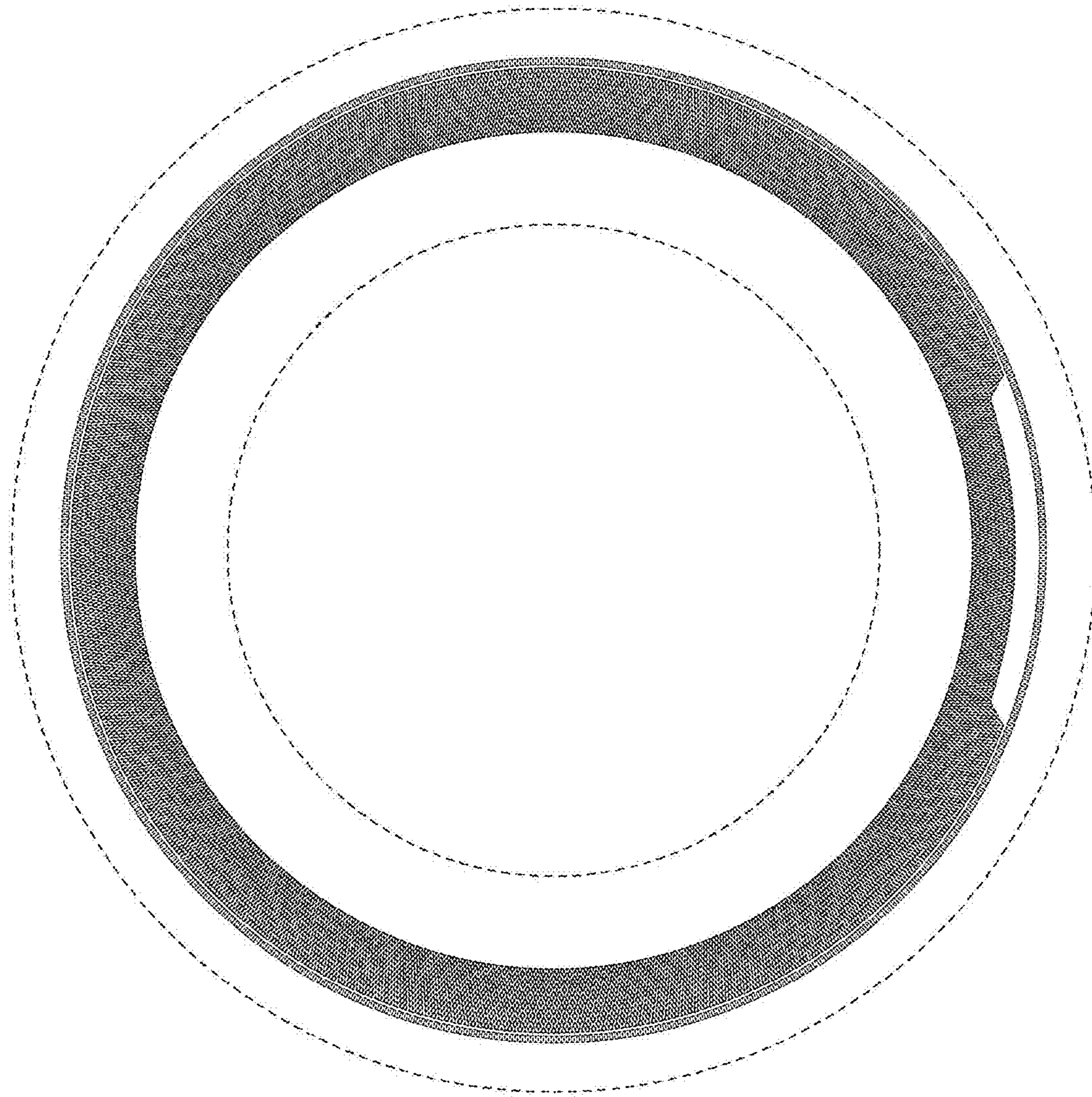

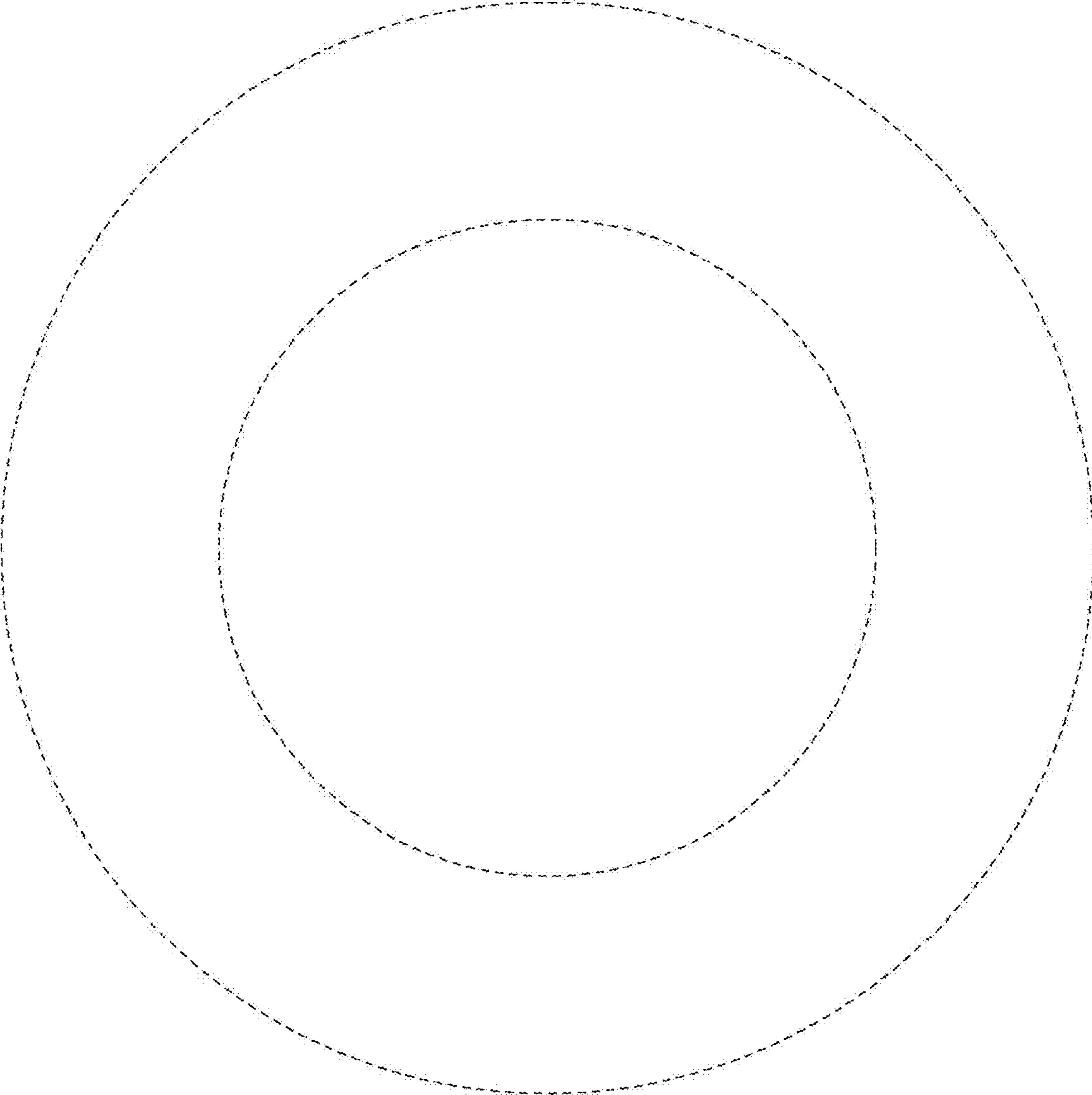

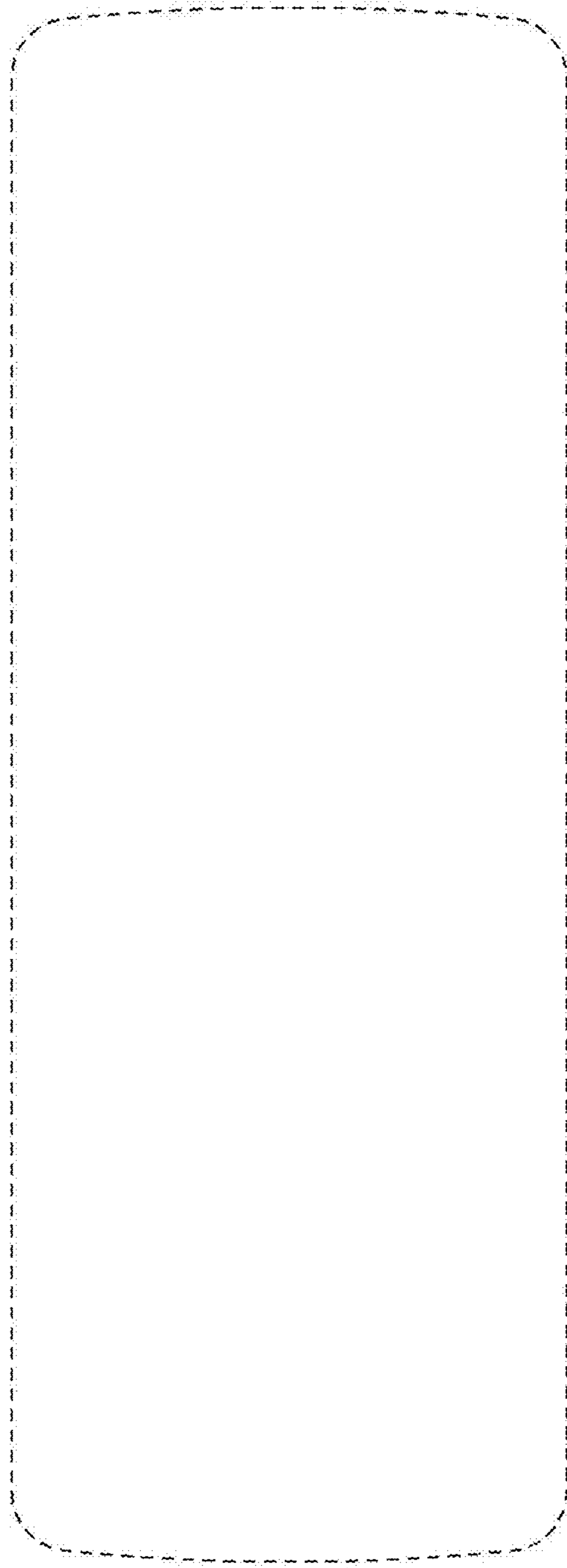

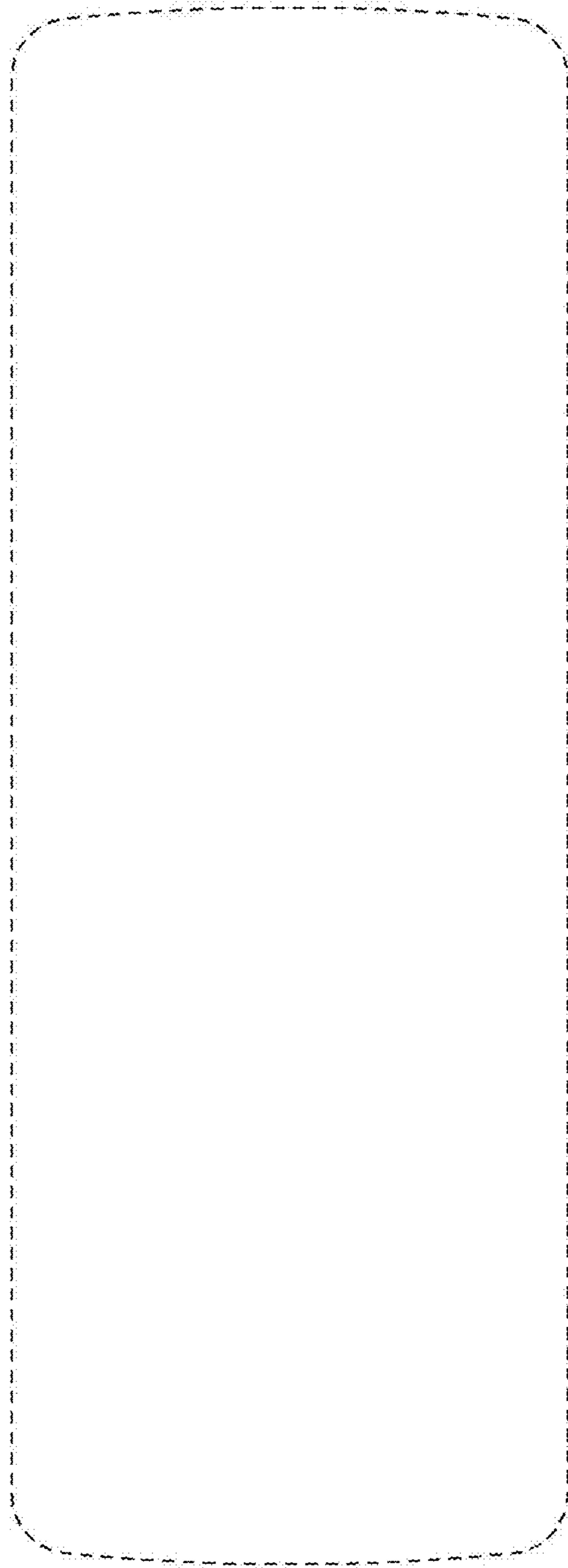
