FIG. 19 is a front elevation view of the mobile phone of FIG. 17;

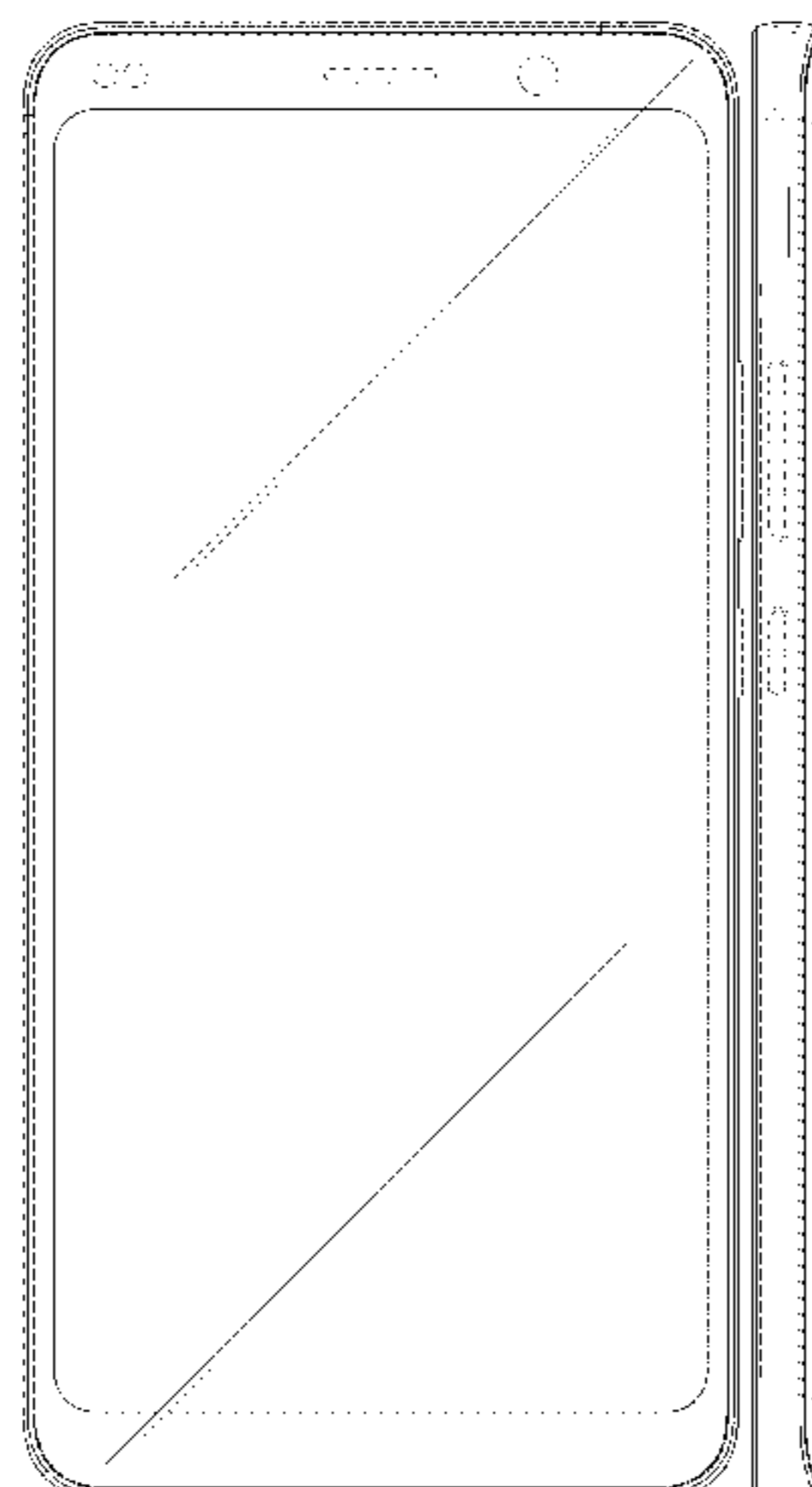
FIG. 20 is a rear elevation view of the mobile phone of FIG. 17;

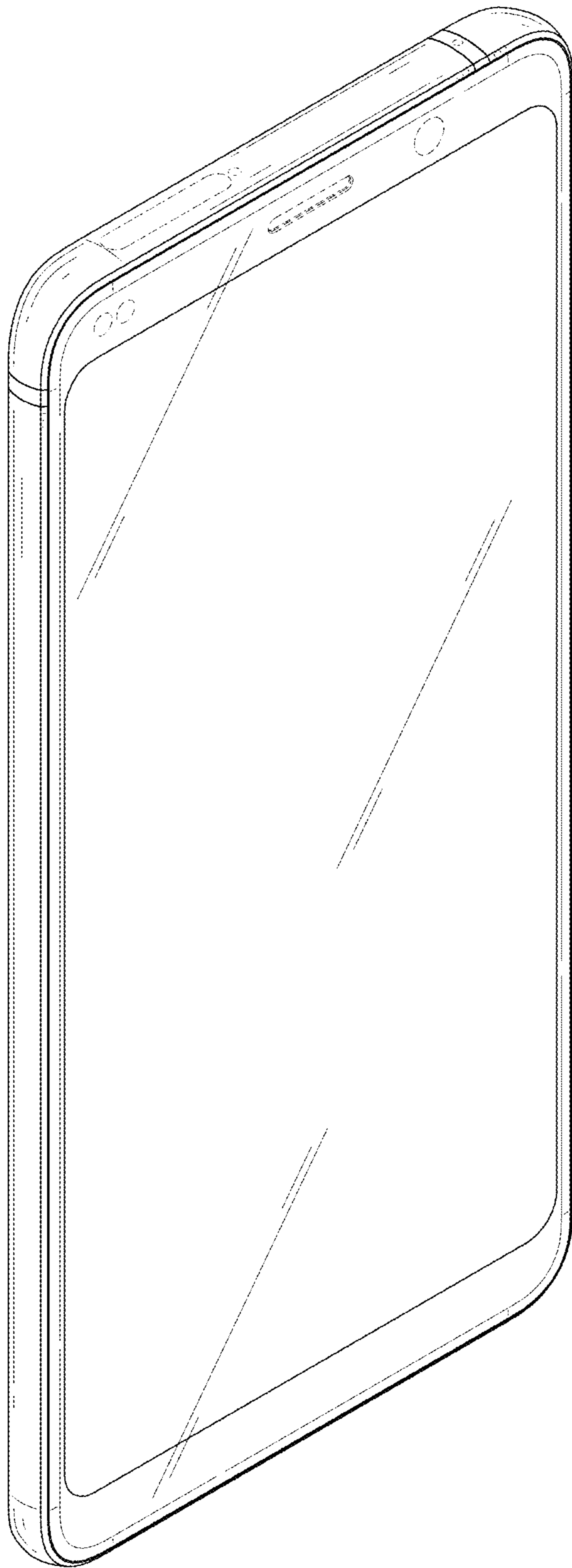

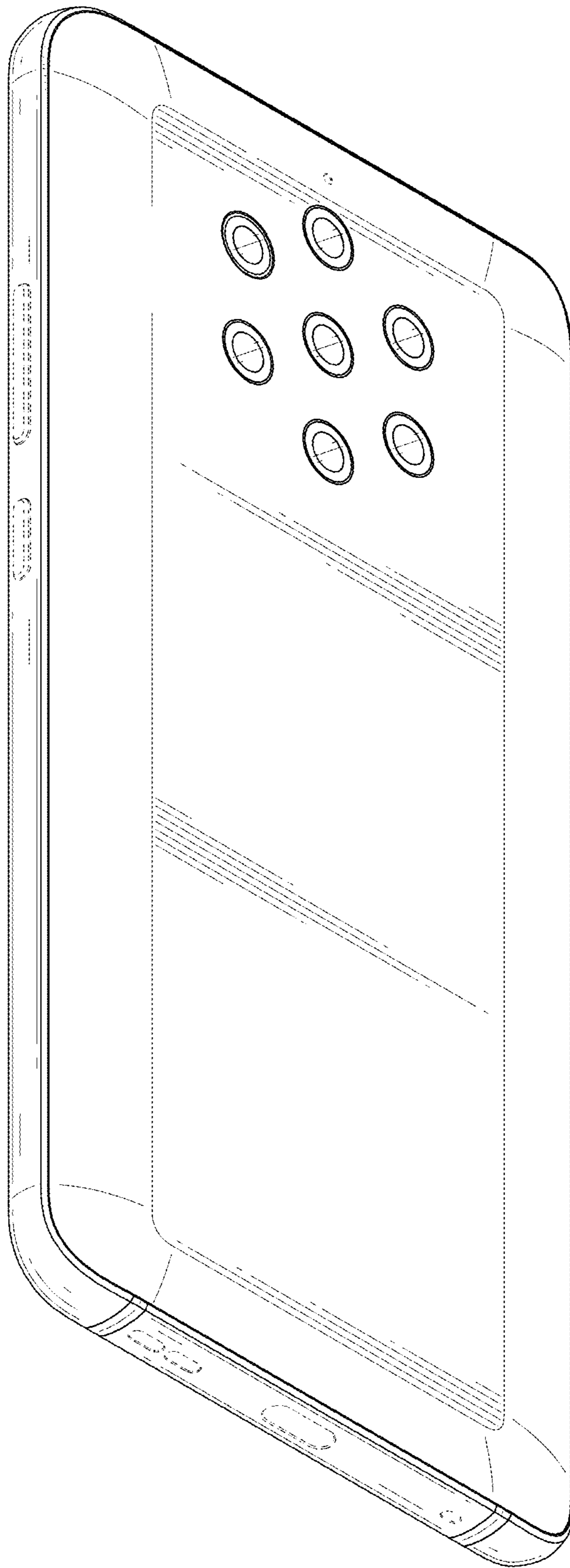

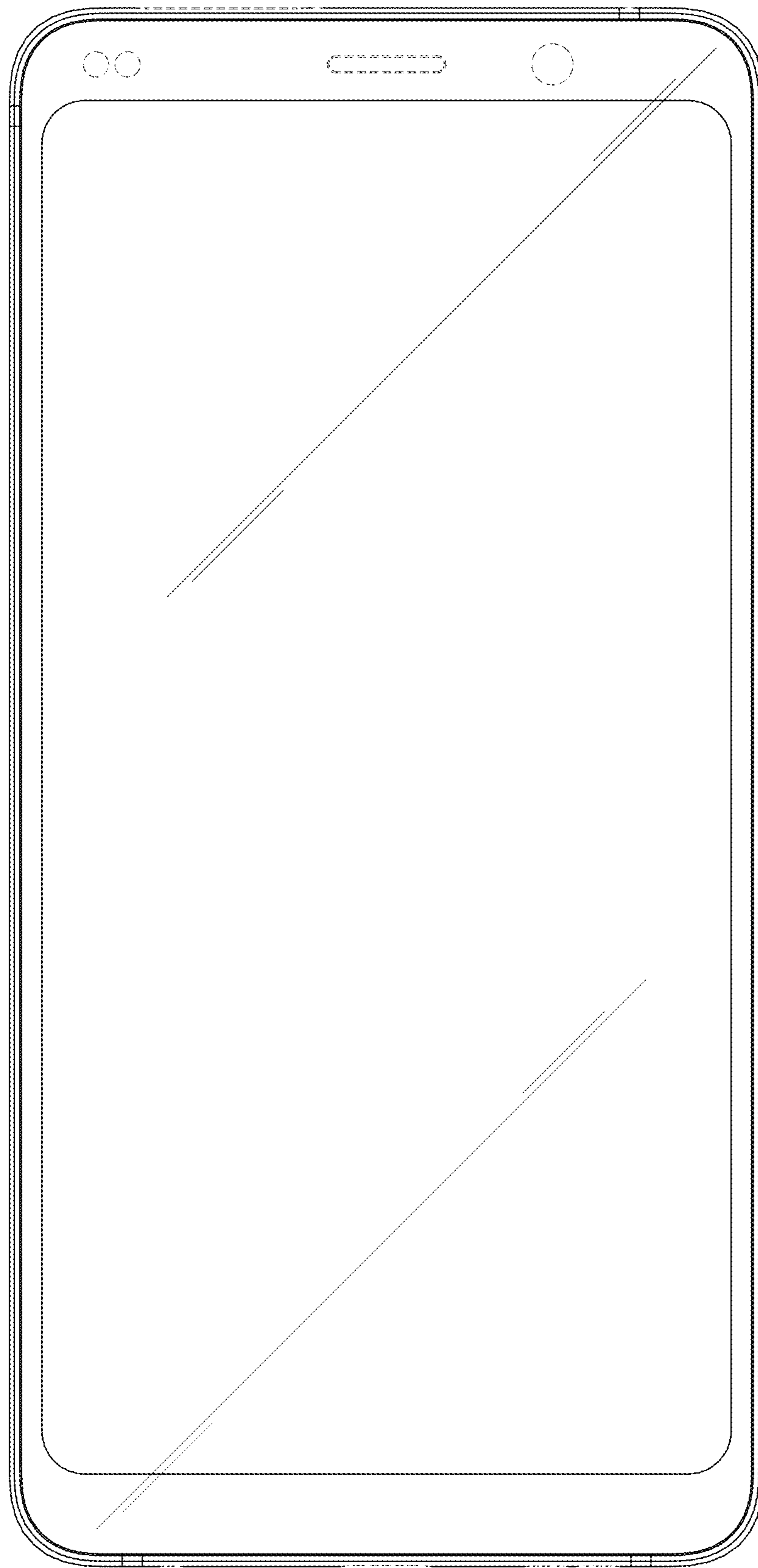

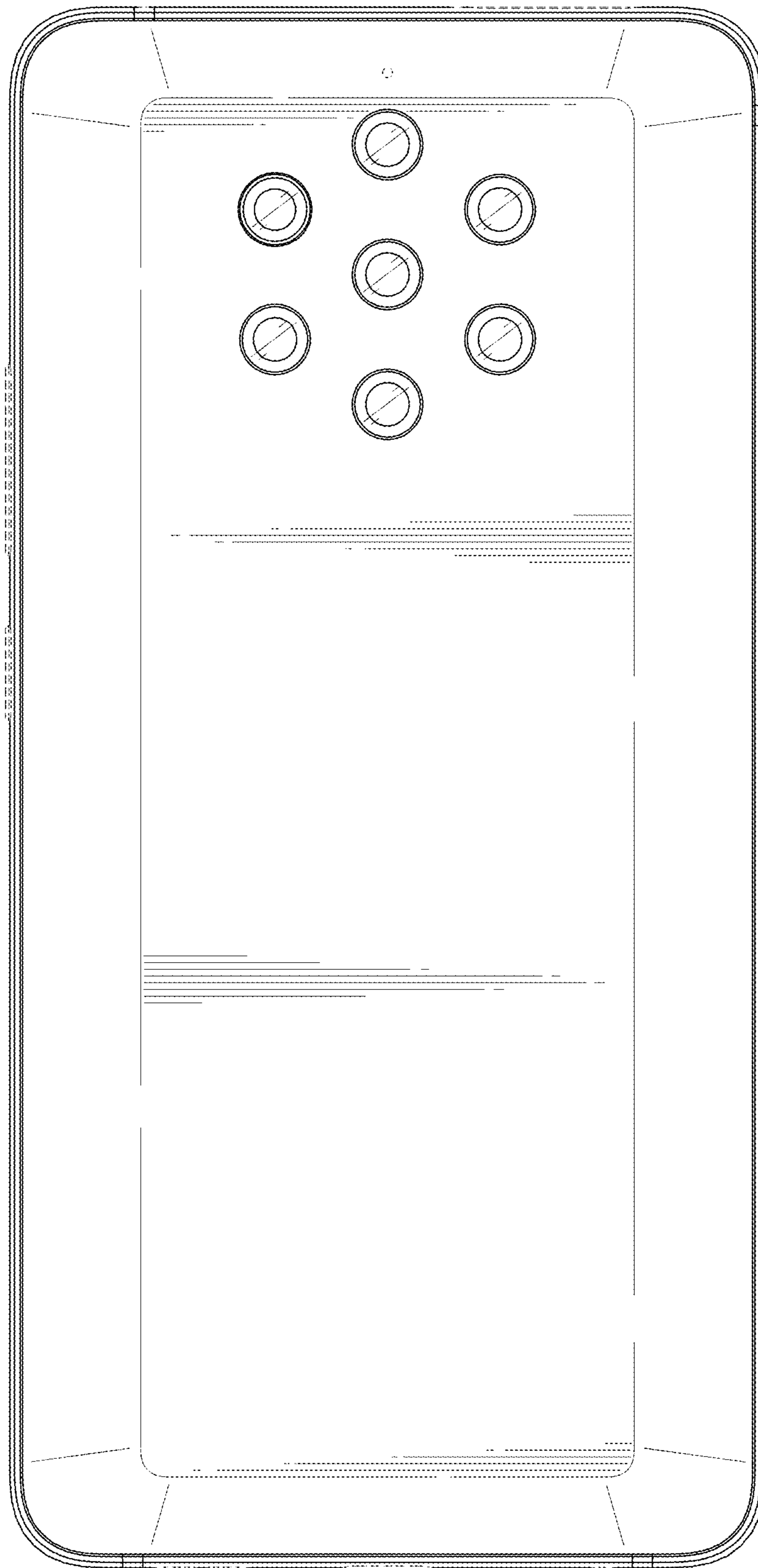

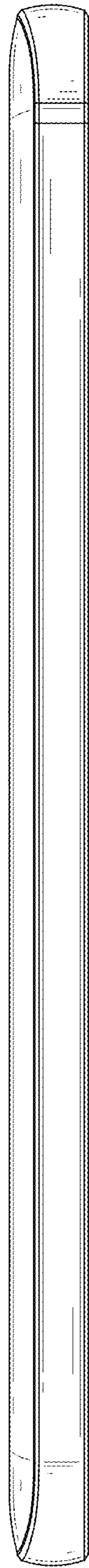

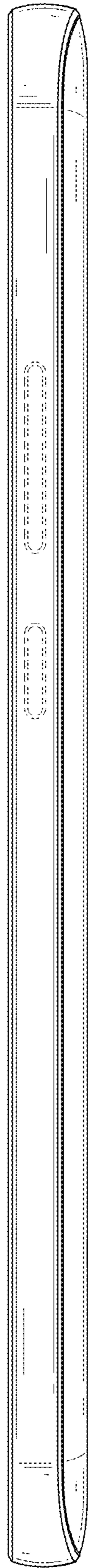

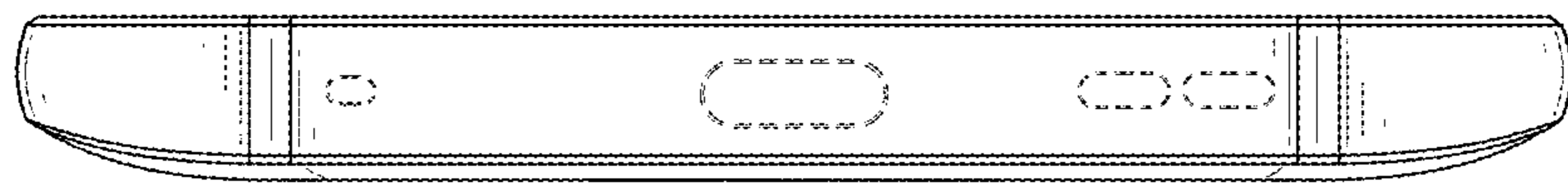

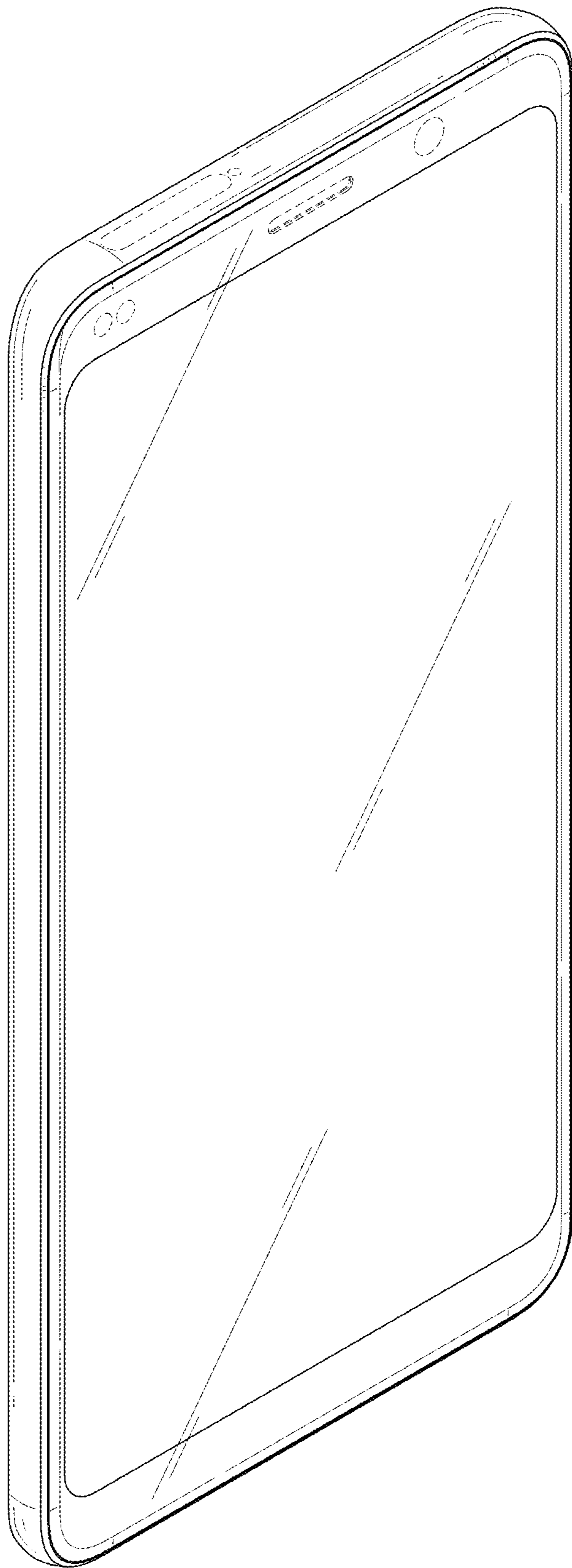

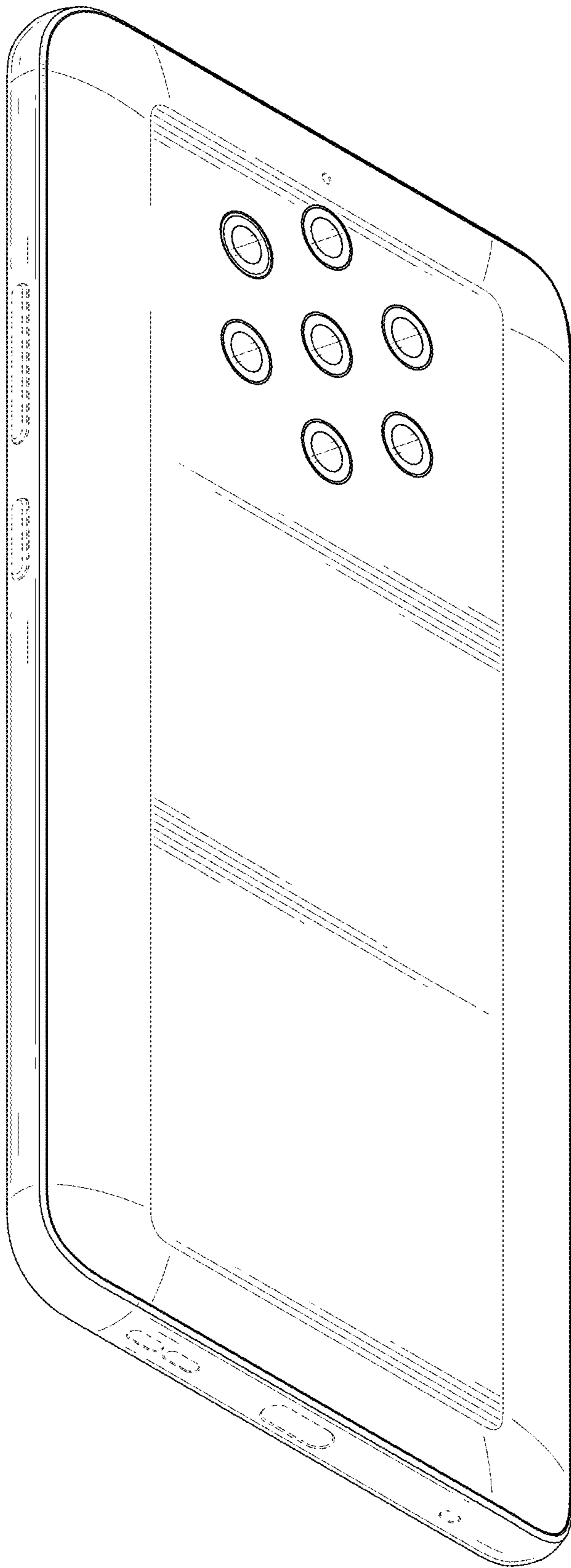

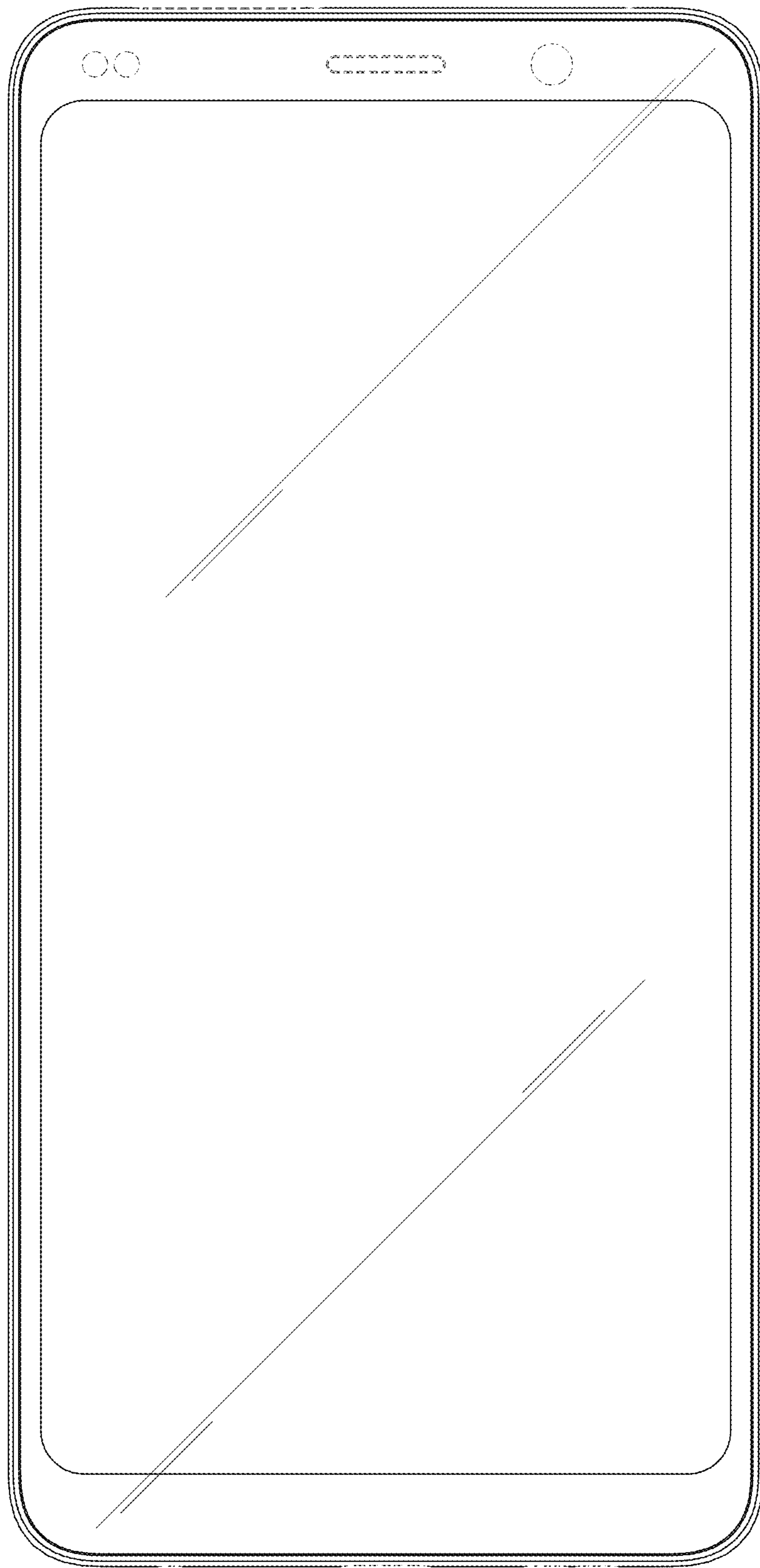

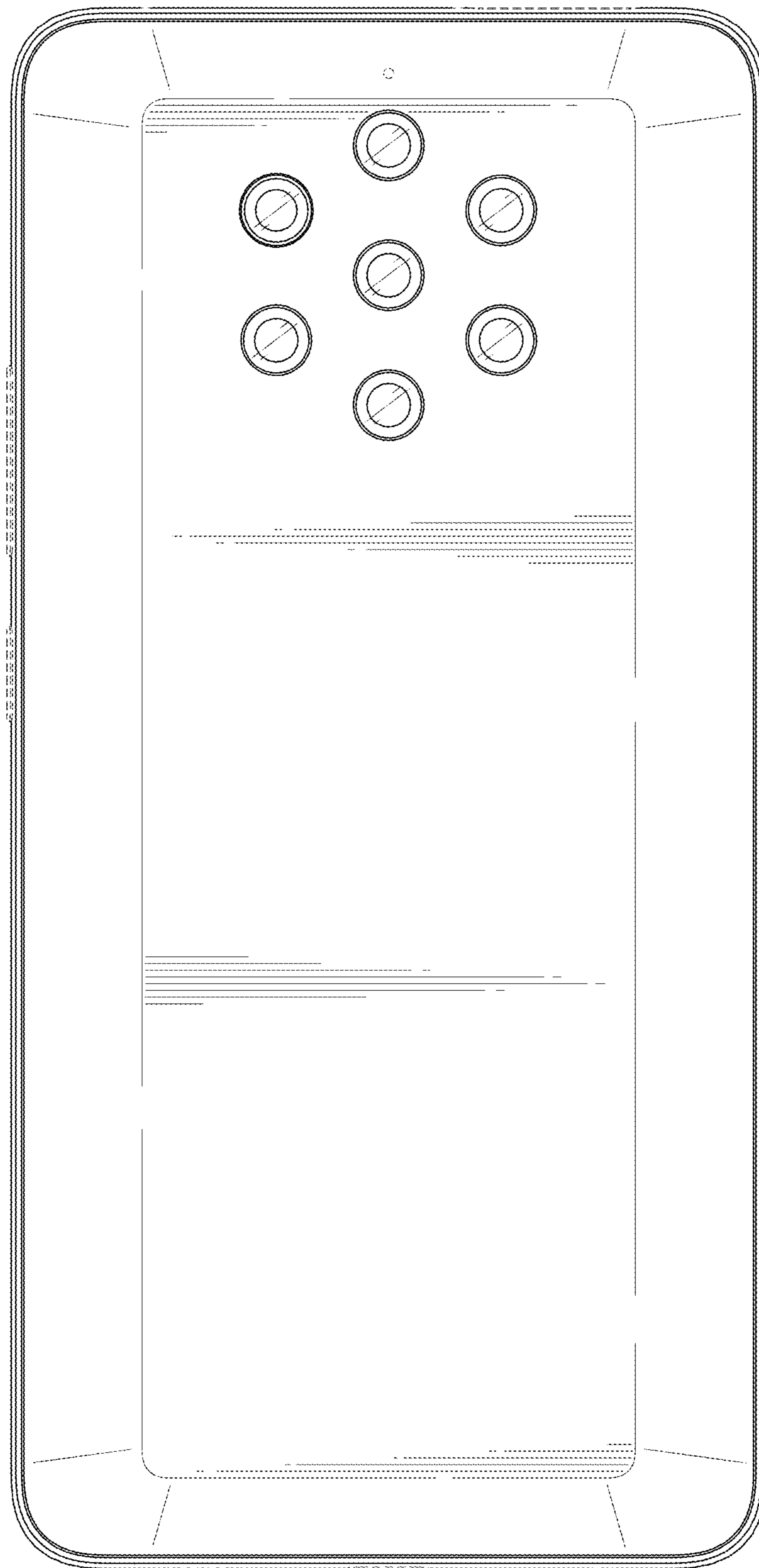

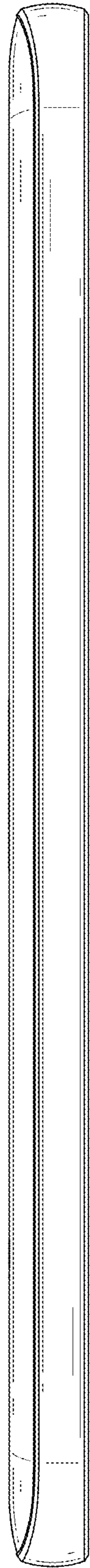

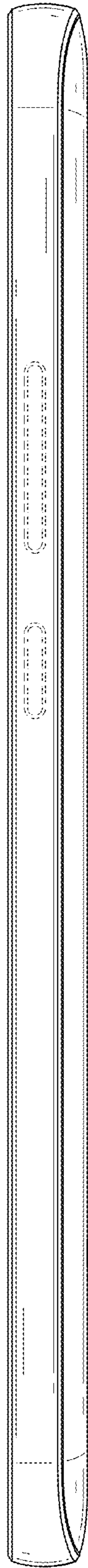

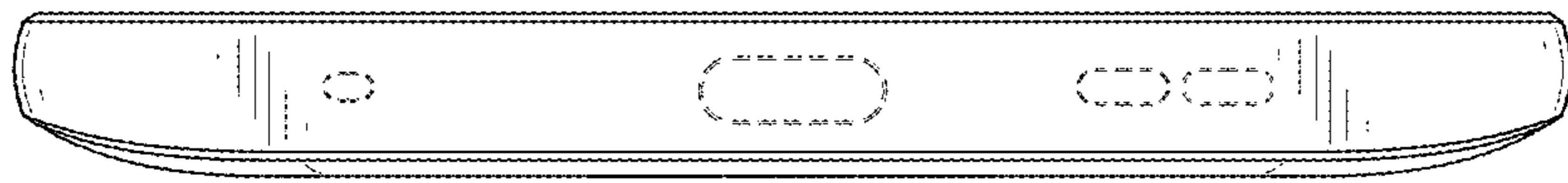

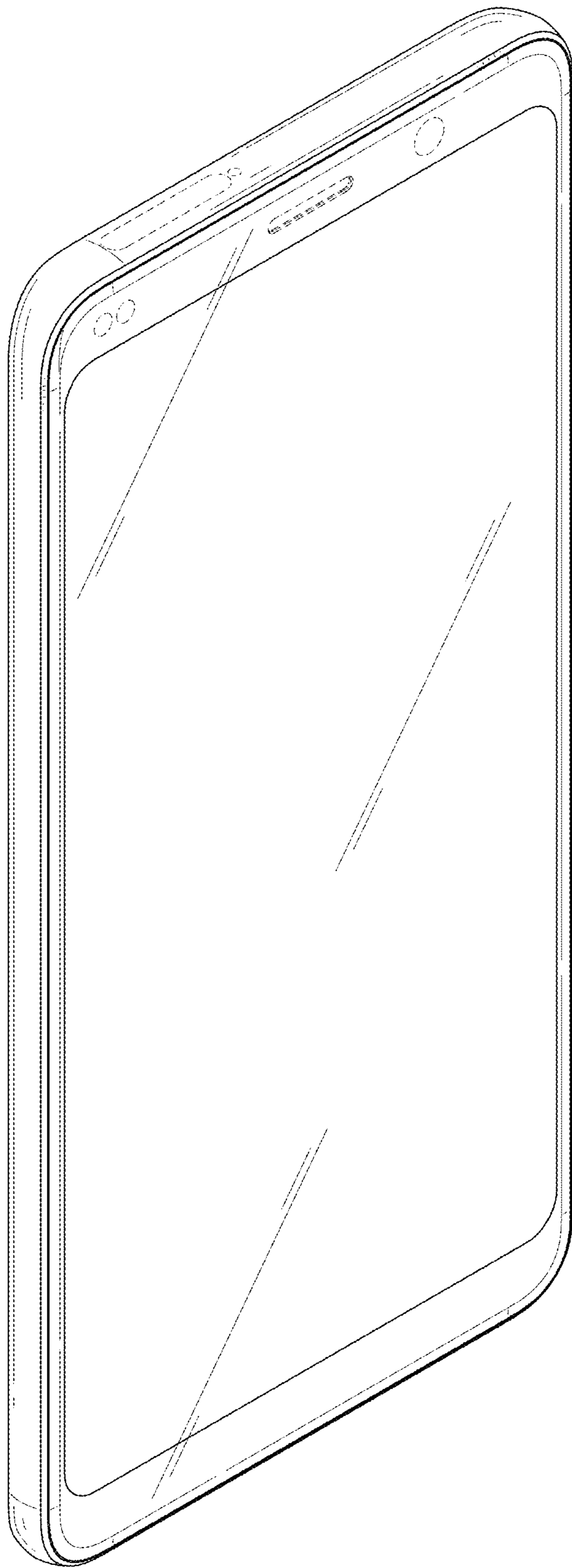

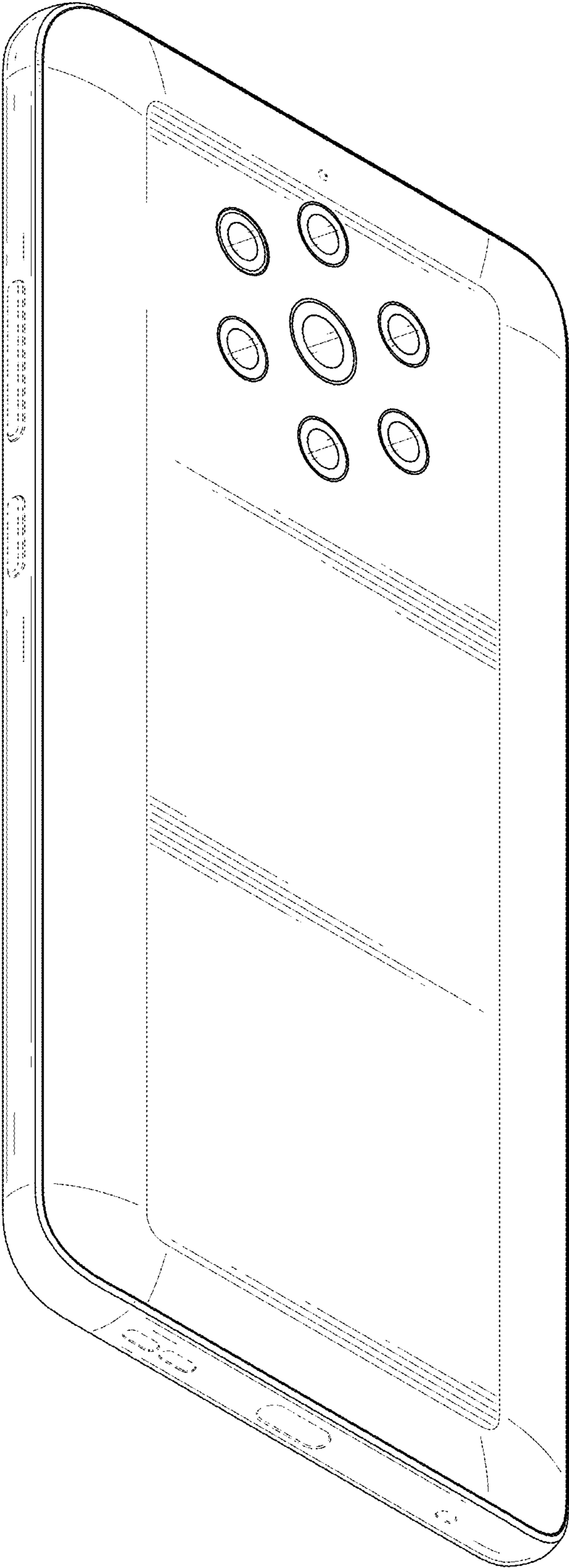

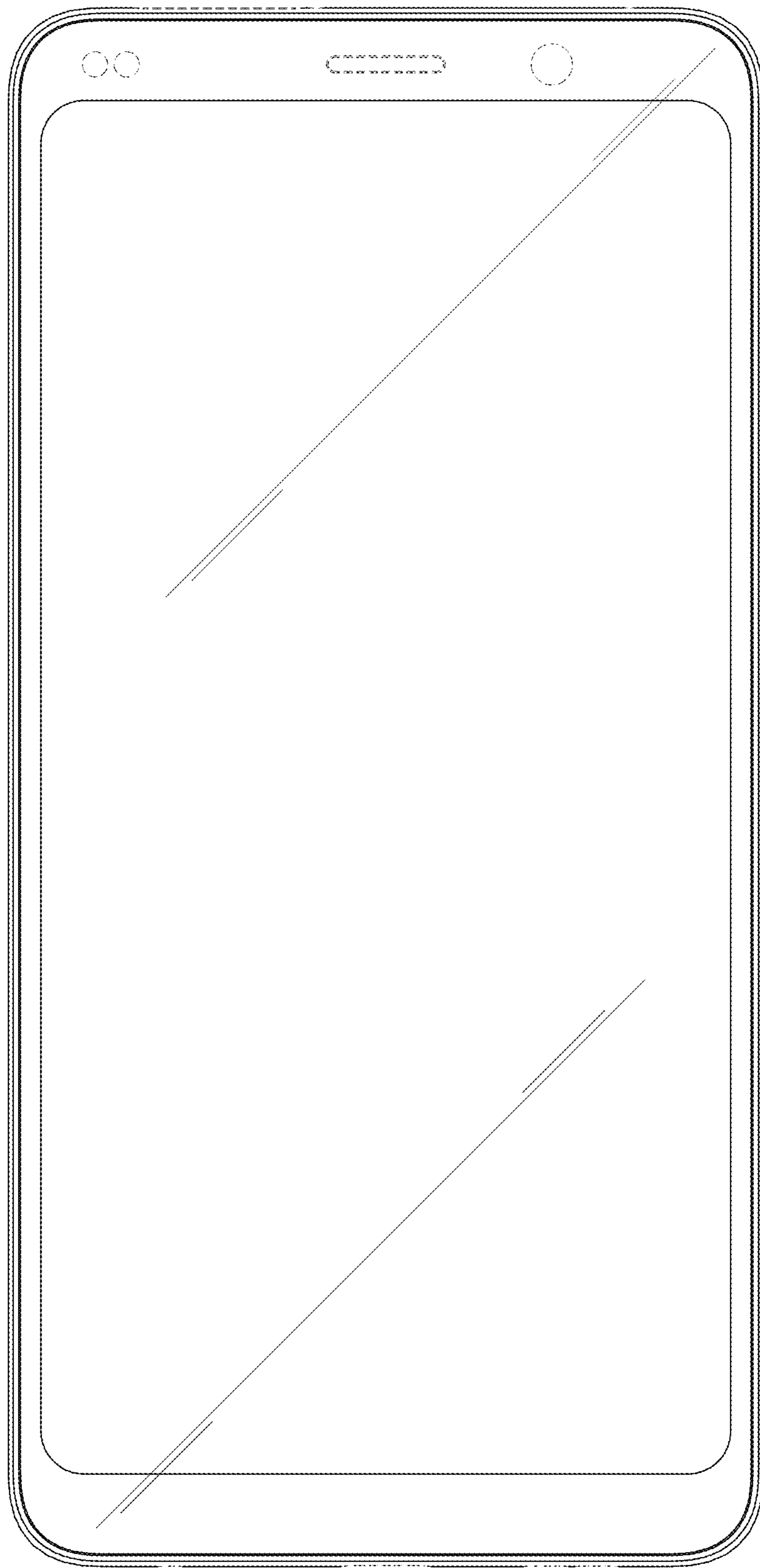

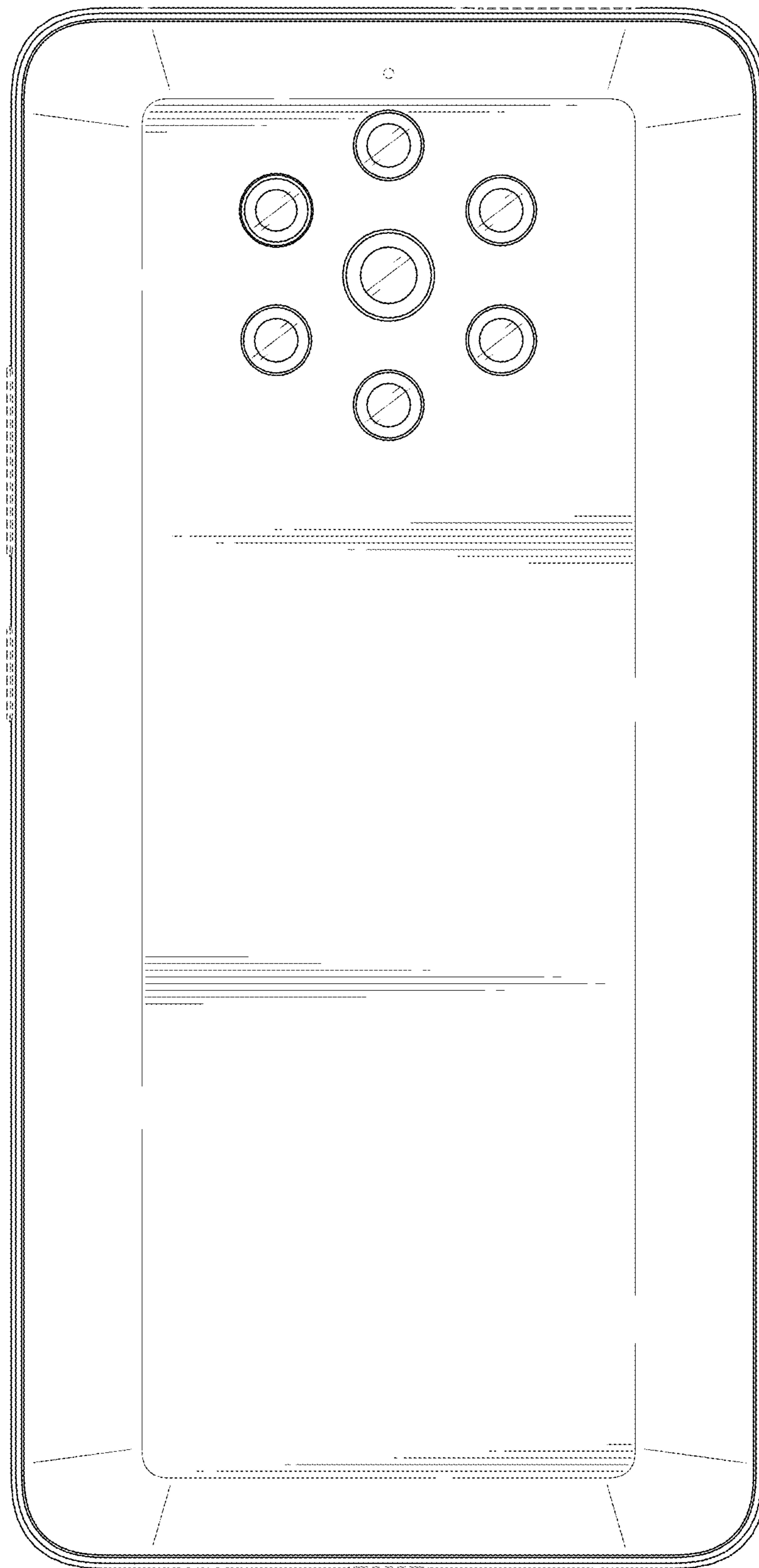

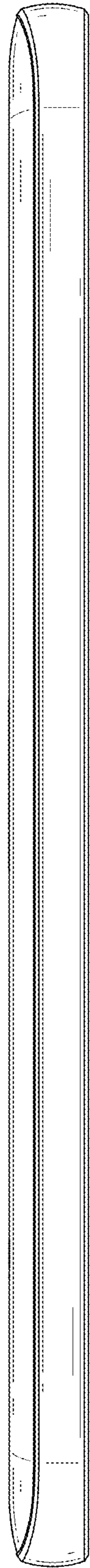

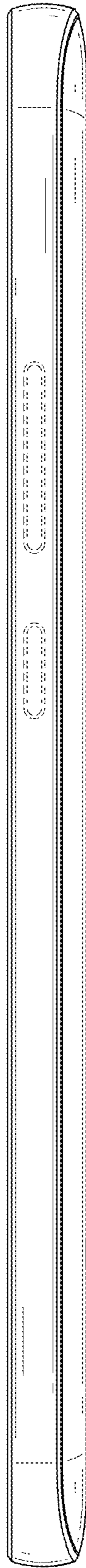

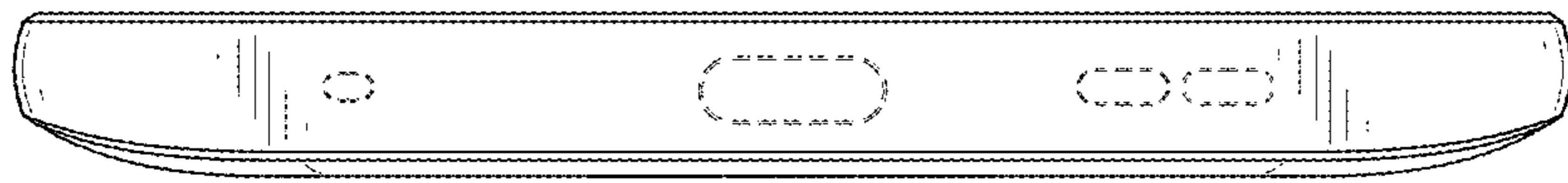
