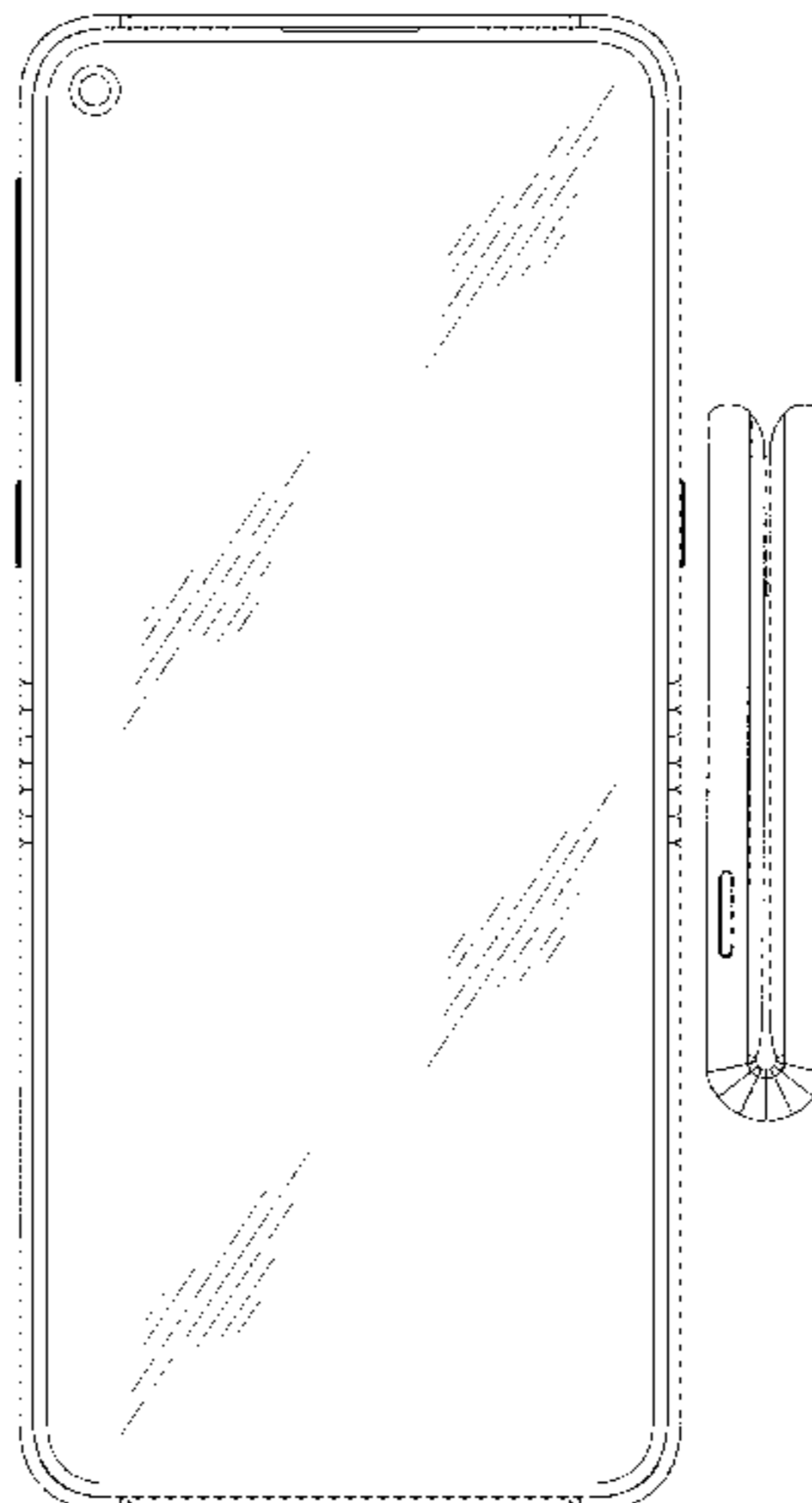


FIG. 18 is another perspective view thereof.

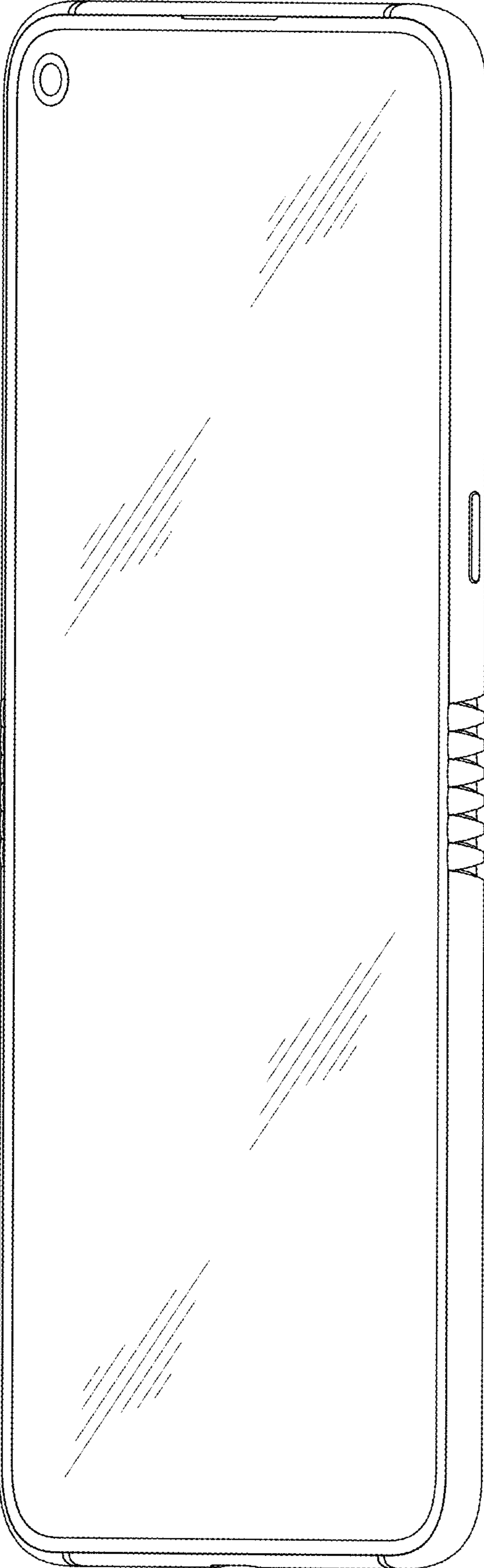

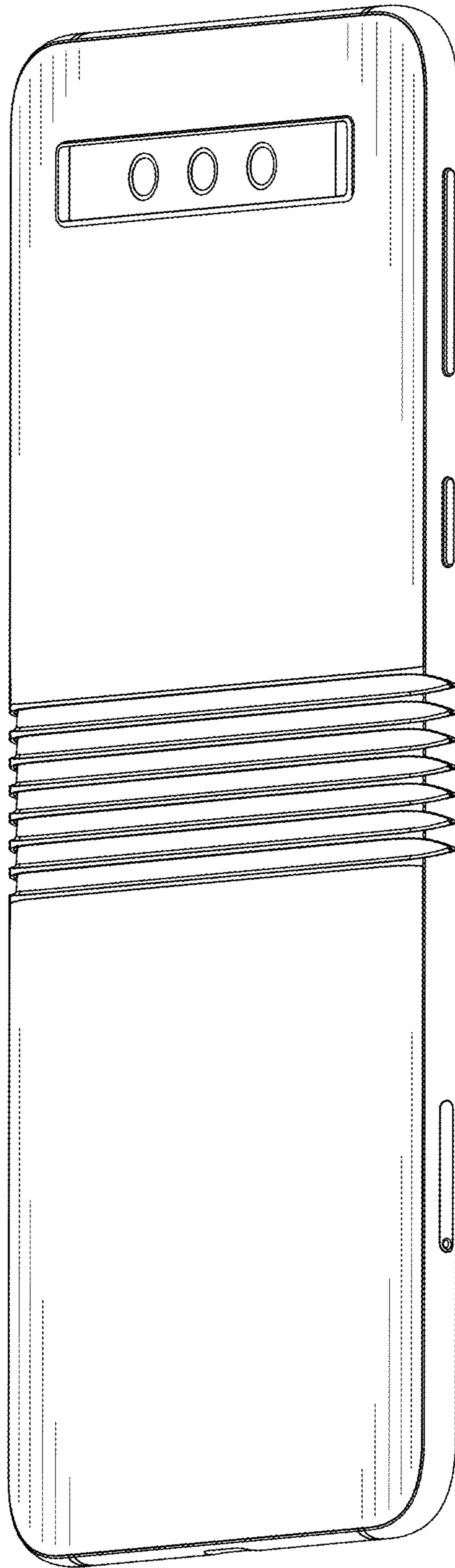

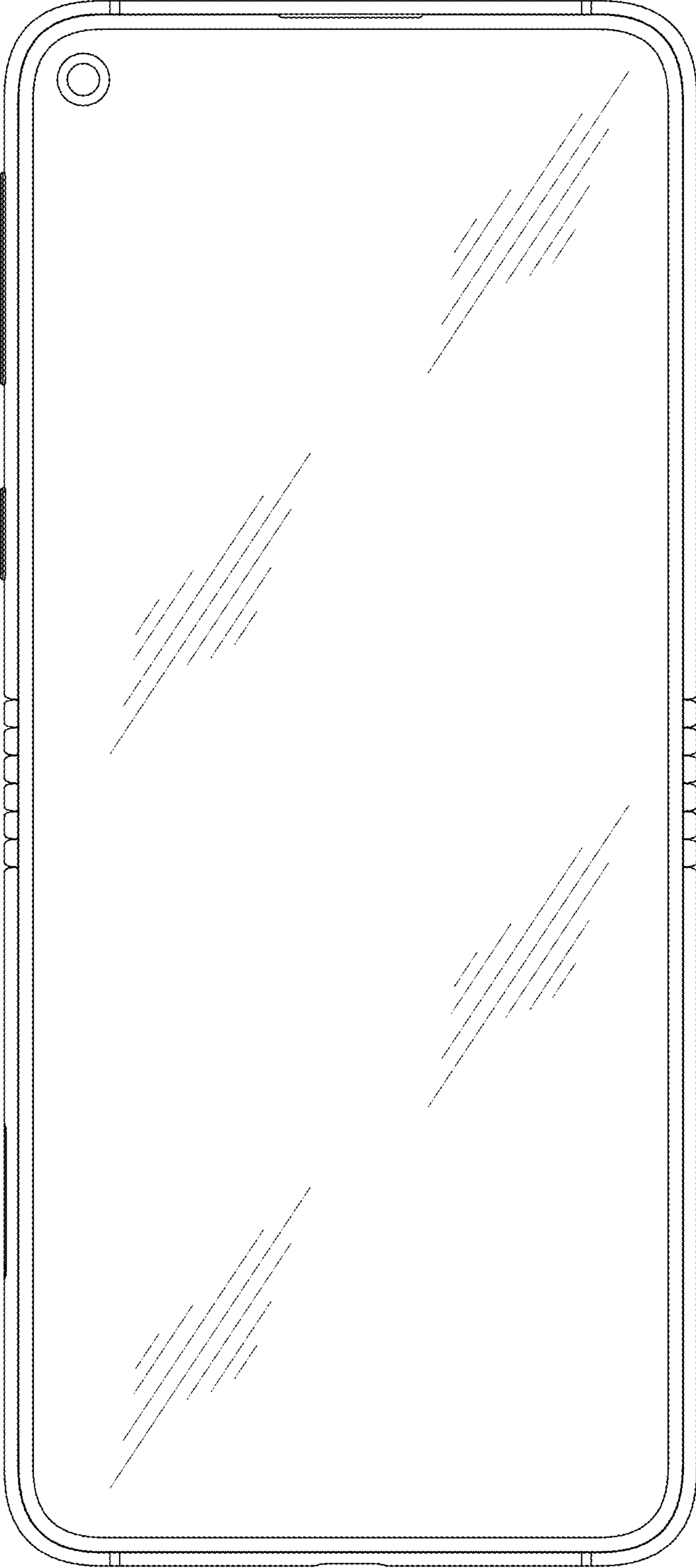

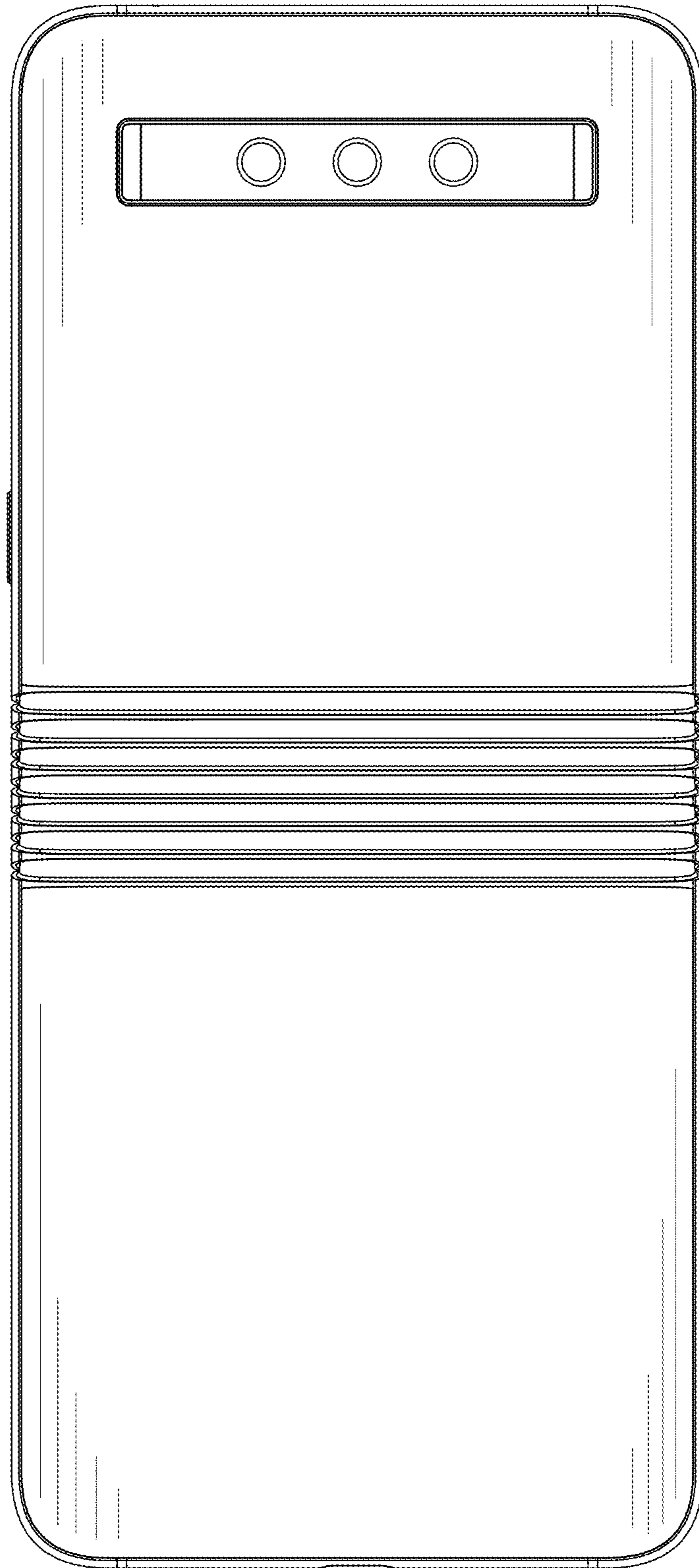

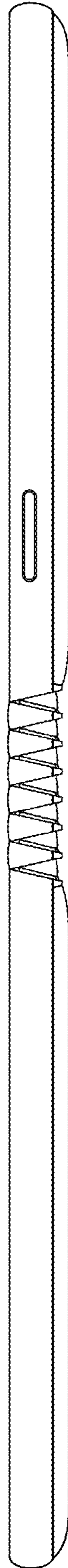

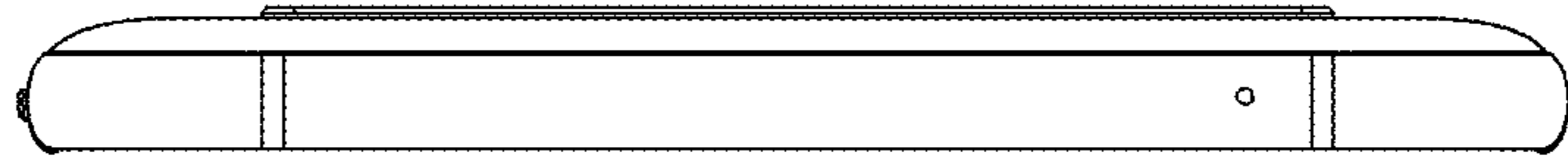

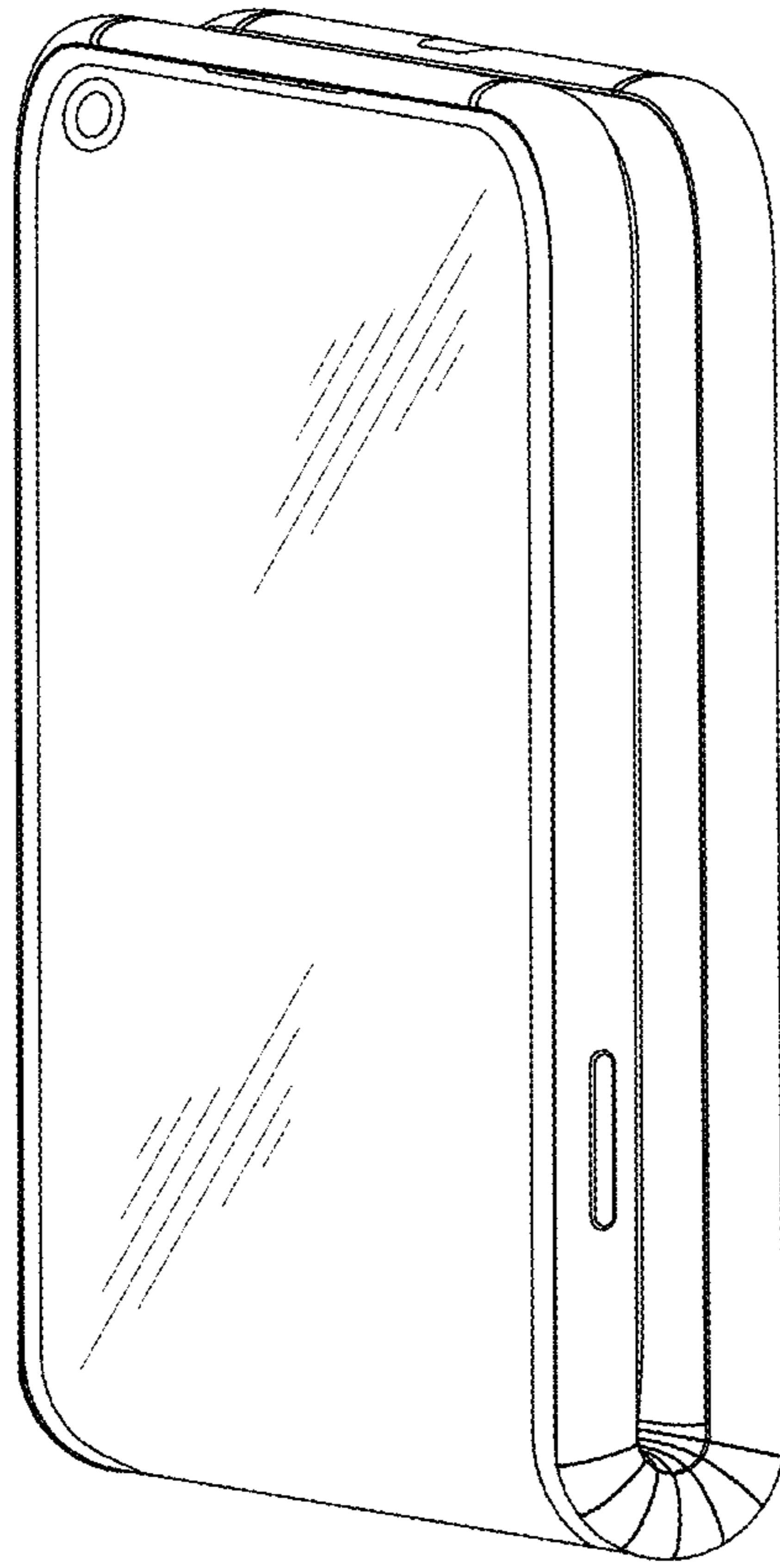

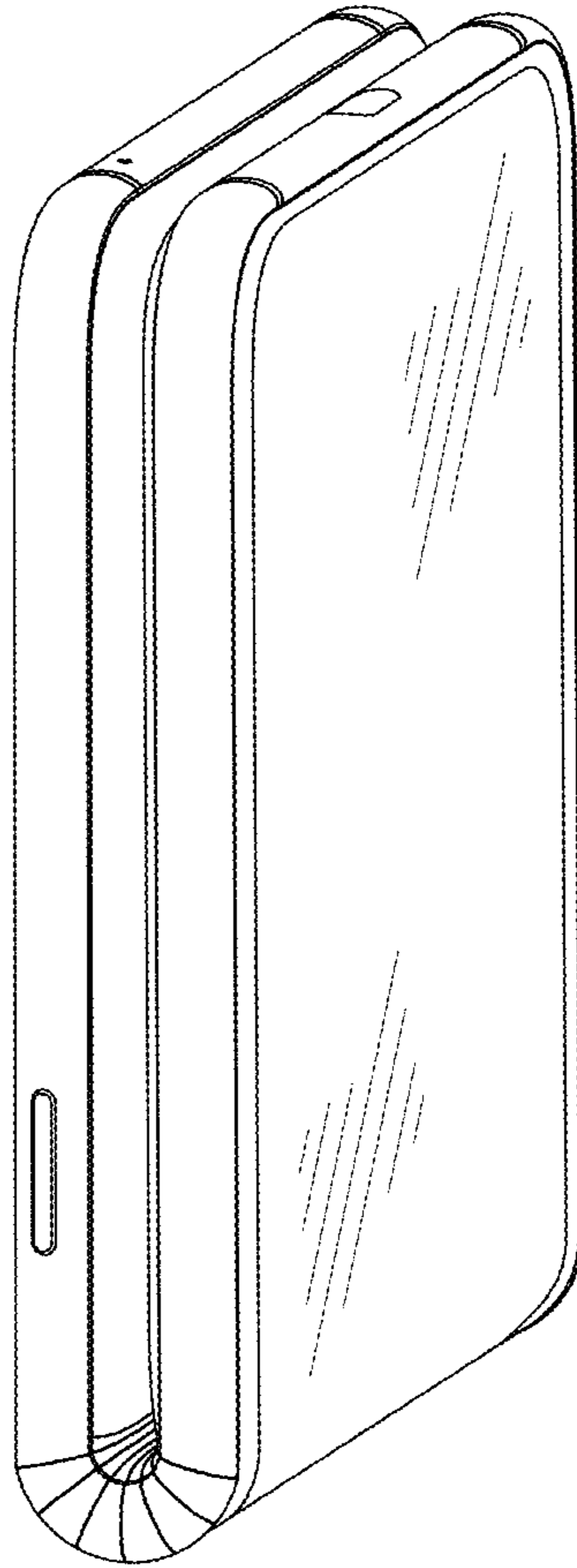

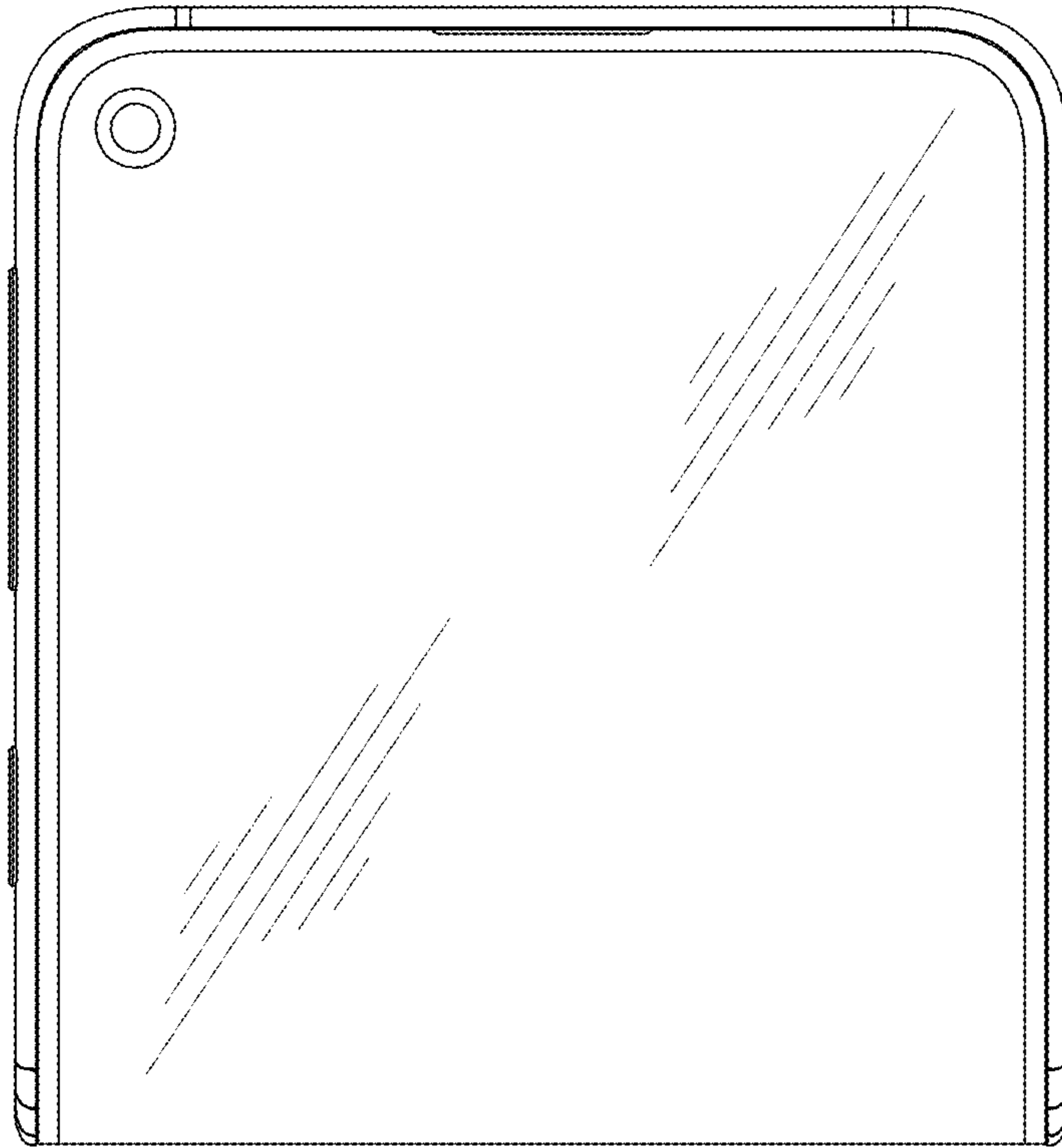

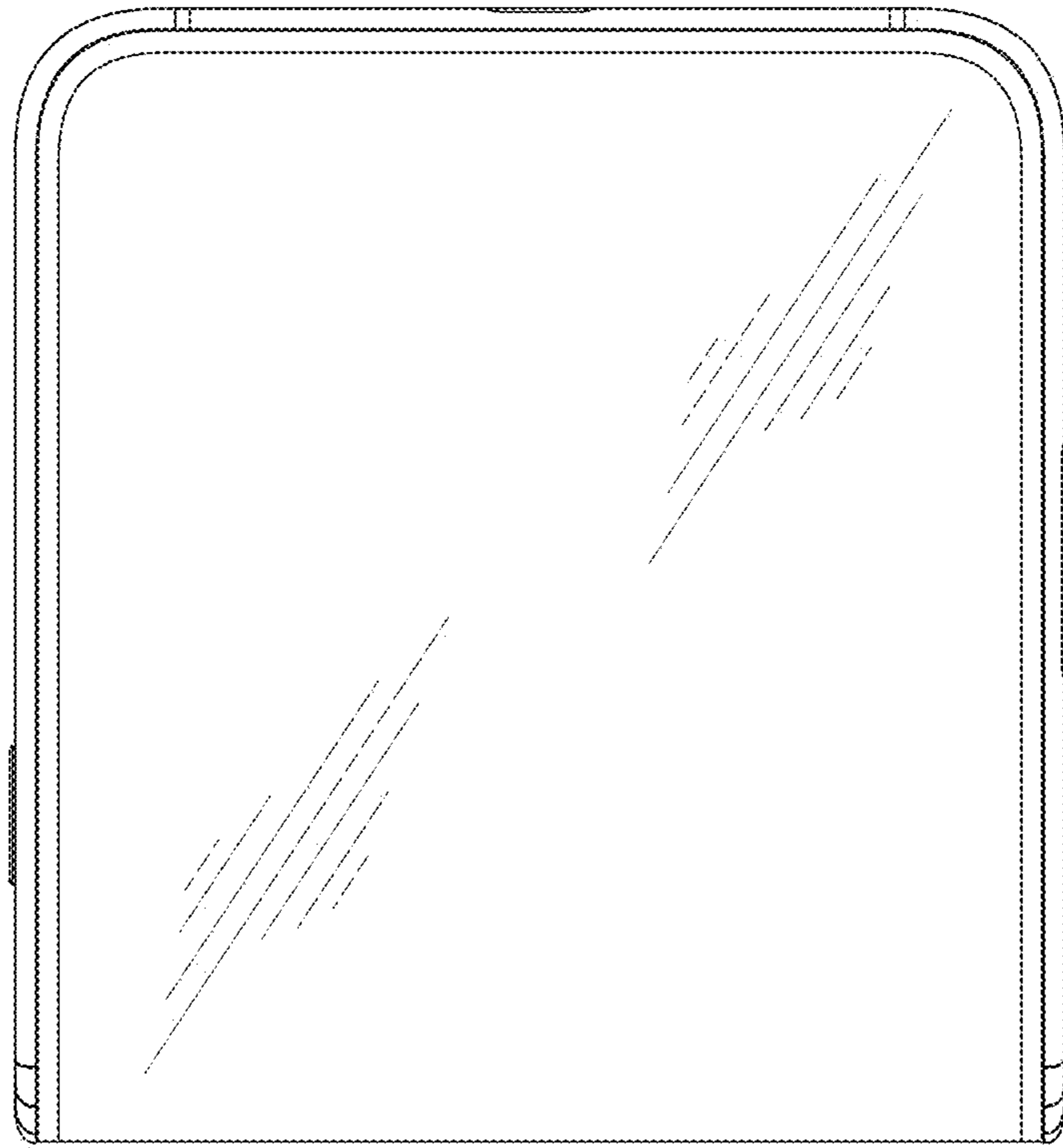

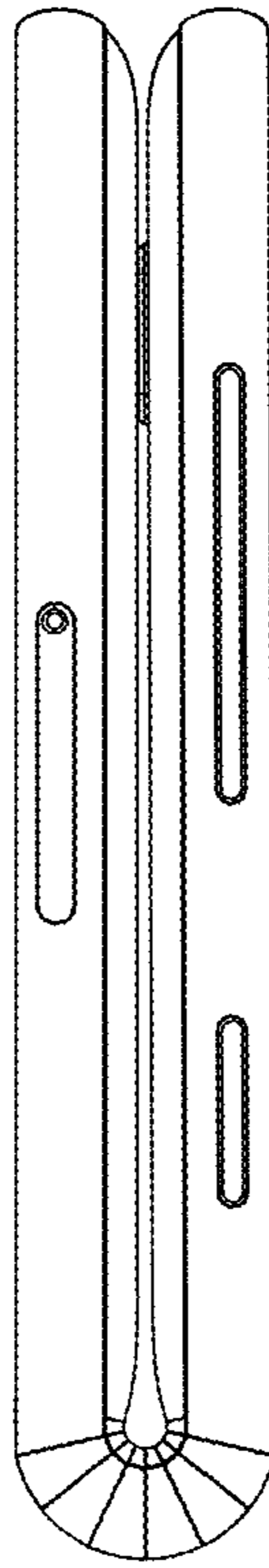

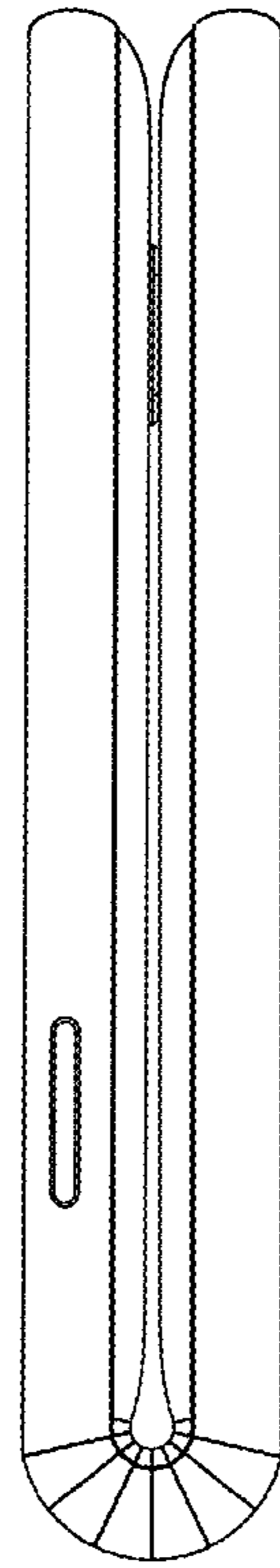

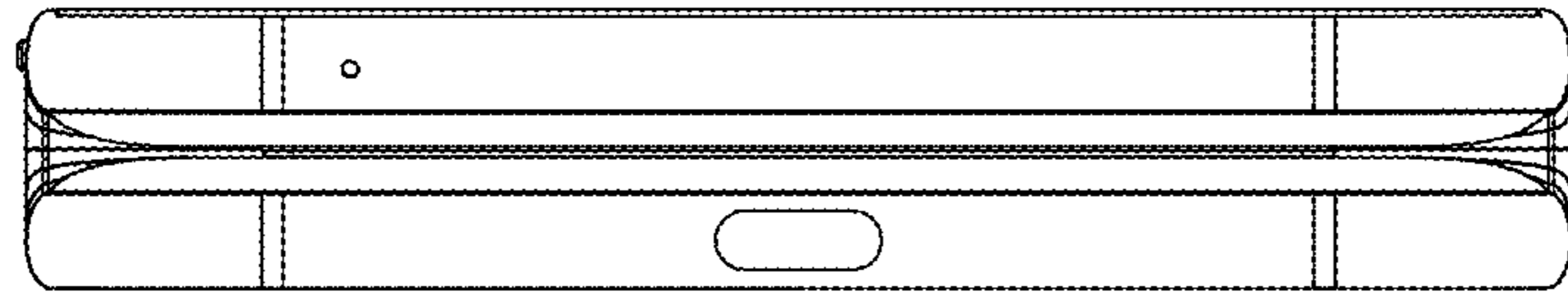

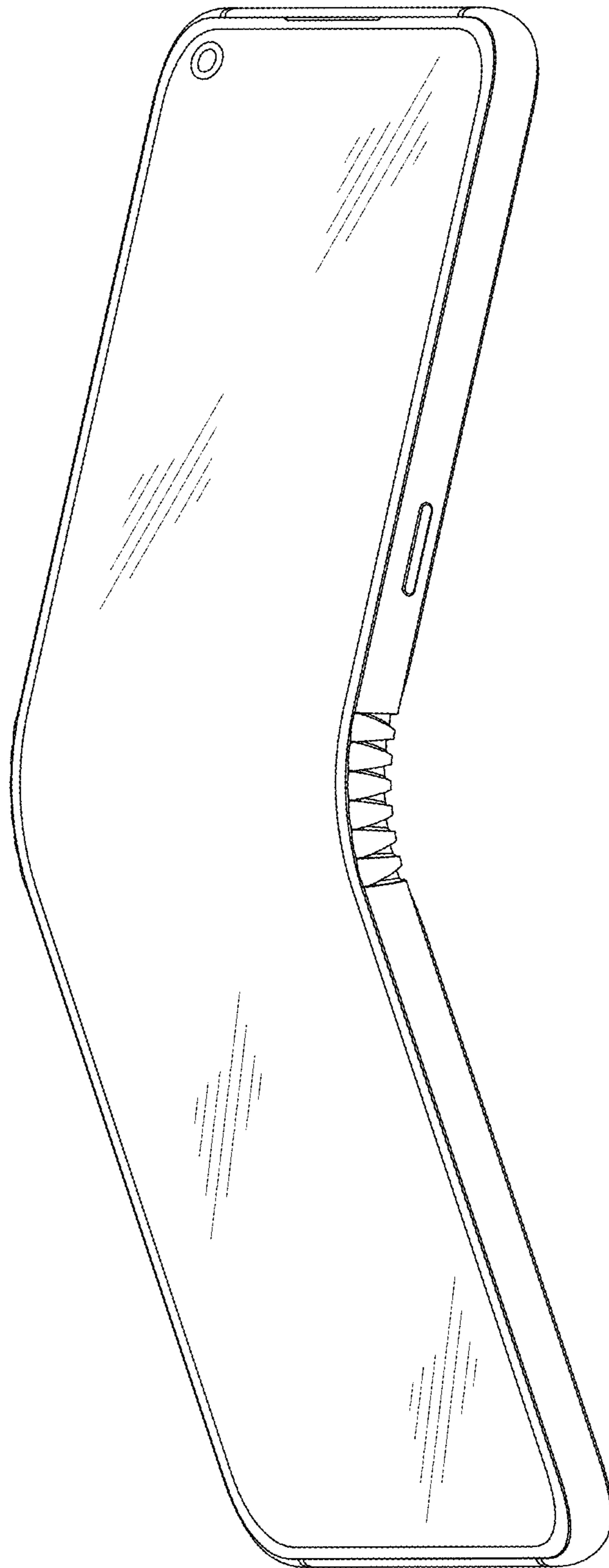

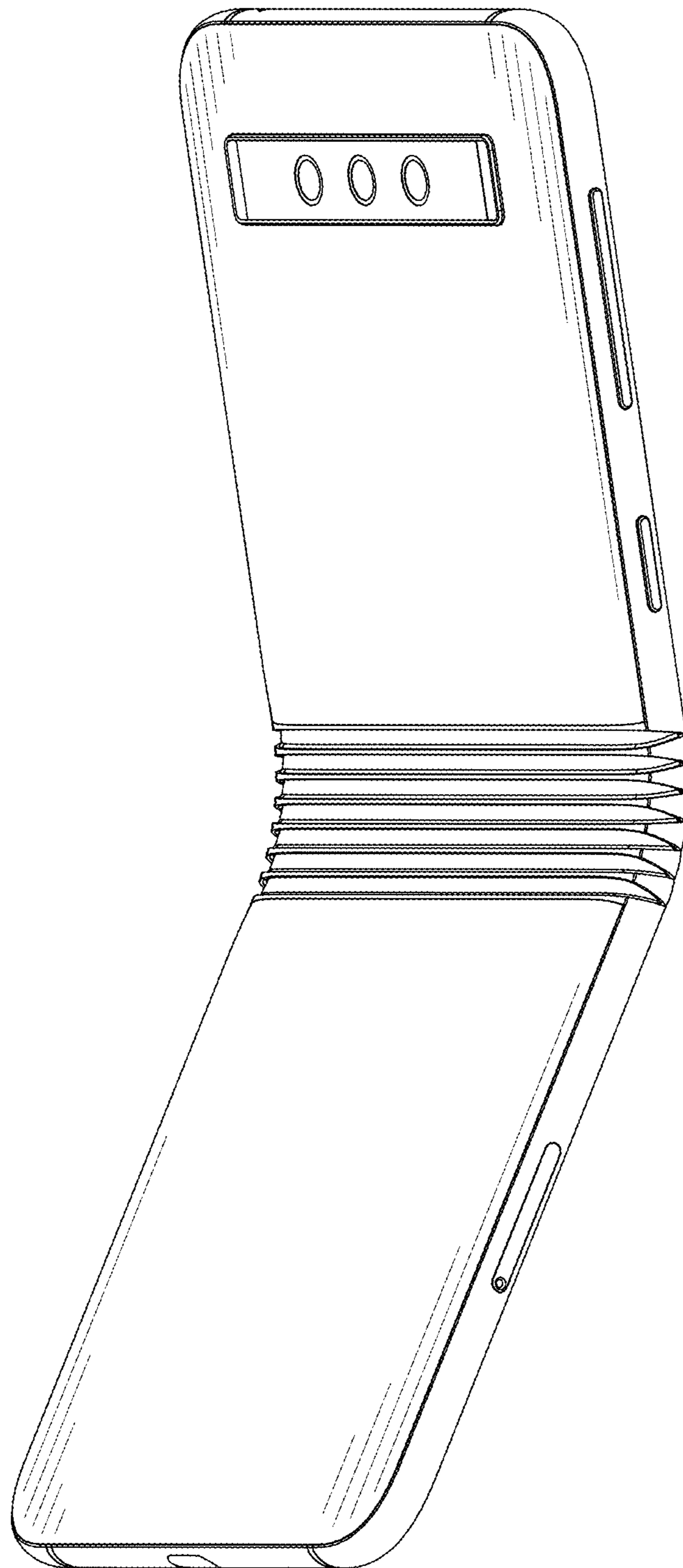
