We claim the ornamental design for a headset respiration faceplate, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a headset respiration faceplate, according to an exemplary embodiment of the present disclosure;

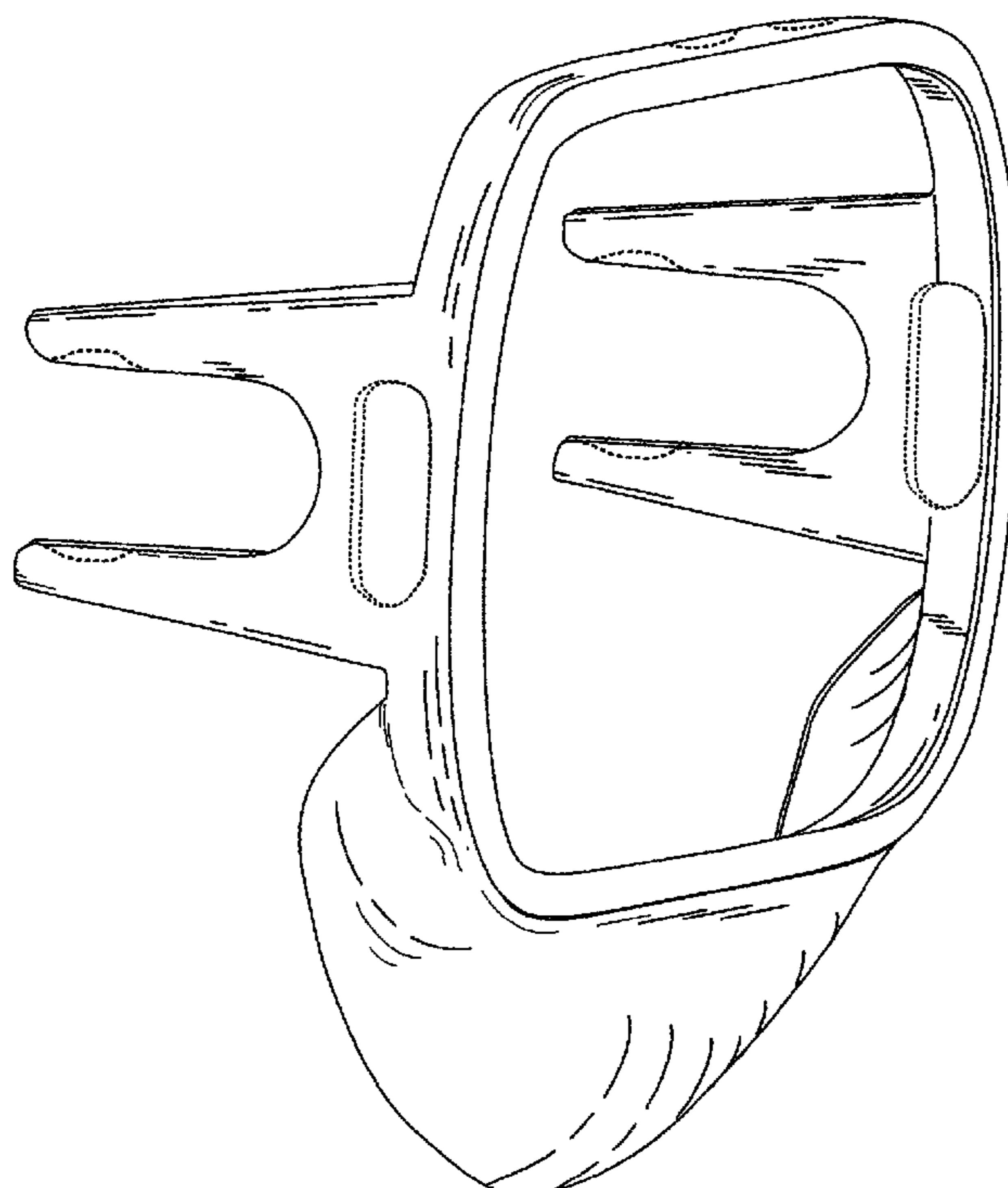

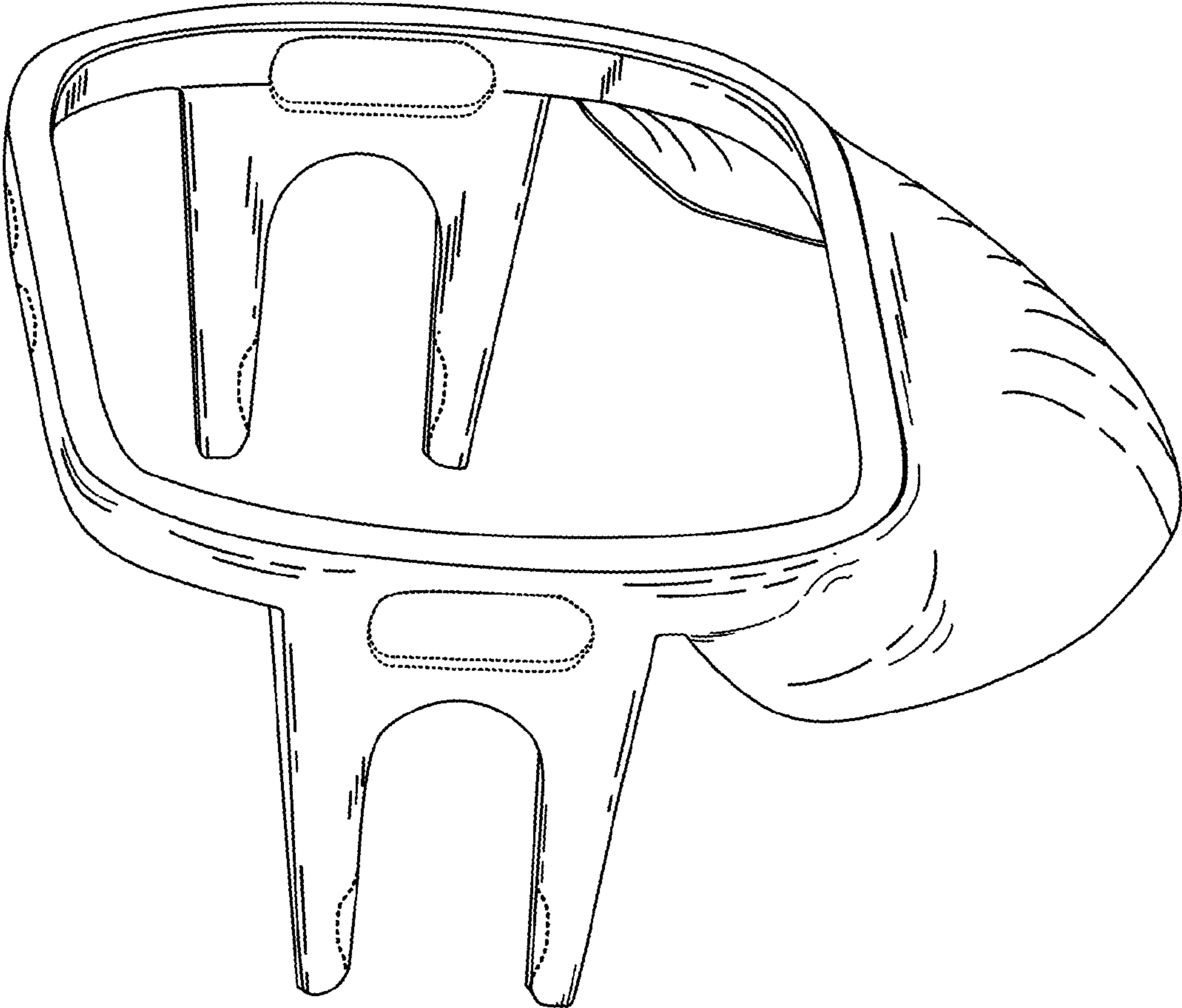

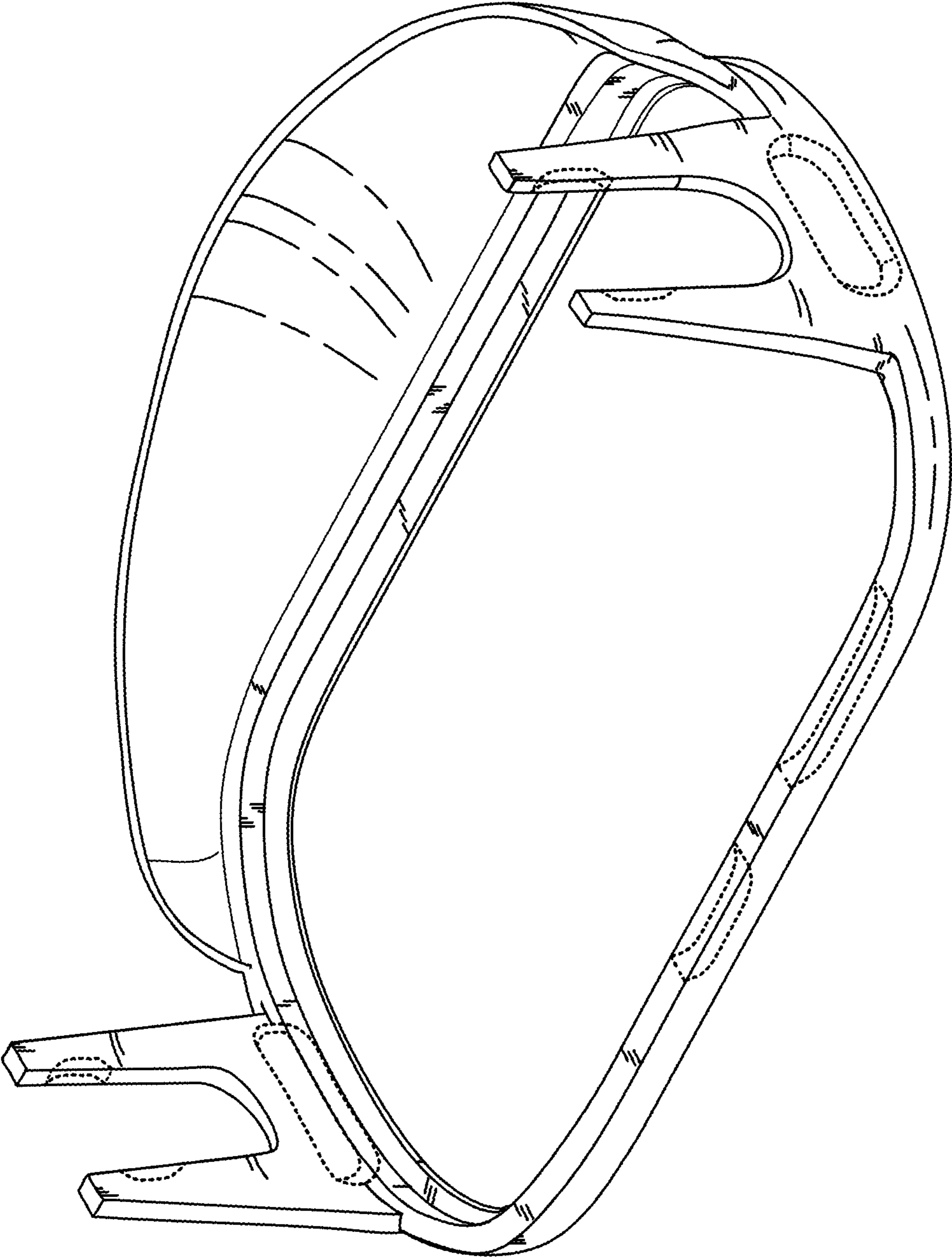

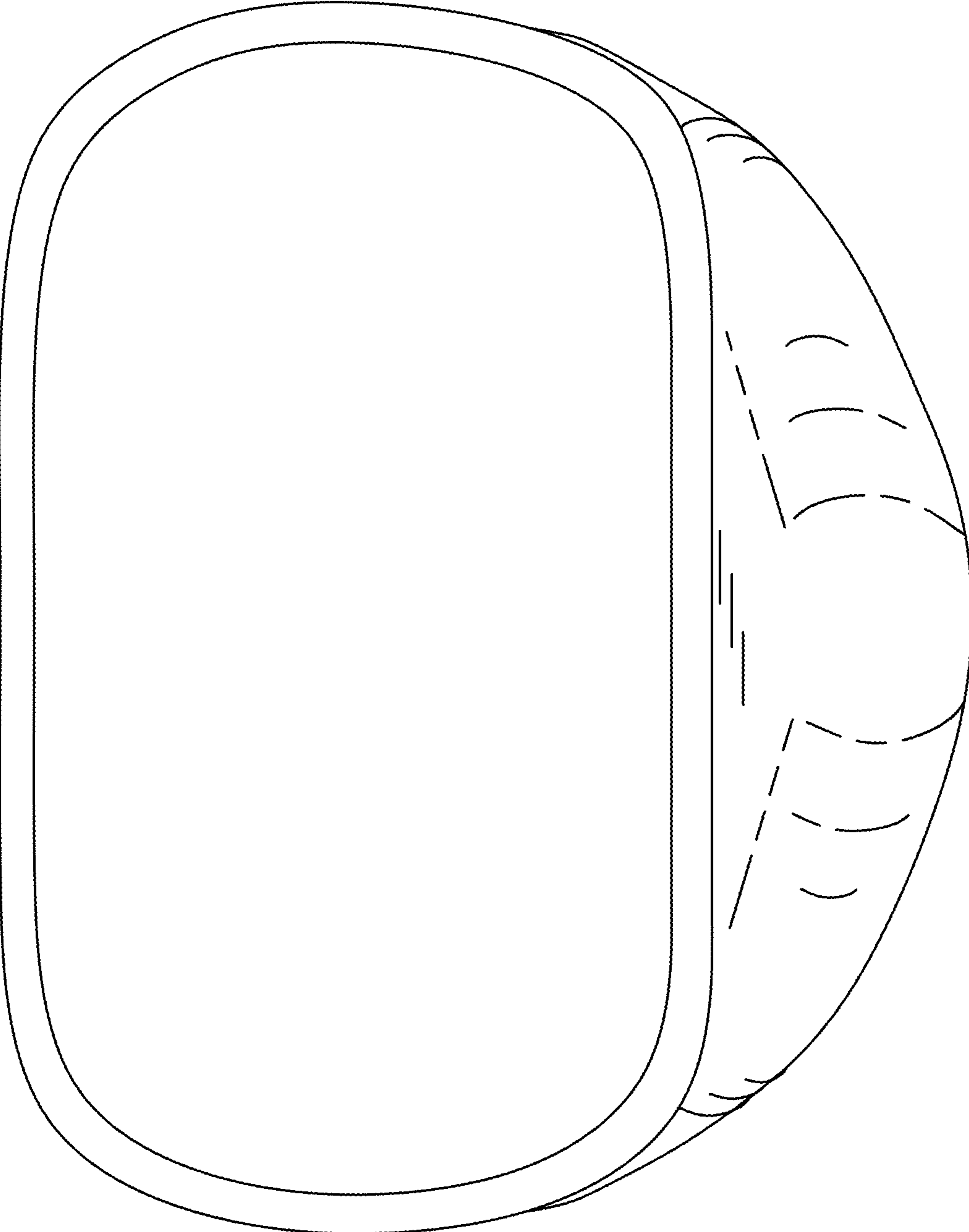

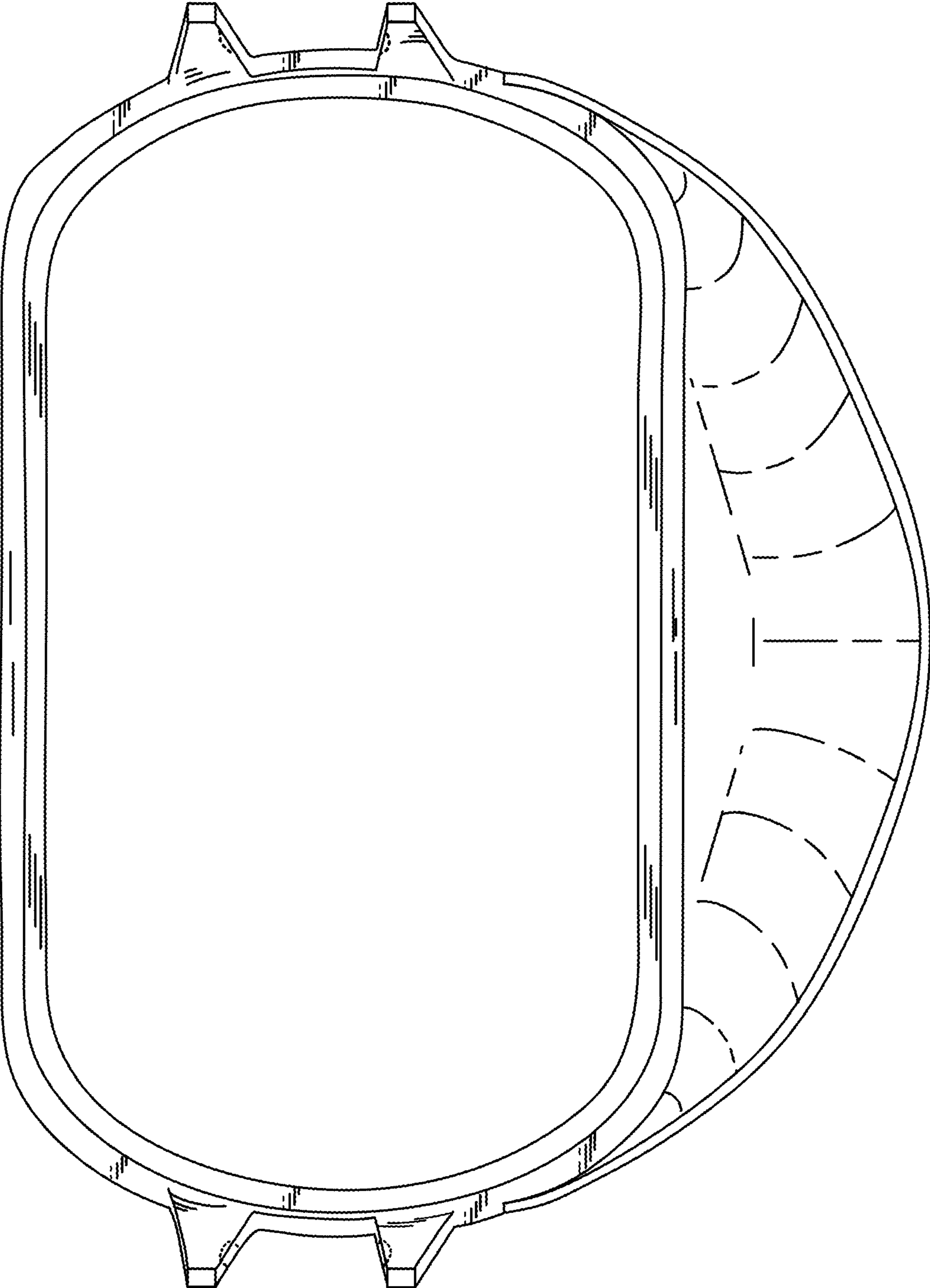

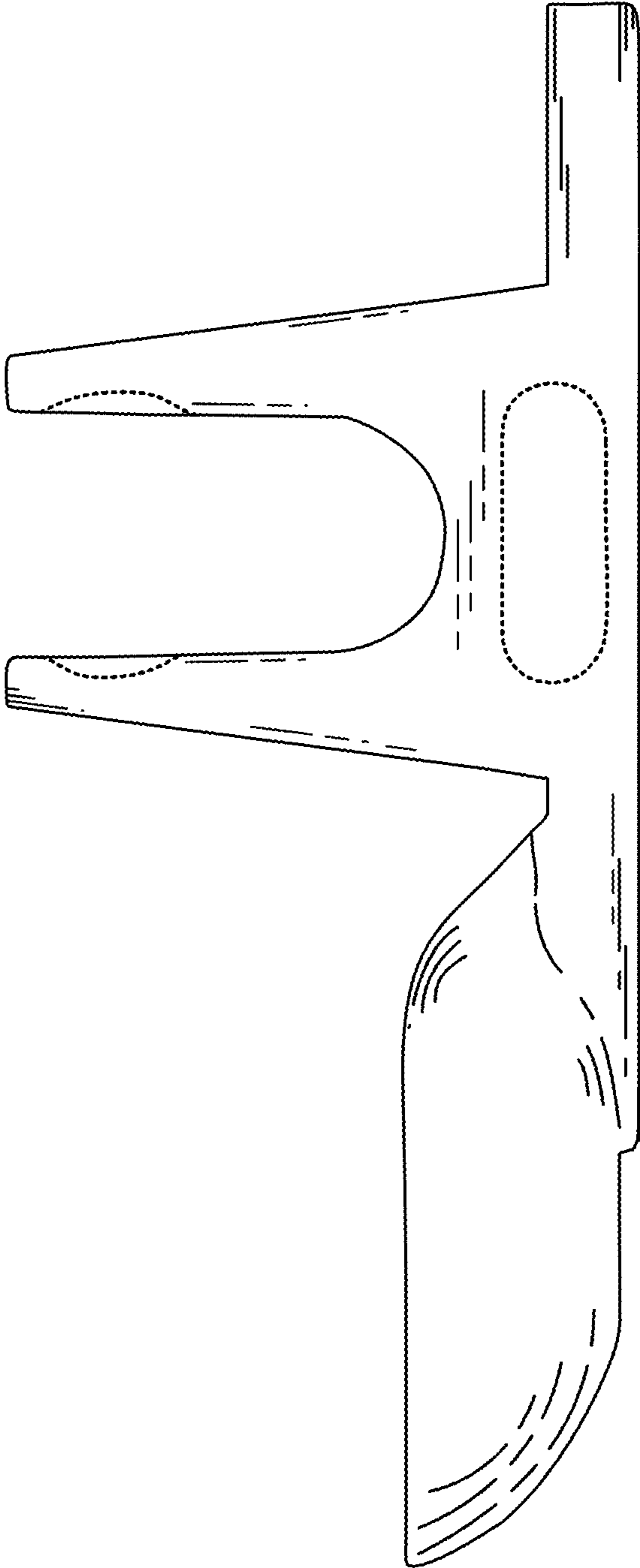

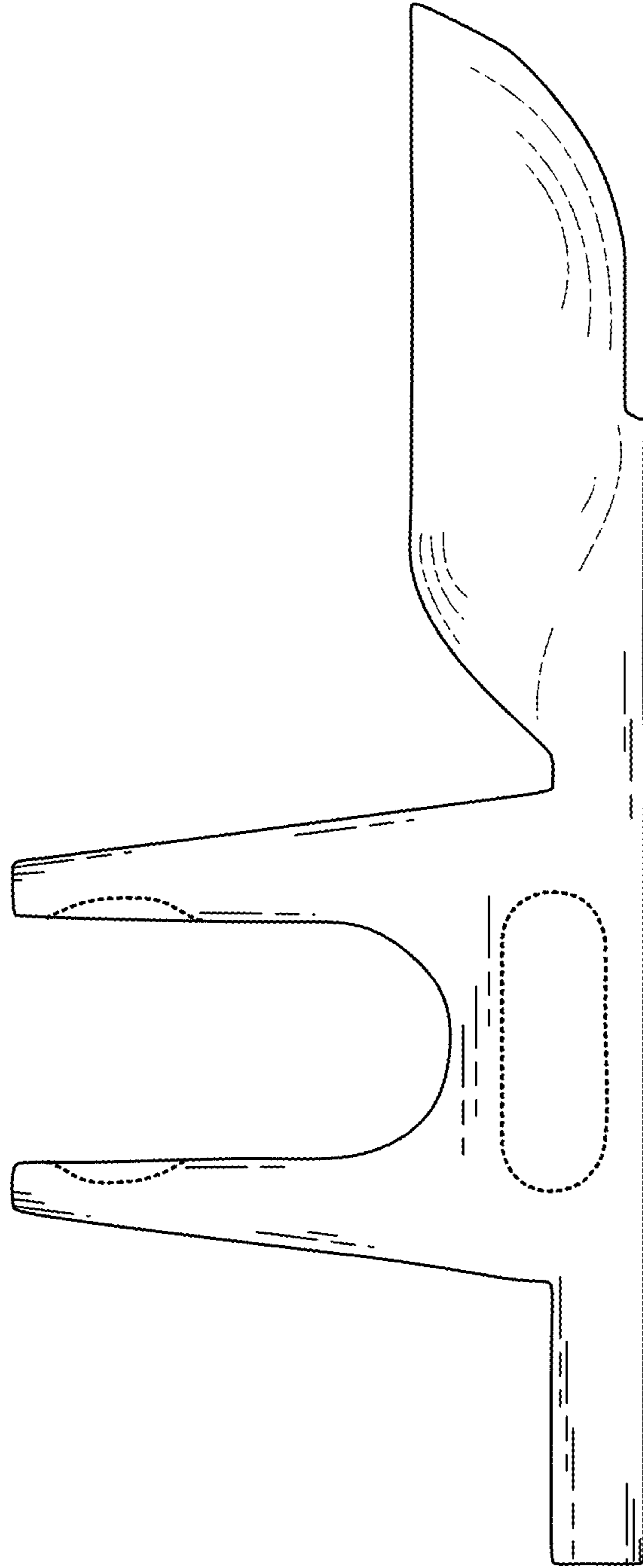

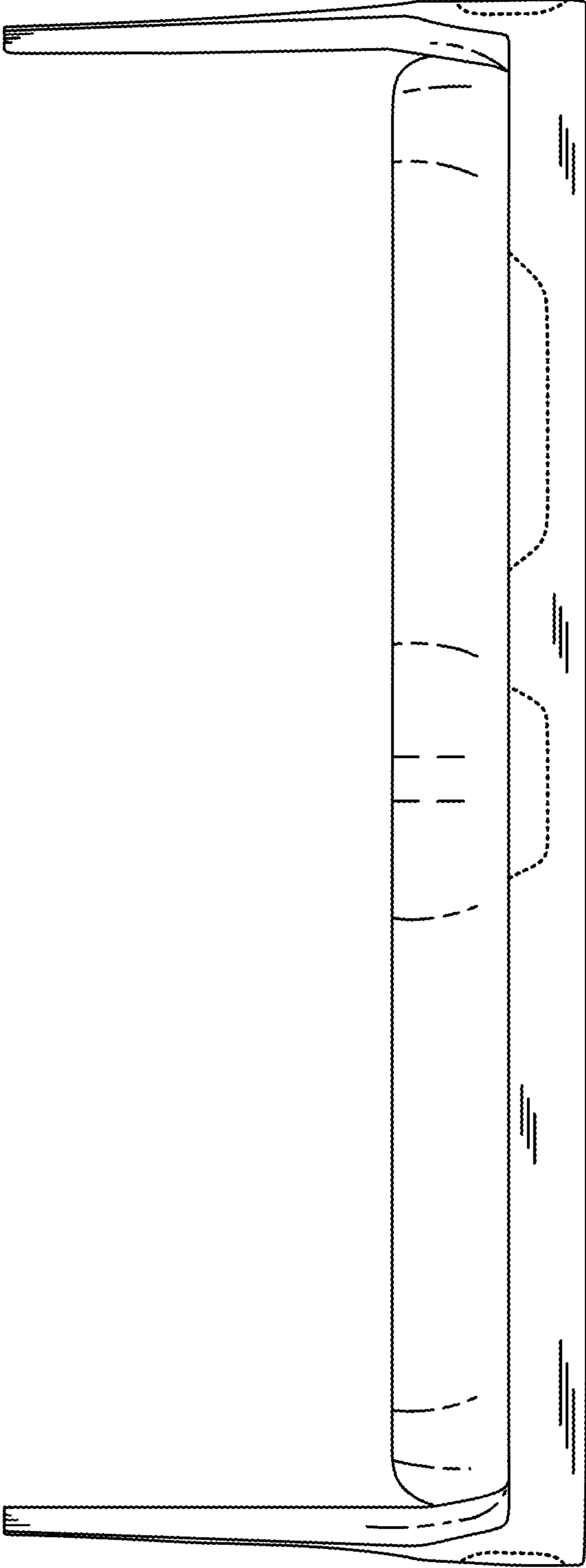

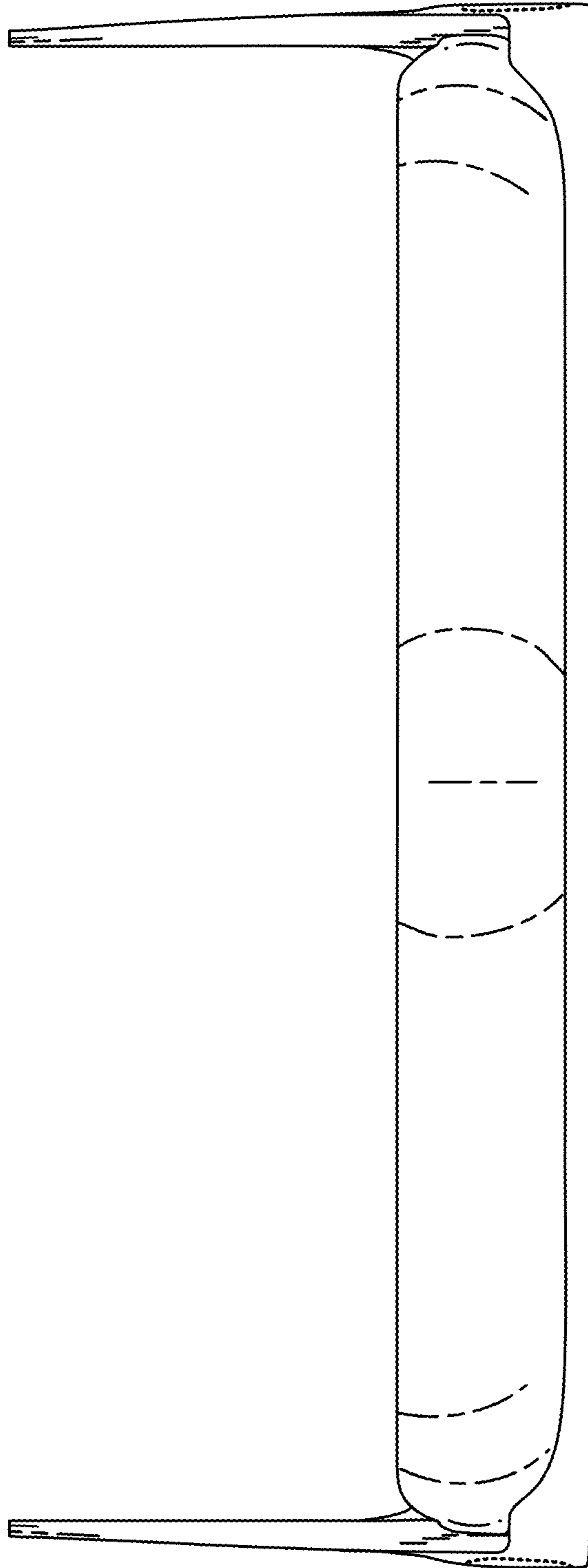
