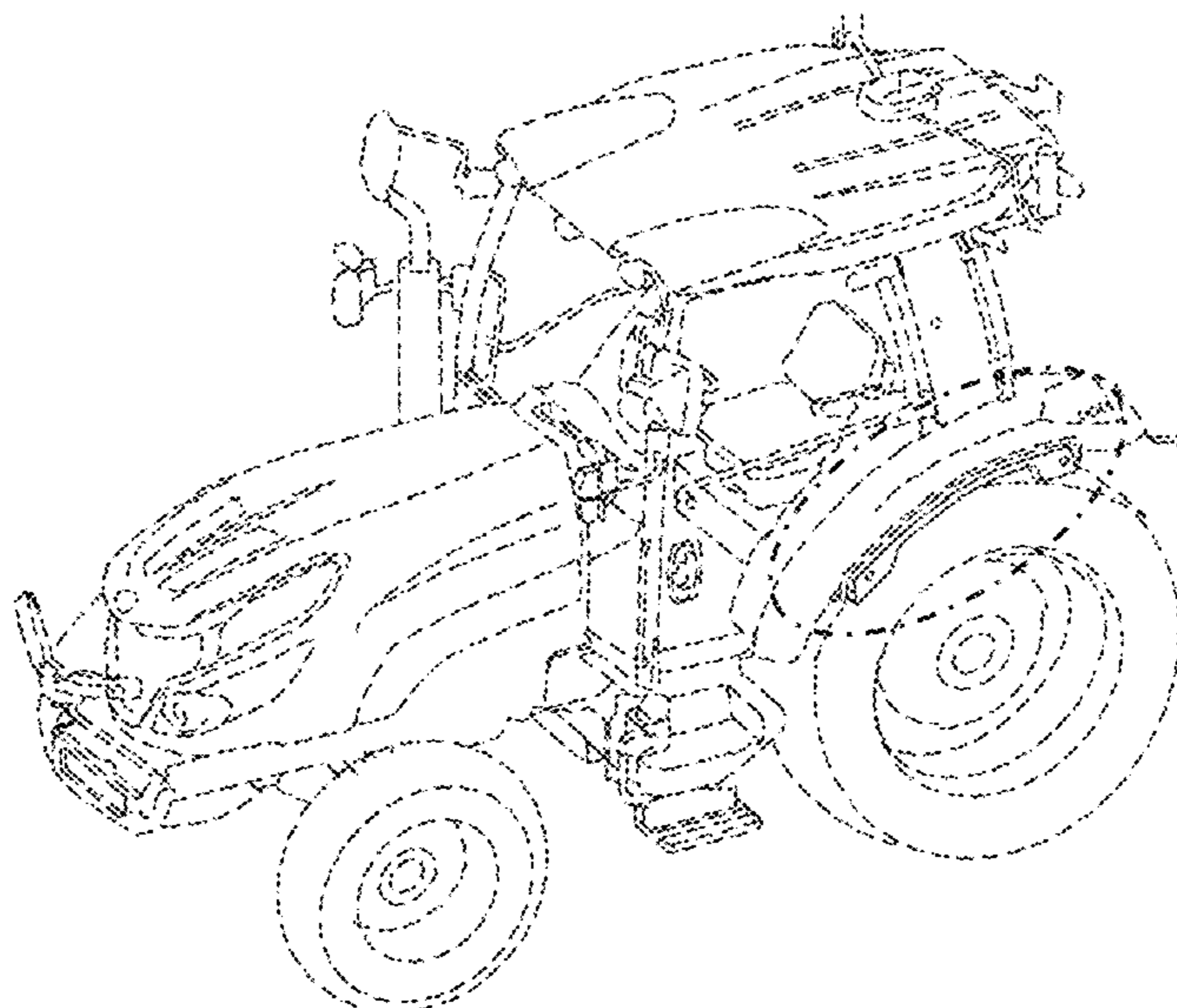
The ornamental design for a mount for tractor, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a mount for tractor; FIG. 2 is an enlarged front elevation view thereof; FIG. 3 is an enlarged rear elevation view thereof; FIG. 4 is an enlarged right side elevation view thereof; and, FIG. 5 is an enlarged top plan view thereof.

The broken line showing of the mount for tractor is for the purpose of illustrating portions of the mount for tractor and forms no part of the claimed design. Shown in dash-dot lines is the boundary of the claimed design.

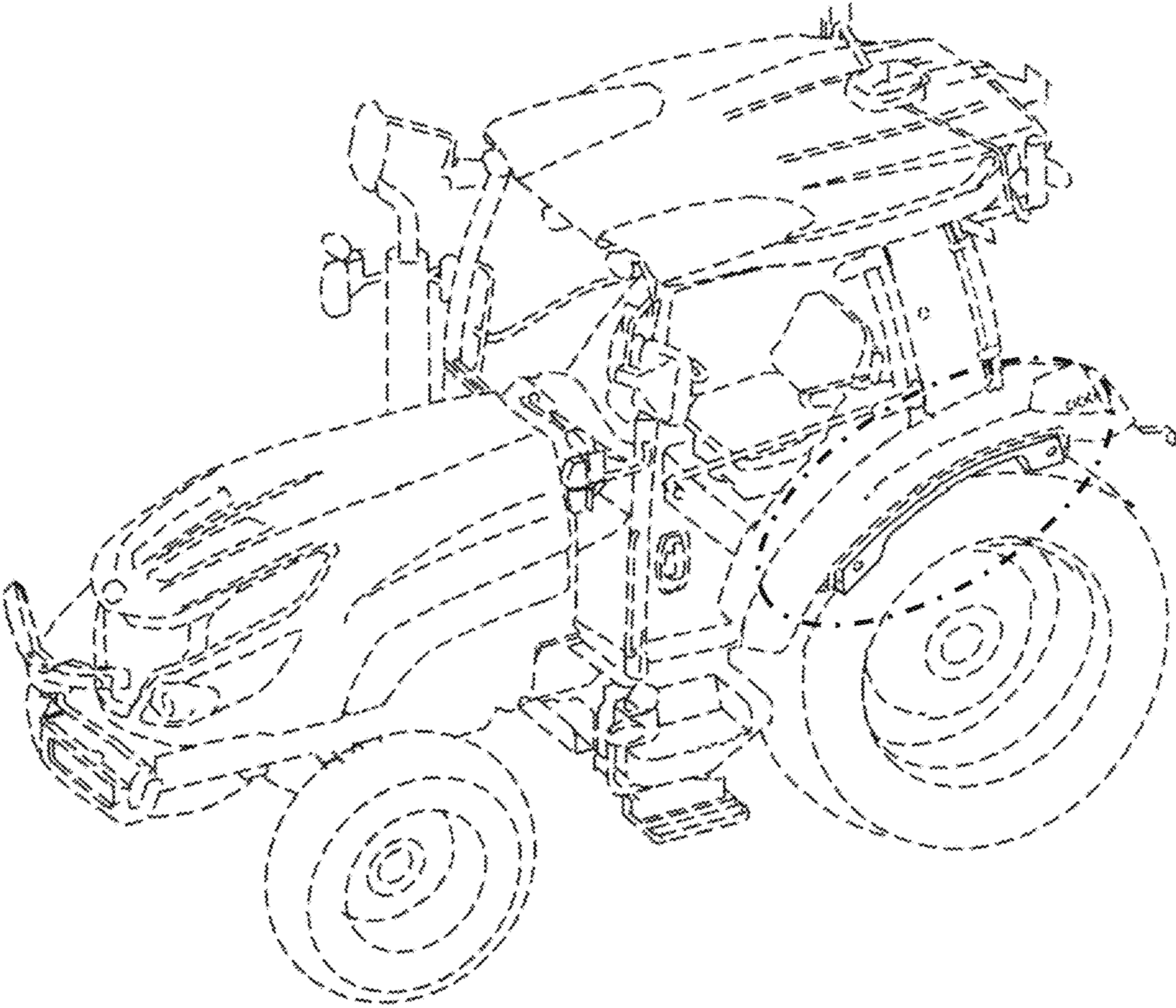

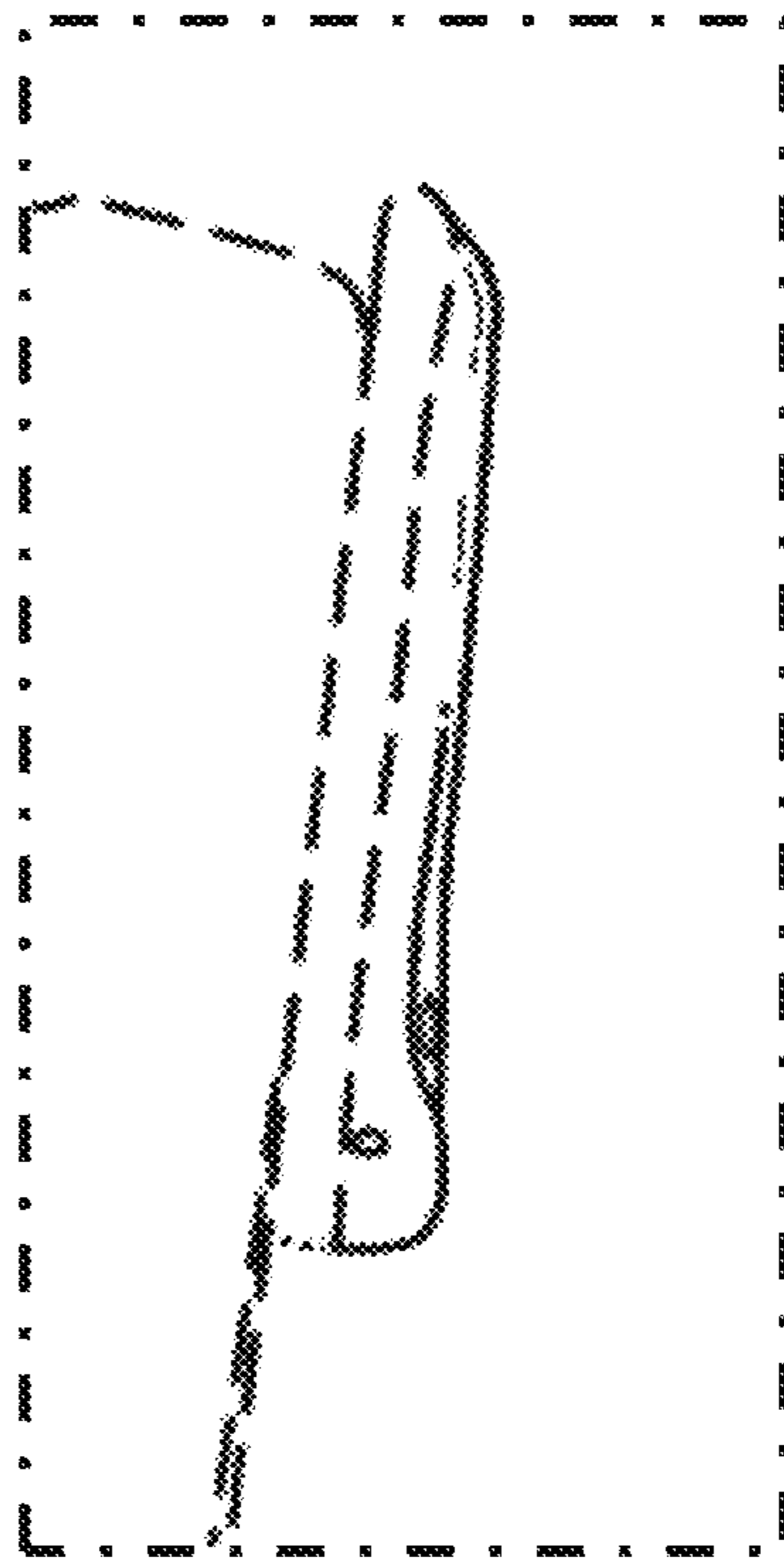

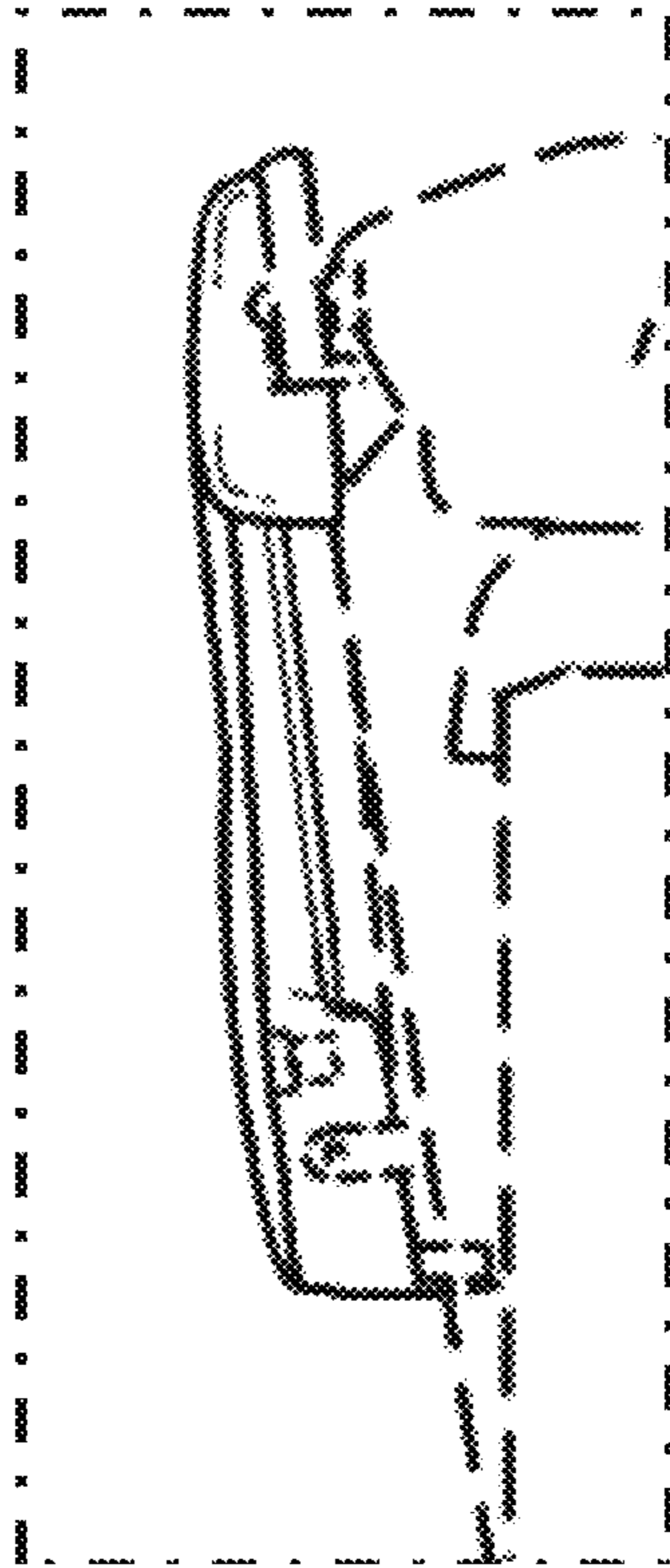

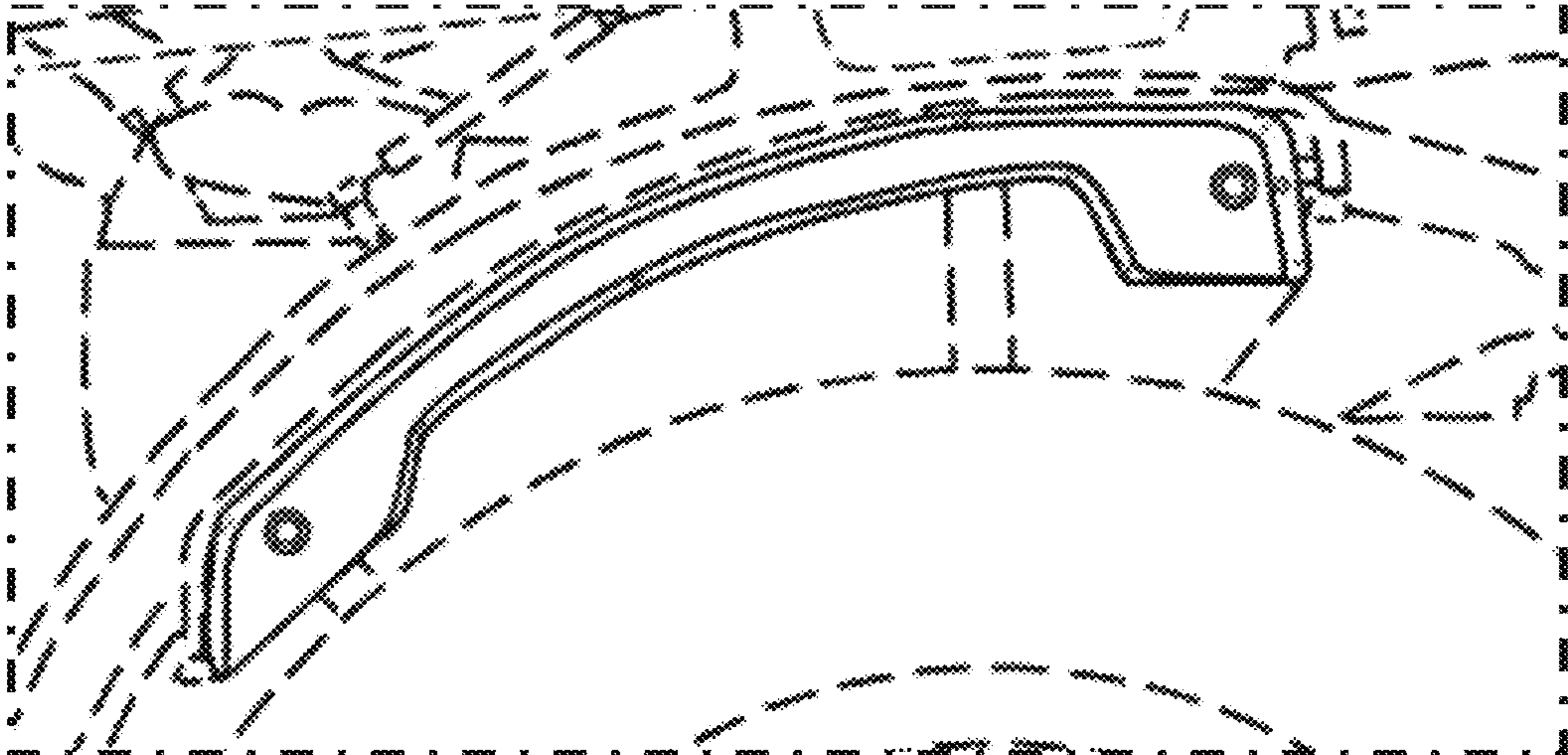

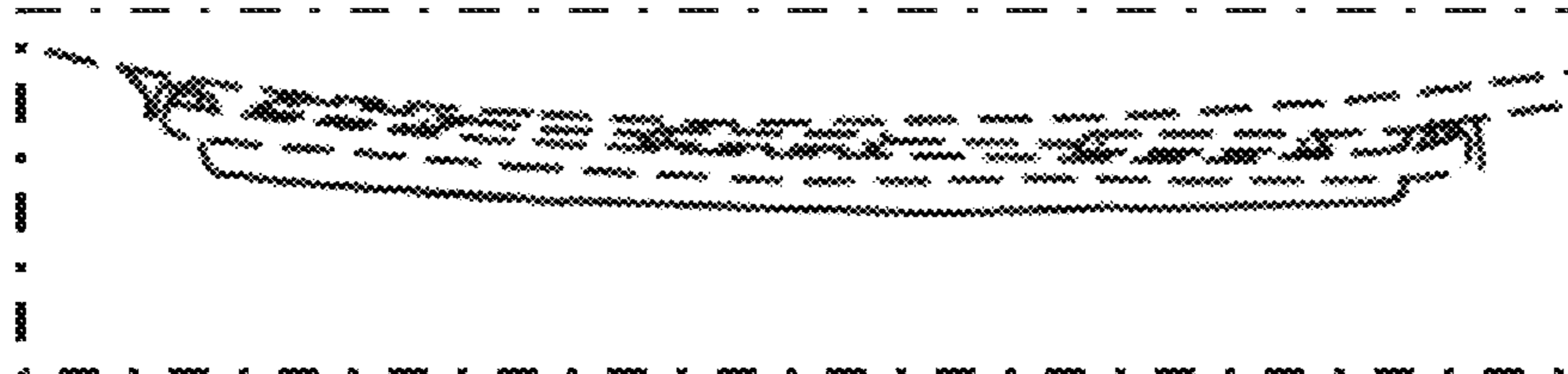
