(57) **CLAIM**

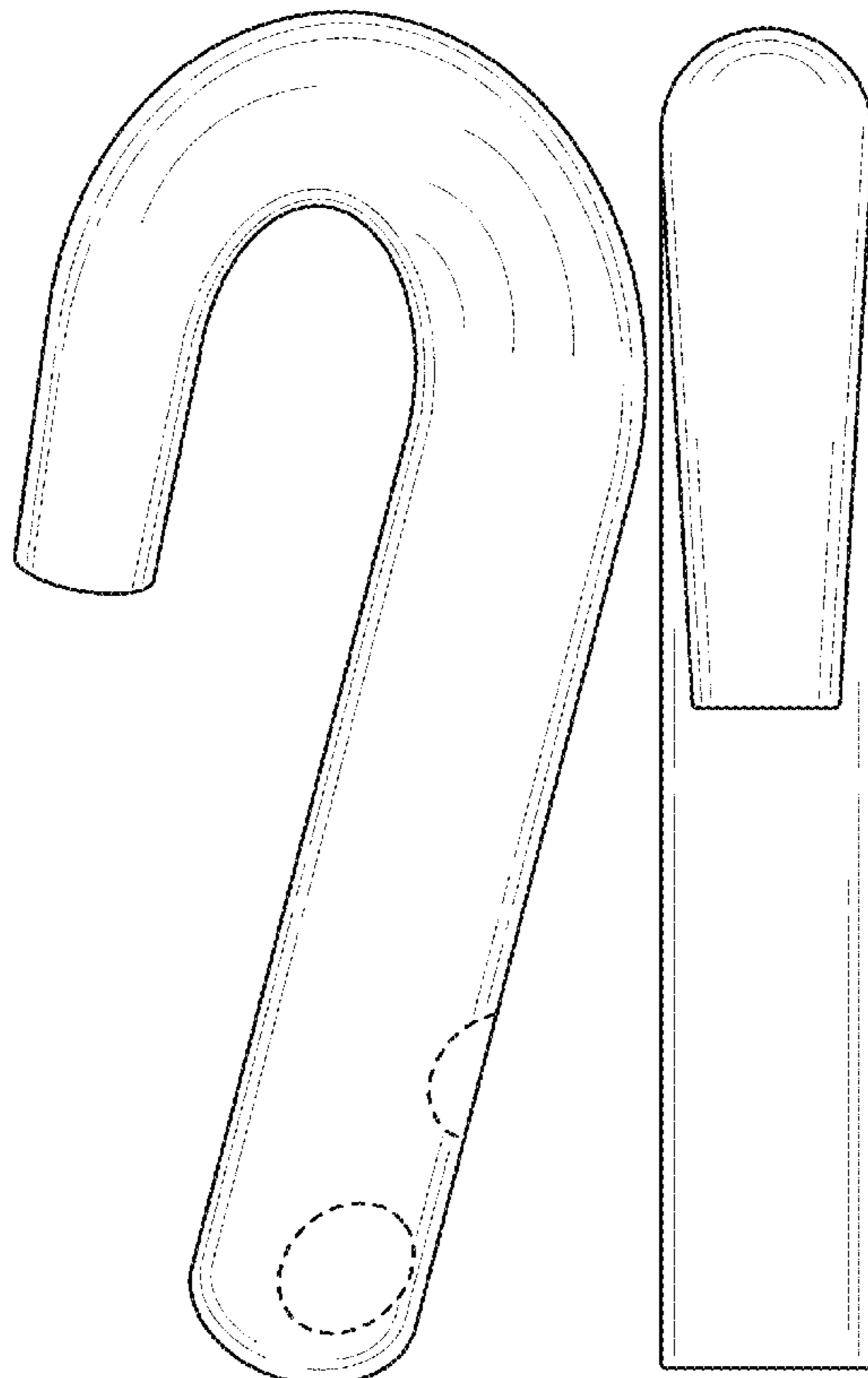
The ornamental design for a baritone saxophone neck, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a baritone saxophone neck; FIG. 2 is a back view of the baritone saxophone neck of FIG. 1; FIG. 3 is a front view of the baritone saxophone neck of FIG. 1; FIG. 4 is a first side view of the baritone saxophone neck of FIG. 1; FIG. 5 is a second side view of the baritone saxophone neck of FIG. 1; FIG. 6 is a top view of the baritone saxophone neck of FIG. 1; and, FIG. 7 is a bottom view of the baritone saxophone neck of FIG. 1. The broken lines illustrate portions of the baritone saxophone neck and form no part of the claimed design.

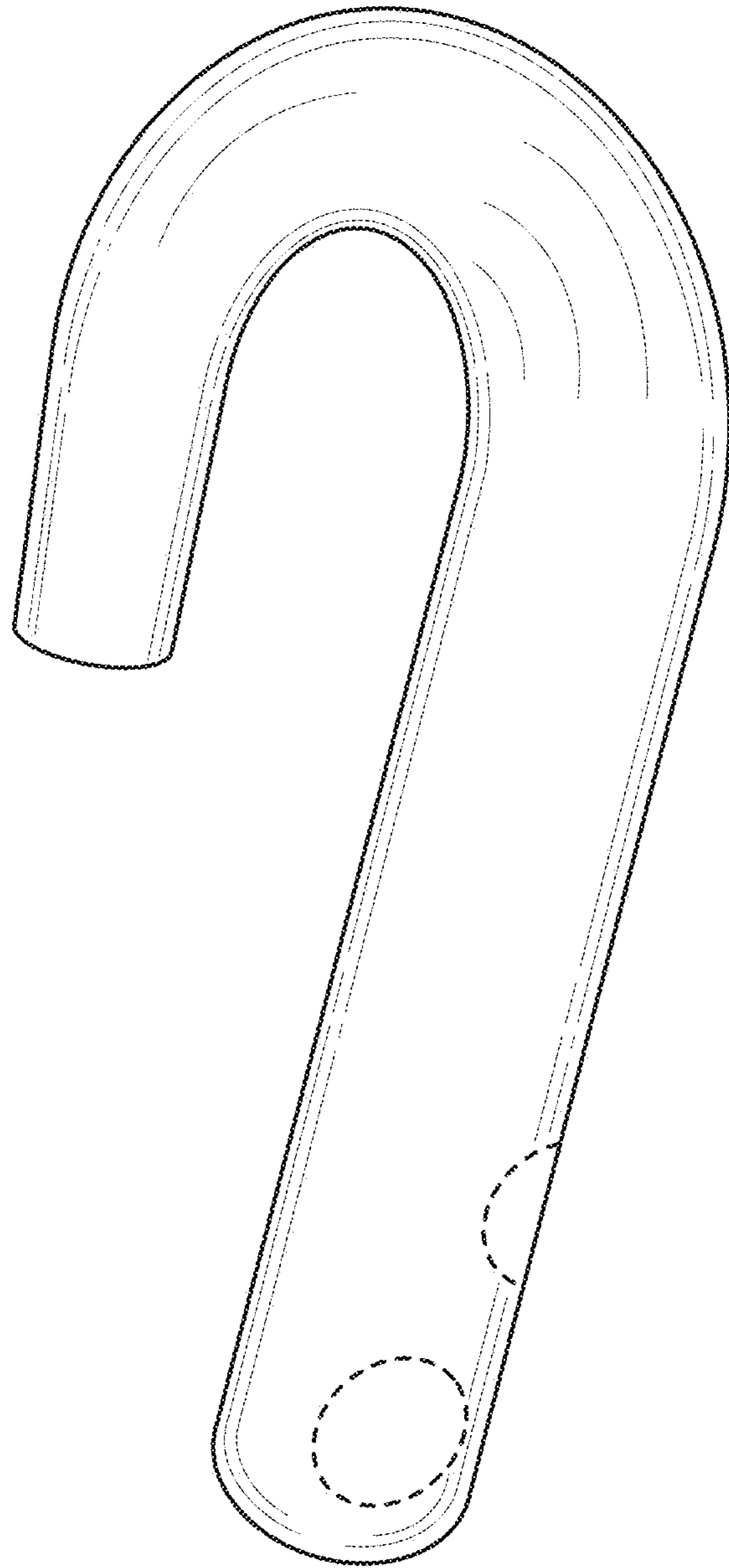

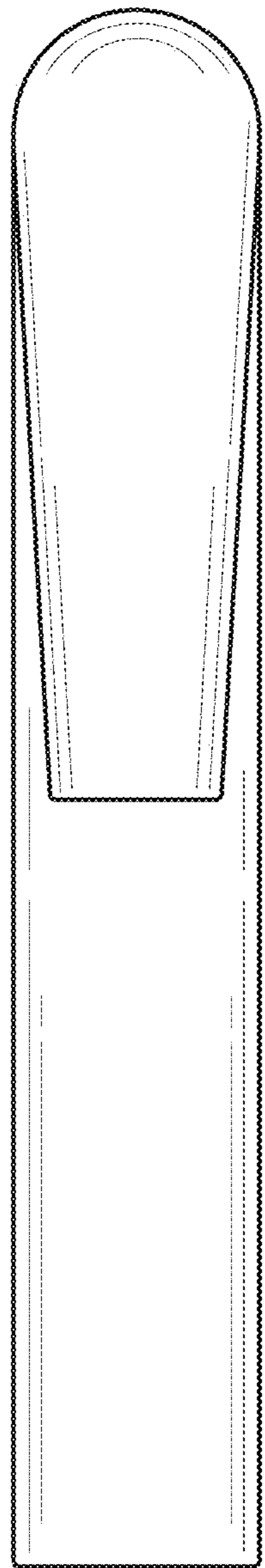

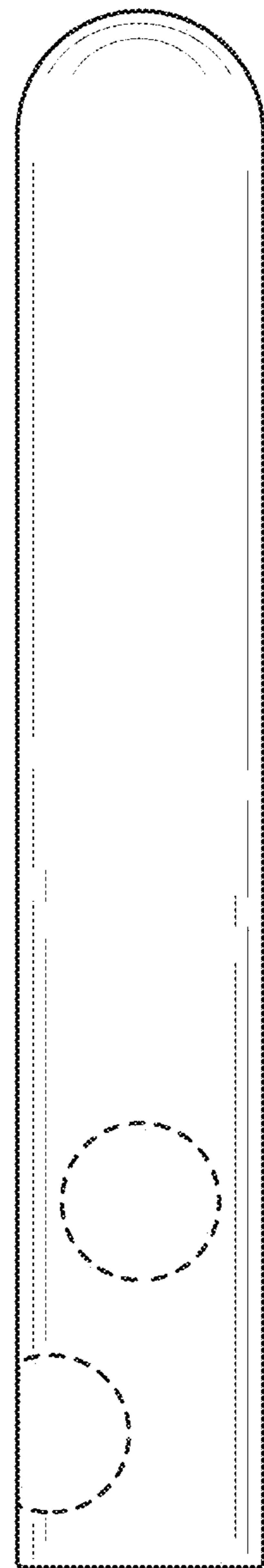

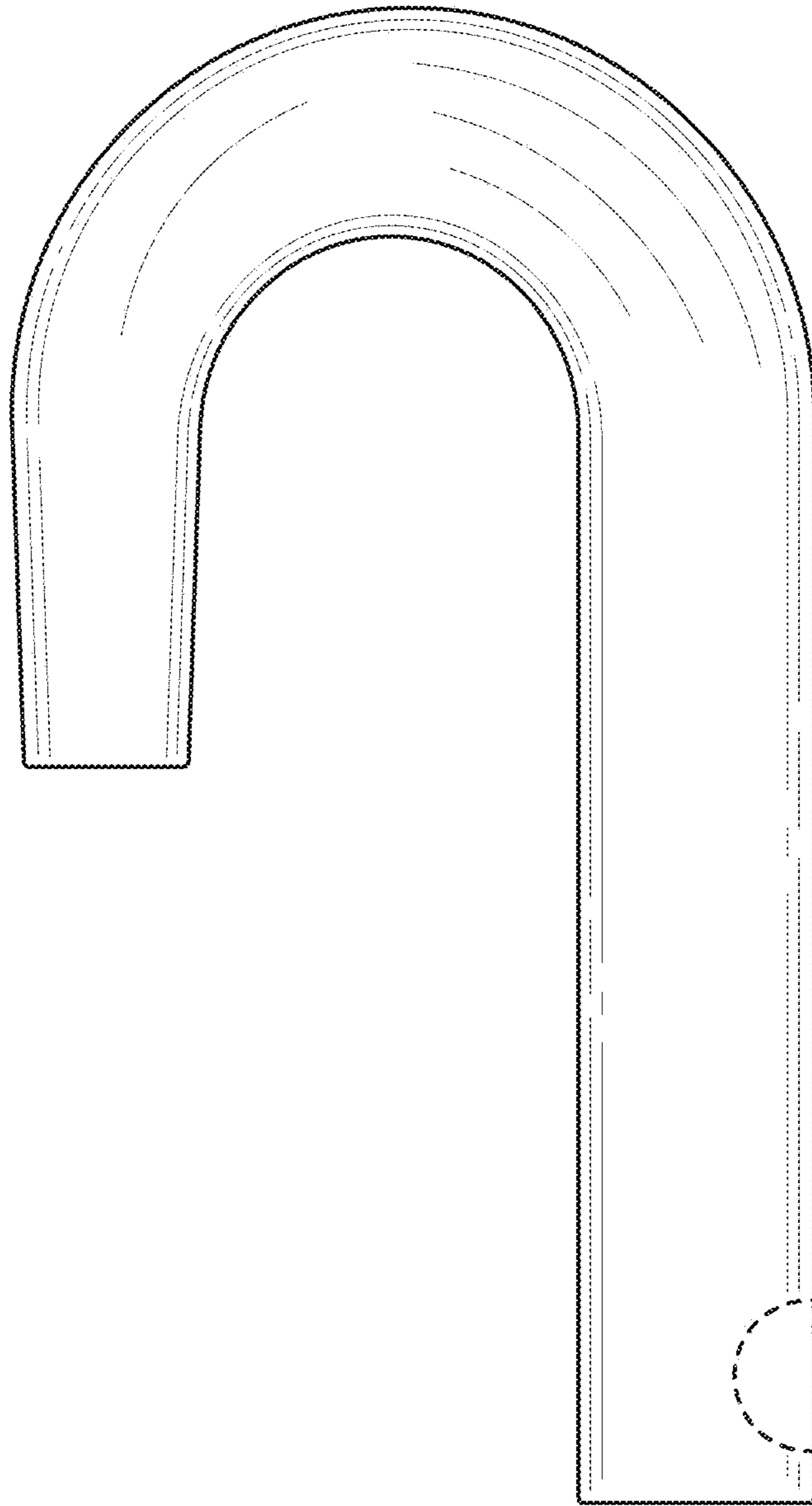

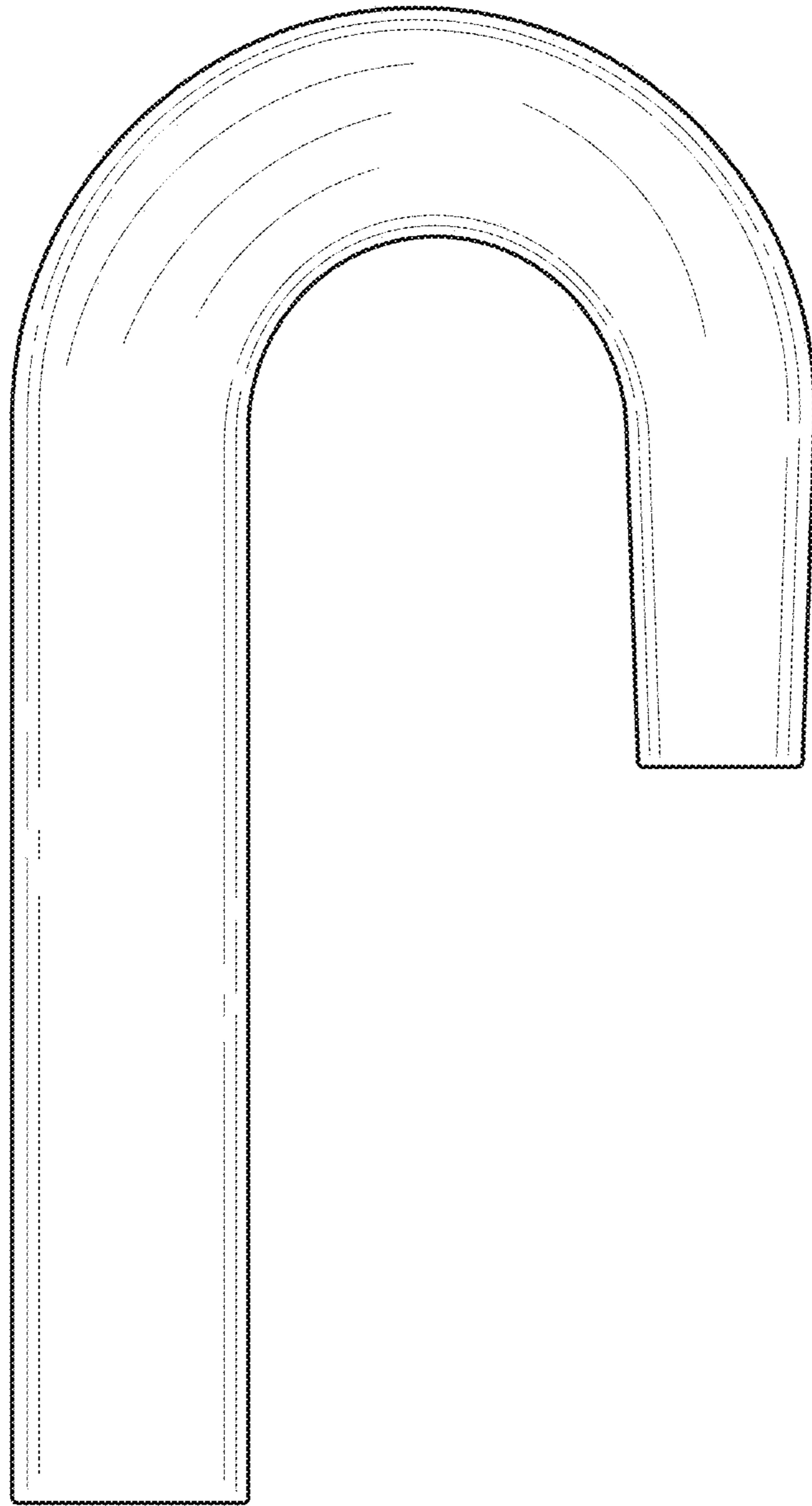

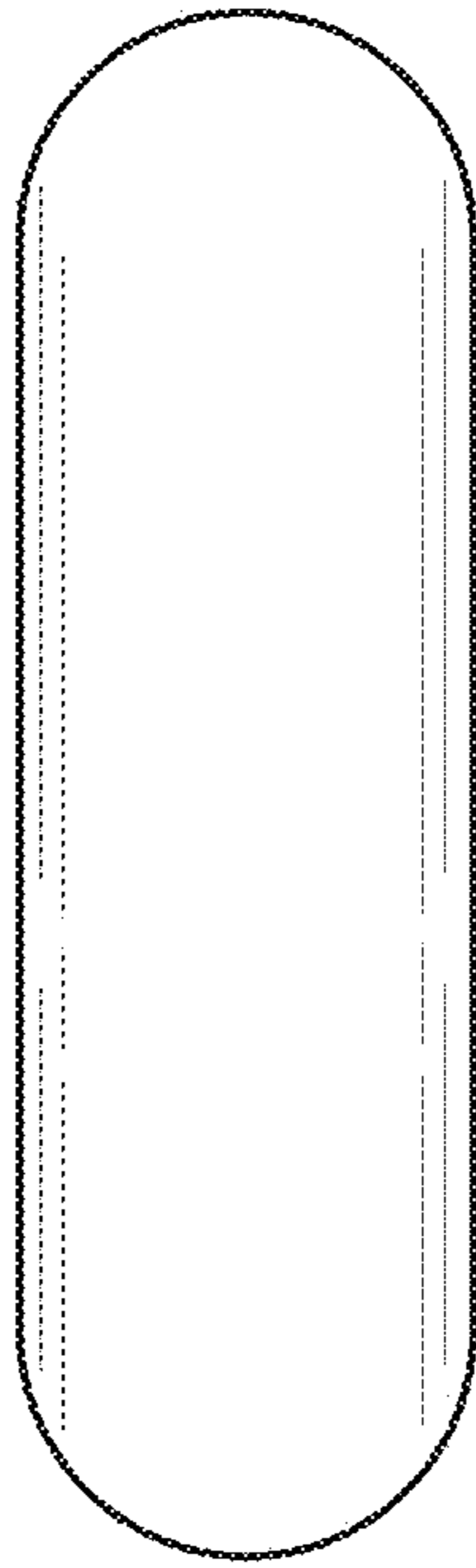

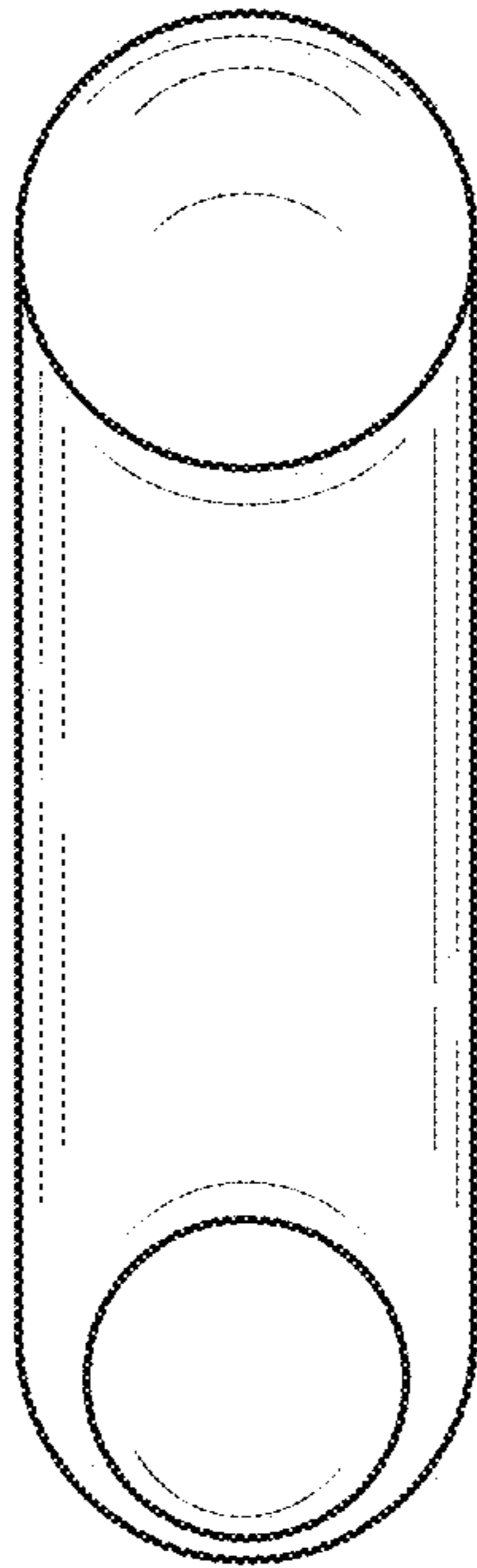
