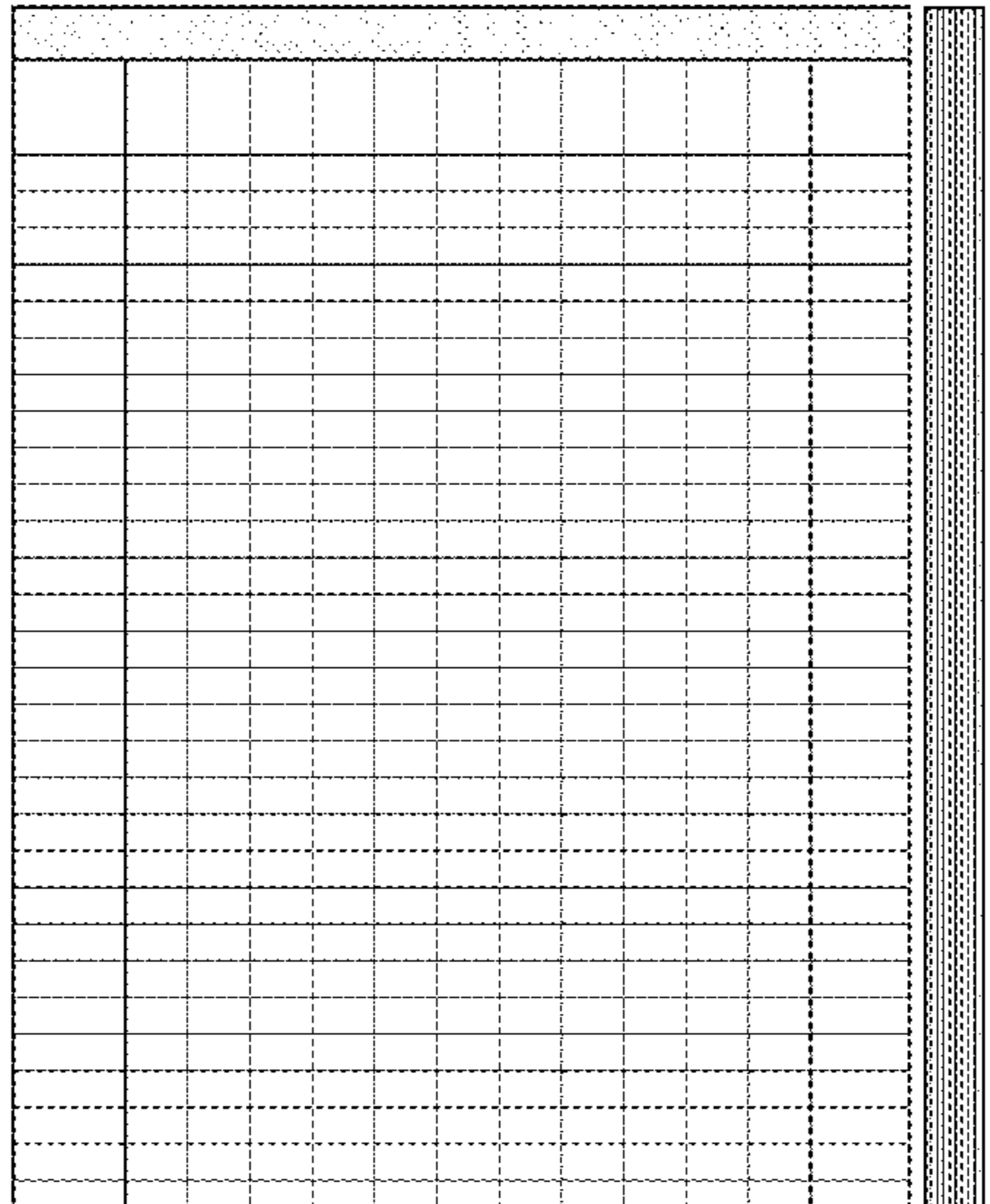
The ornamental design for a writing tablet with tab lines, as shown and described.

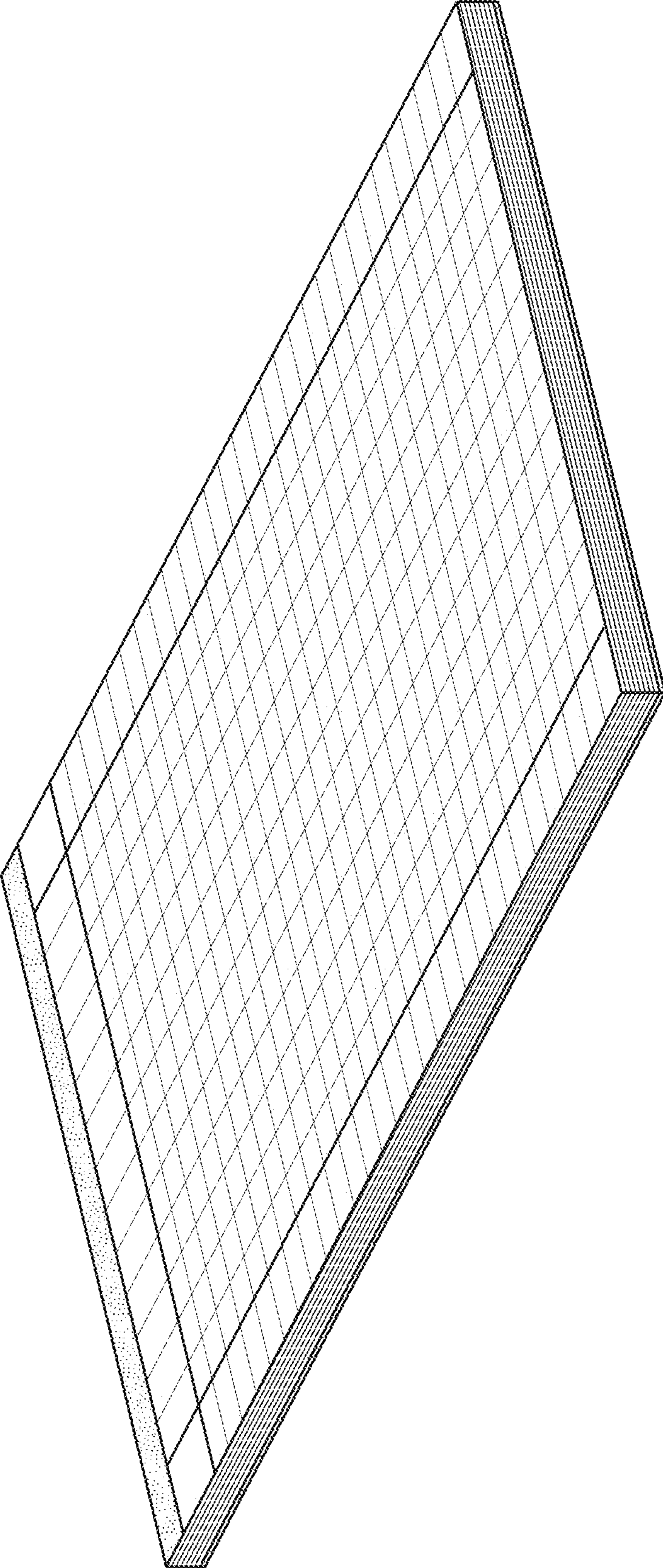

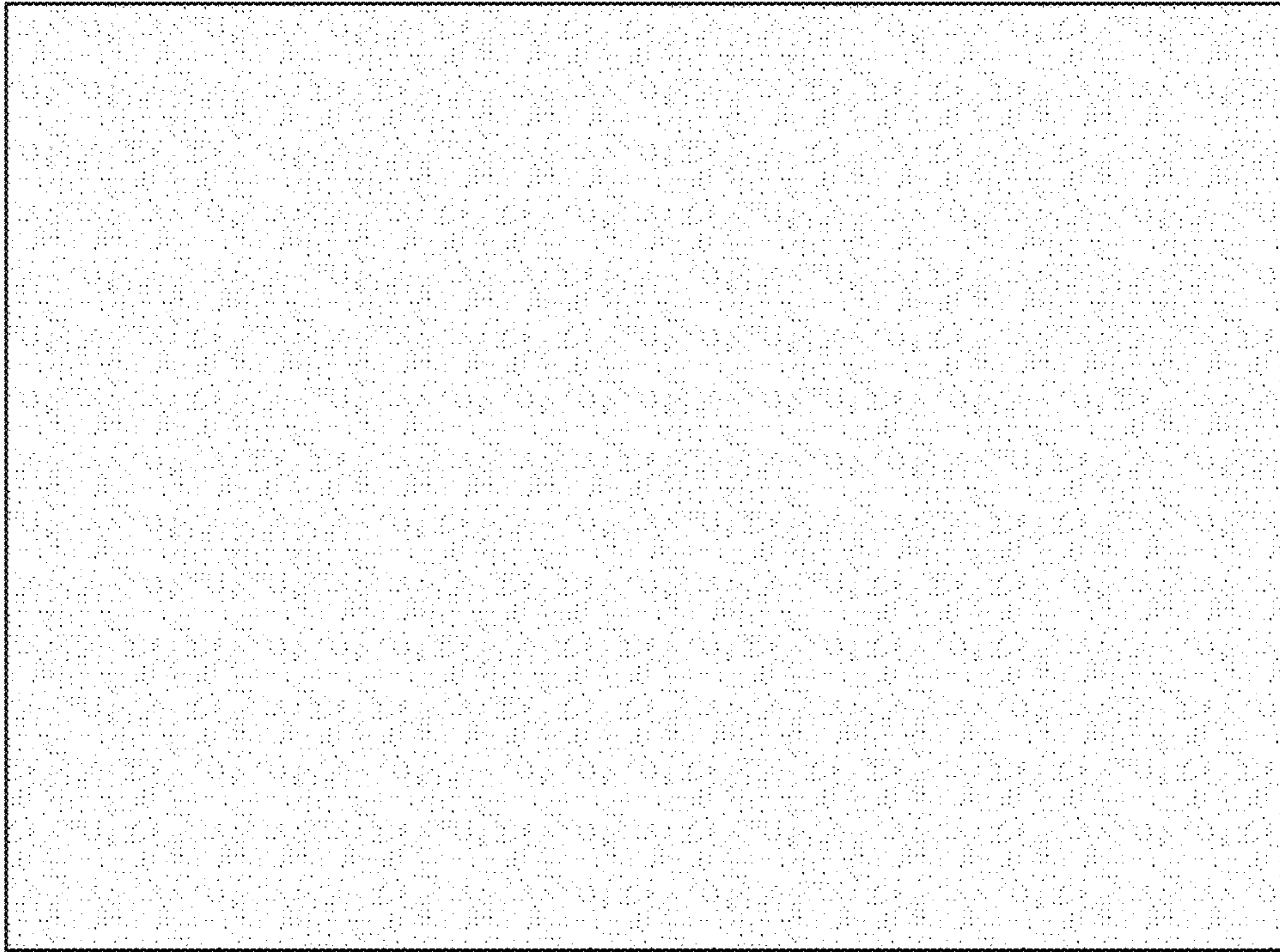

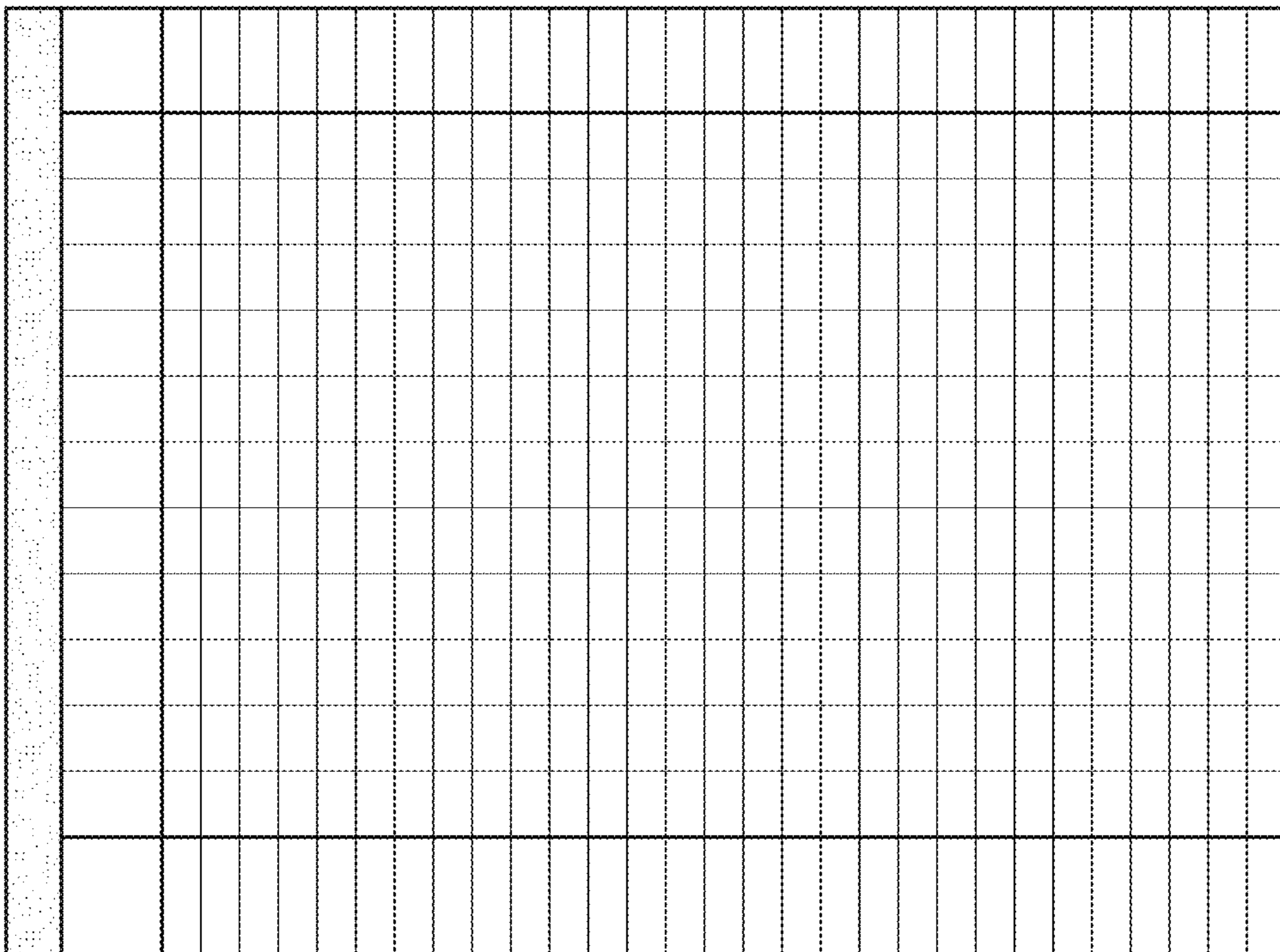

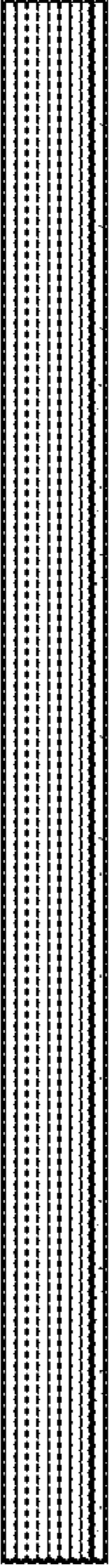
