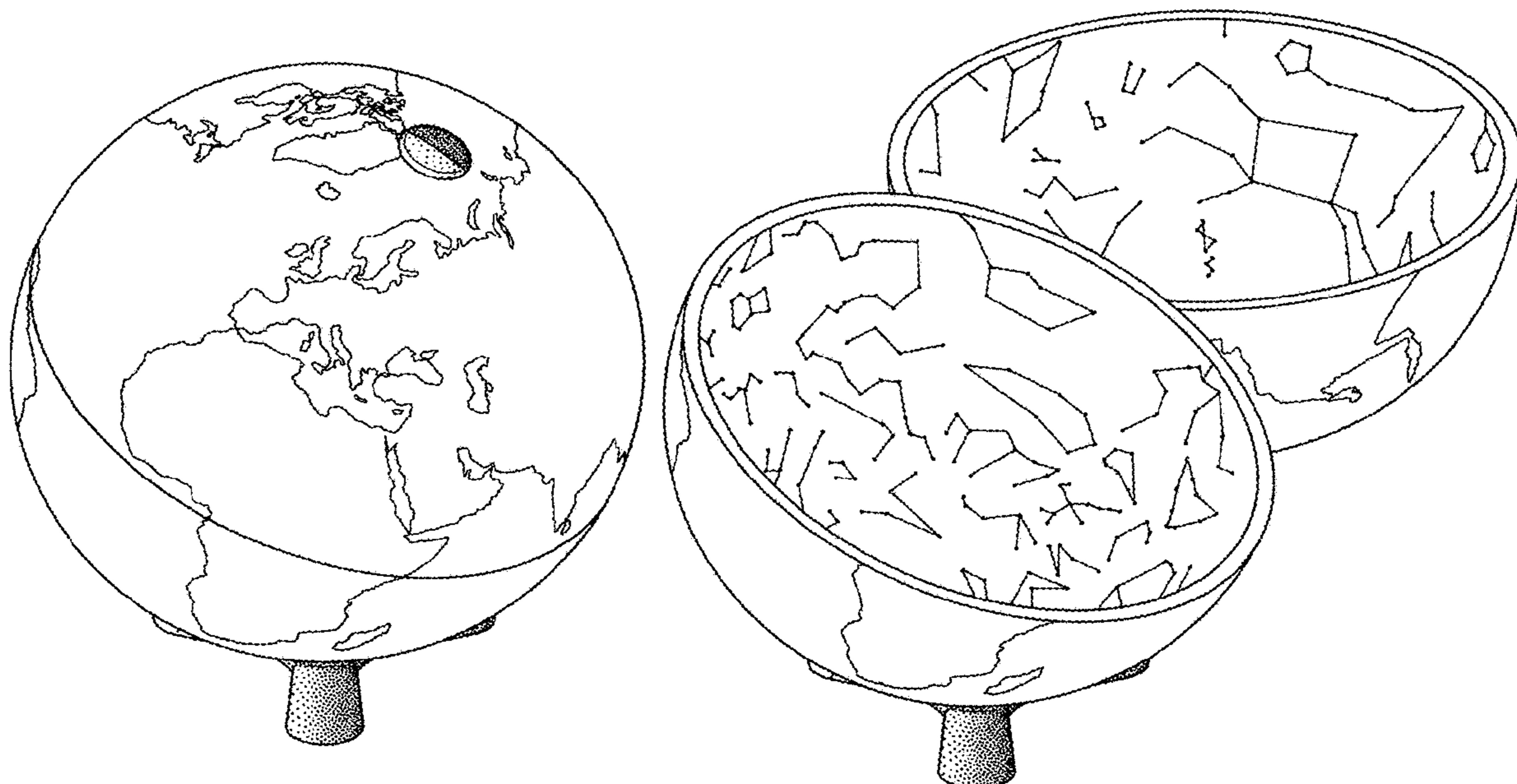
(57) **CLAIM**

The ornamental design for a globe with stand, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a globe with stand showing our new design in a first configuration; FIG. 2 is a perspective view of the globe with stand in an alternate configuration thereof; FIG. 3 is a front elevation view of FIG. 1; FIG. 4 is a rear elevation view thereof; FIG. 5 is a left-side elevation view thereof; FIG. 6 is a right-side elevation view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof. The stipple shading as used in this application is a drafting convention used to show contrast with adjacent surfaces.

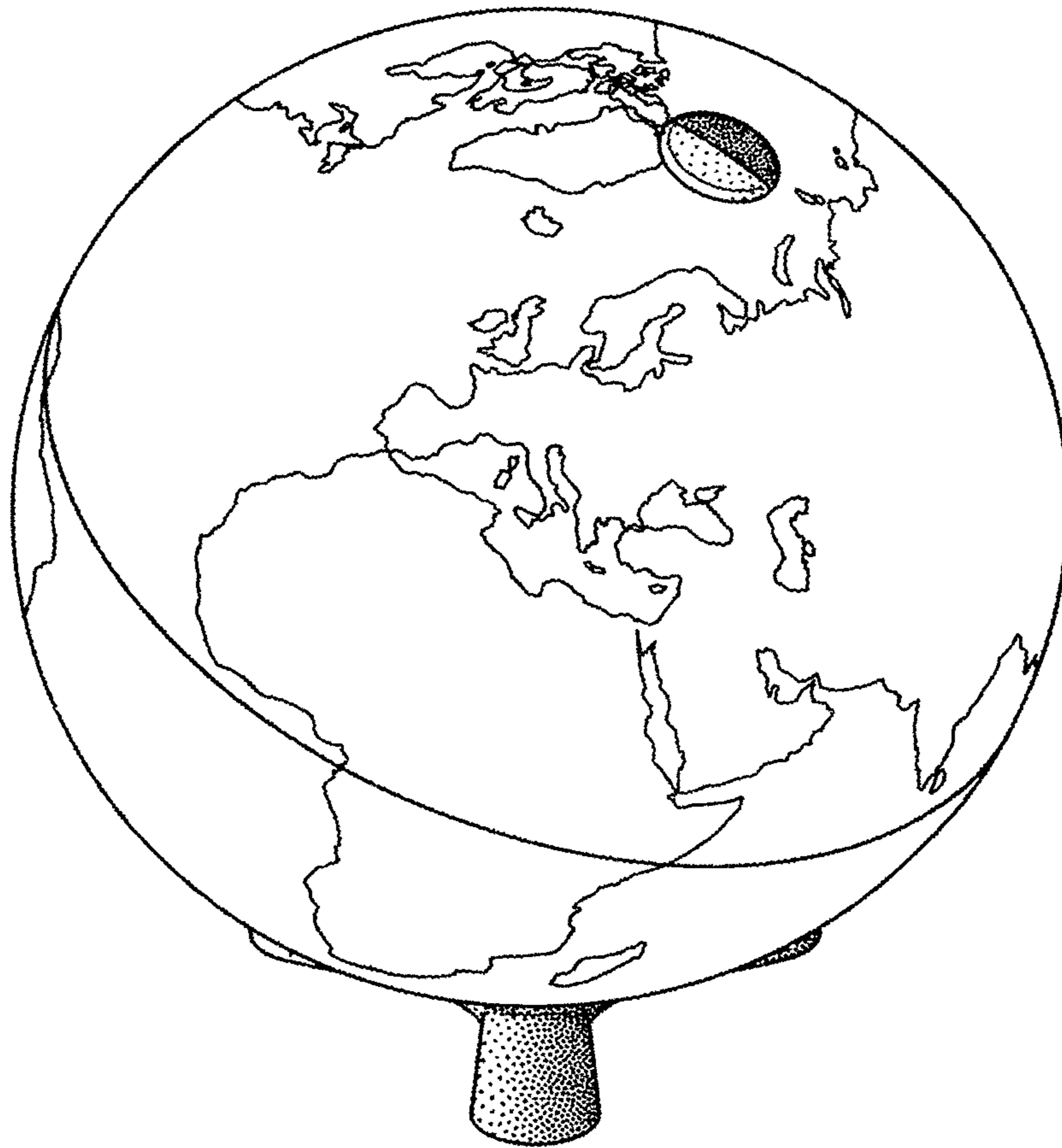

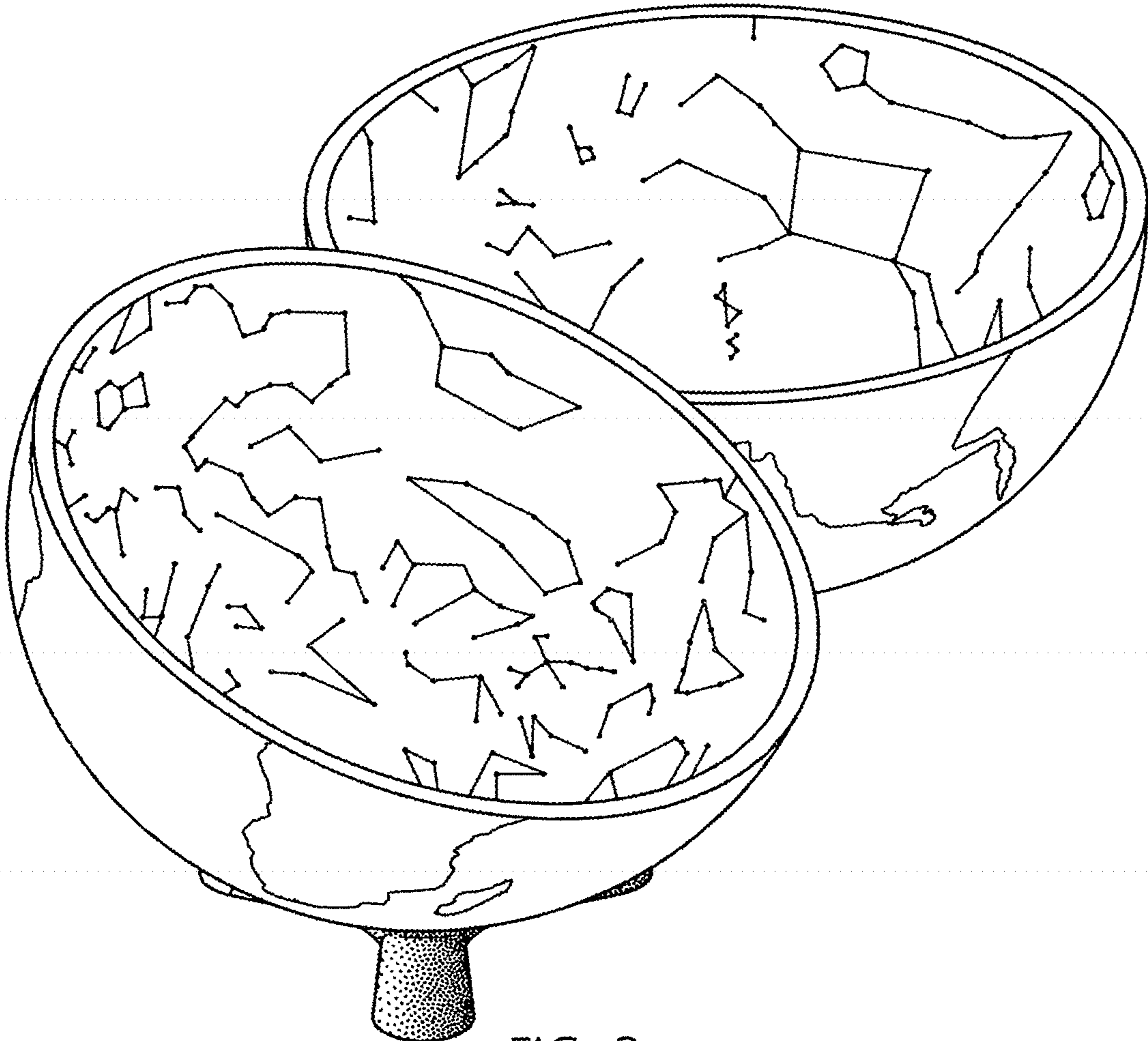

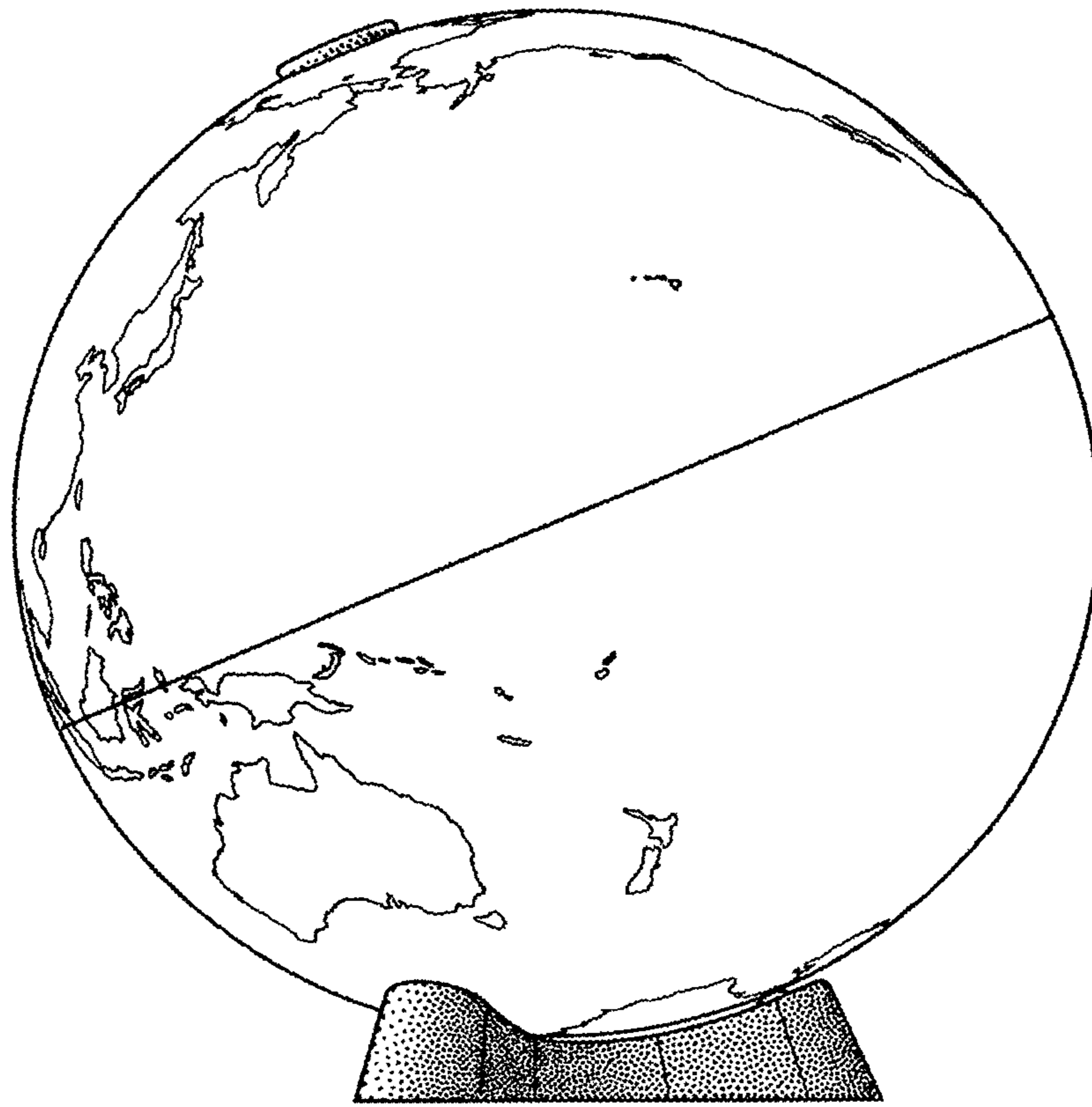

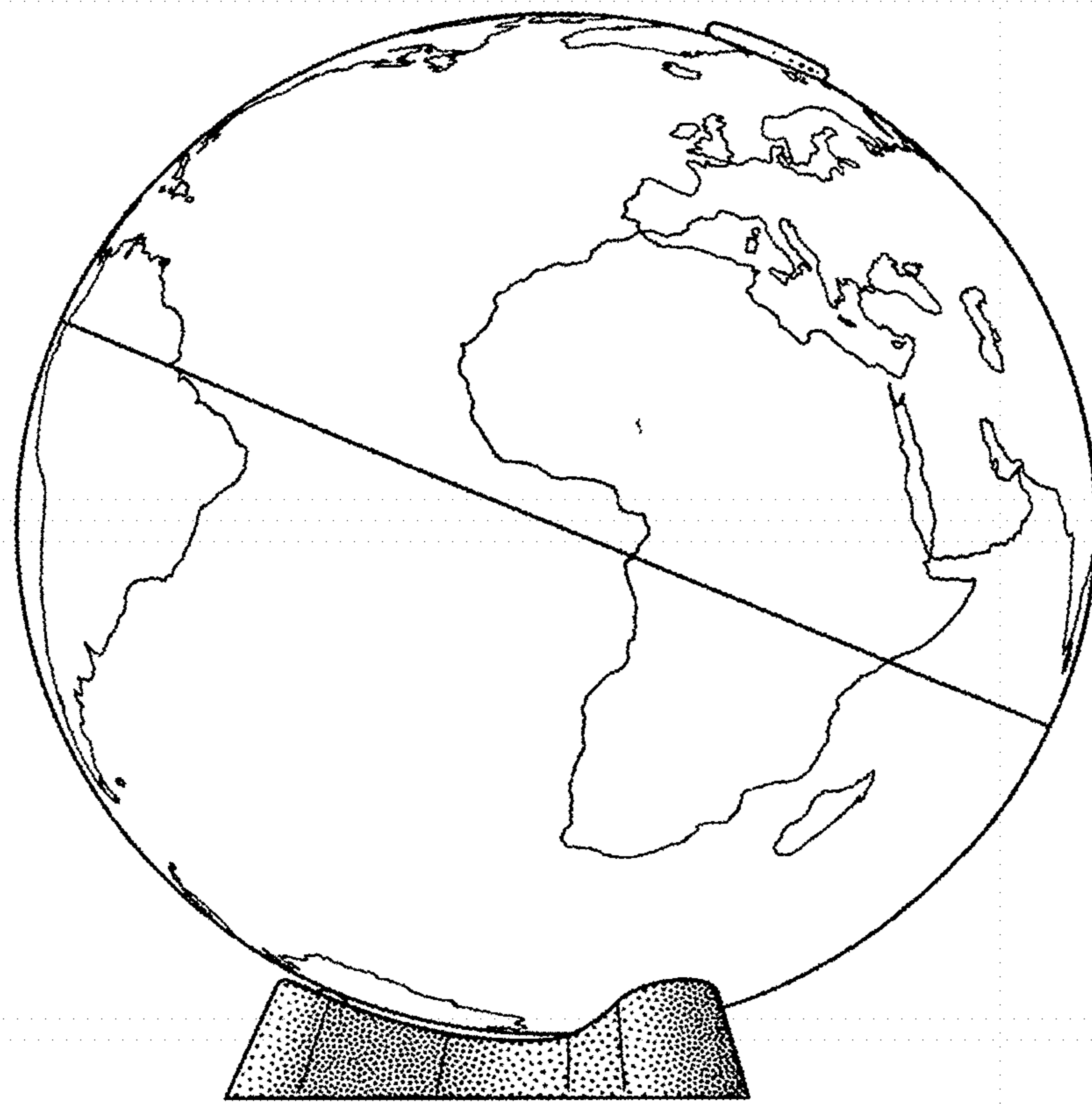

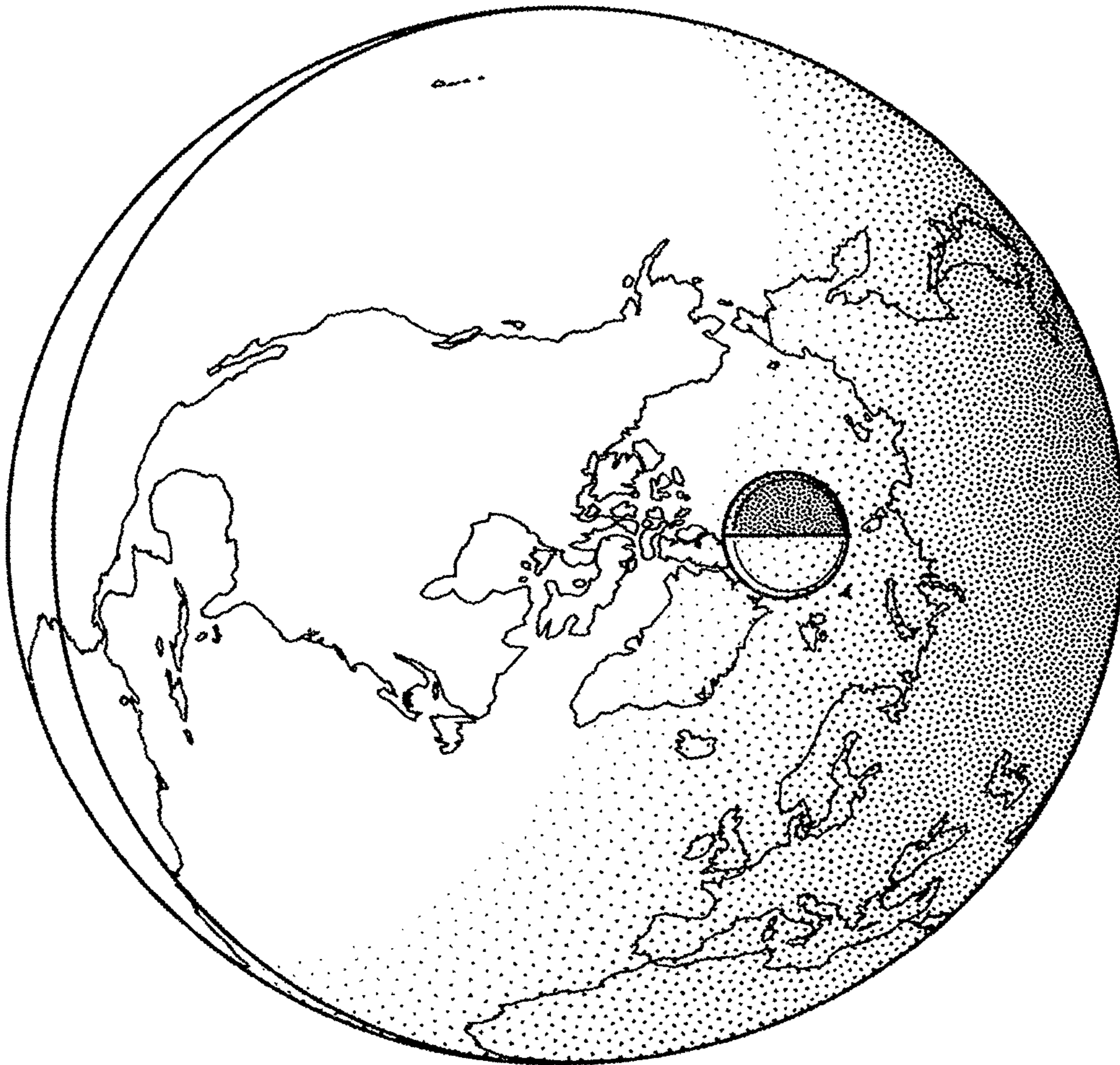

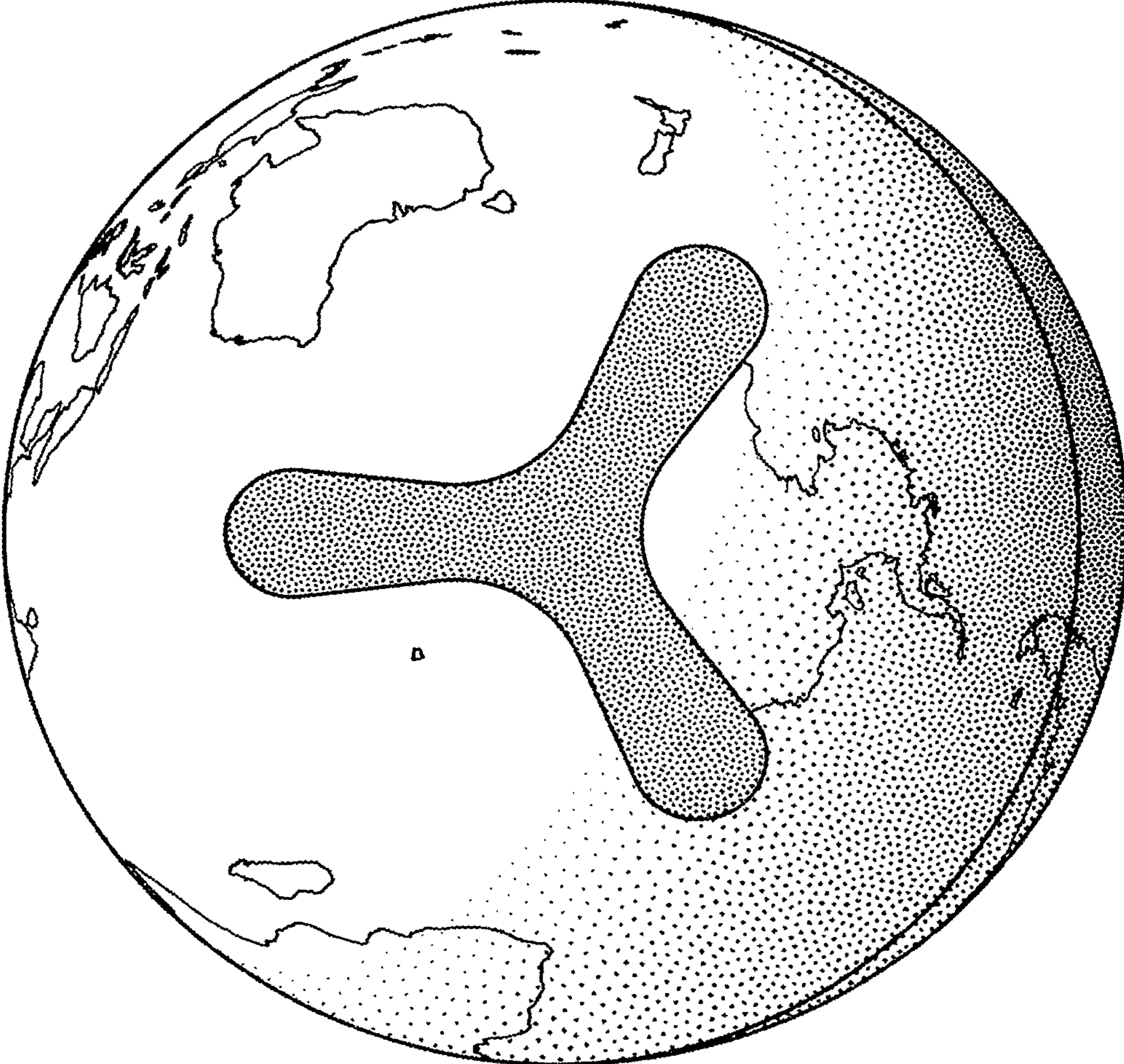
