The broken lines showing the bottom of the tank for gaseous or liquid substances are for the purpose of illustrating environmental structure and form no part of the claimed design.

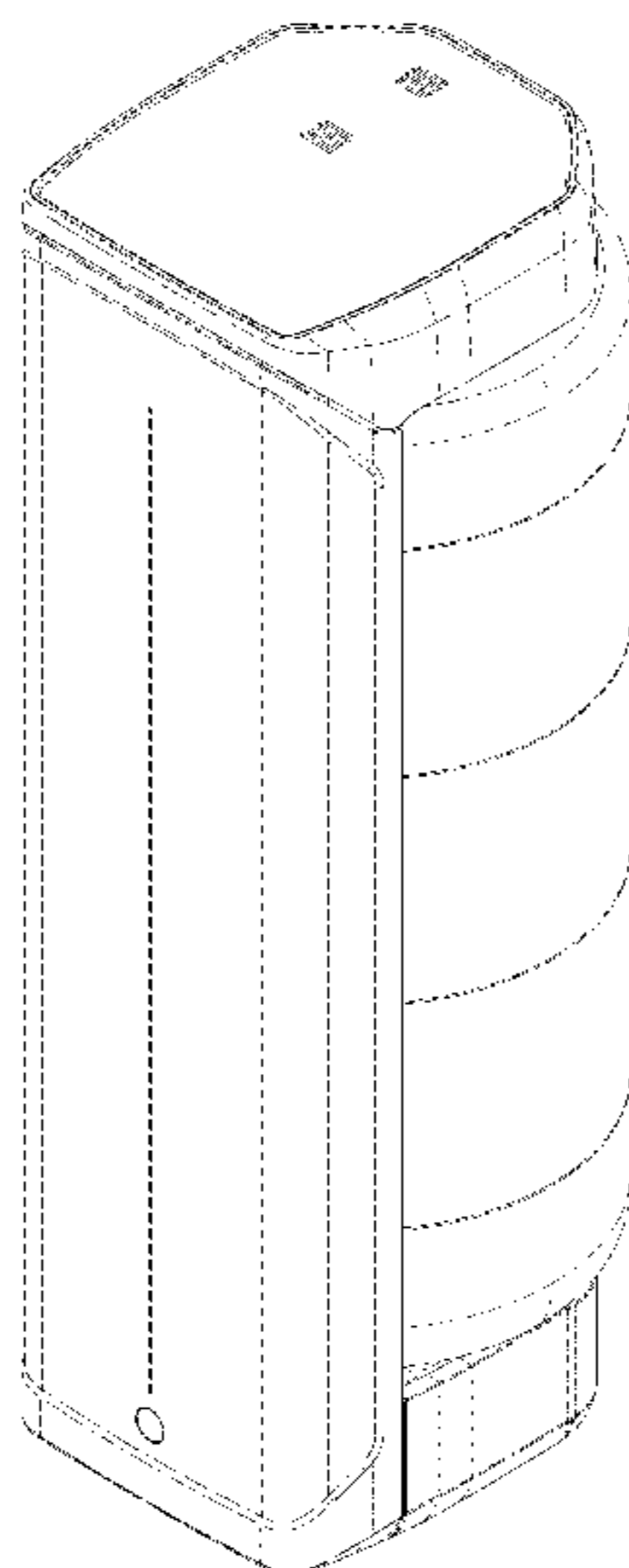

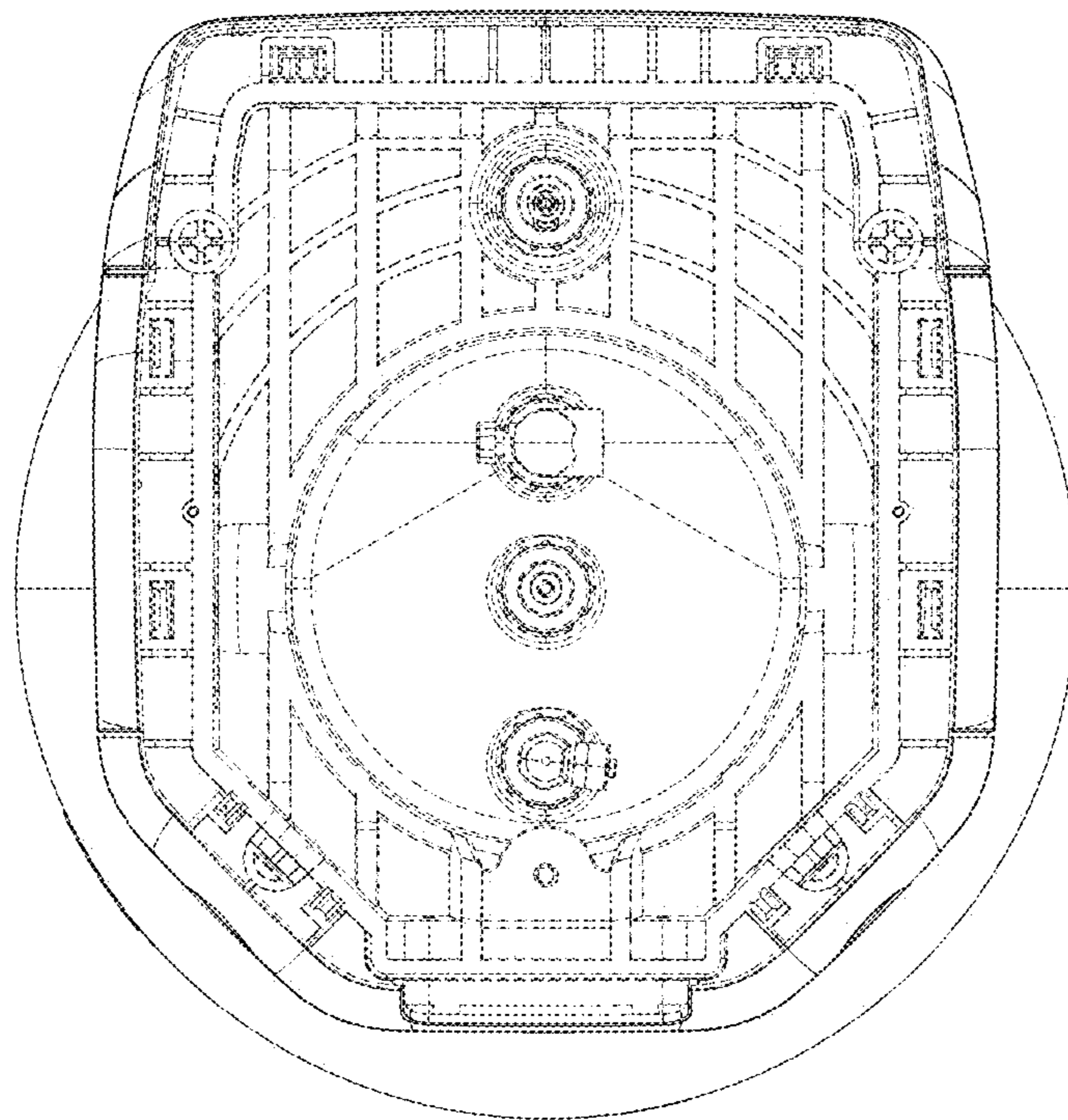

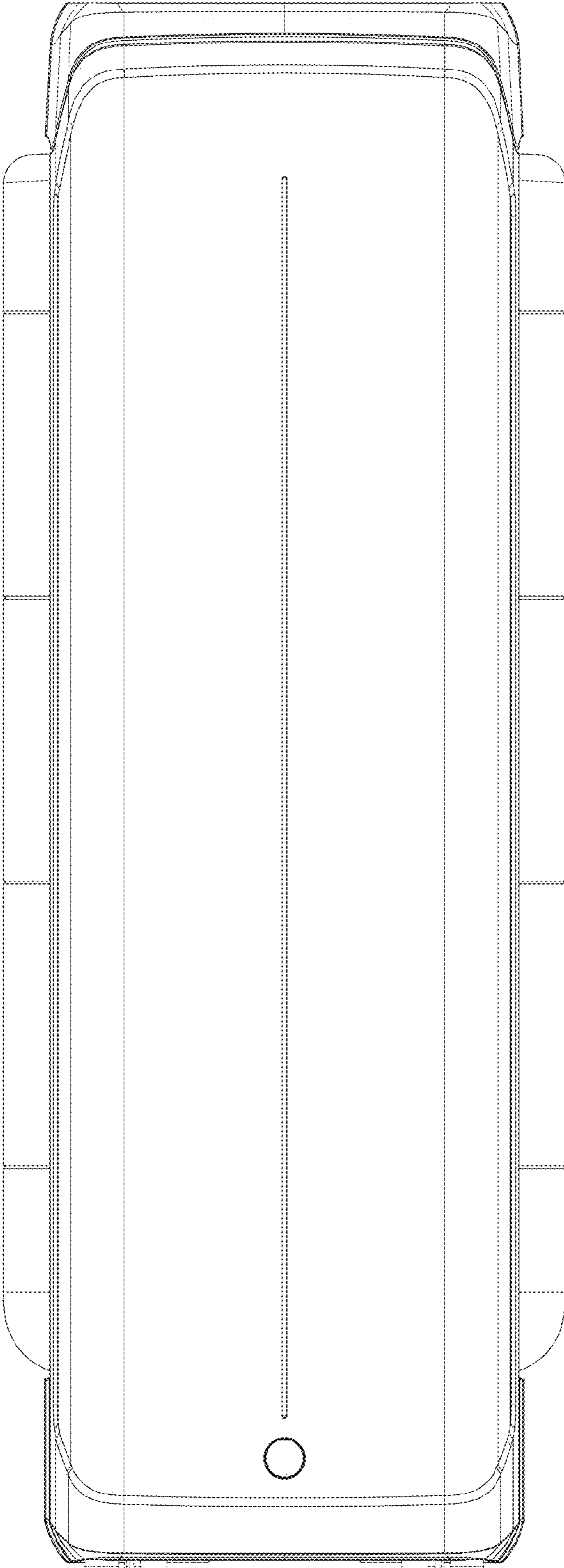

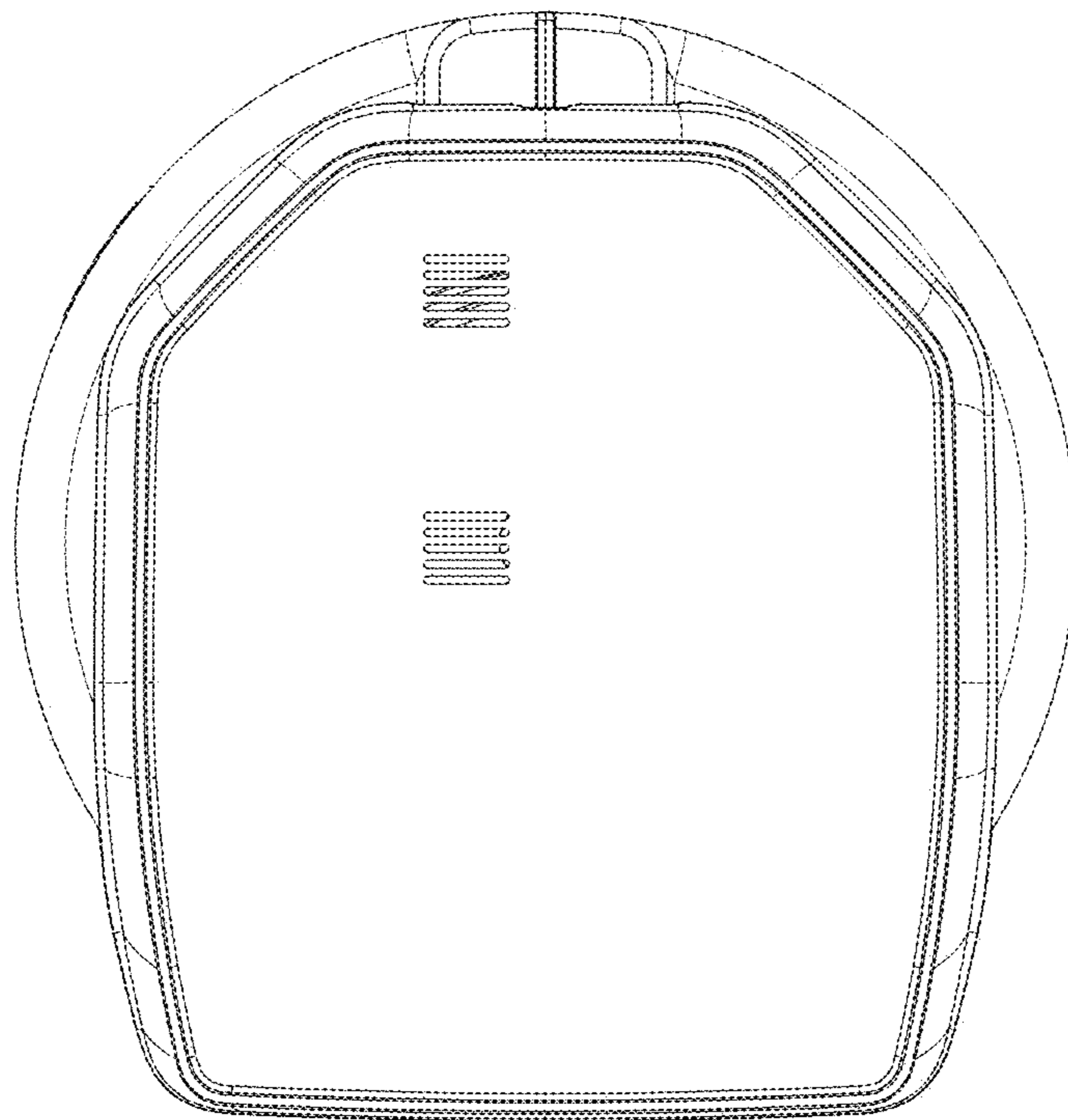

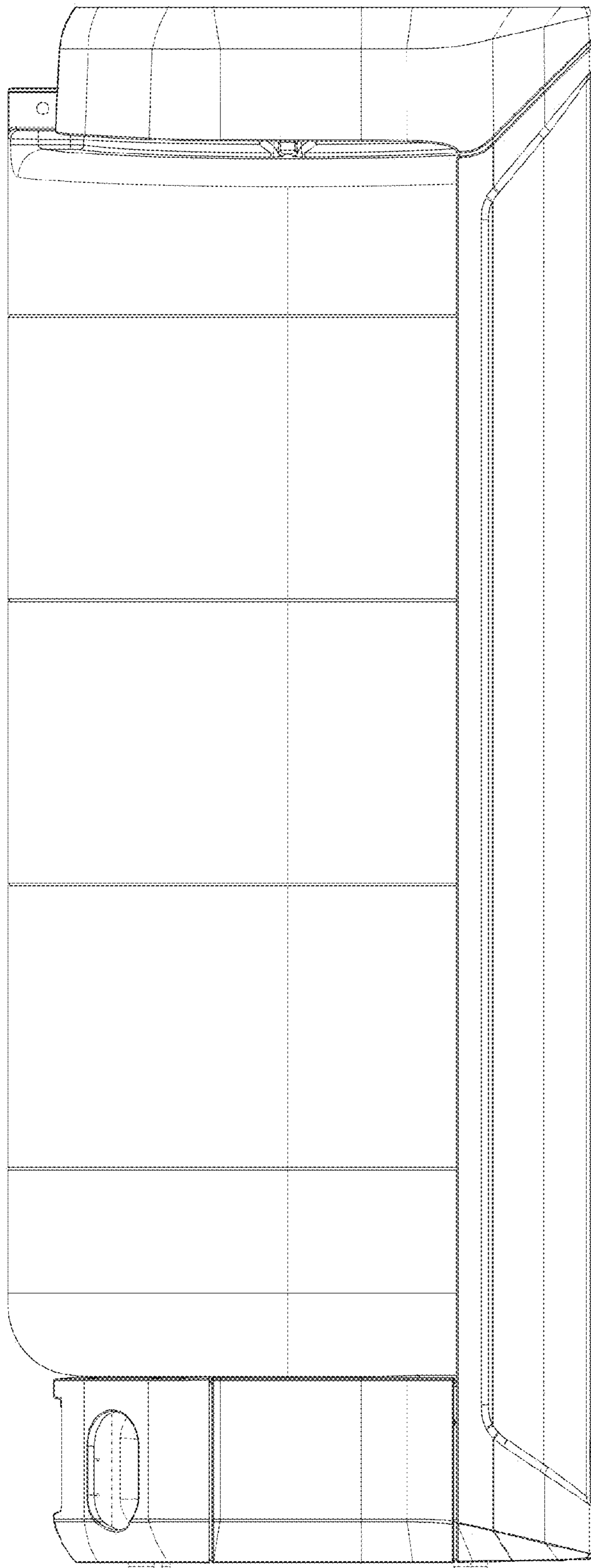

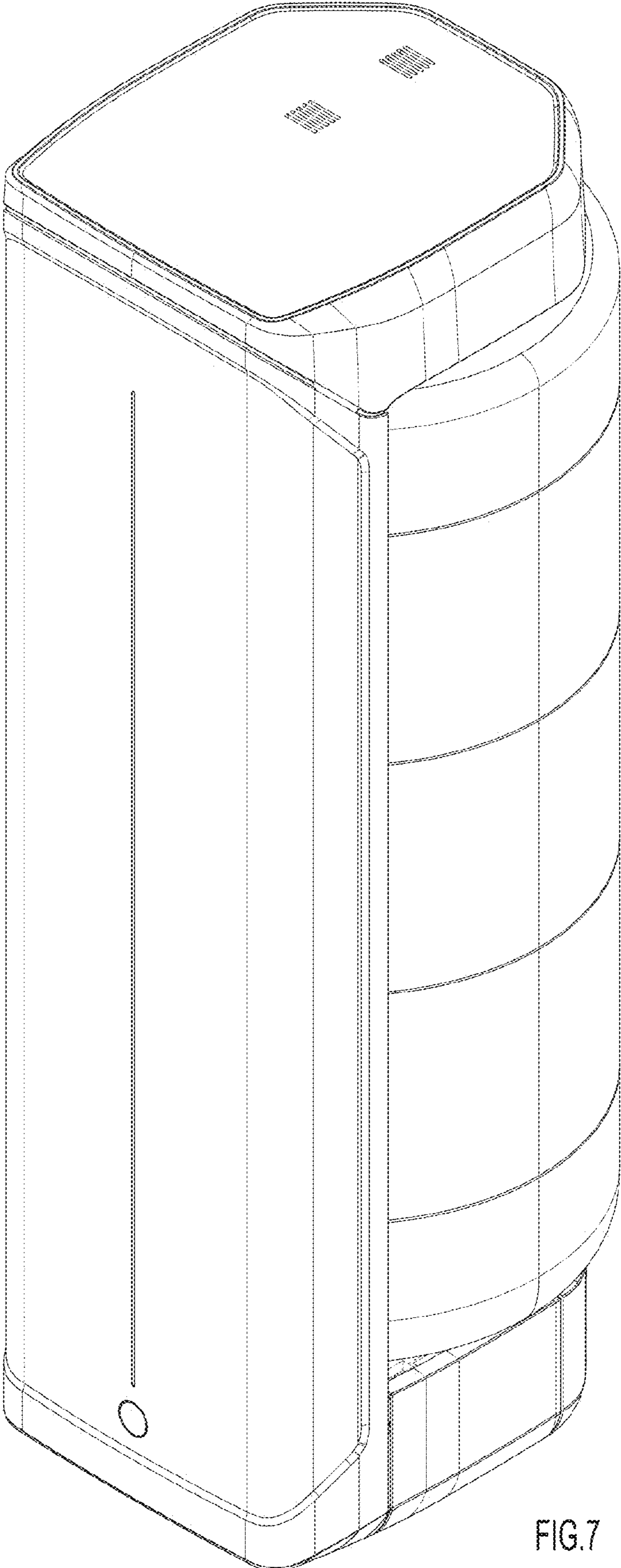

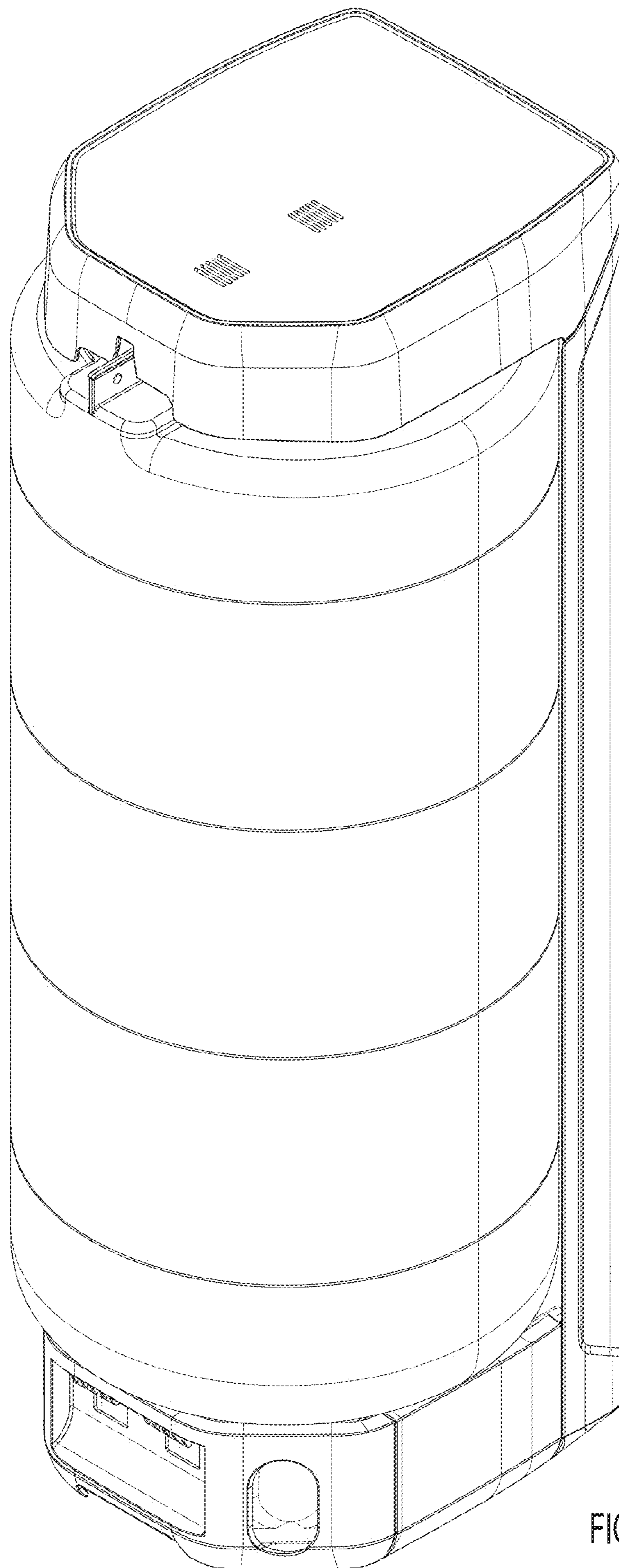
