tioner, as shown and described.

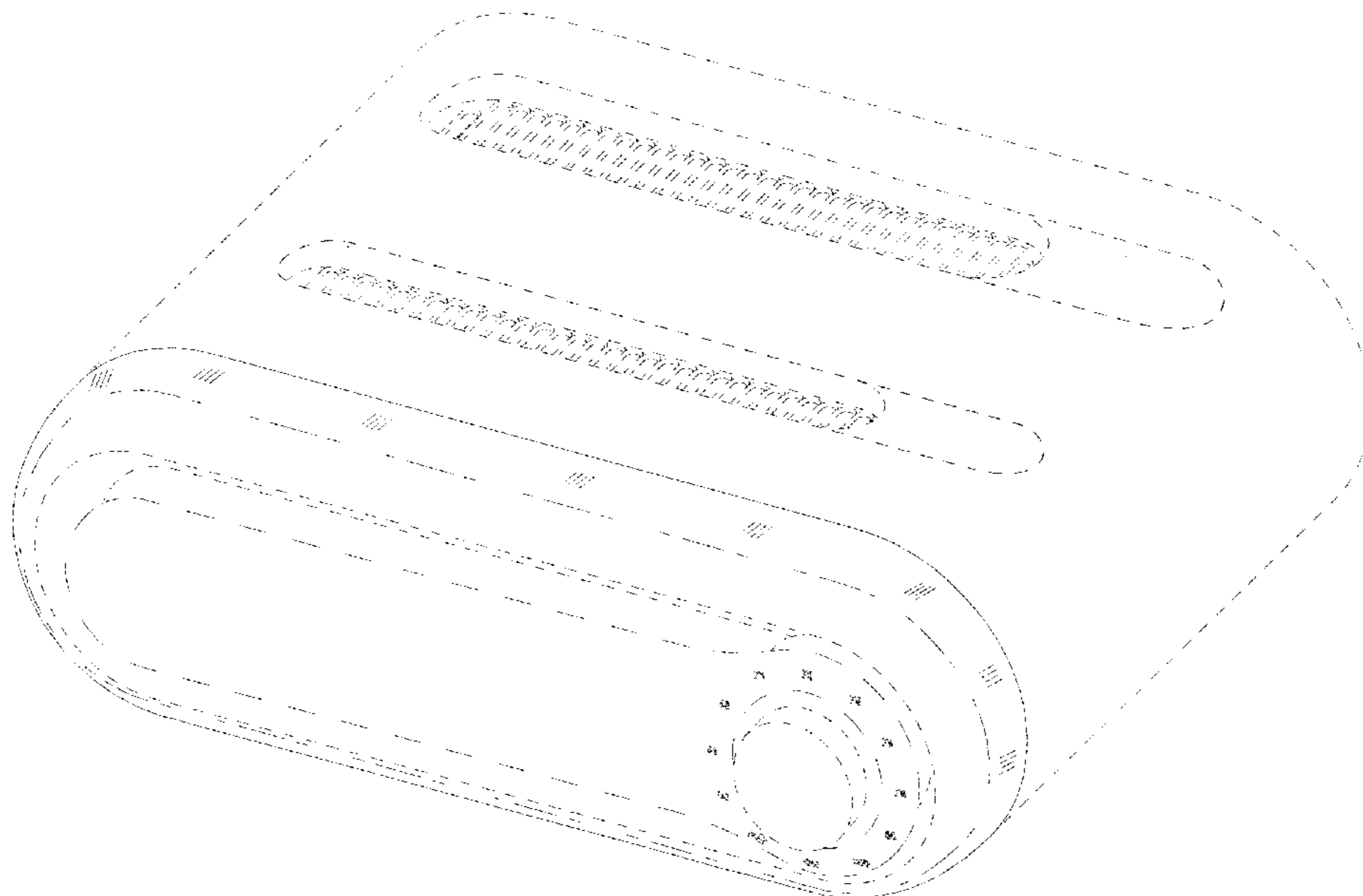
DESCRIPTION

FIG. 1 is a front perspective view of a part of a compact air
conditioner in accordance with the present invention;

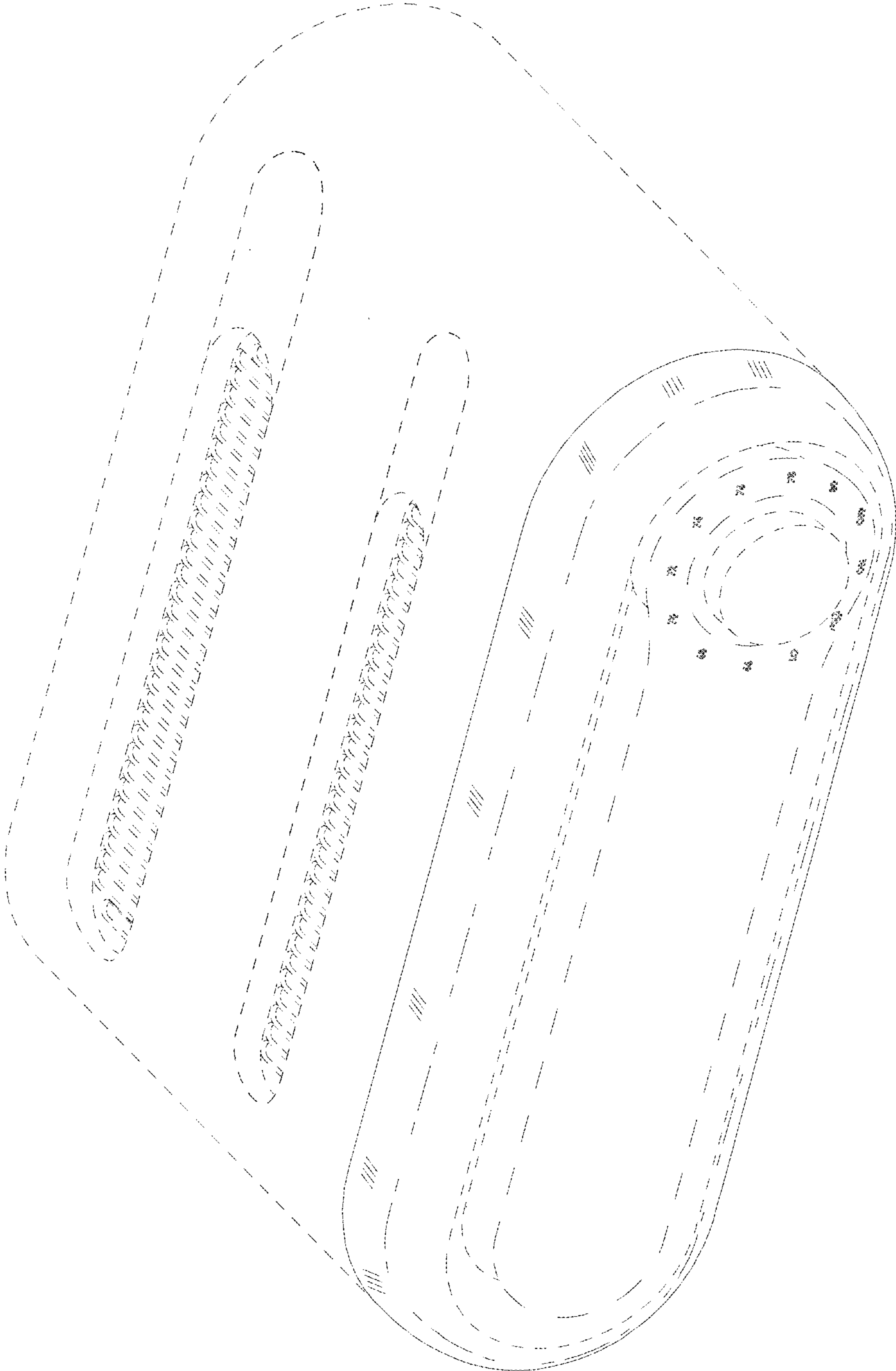

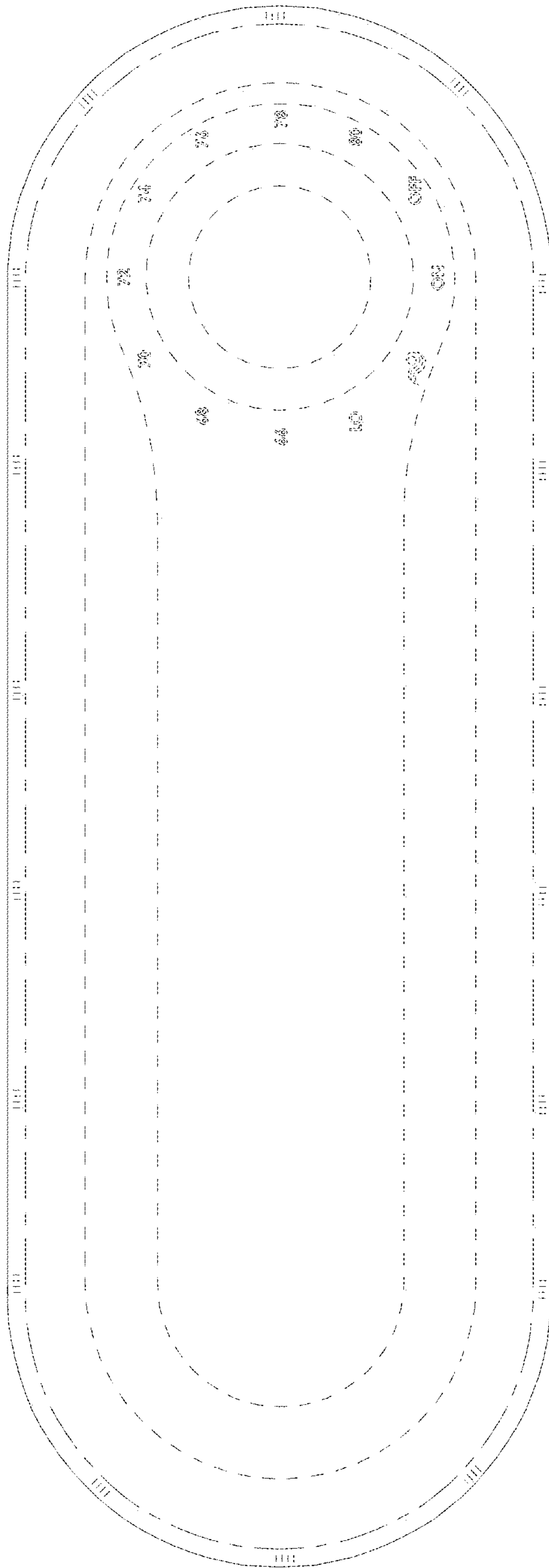

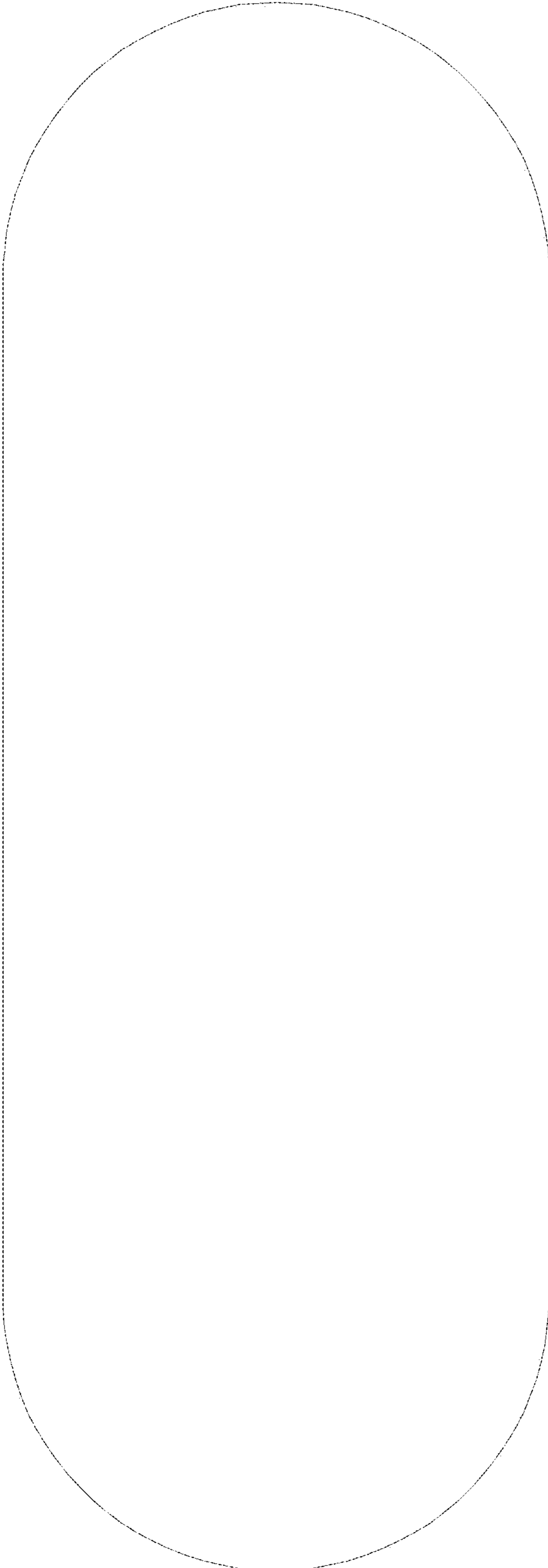

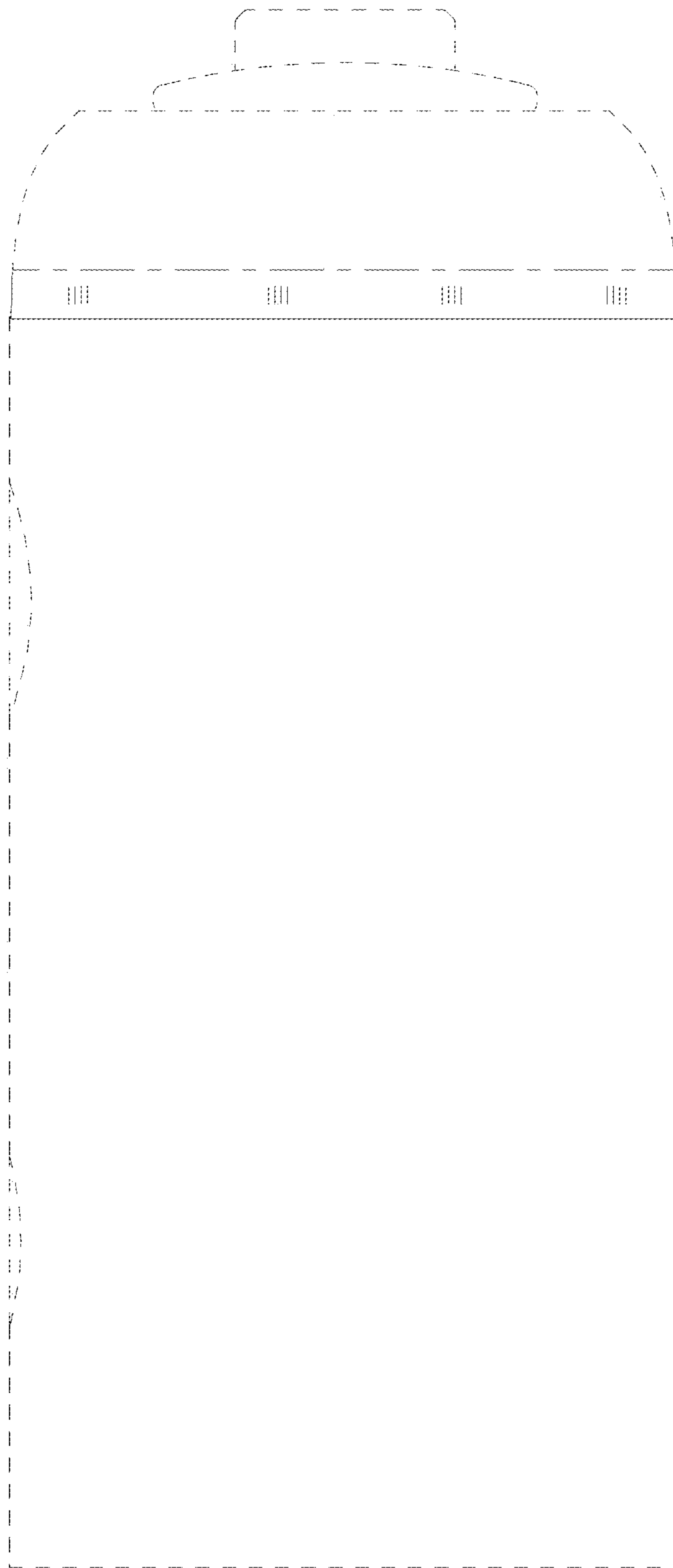

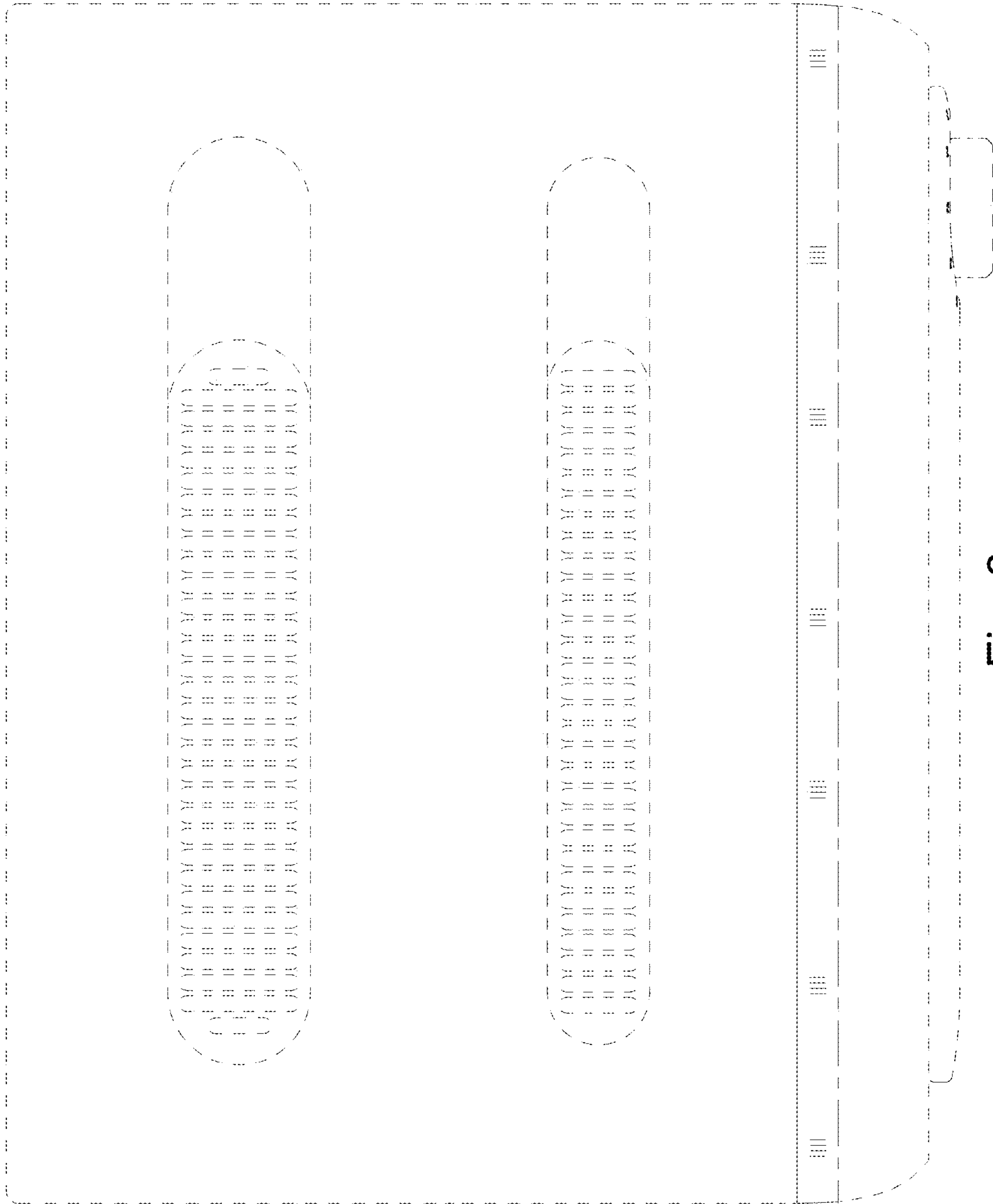

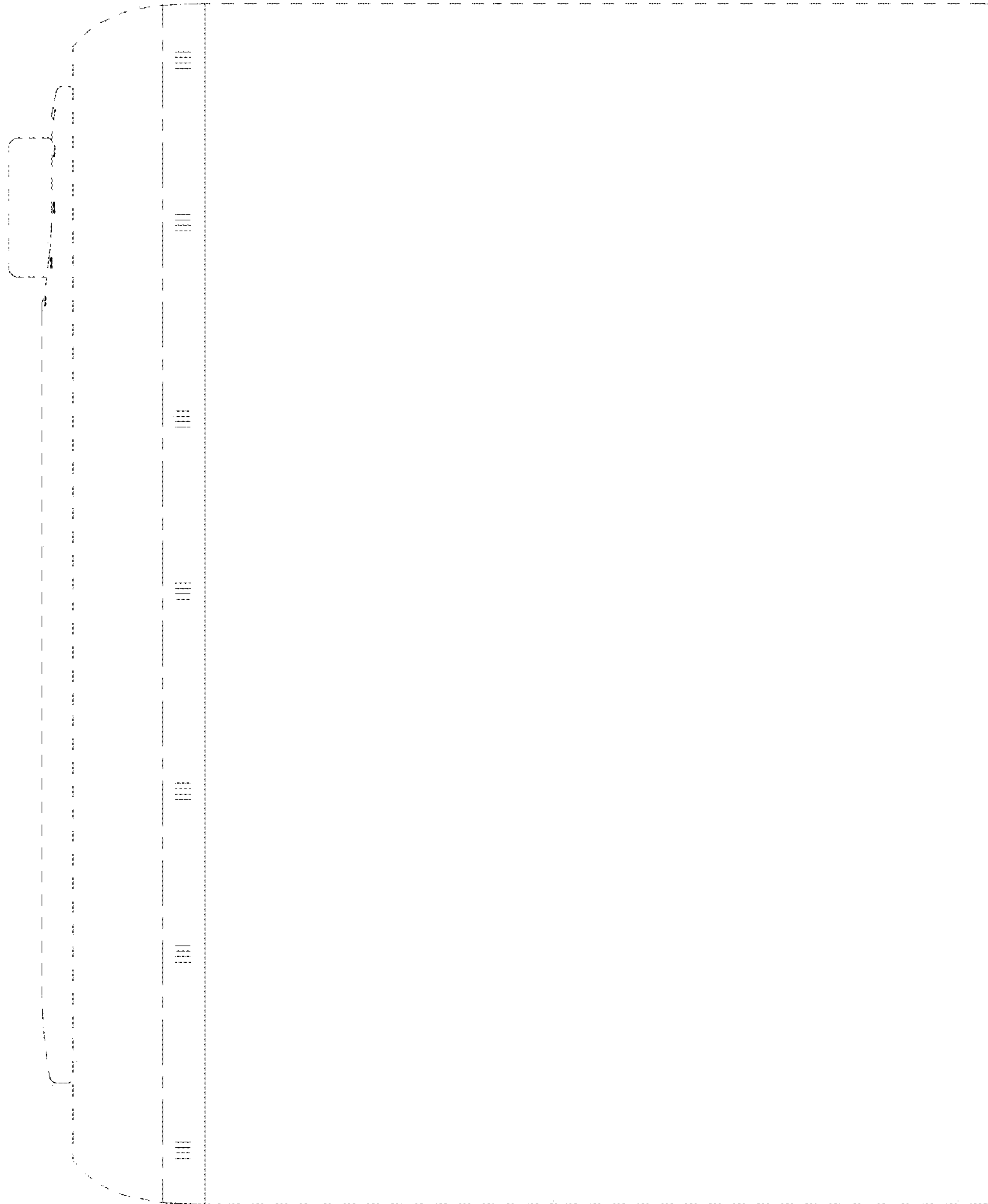
