The ornamental design for a ceiling fan blade, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a ceiling fan blade, showing my new design;

FIG. 5 is a front view thereof;

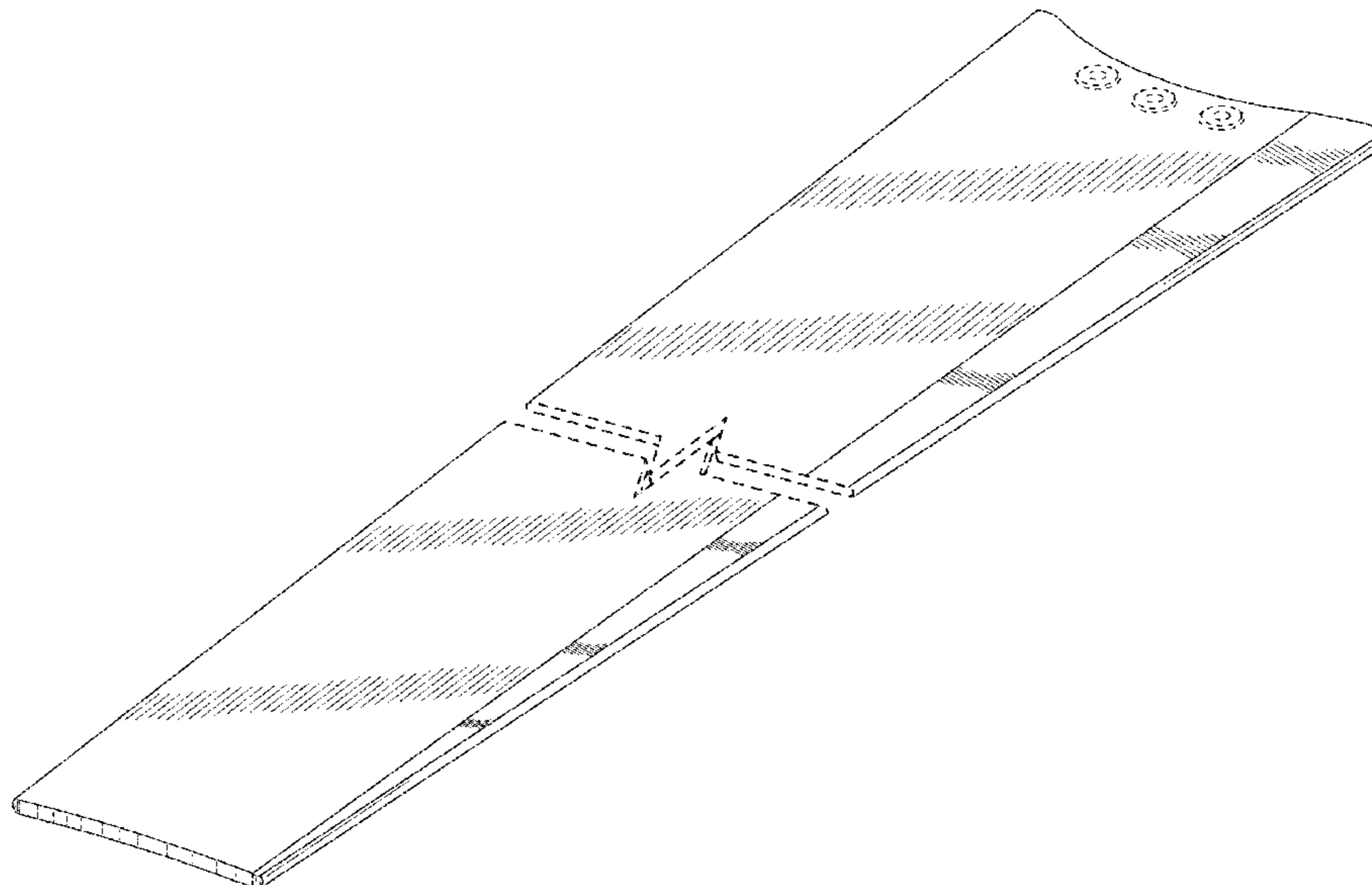
FIG. 6 is a rear view thereof;

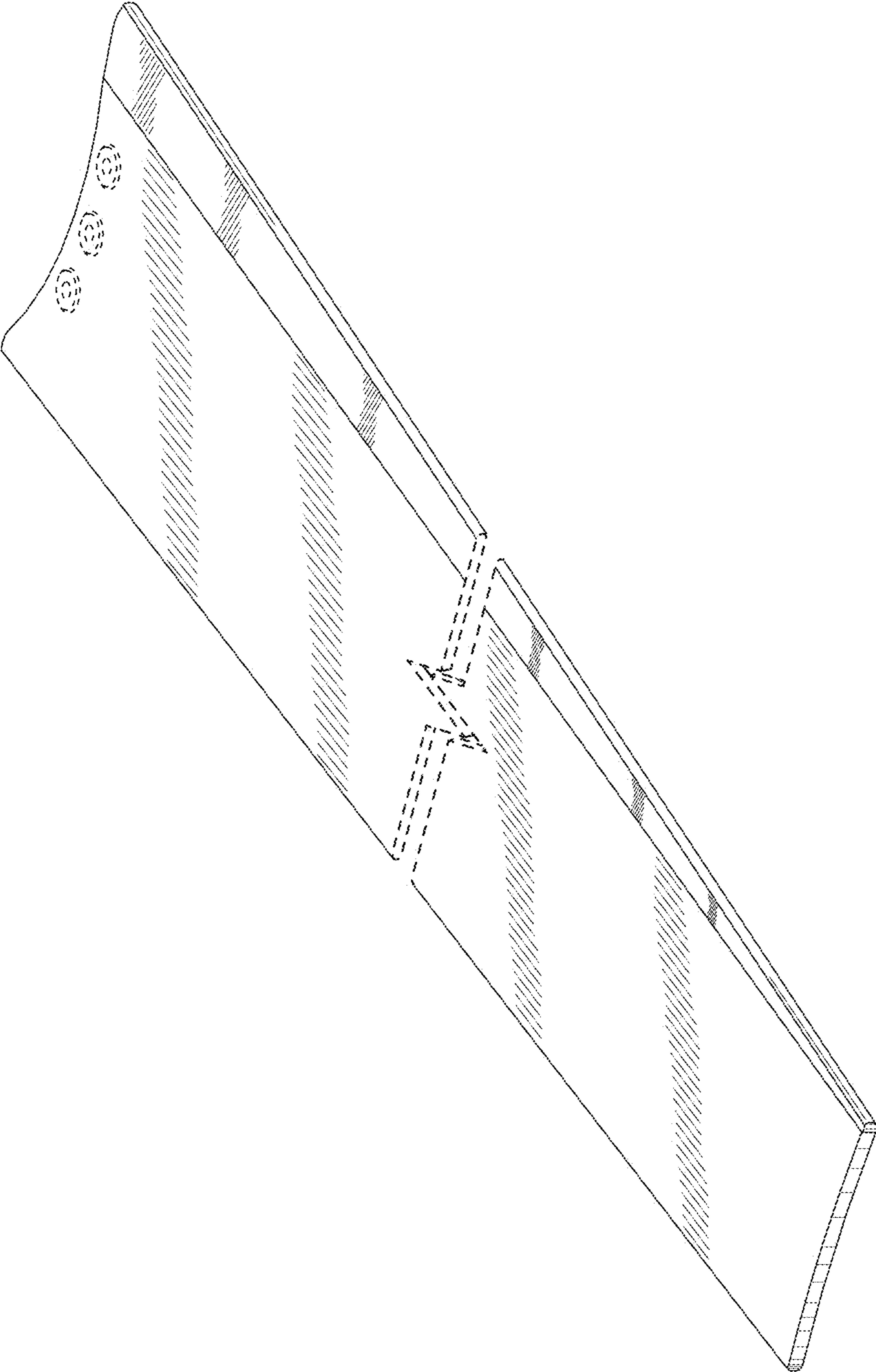

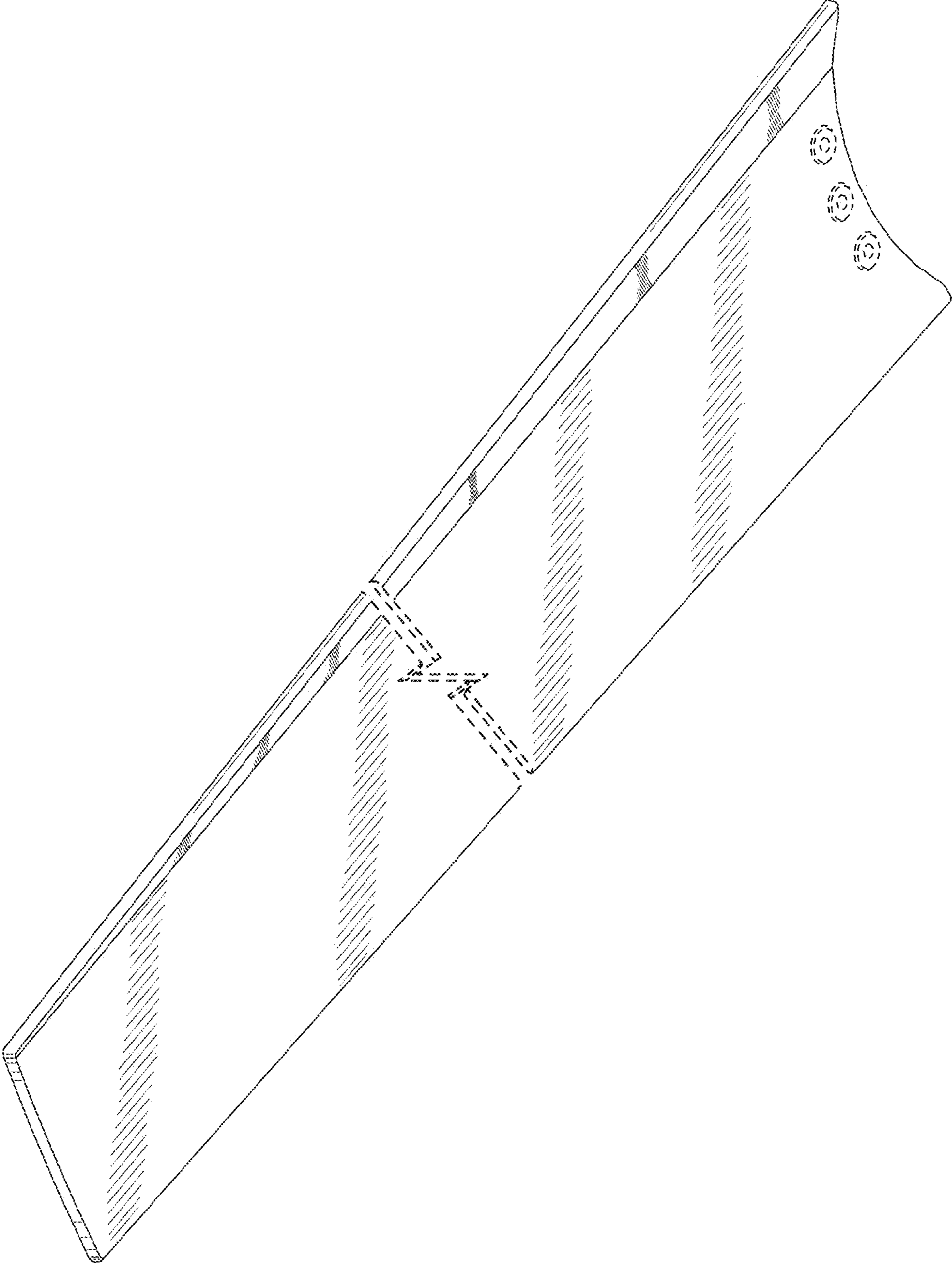

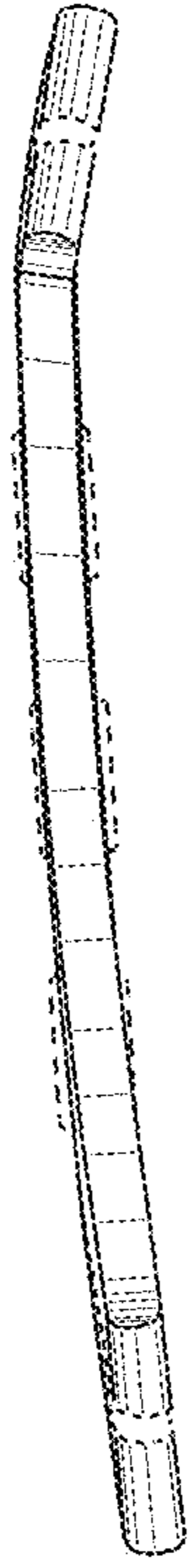

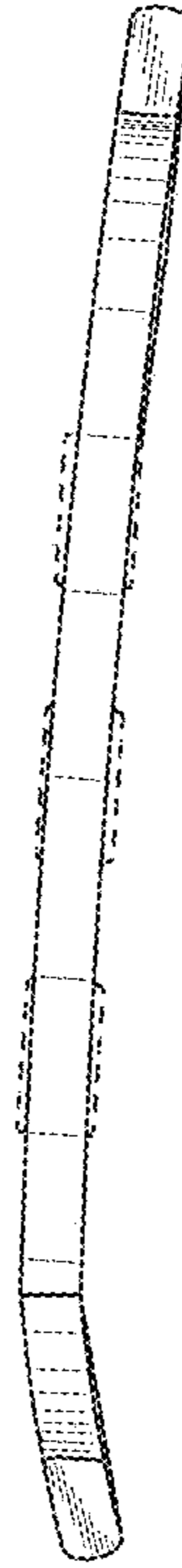

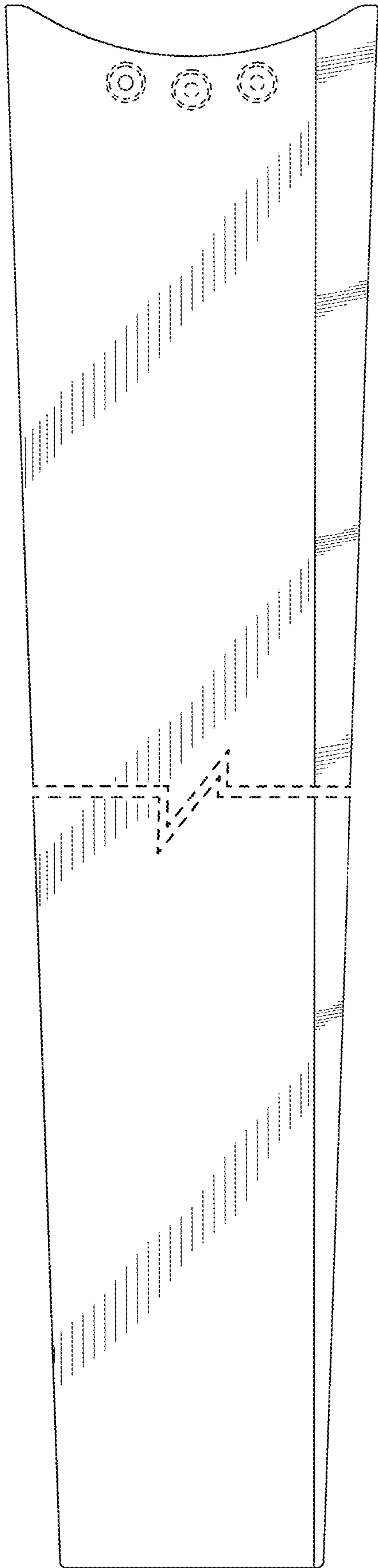

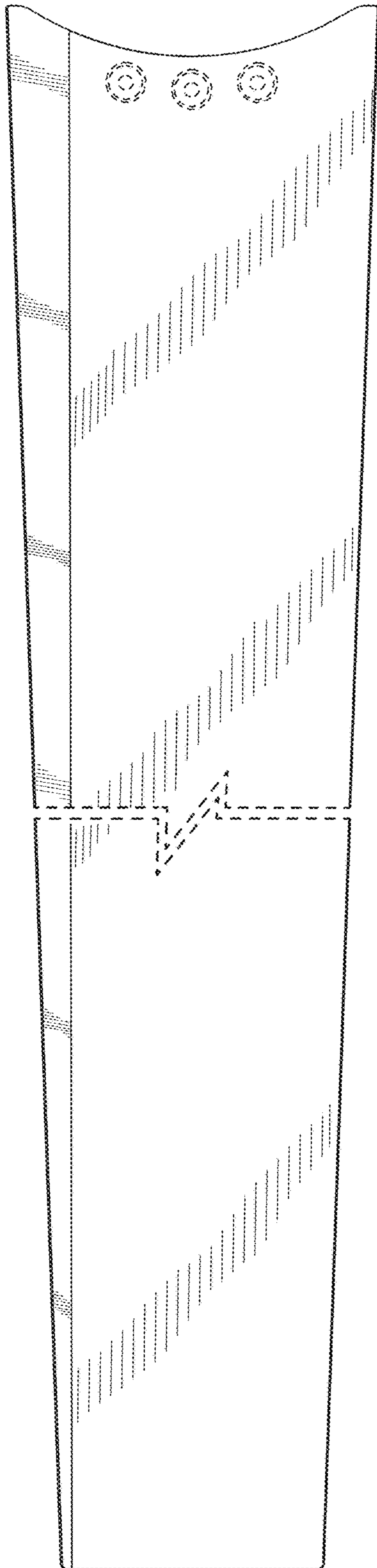
