(57) **CLAIM**

The ornamental design for a catheter with protected needle and balloon, as shown and described.

DESCRIPTION

FIG. 1 is a top view of the catheter with protected needle and balloon prior to expansion;
FIG. 2 is a right view of the catheter thereof;
FIG. 3 is a bottom view of the catheter thereof;
FIG. 4 is a left view of the catheter thereof;
FIG. 5 is a back view of the catheter thereof;
FIG. 6 is a front view of the catheter thereof; and,
FIG. 7 is a longitudinal cross-sectional view of the catheter thereof.

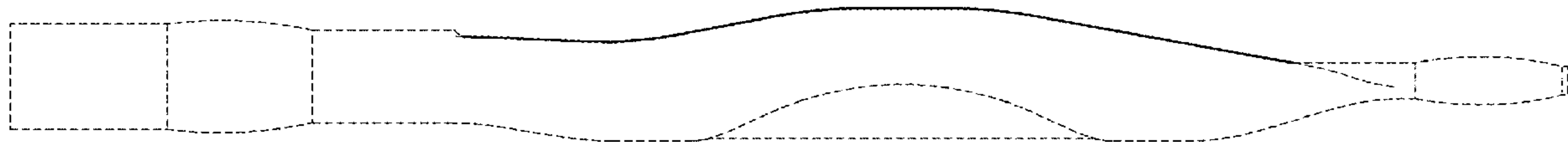
The broken line depiction of a catheter with protected needle and balloon prior to expansion is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

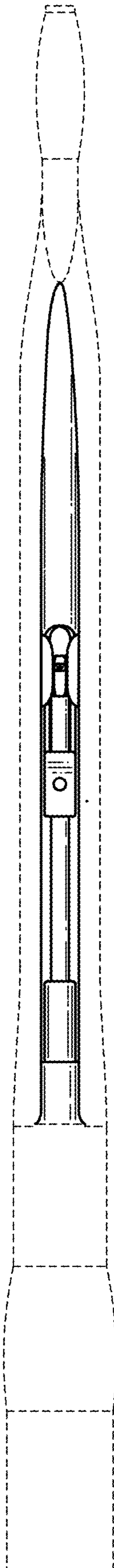

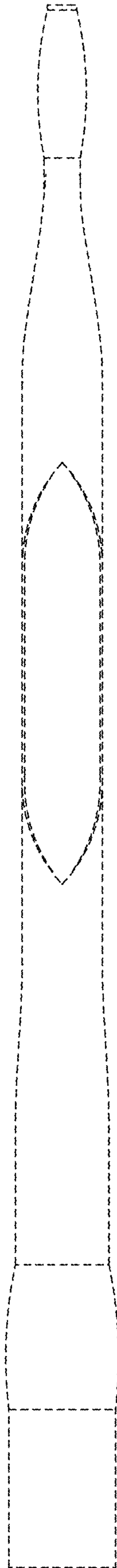

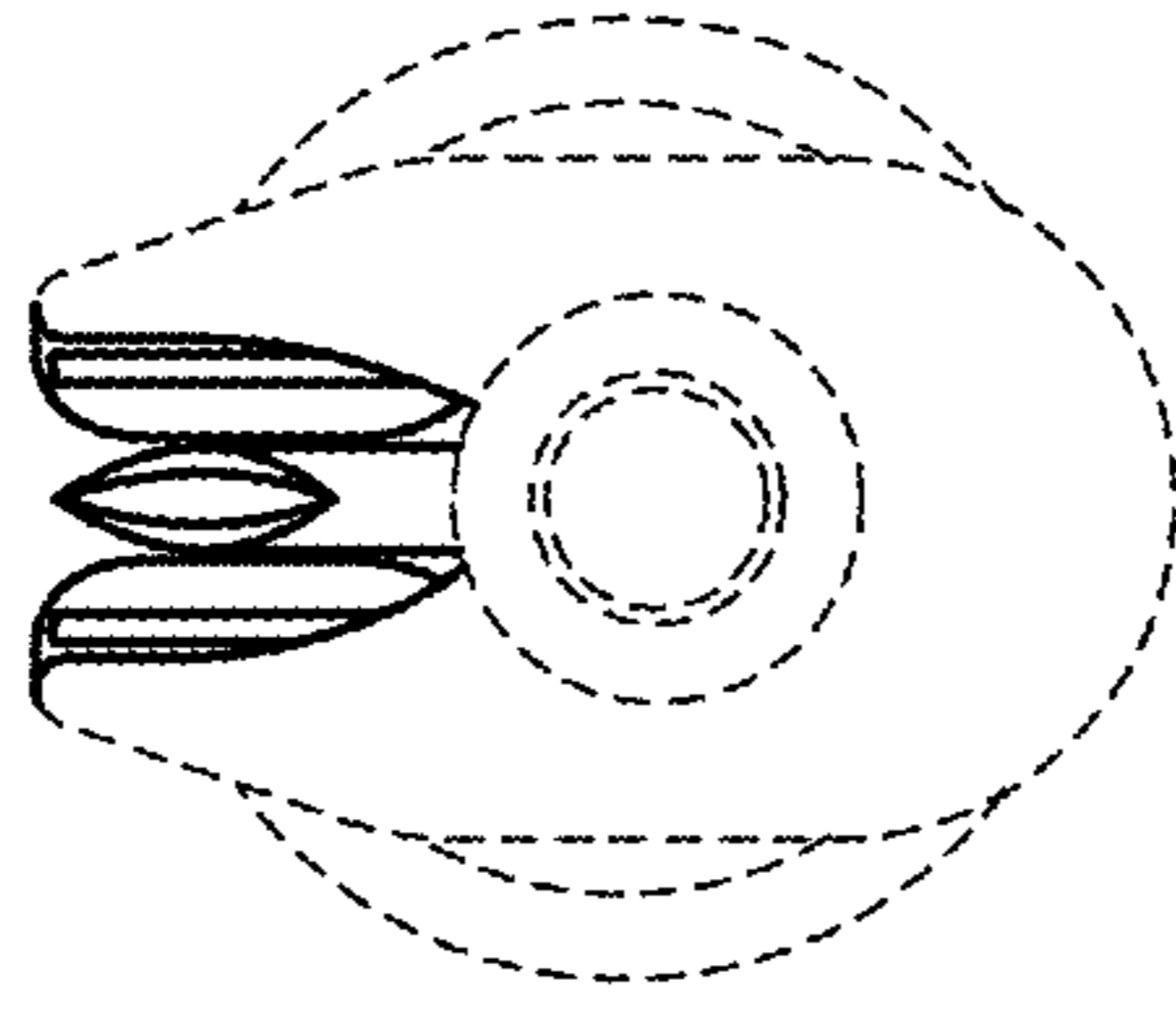

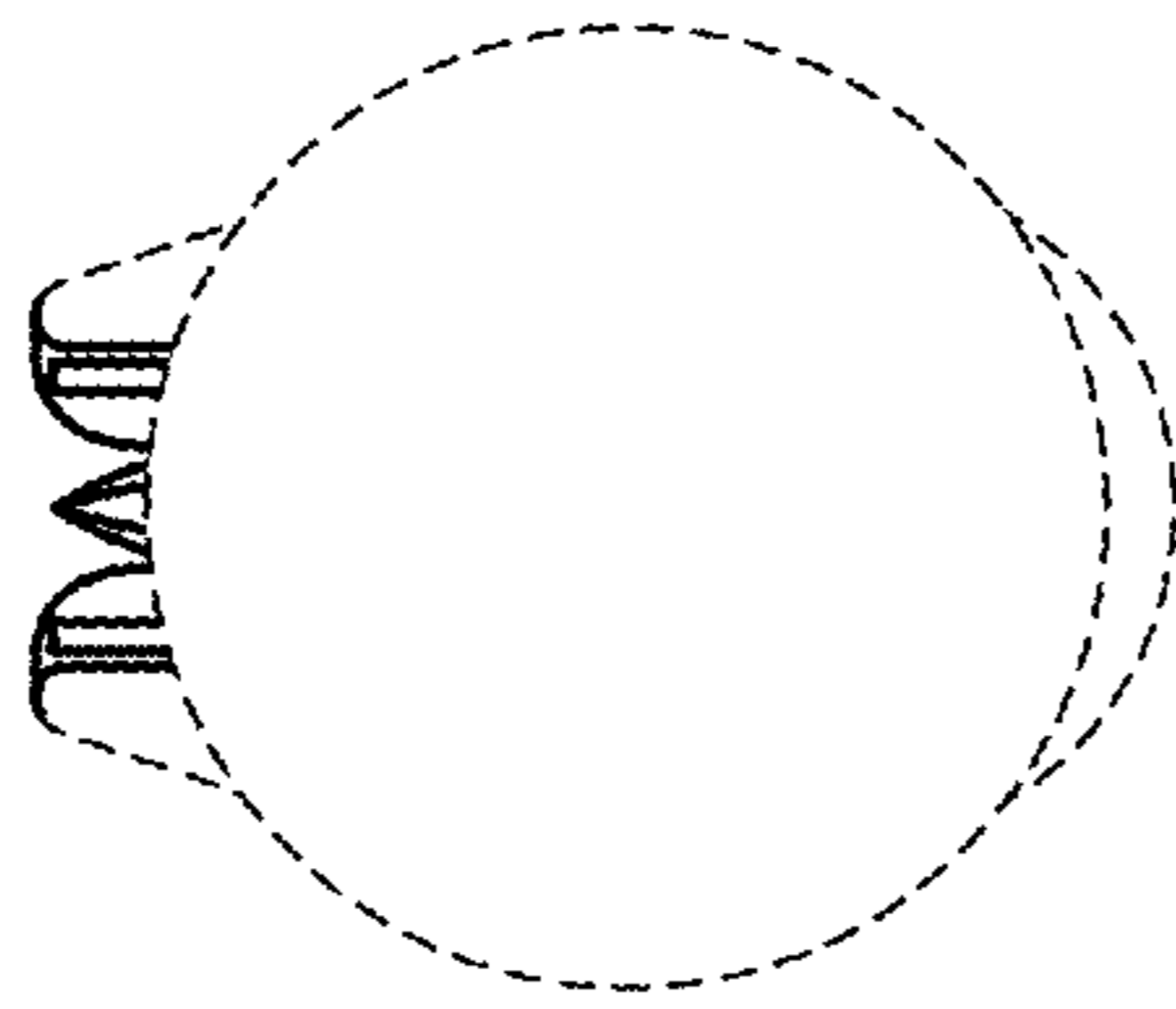

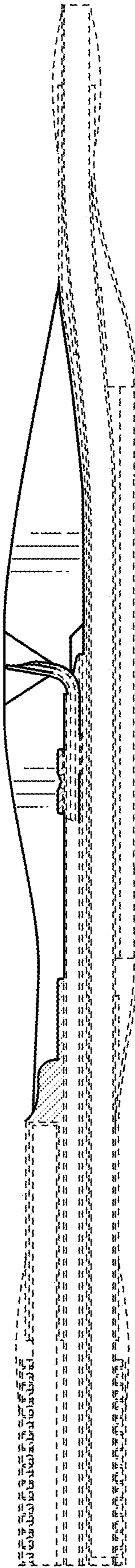
