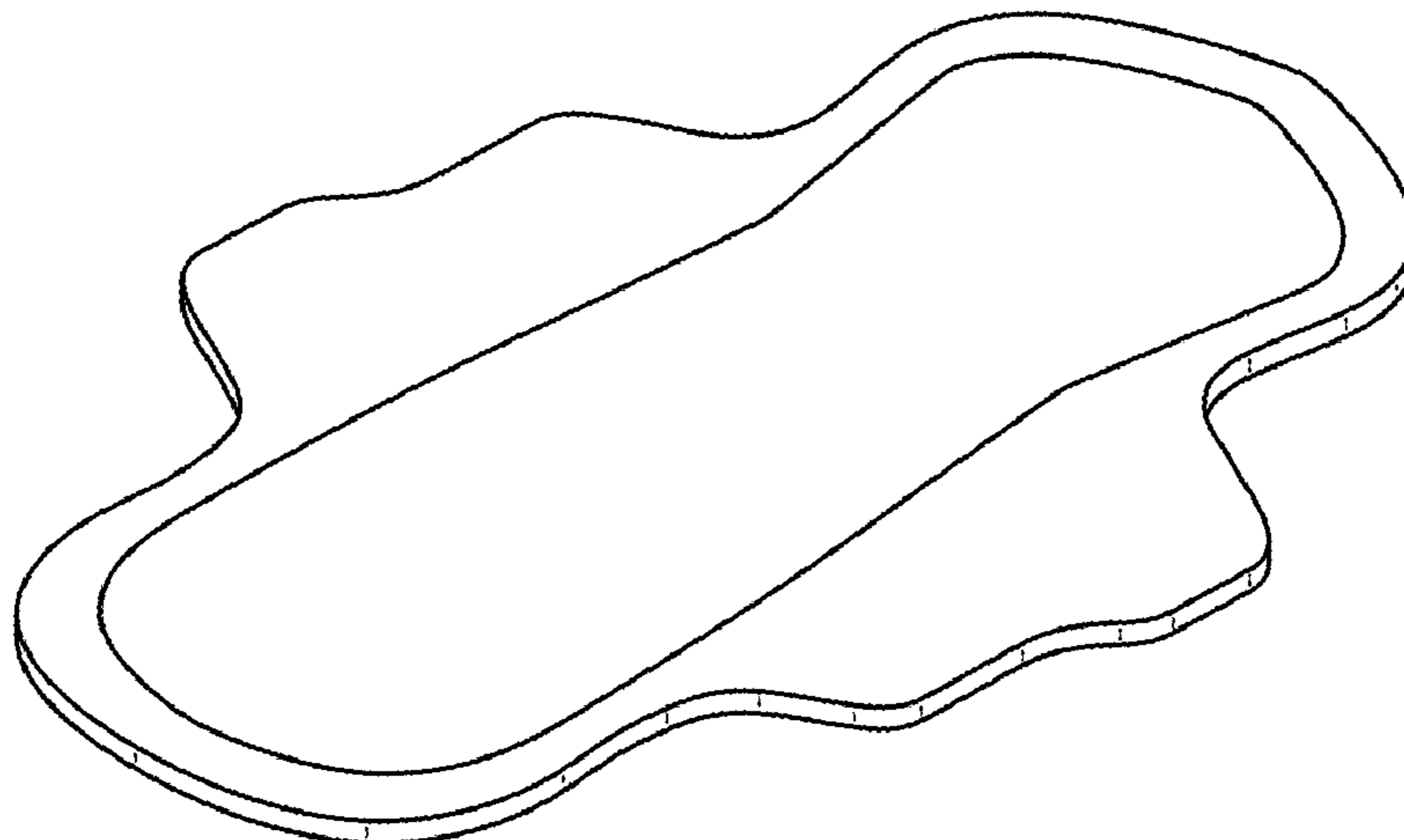


FIG. 15 is a perspective view of a third embodiment of a sanitary napkin;

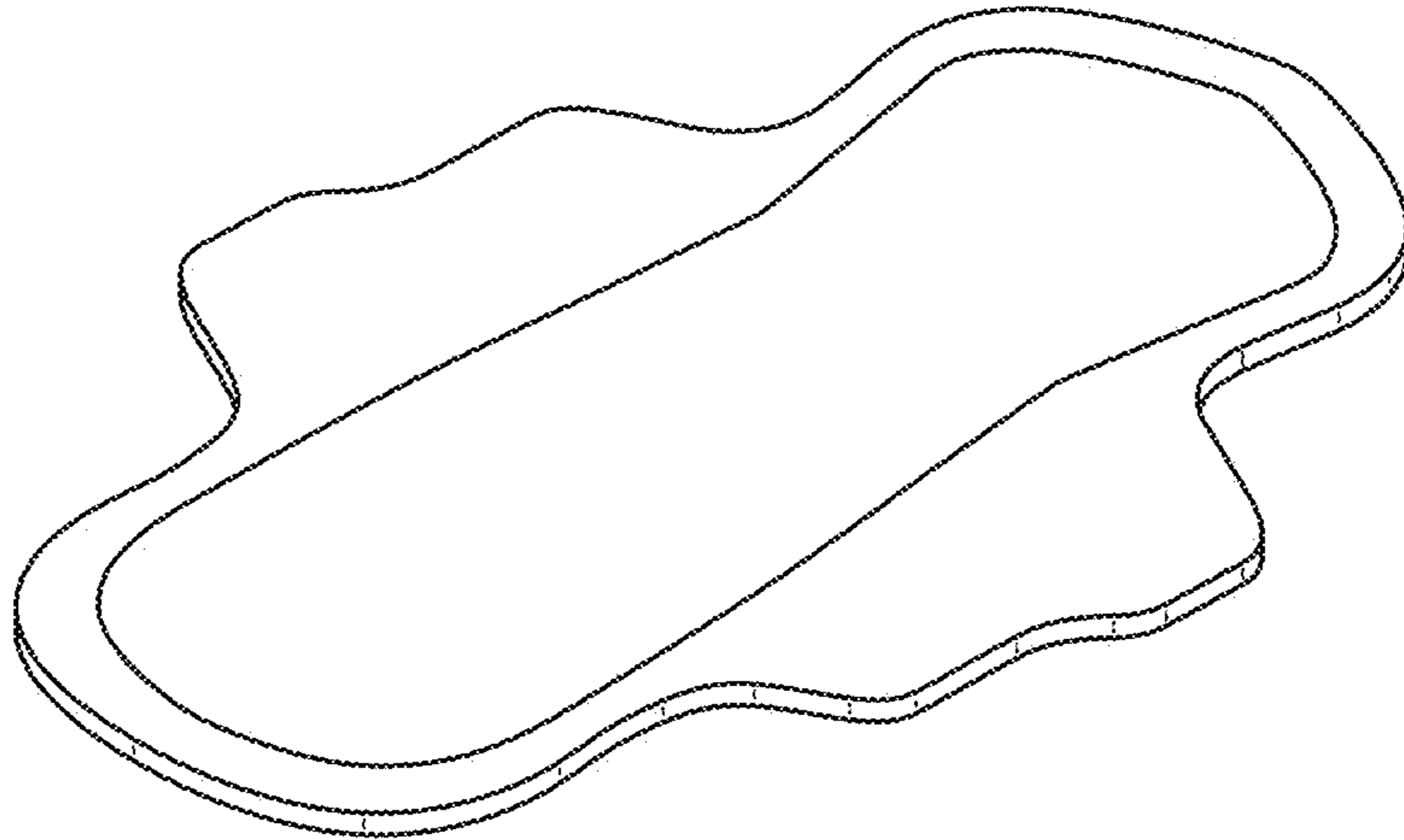

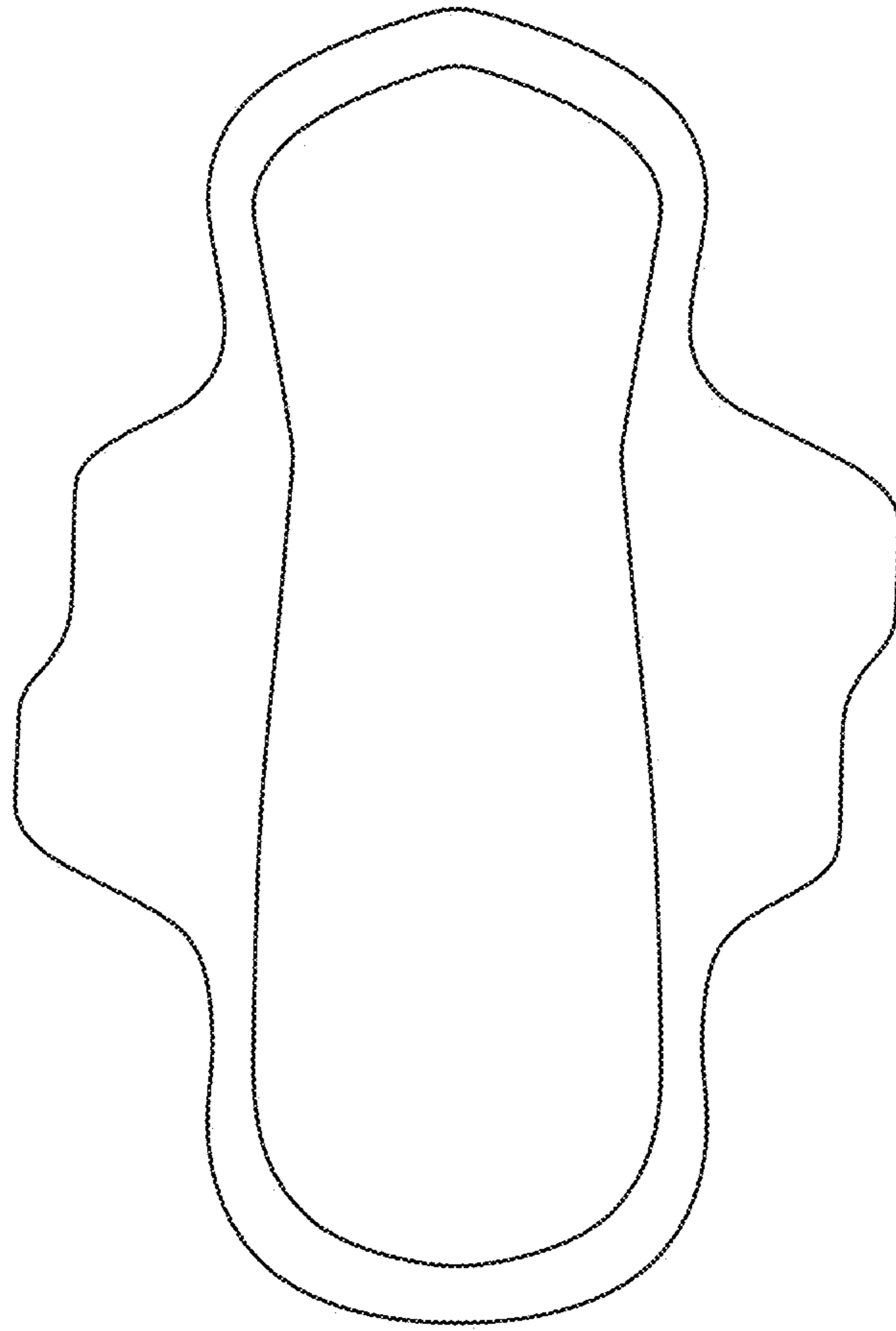

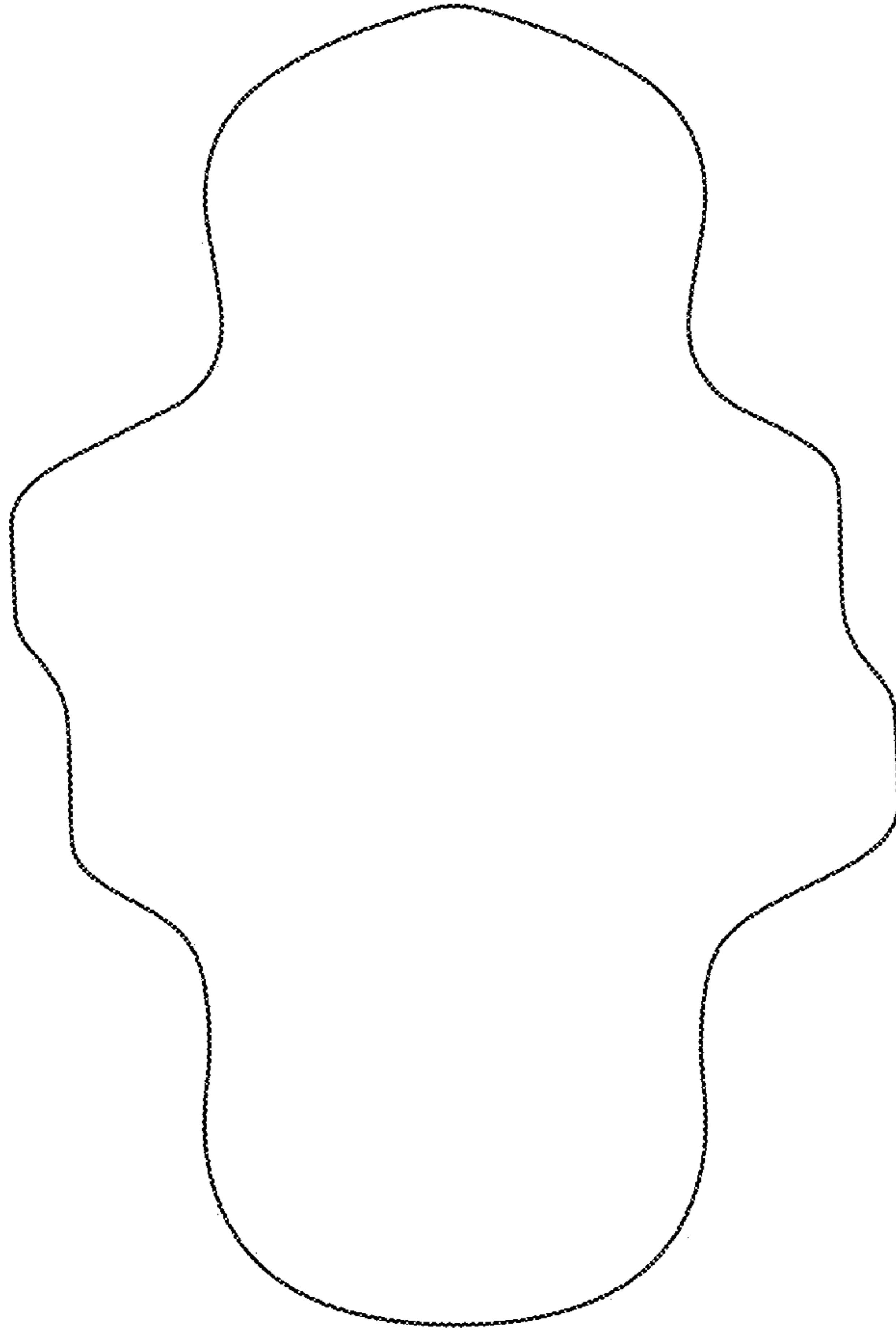

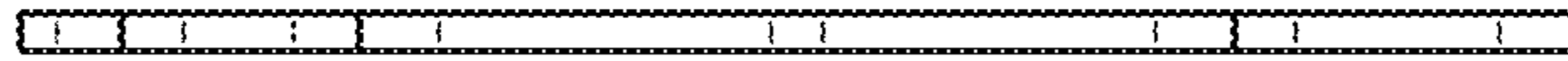

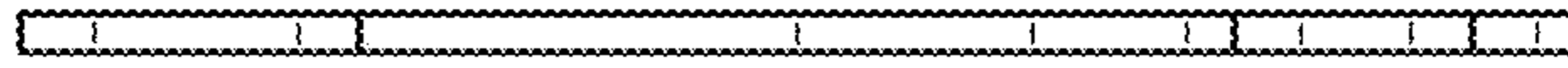

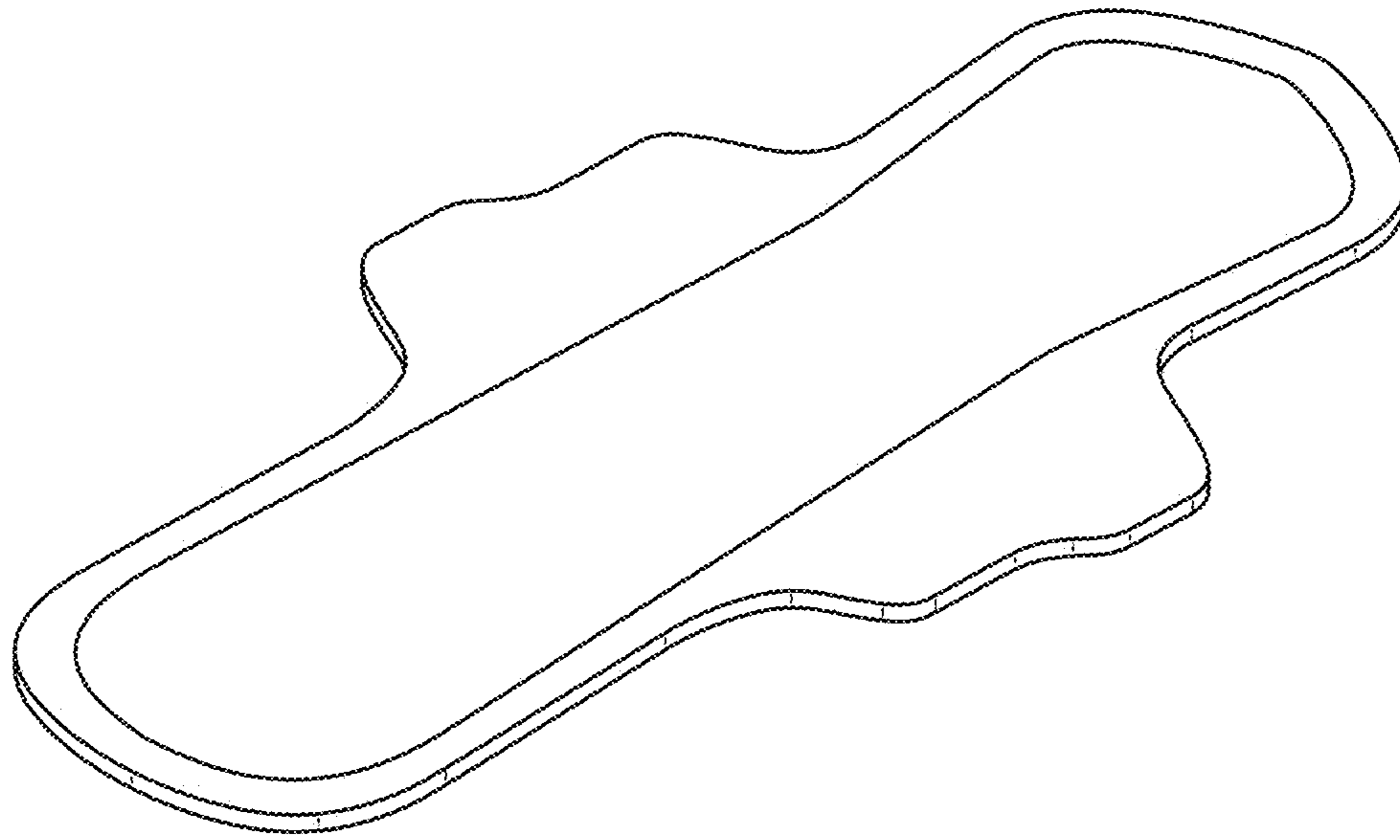

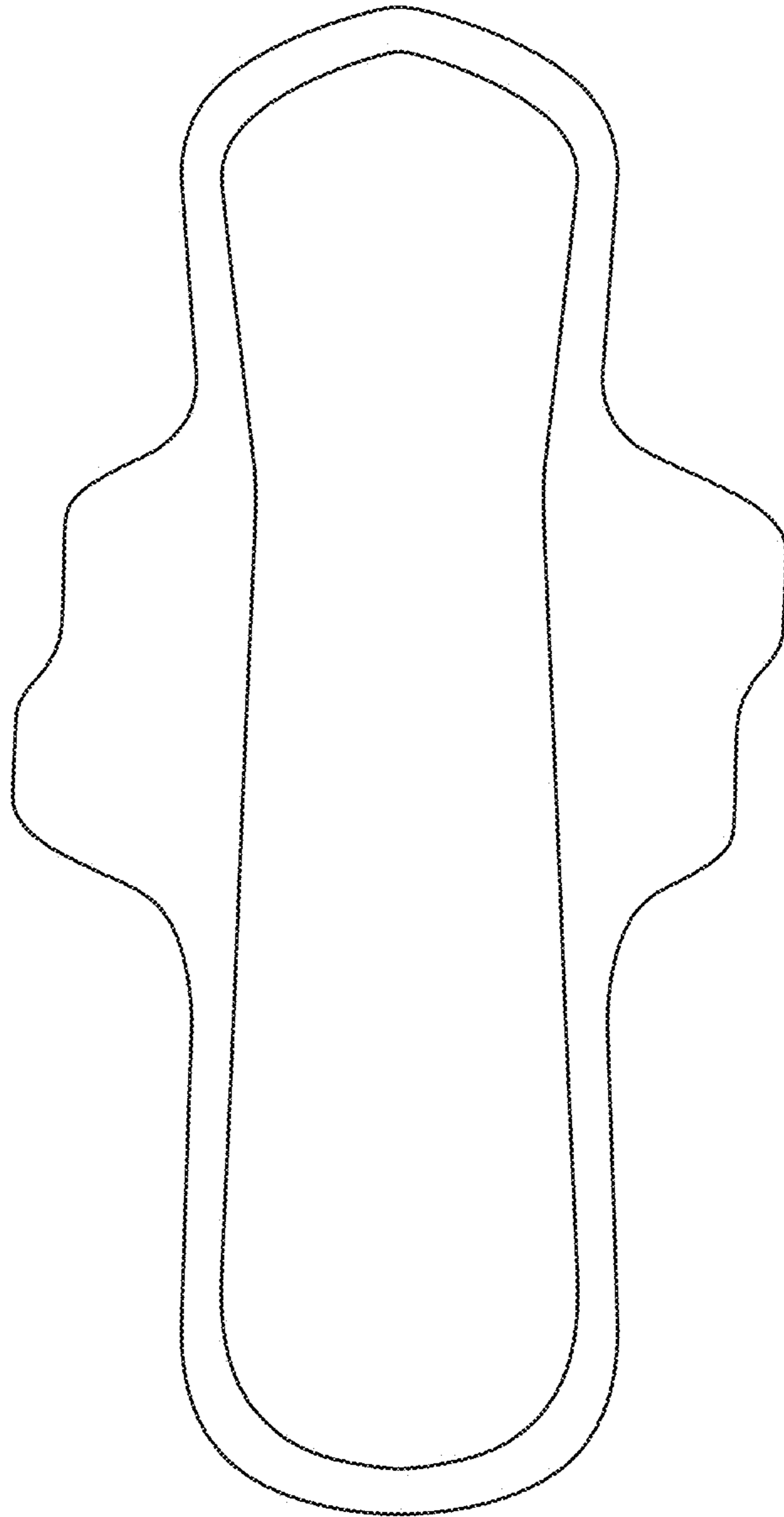

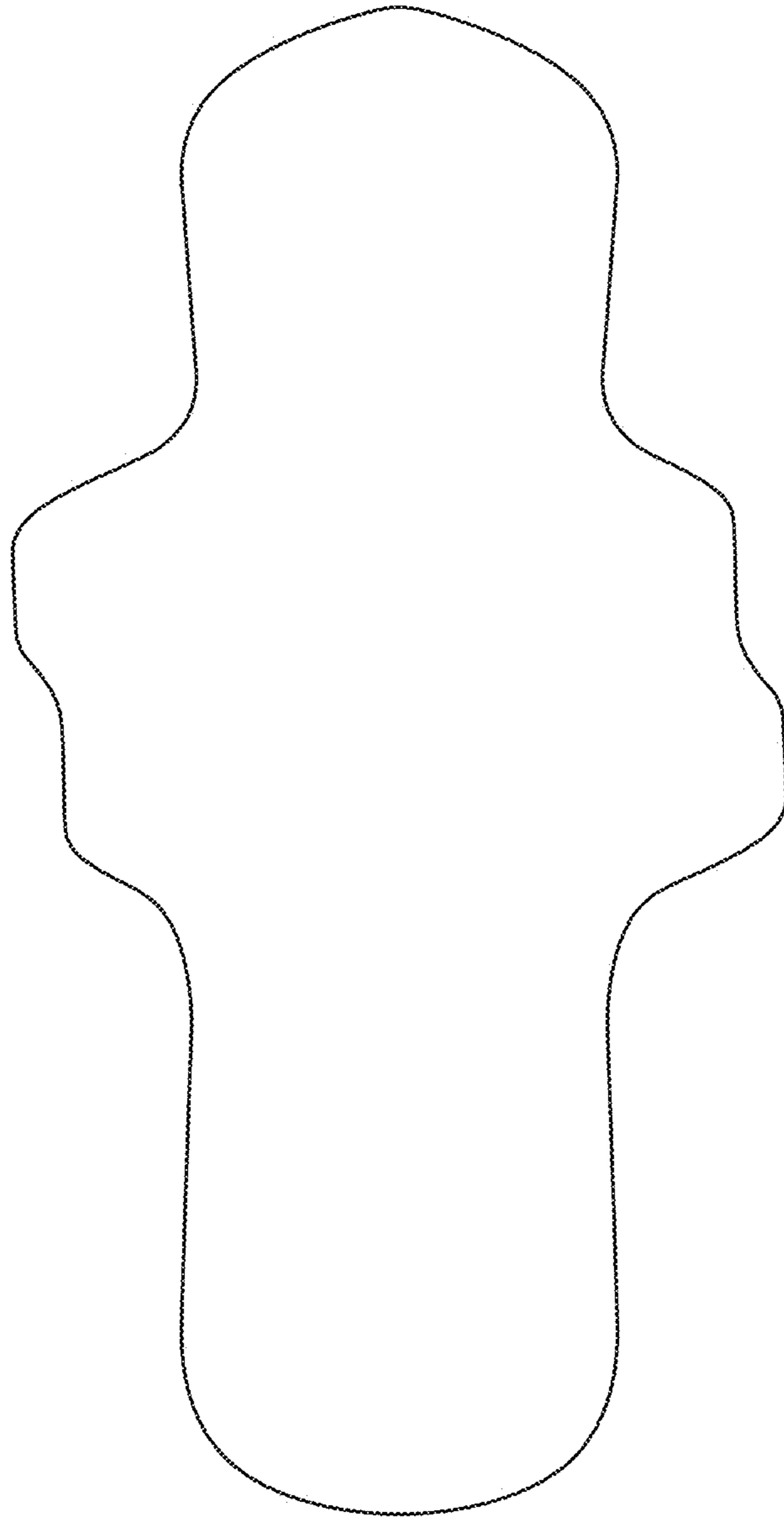

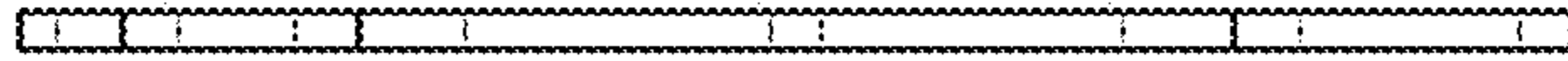

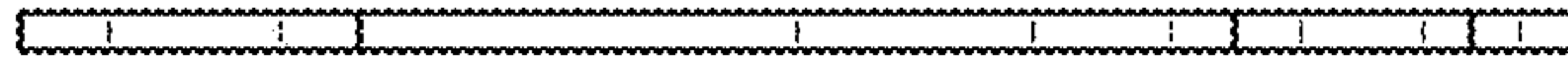

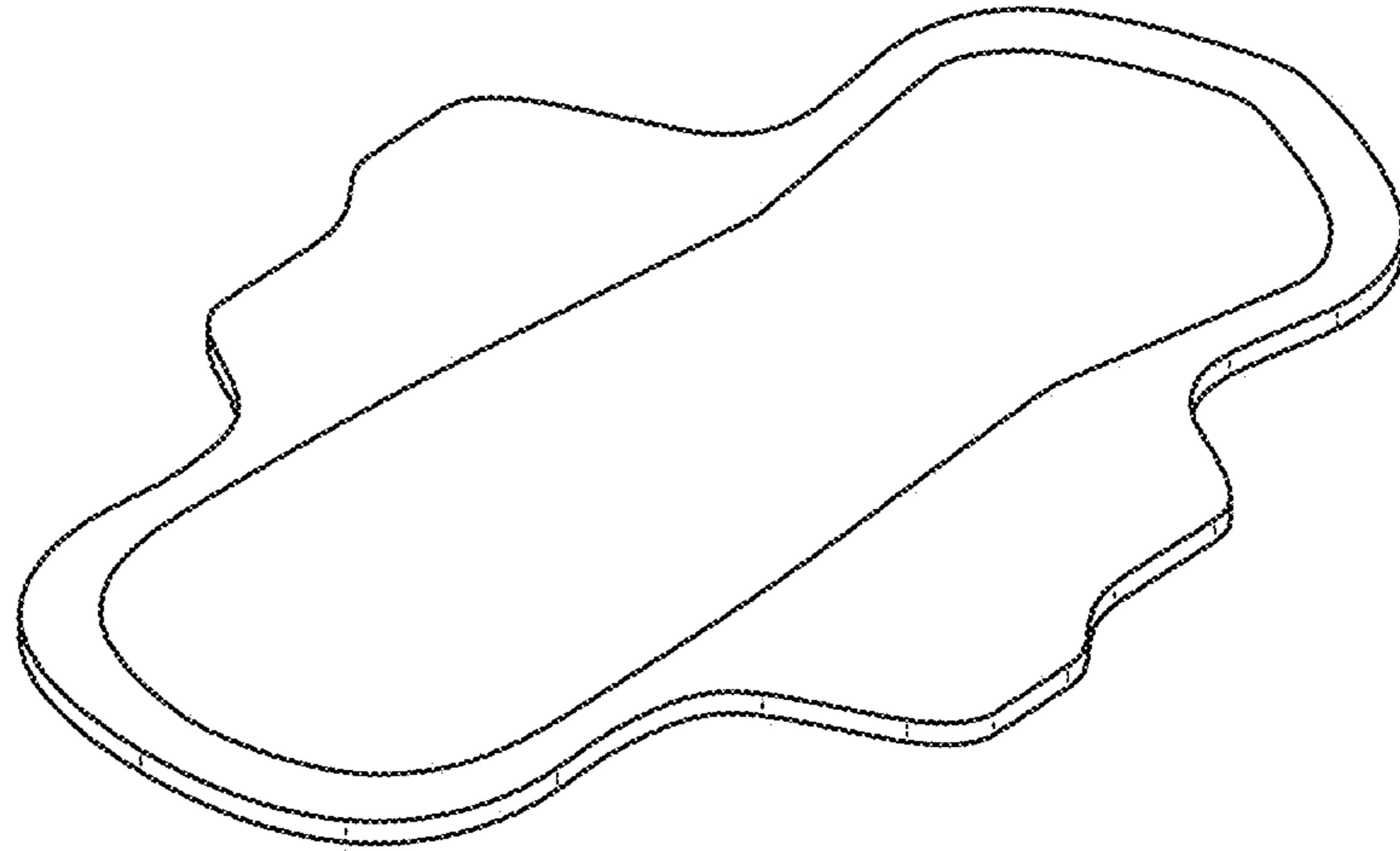

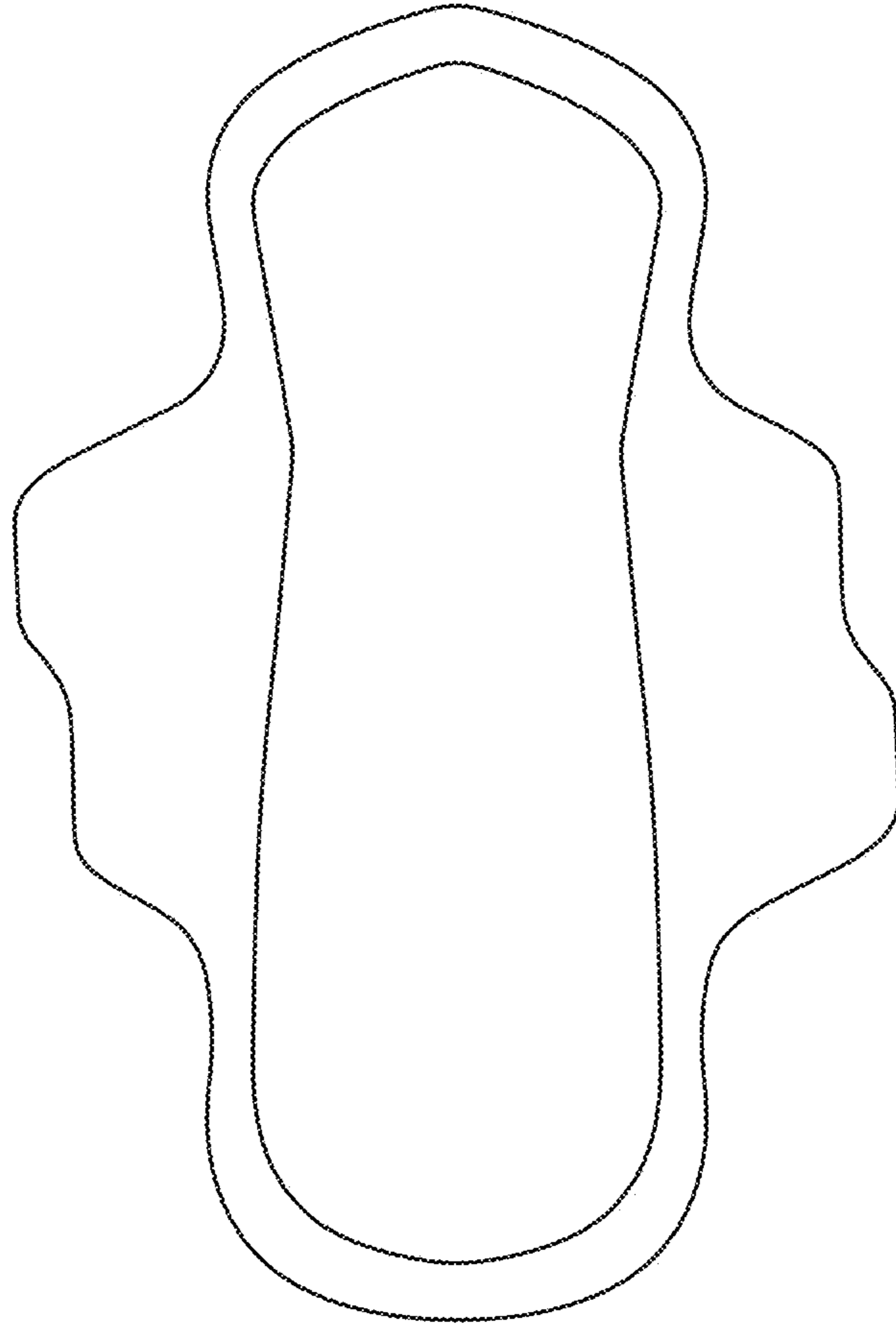

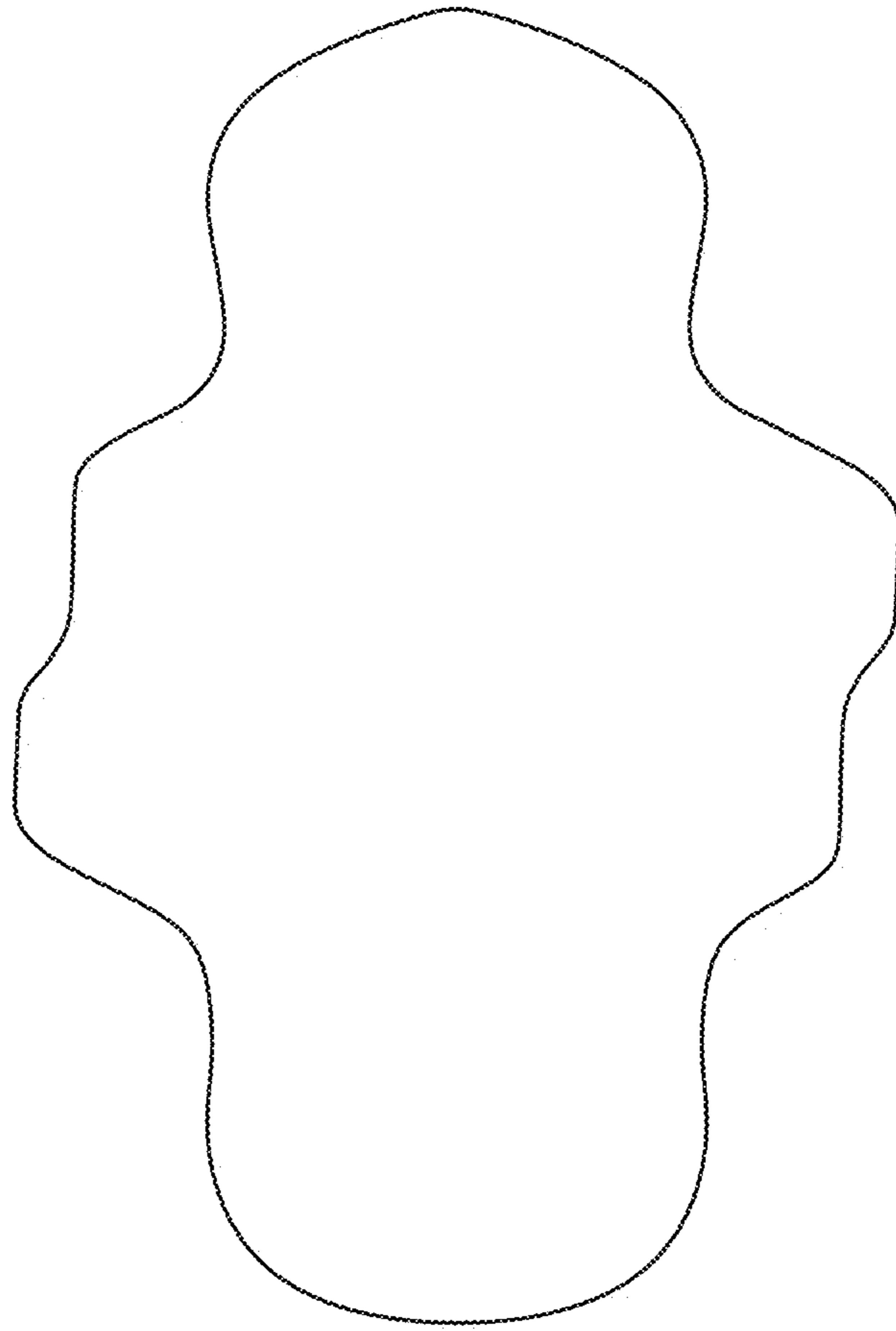

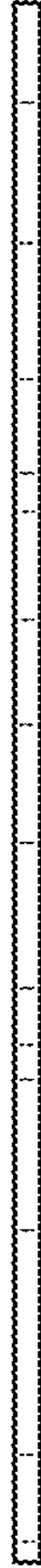

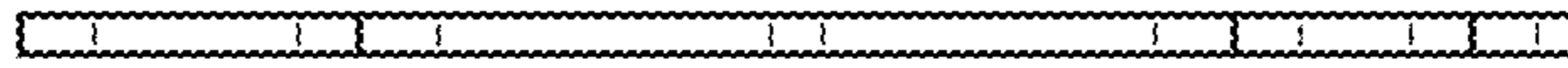

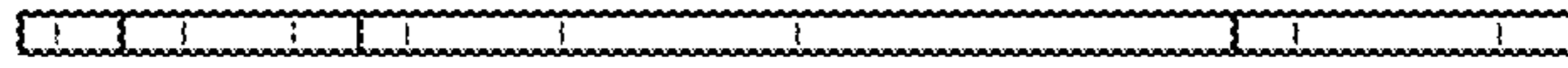

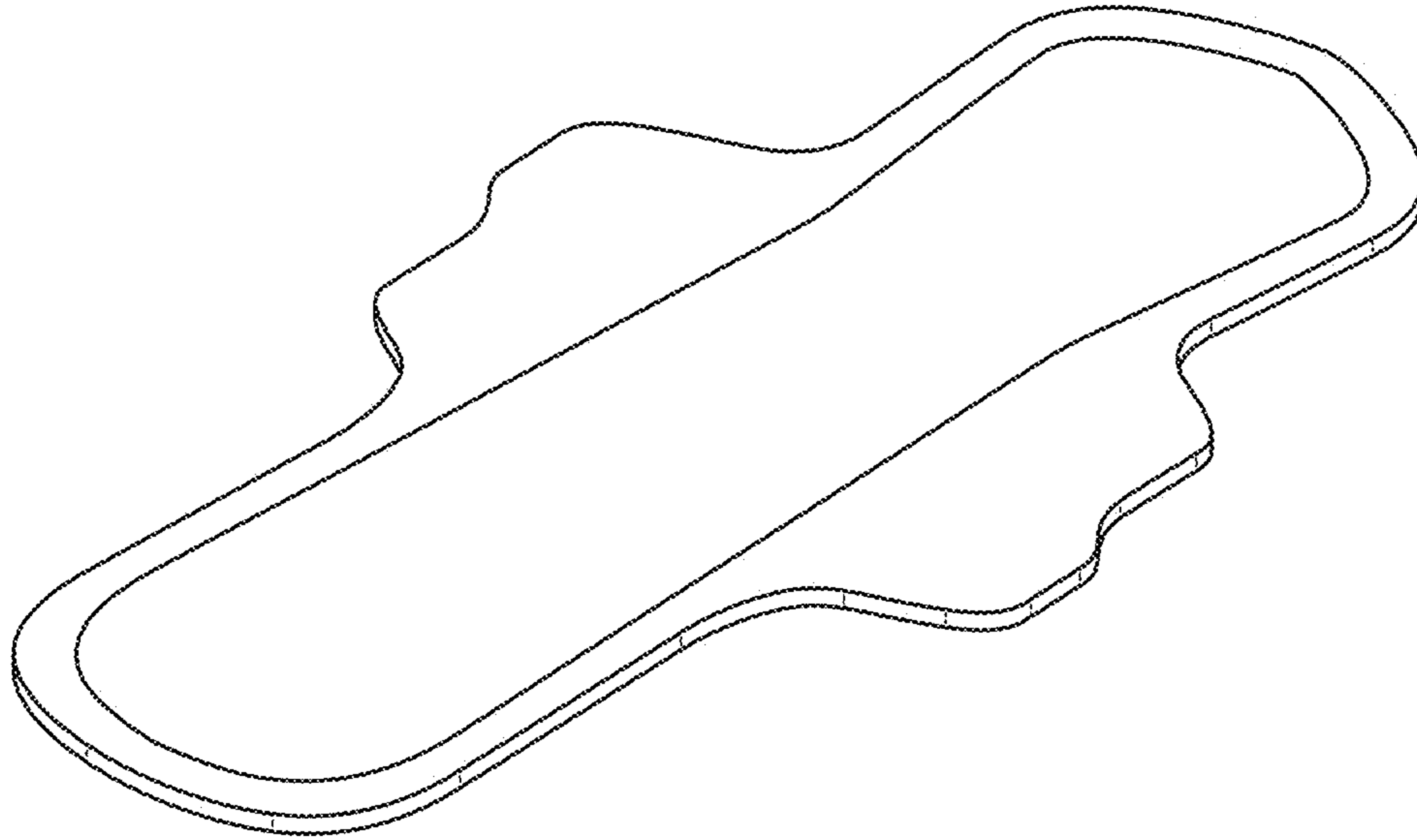

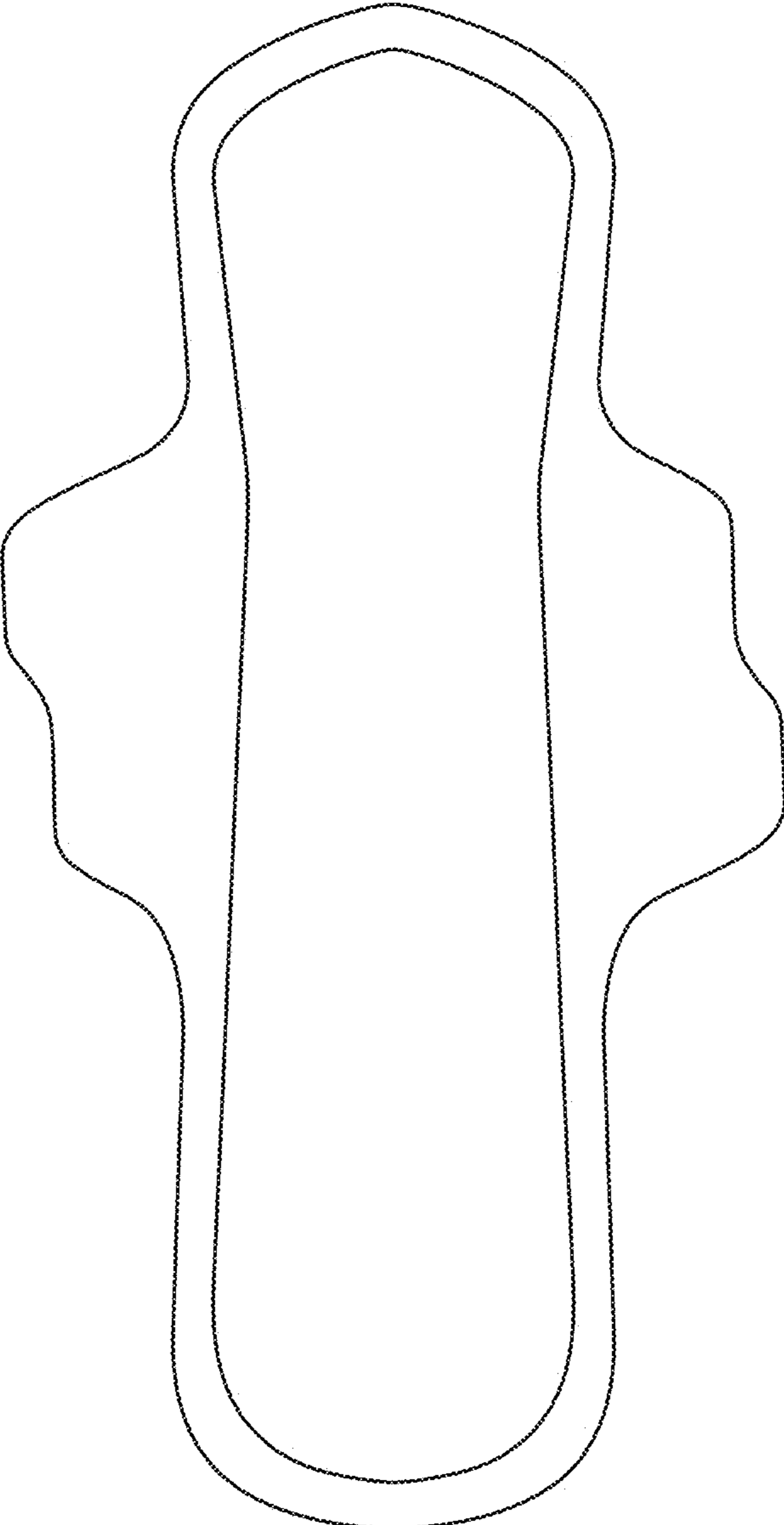

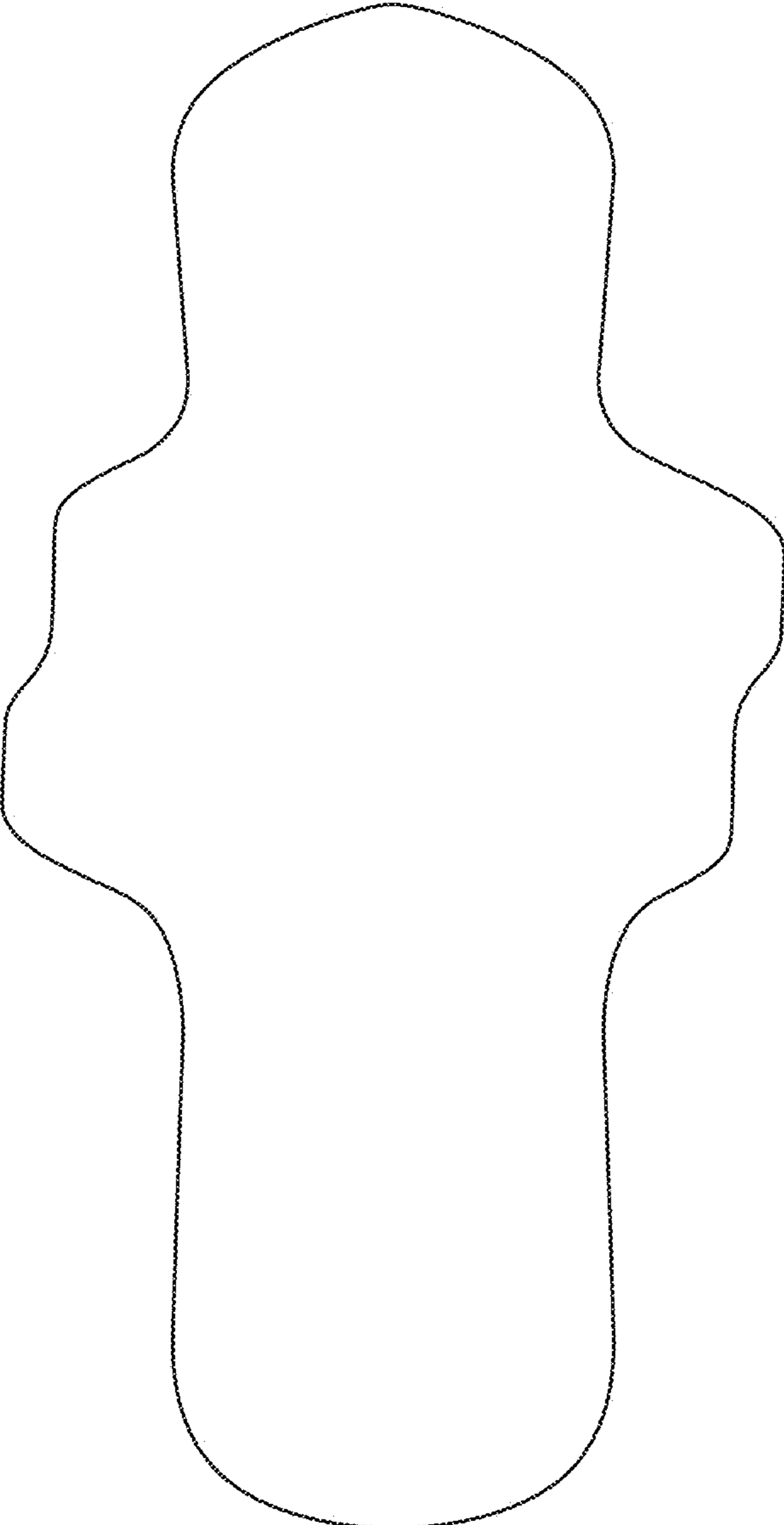

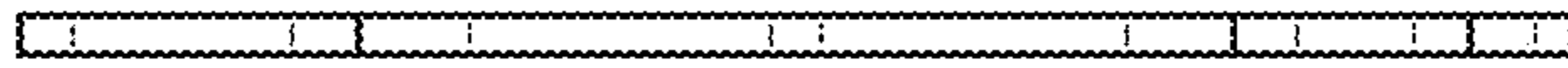

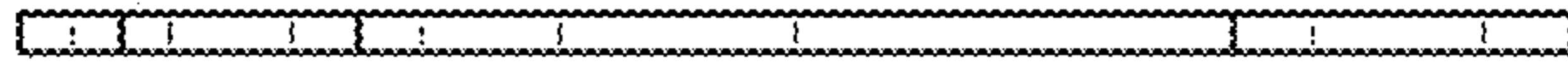

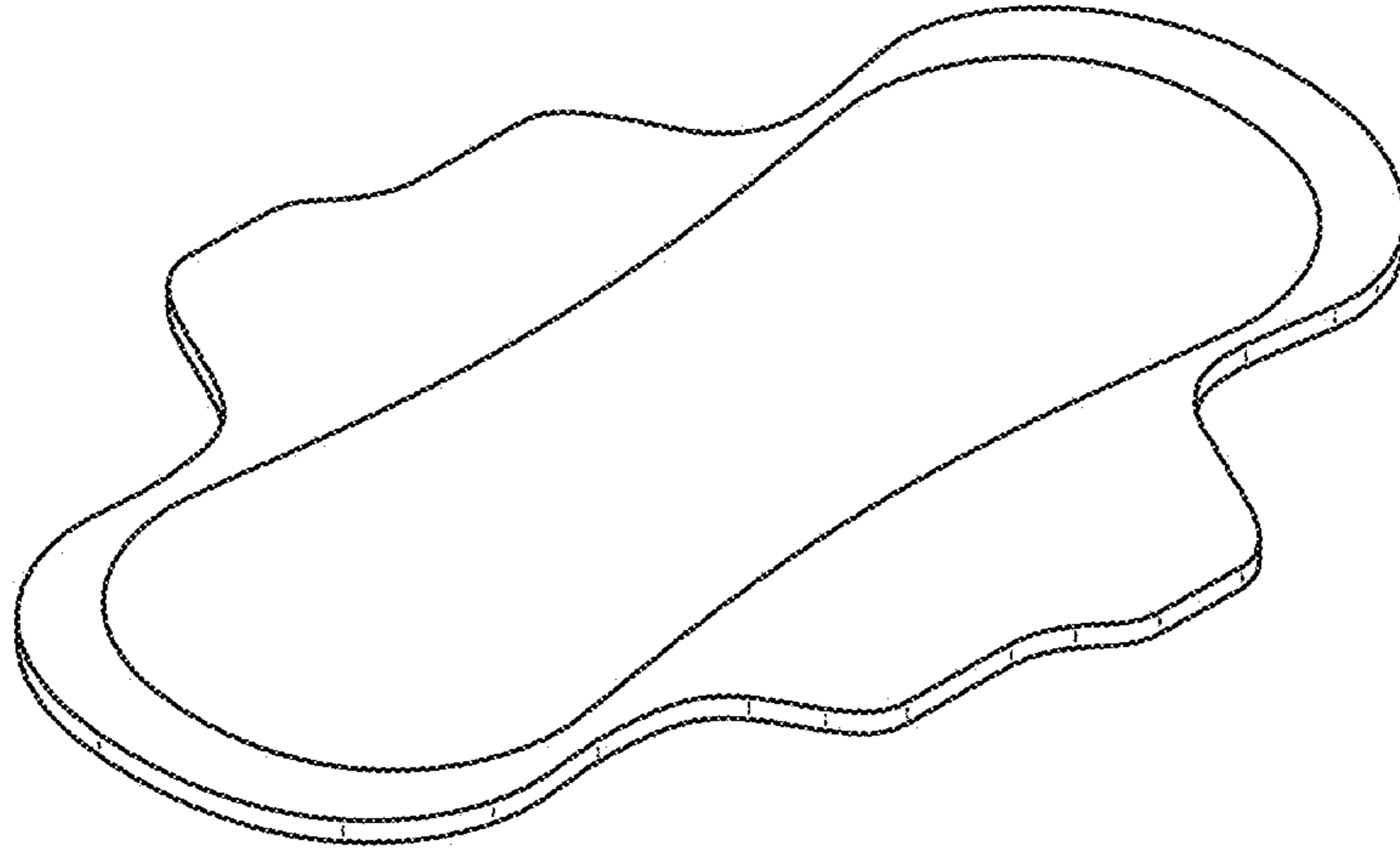

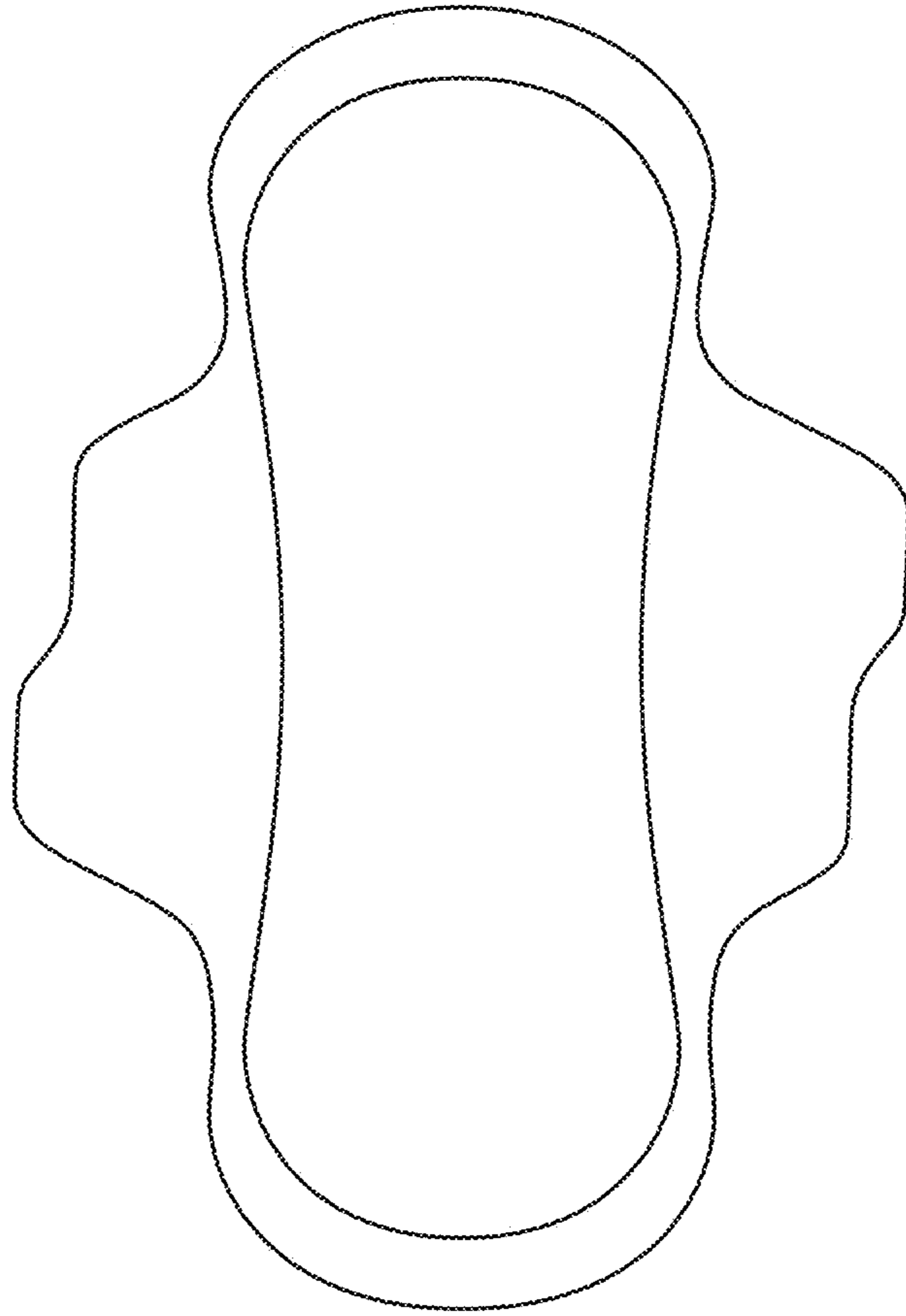

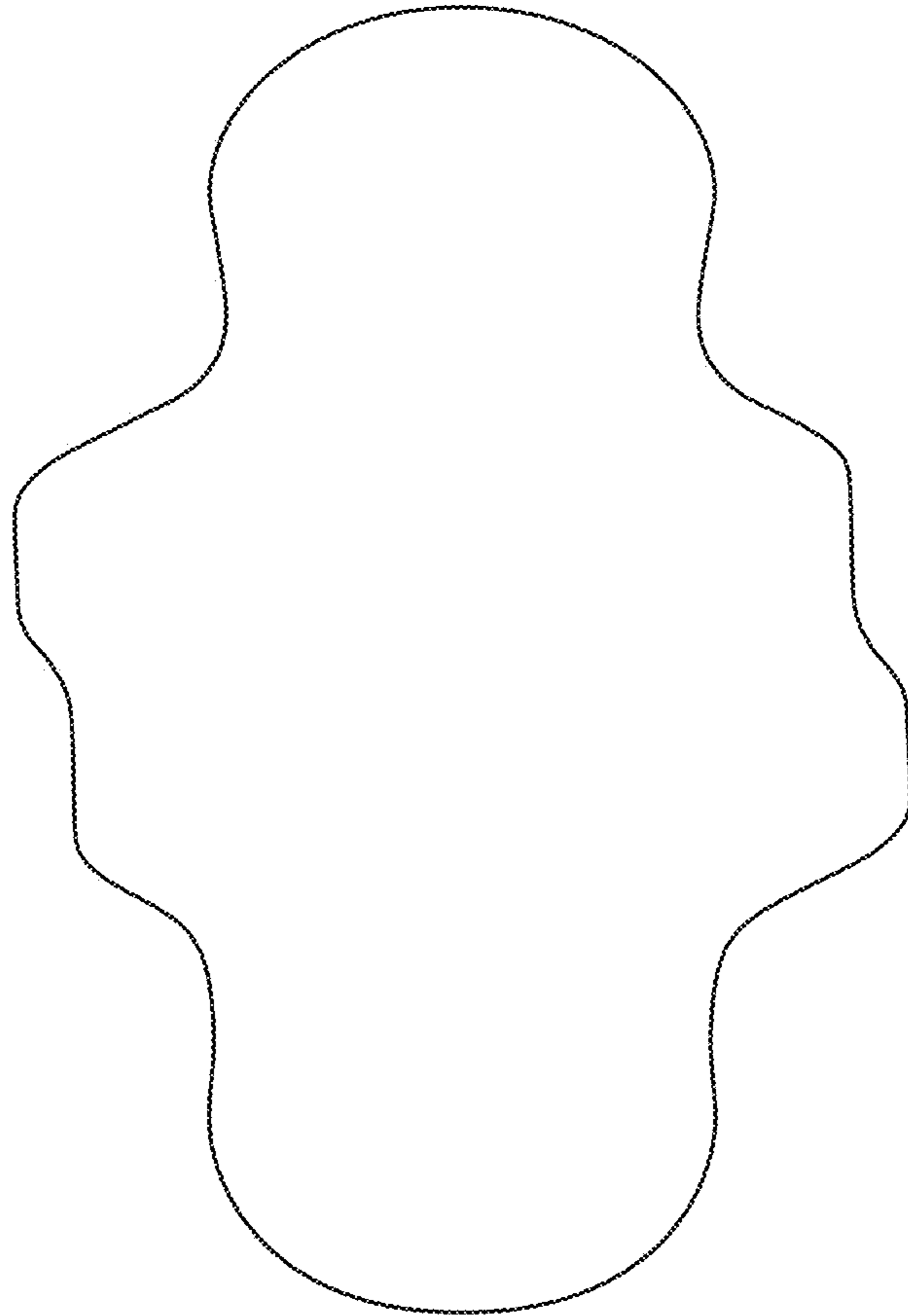

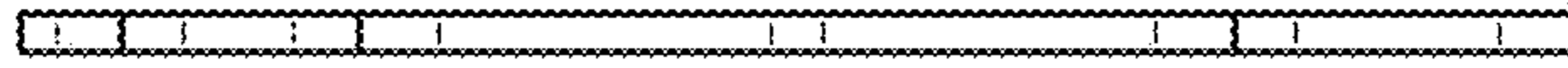

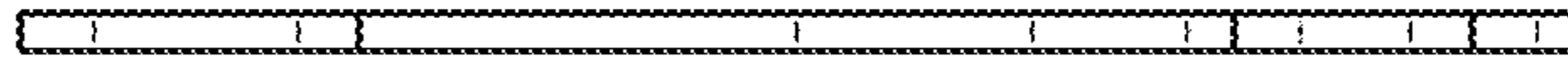

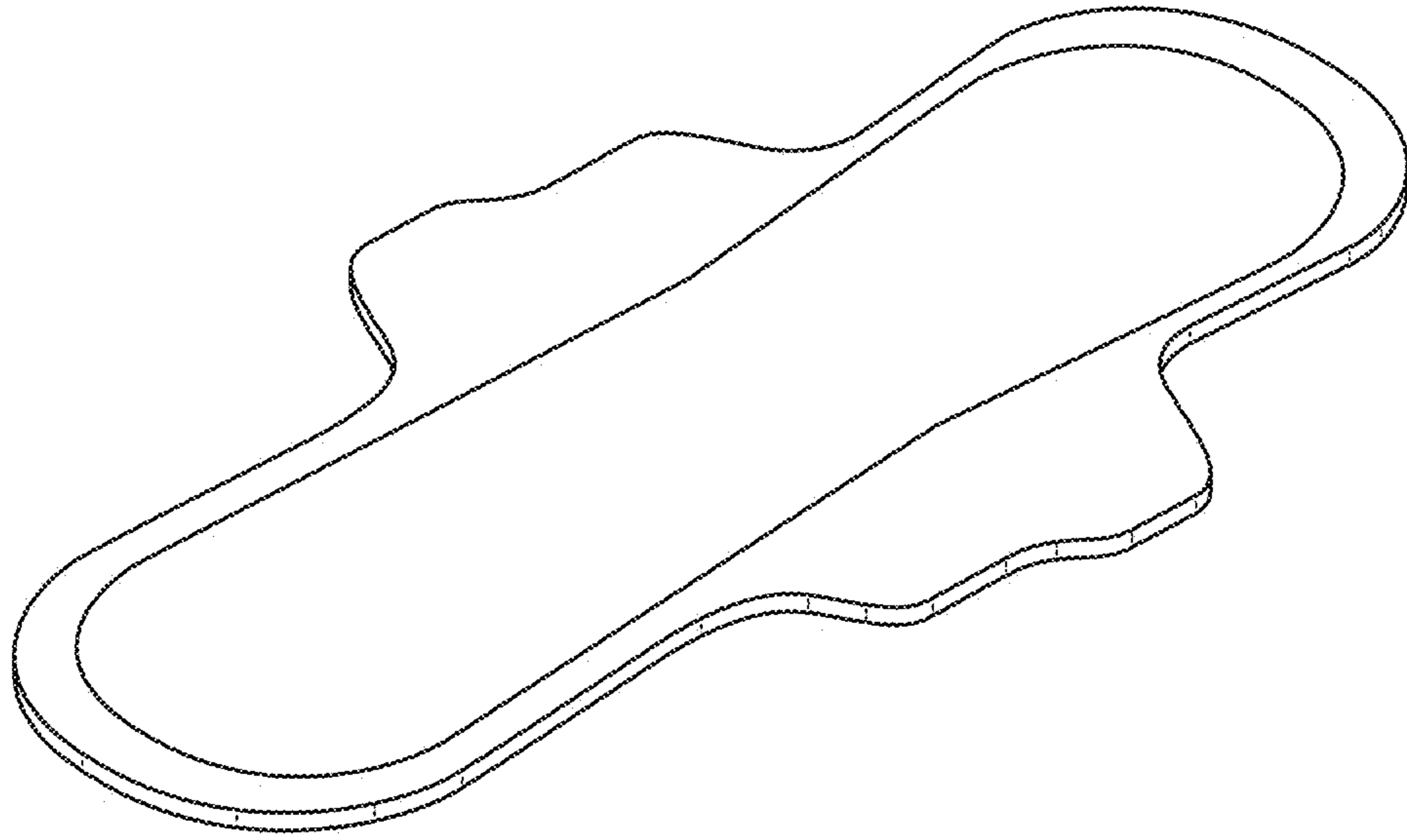

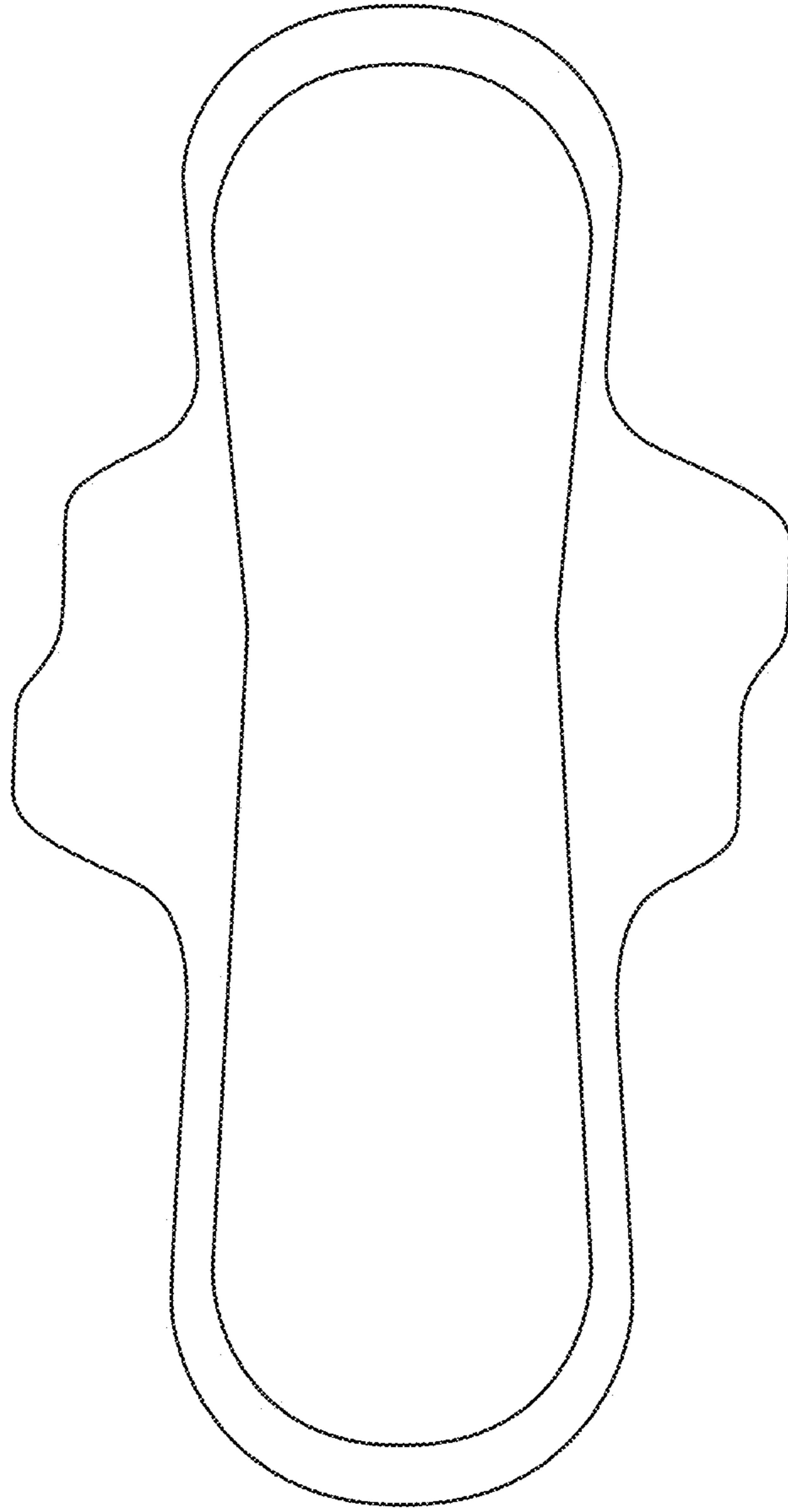

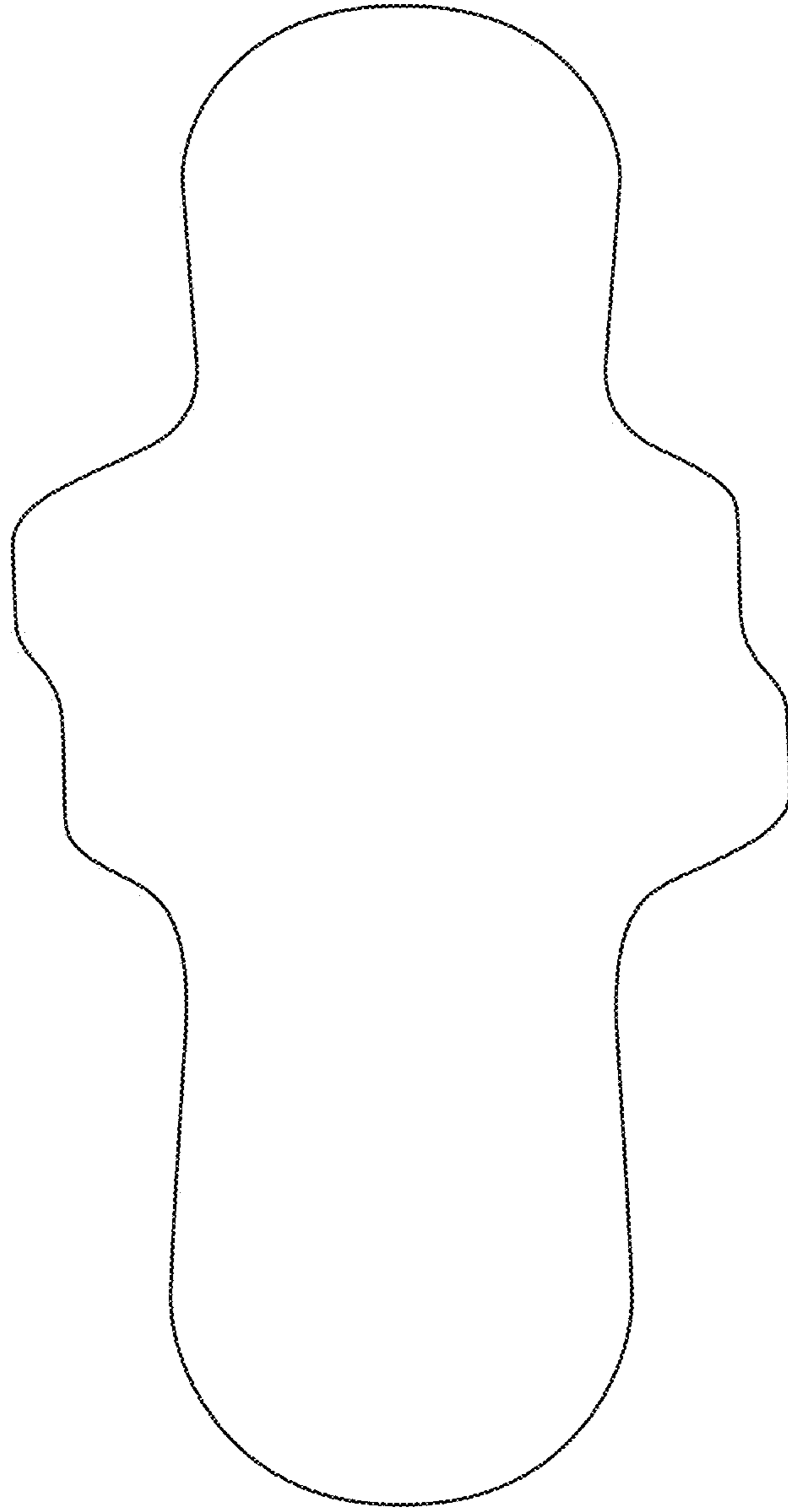

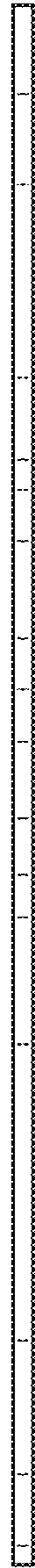

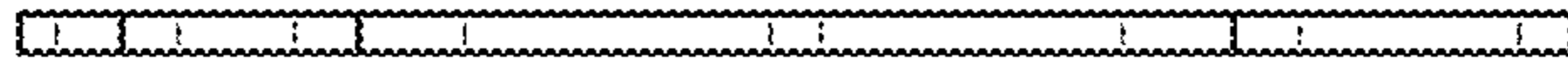

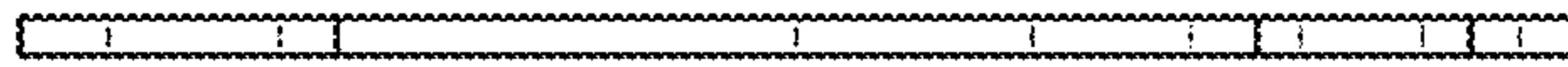
