The ornamental design for a hot and cold pack for the shoulder, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a hot and cold pack for the shoulder in accordance with the invention with attachment straps shown in broken lines;

FIG. 2 is a front view of FIG. 1 with attachment straps shown in broken lines;

FIG. 3 is a rear view of FIG. 1 with attachment straps shown in broken lines;

FIG. 4 is a top view of FIG. 1 with attachment straps shown in broken lines;

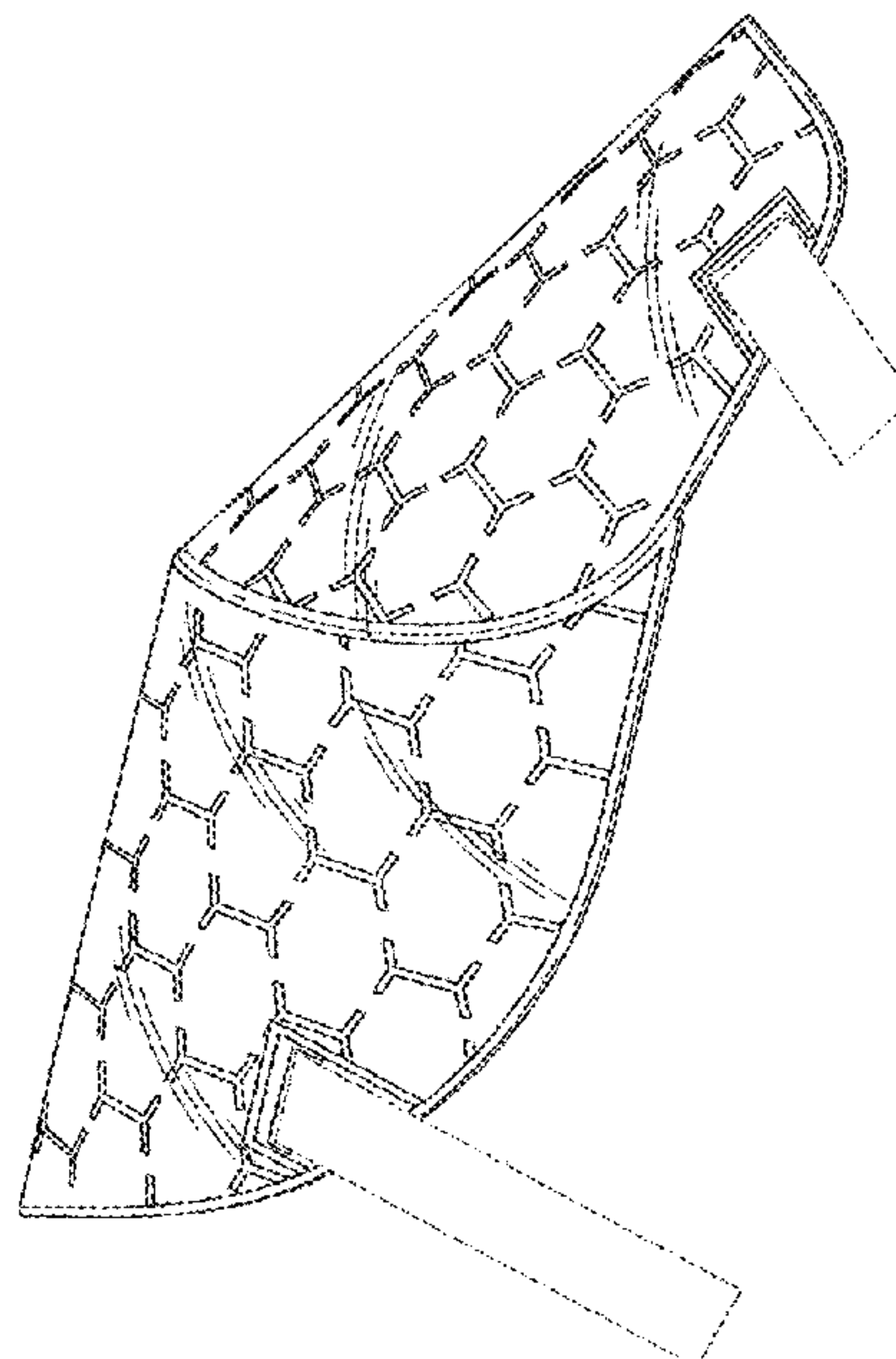
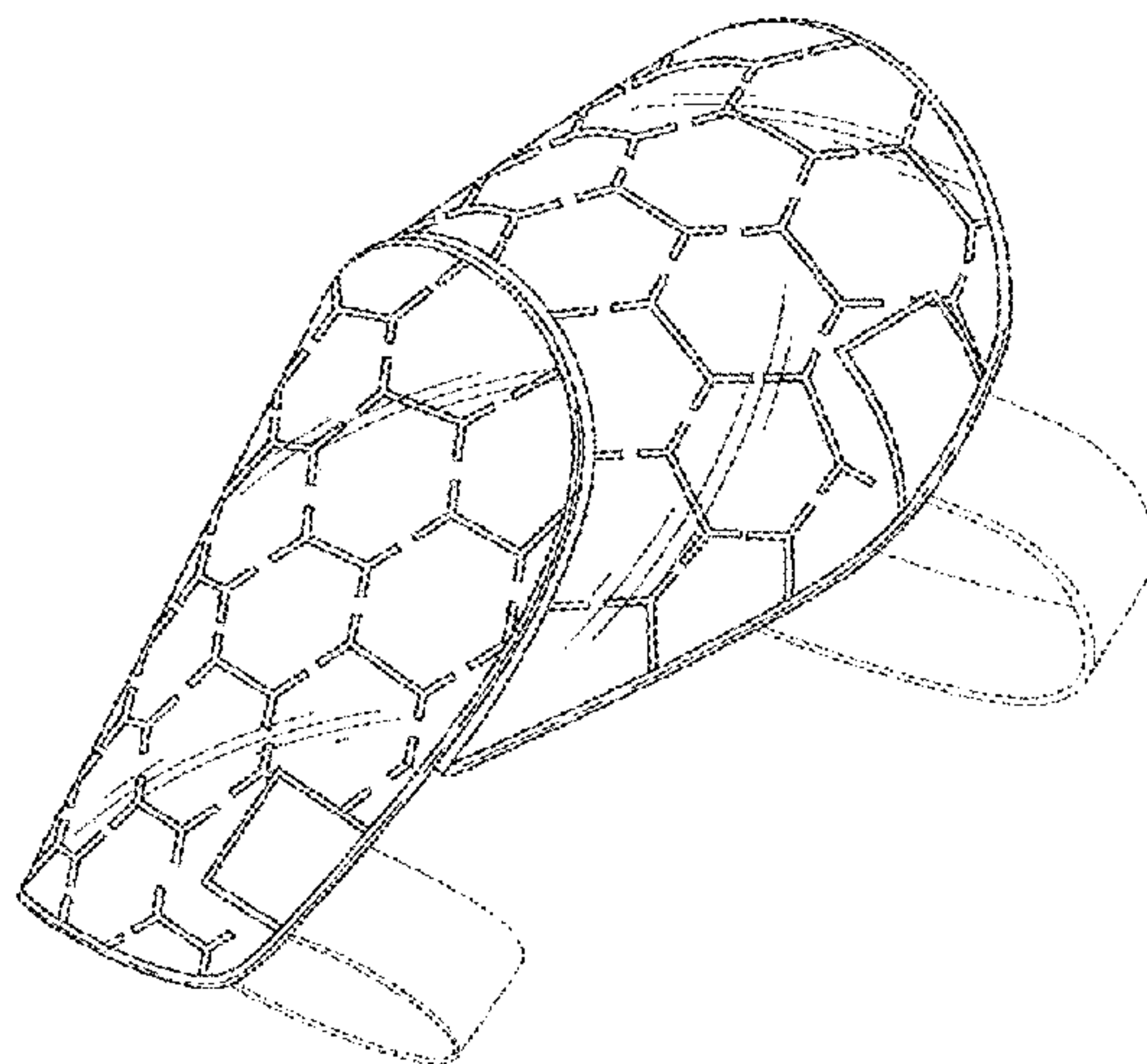
FIG. 5 is a bottom view of FIG. 1 with attachment straps shown in broken lines;

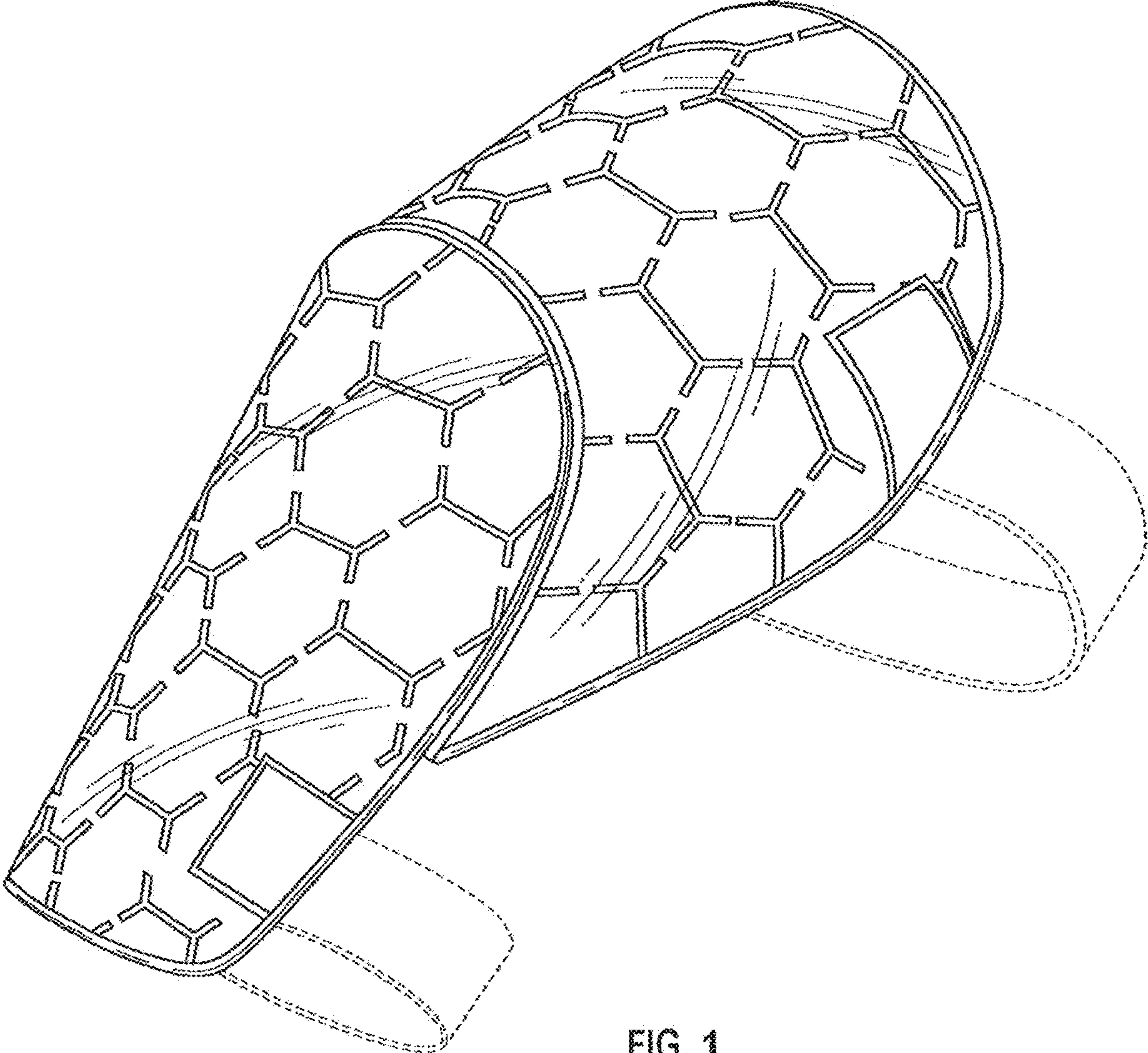

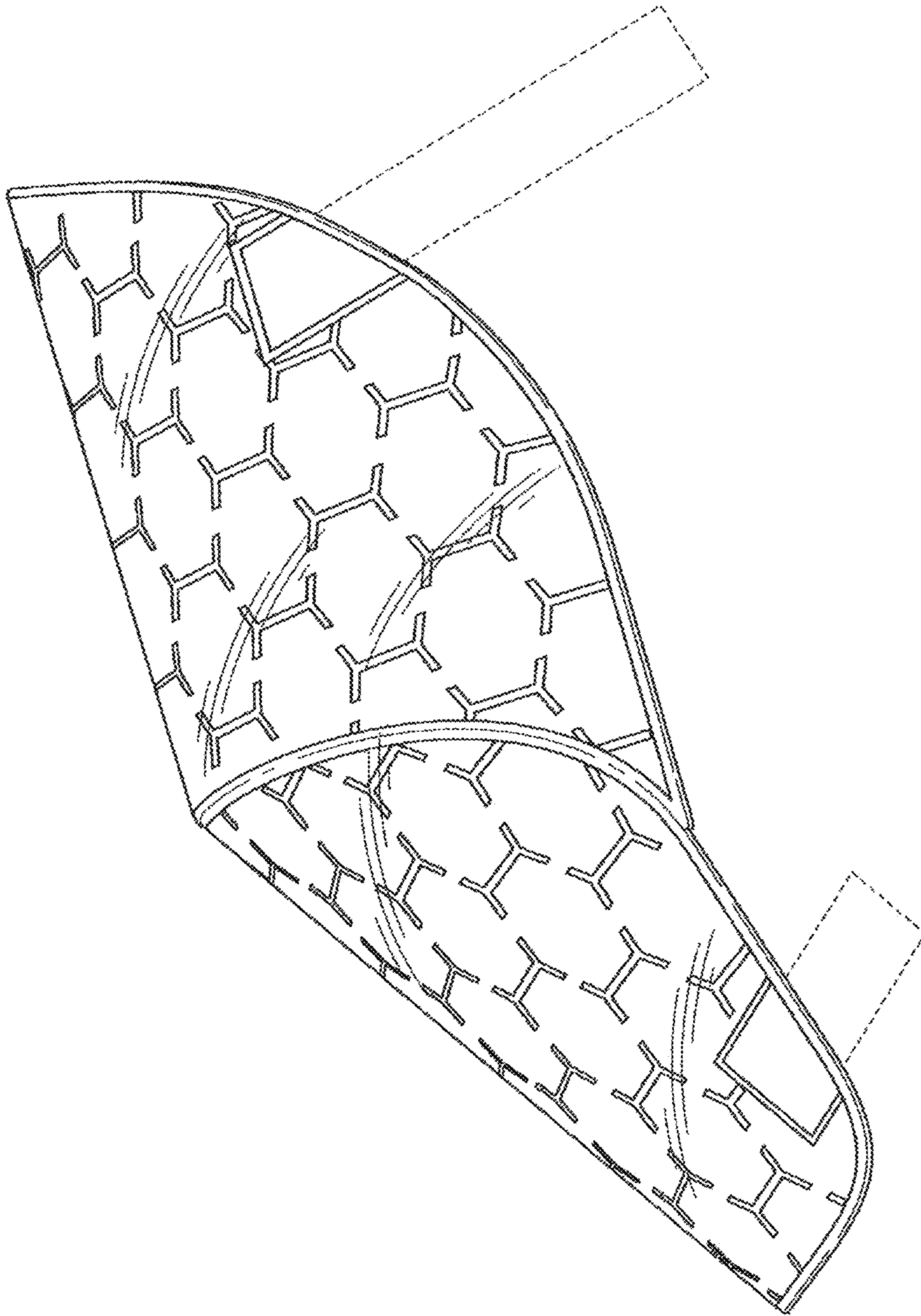

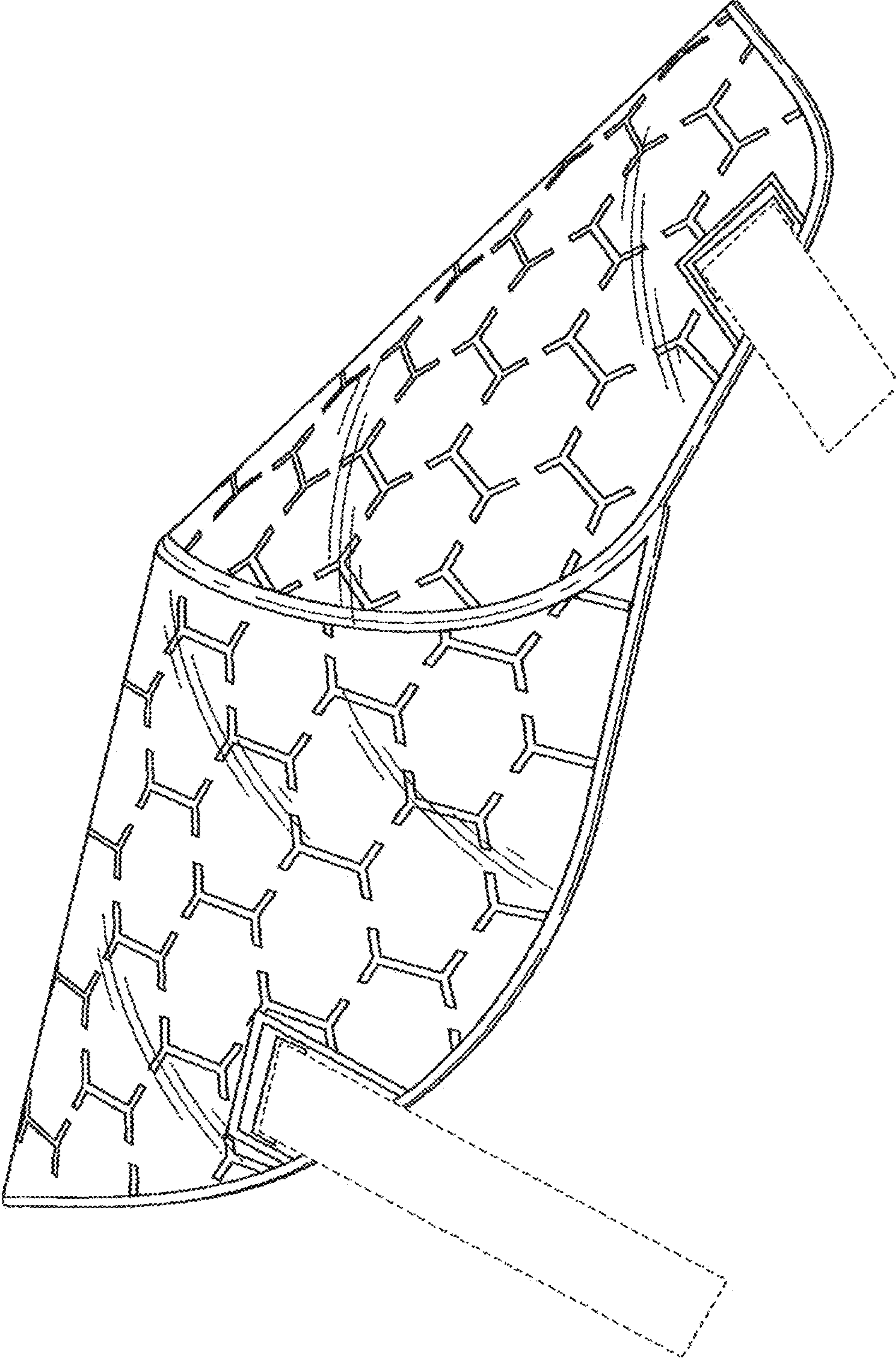

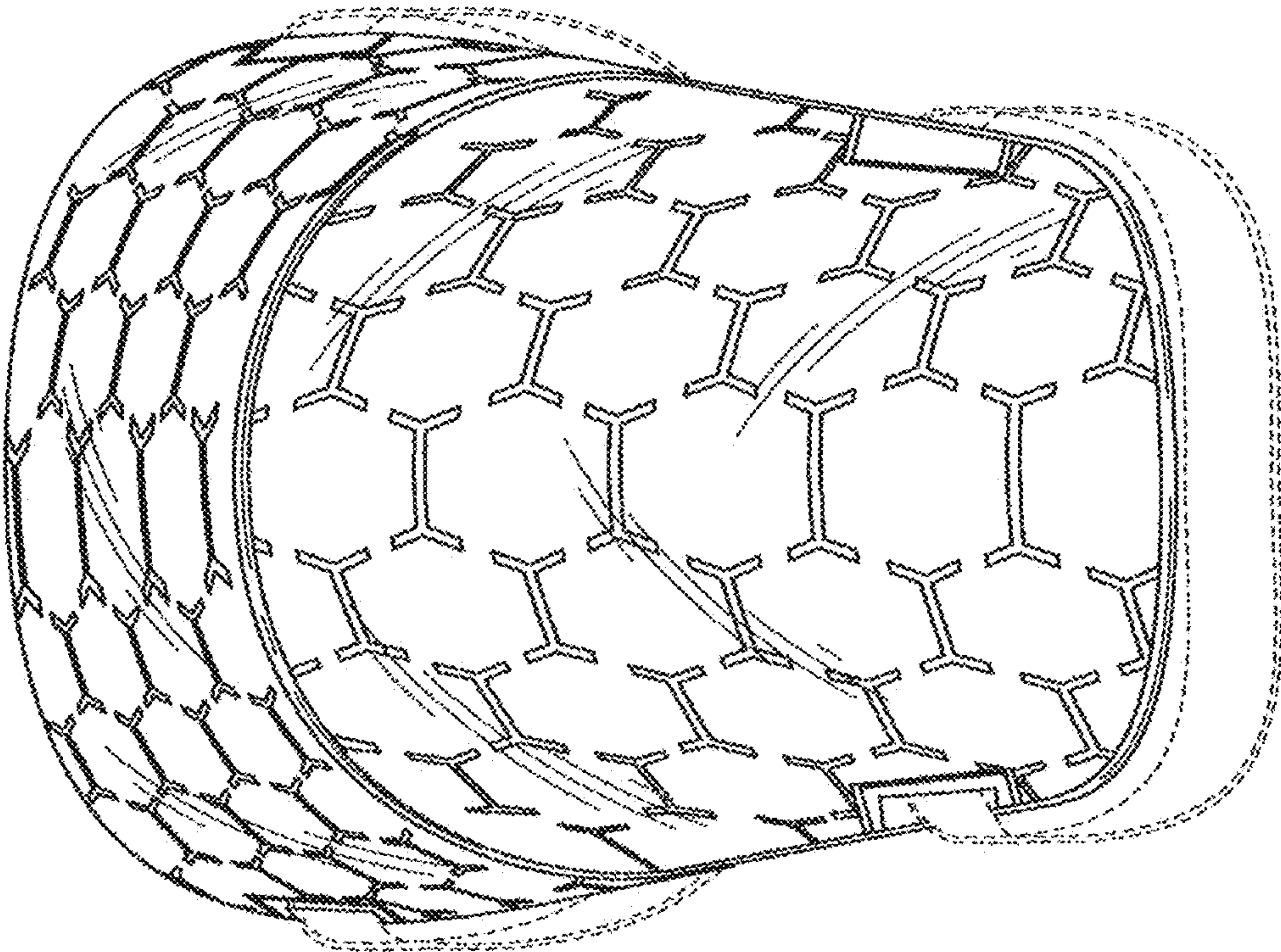

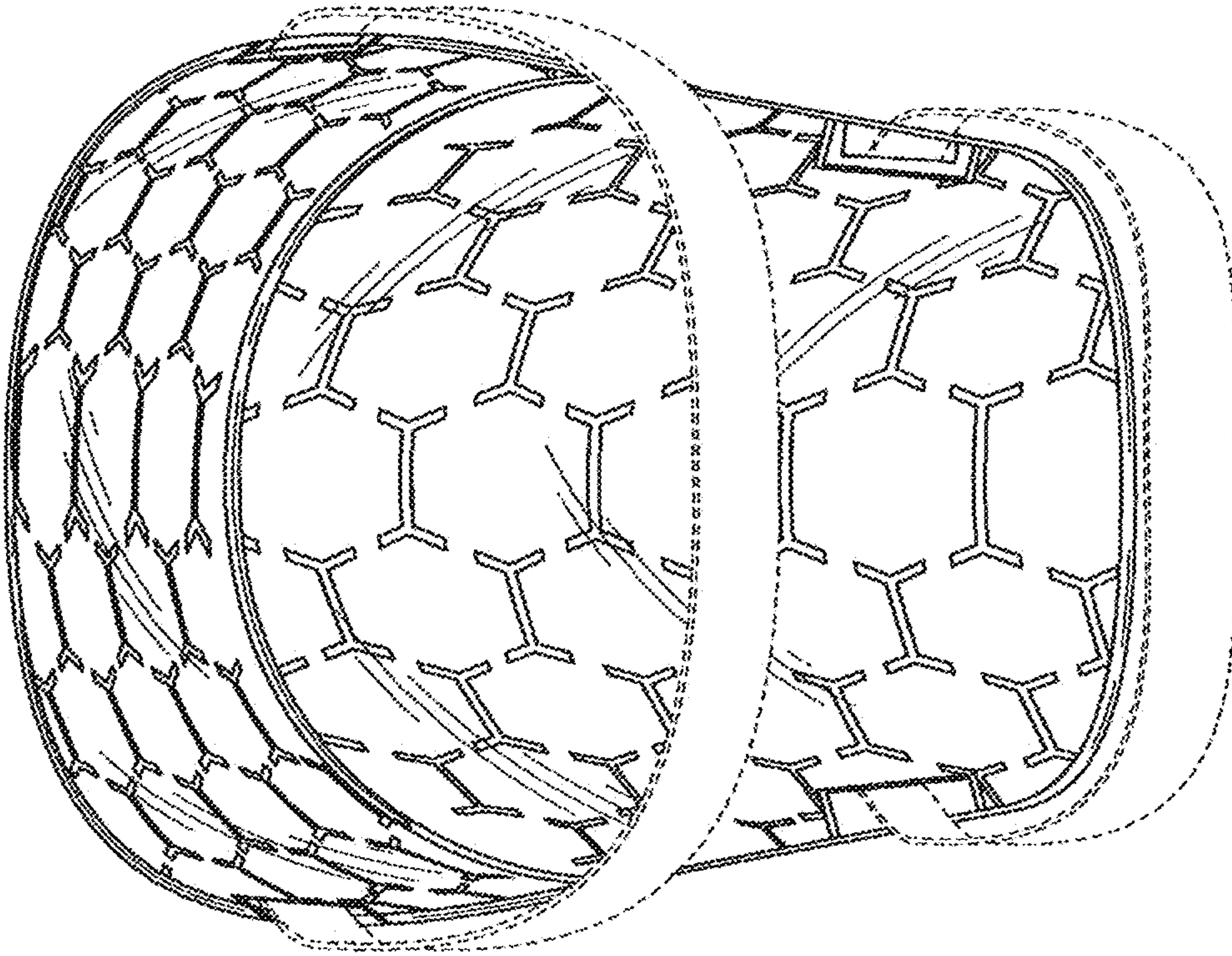

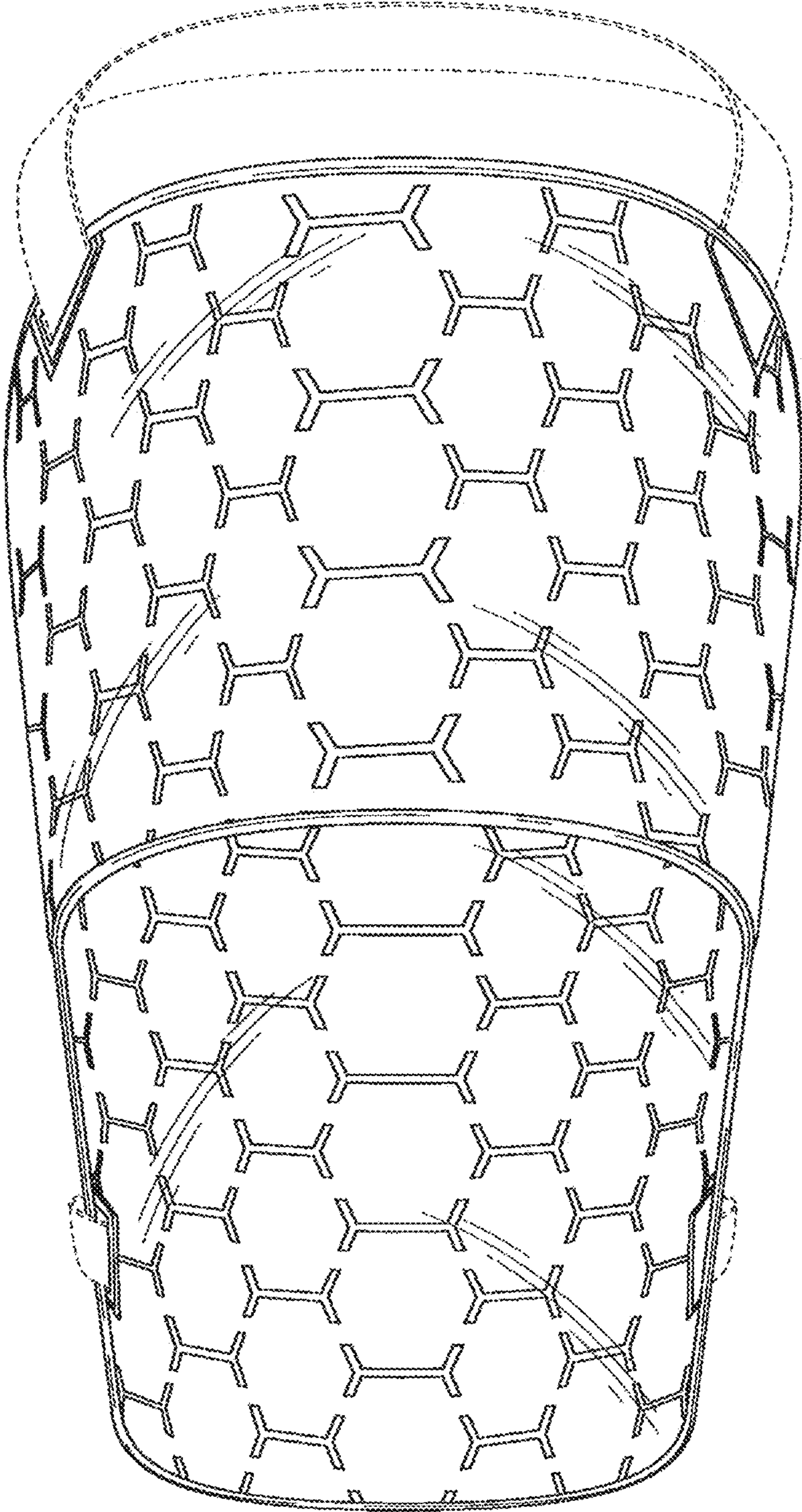

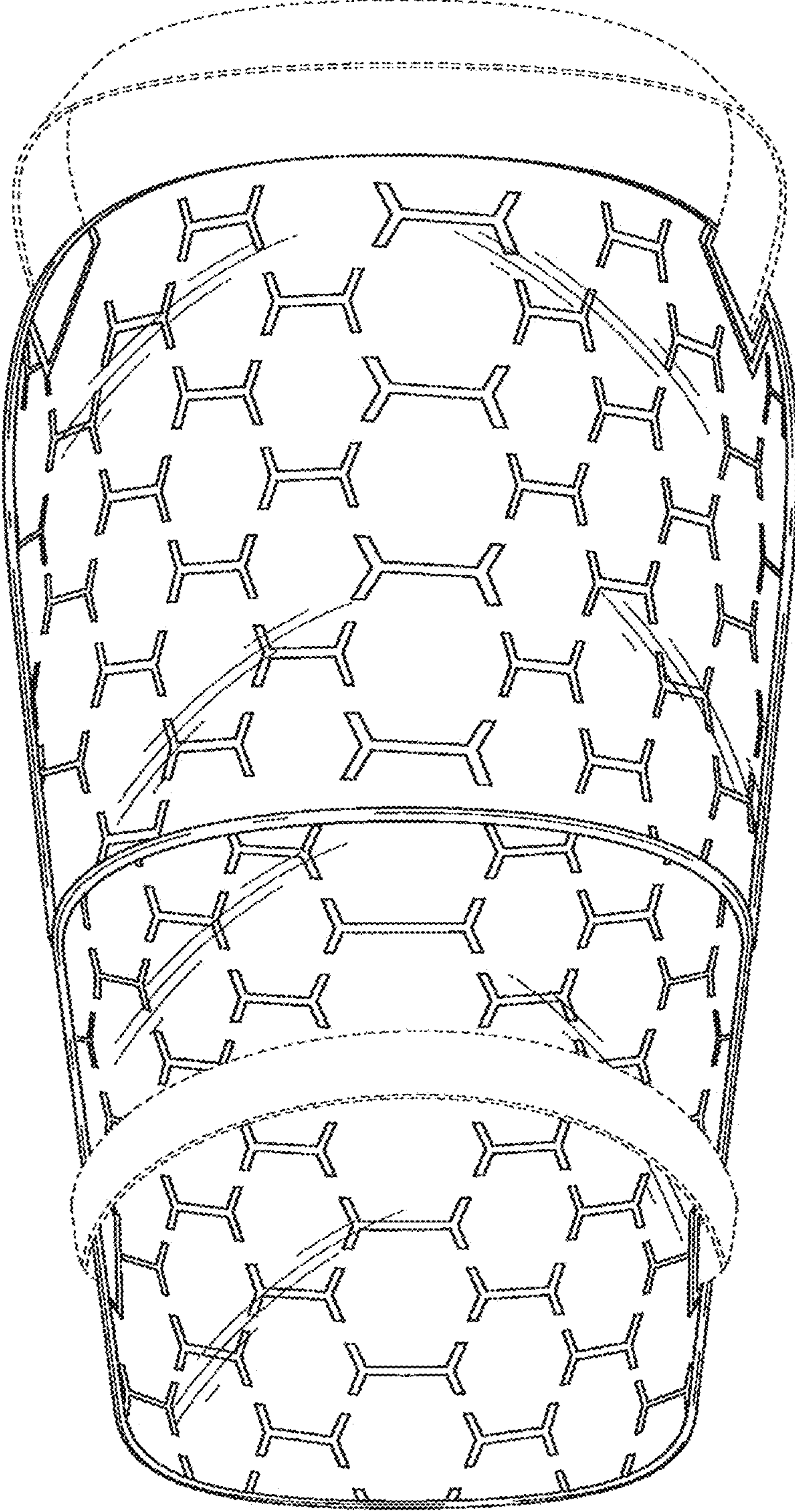
