shown in FIG. 1.

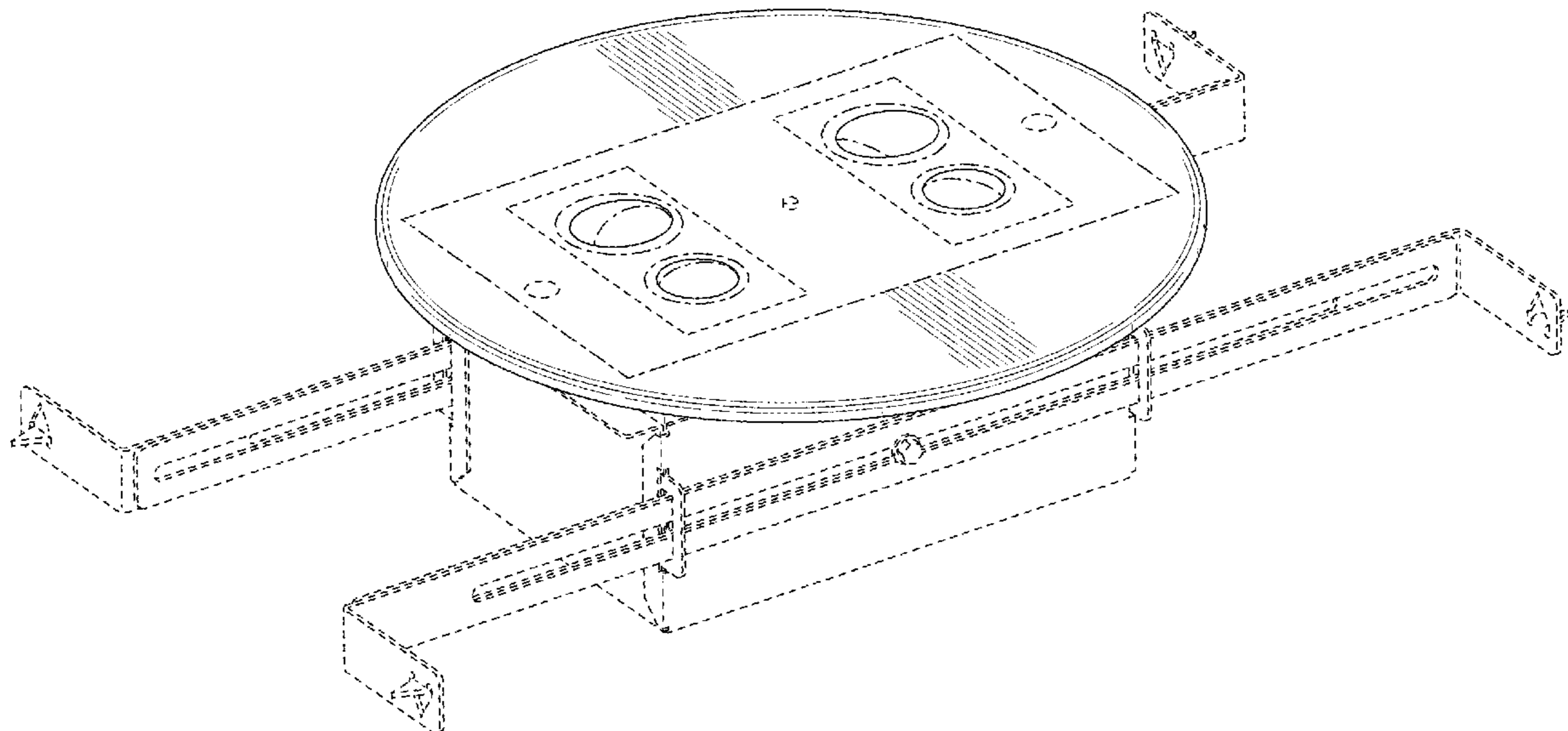
FIG. 3 is a first side view of the light fixture shown in FIG.

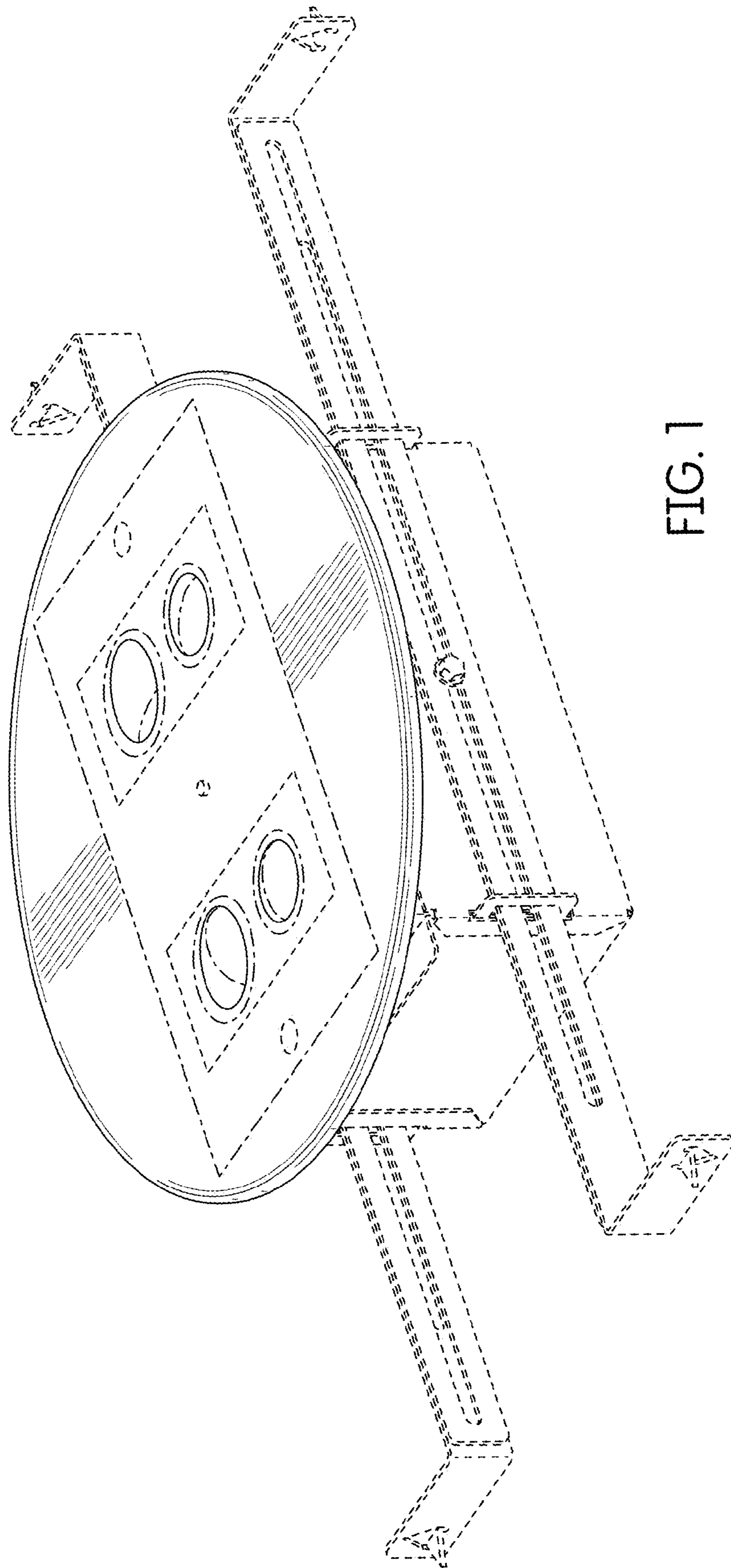

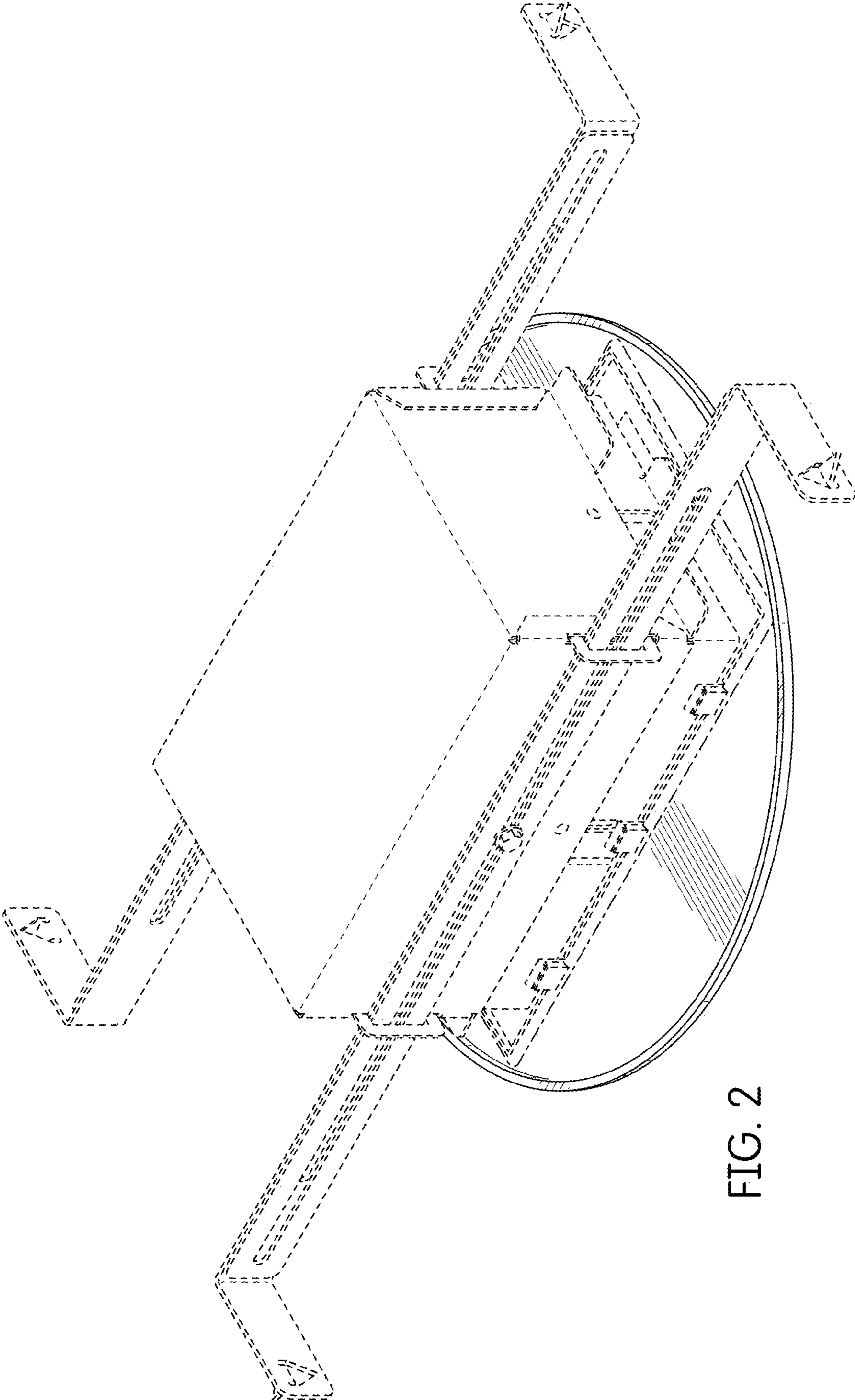

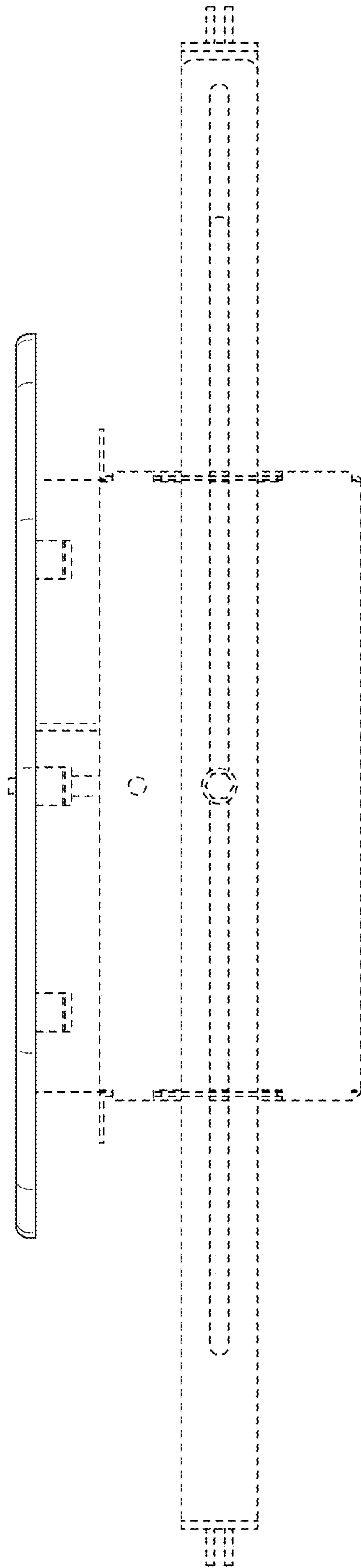

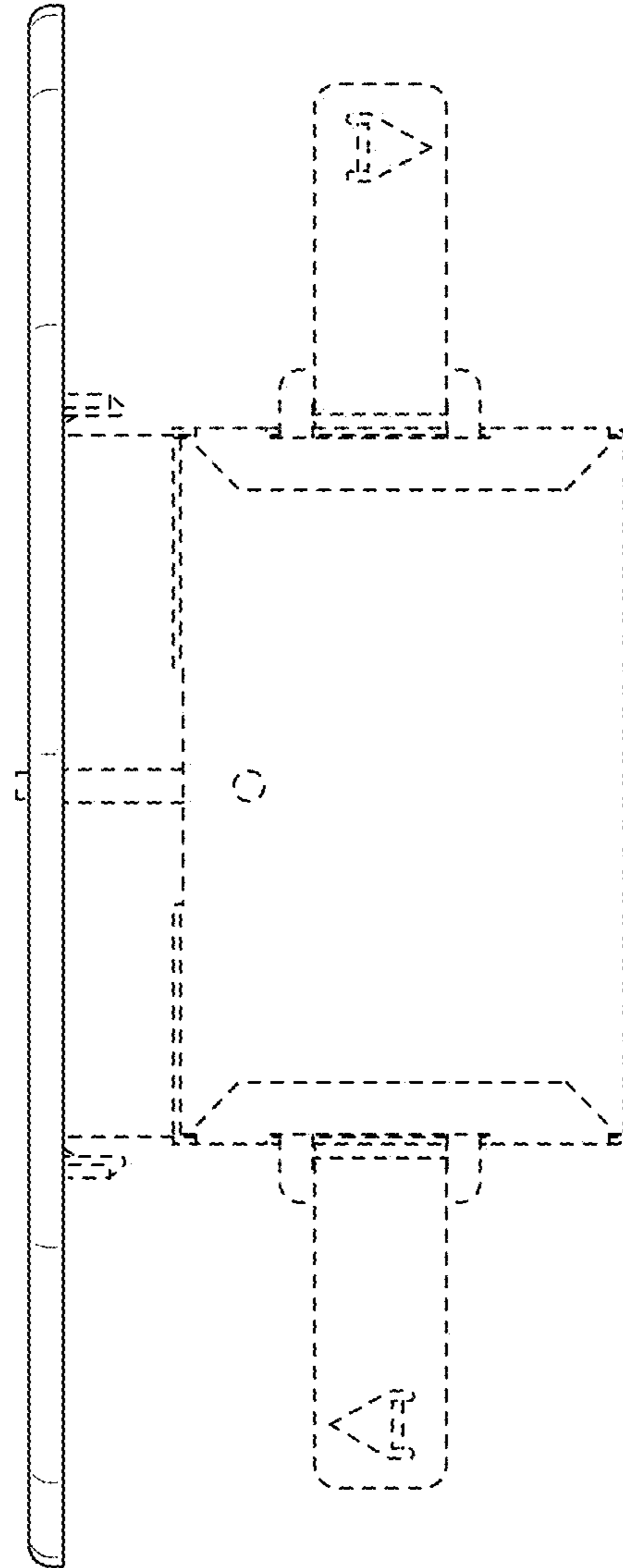

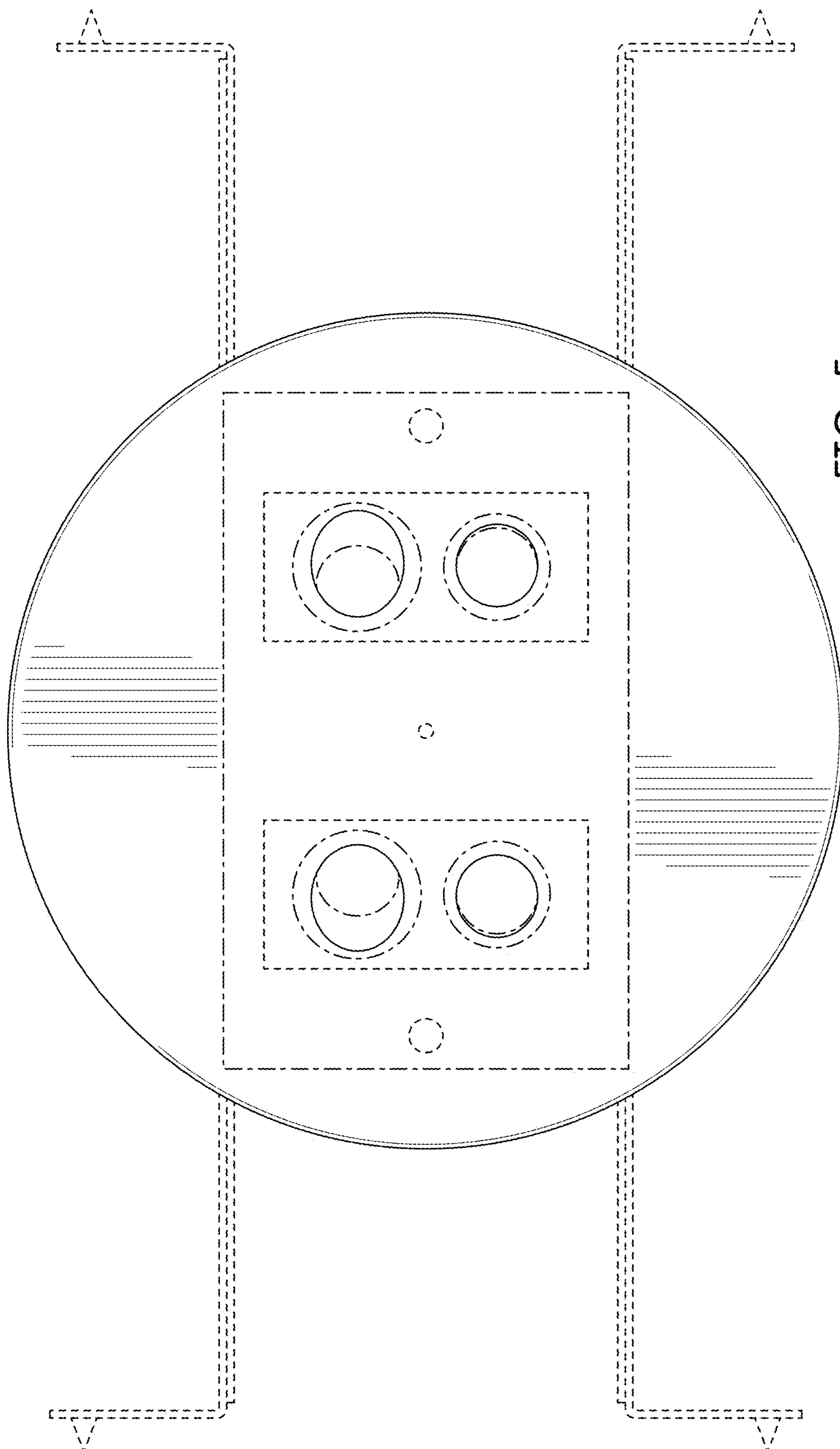

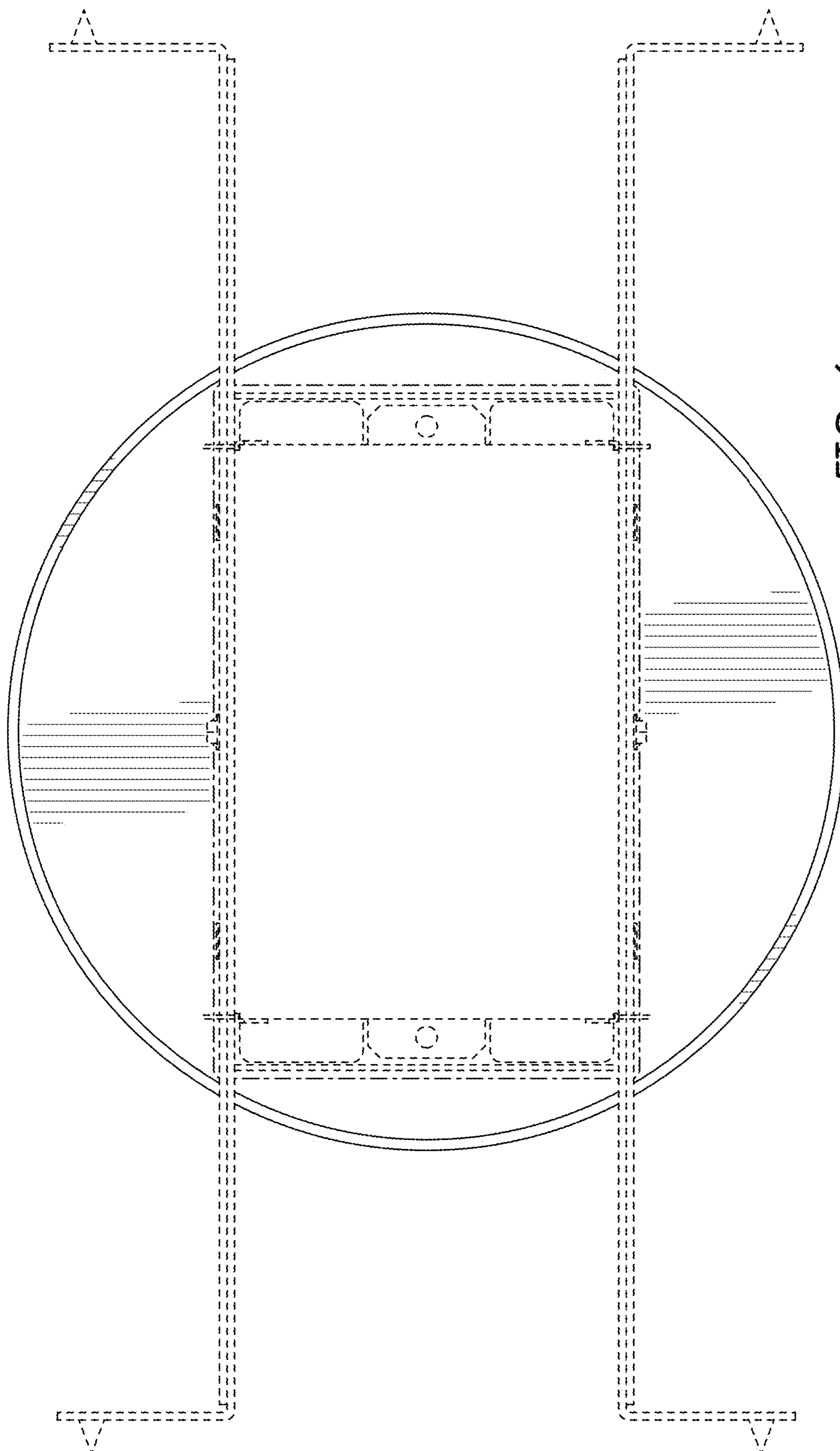
