The ornamental design for an electronic cigarette, as shown and described.

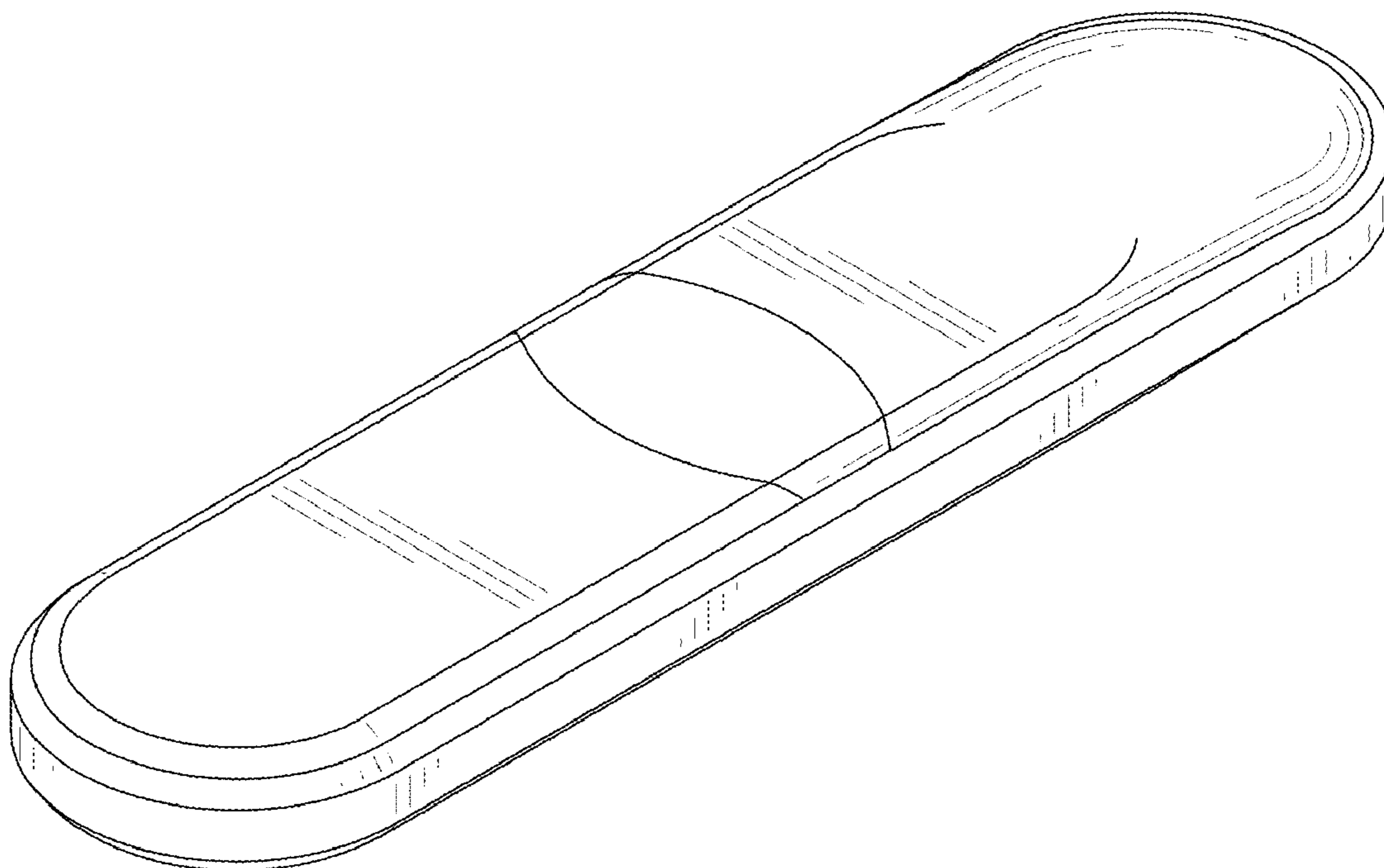
DESCRIPTION

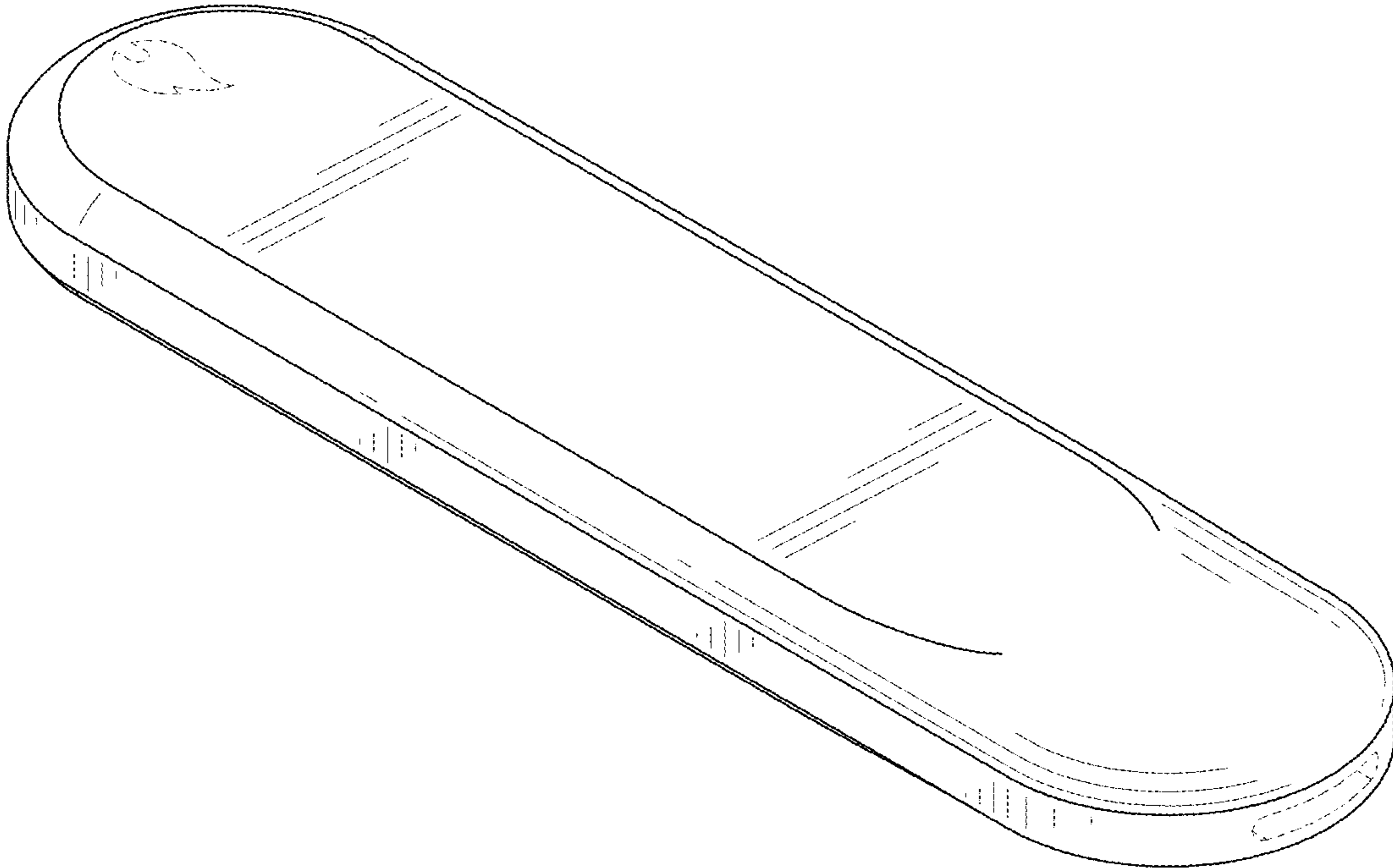

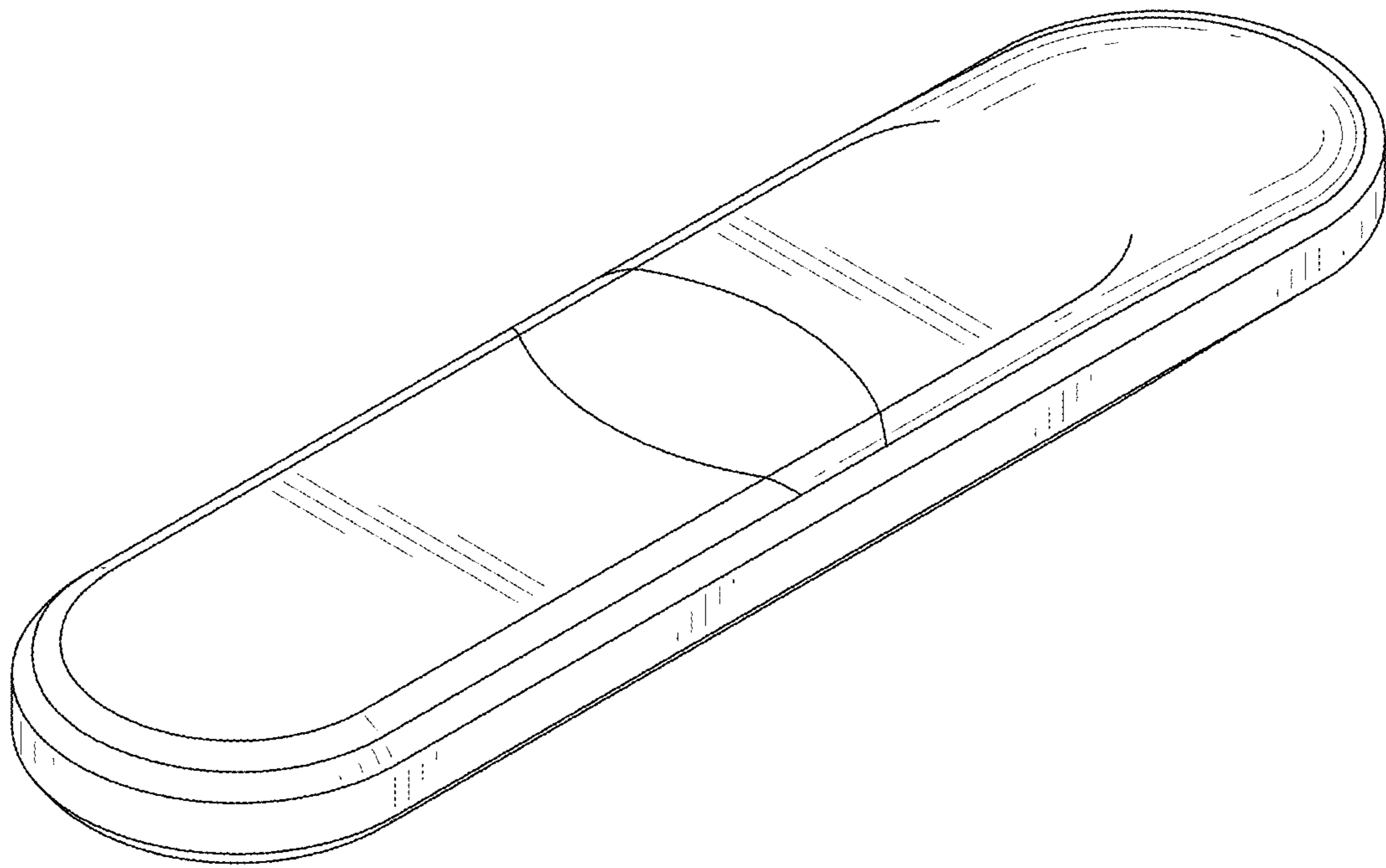

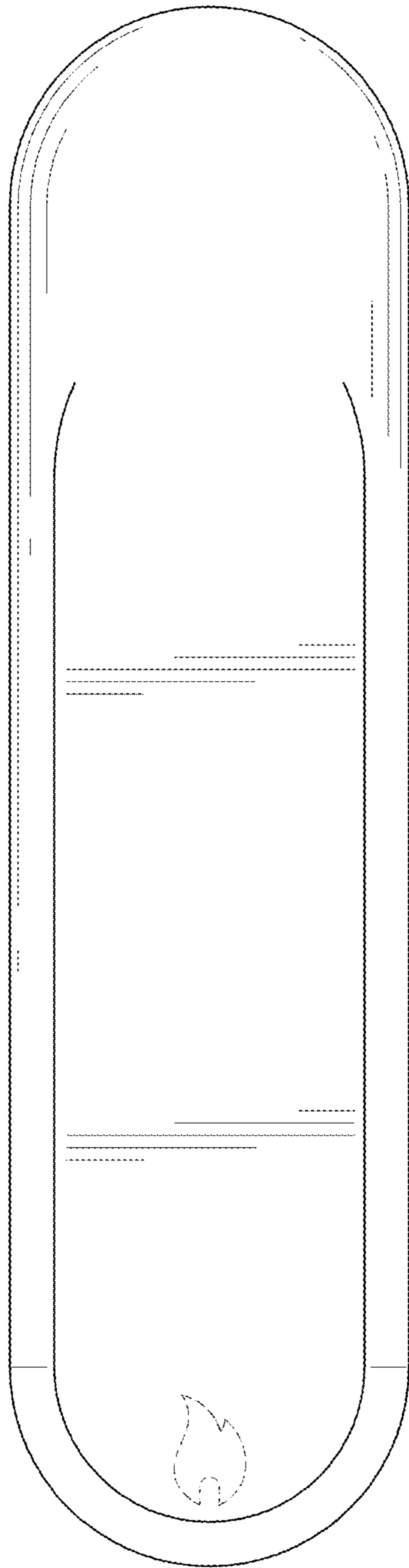

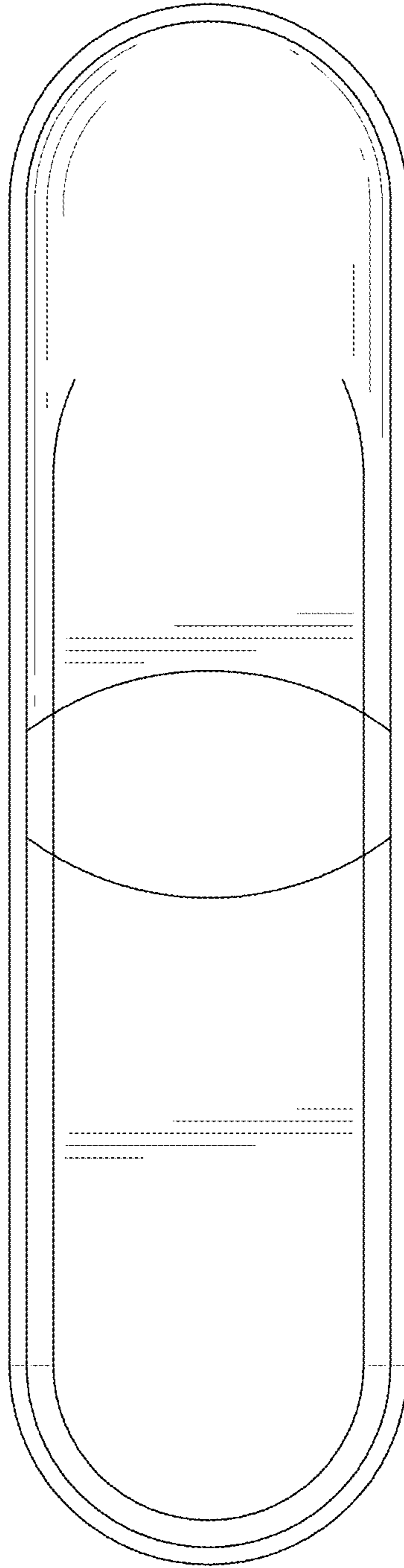

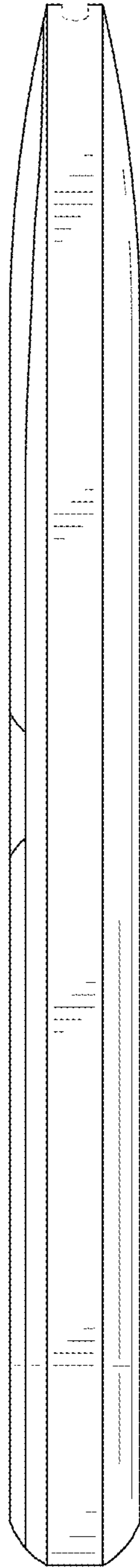

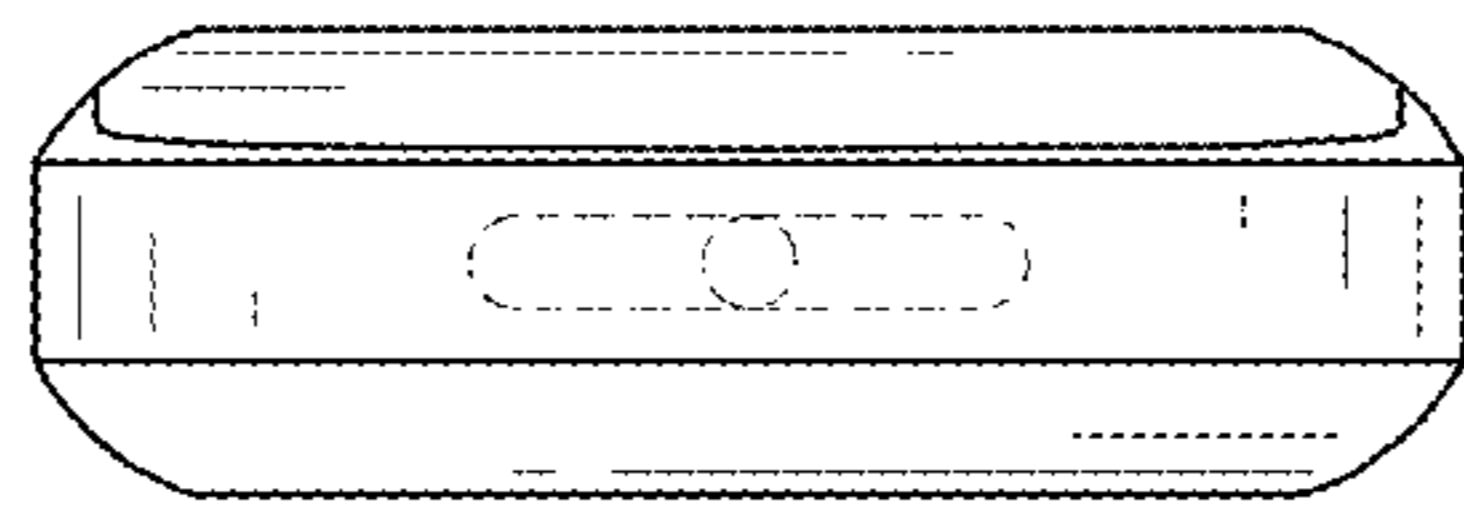

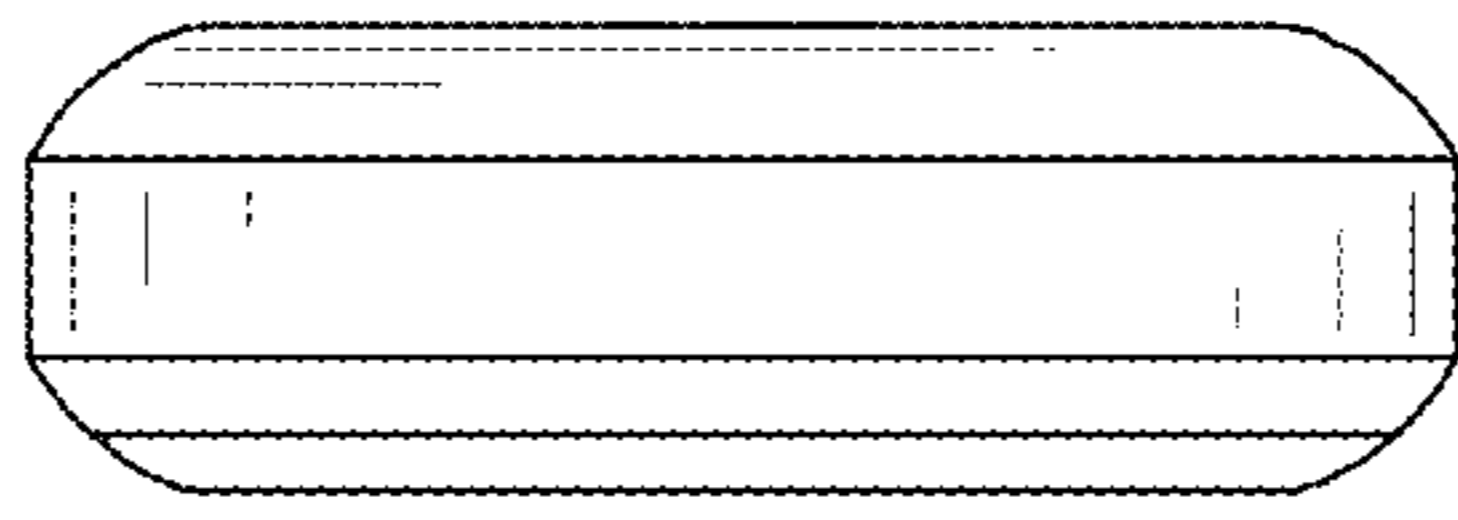
