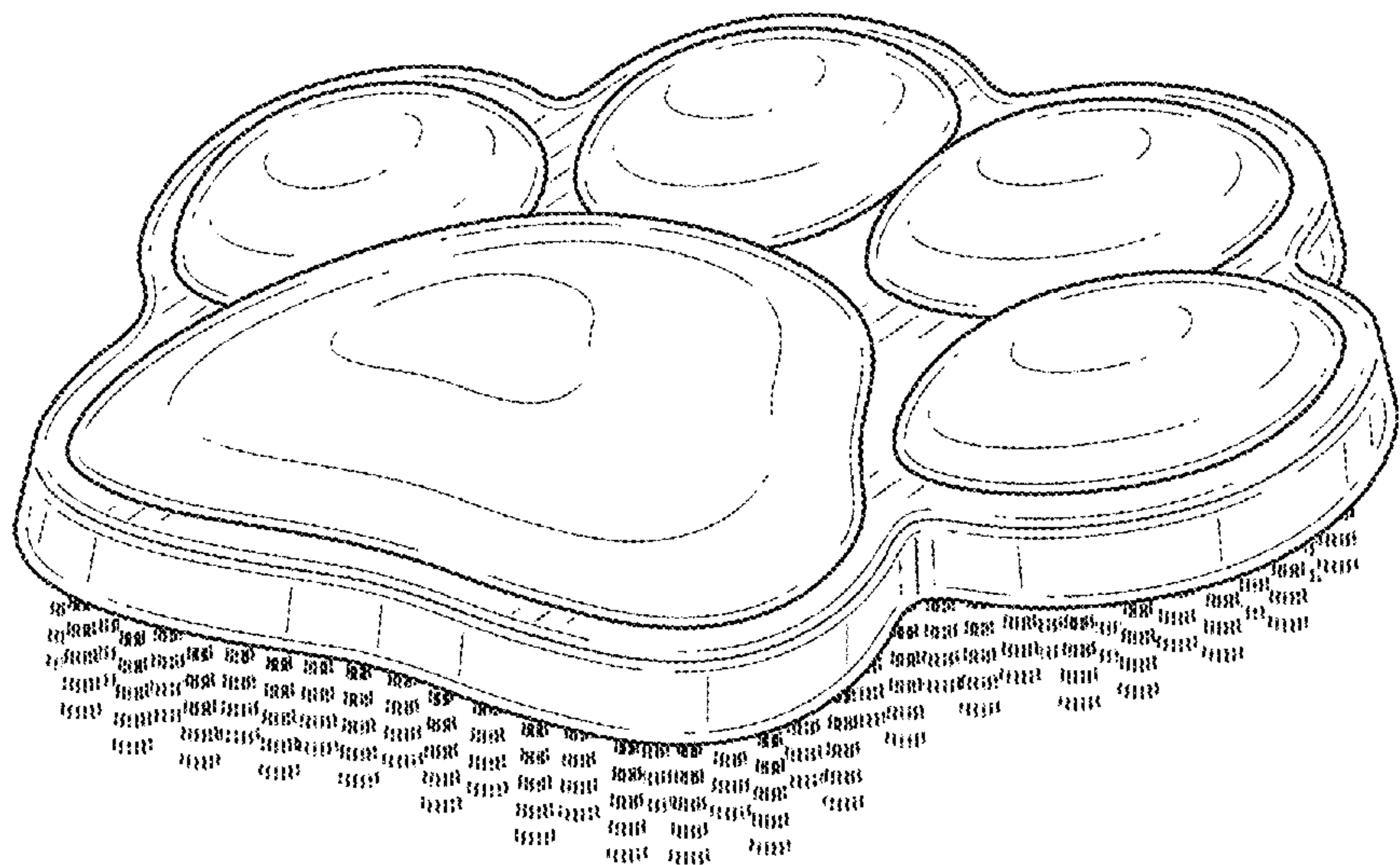
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front perspective view of-a paw-shaped brush, showing my new design;

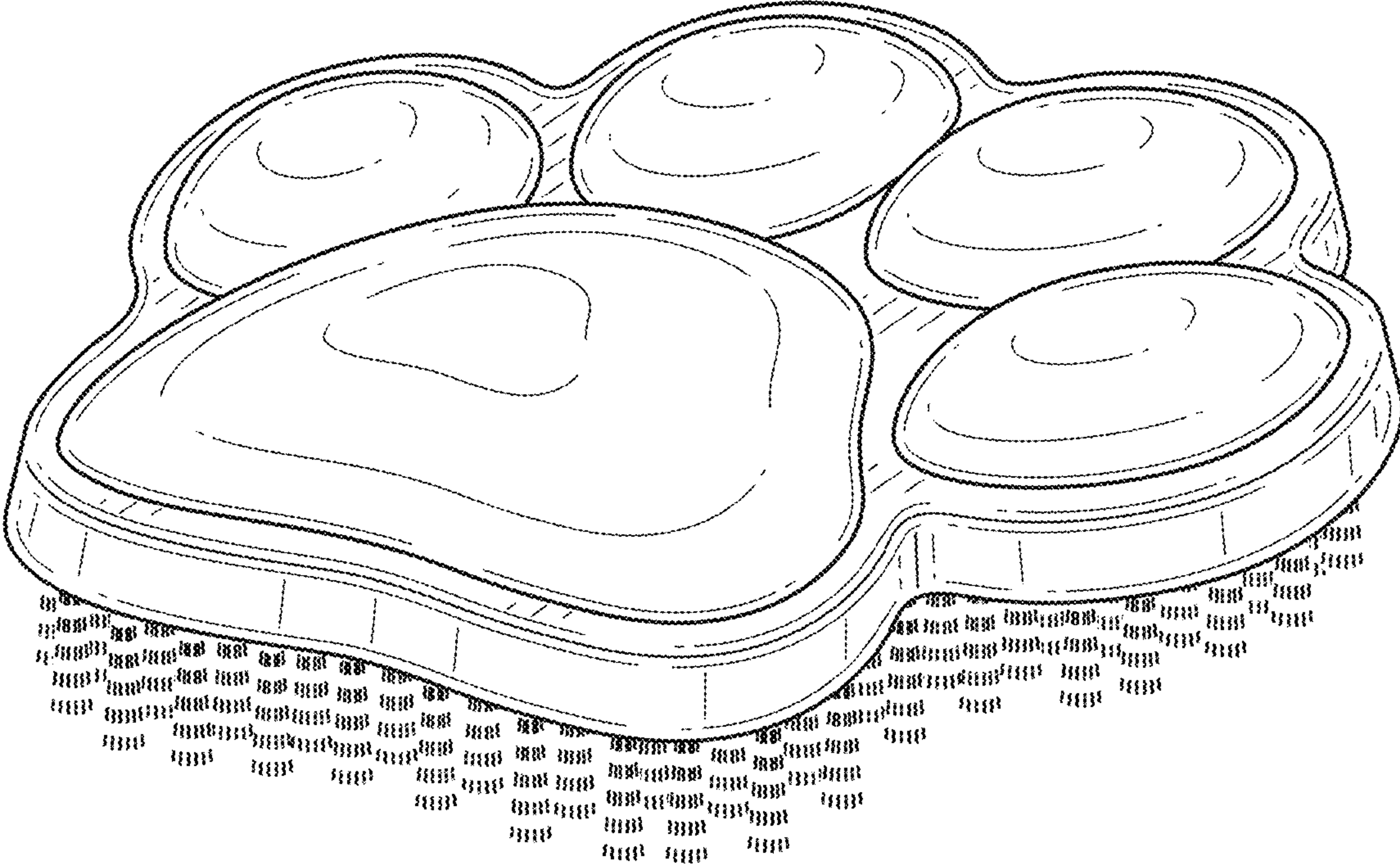

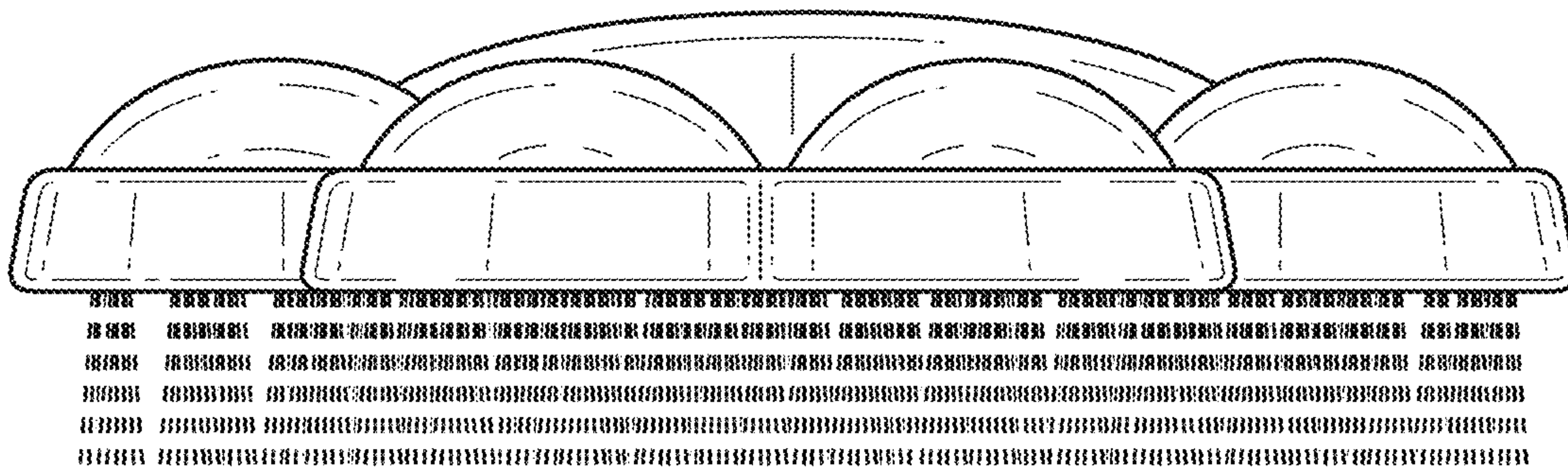

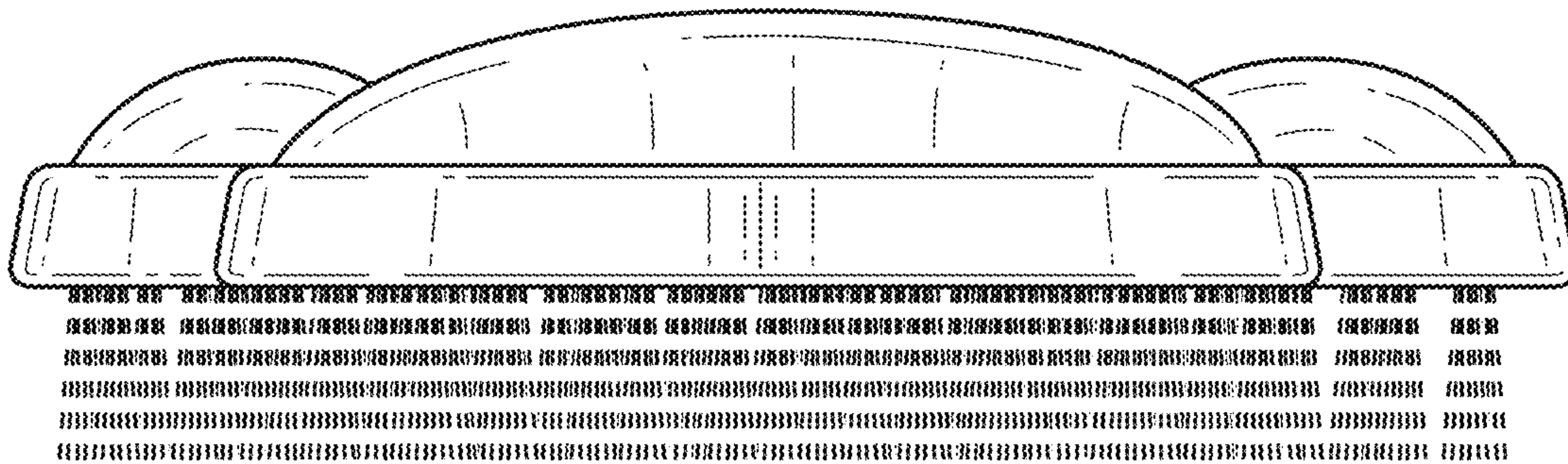




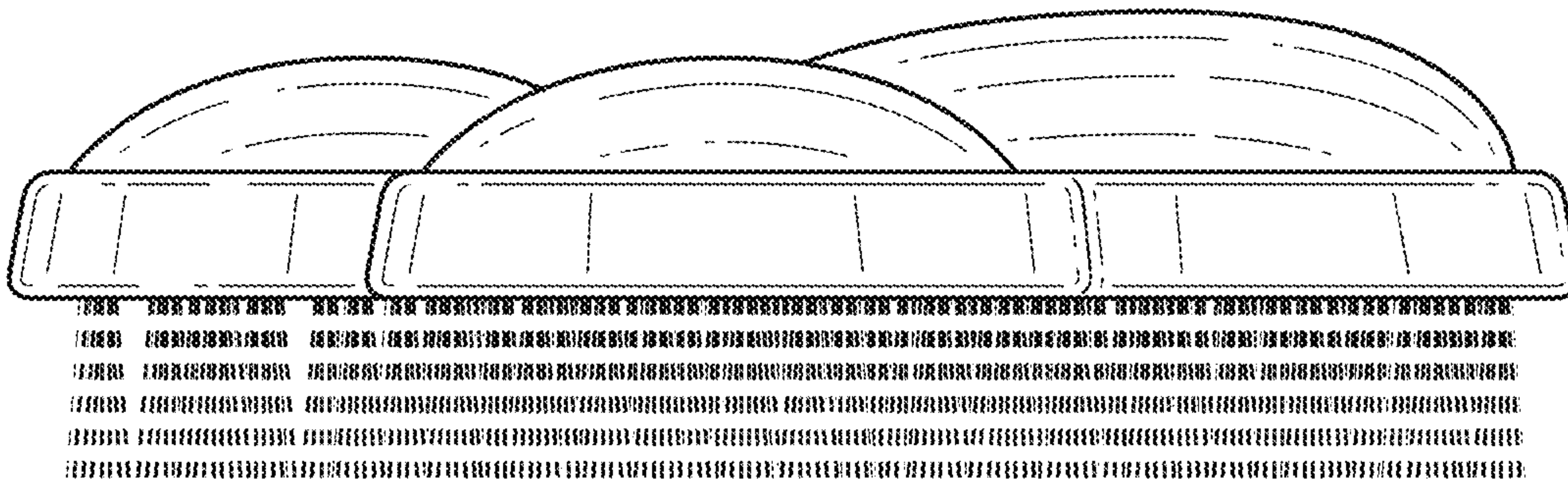

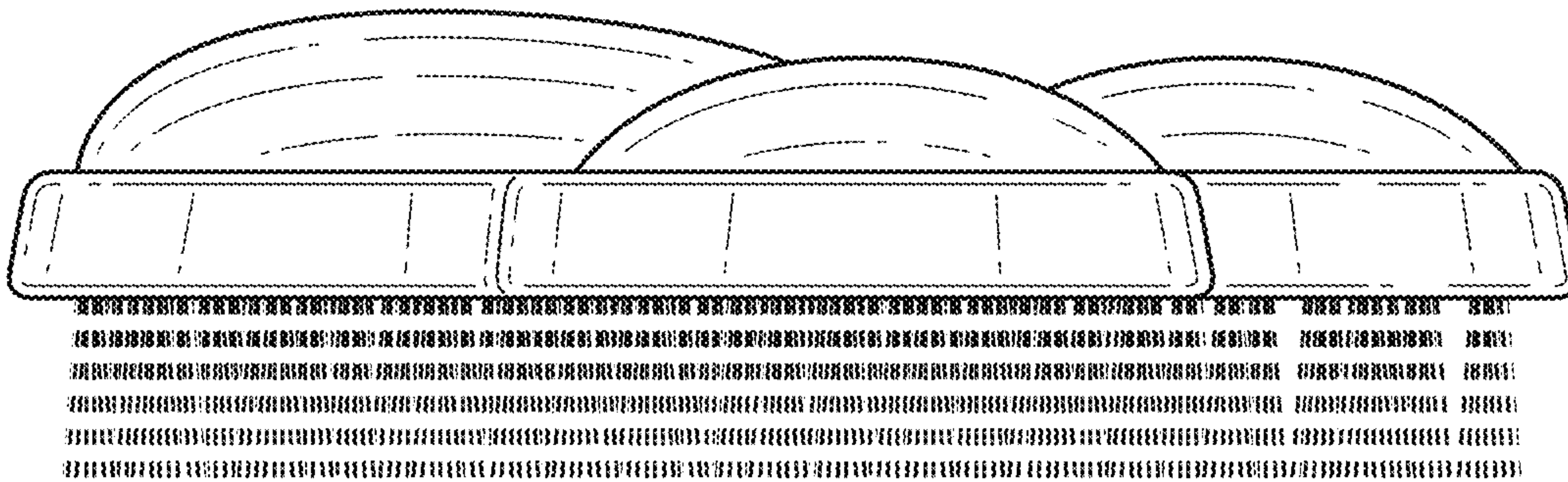

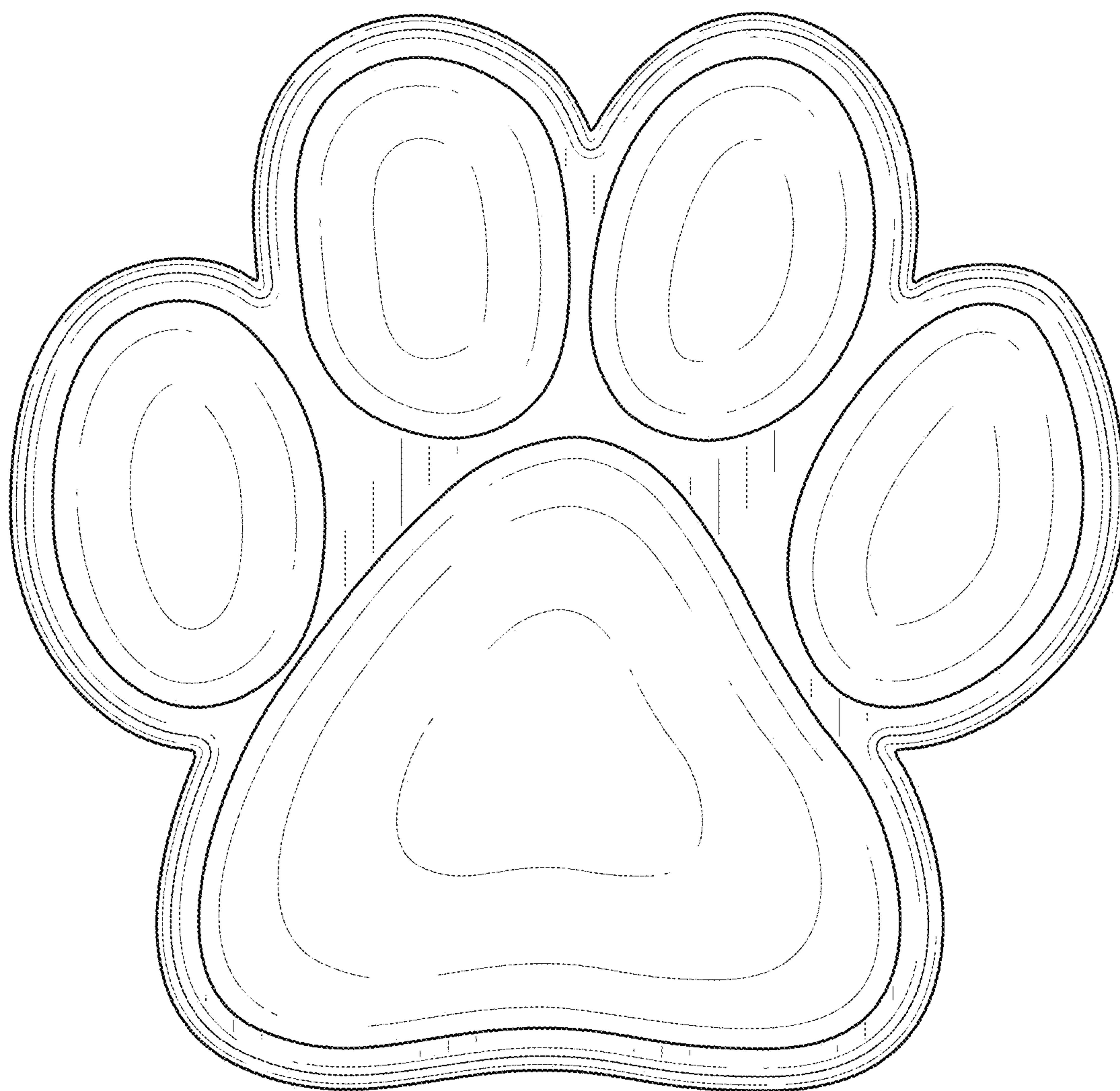

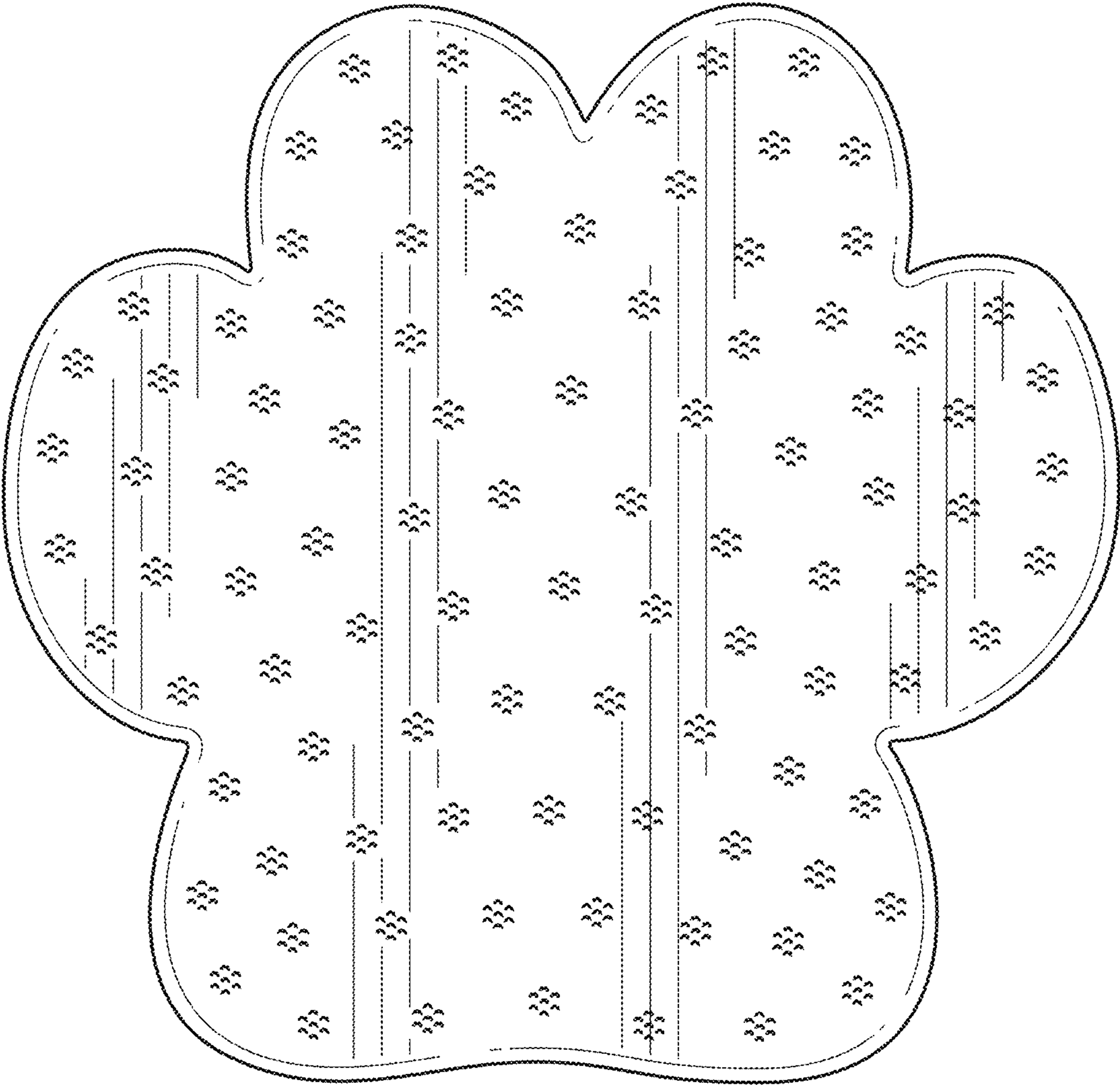
