FIG. 1 is a front view of a swimsuit on a model showing the new design according to the present invention.

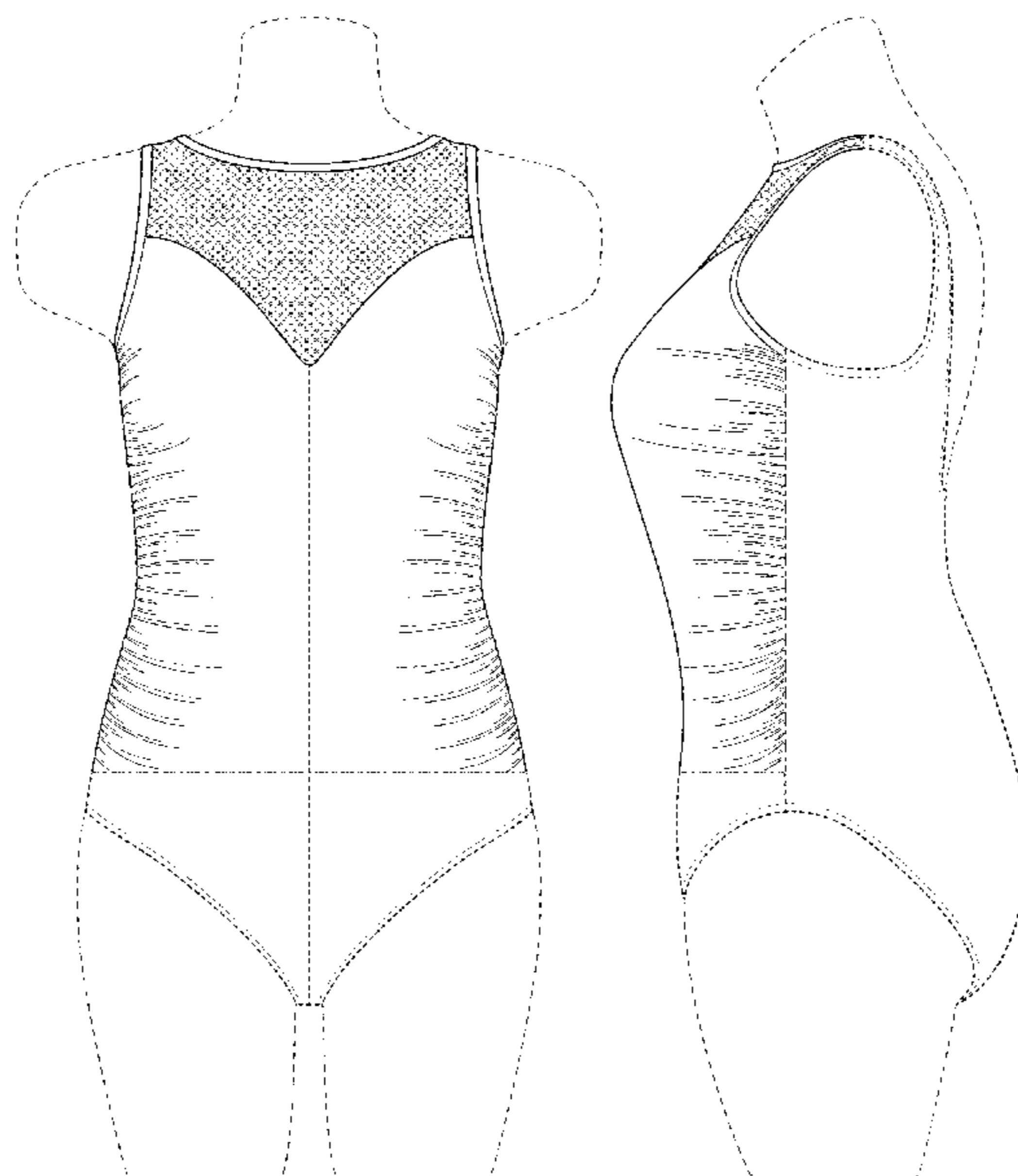
FIG. 2 is a rear view thereof.

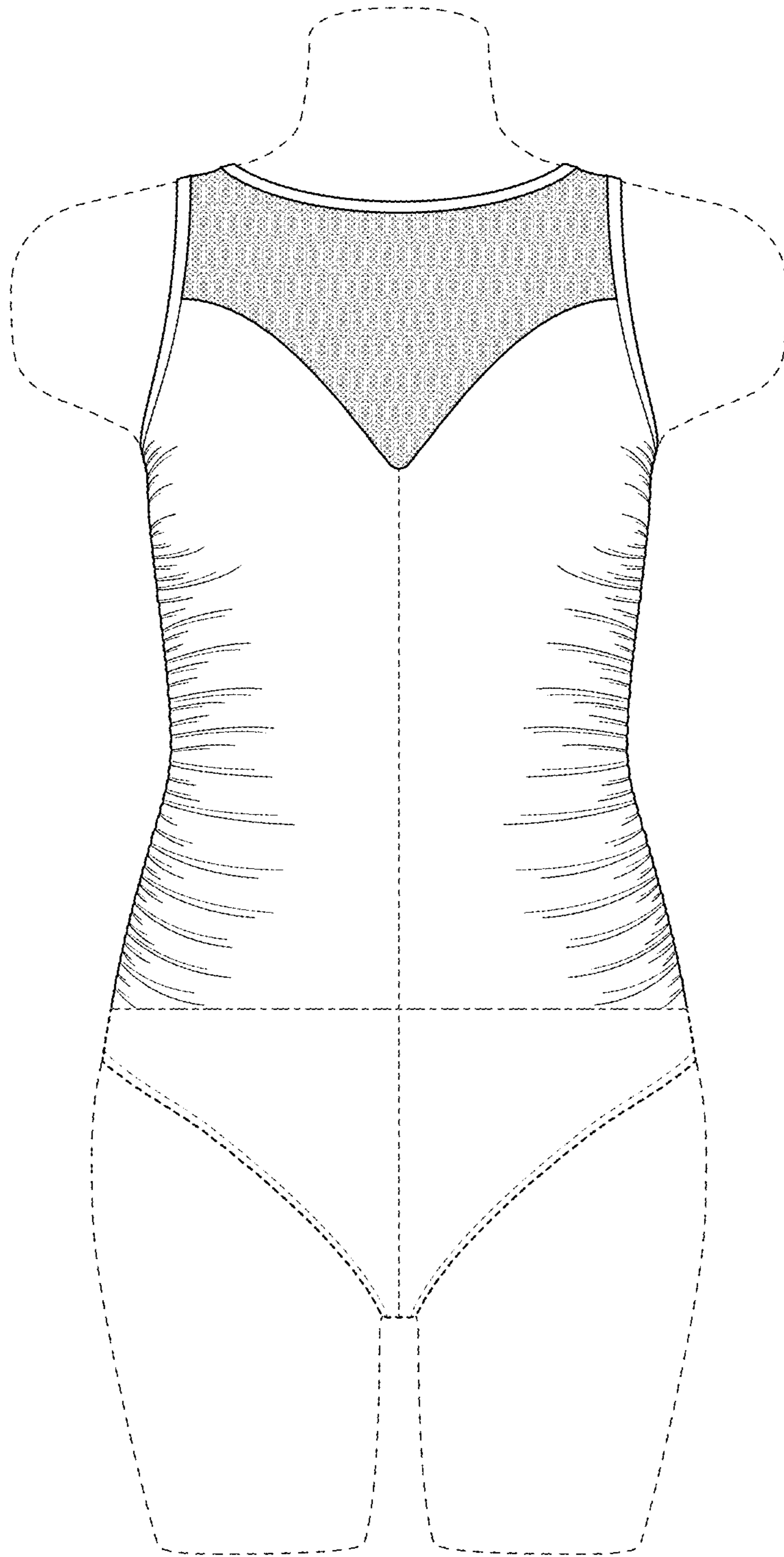

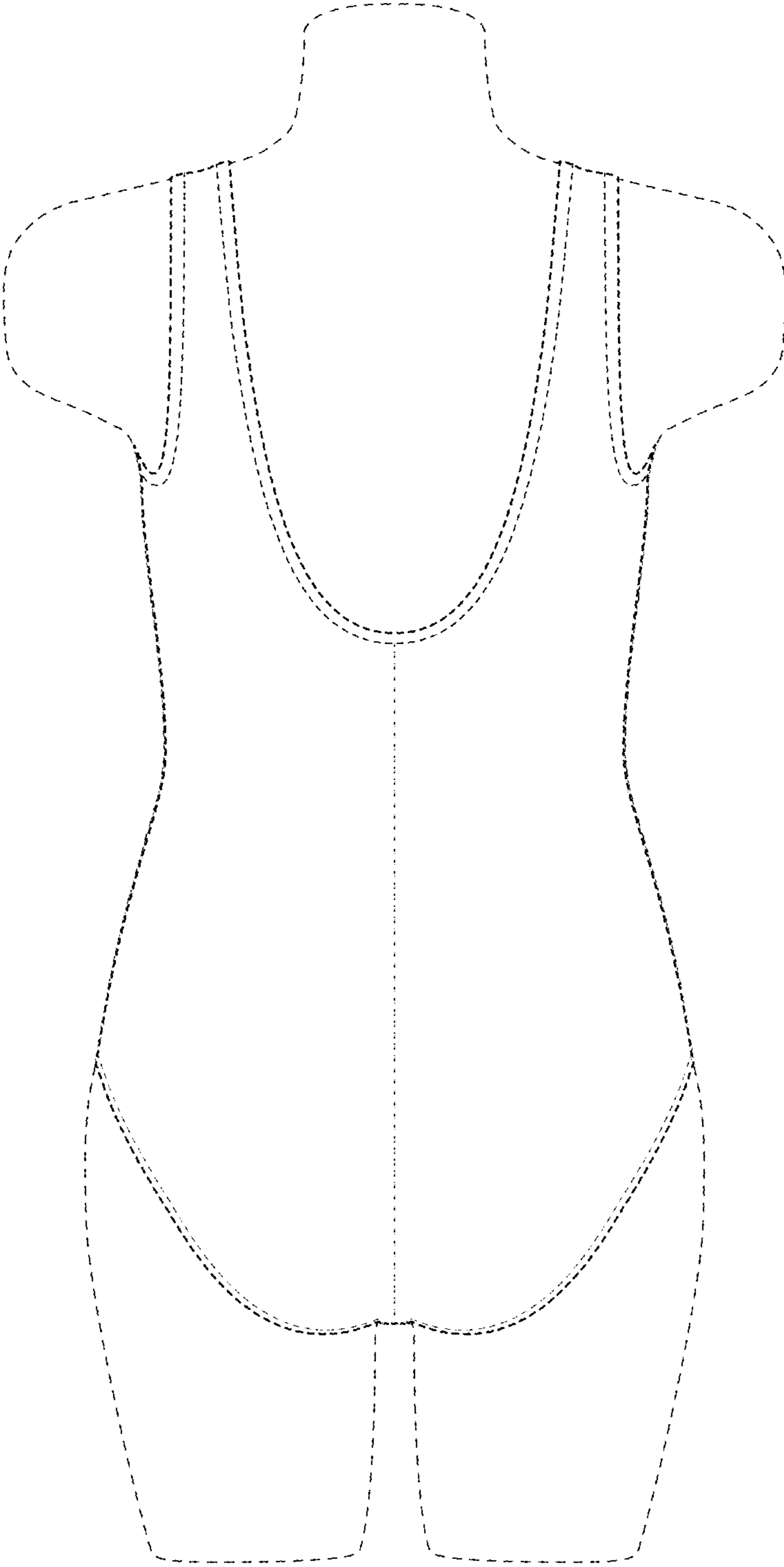

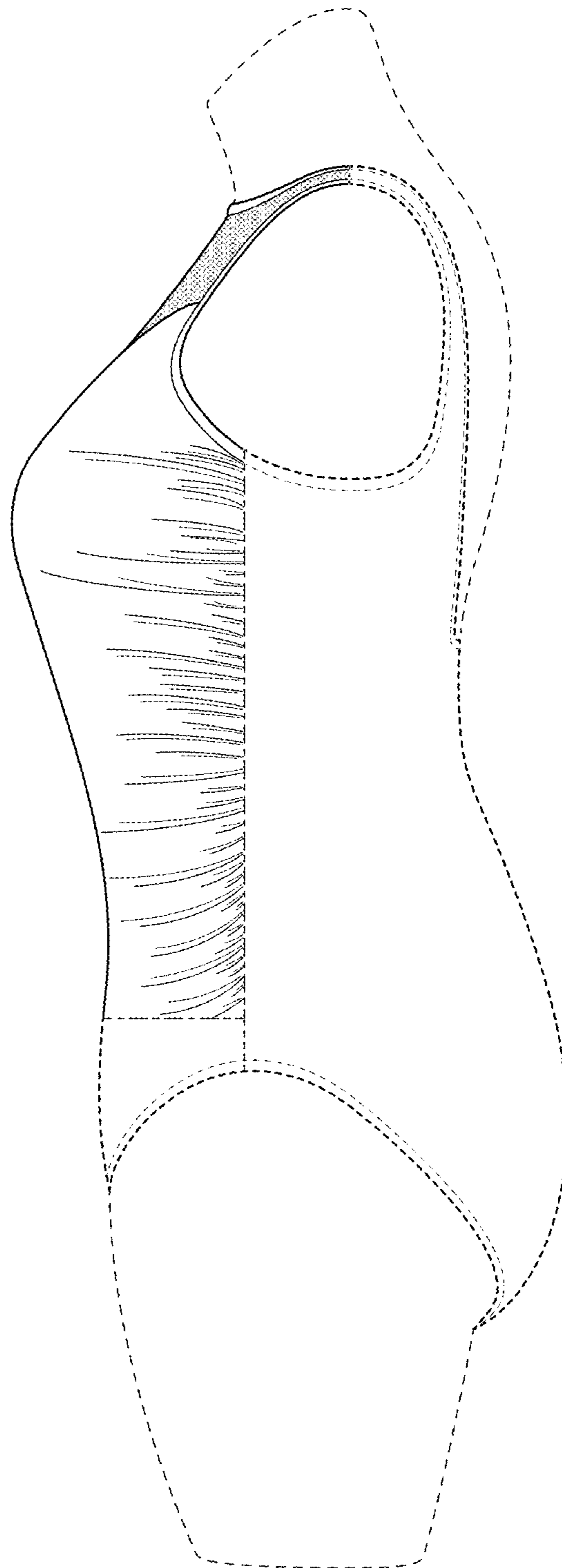

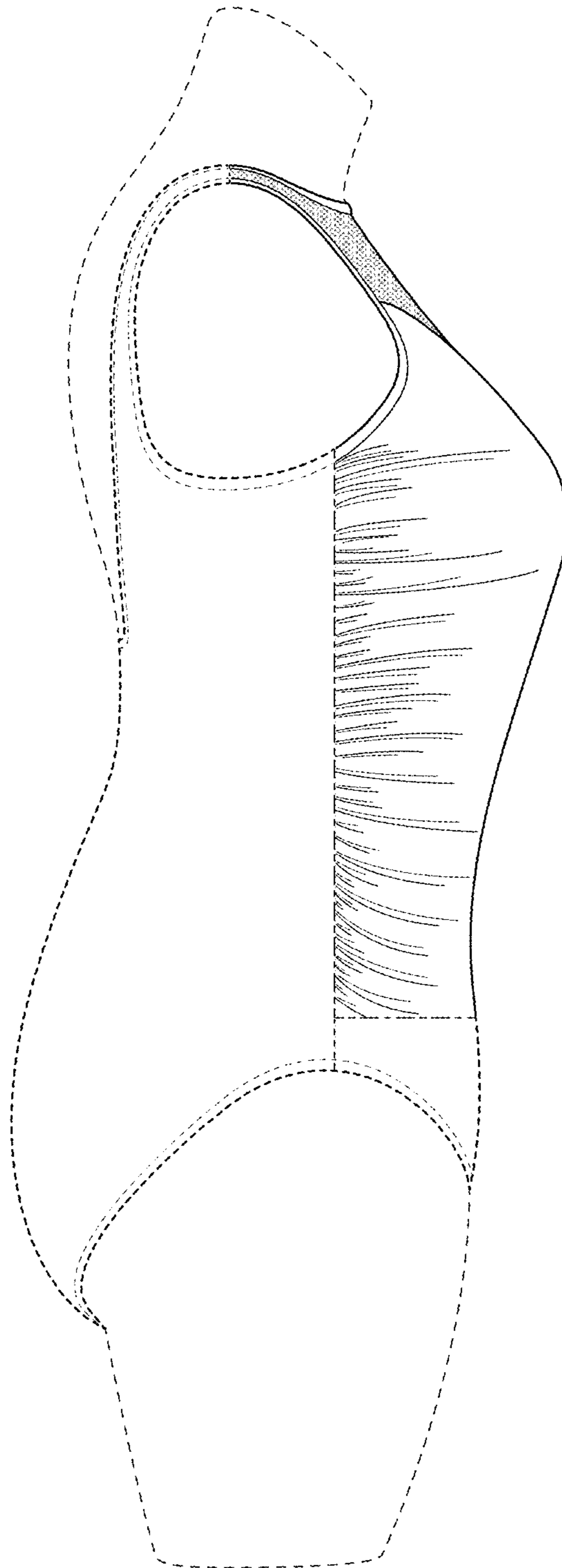
