**DESCRIPTION**

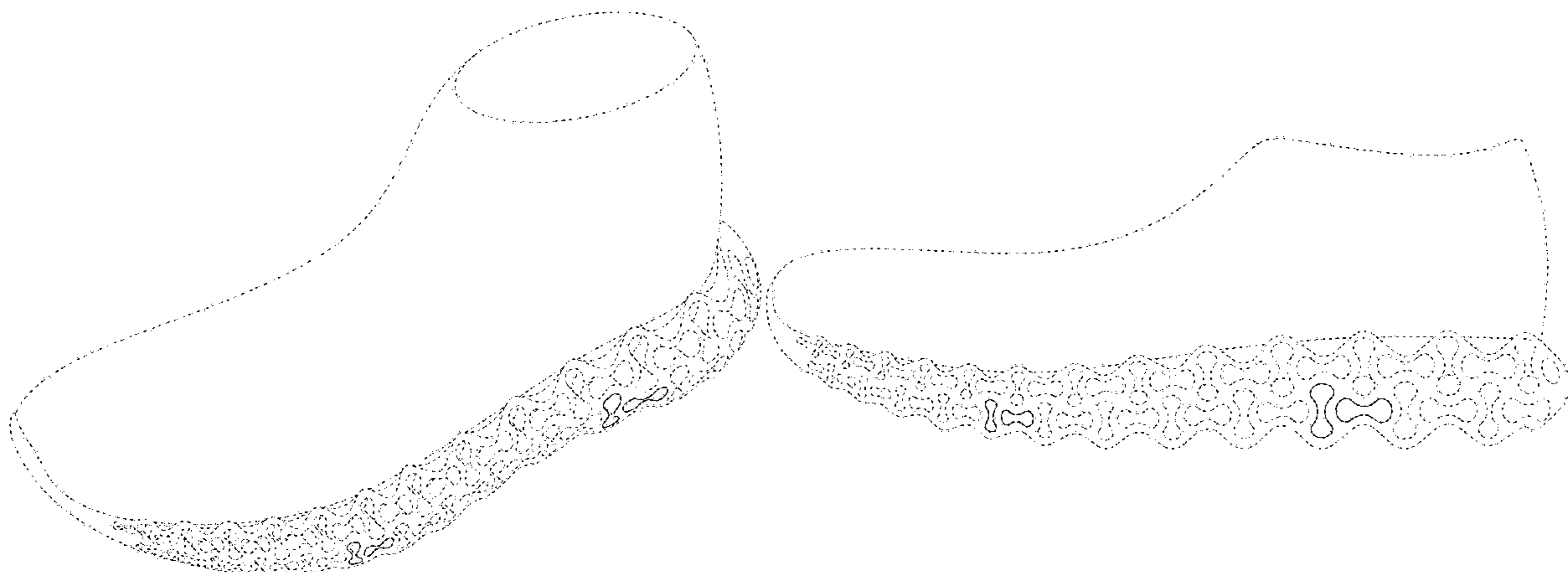
FIG. 1 is a top, left, and front perspective view of an ornamental design for a shoe;

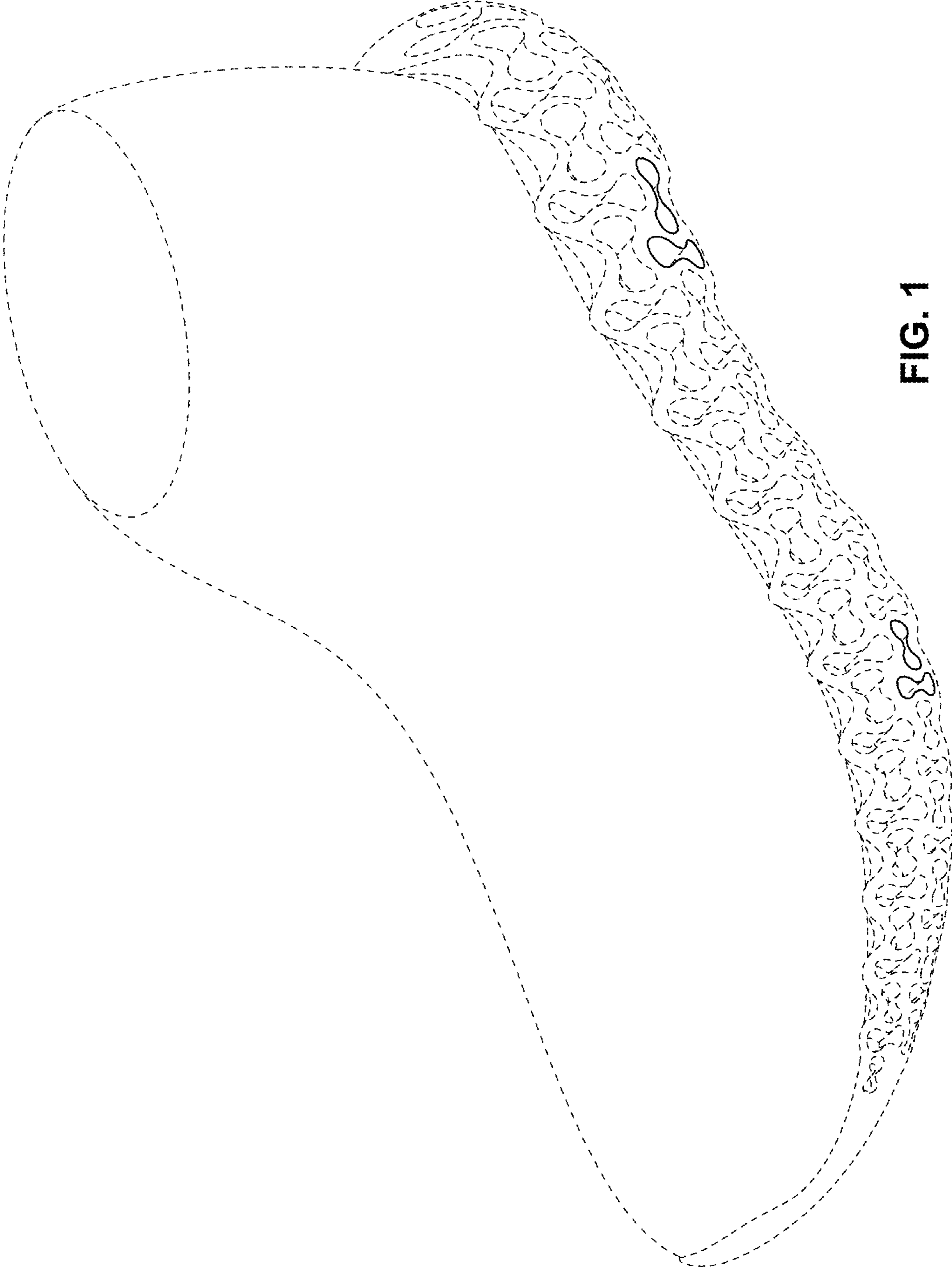

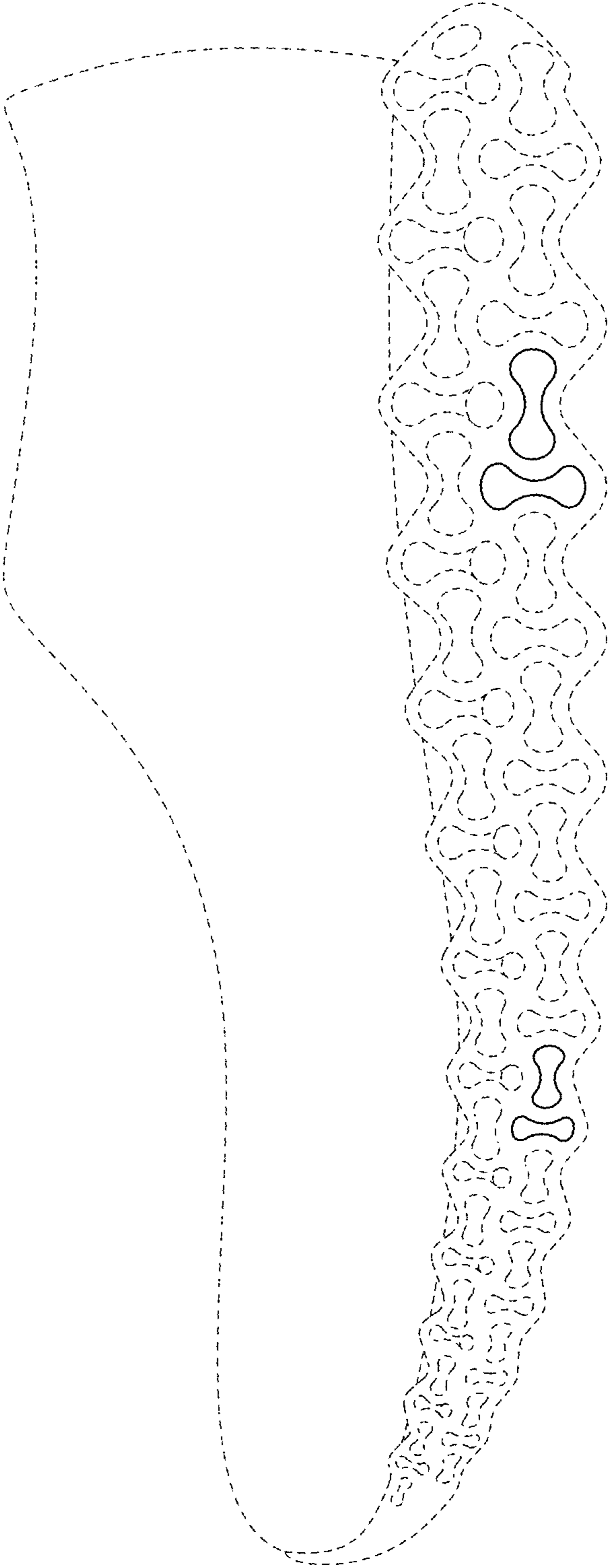

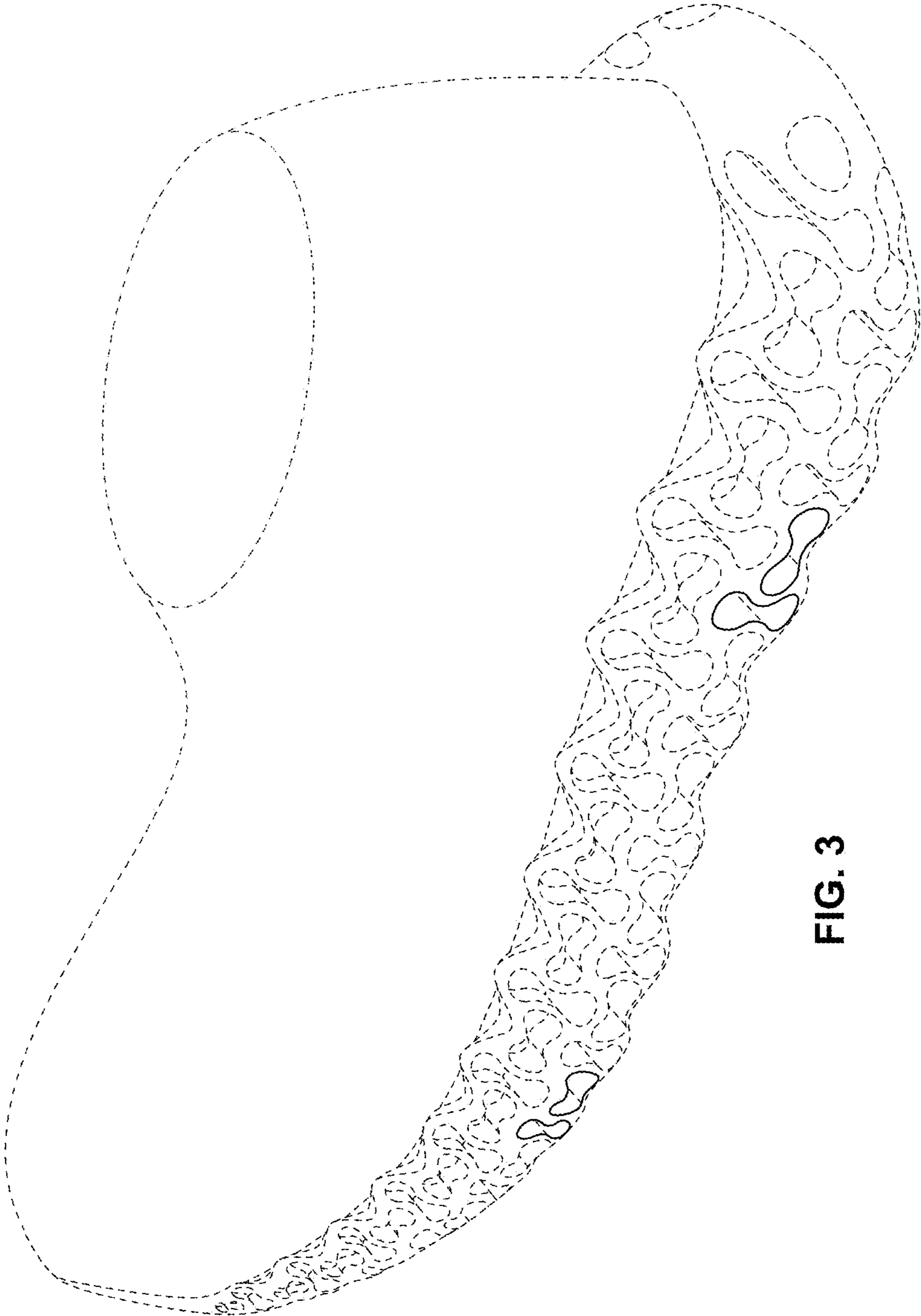
