(57) **CLAIM**

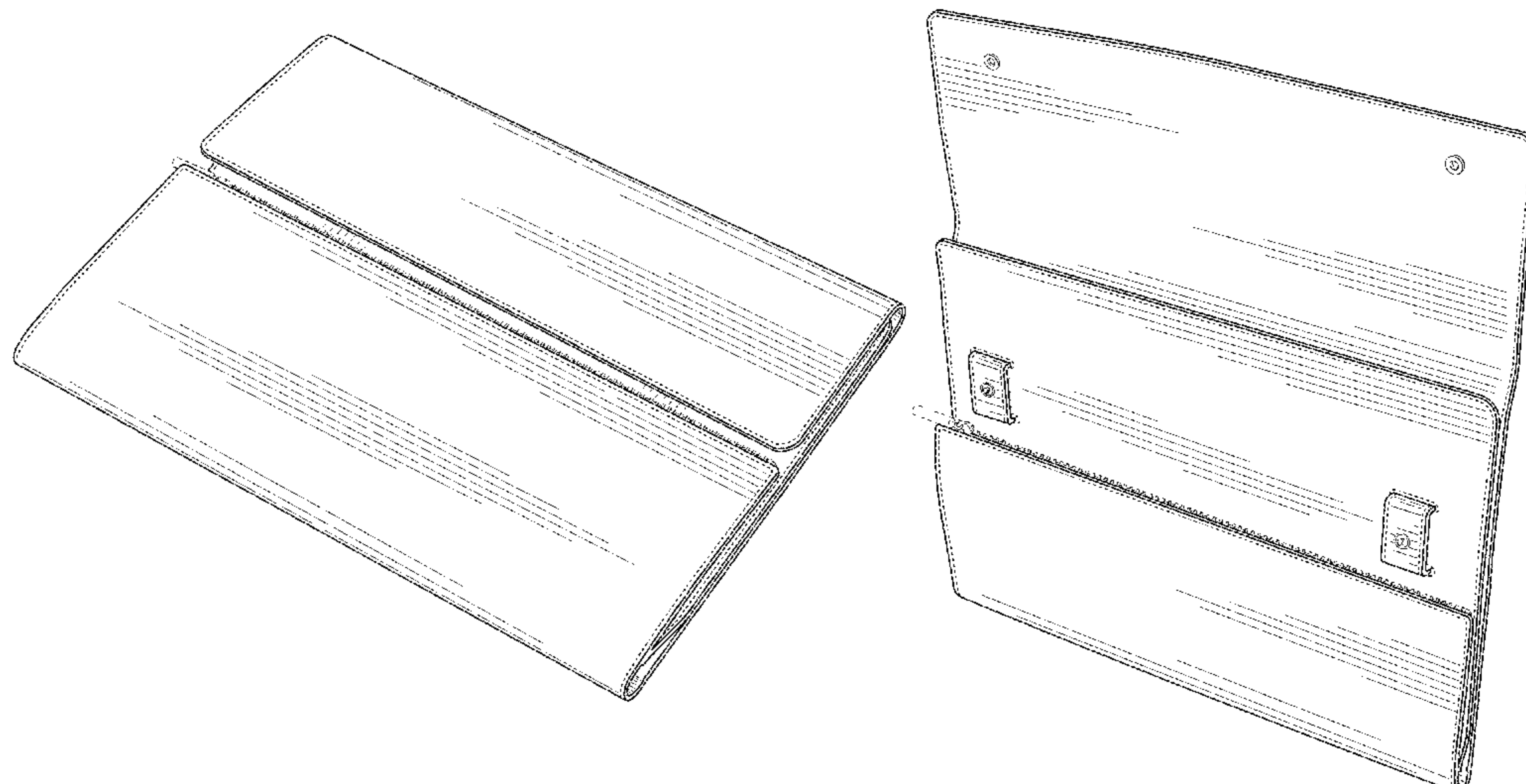
The ornamental design for a carryall, as shown and described.

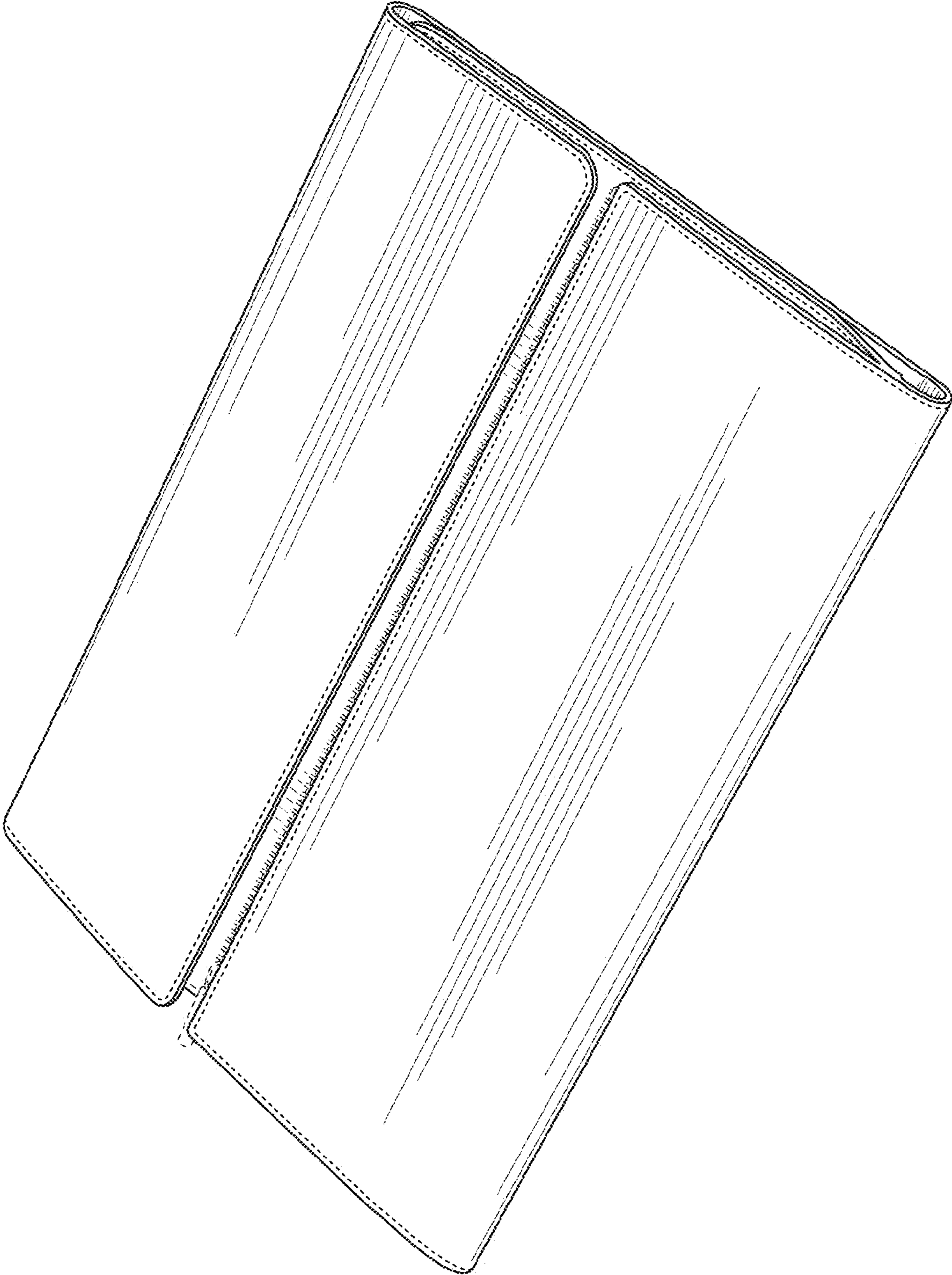

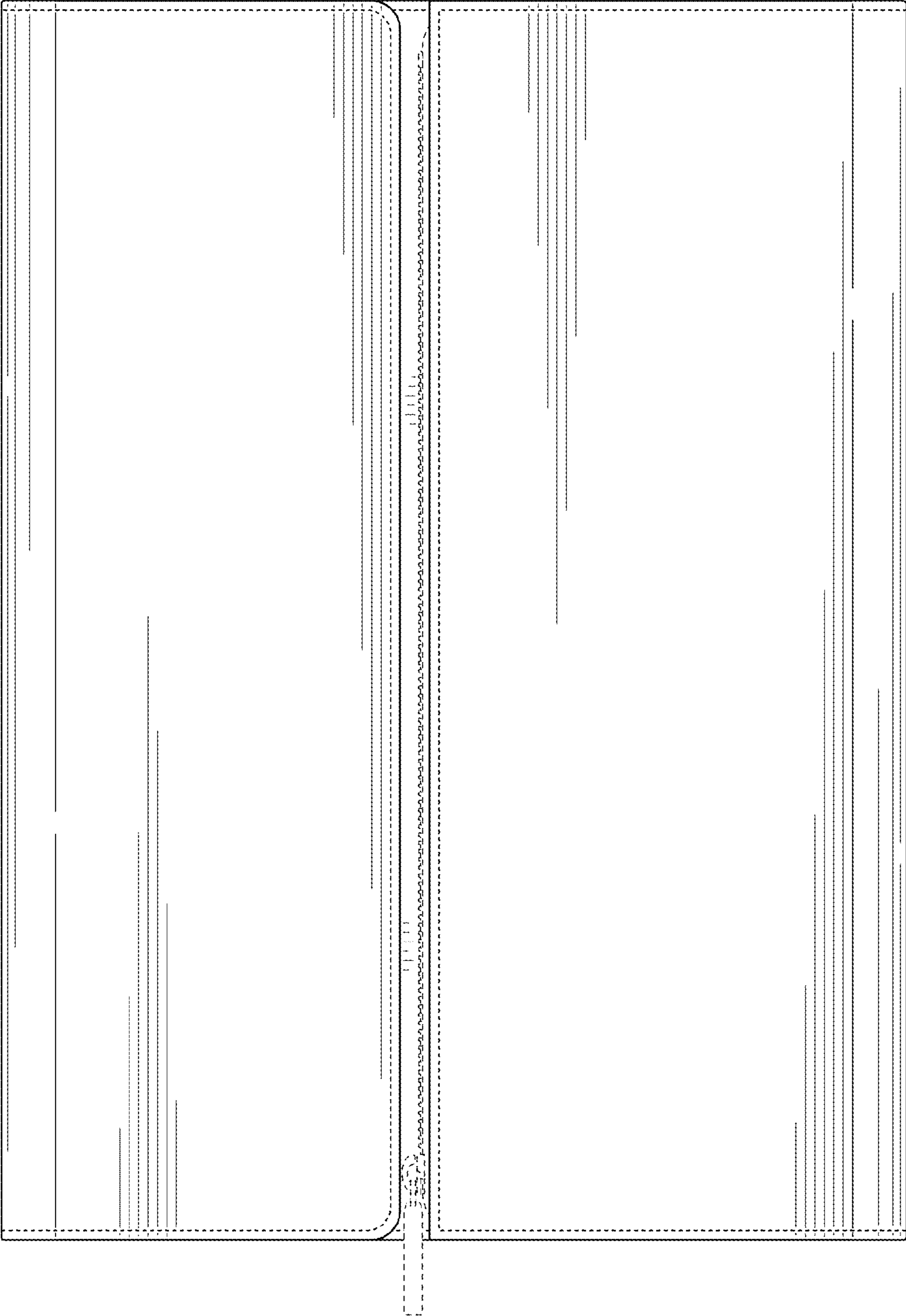

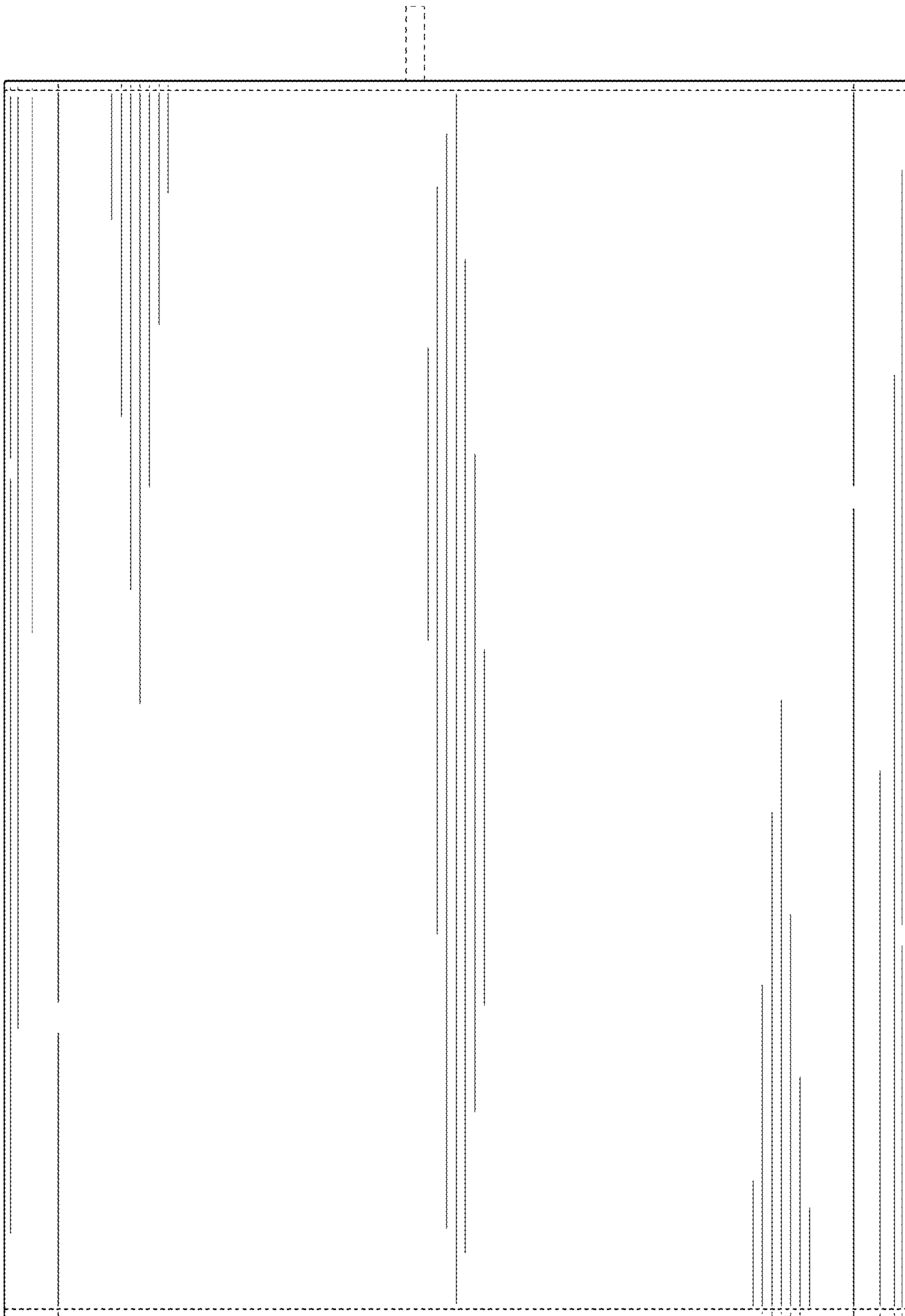

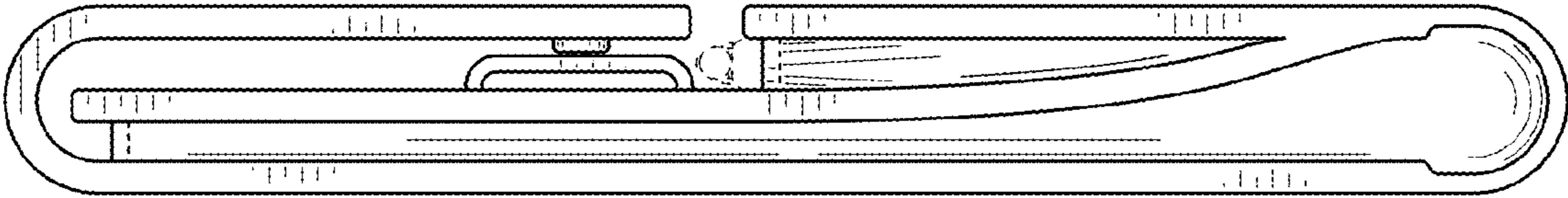

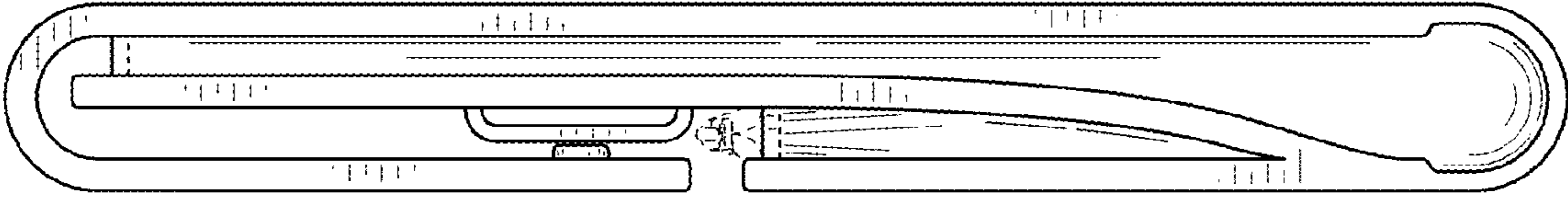

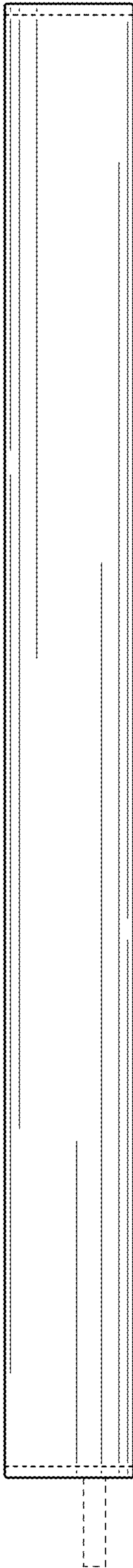

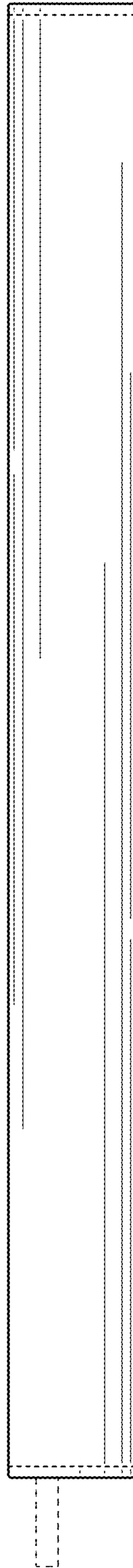

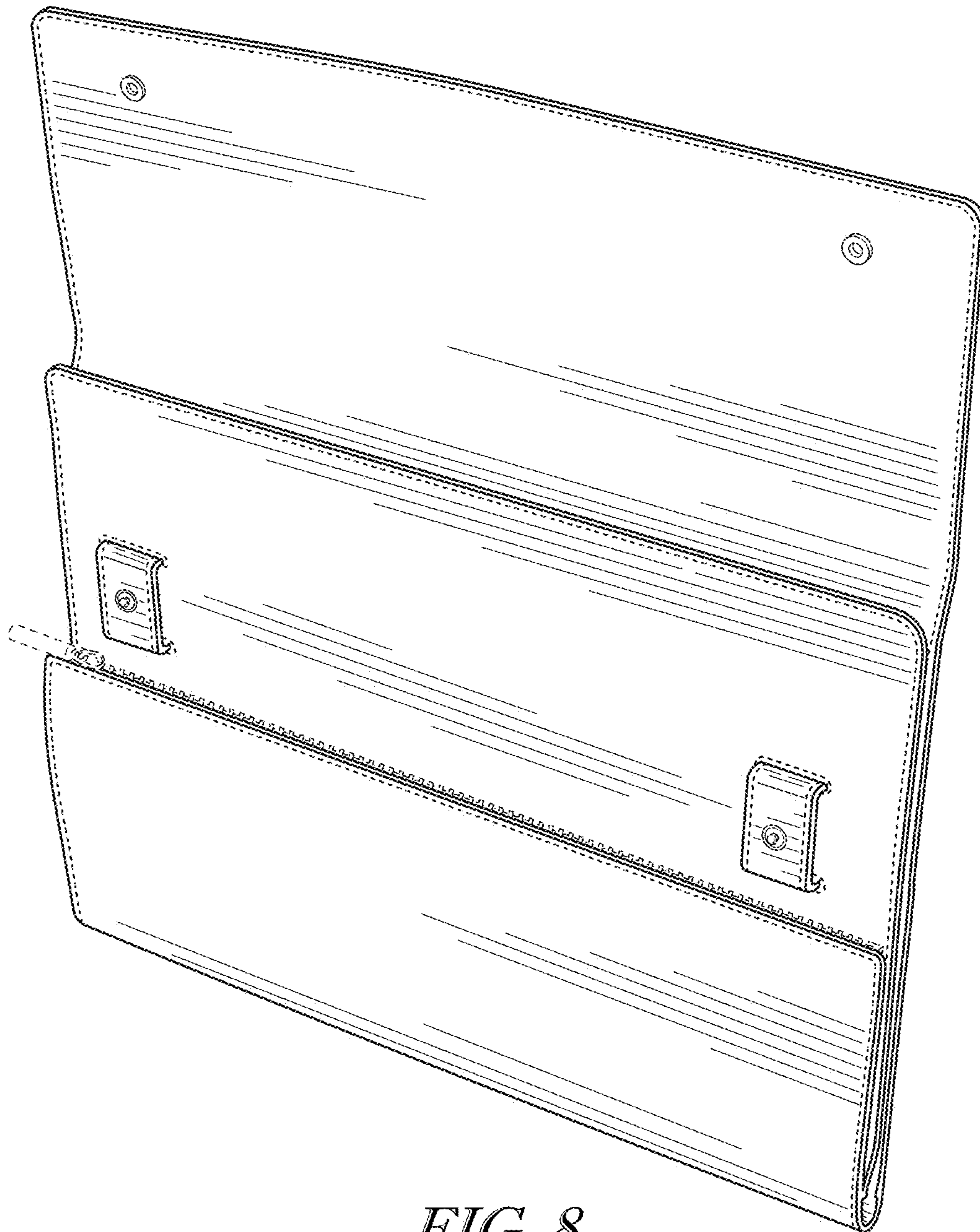

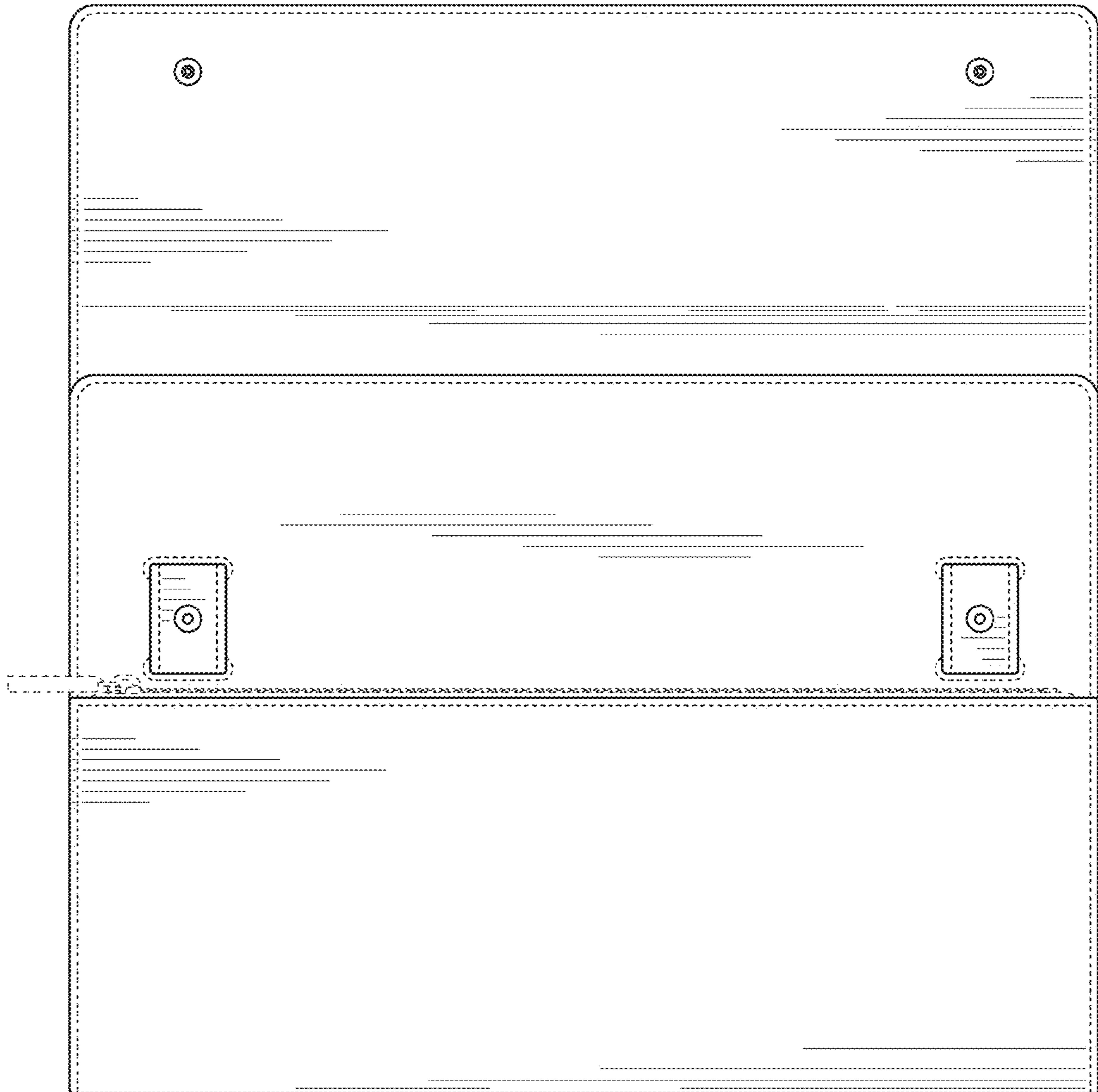

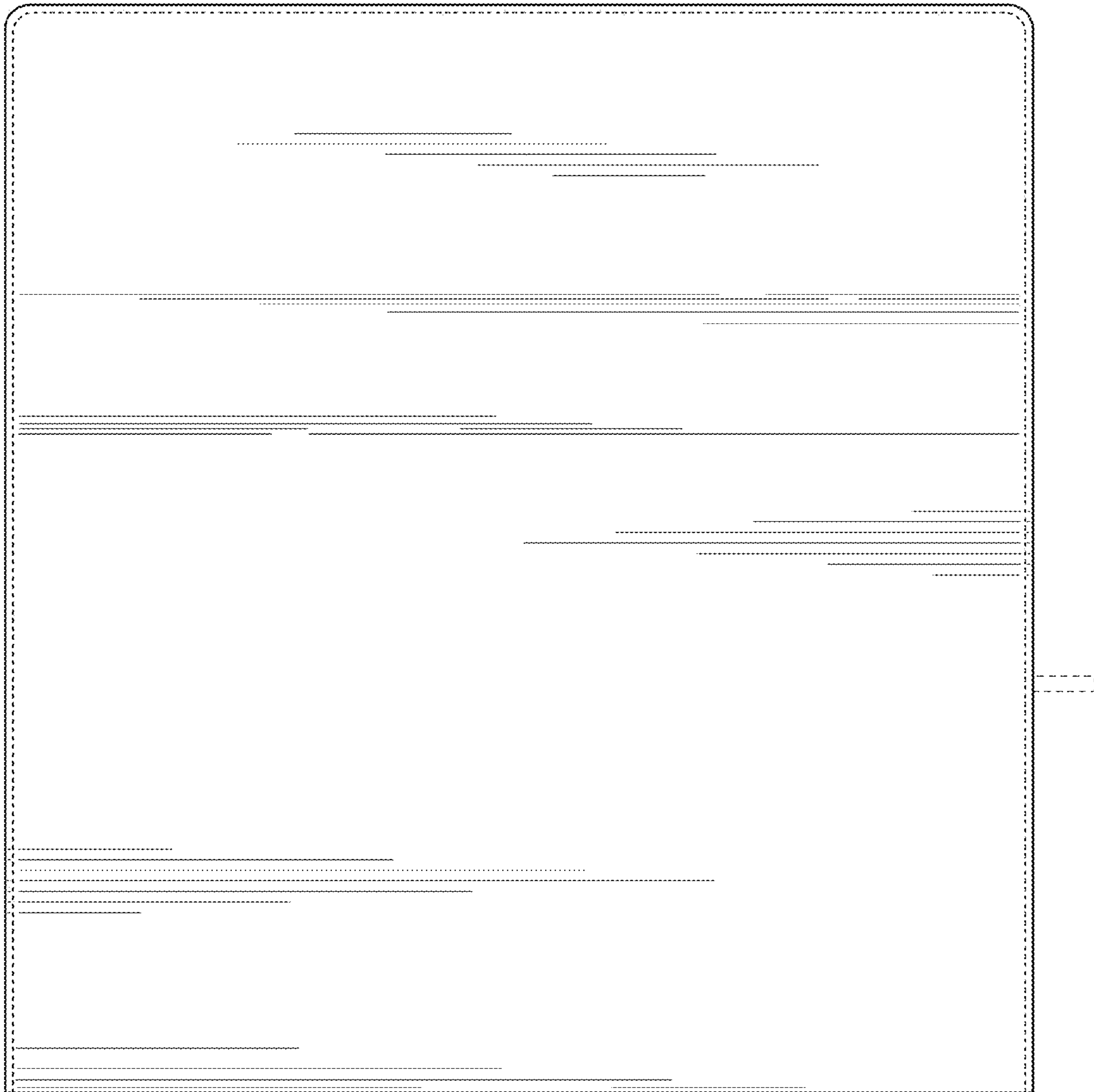

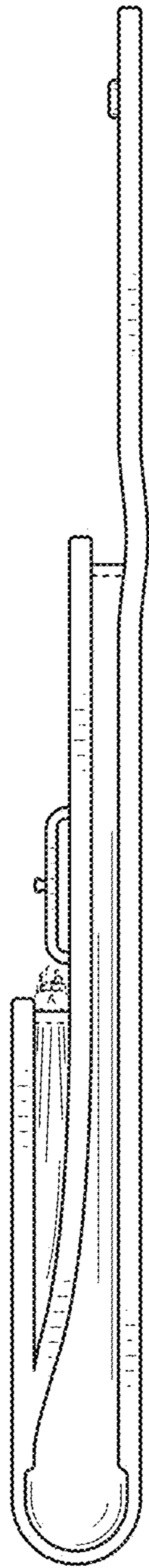

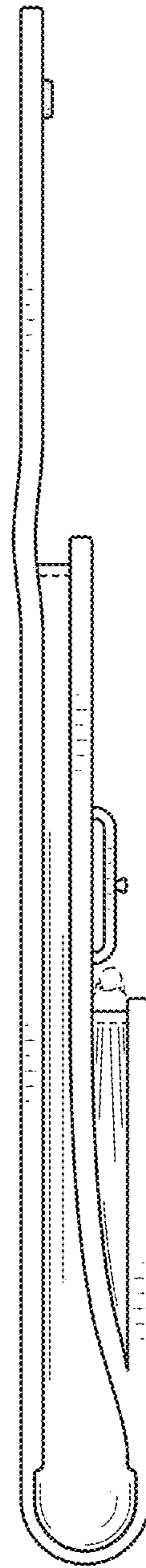

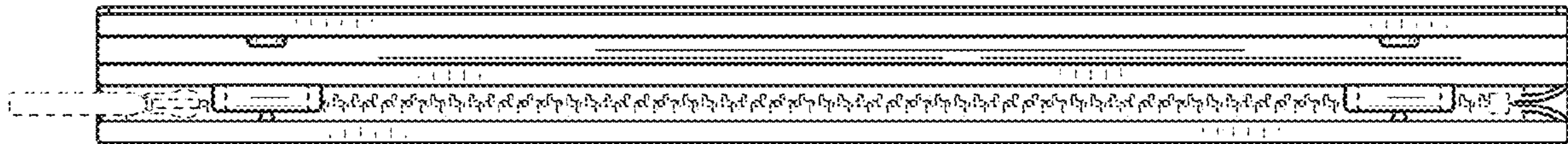

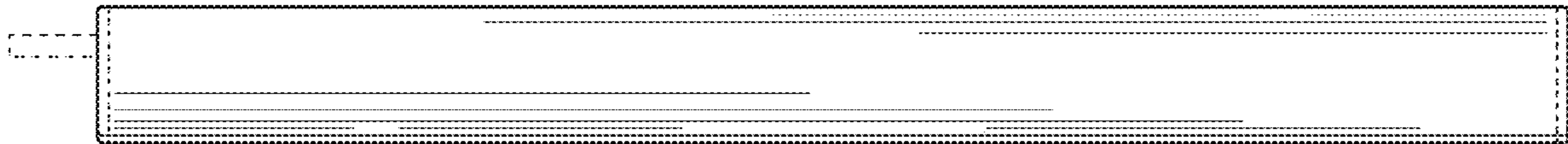
