DESCRIPTION

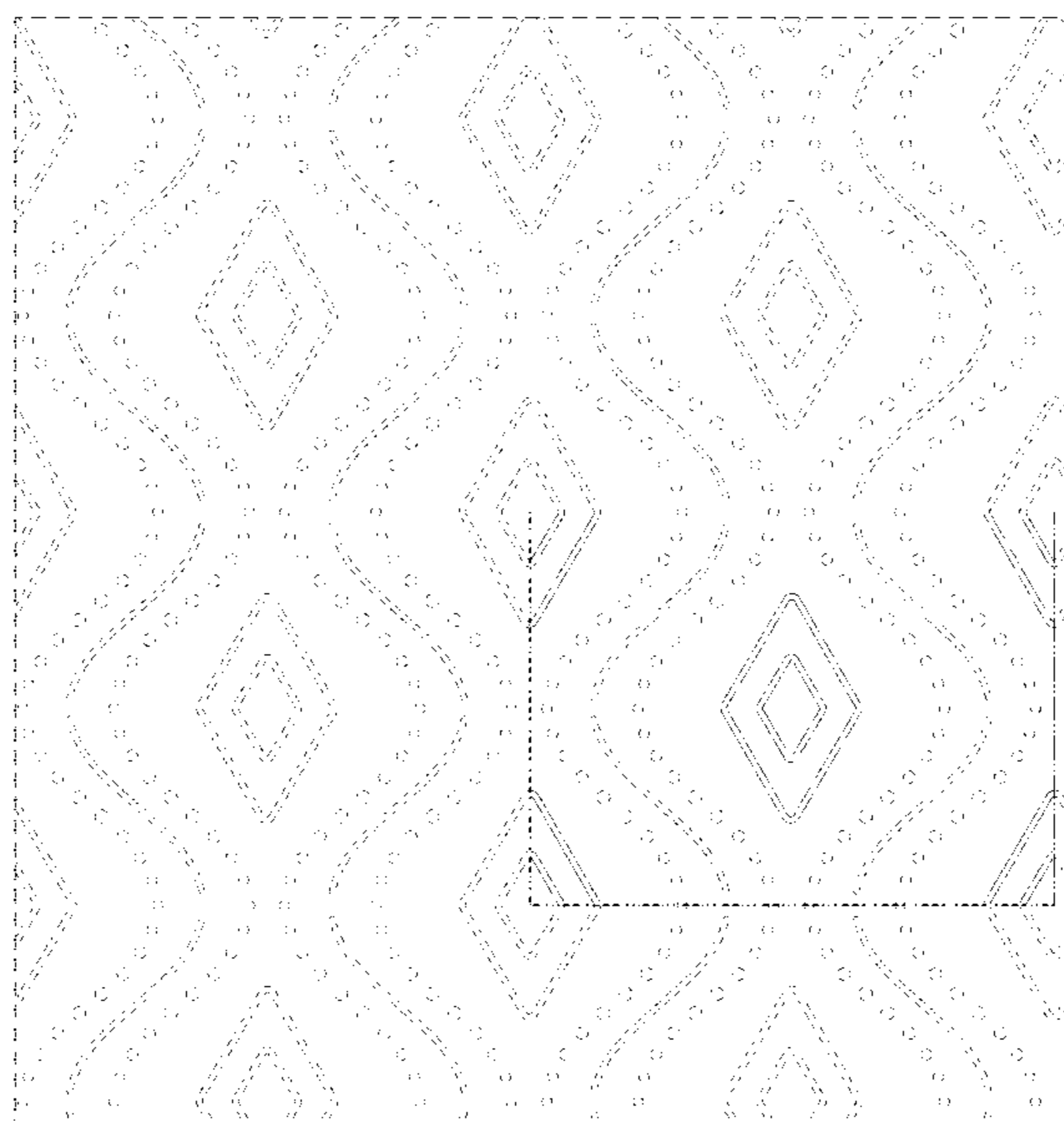
FIG. 1 is a perspective view of a paper product showing my

The areas and broken lines outside of the boundaries of the
claim illustrate environmental material that forms no part of
the claimed design. The broken lines inside of the bound-
aries of the claim depict portions of the paper product that
form no part of the claimed design.

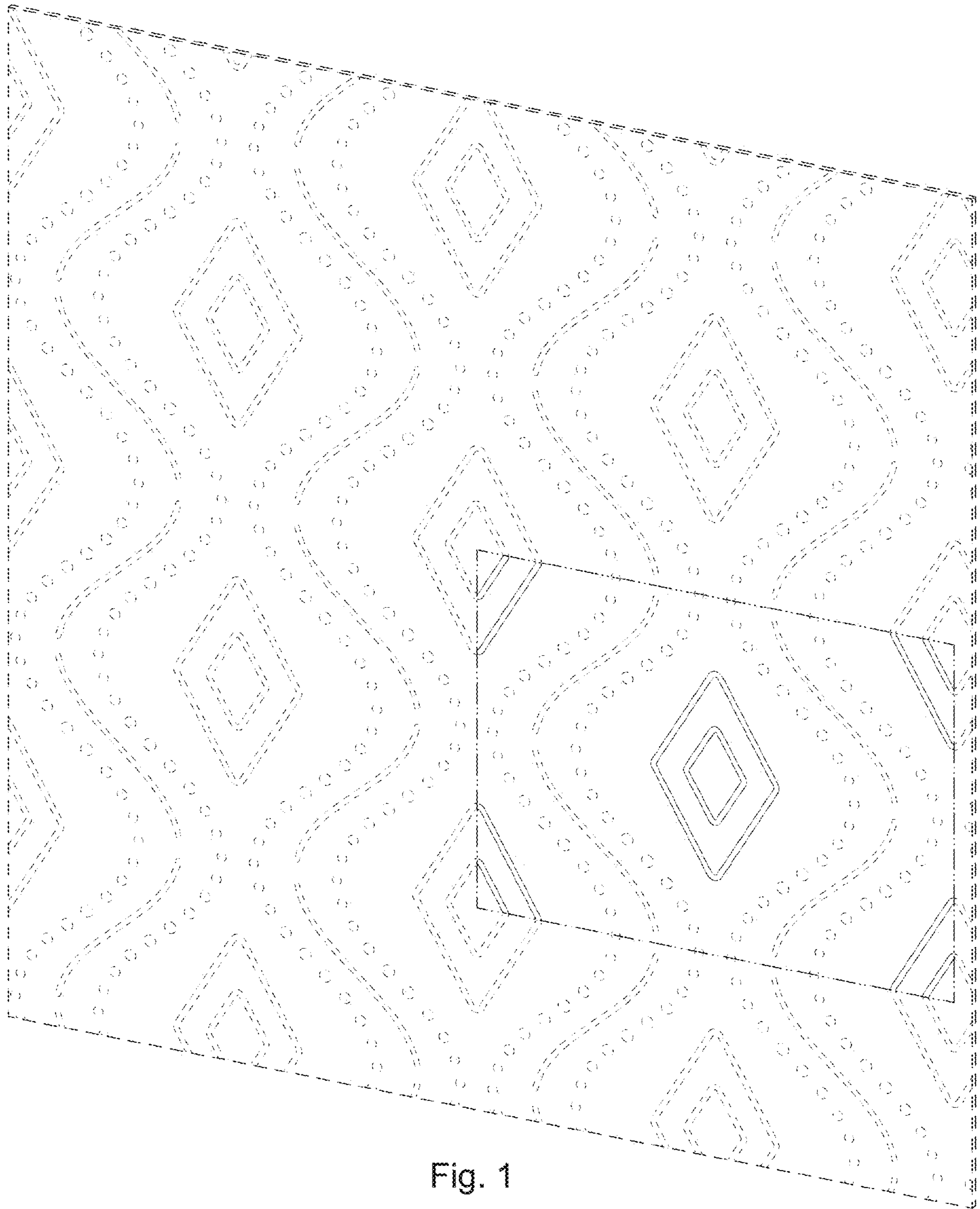

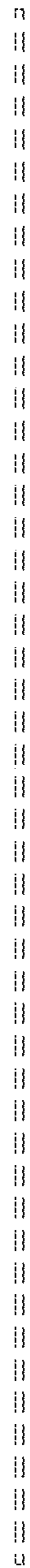

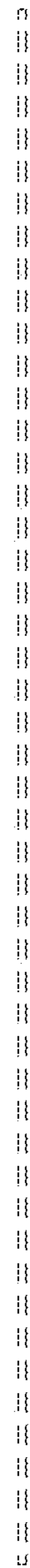

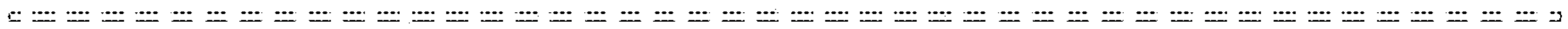

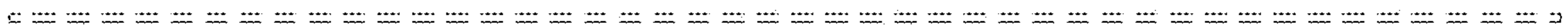
