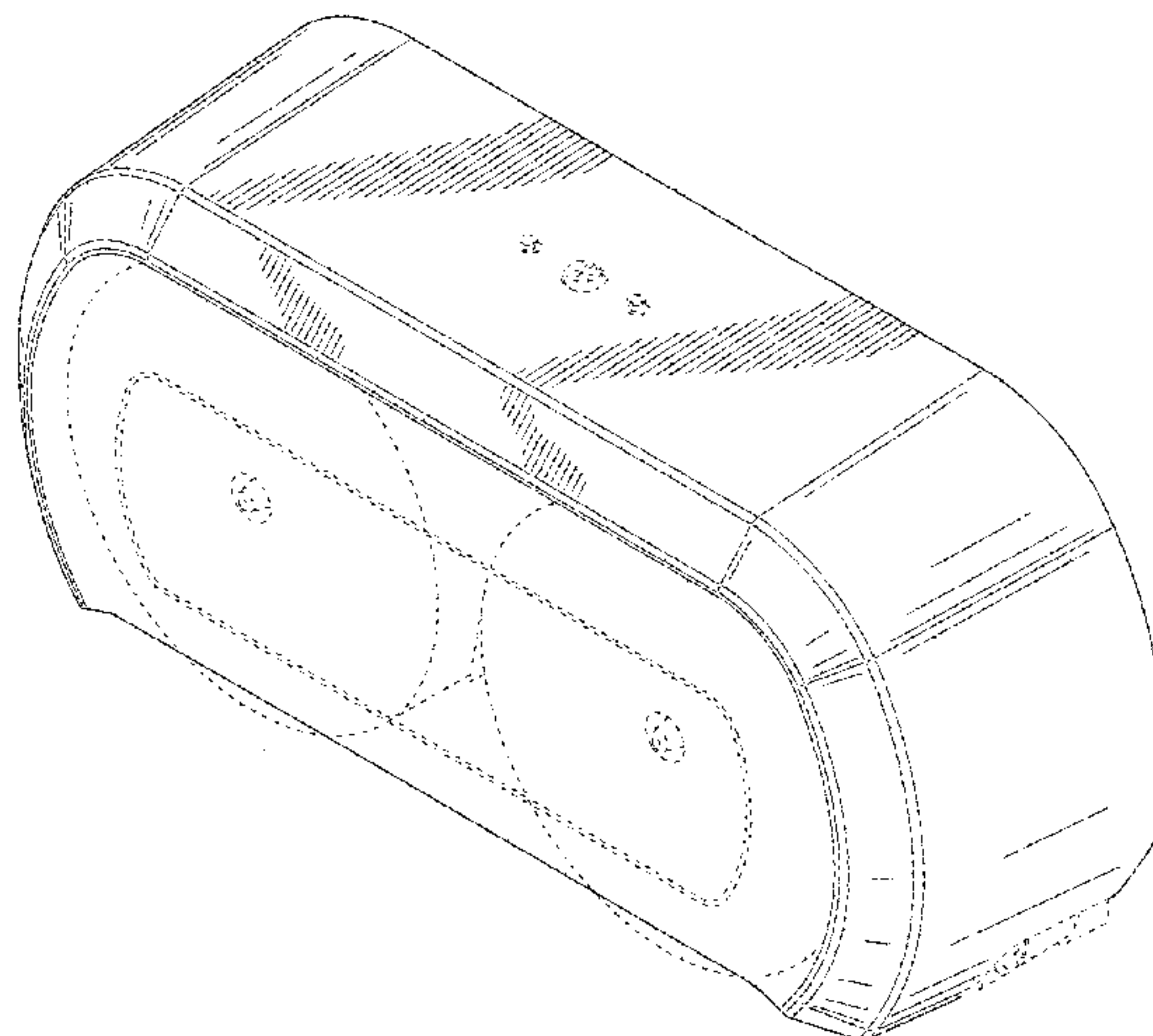
(57) **CLAIM**

The ornamental design for a sheet product dispenser, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a sheet product dispenser in accordance with the present invention;

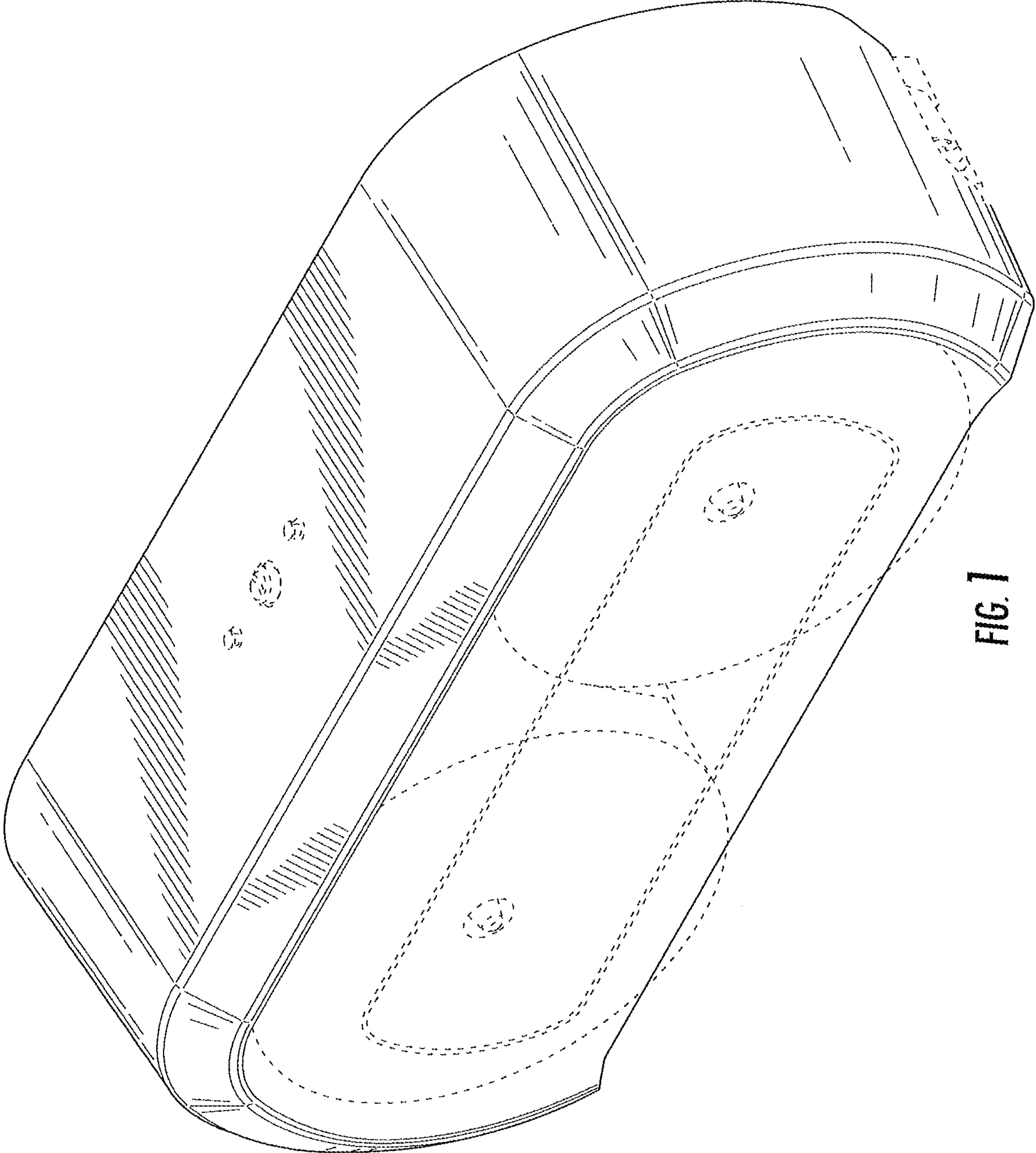

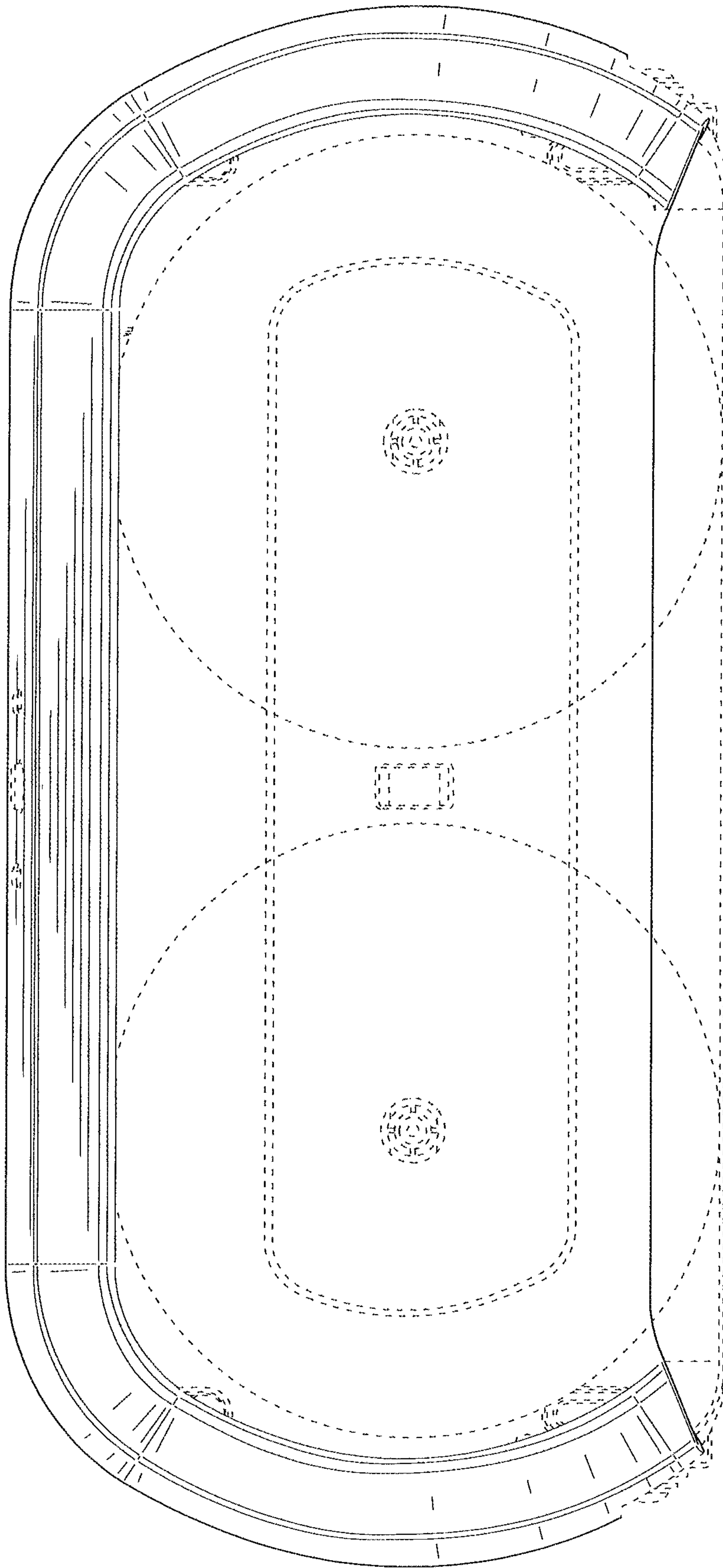

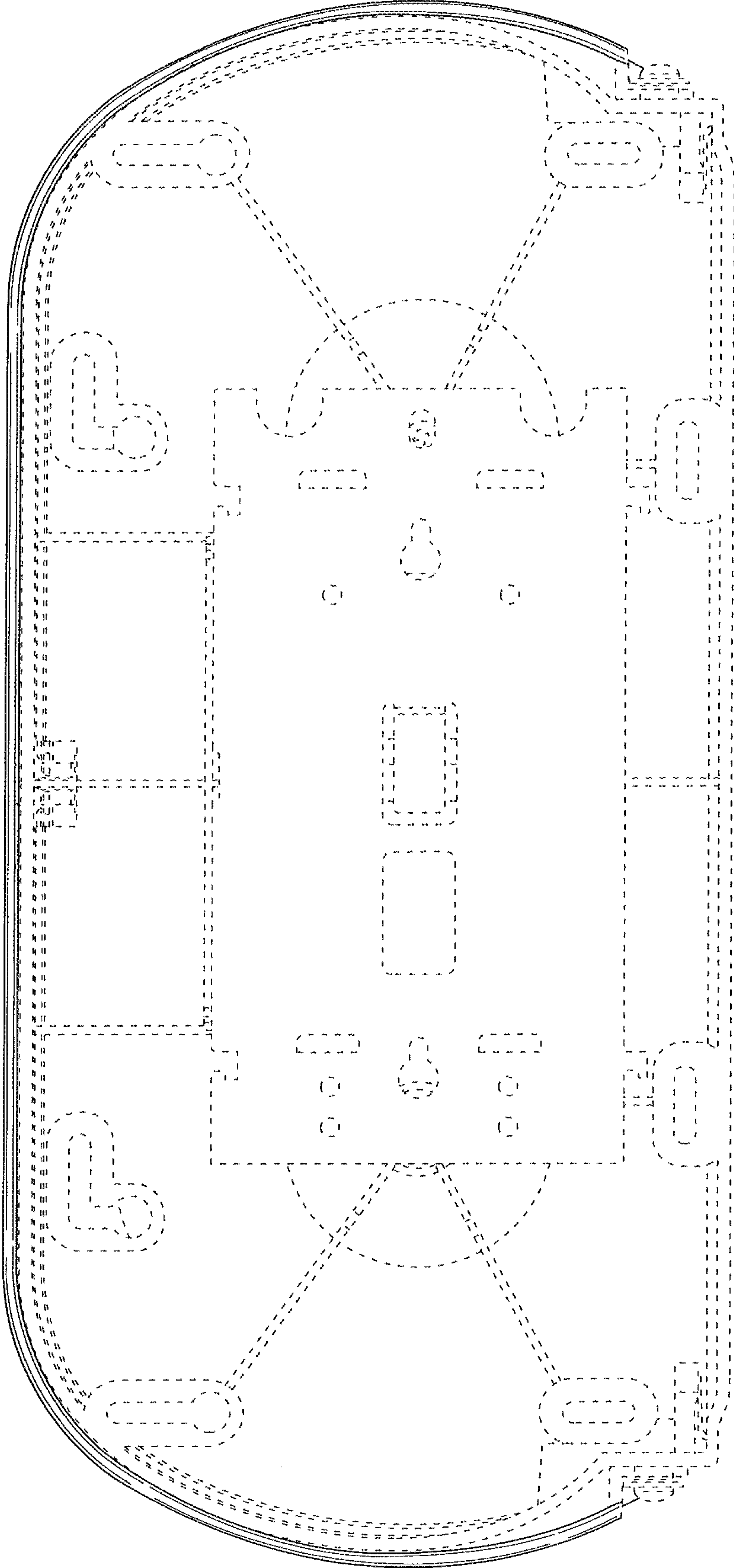

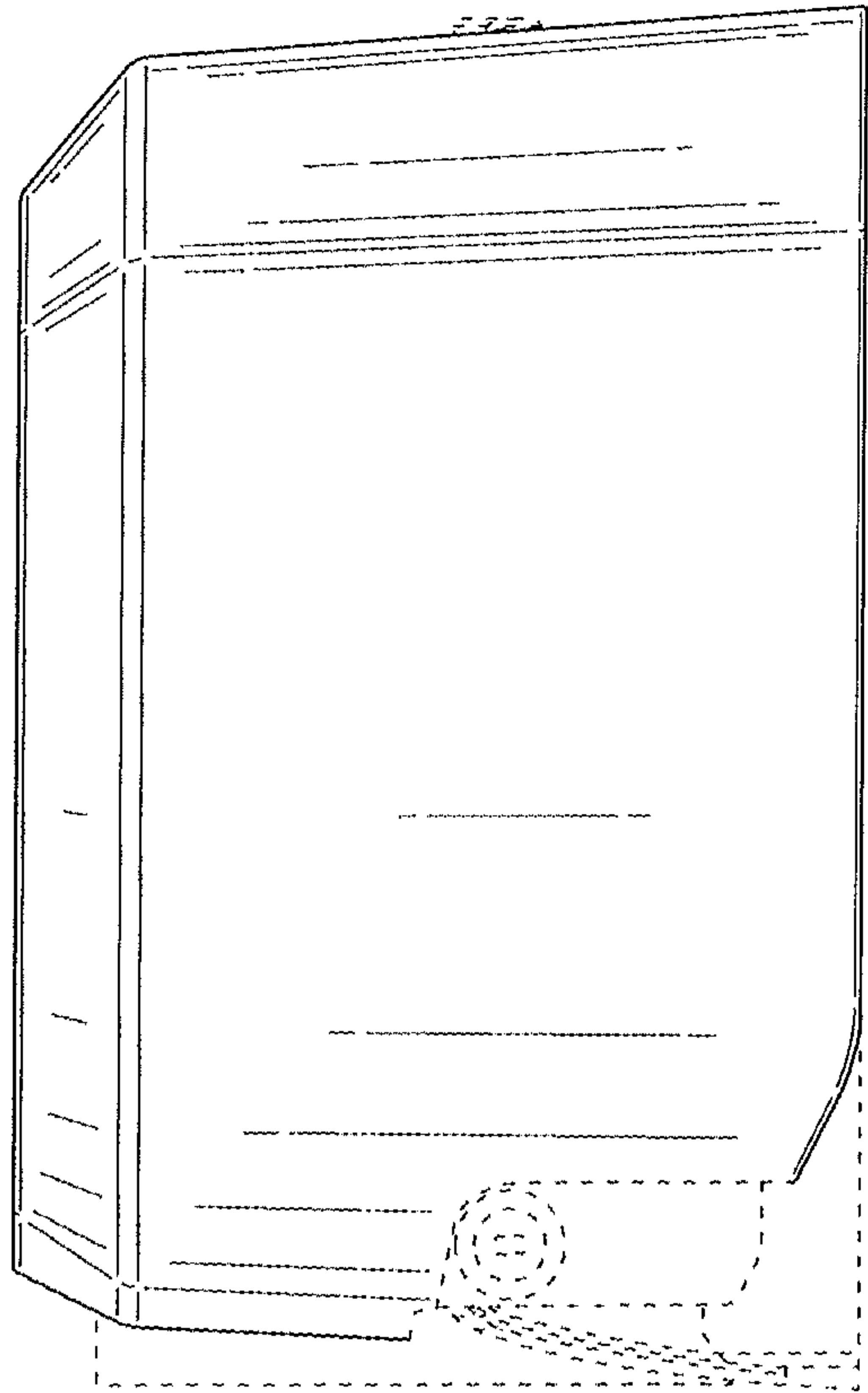

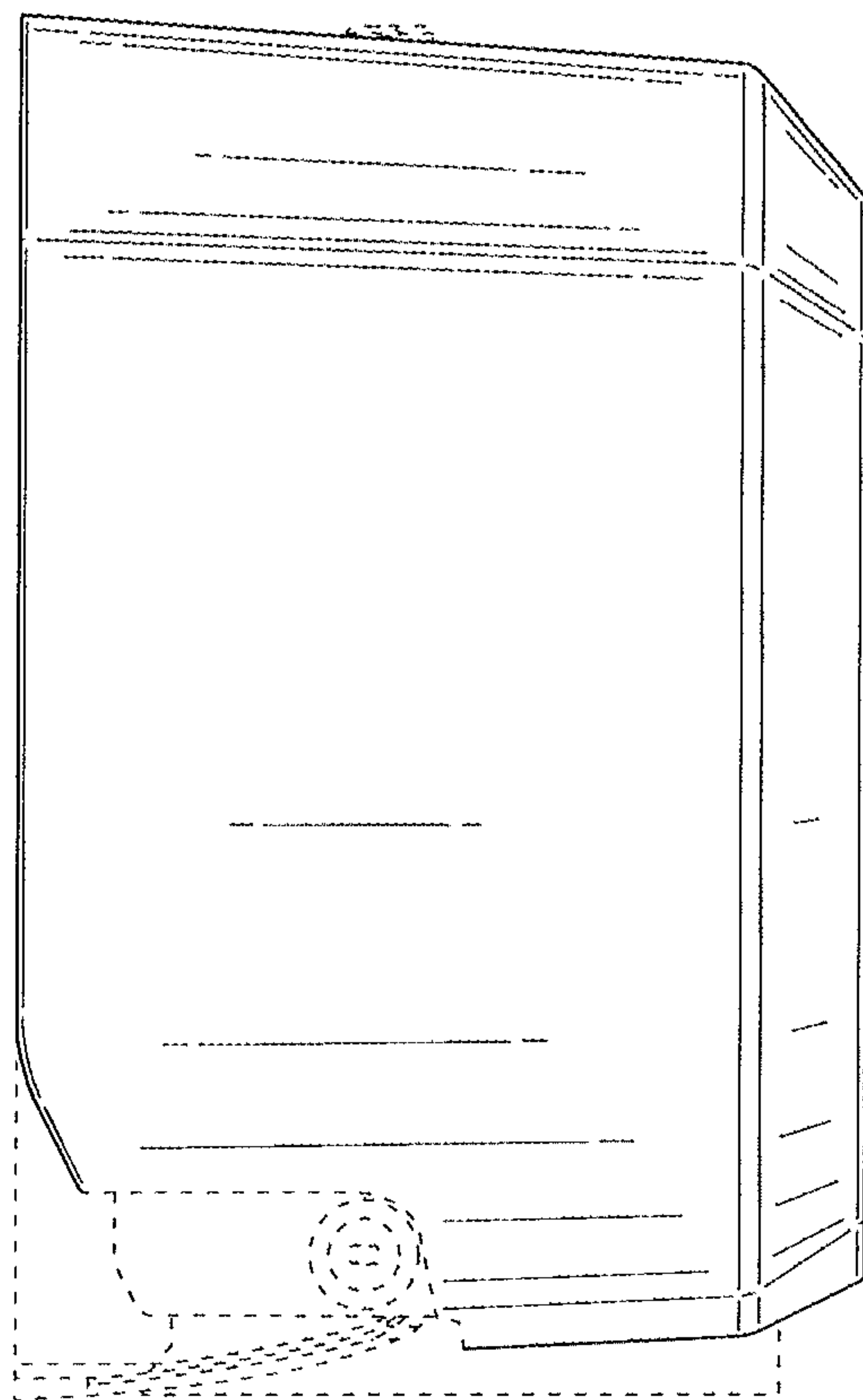

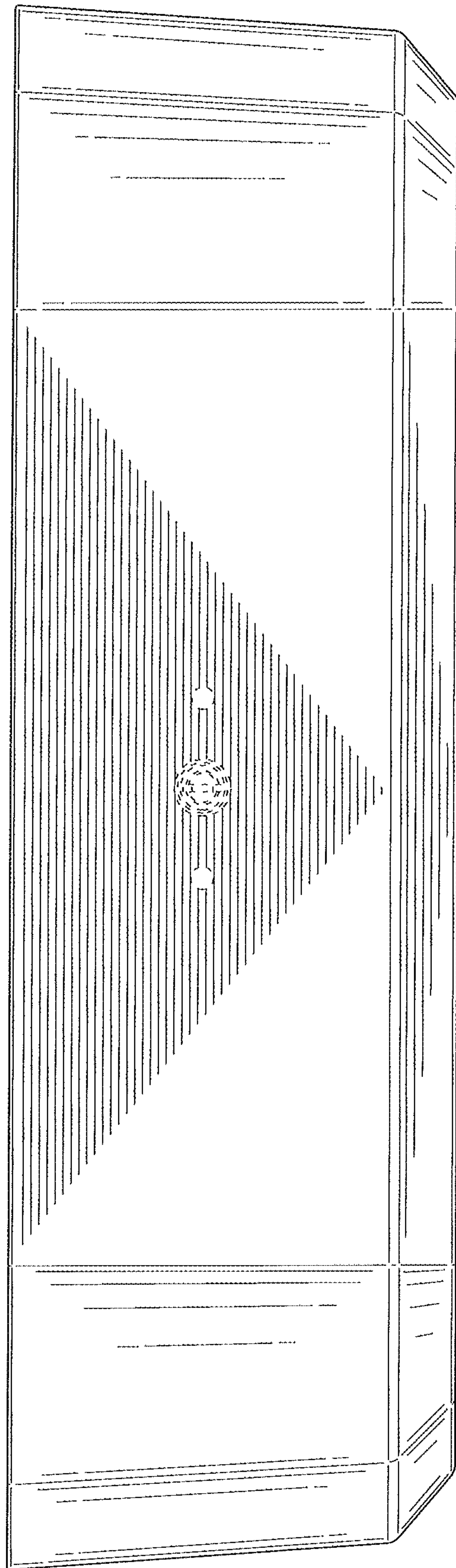

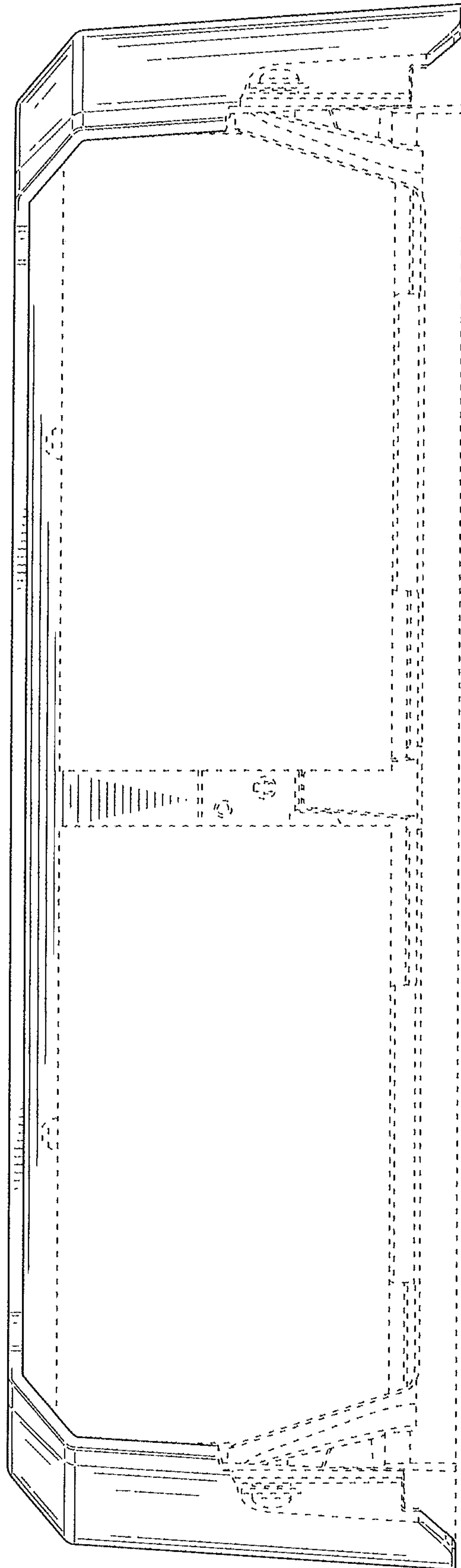
