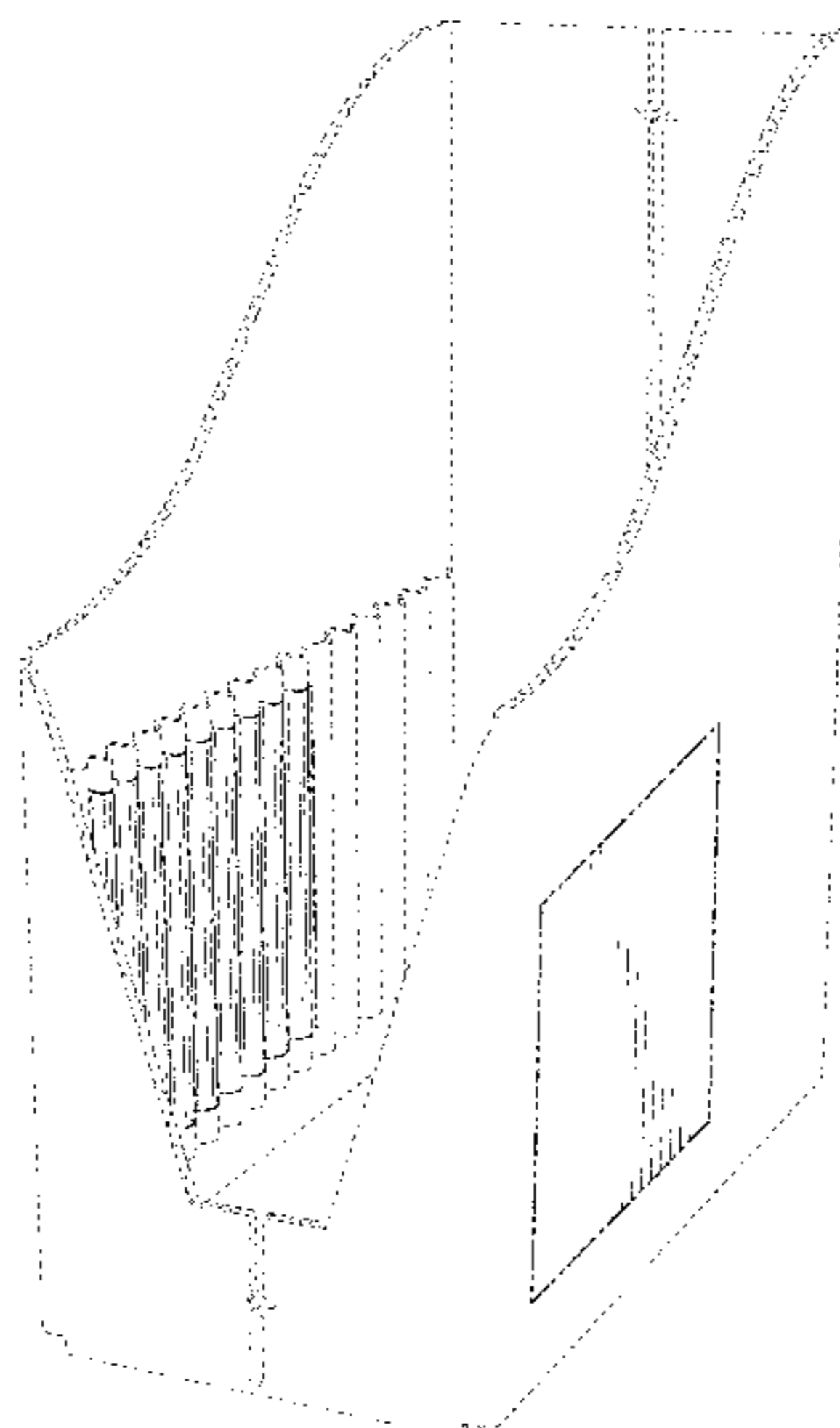
(57) **CLAIM**

We claim the ornamental design for a packaging assembly, as shown and described.

**DESCRIPTION**

FIG. 1 is an upper perspective view showing our new design for a packaging assembly.

FIG. 8 is an upper perspective view showing the packaging assembly of FIG. 1 holding products.  
FIG. 9 is a cross-sectional view showing the design of FIG. 1, taken along line 9-9.  
FIG. 10 is an upper perspective view of a blank for the packaging assembly of FIG. 1.  
FIG. 11 is a front plan view of the blank of FIG. 10.  
FIG. 12 is a rear plan view of the blank of FIG. 10.  
FIG. 13 is a first side view of the blank of FIG. 10.  
FIG. 14 is a second side view of the blank of FIG. 10.  
FIG. 15 is an upper view of the blank of FIG. 10; and, FIG. 16 is a bottom view of the blank of FIG. 10.

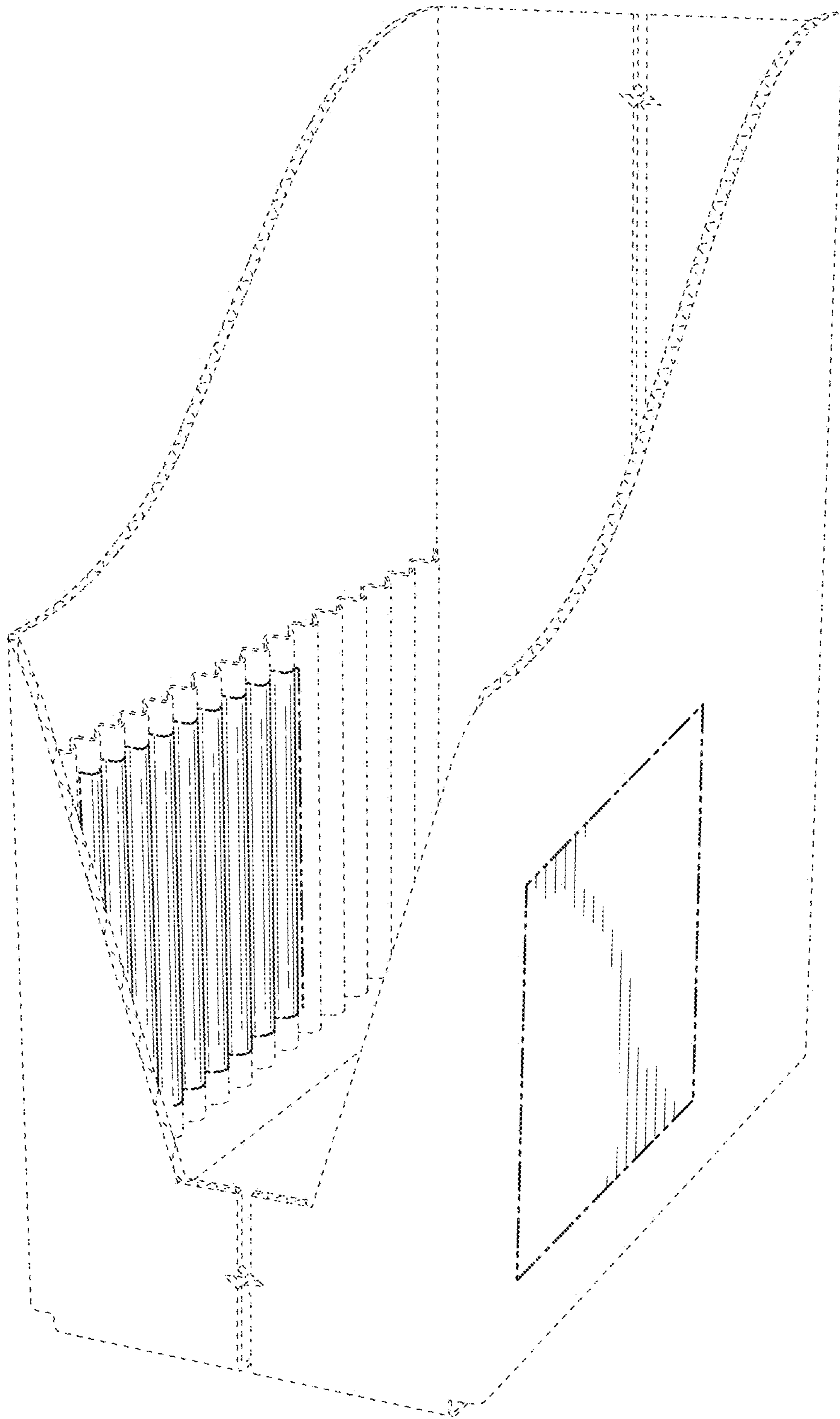

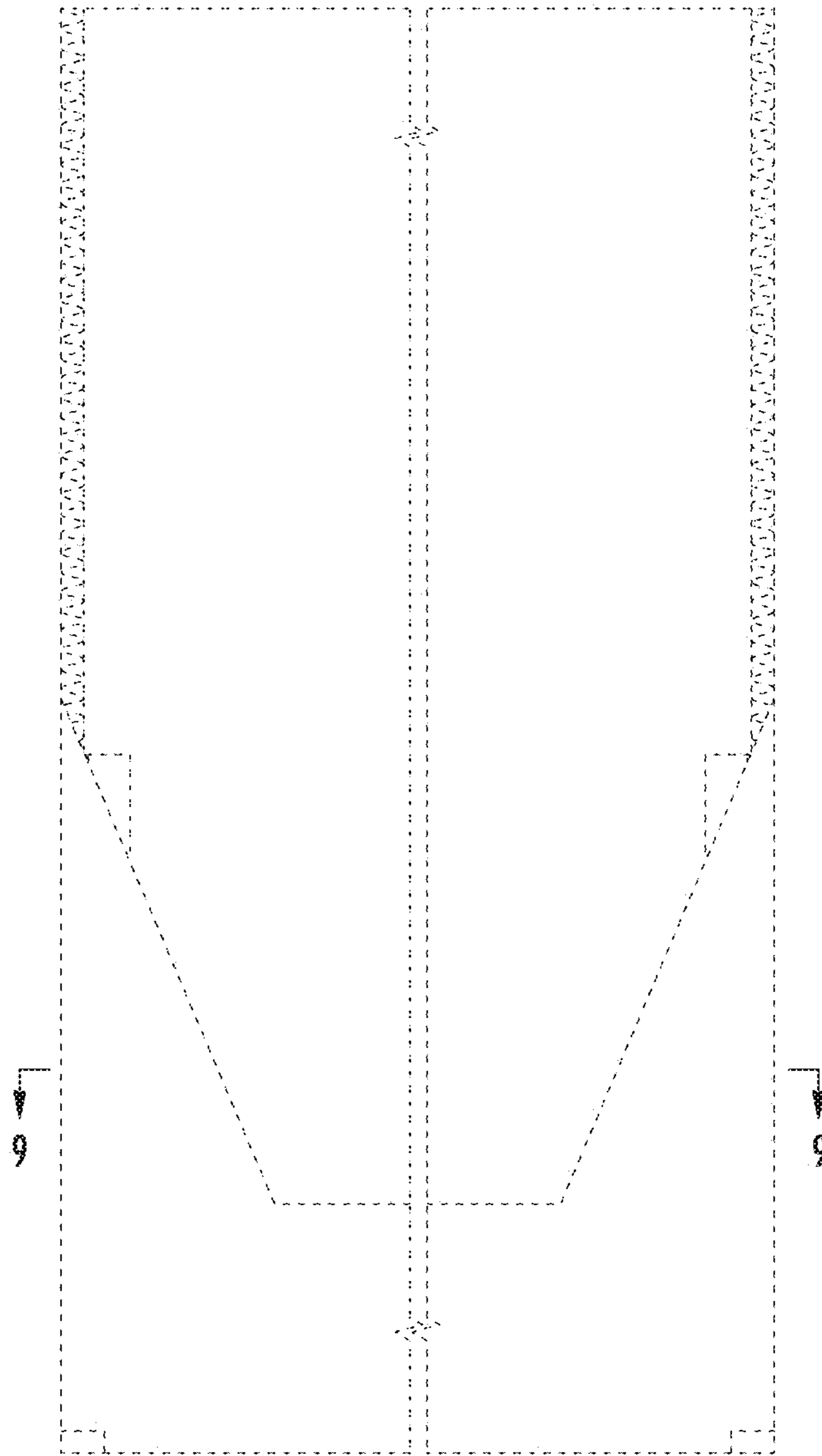

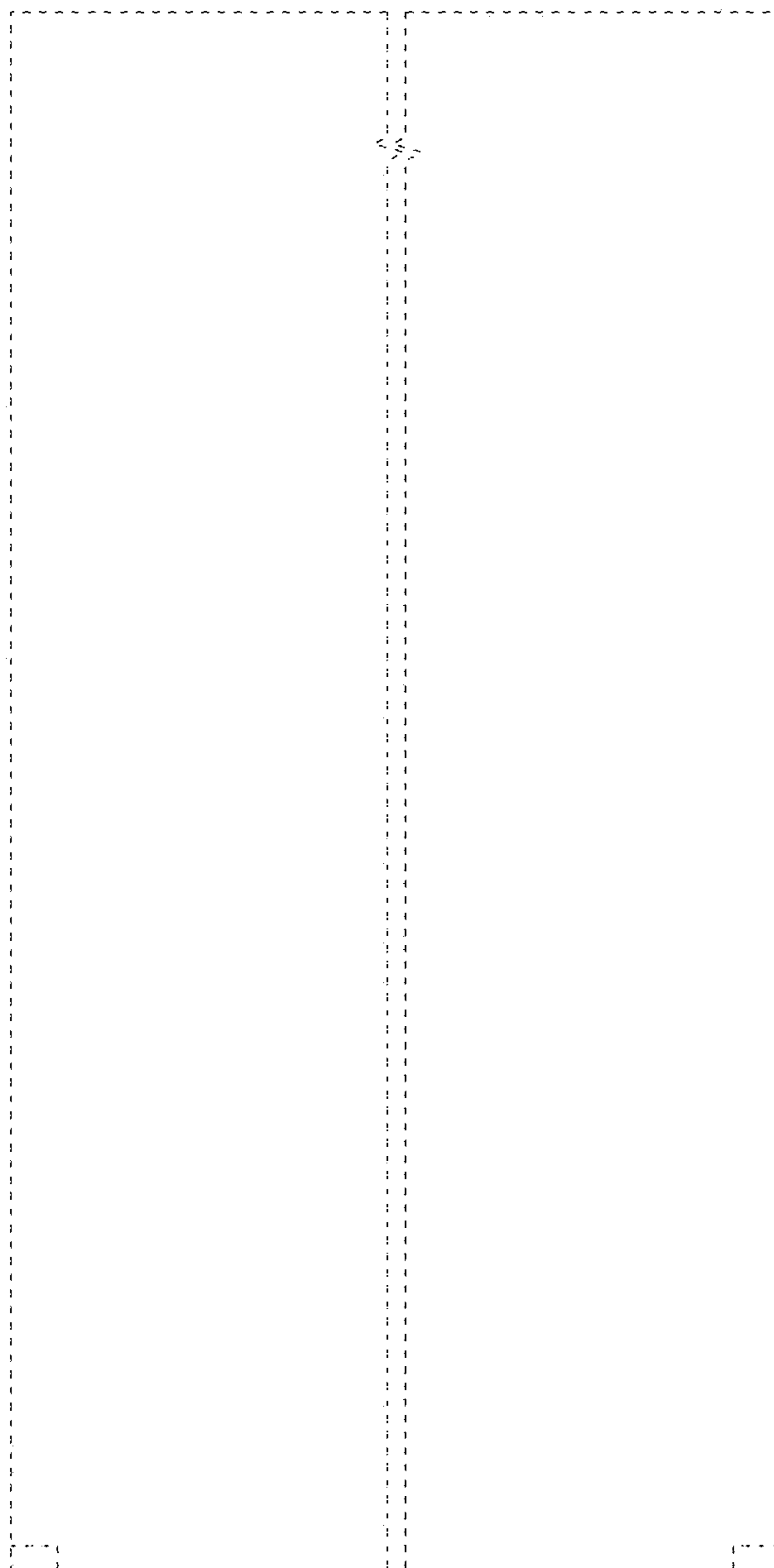

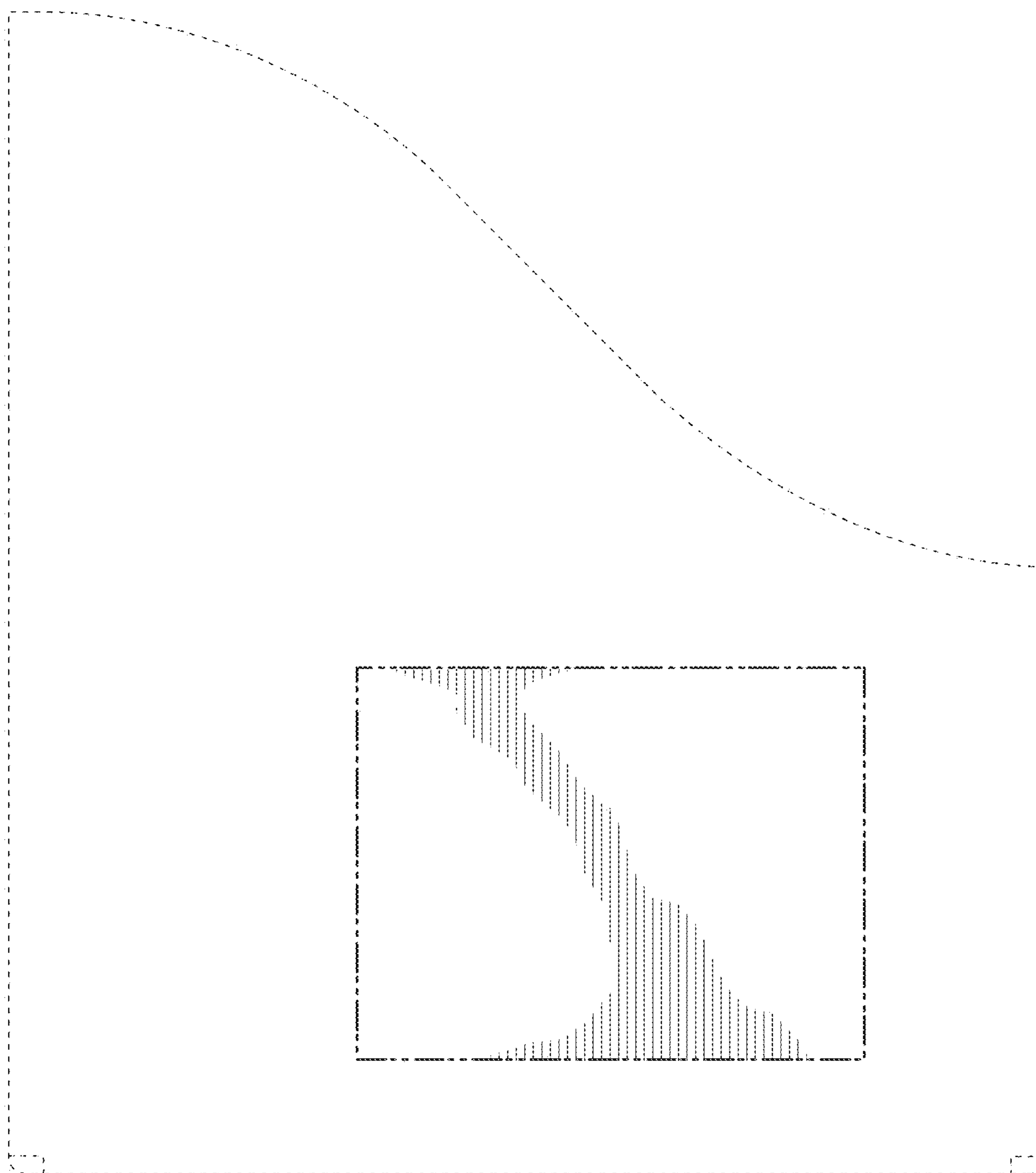
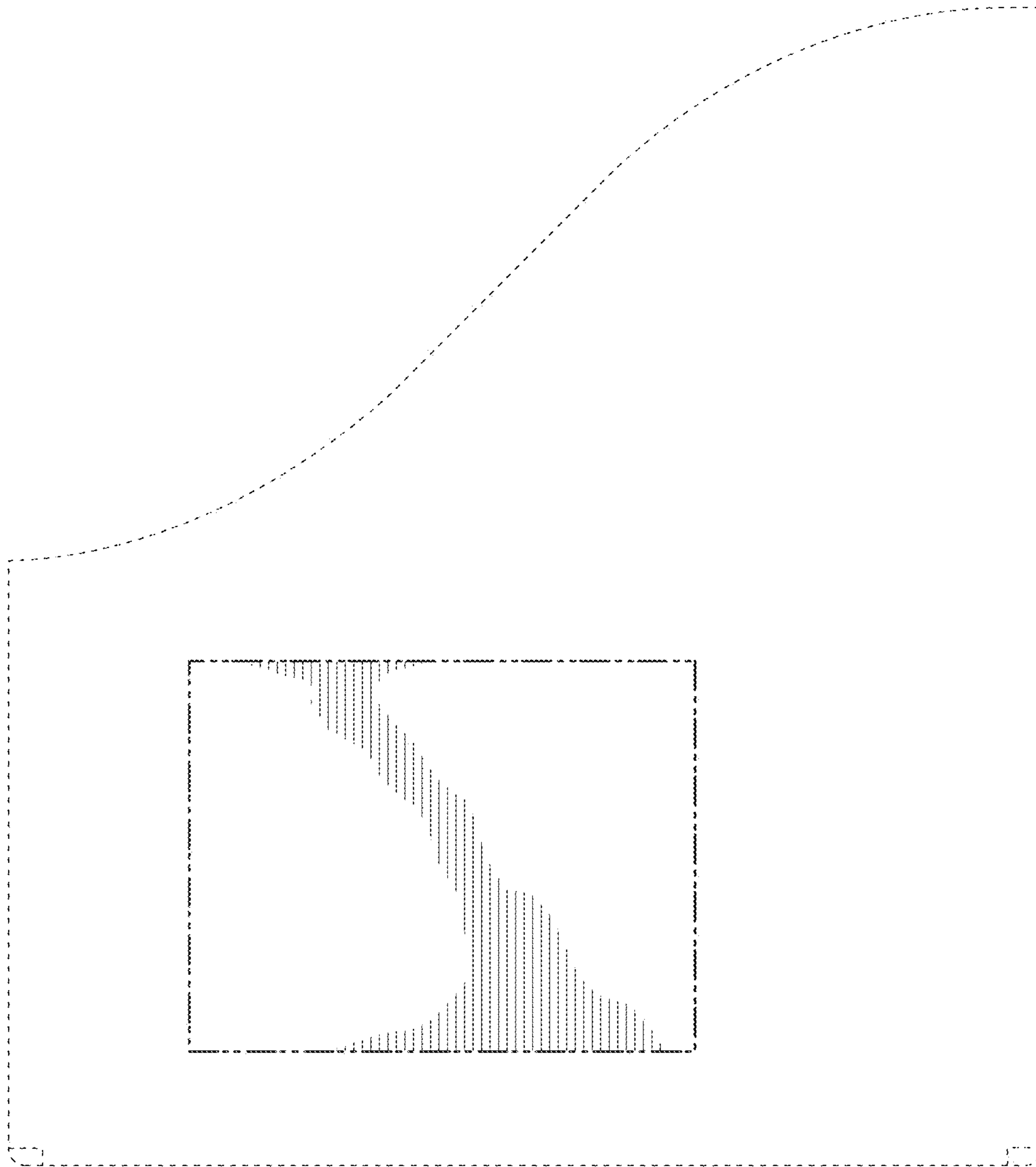

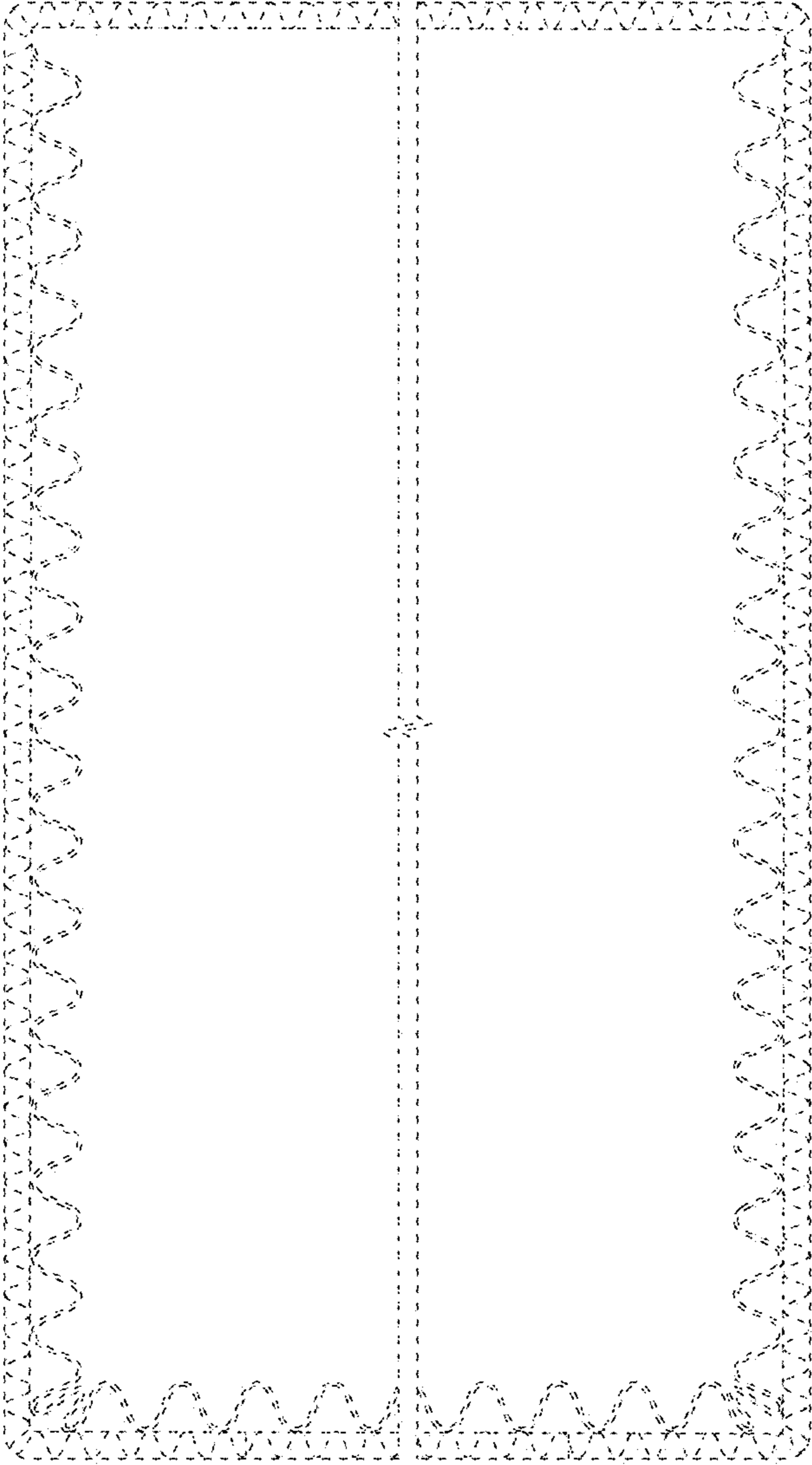

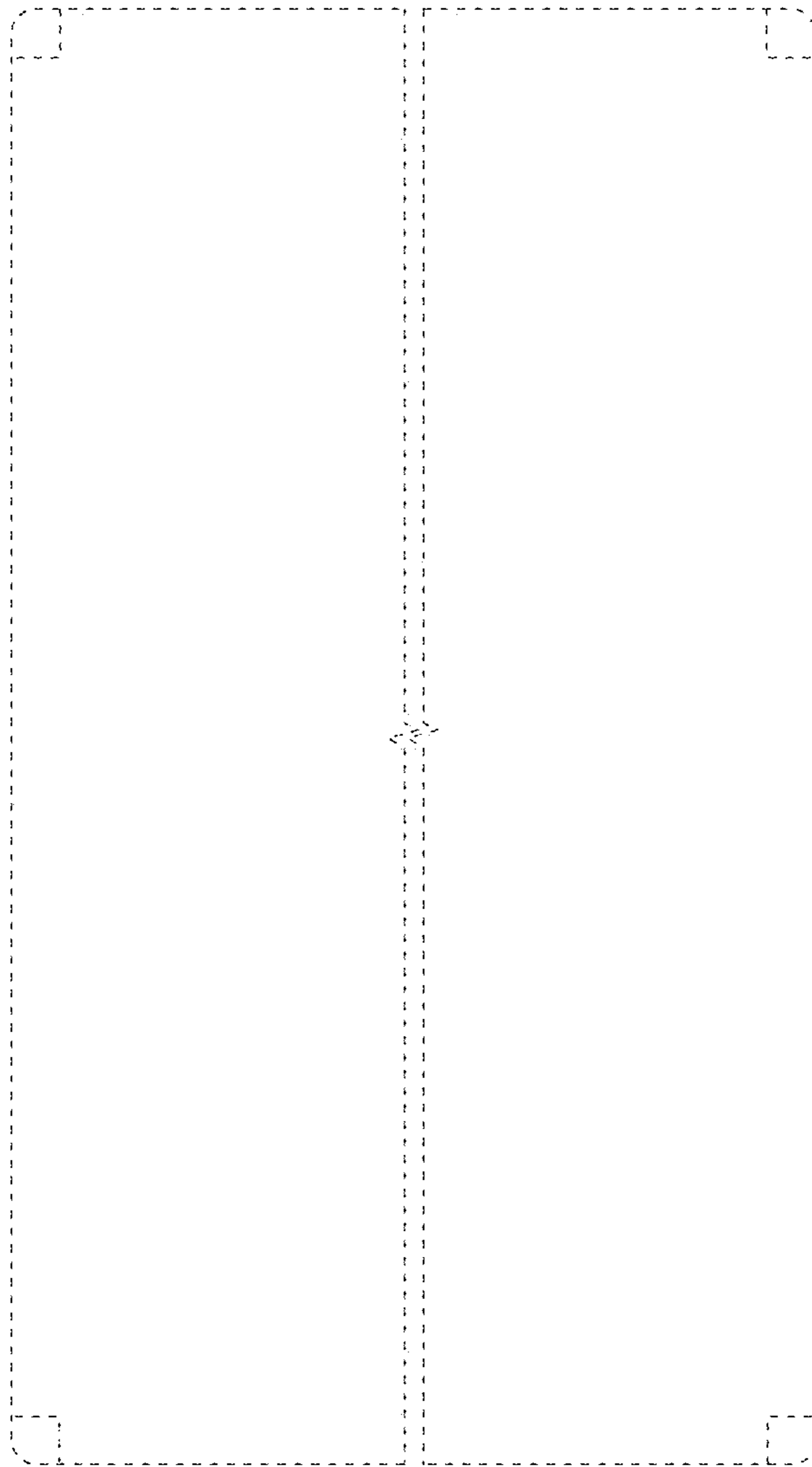

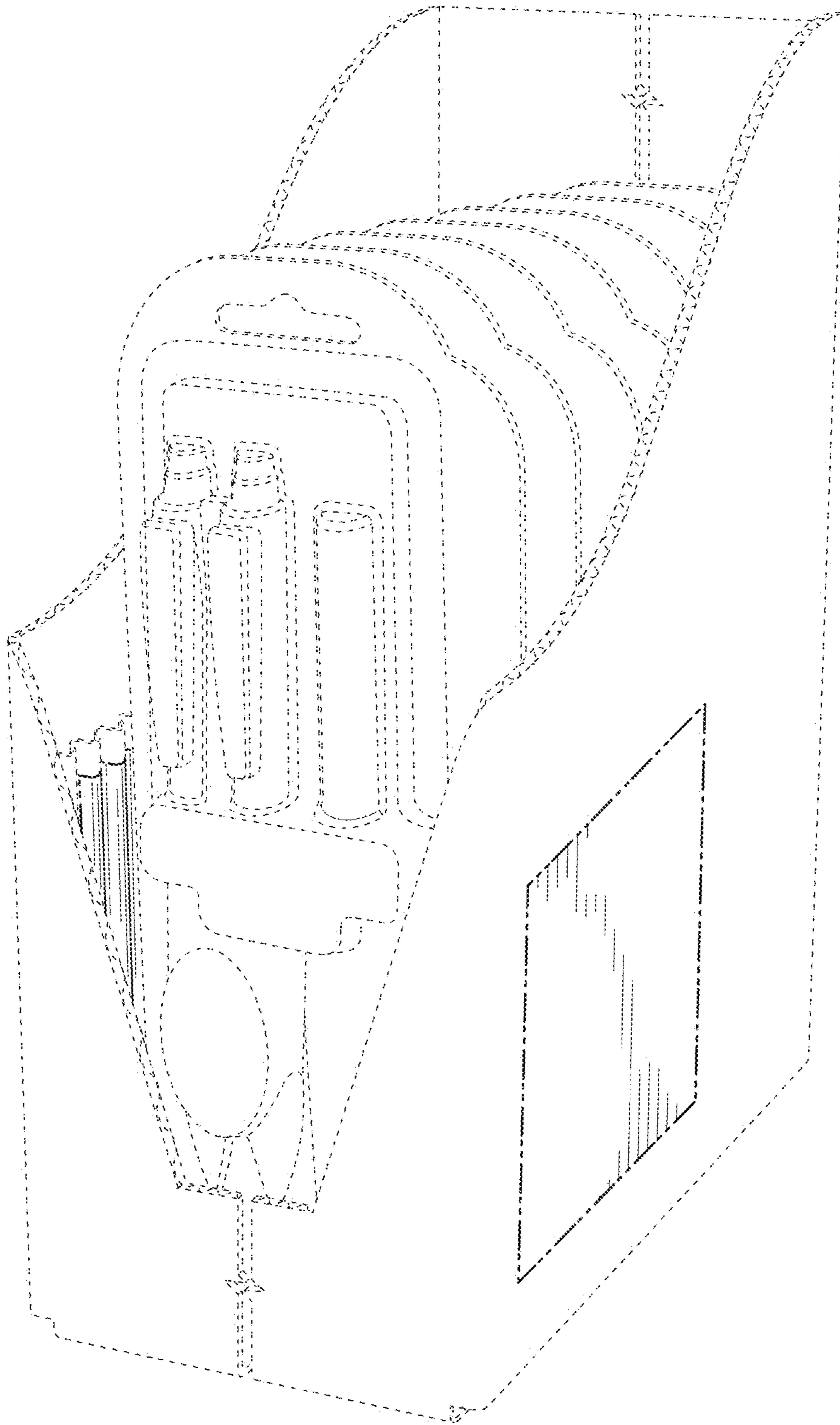

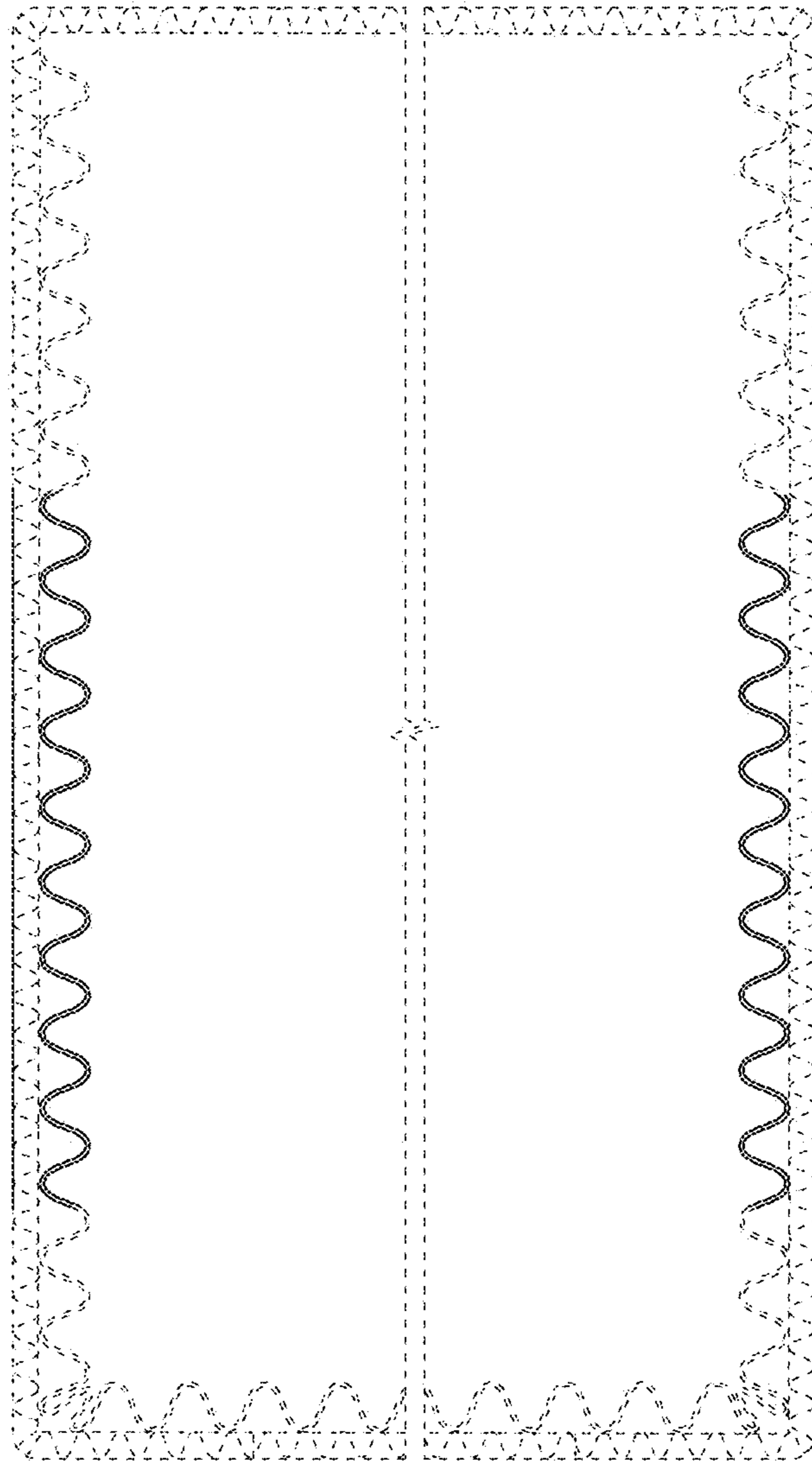

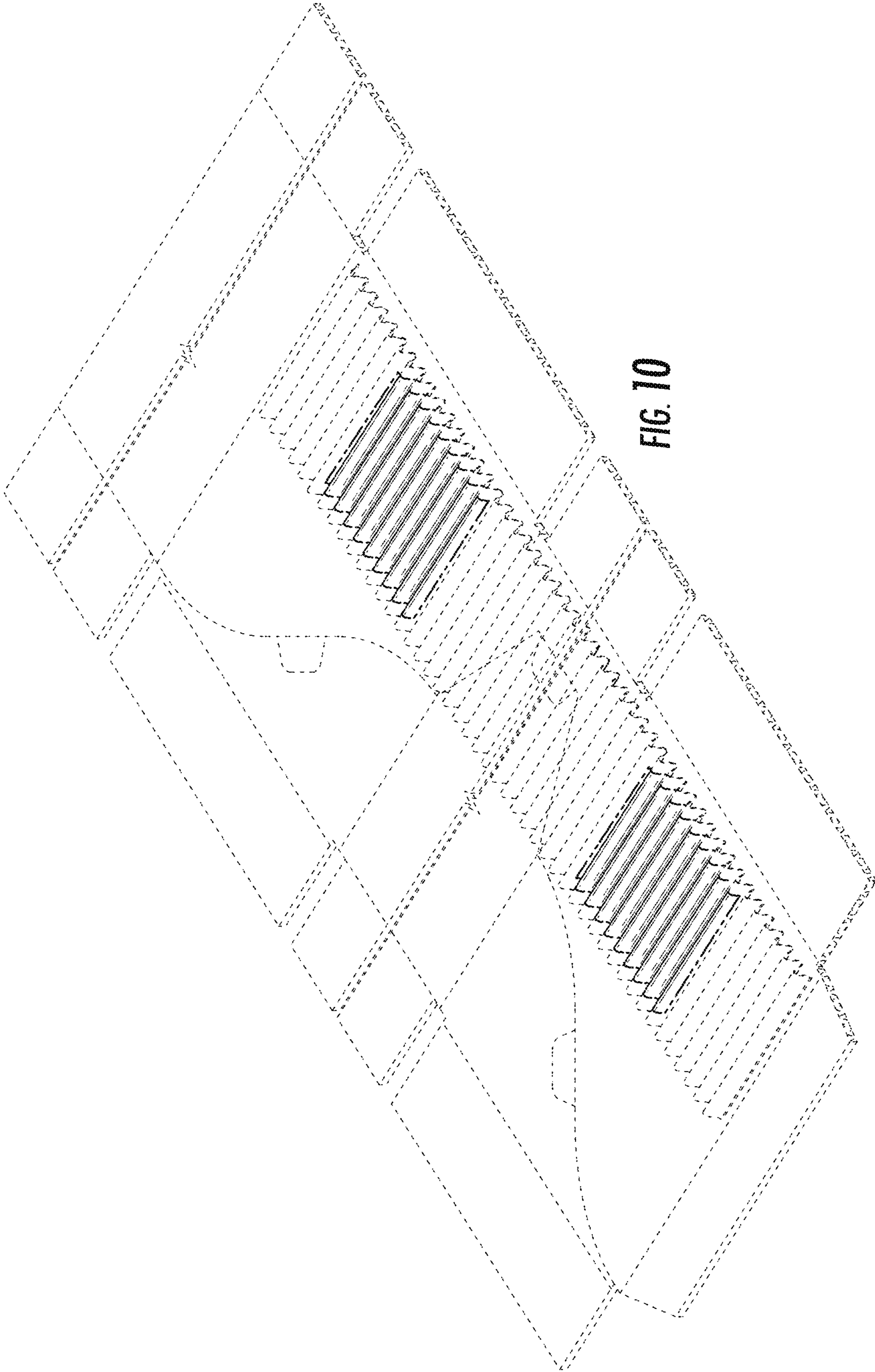

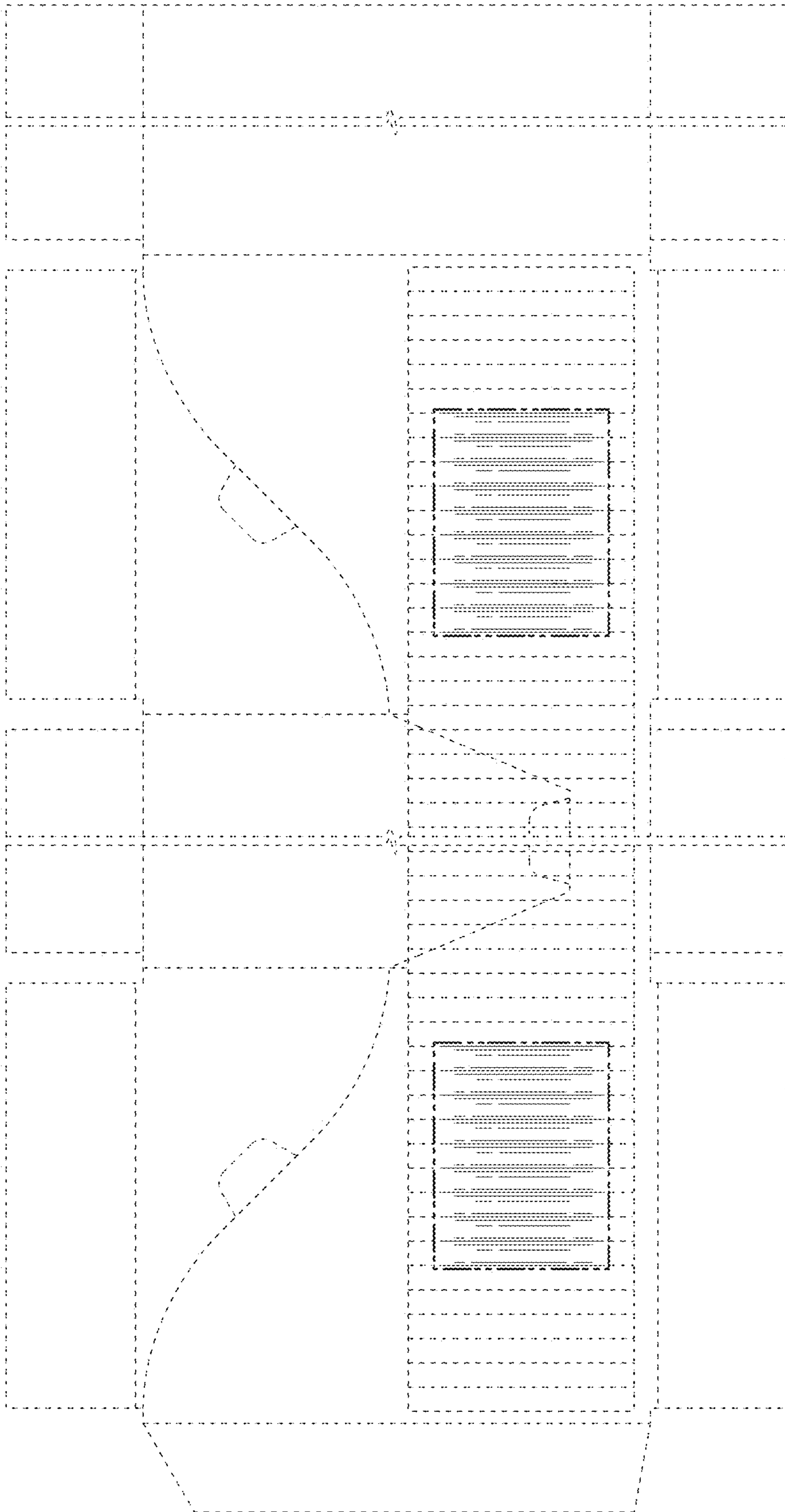

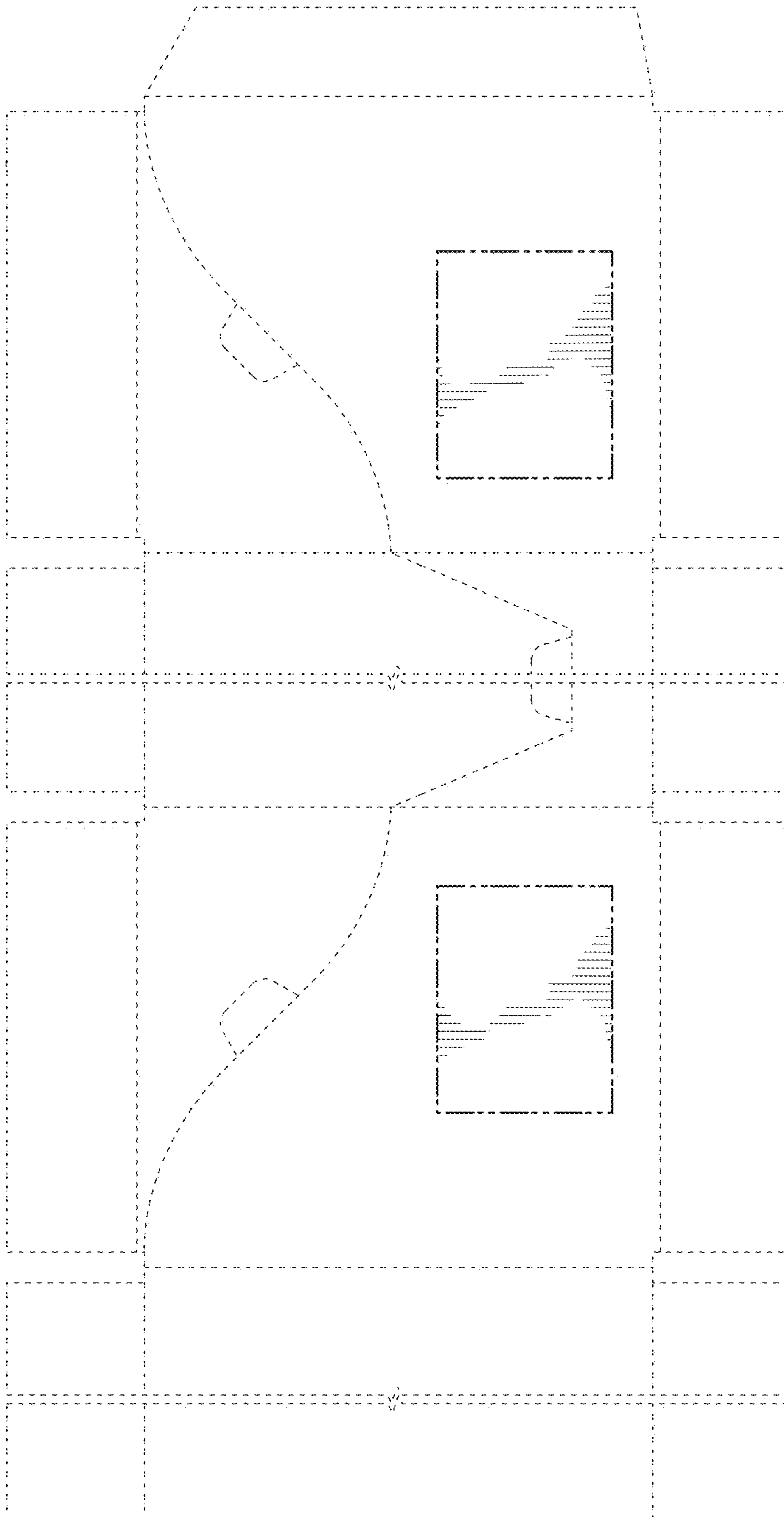
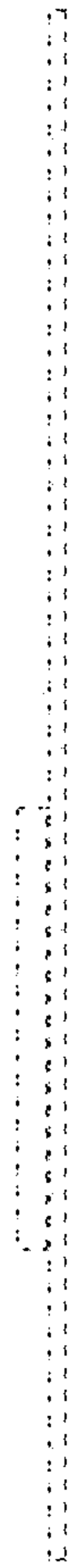
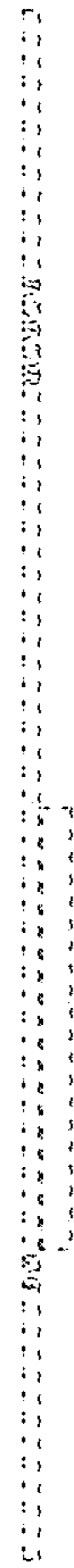

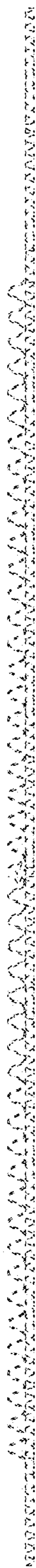
