(57) **CLAIM**

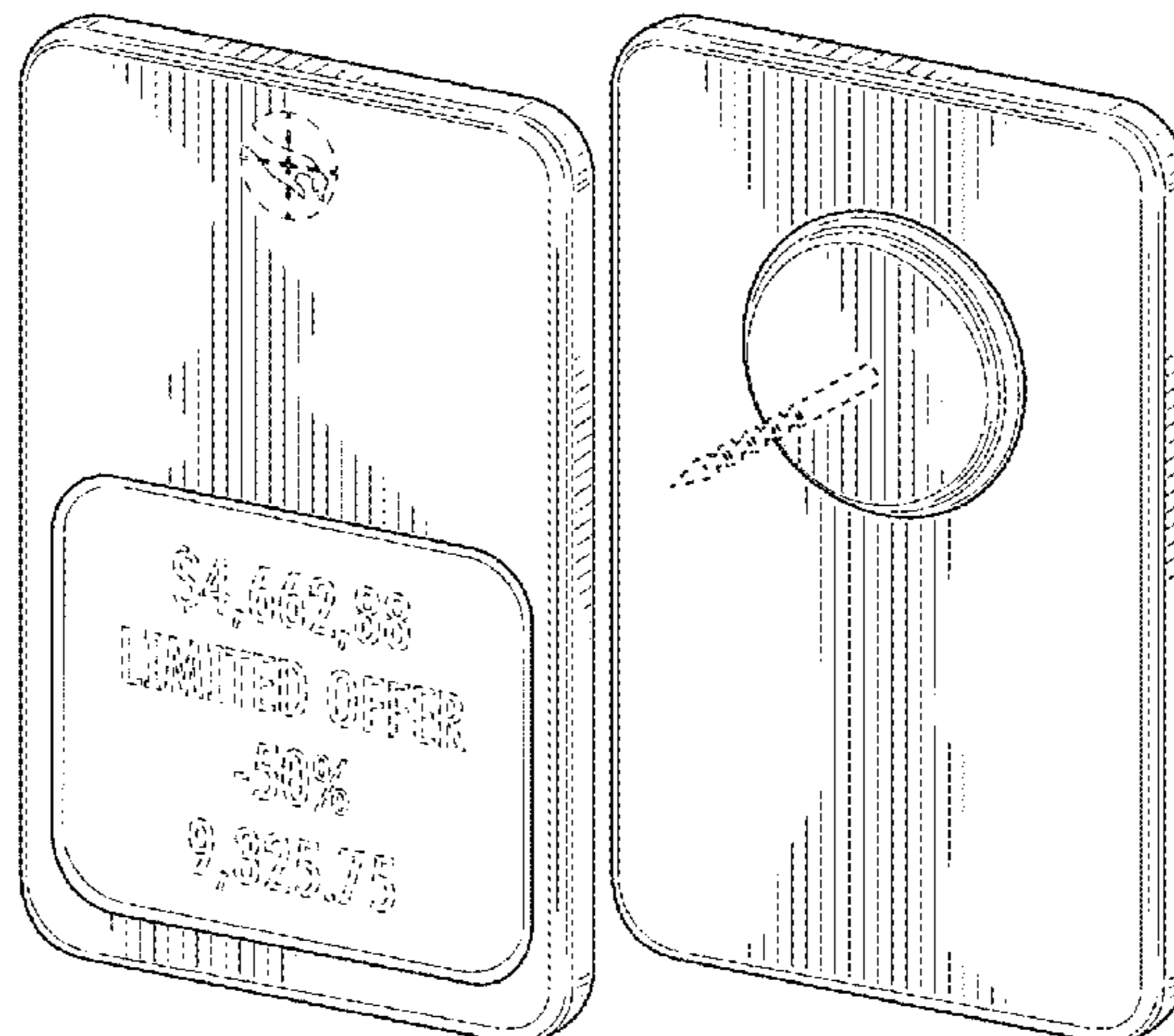
The ornamental design for a merchandise tag with electronic display, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a merchandise tag with electronic display, showing our new design; FIG. 2 is a rear perspective view thereof; FIG. 3 is another front perspective view thereof; FIG. 4 is another rear perspective view thereof; FIG. 5 is a front view thereof; FIG. 6 is a rear view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom plan view thereof; FIG. 9 is a left side view thereof; and, FIG. 10 is a right side view thereof.

The broken lines shown in the figures are included for the purpose of illustrating portions of the merchandise tag with electronic display and form no part of the claimed design.

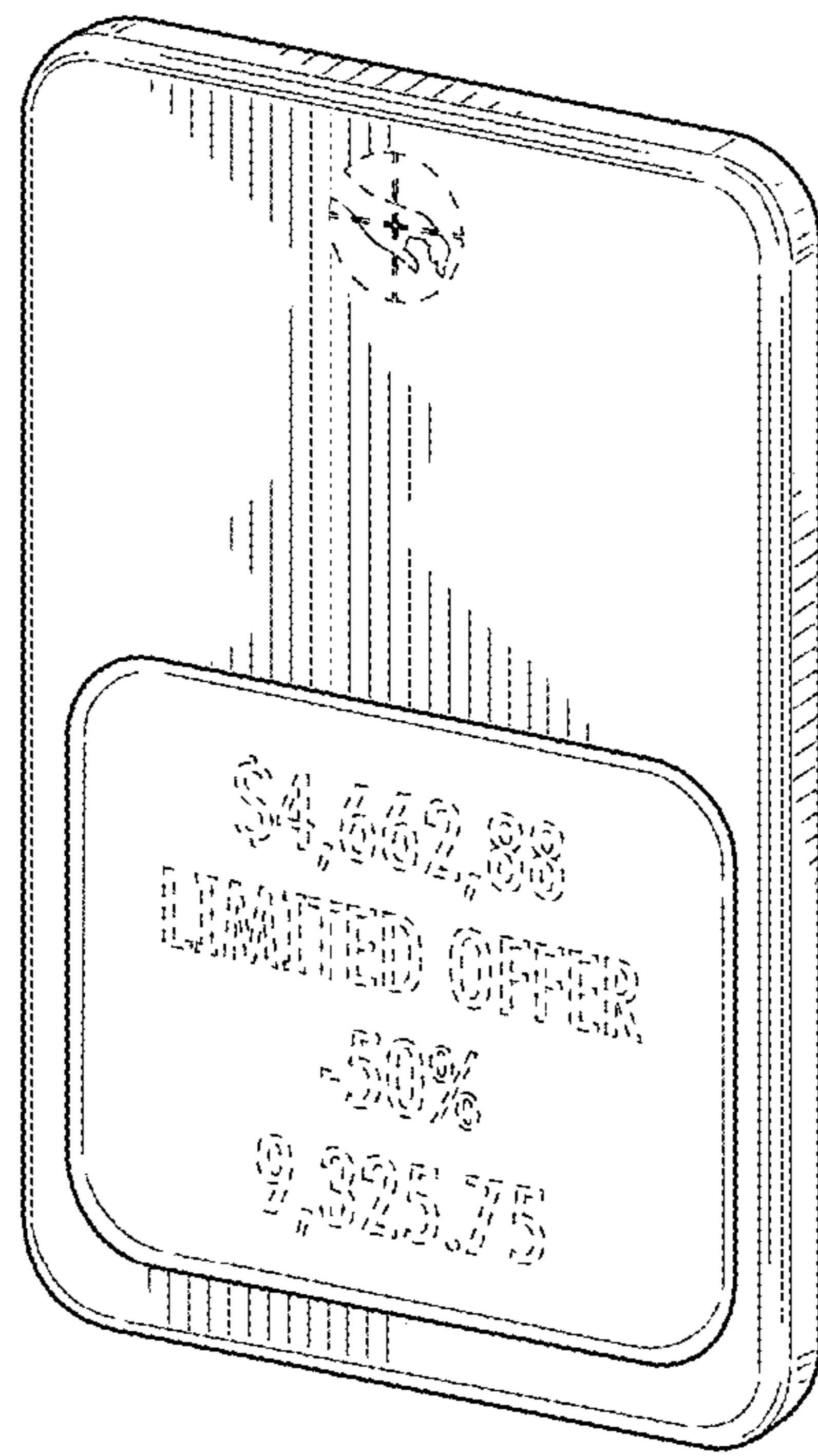

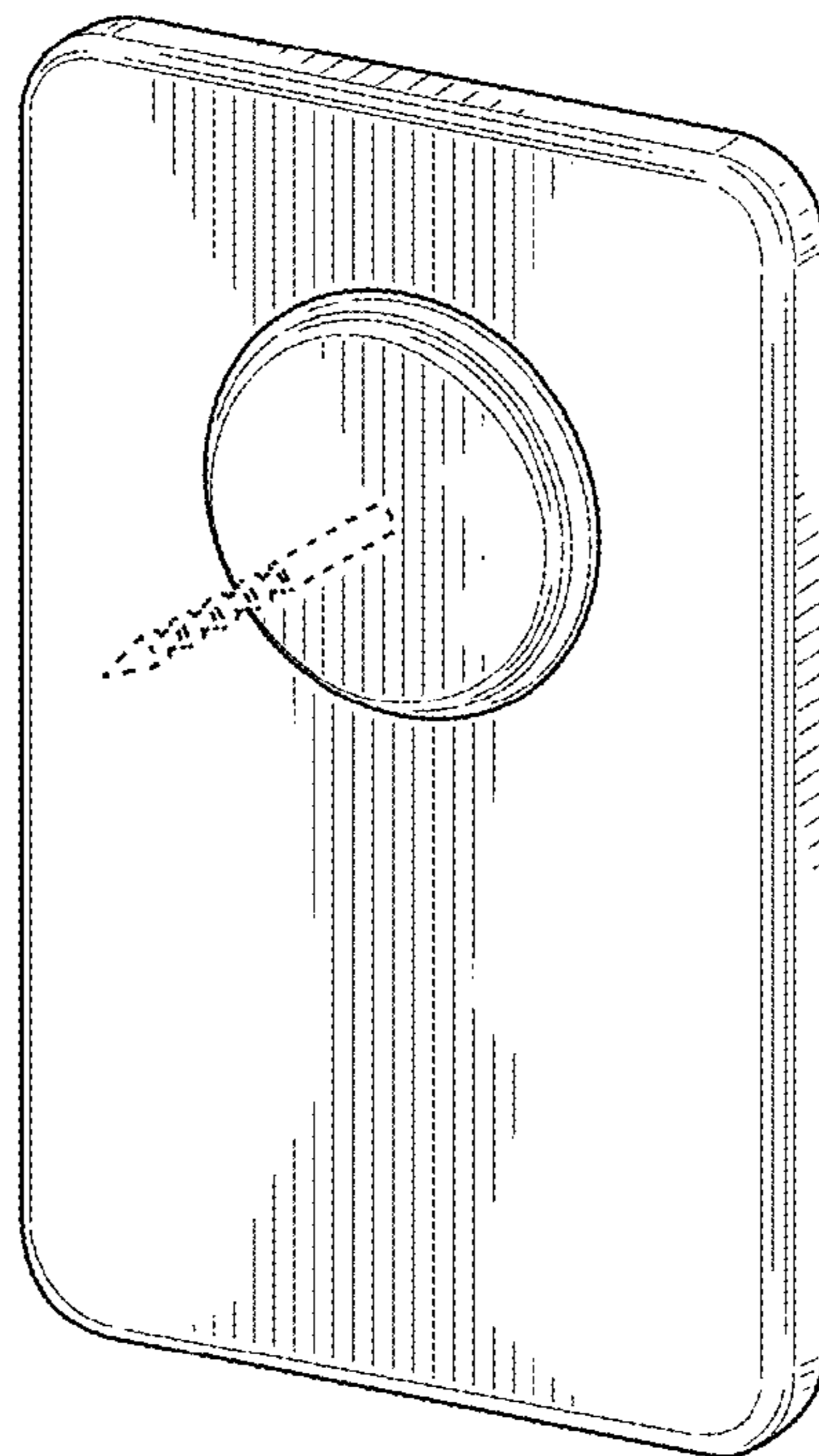

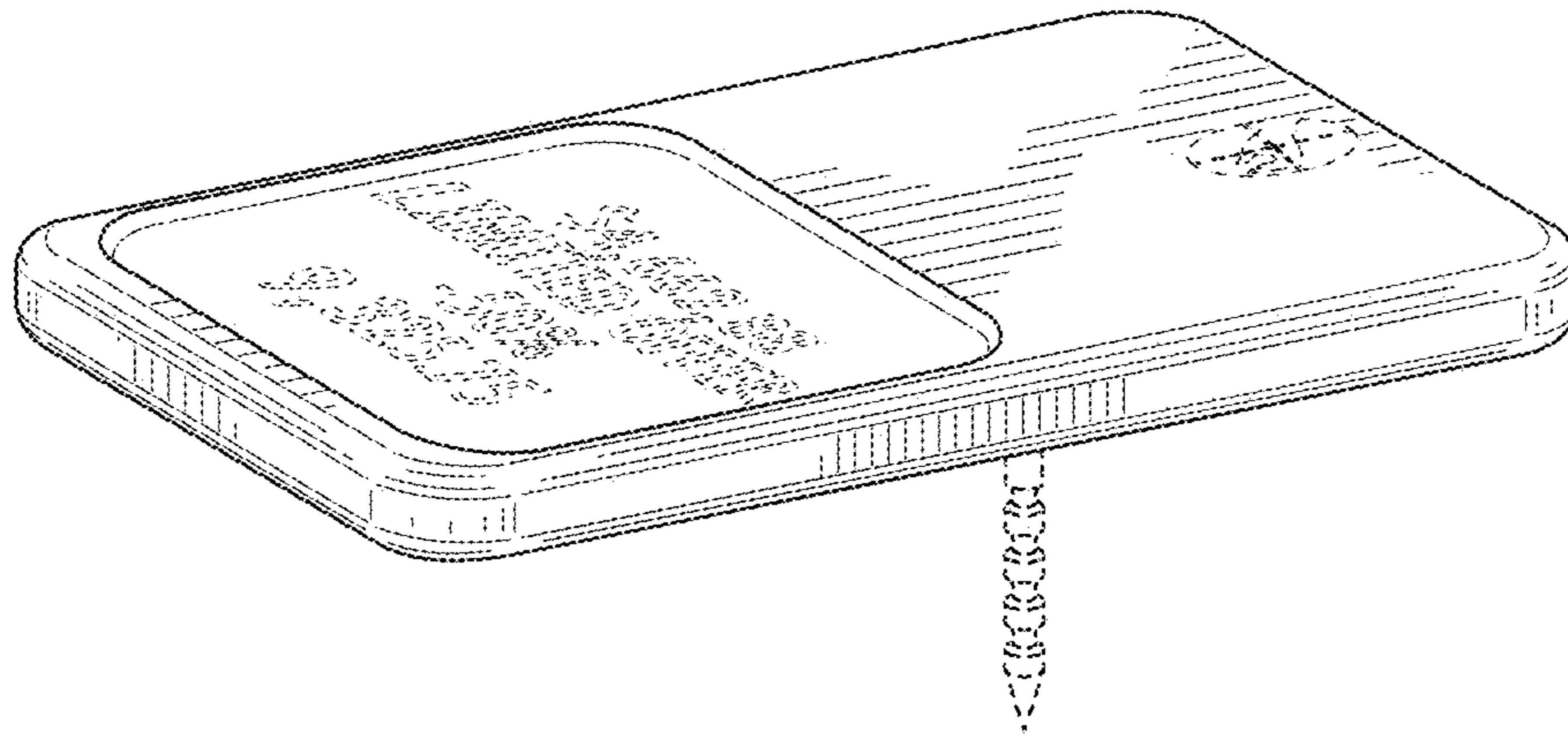

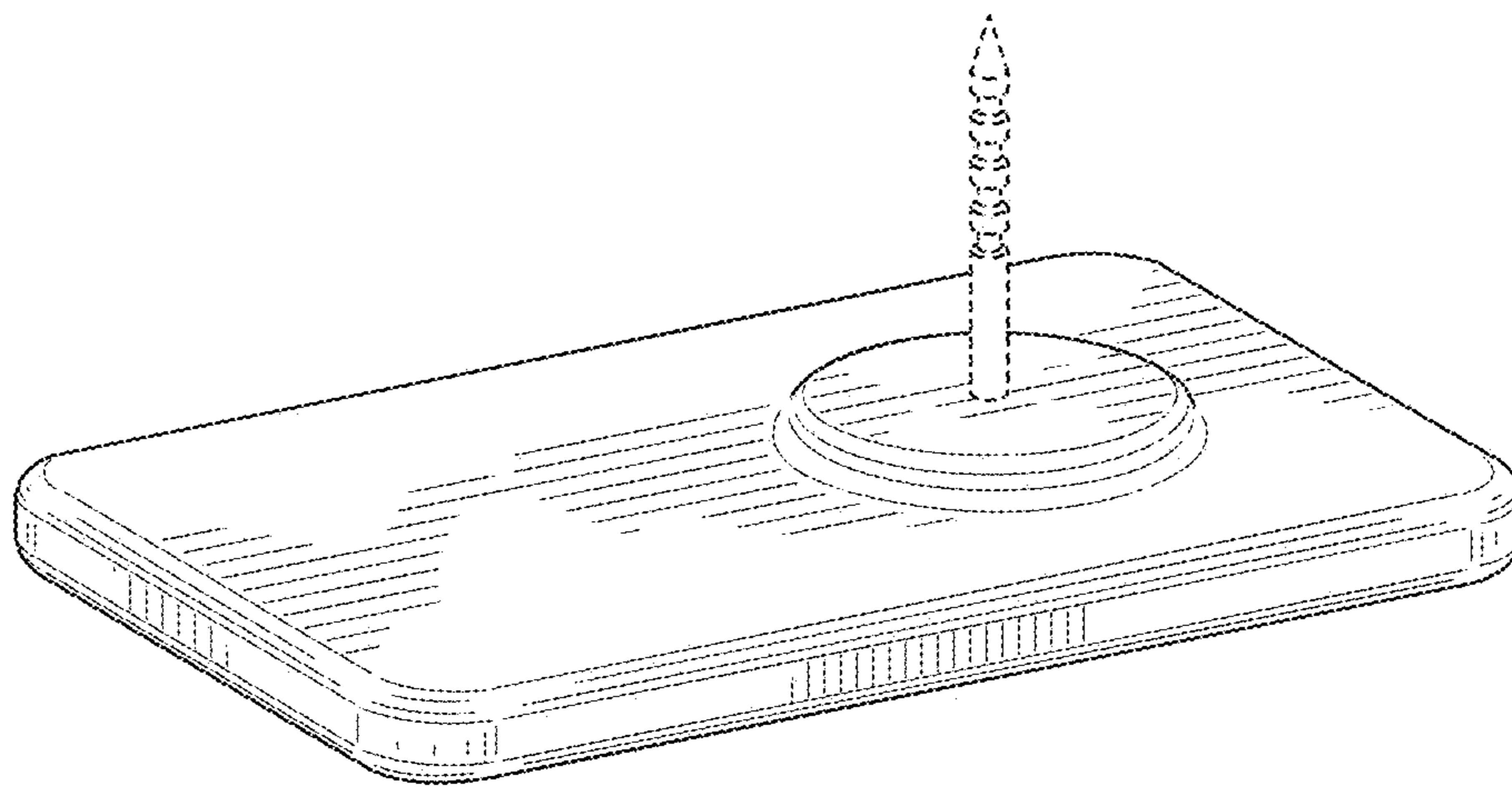

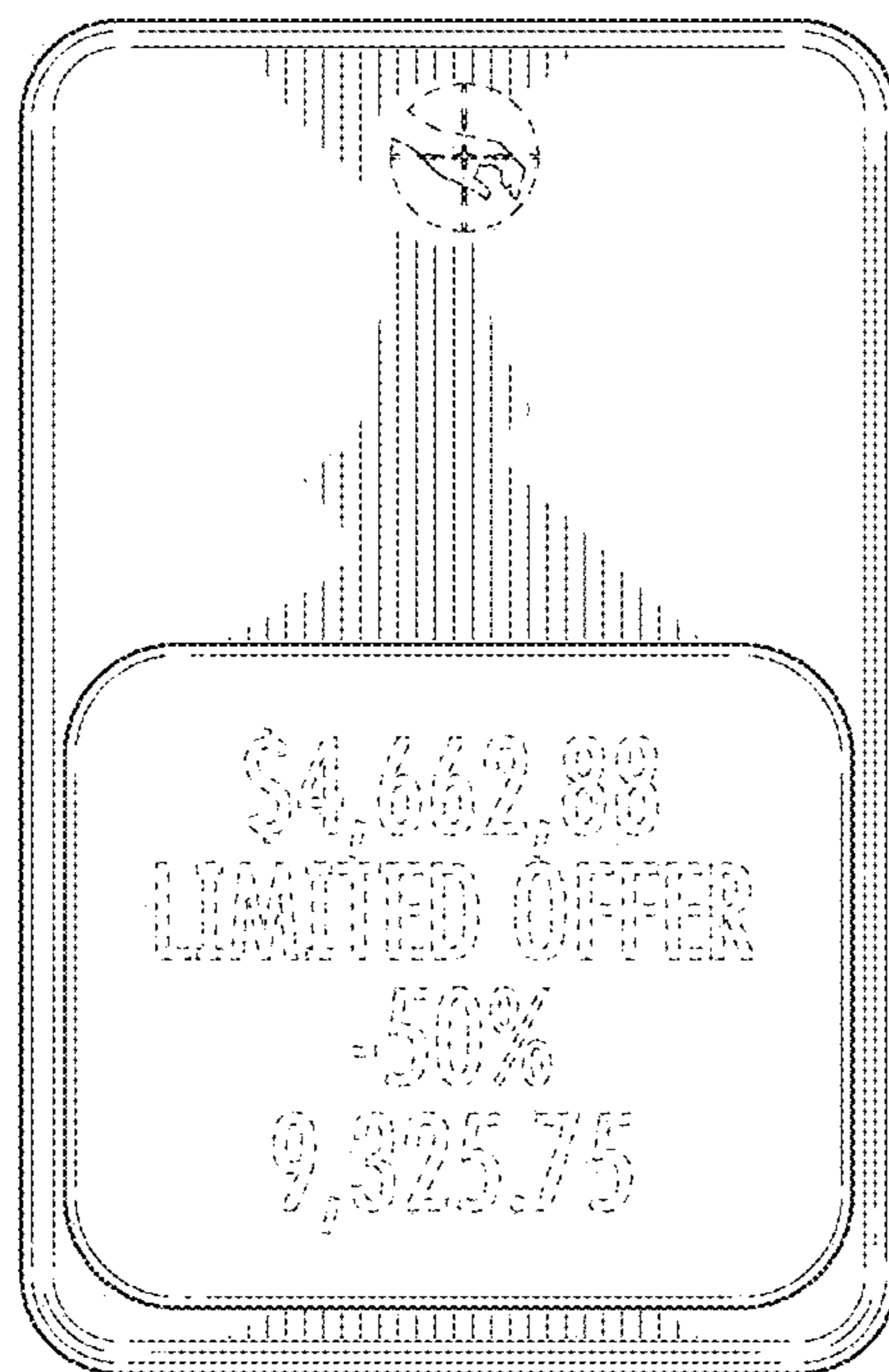

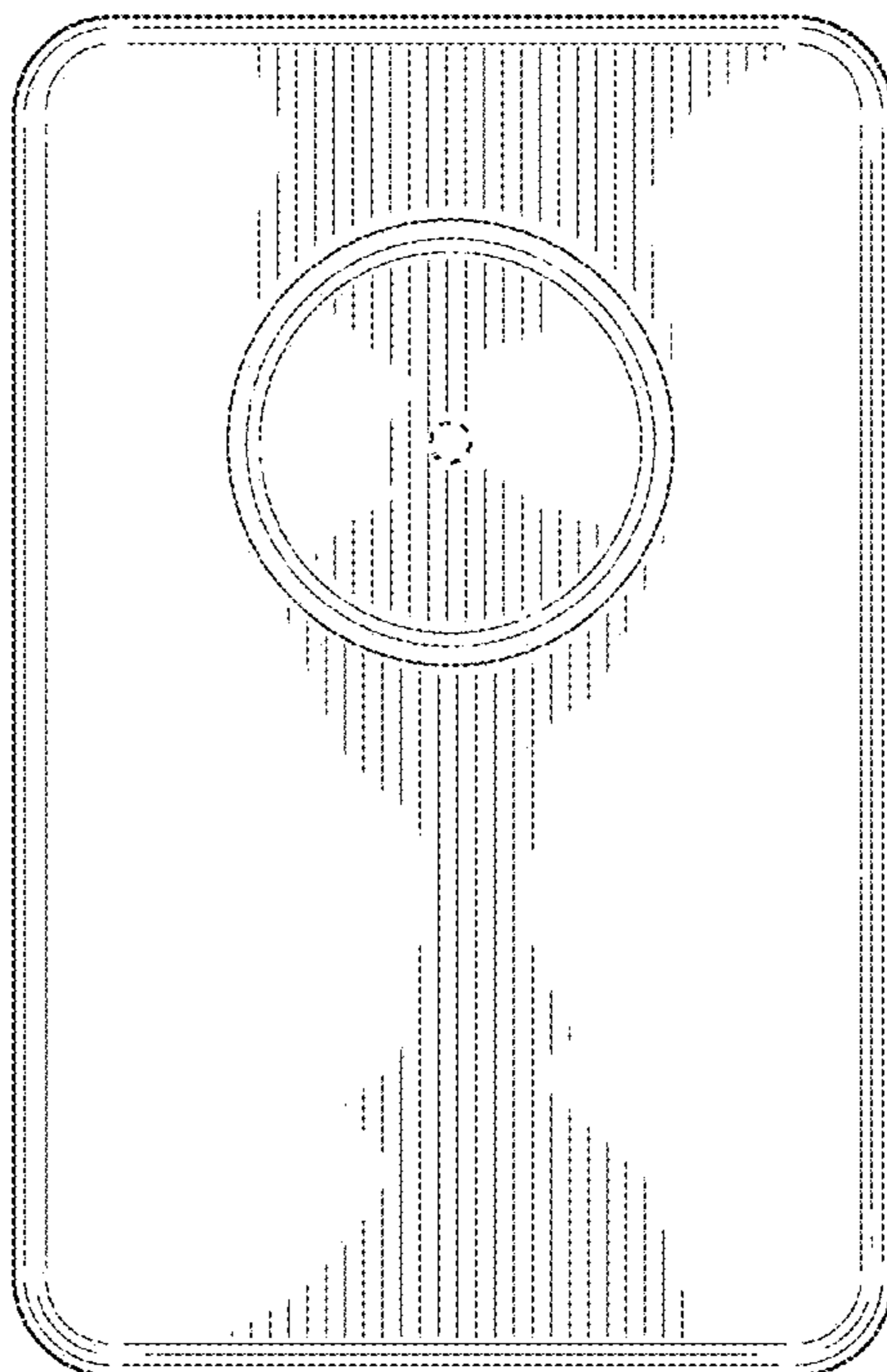

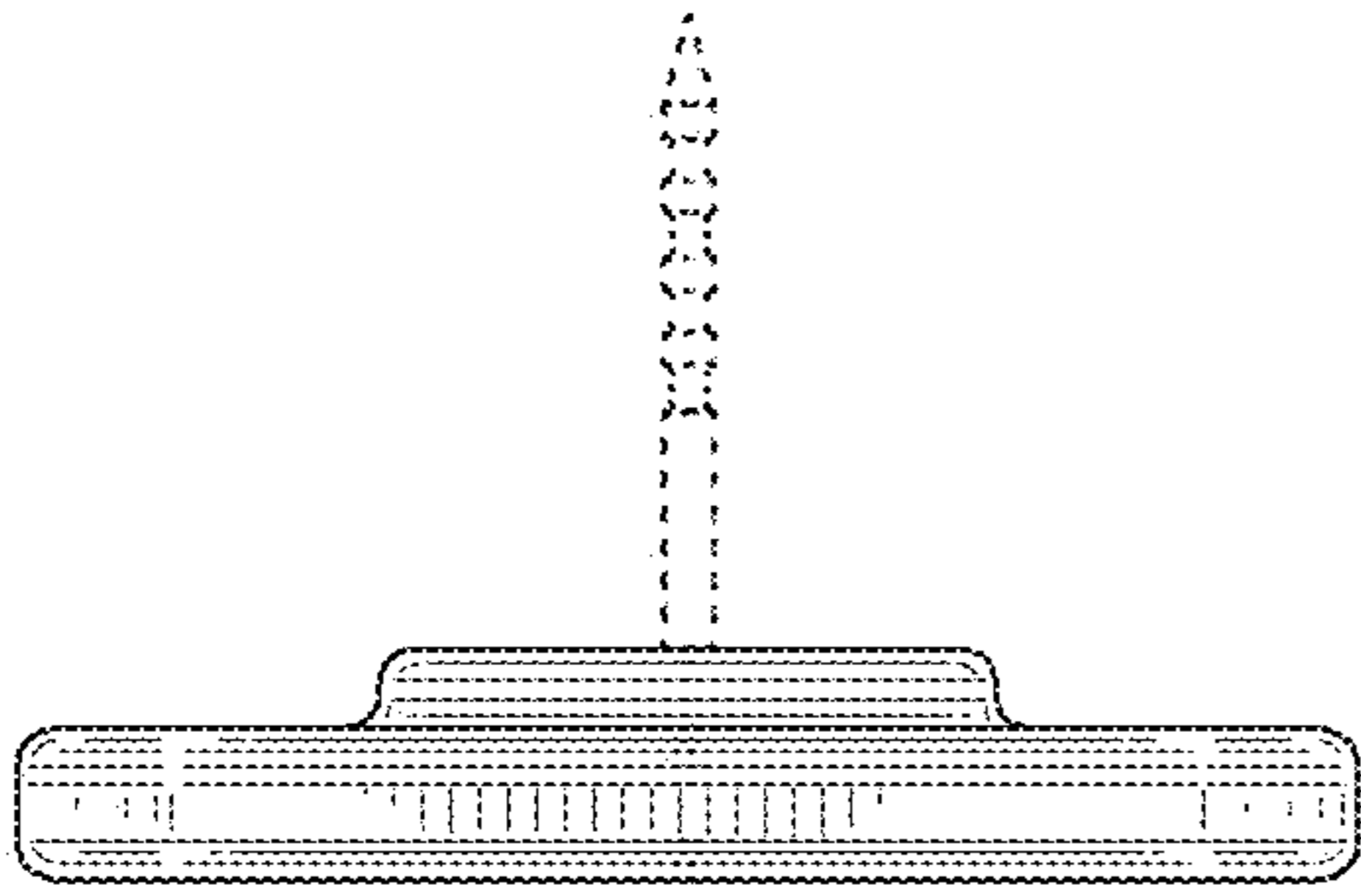

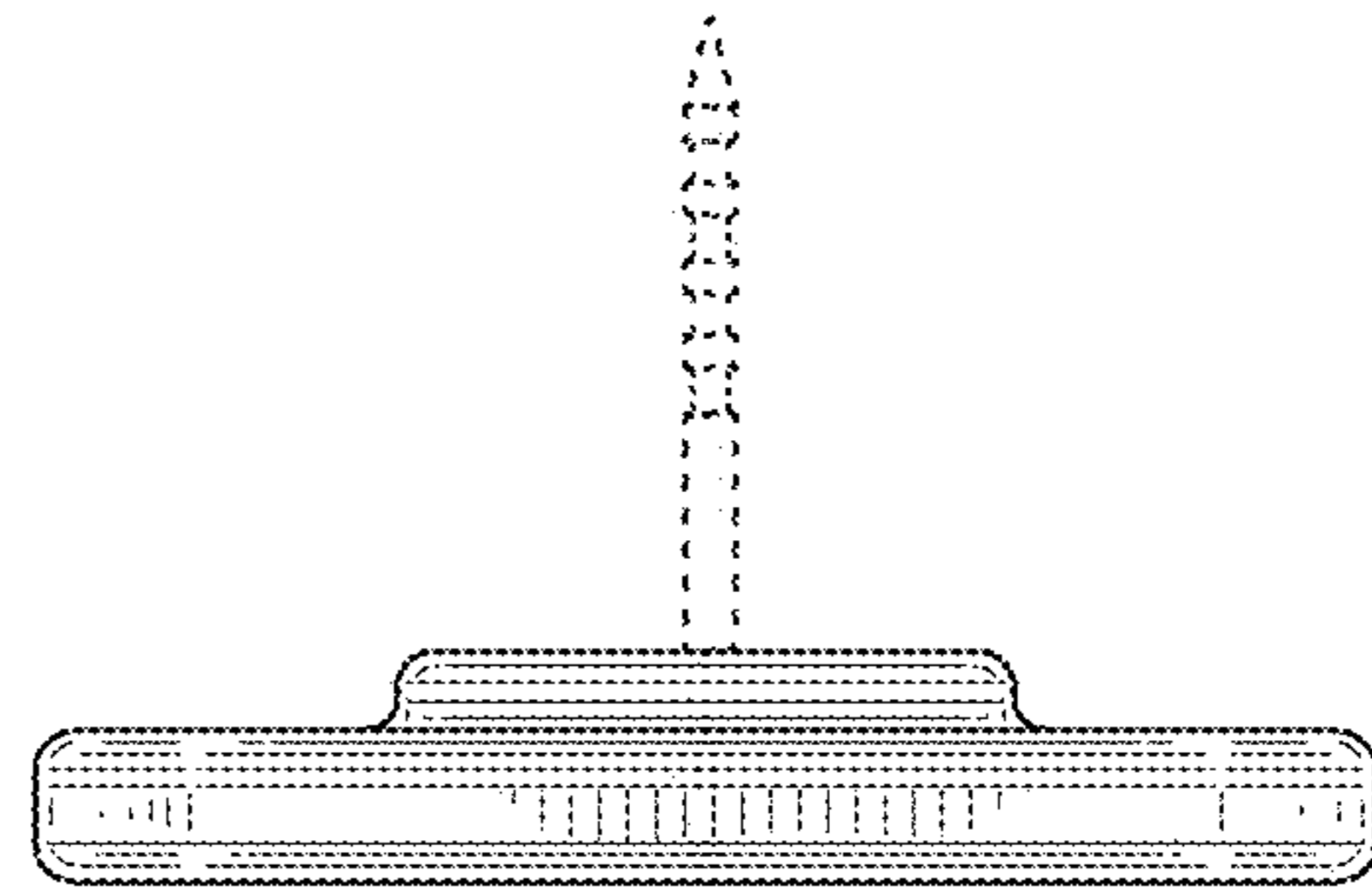

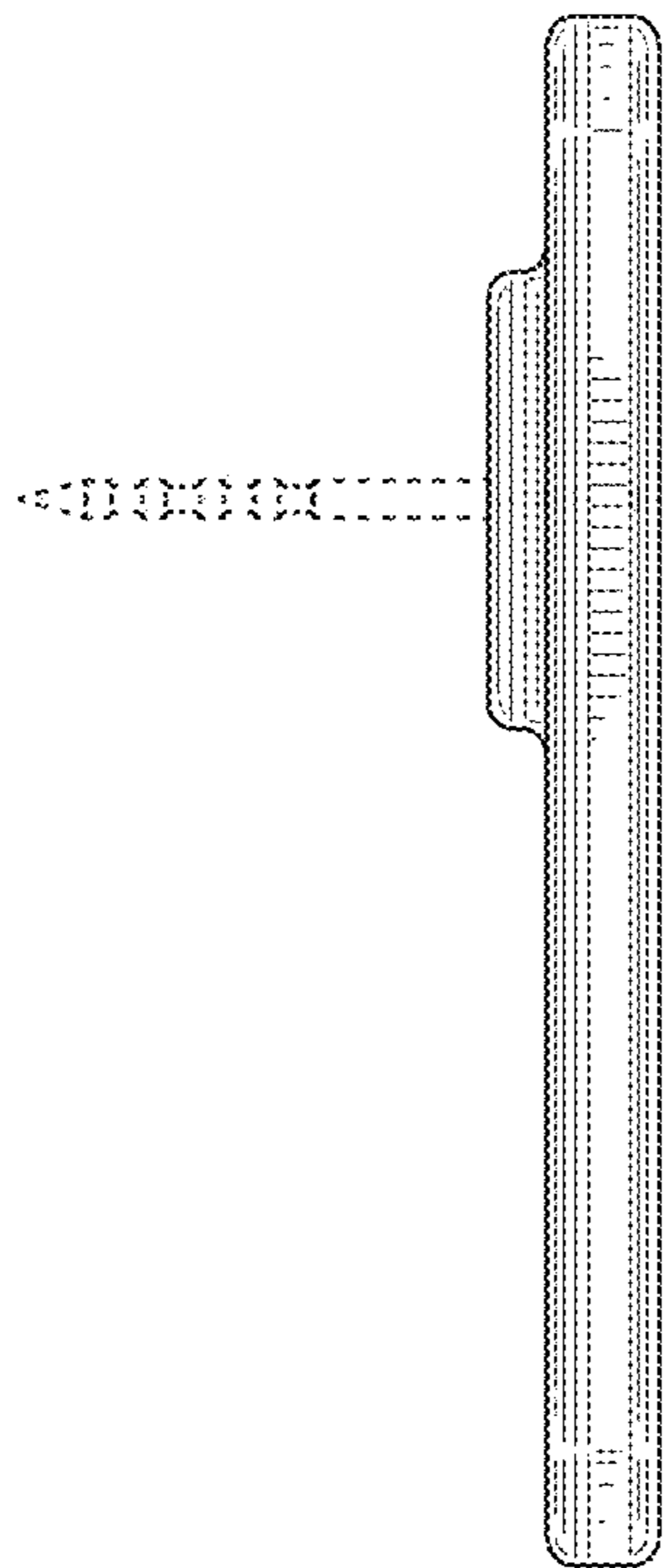

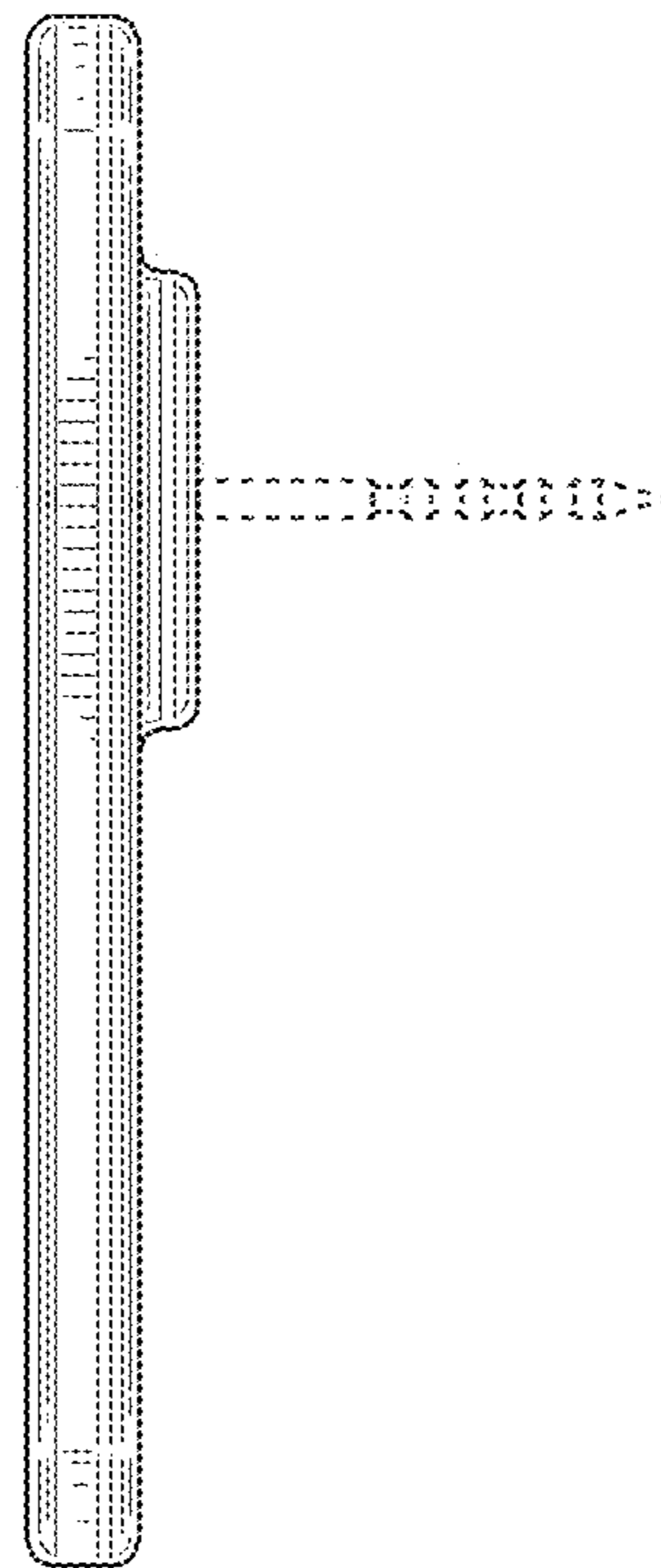
