FIG. 3 is a top view; and,

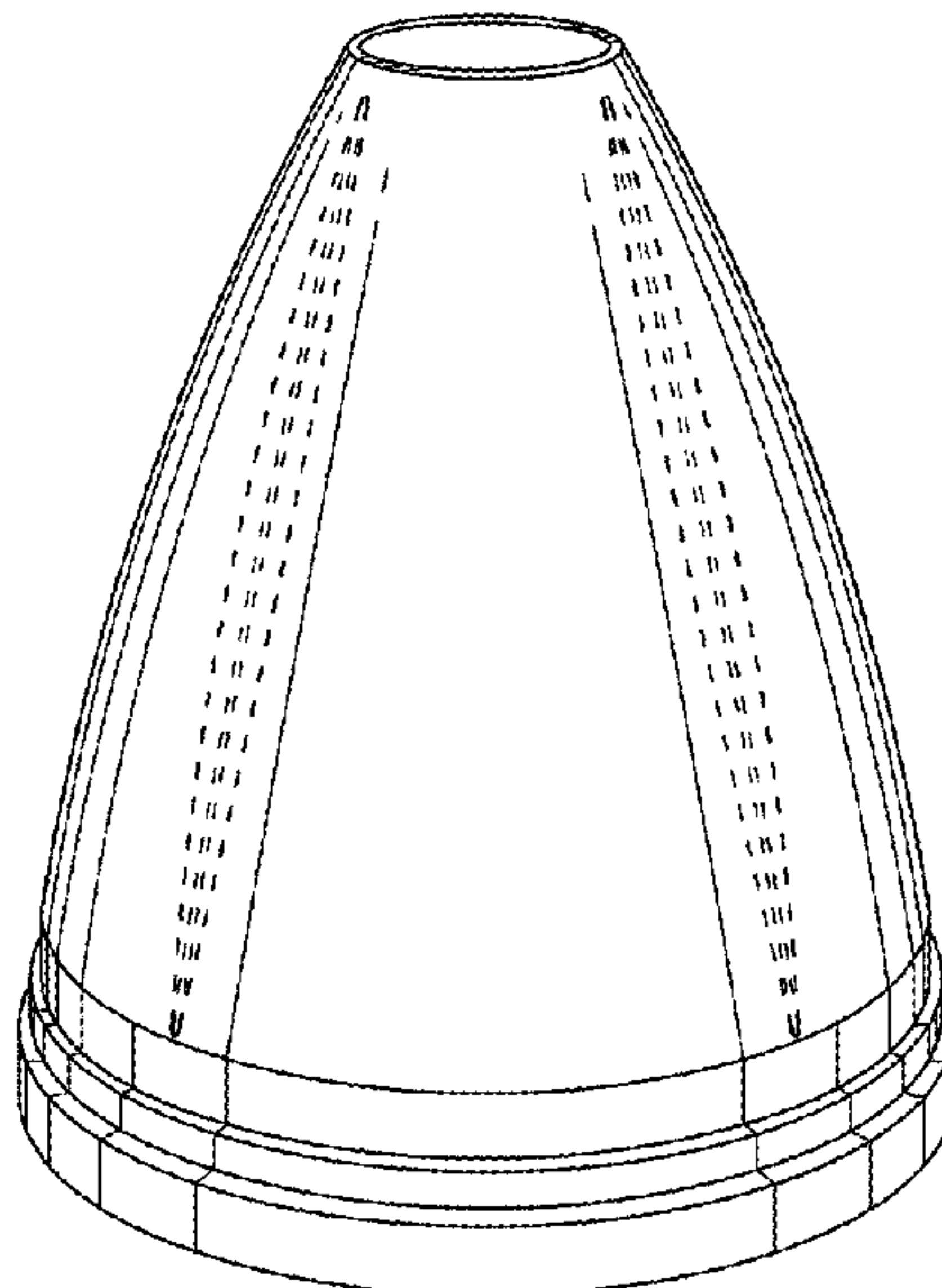
FIG. 4 is a bottom view.

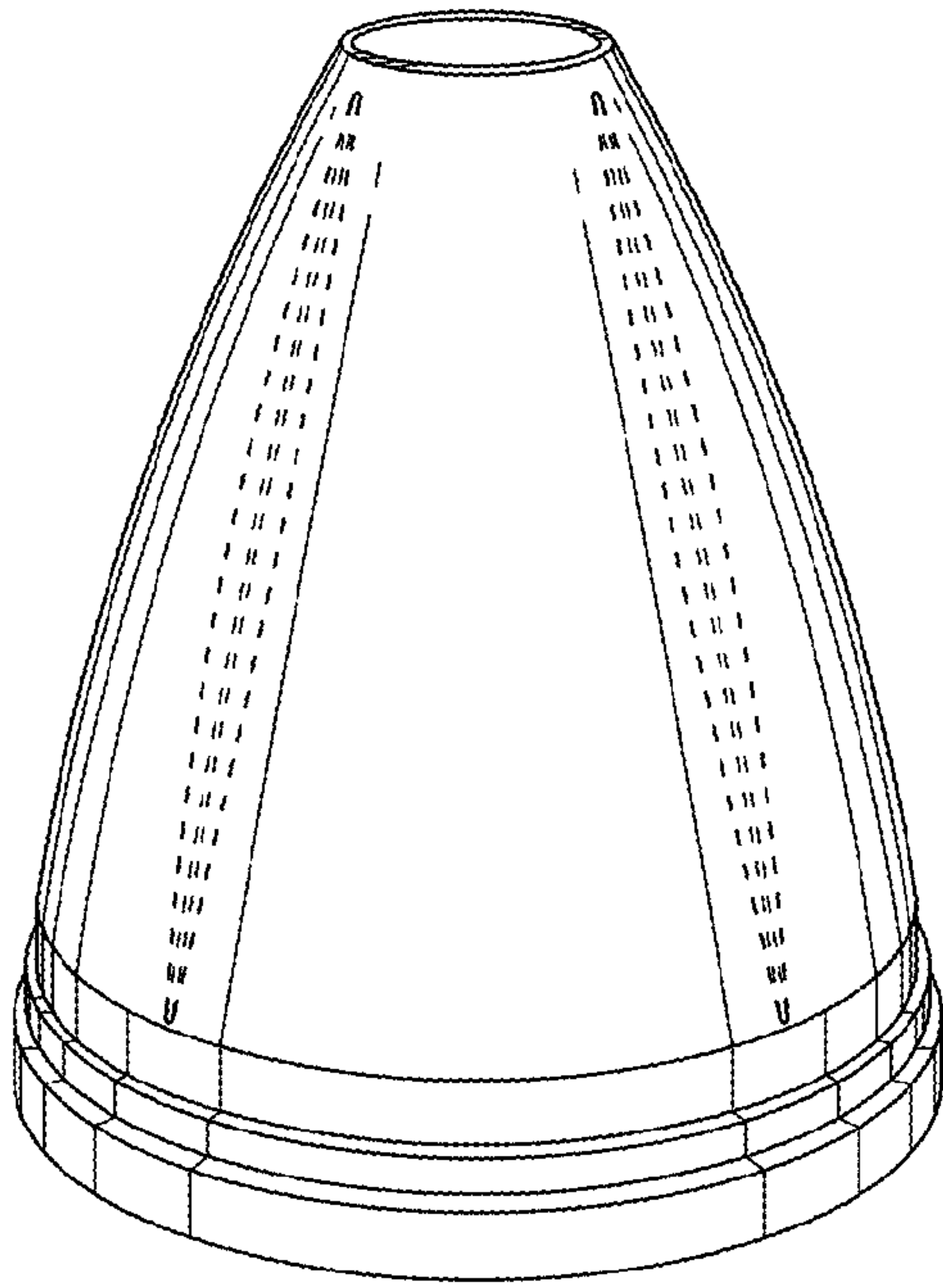

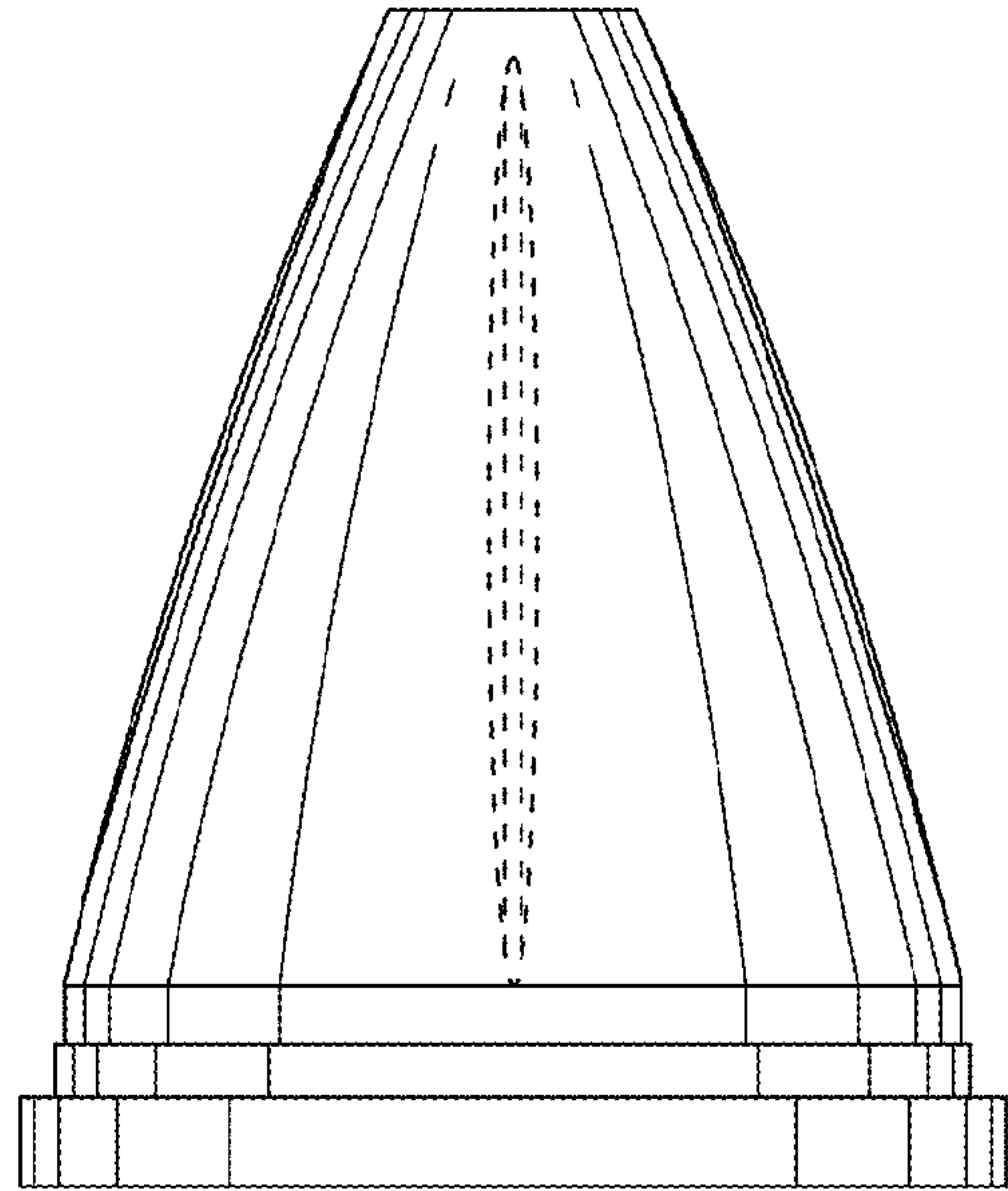

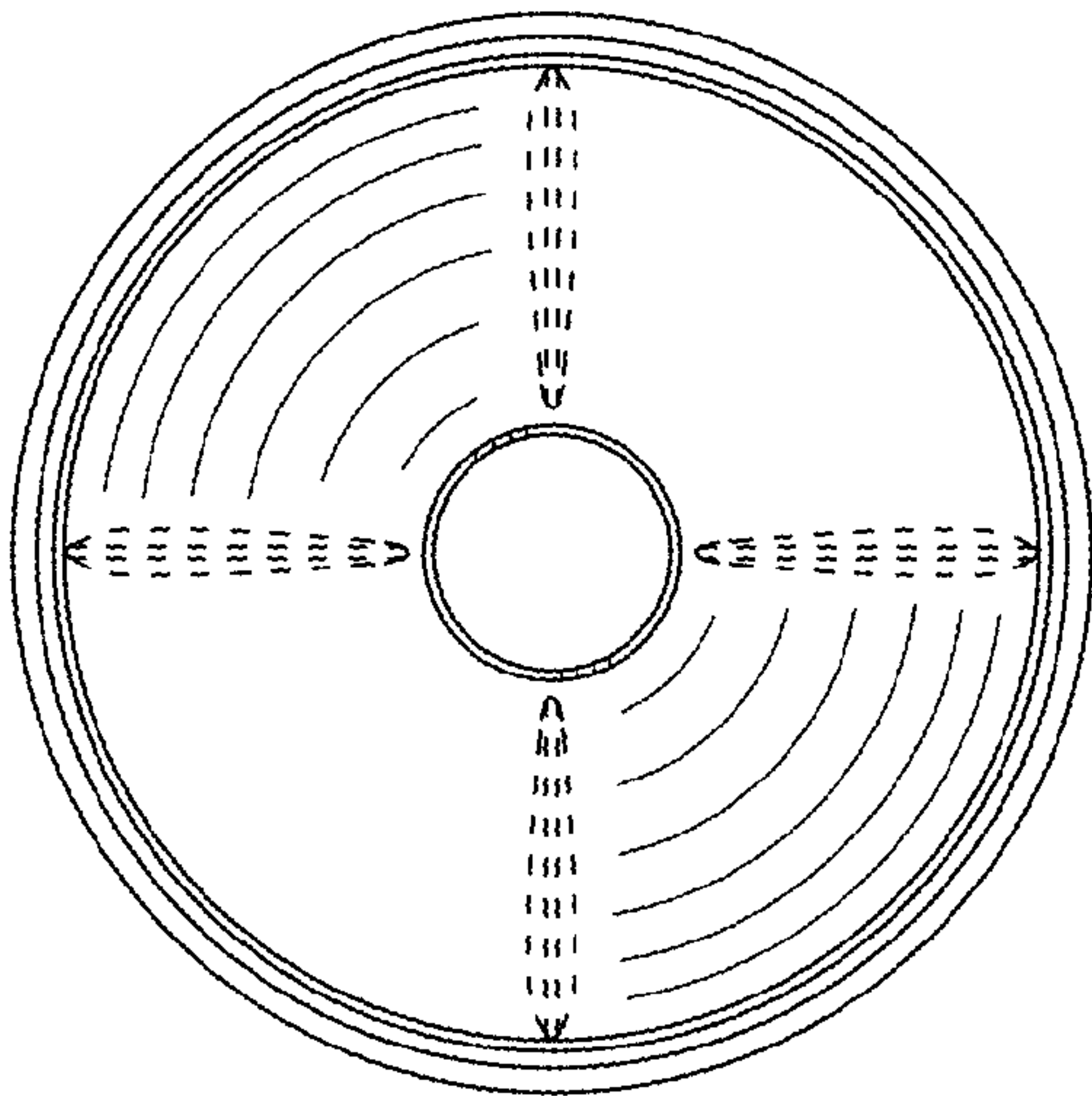

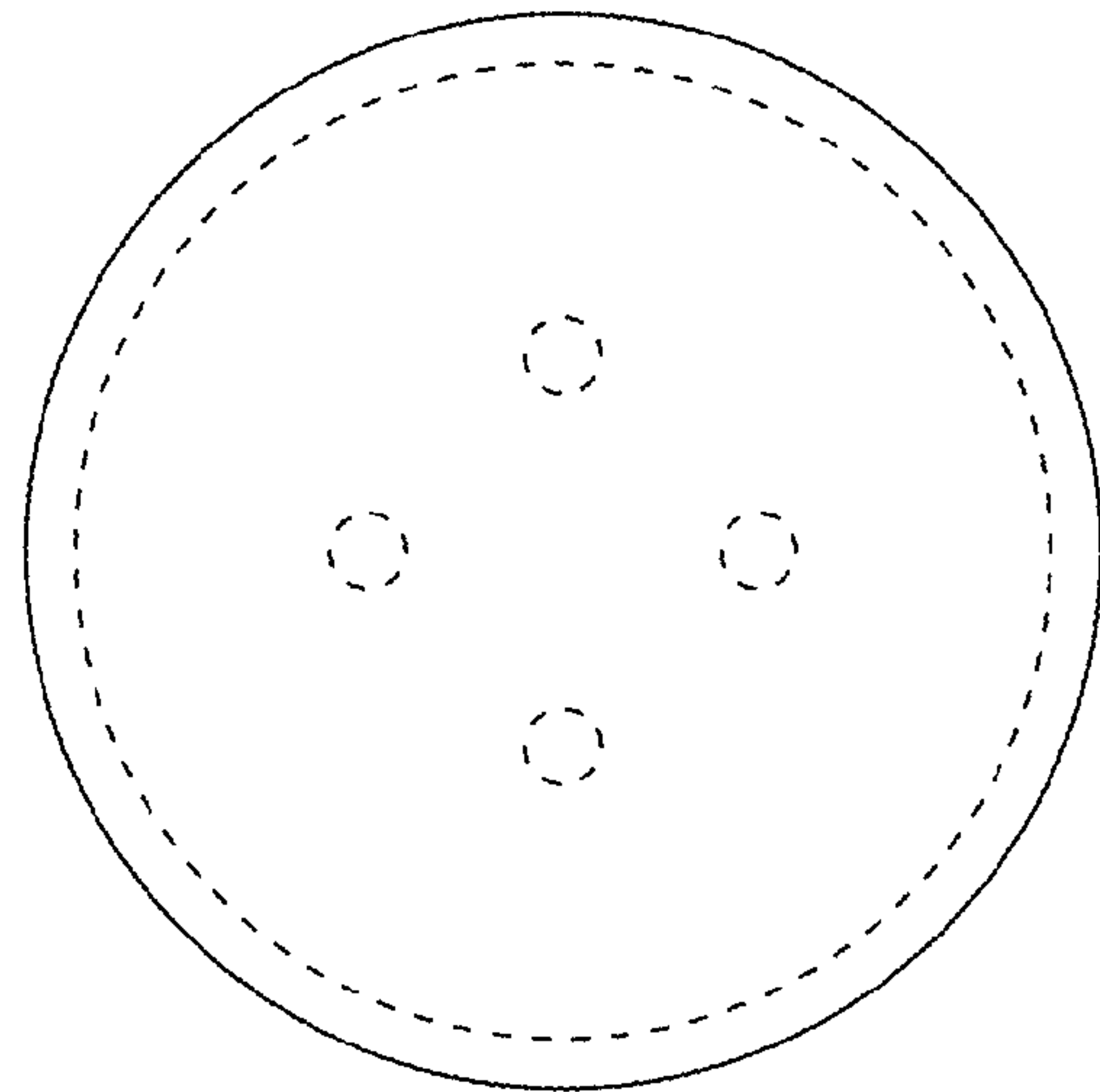
