**DESCRIPTION**

FIG. 1 is a perspective view of a jump starter showing my new design;

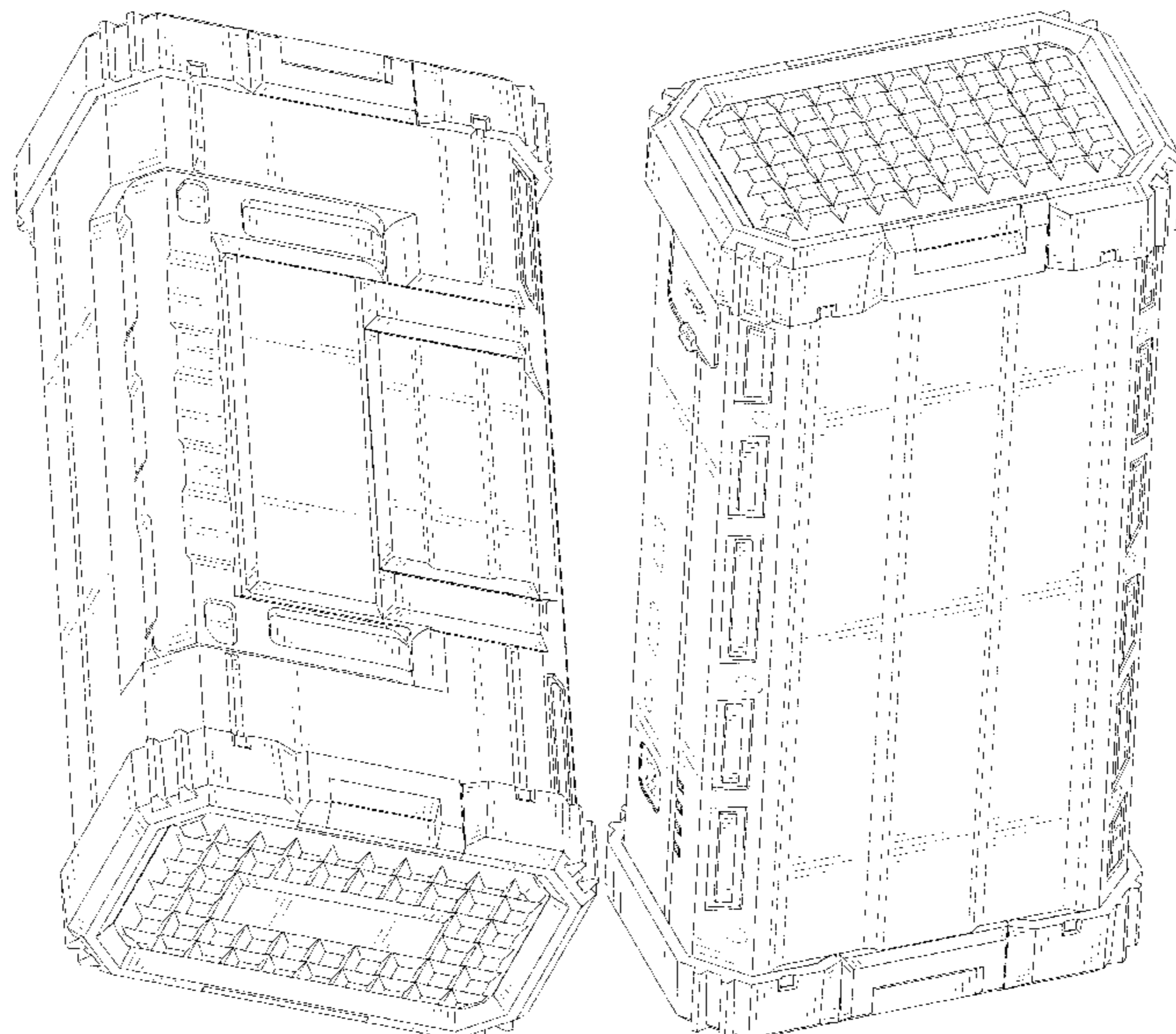

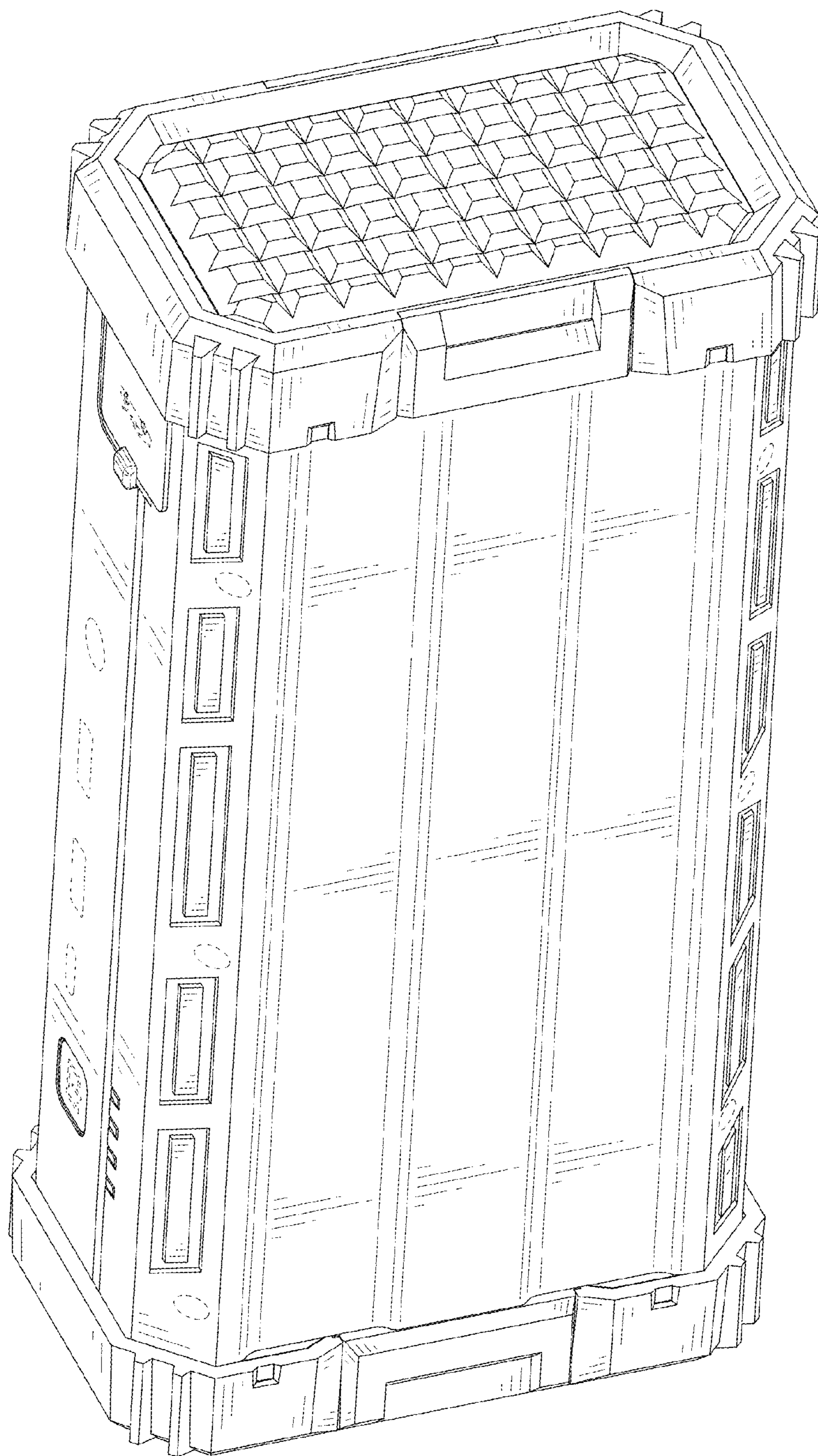

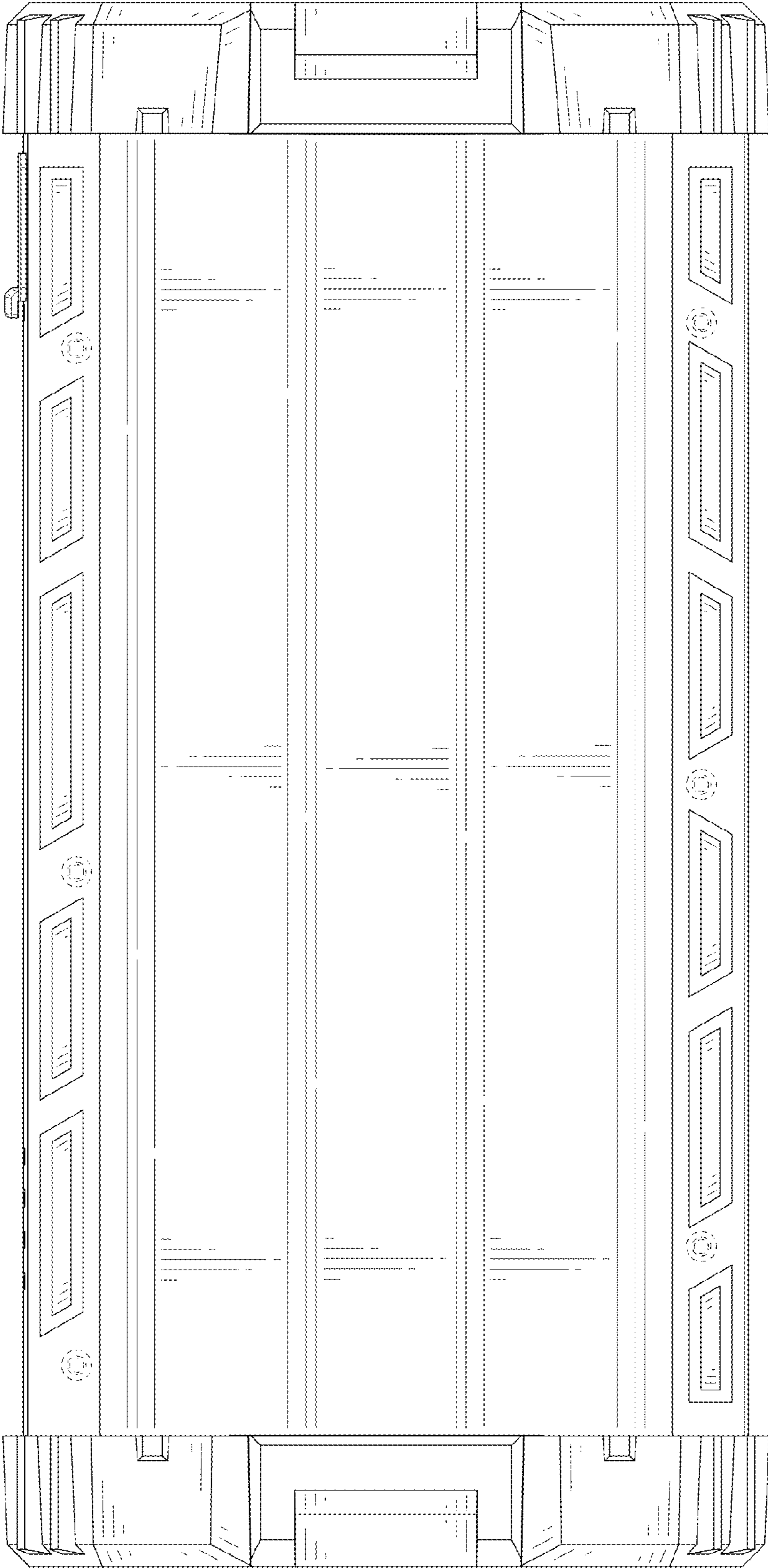

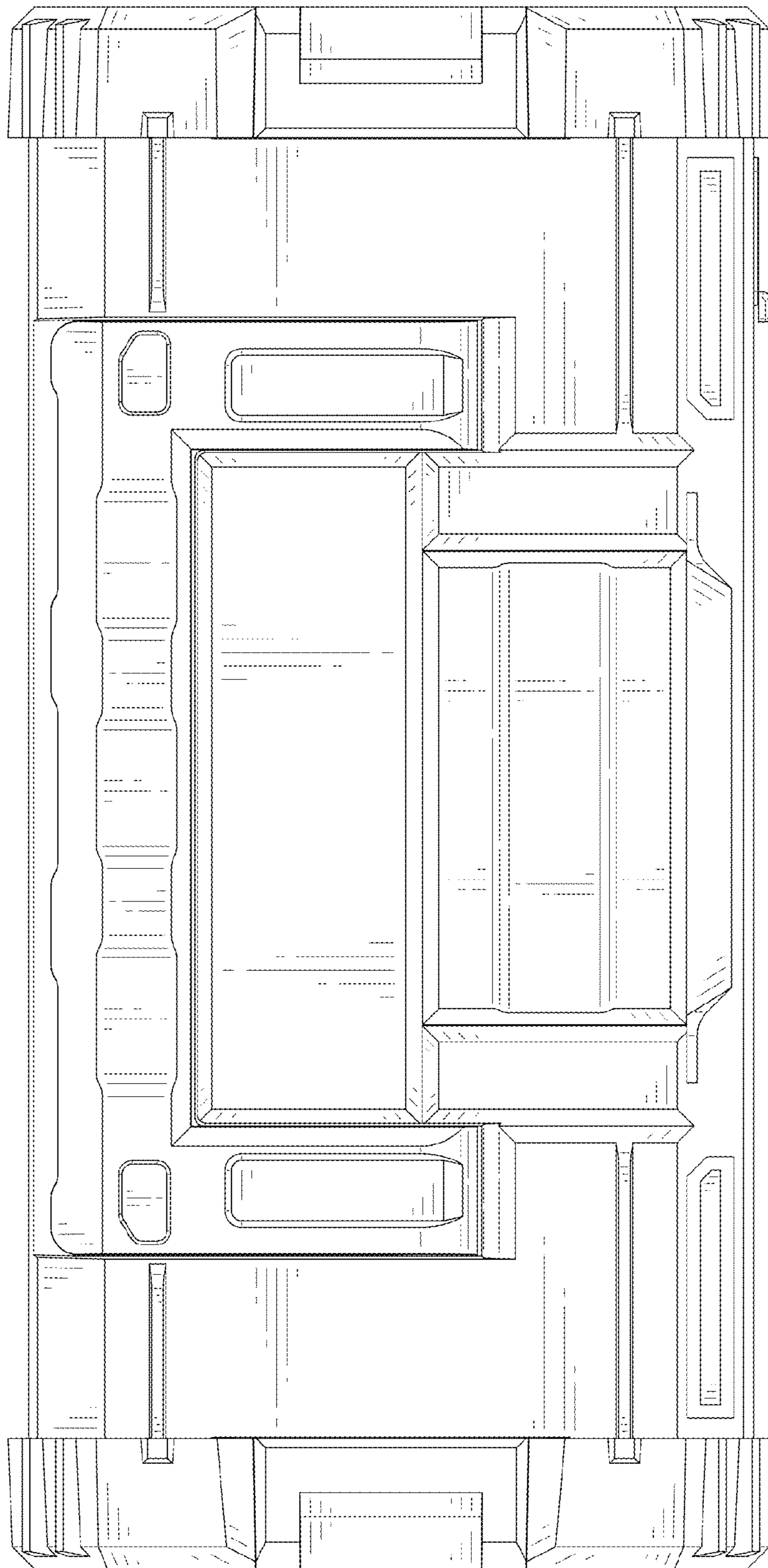

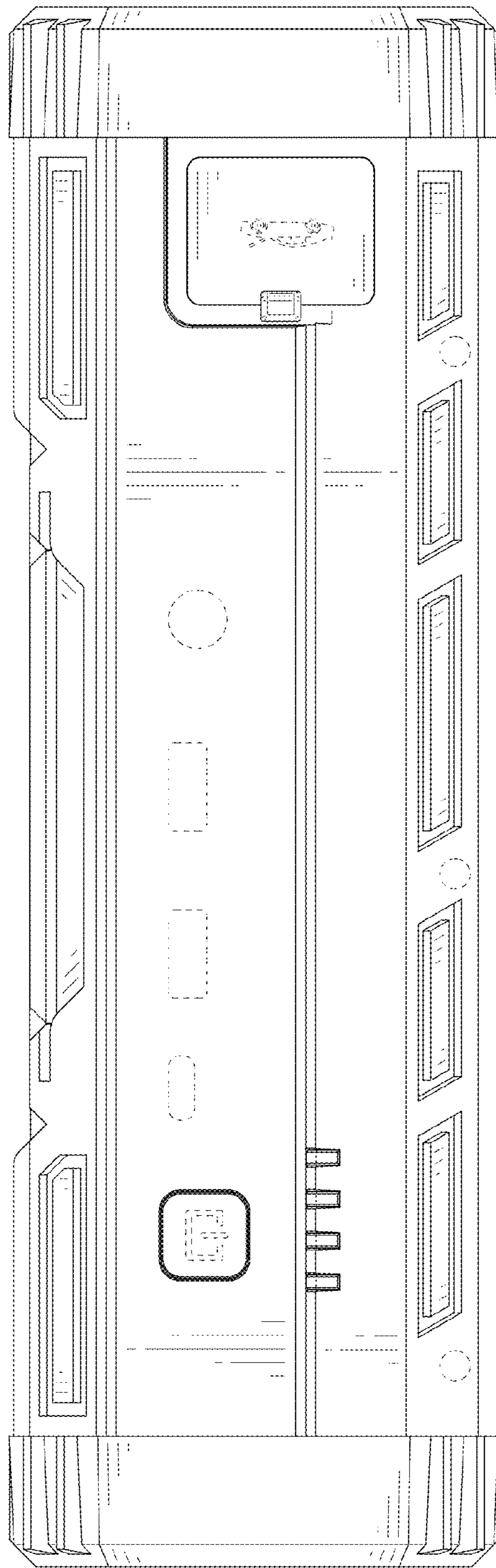

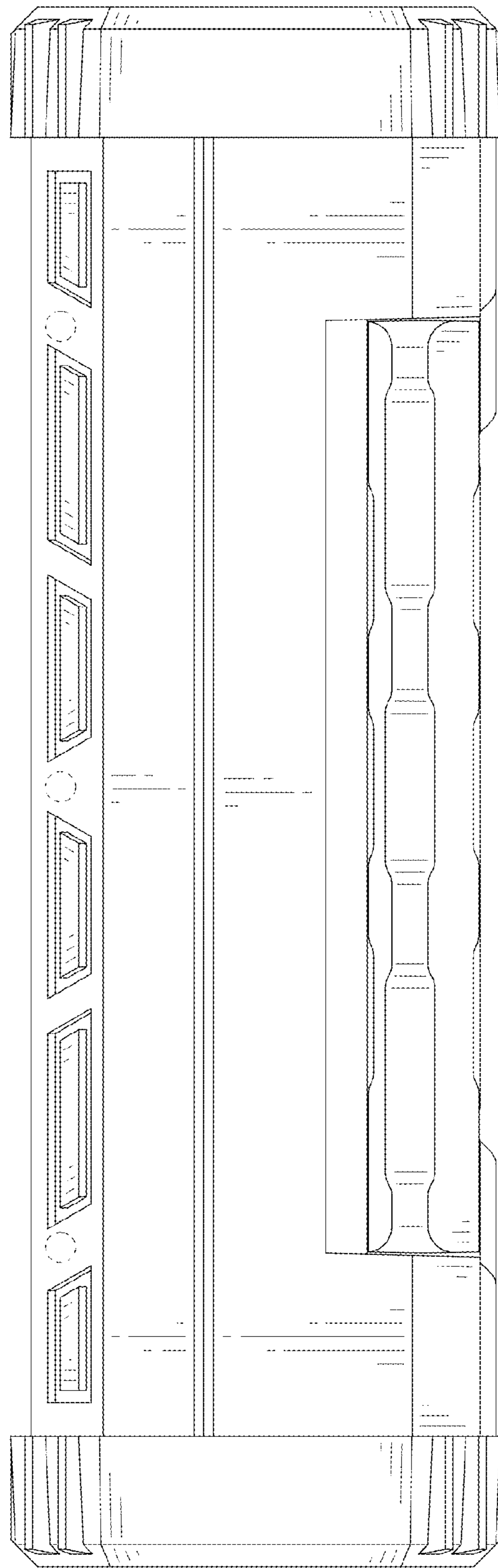

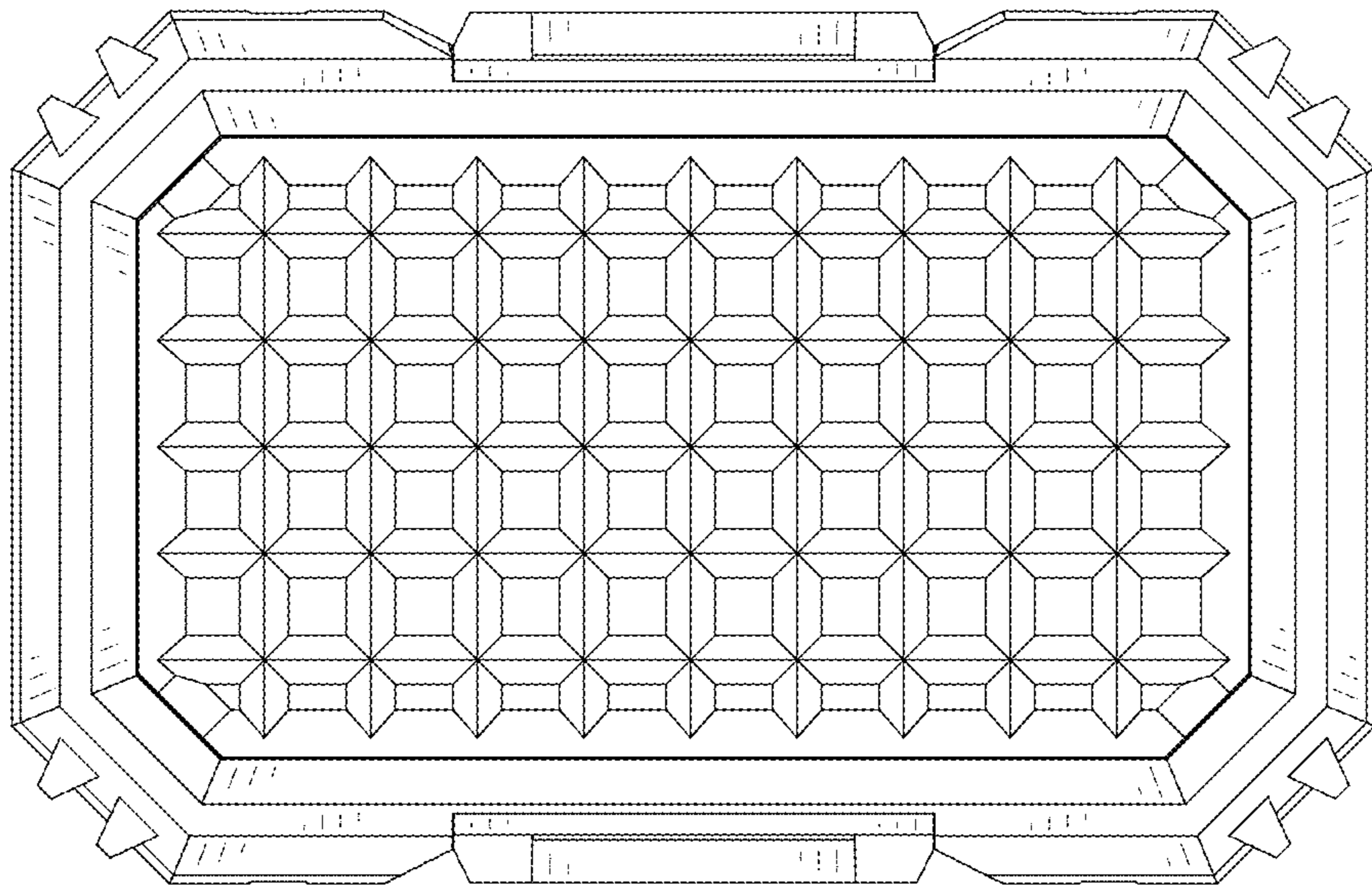

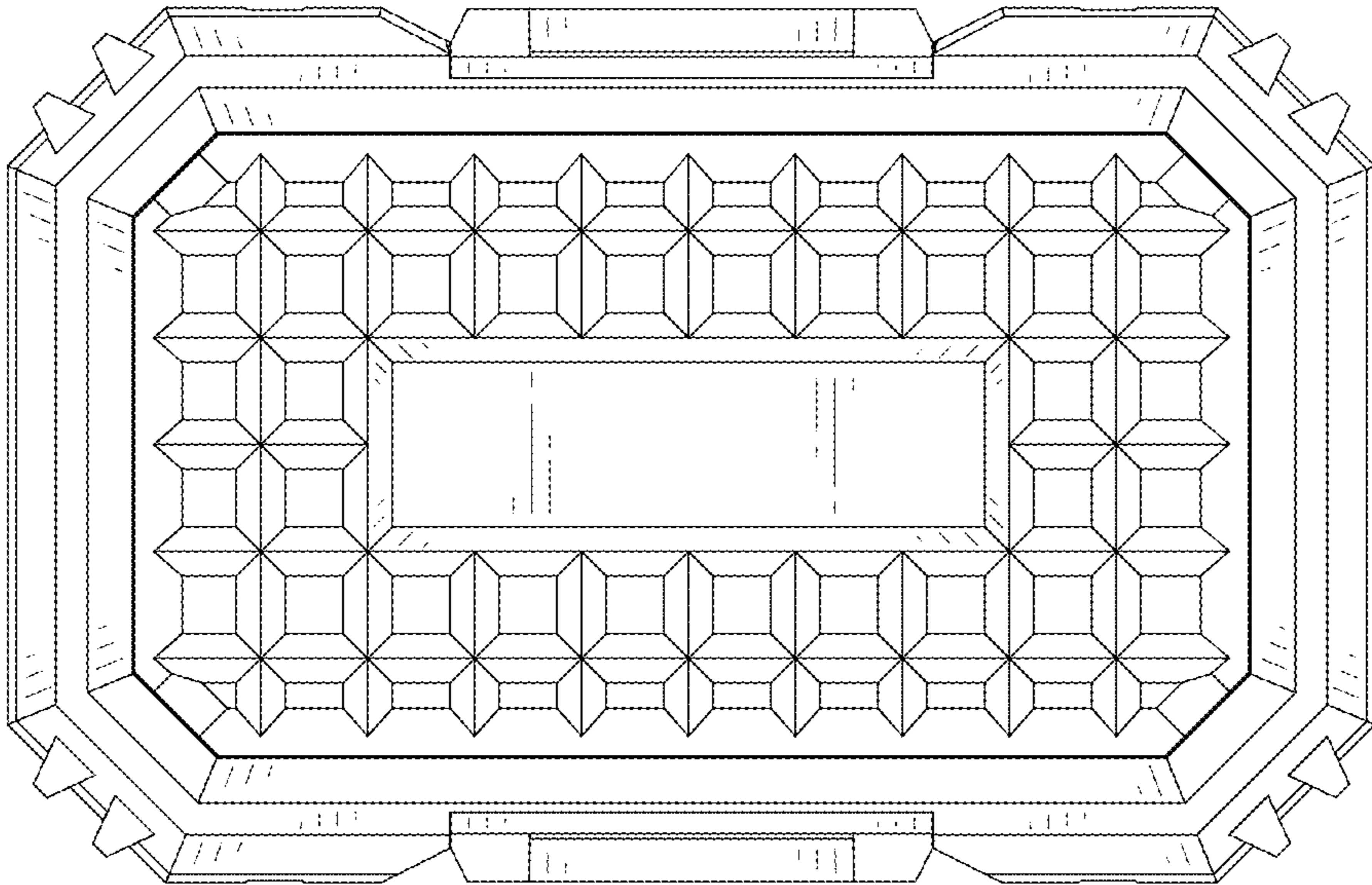
