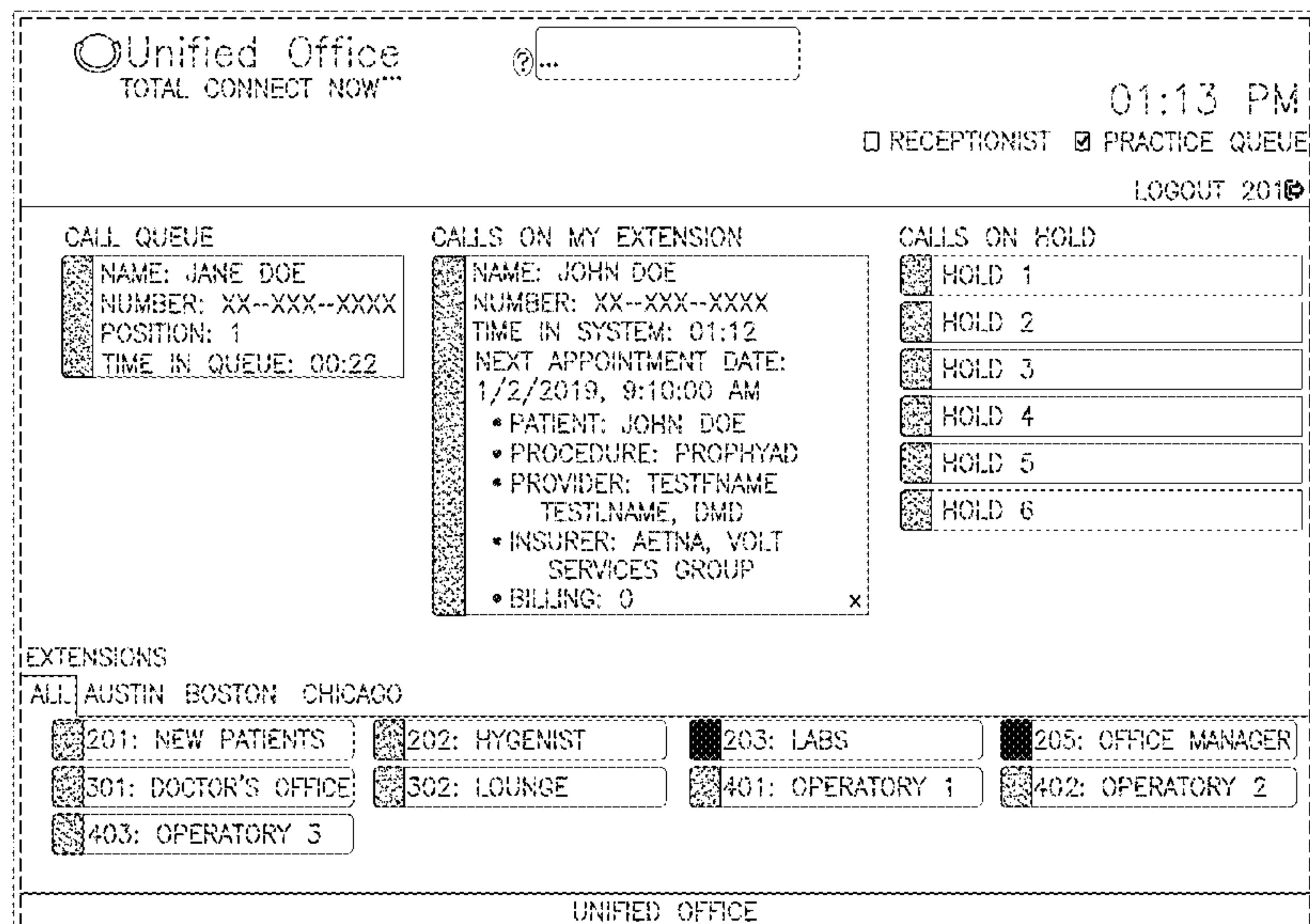
(57) **CLAIM**

What is claimed is the ornamental design for a display device having a graphical user interface, as shown and described.
