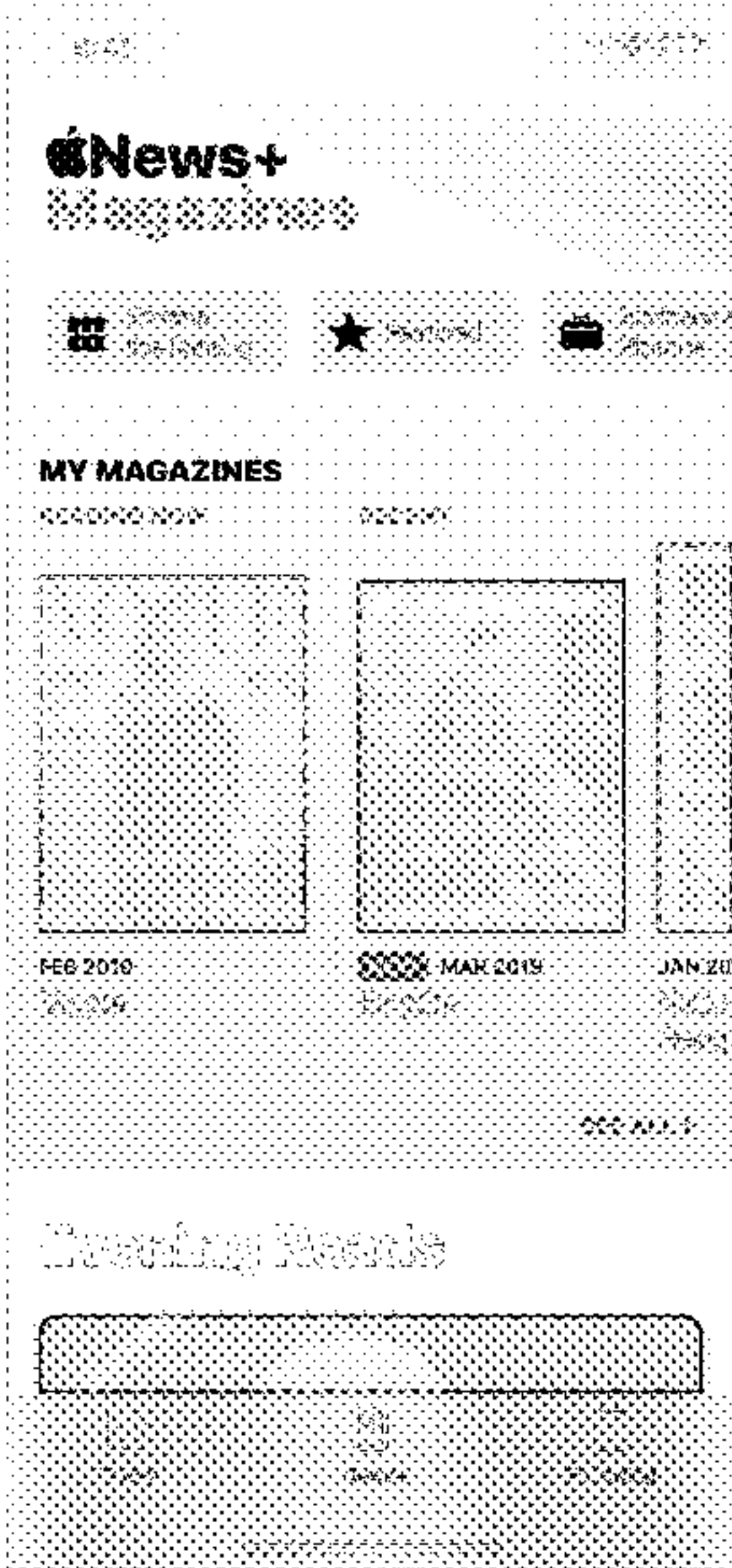
FIG. 1 is a front view of art electronic device with graphical user interface showing the claimed design; and, FIG. 2 is another embodiment thereof.

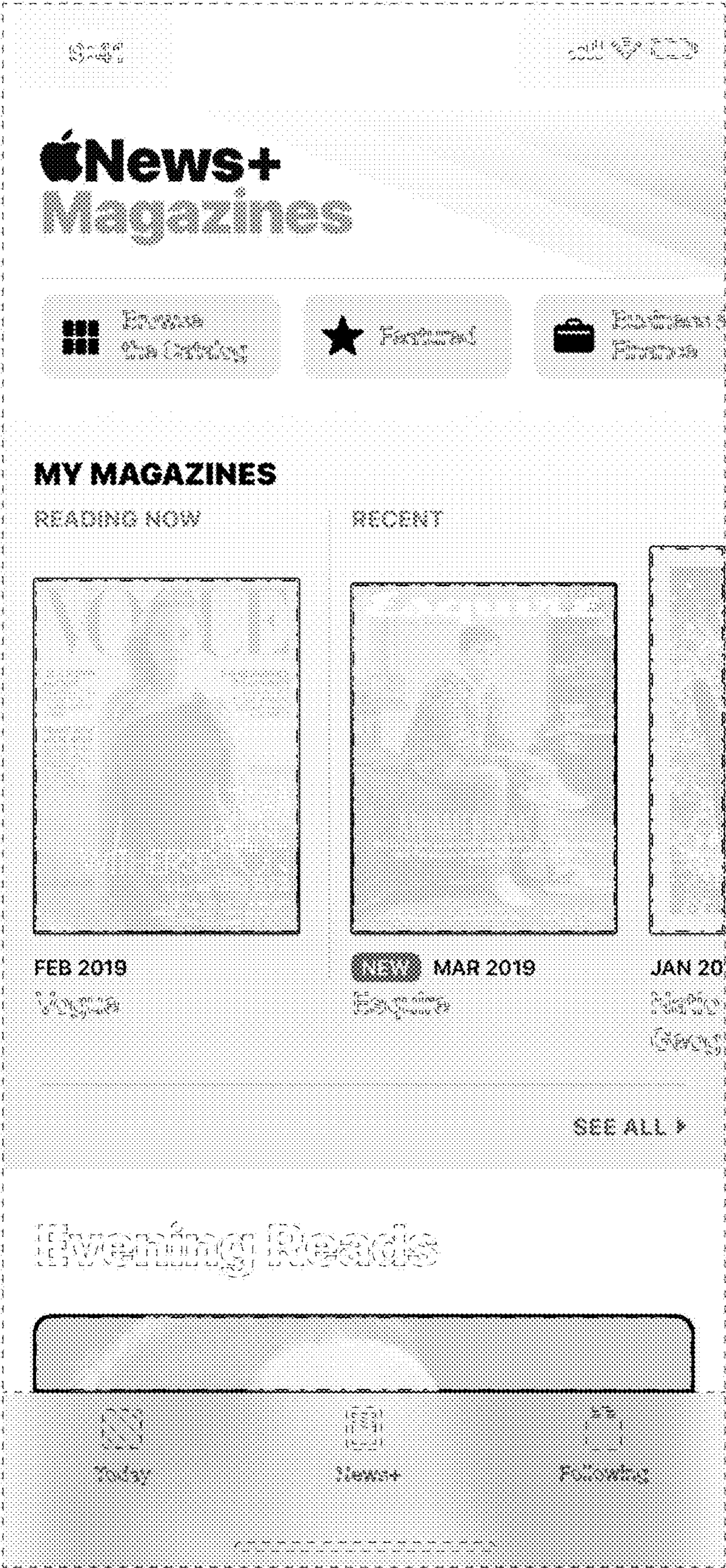
