FIG. 8 is a third image thereof;

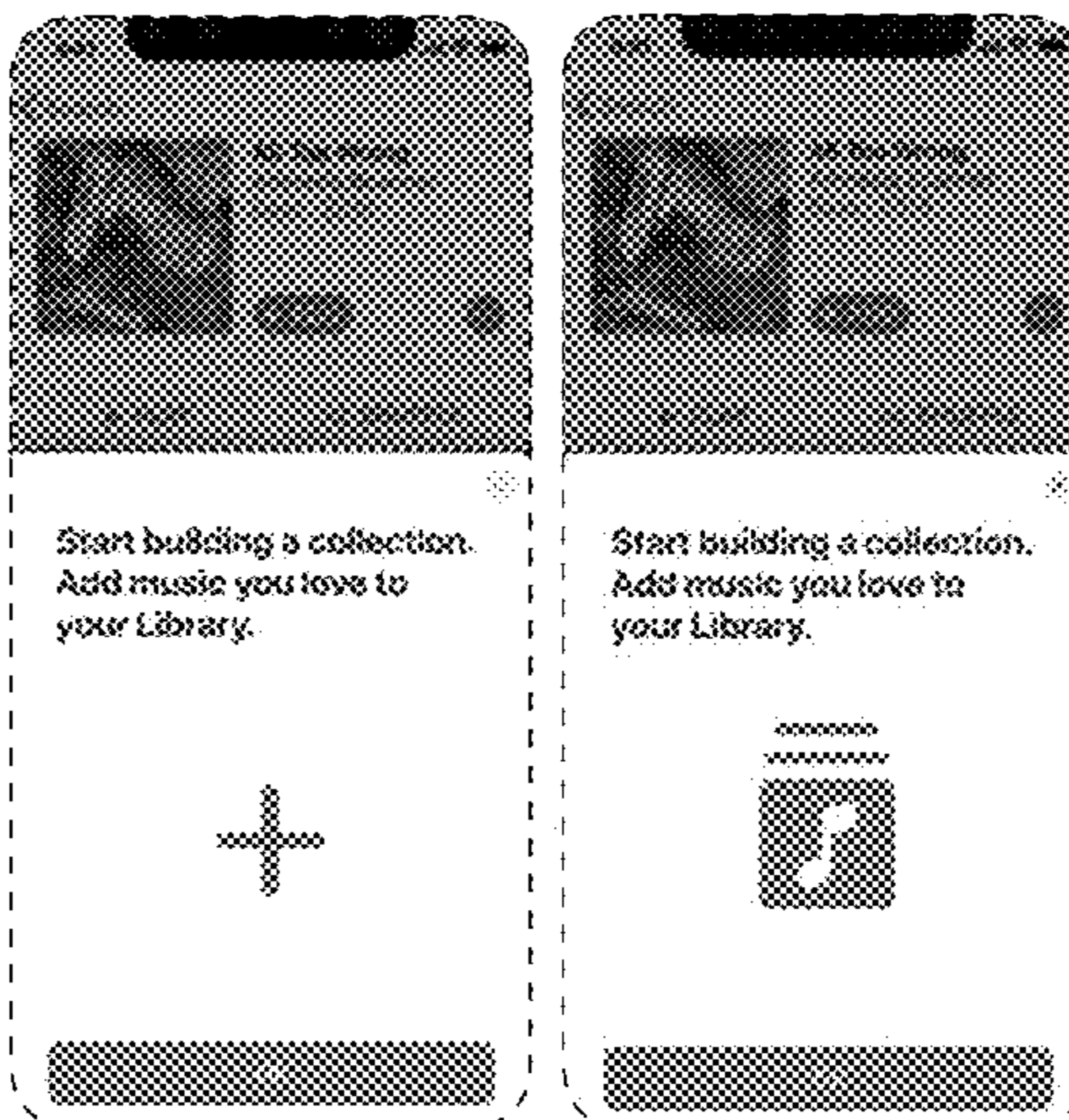
FIG. 9 is a fourth image thereof; and,

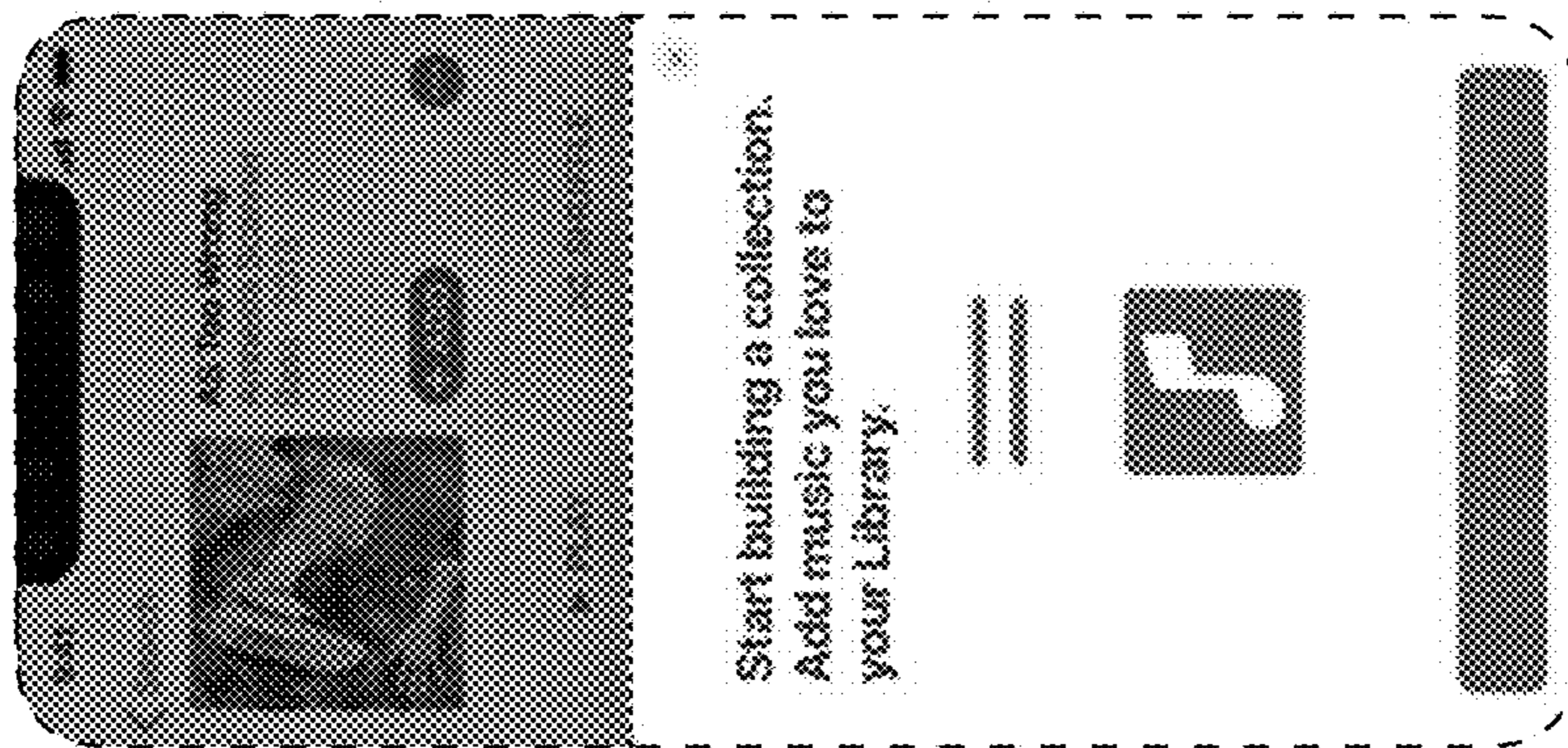

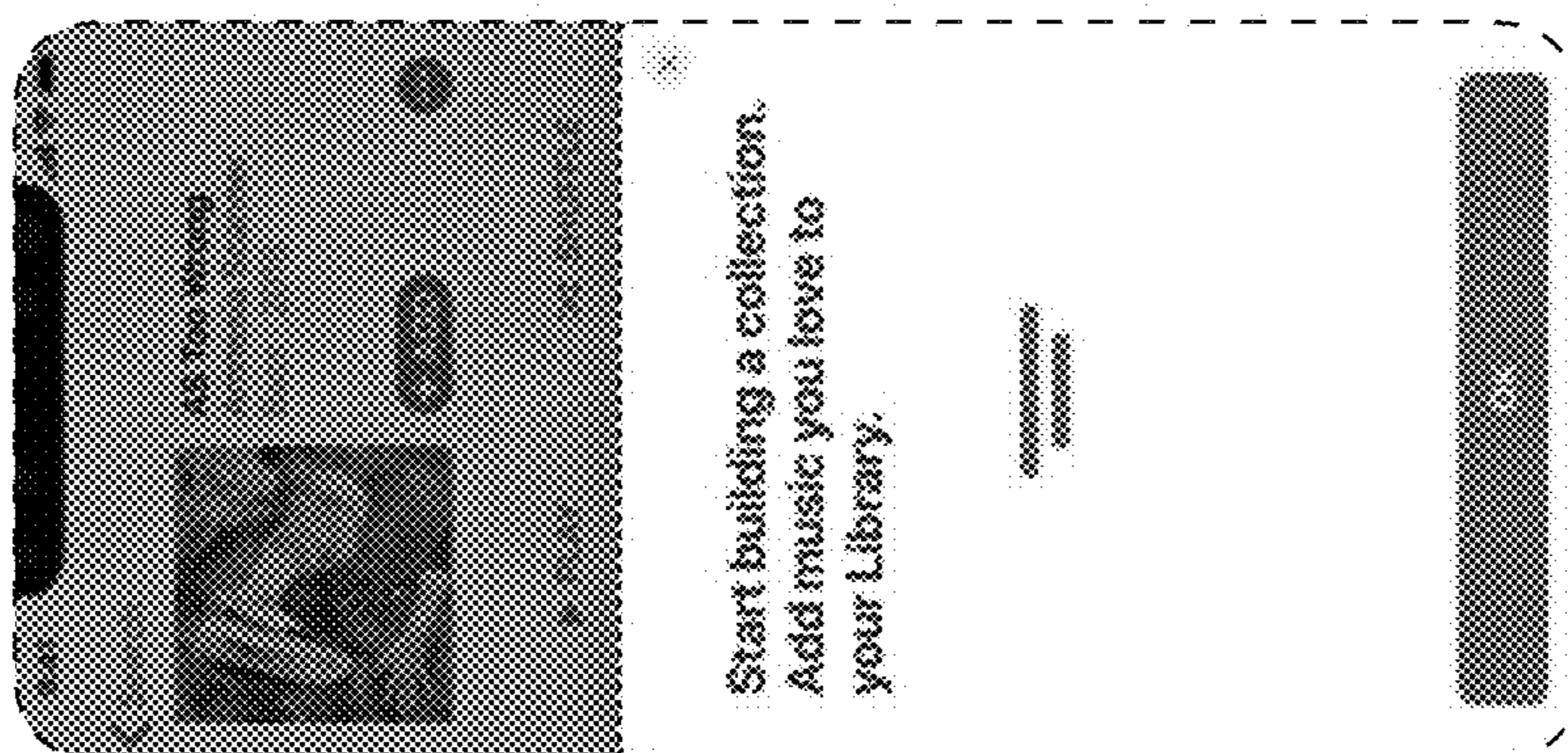

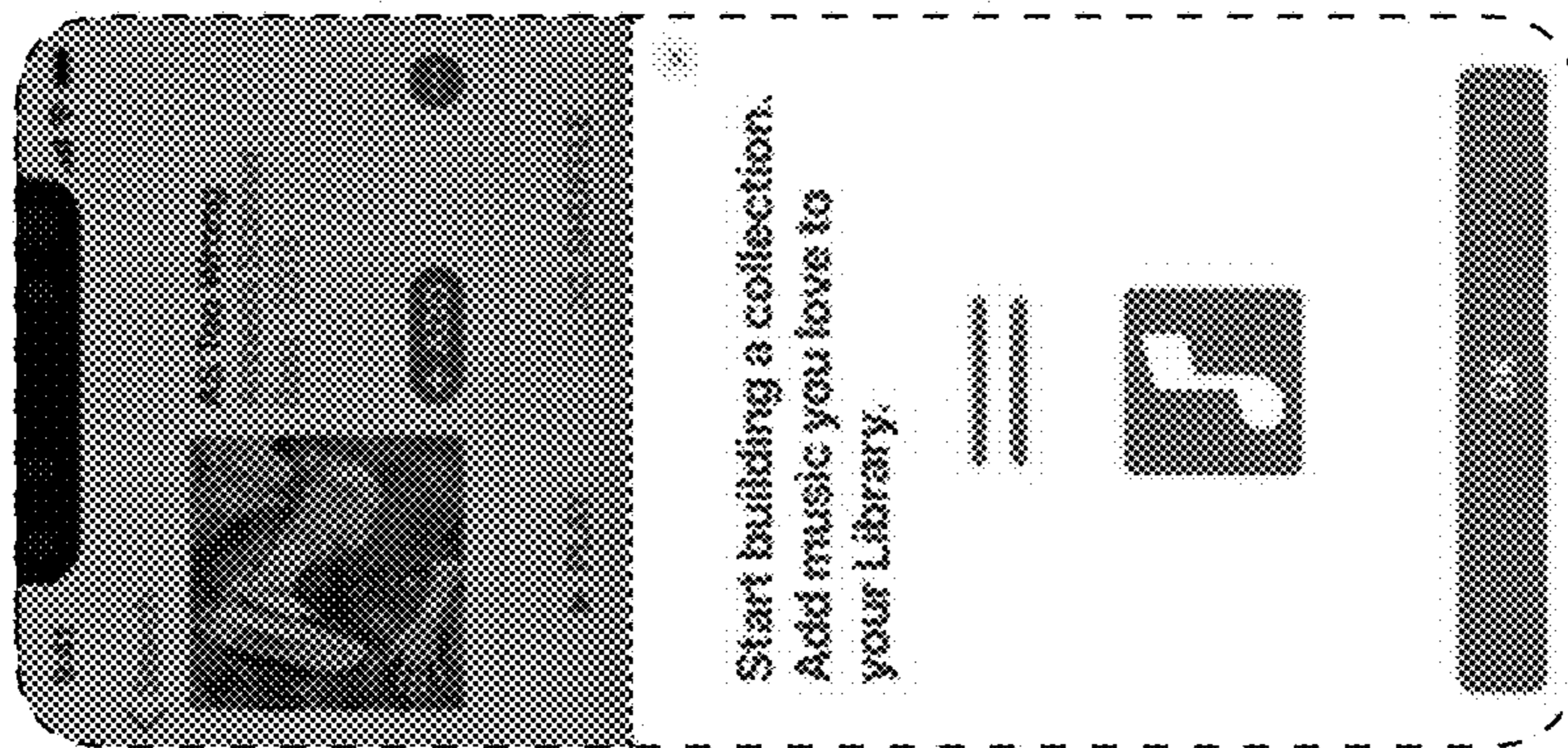

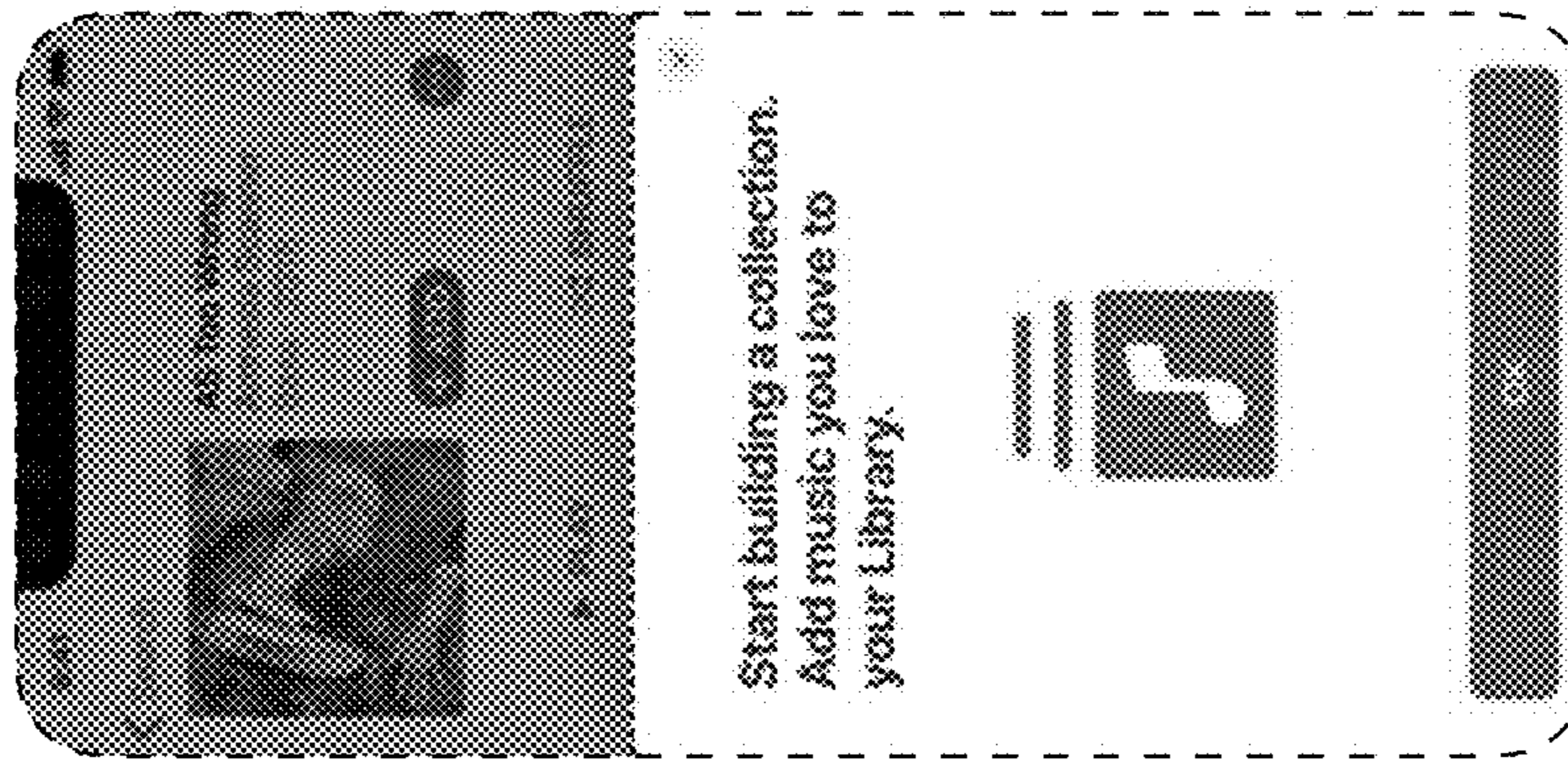

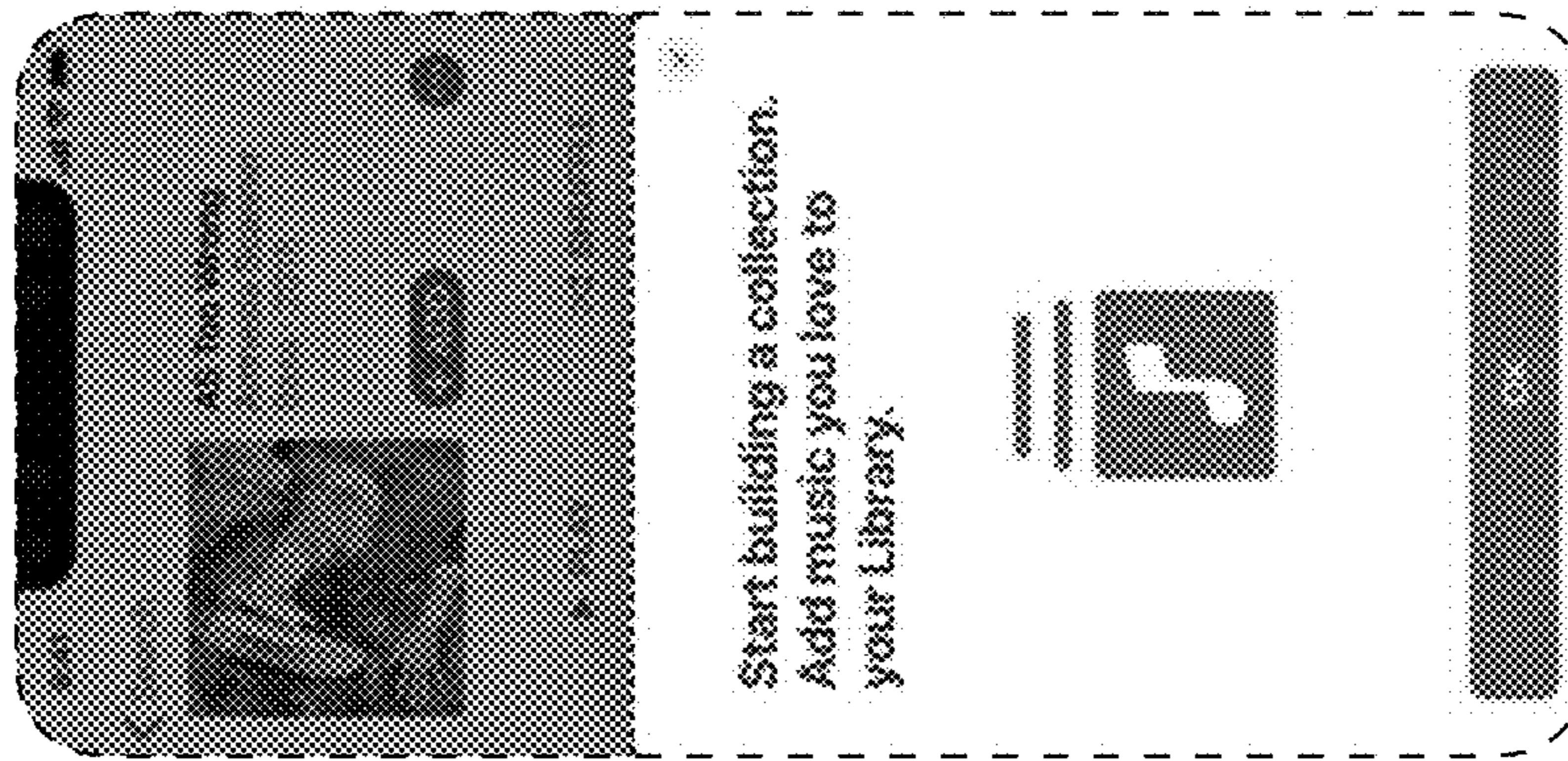

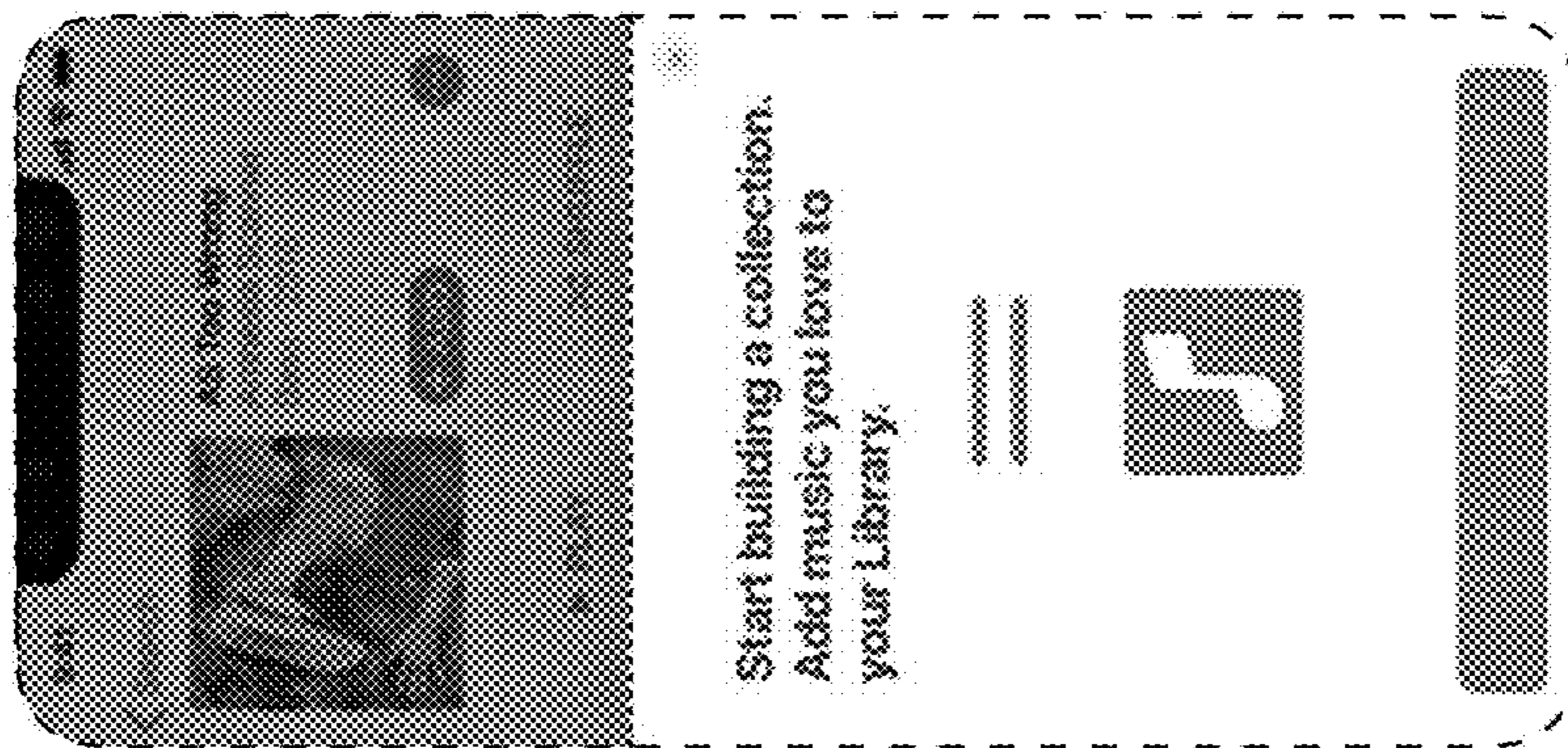

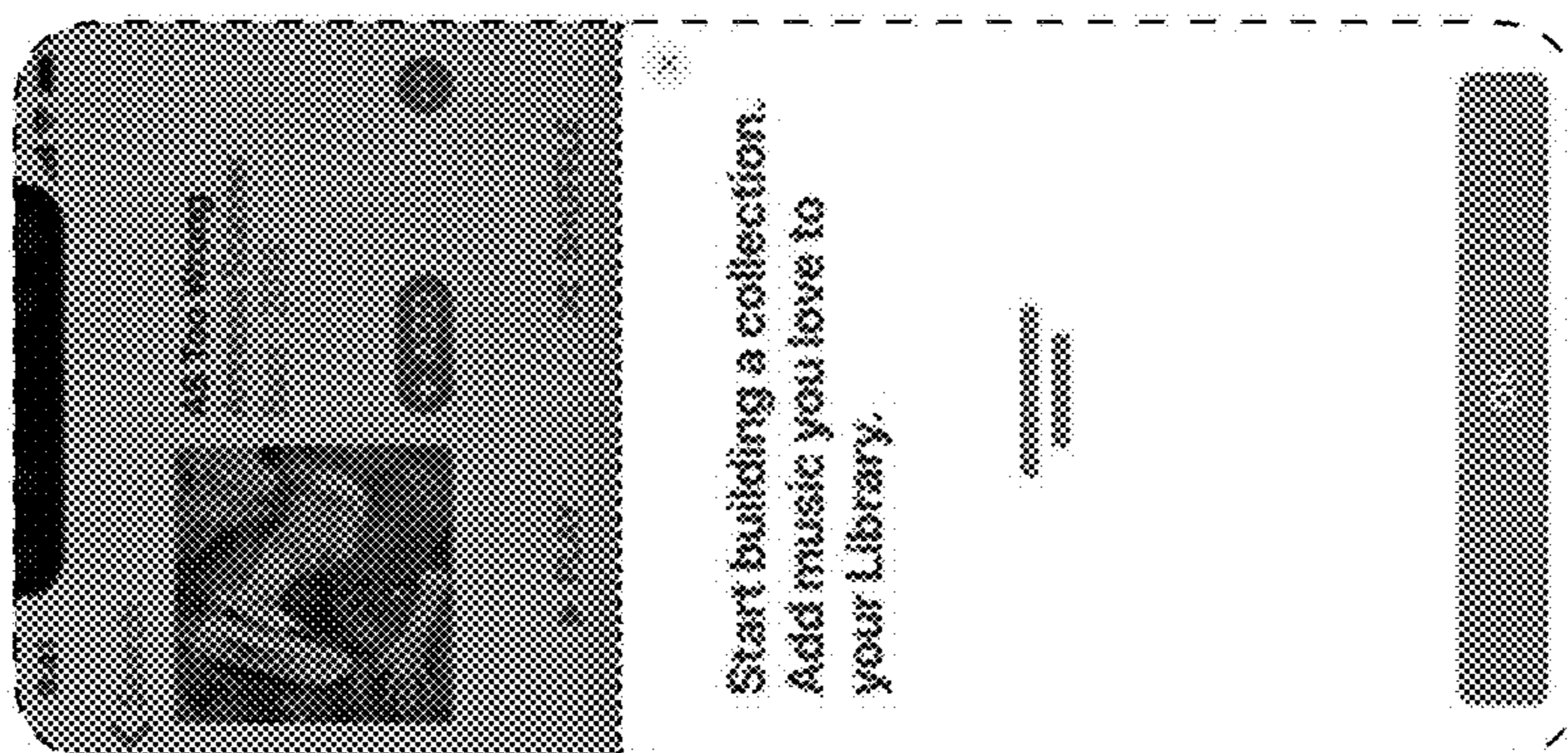

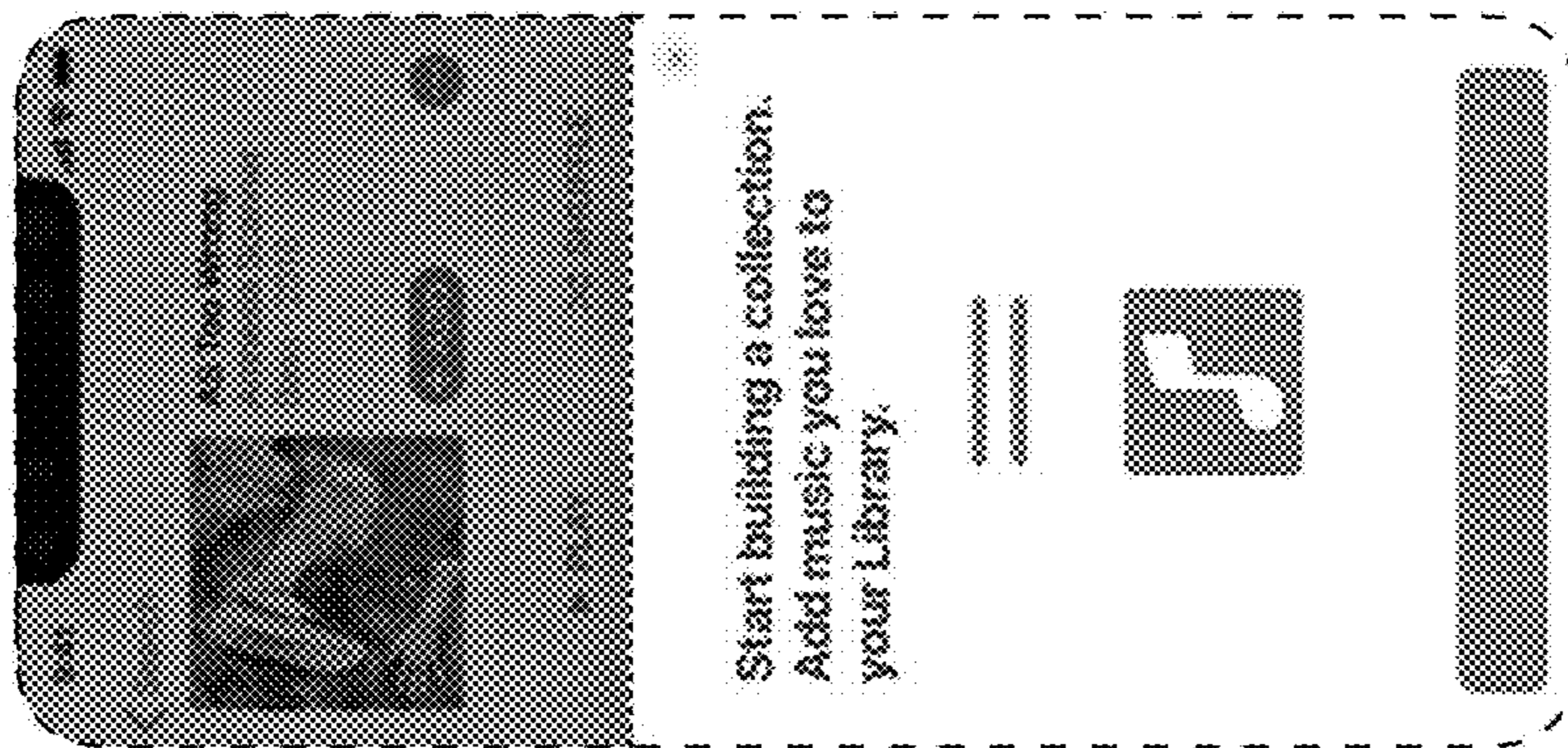

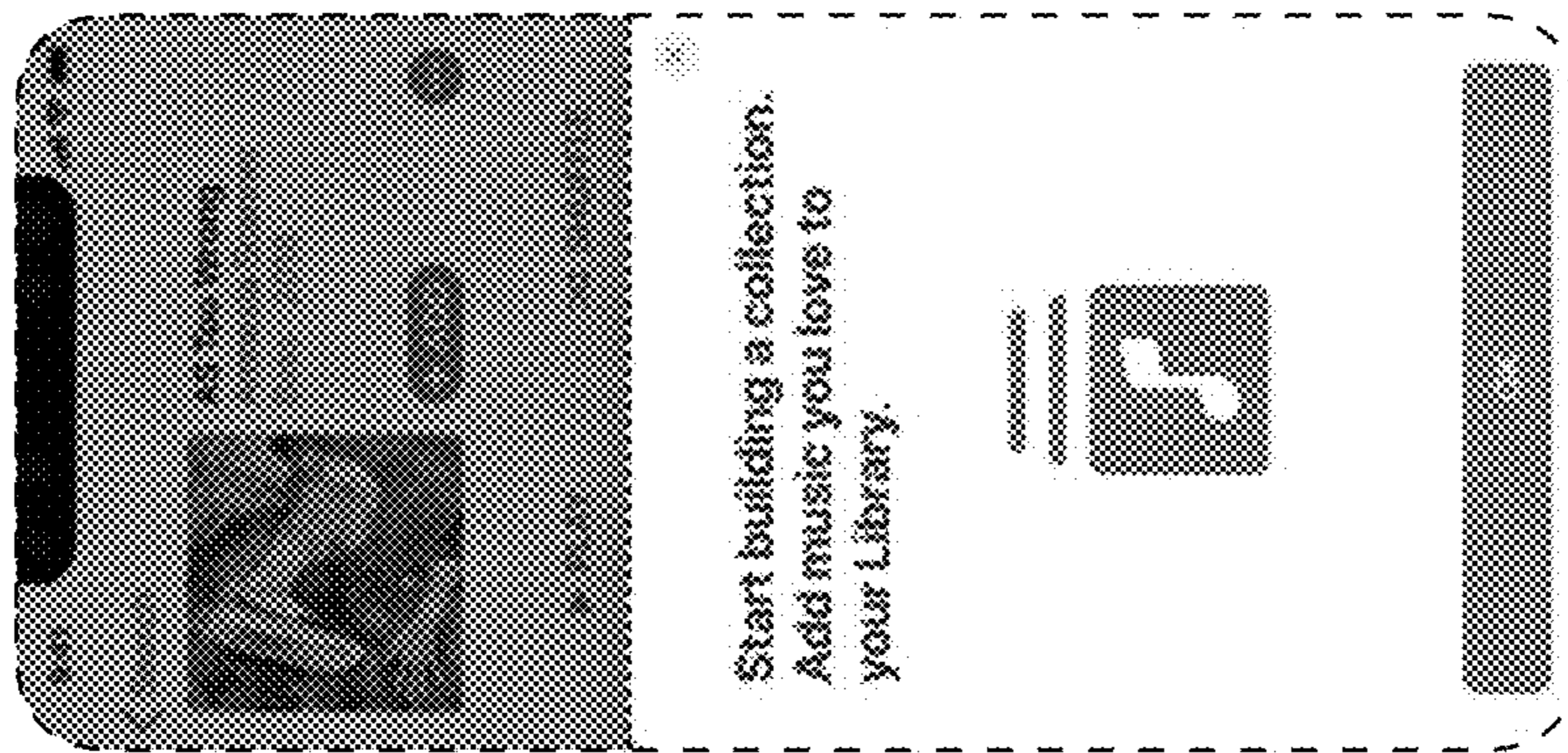

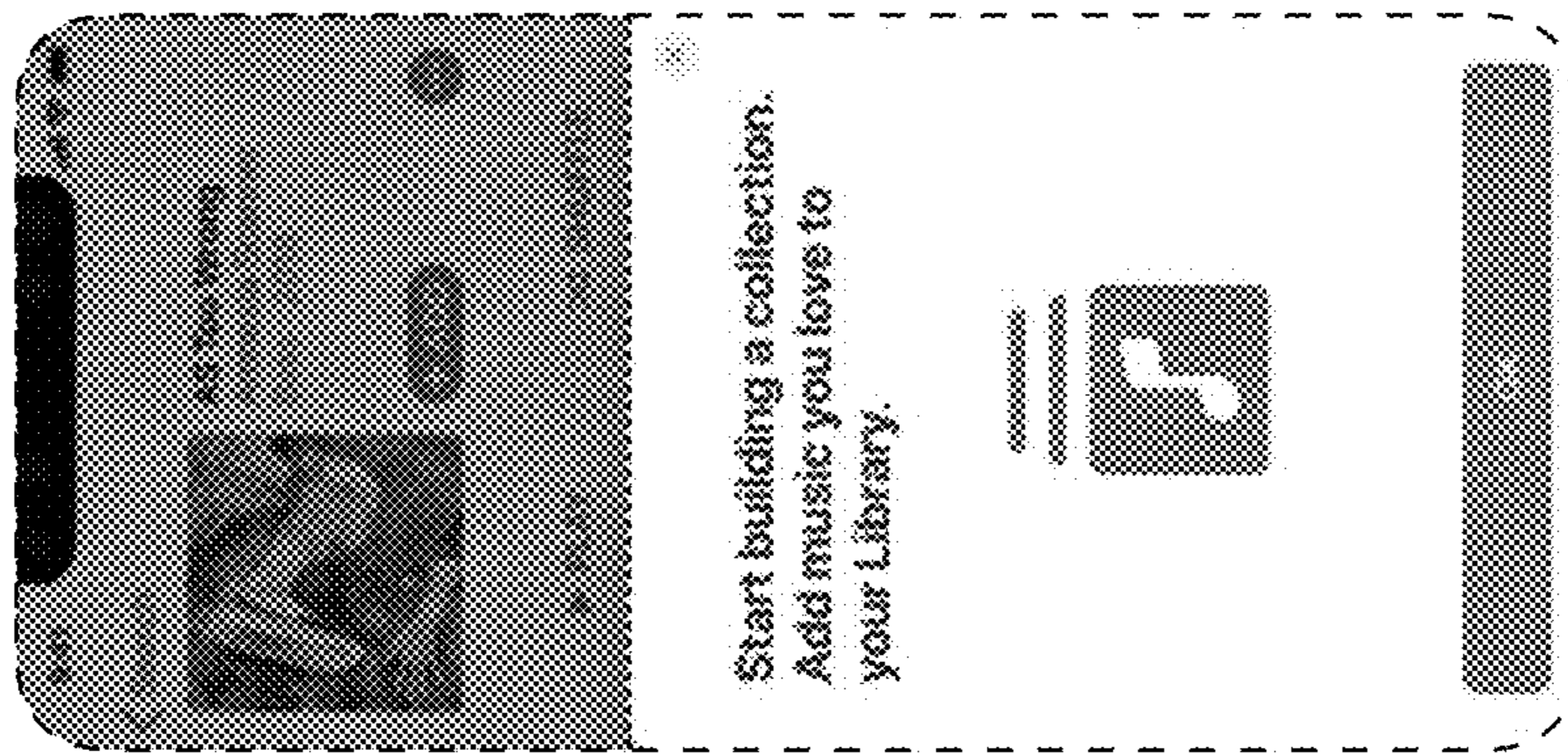
