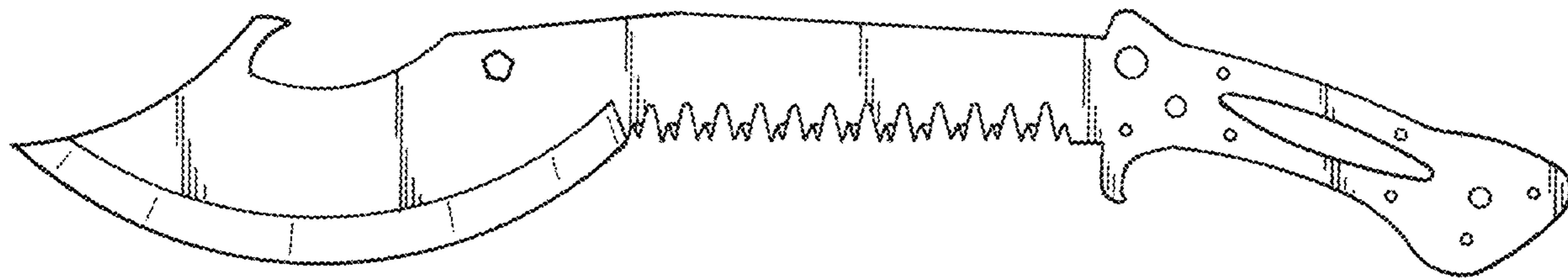
FIG. 1 is a side elevation view of a decorative ergonomic machete in accordance with the present disclosure;

FIG. 11 is an enlarged view similar to FIG. 10, showing the rear saw teeth portion from the bottom of the design.

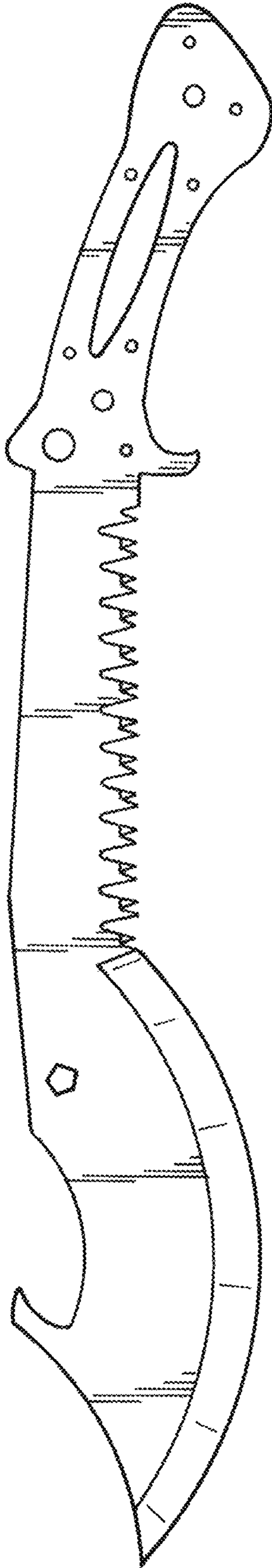

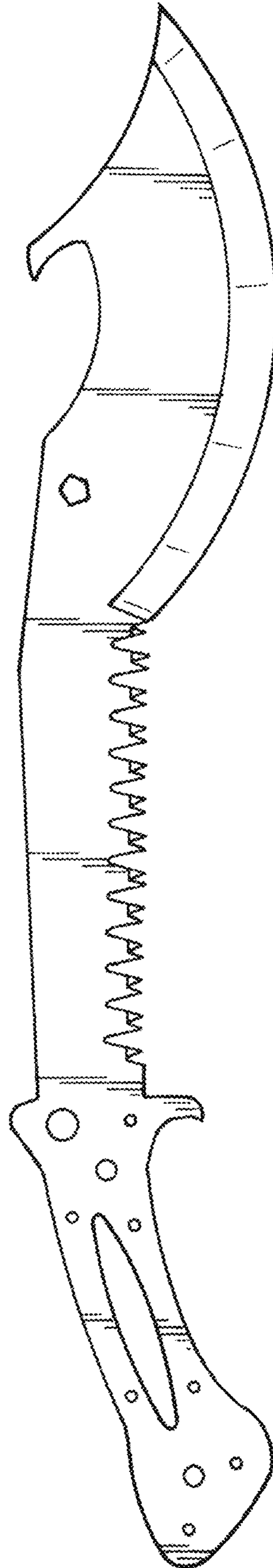

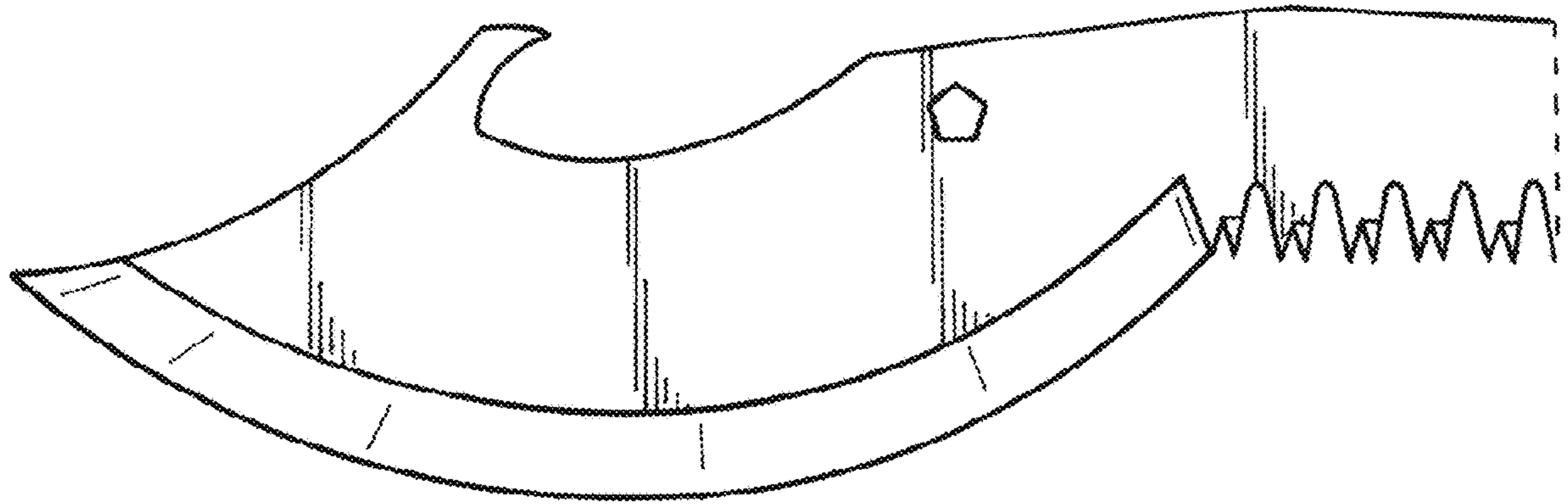

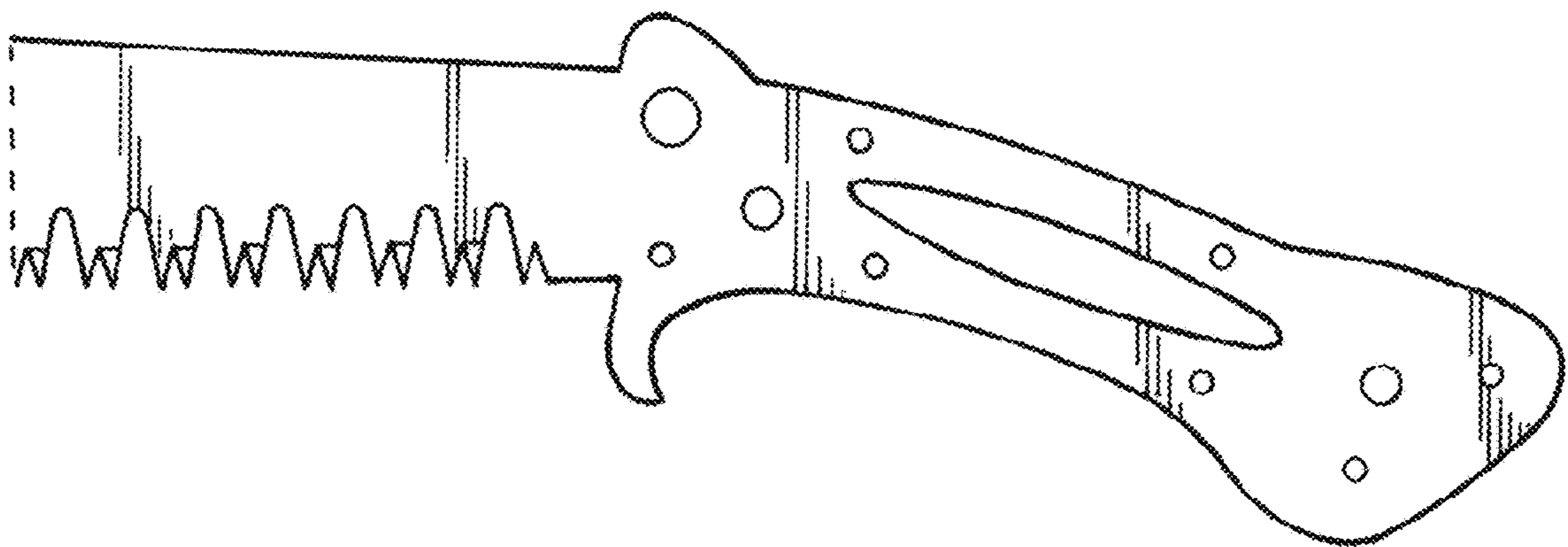

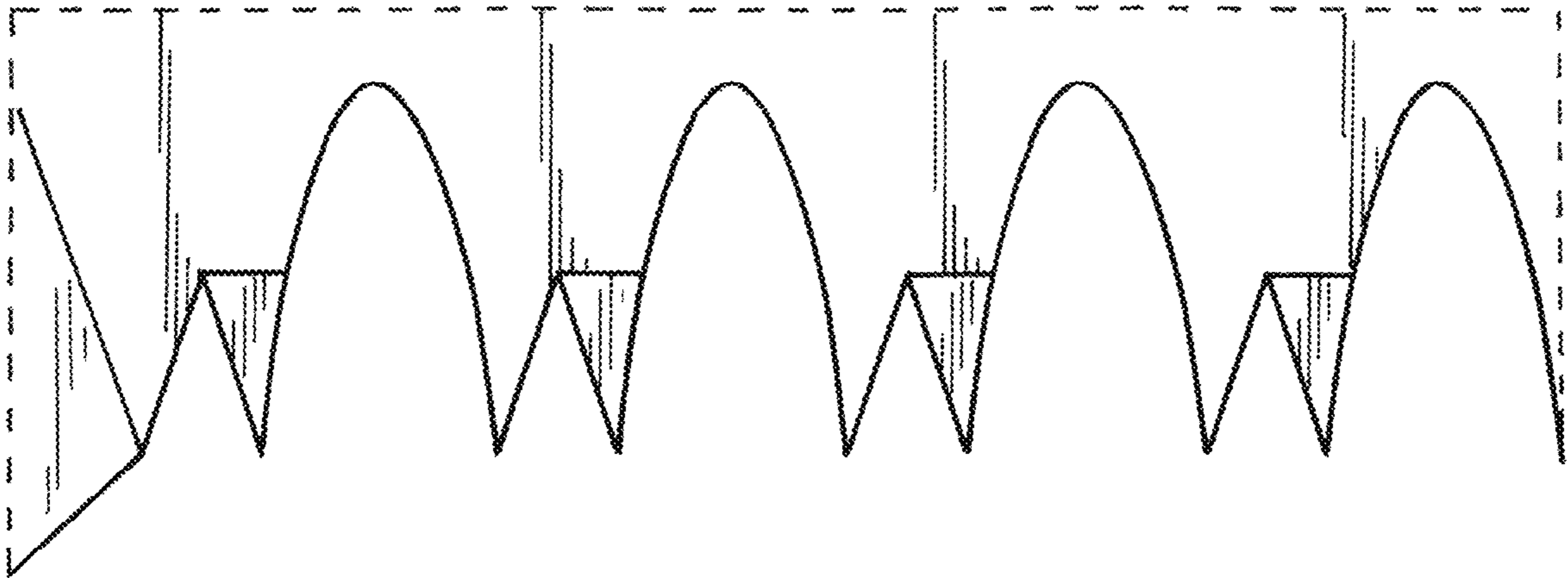

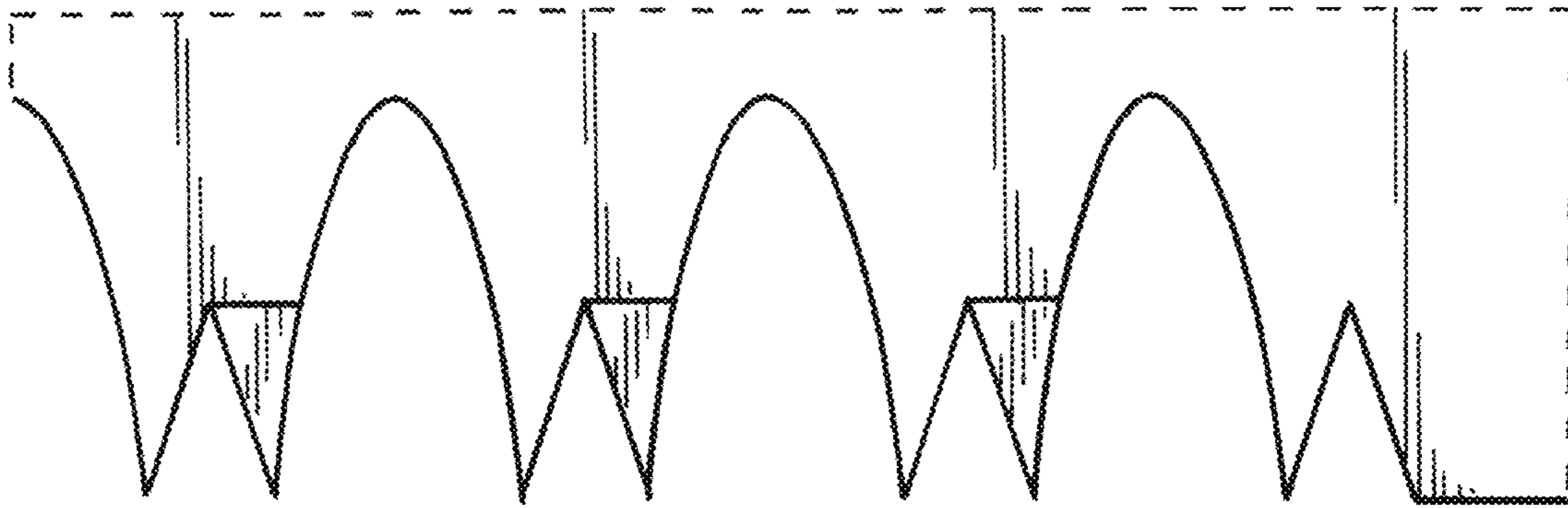
