The ornamental design for a fragrance vessel, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a fragrance vessel showing the new design;
FIG. 2 is a left side view of the fragrance vessel of FIG. 1;
FIG. 3 is a right side view of the fragrance vessel shown in FIG. 1;
FIG. 4 is a front view of the fragrance vessel shown in FIG. 1;

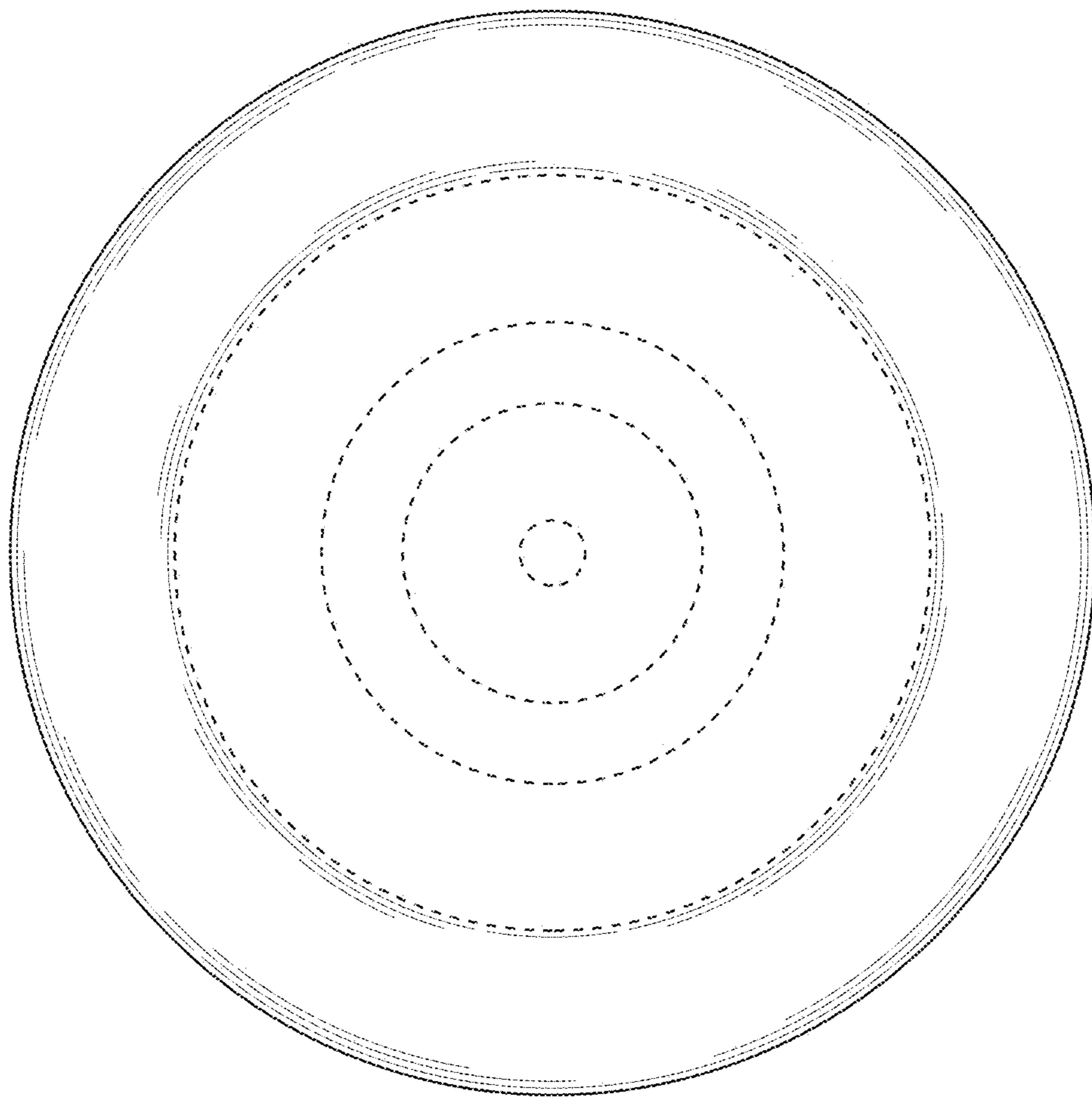
