DESCRIPTION

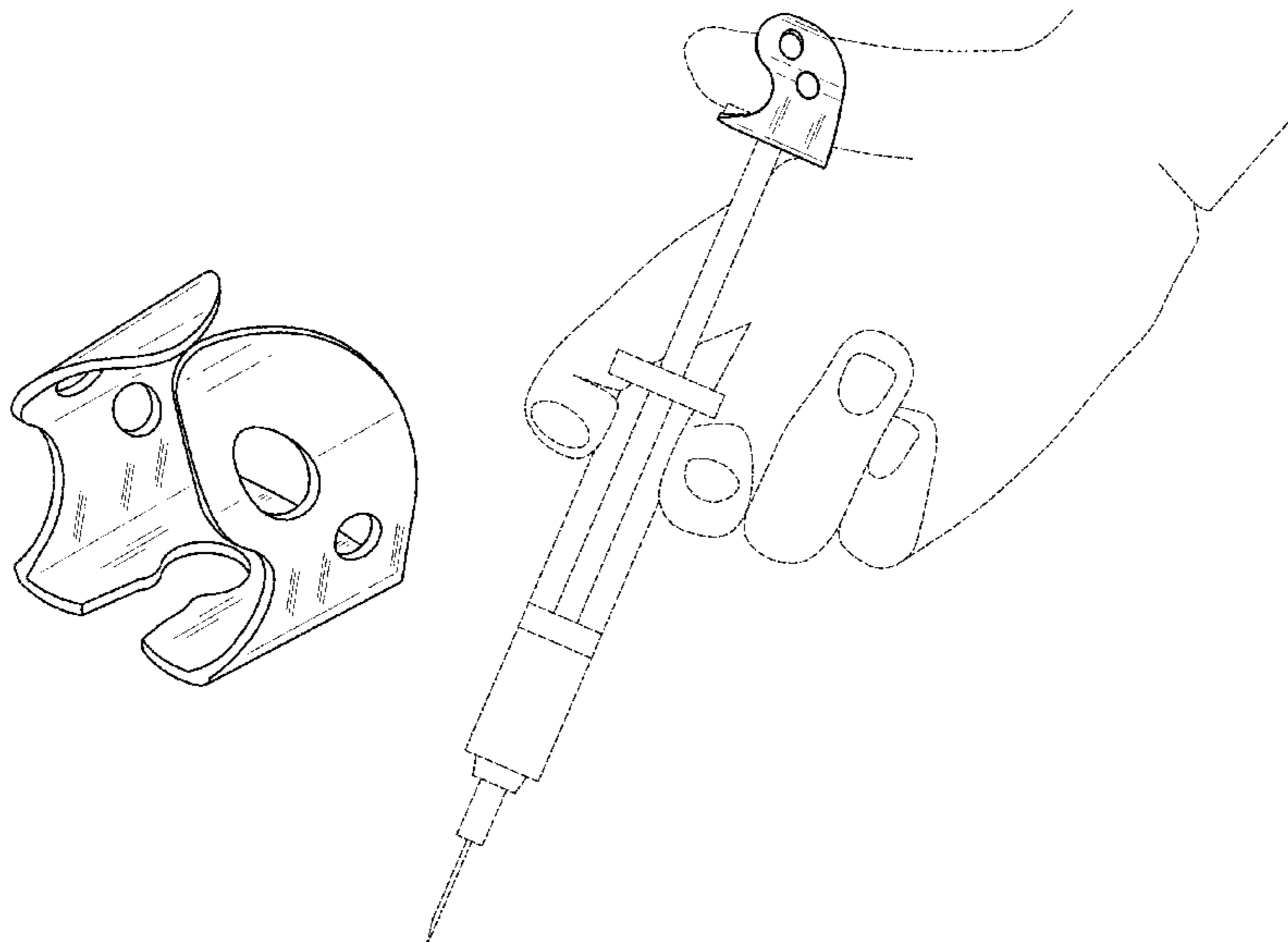
FIG. 1 is a perspective view of a plunger fastening device, showing my new design;

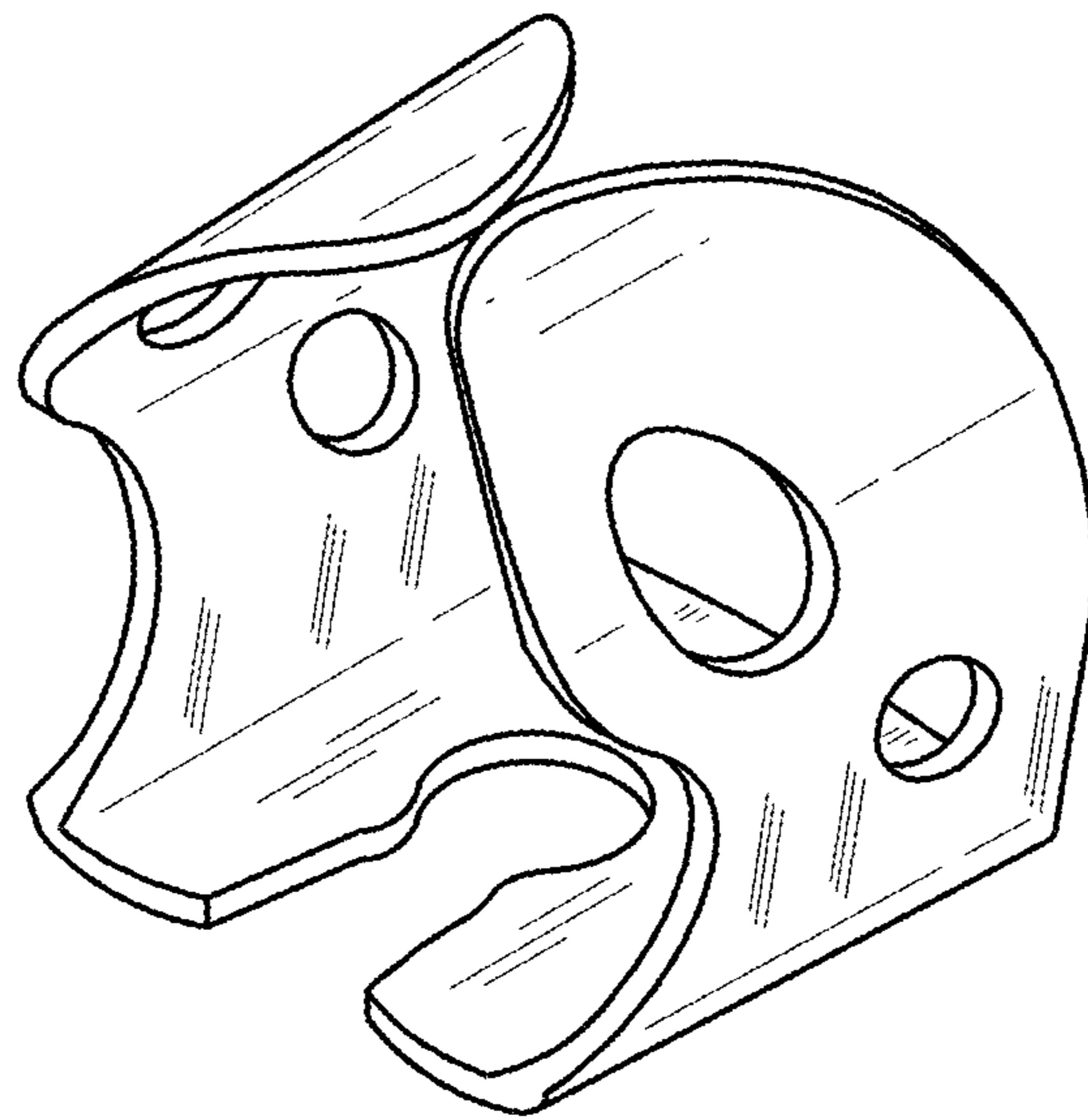

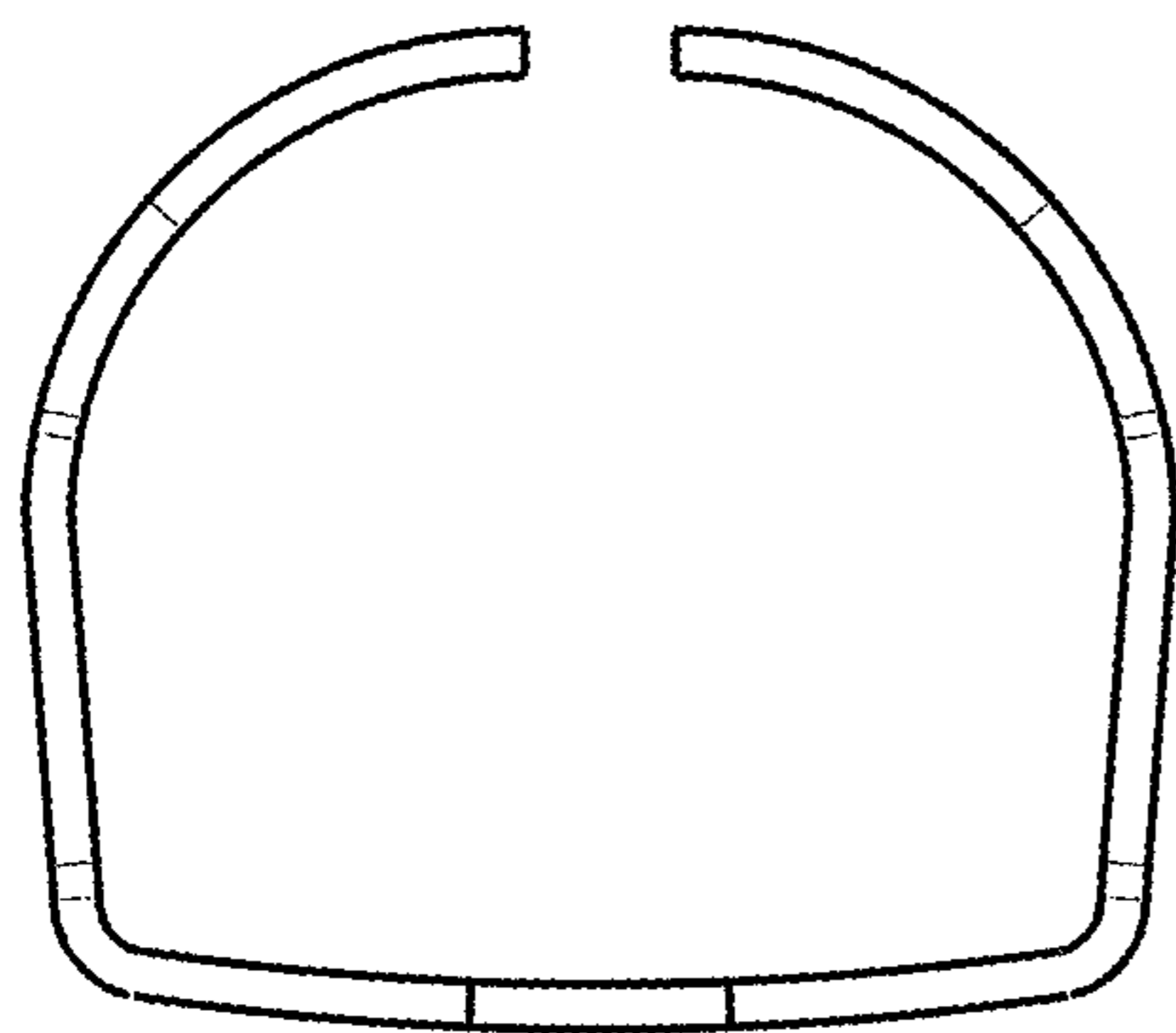

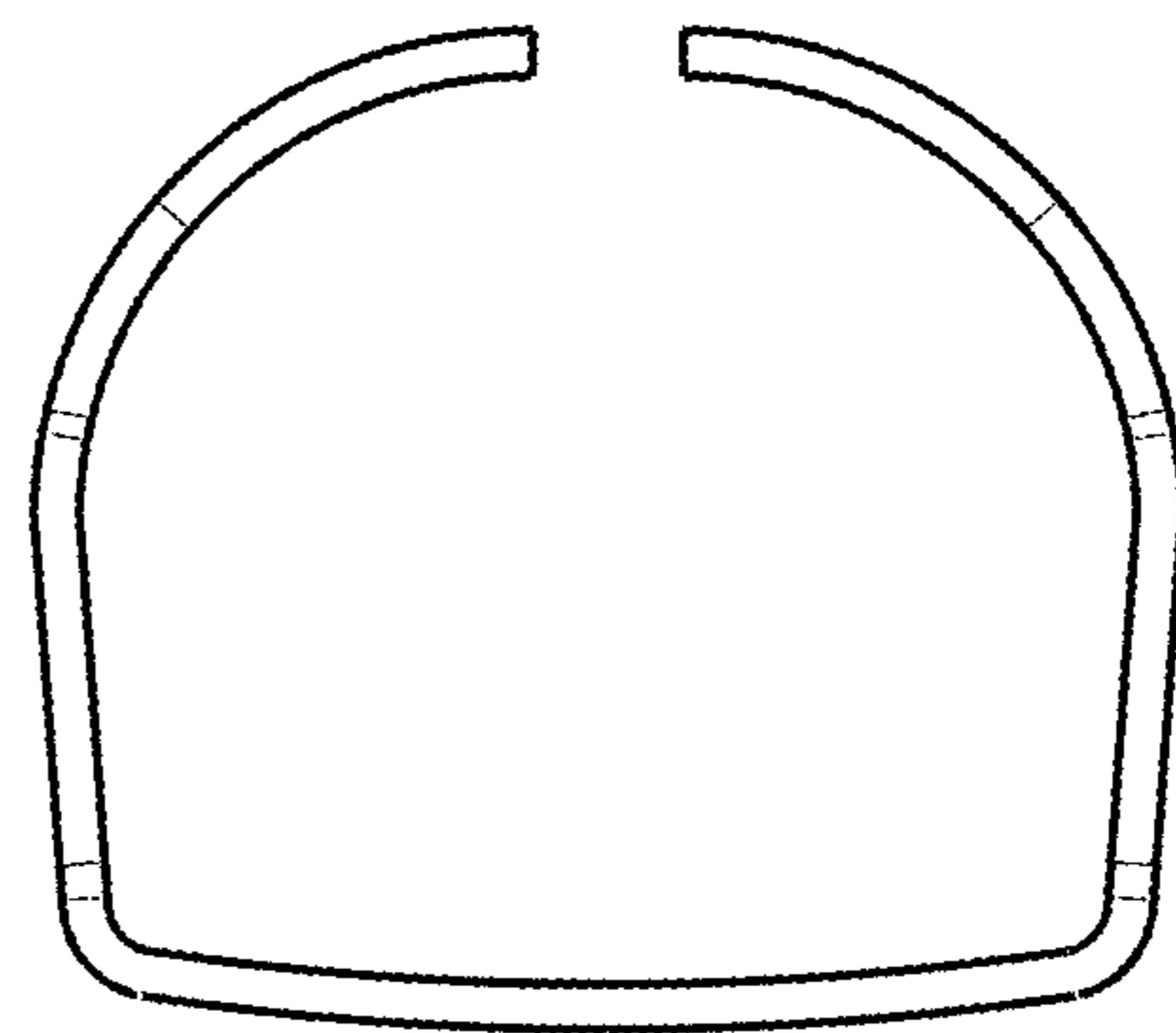

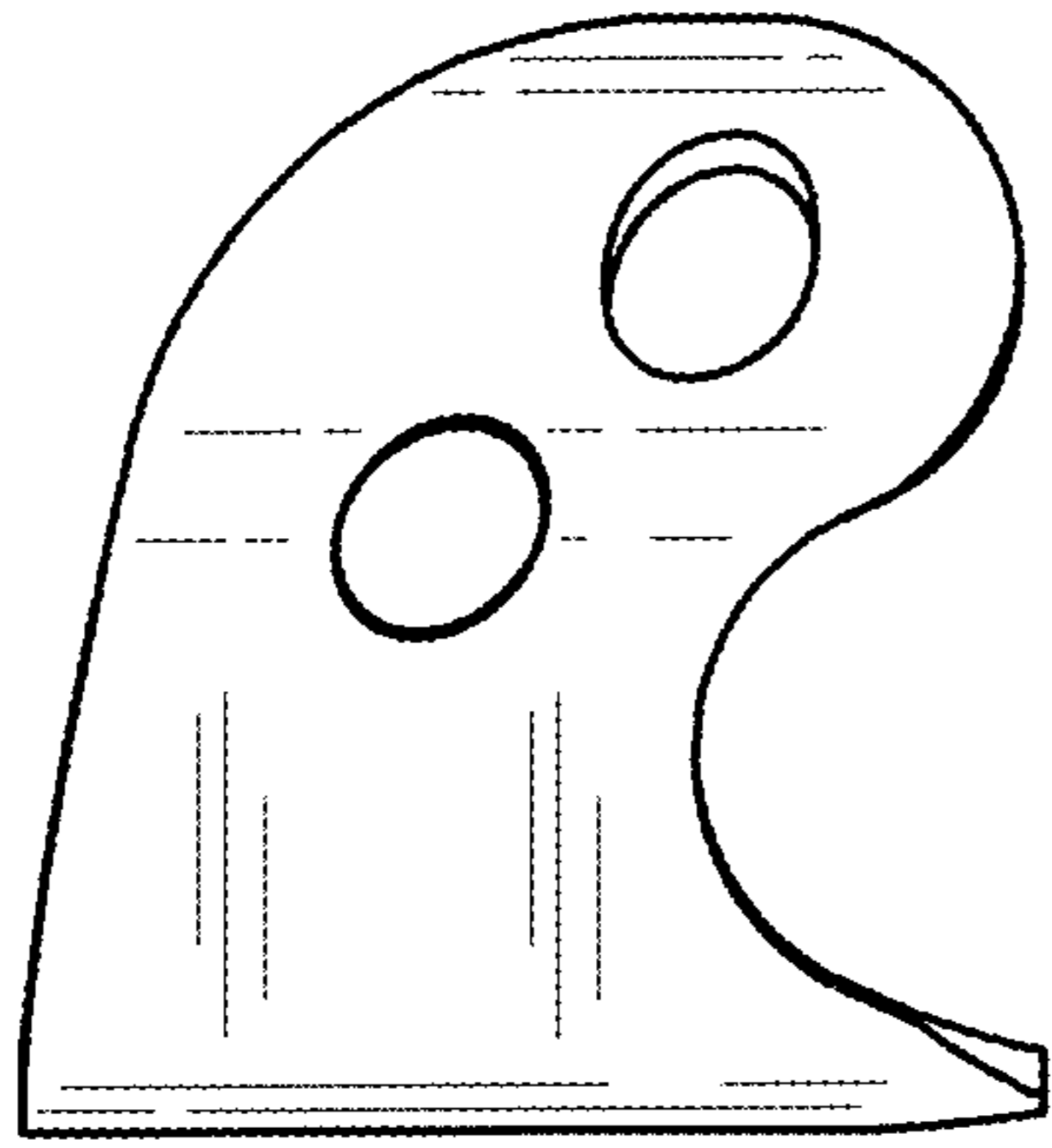

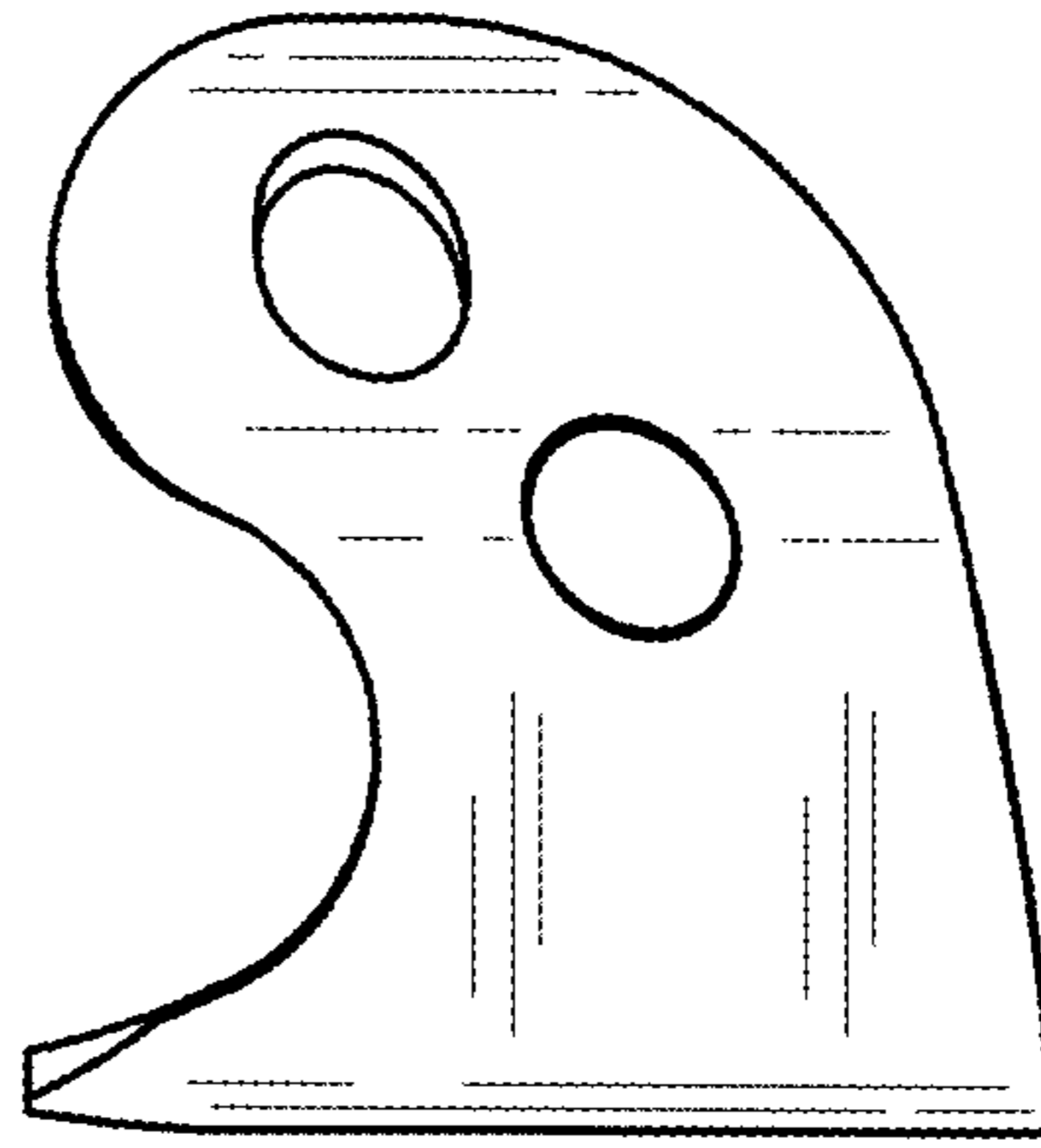

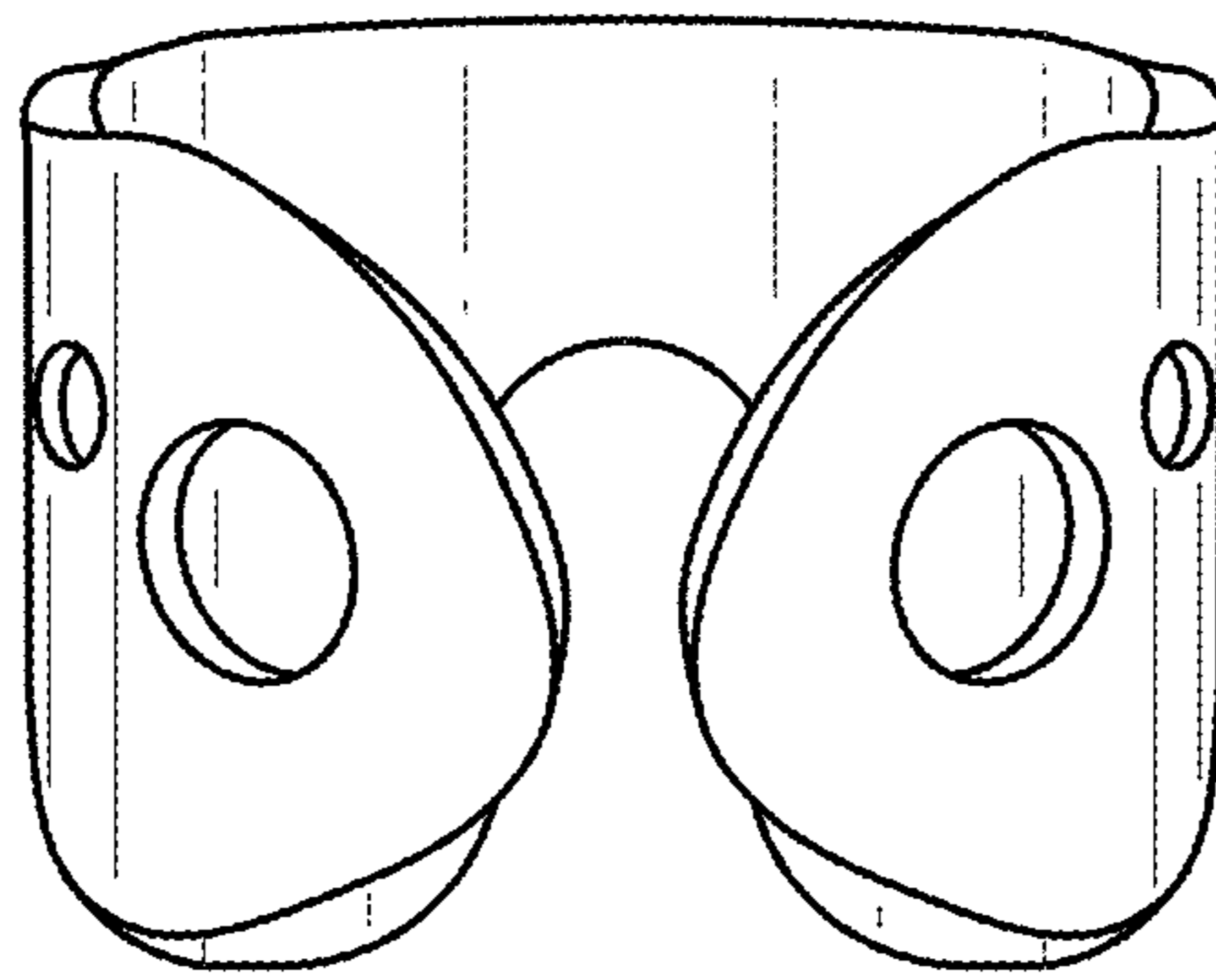

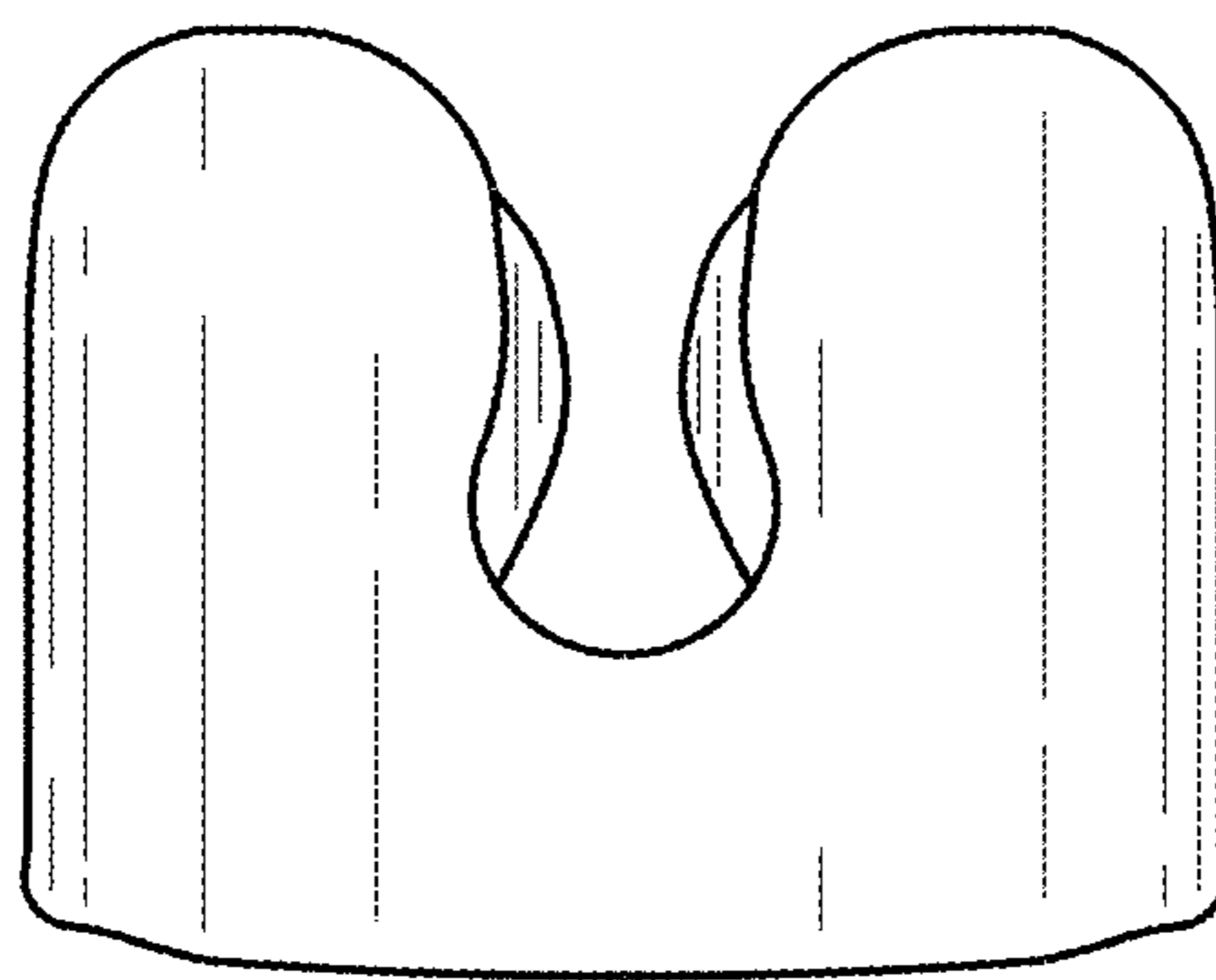
