DESCRIPTION

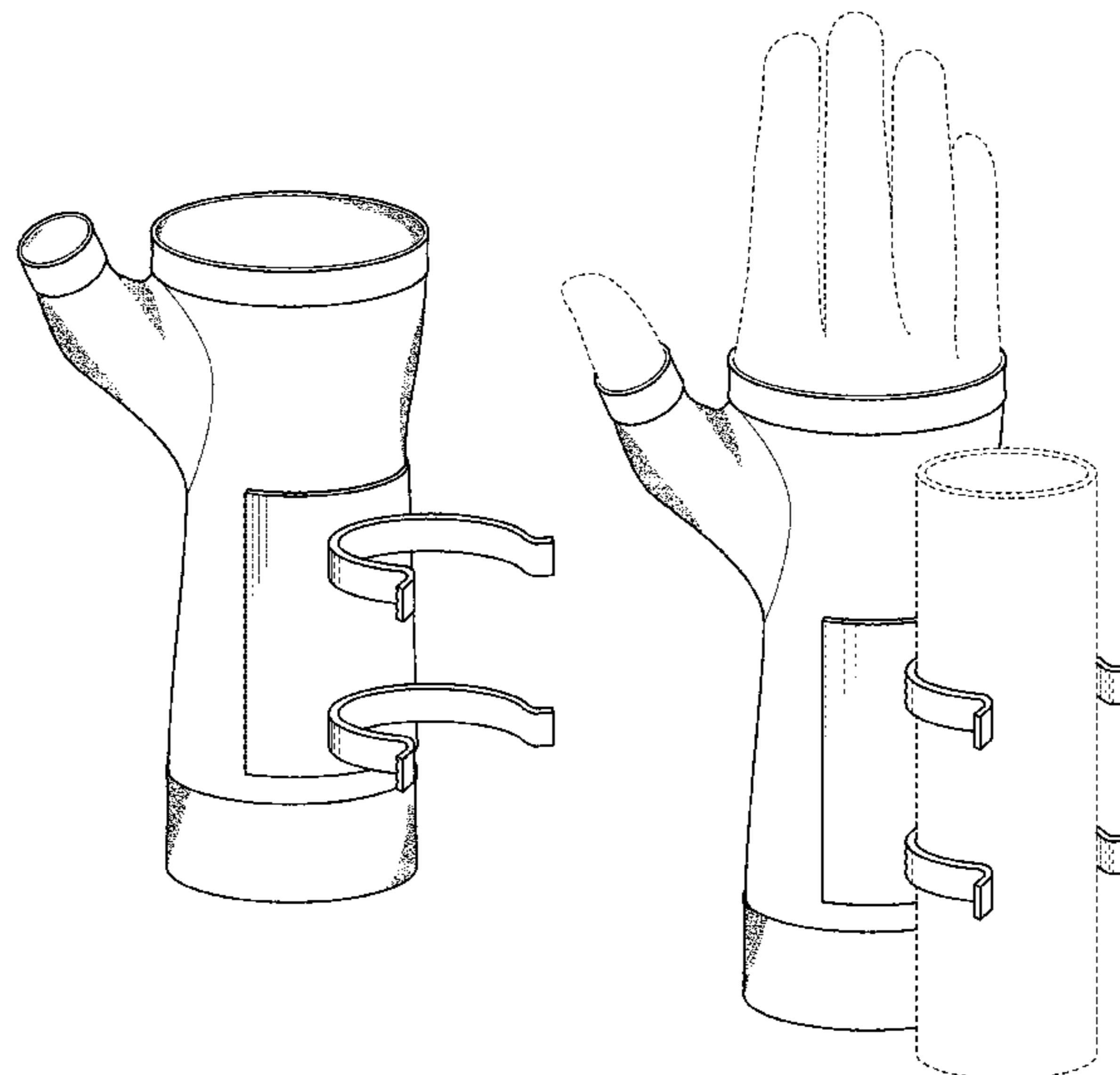
FIG. 1 is a perspective front view of the compression sleeve, which embodies my design;

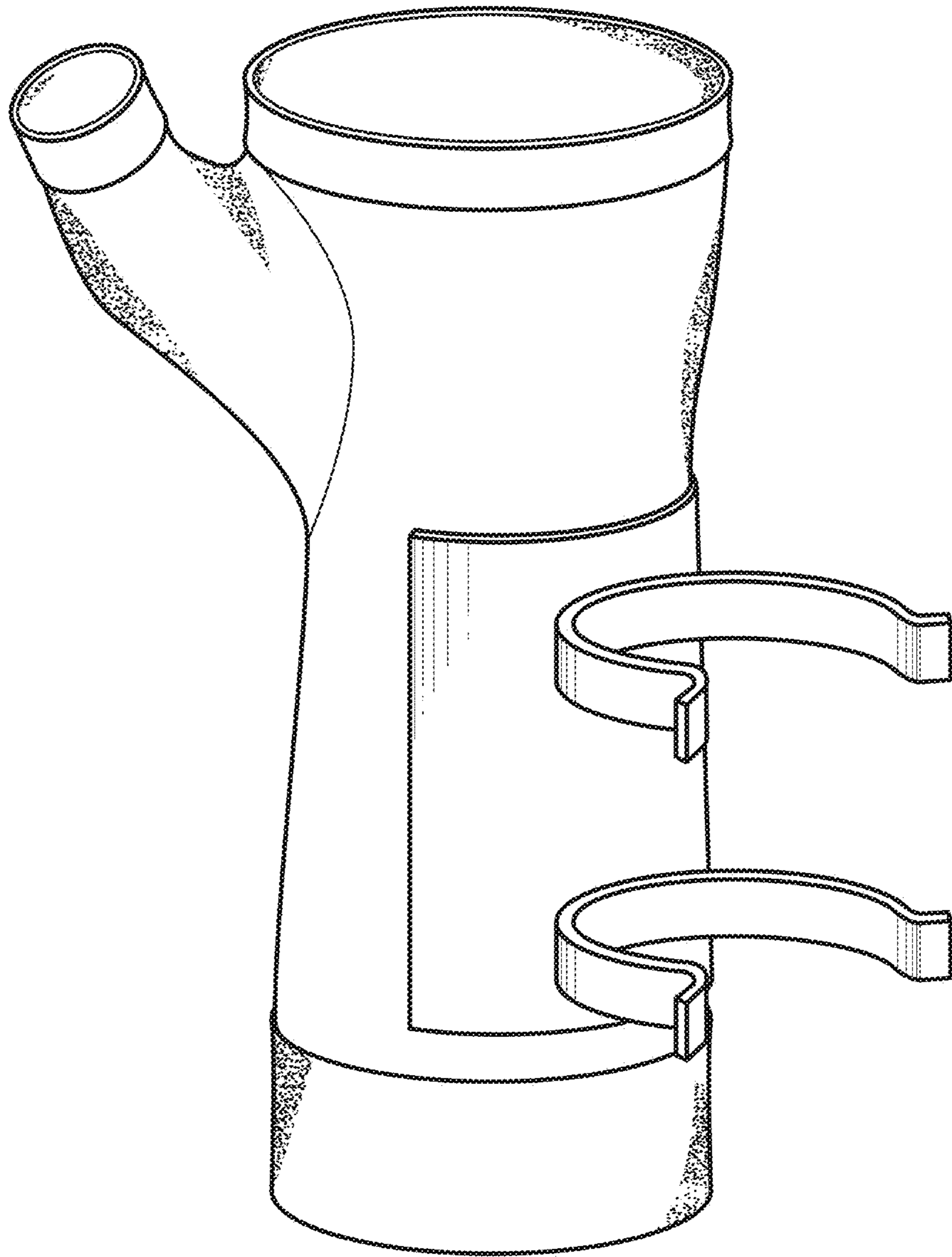

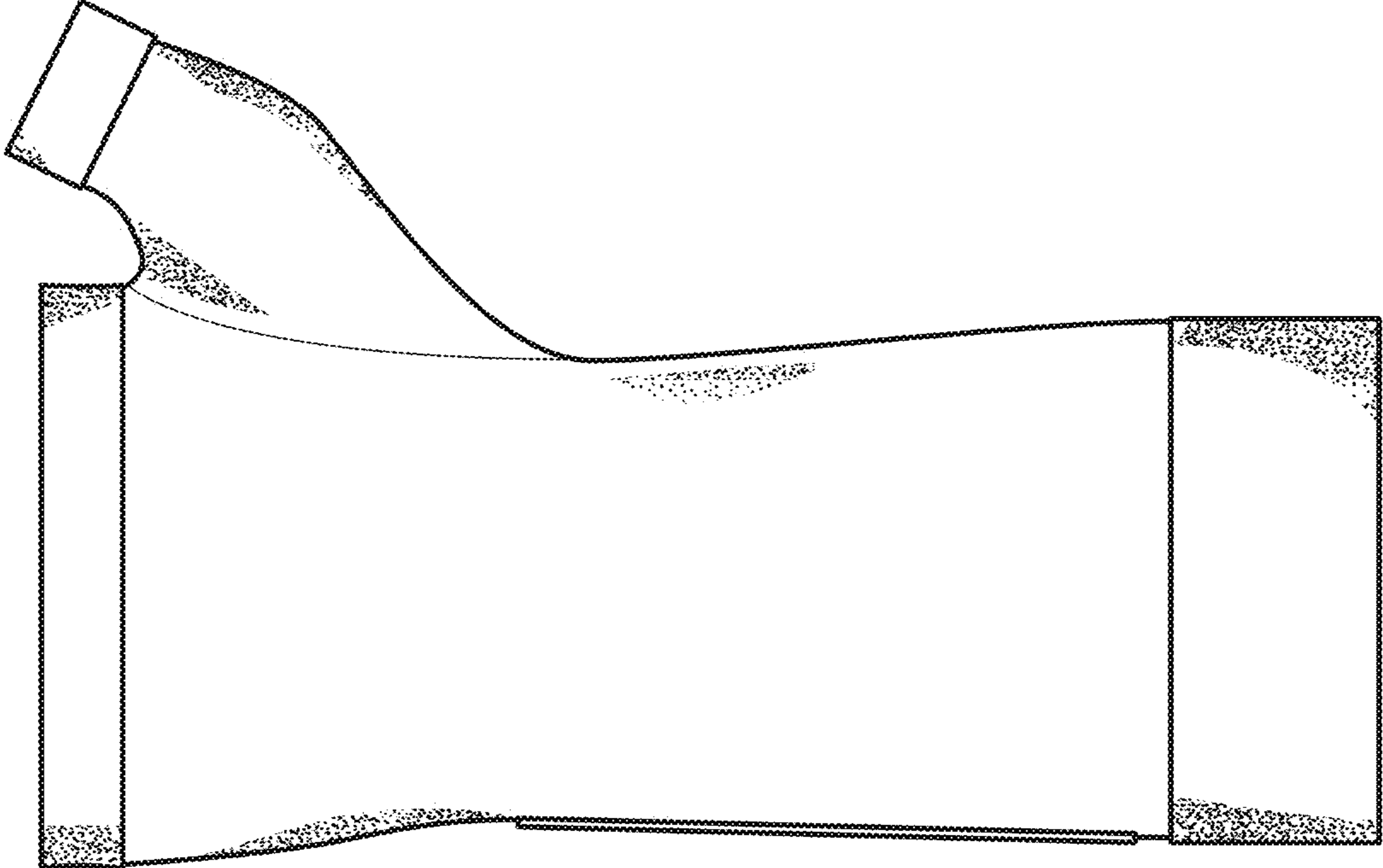

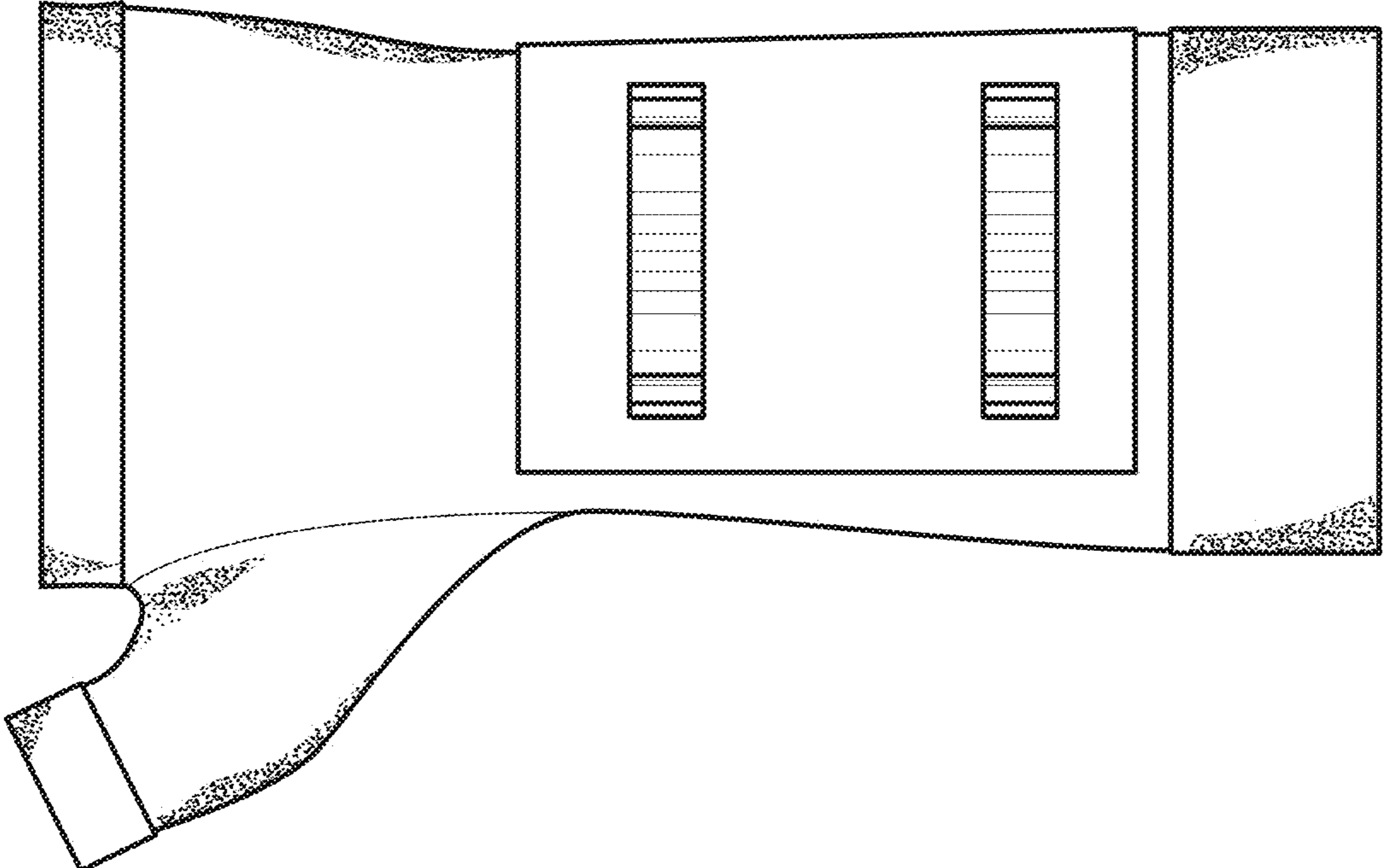

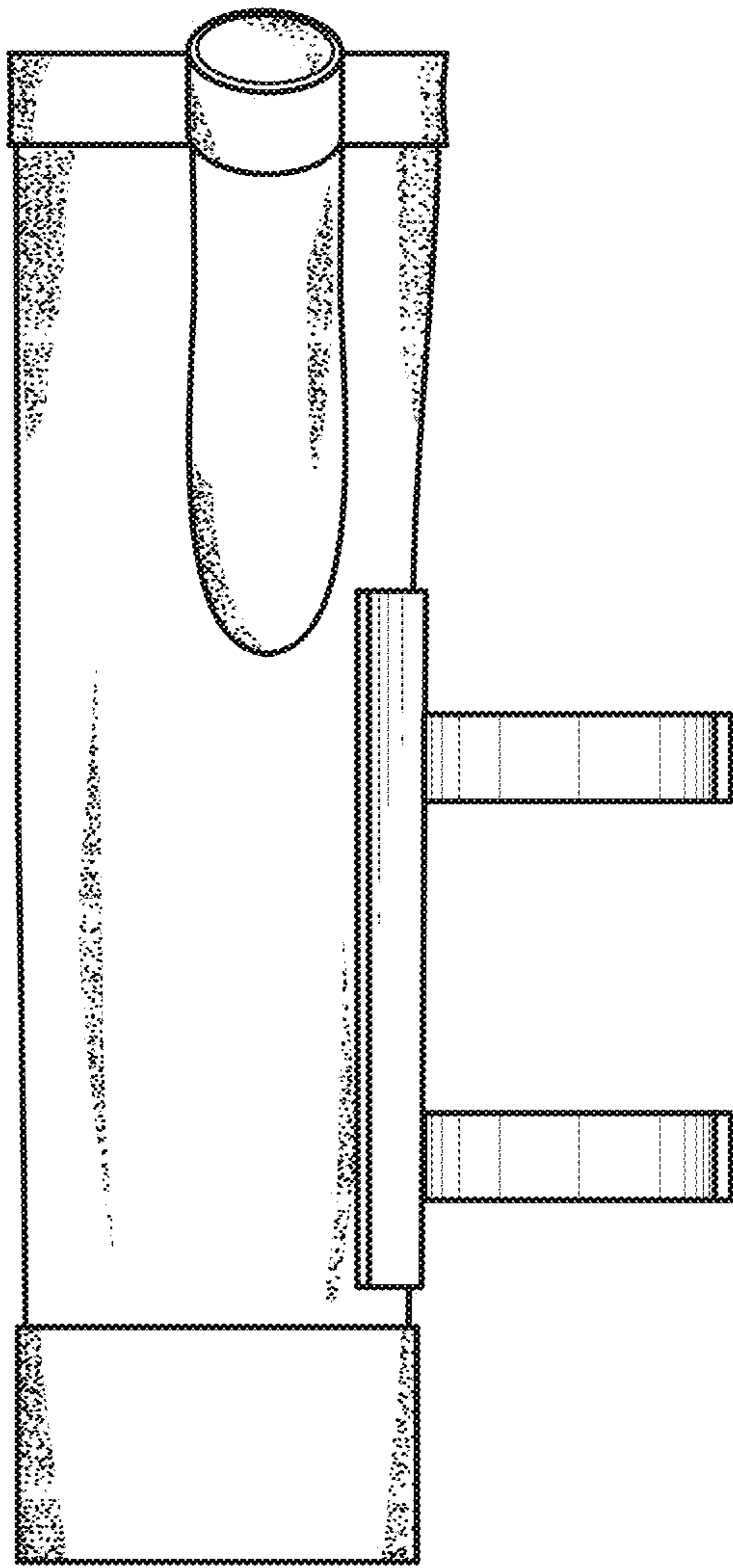

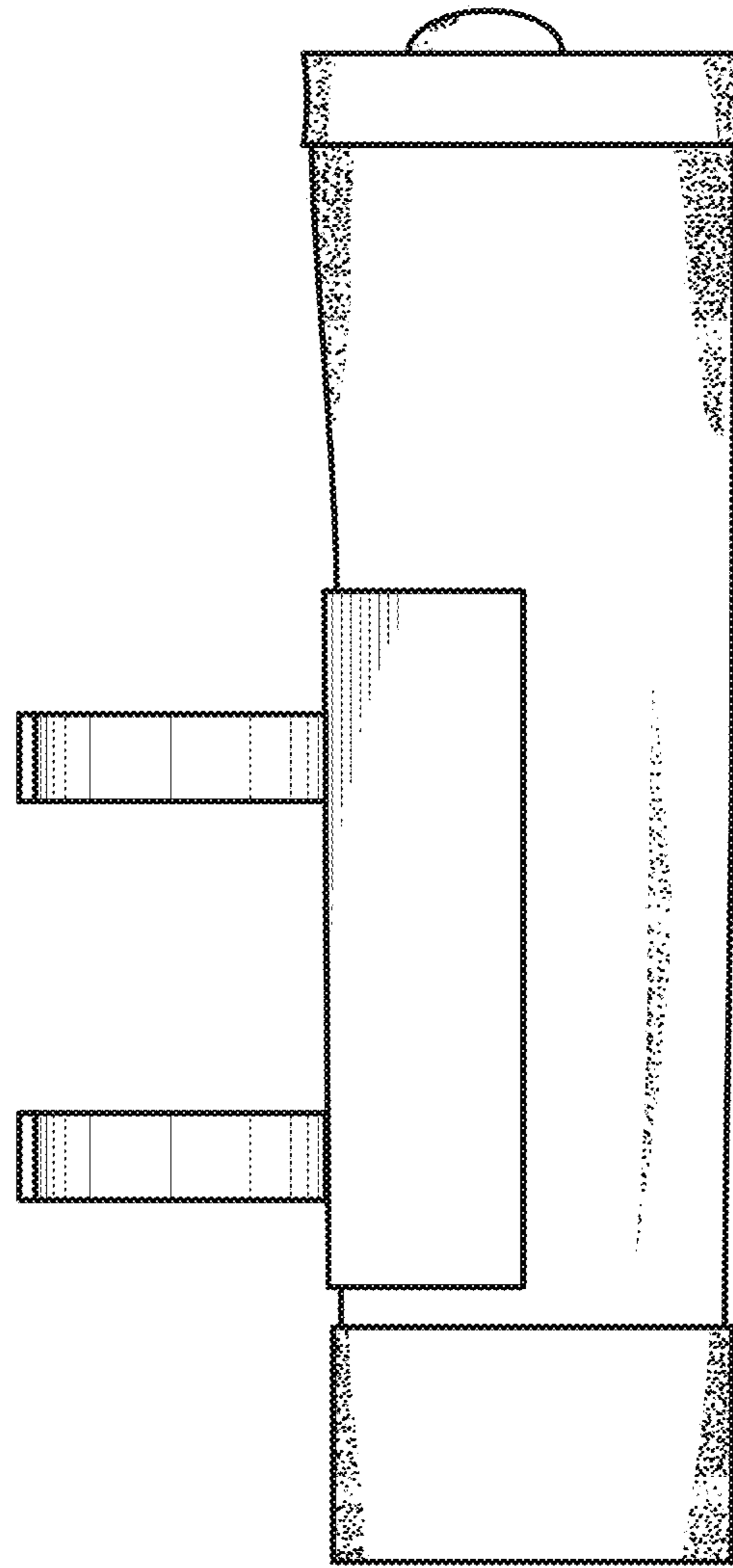

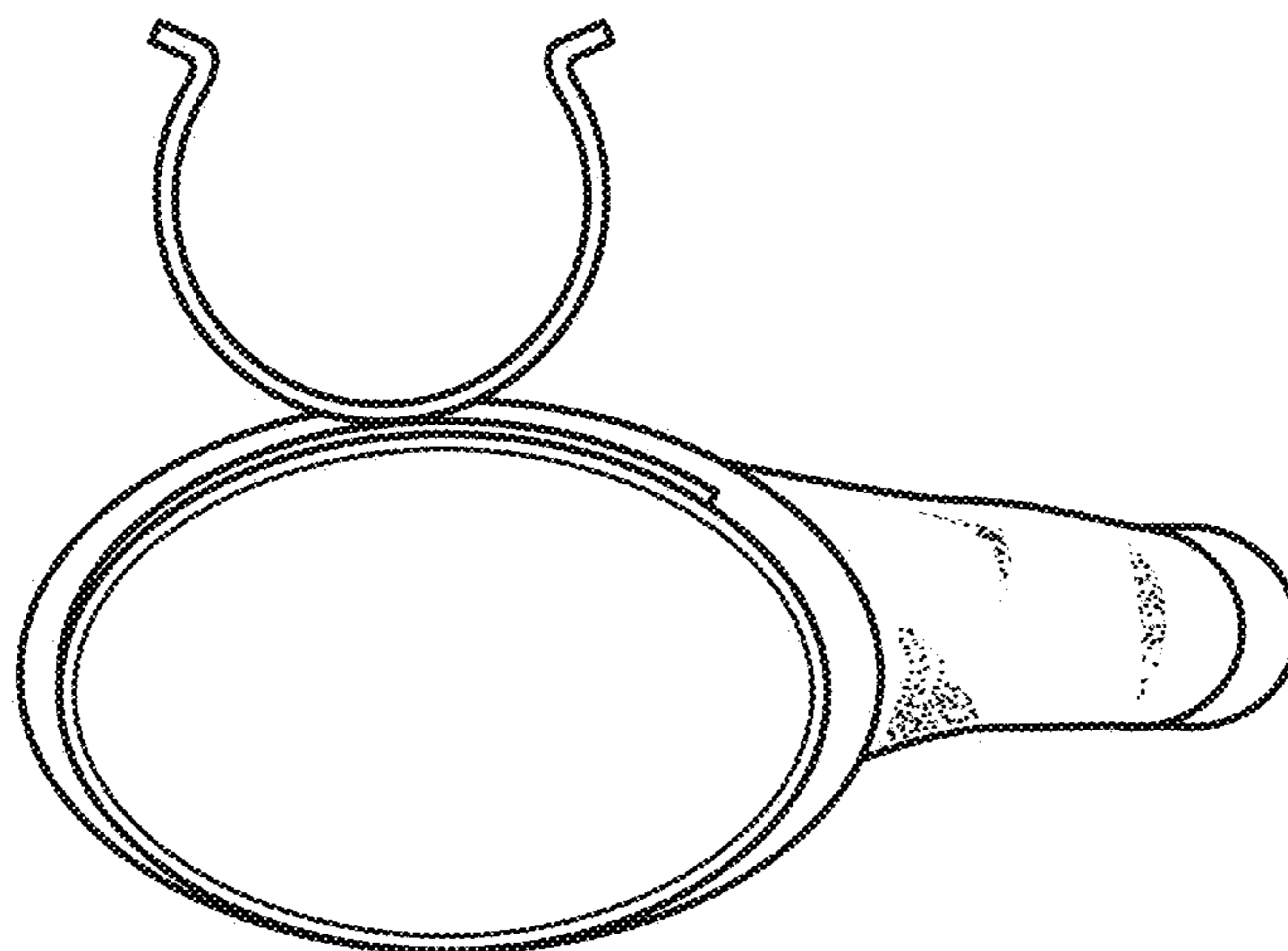

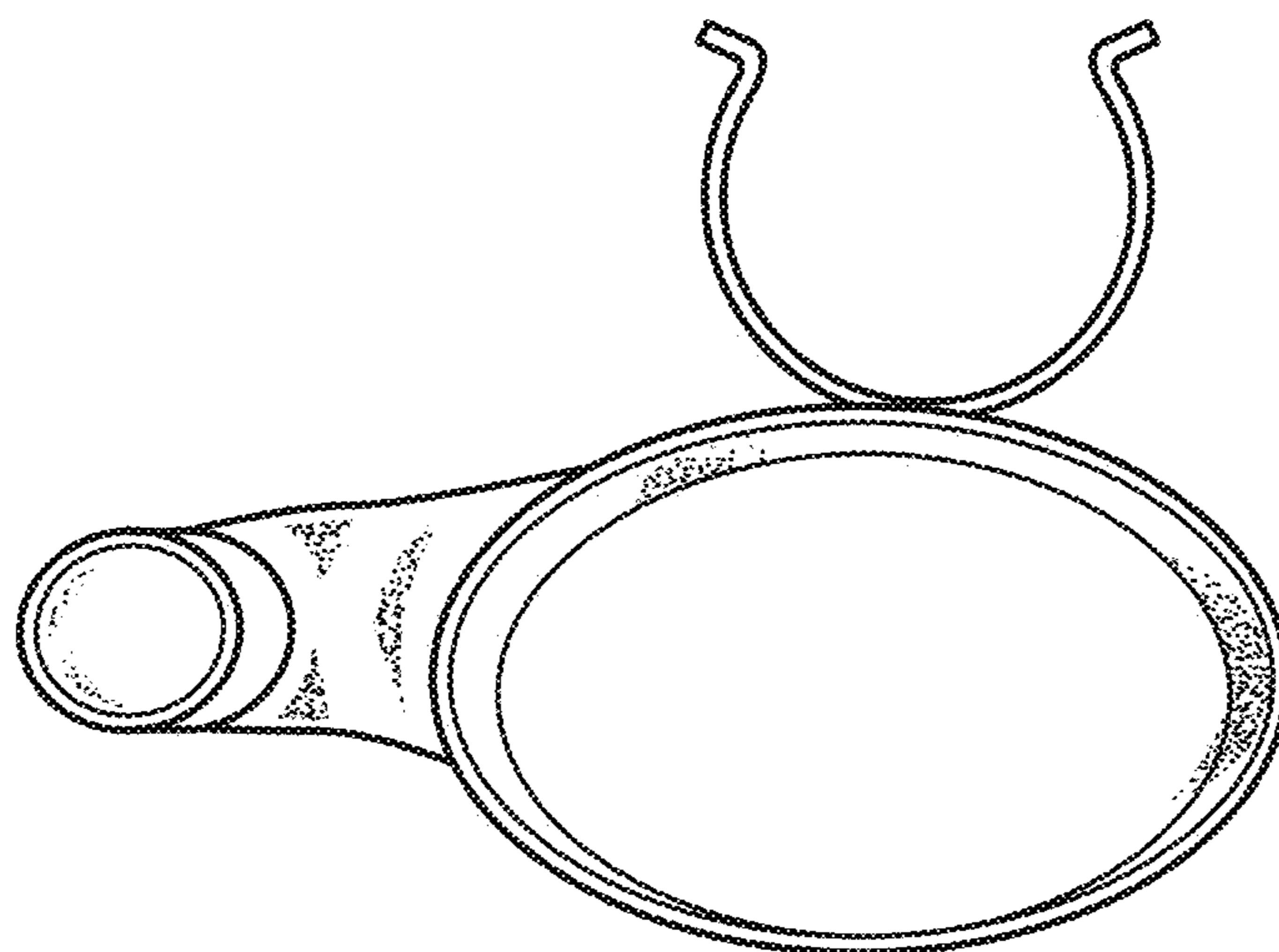

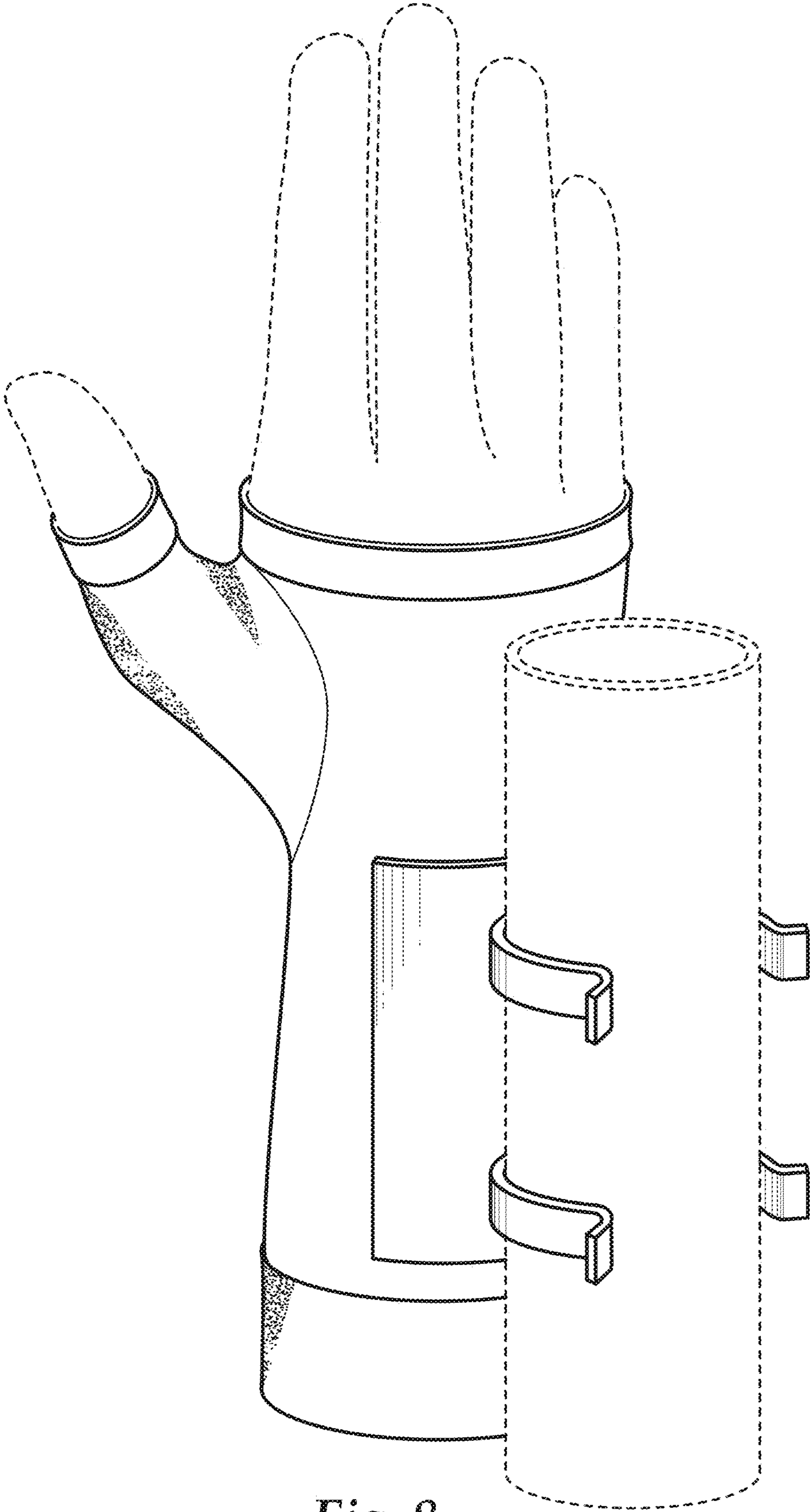
