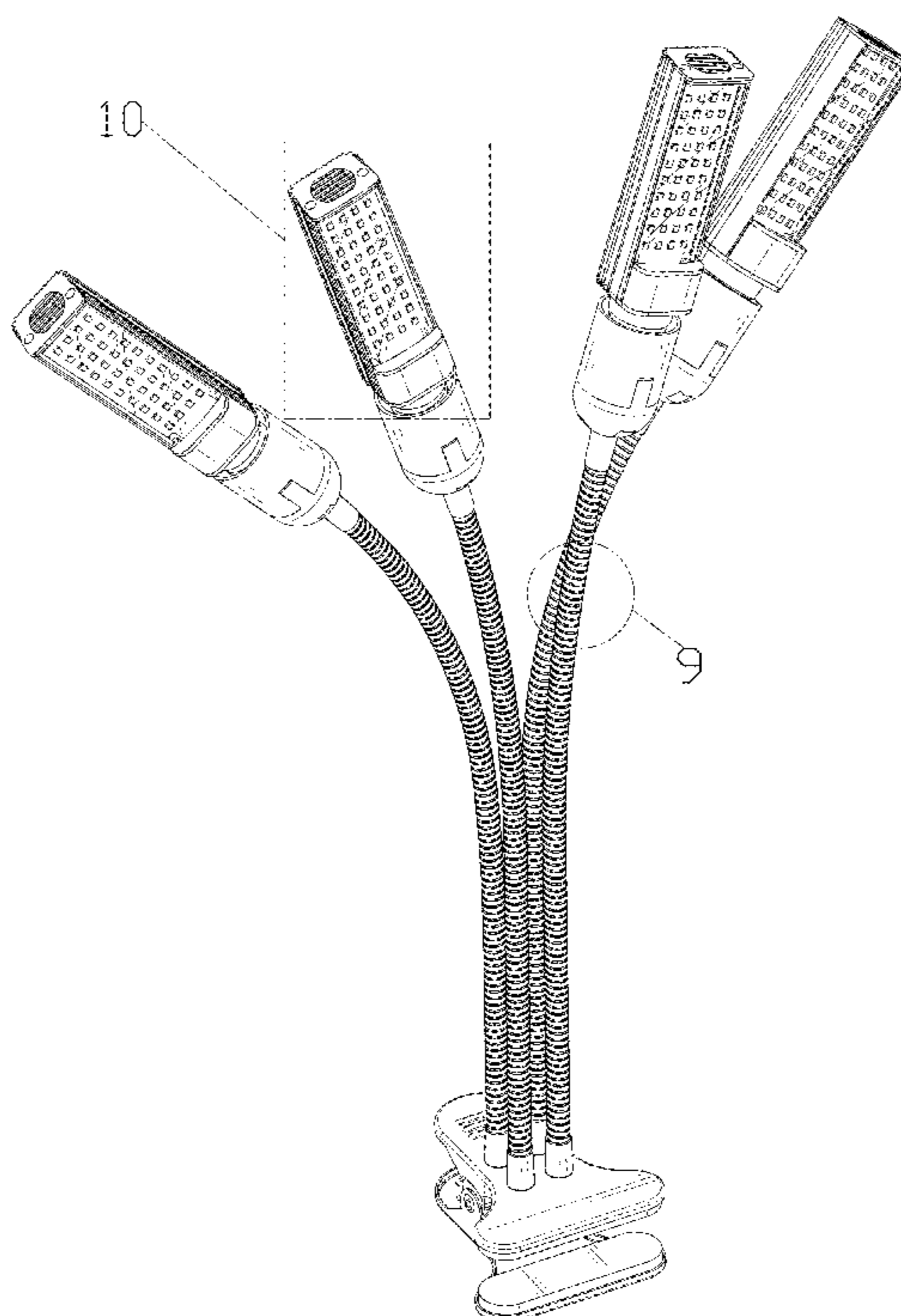
(57) **CLAIM**

The ornamental design for a plant grow light, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a plant grow light showing my new design;
FIG. 2 is another perspective view thereof;

FIG. 5 is a left side elevational view thereof;

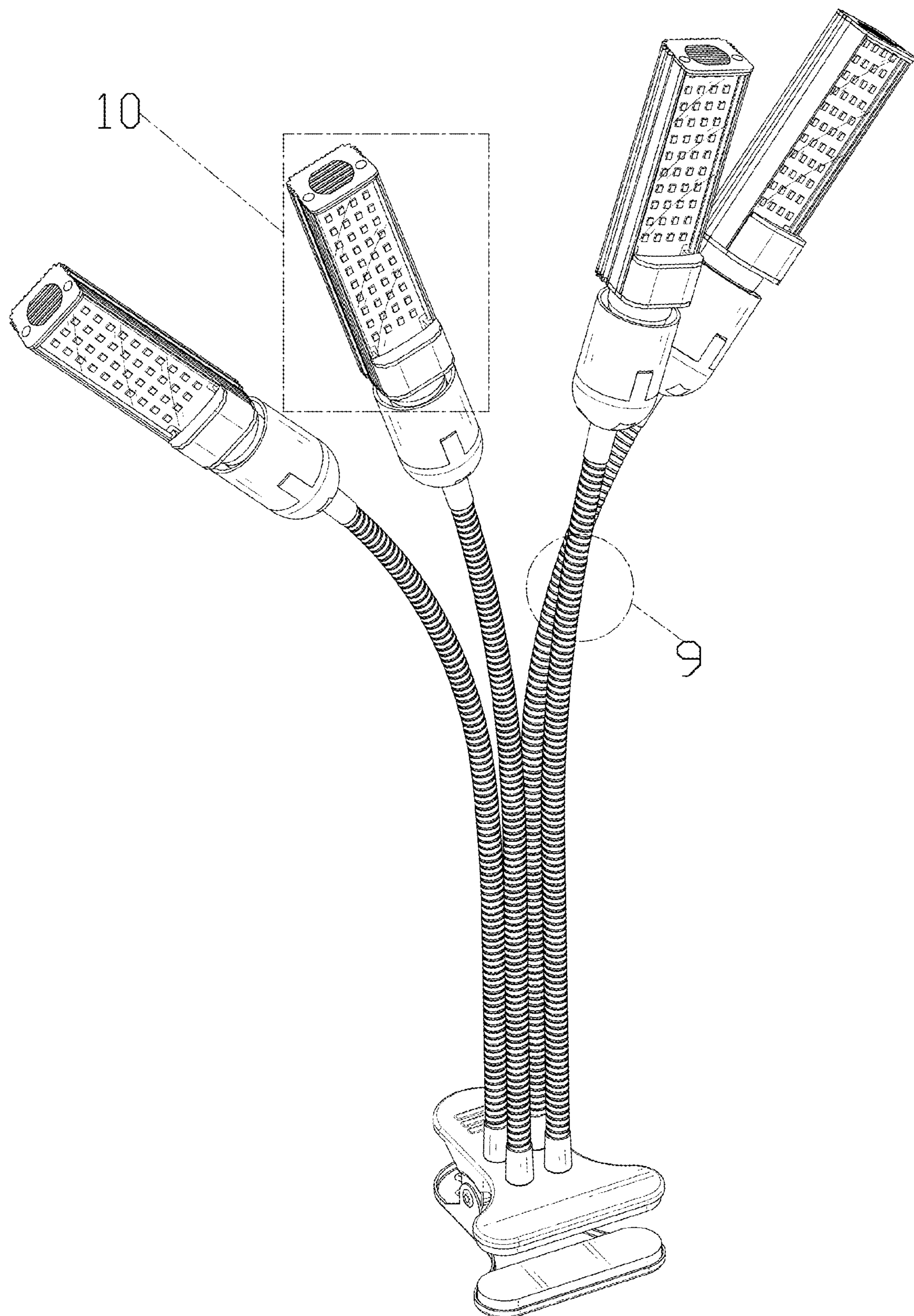

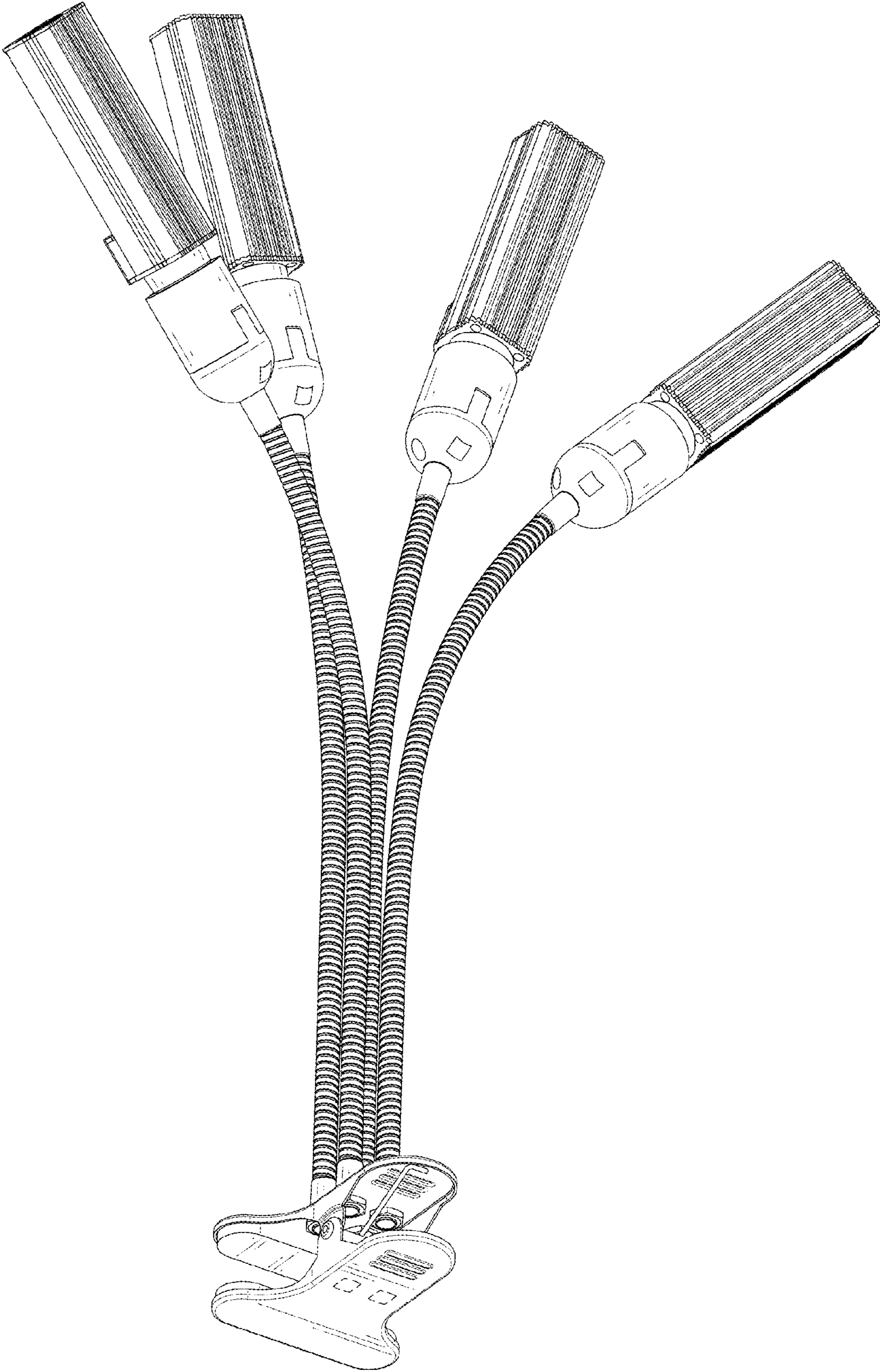

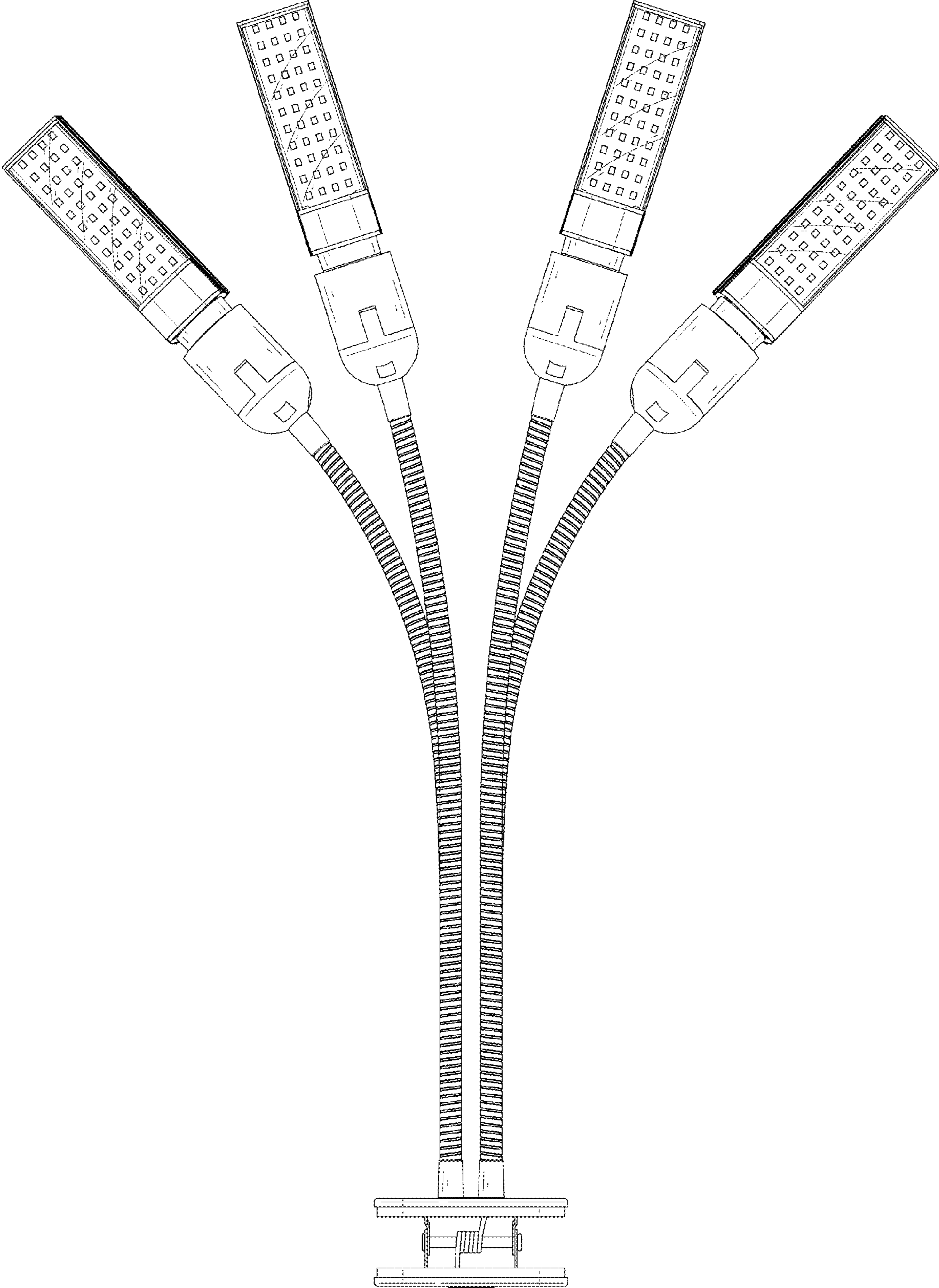

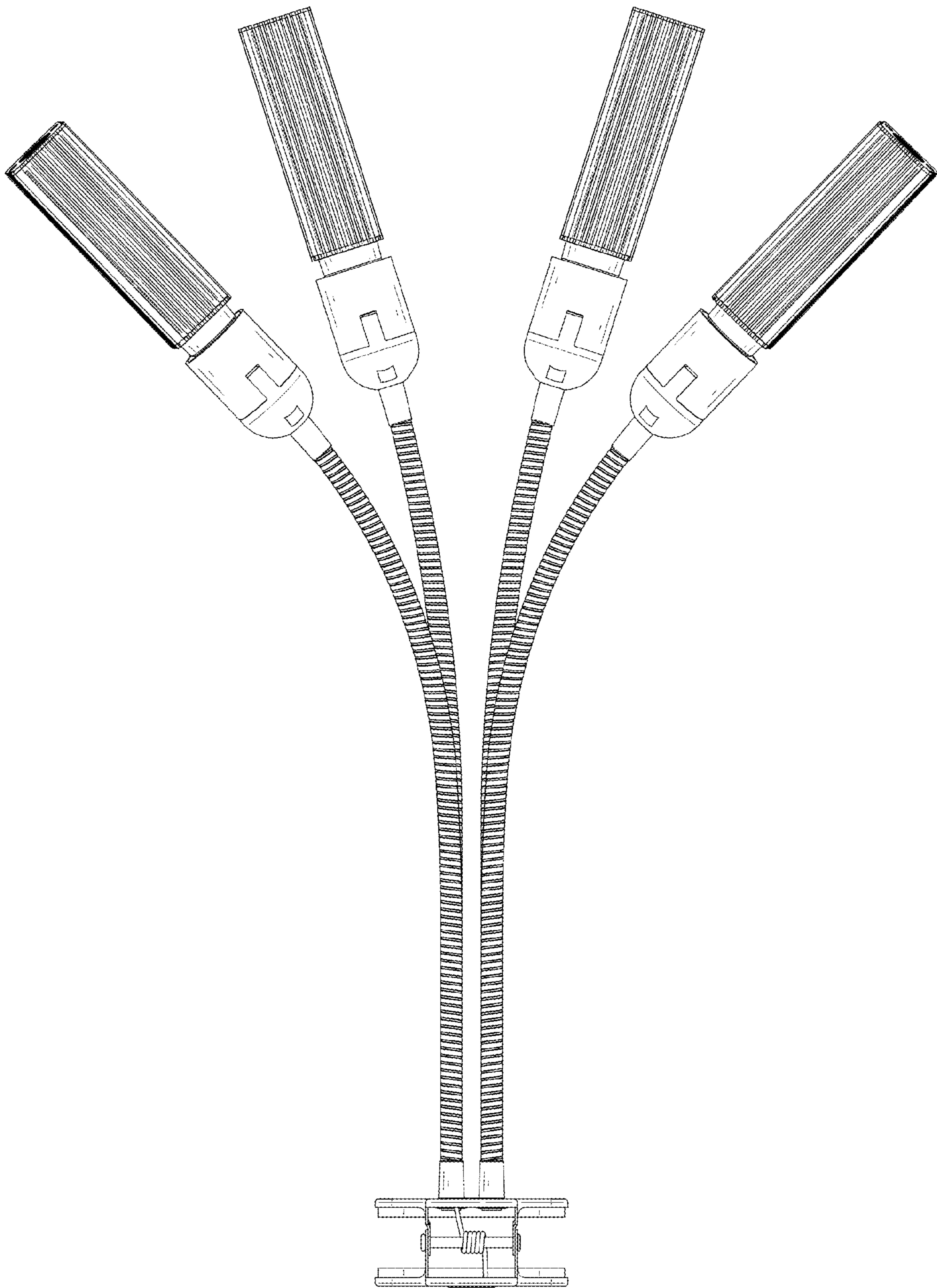

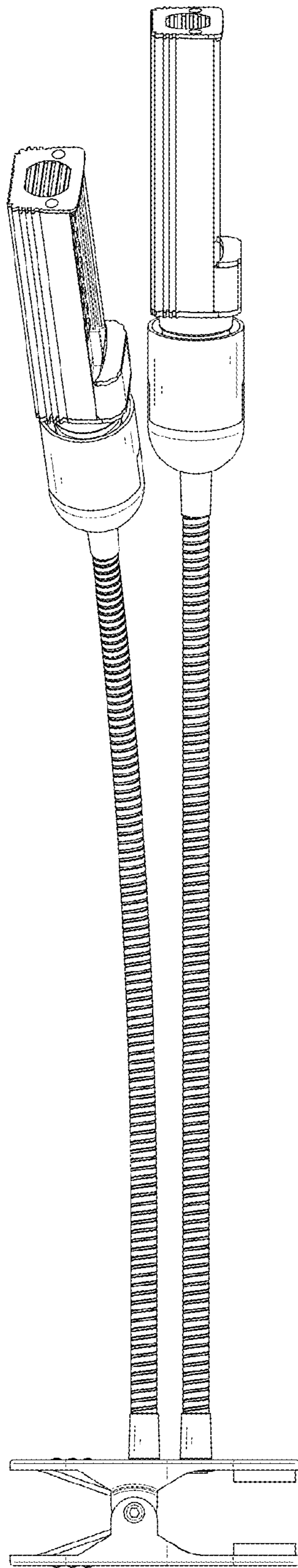

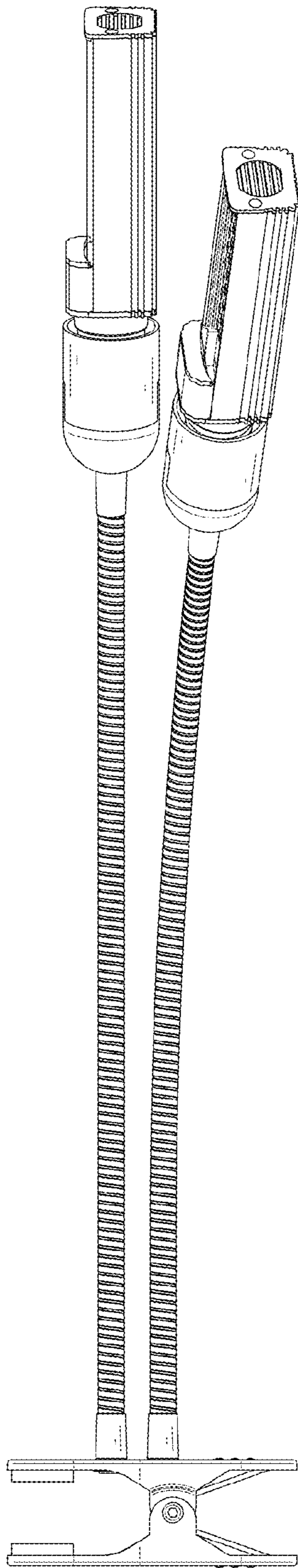

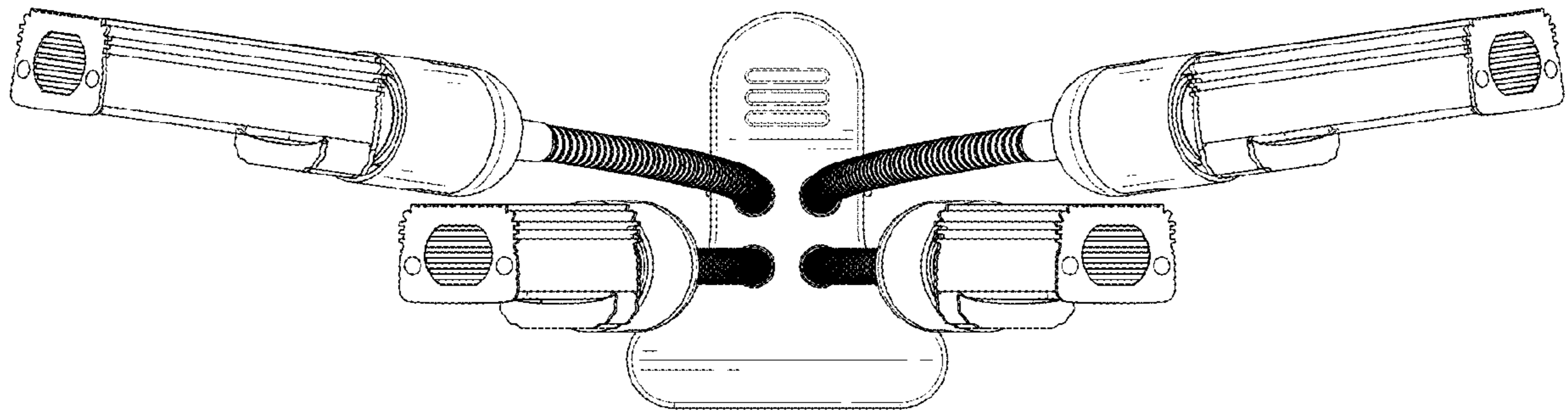

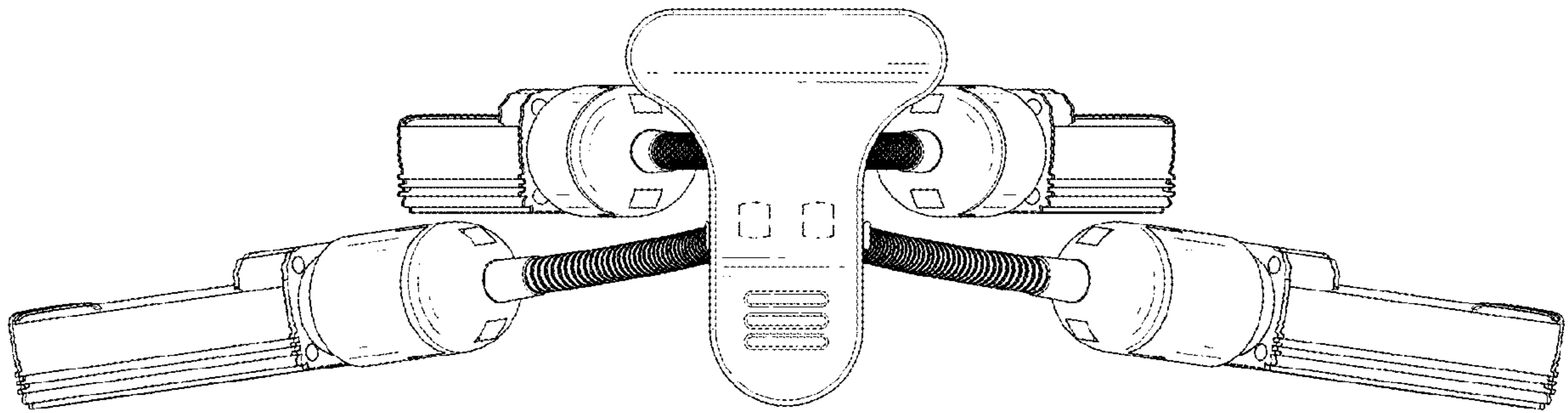

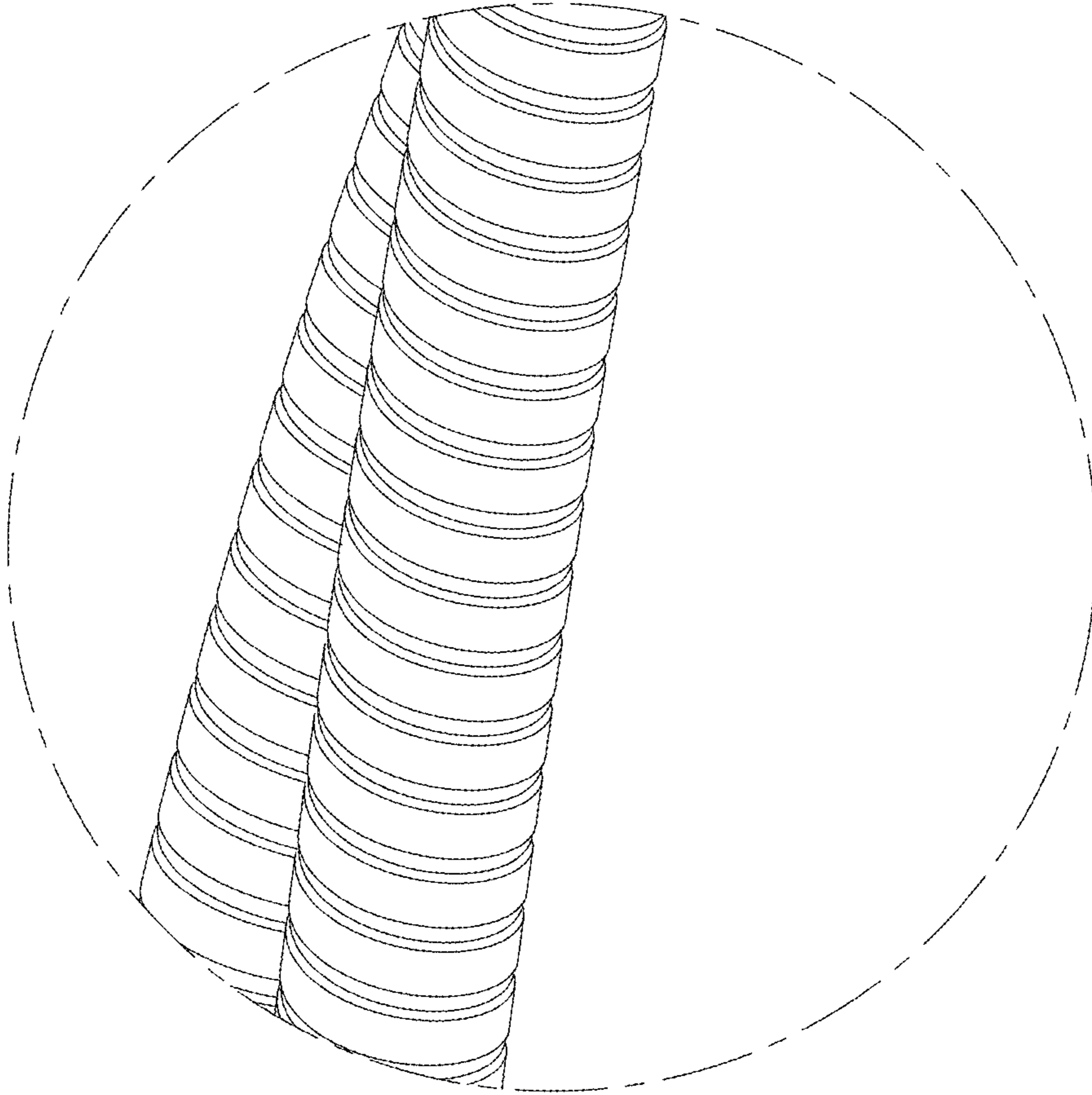

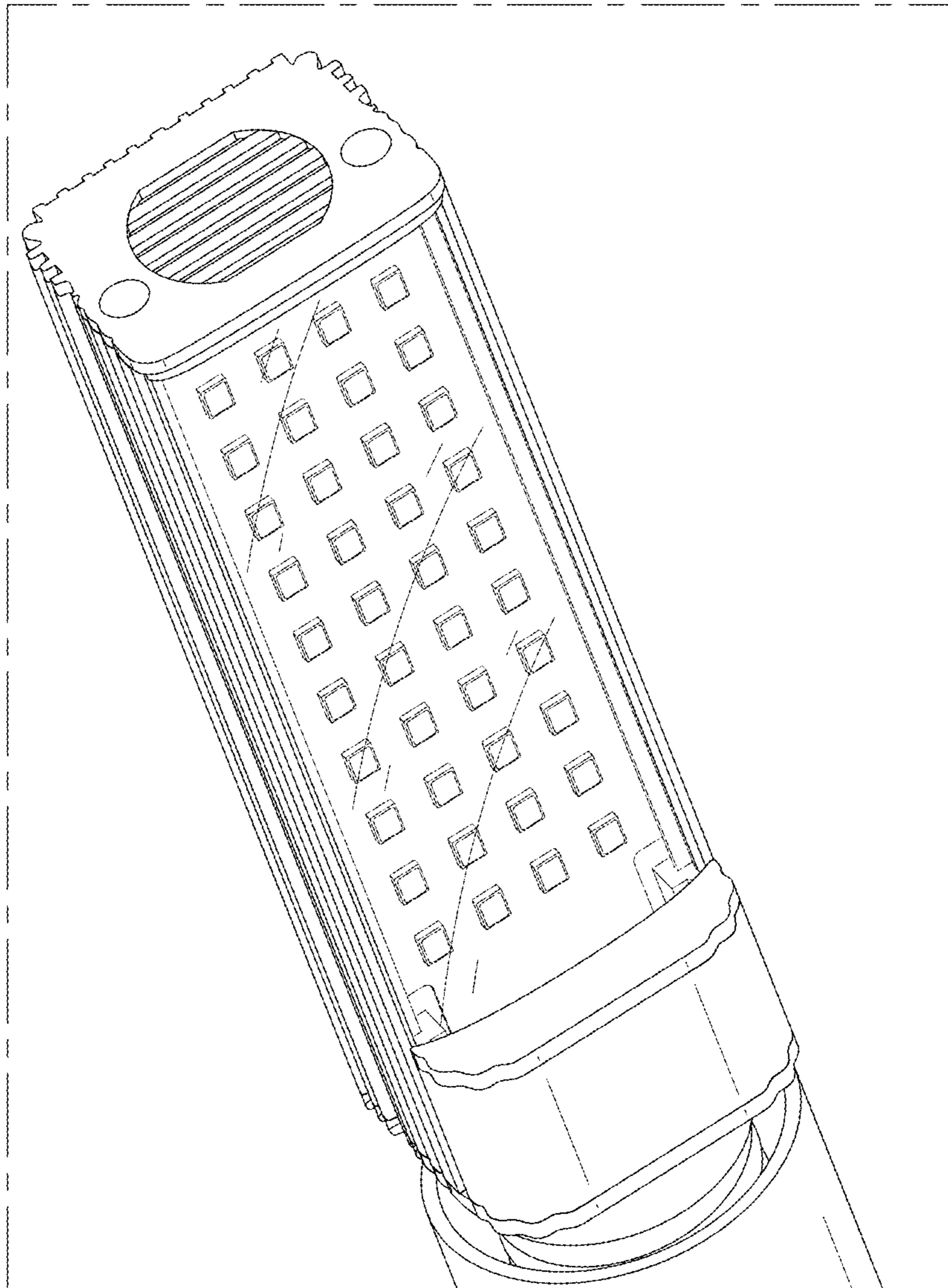
