(57) **CLAIM**

The ornamental design for a coat with apron, as shown and described.

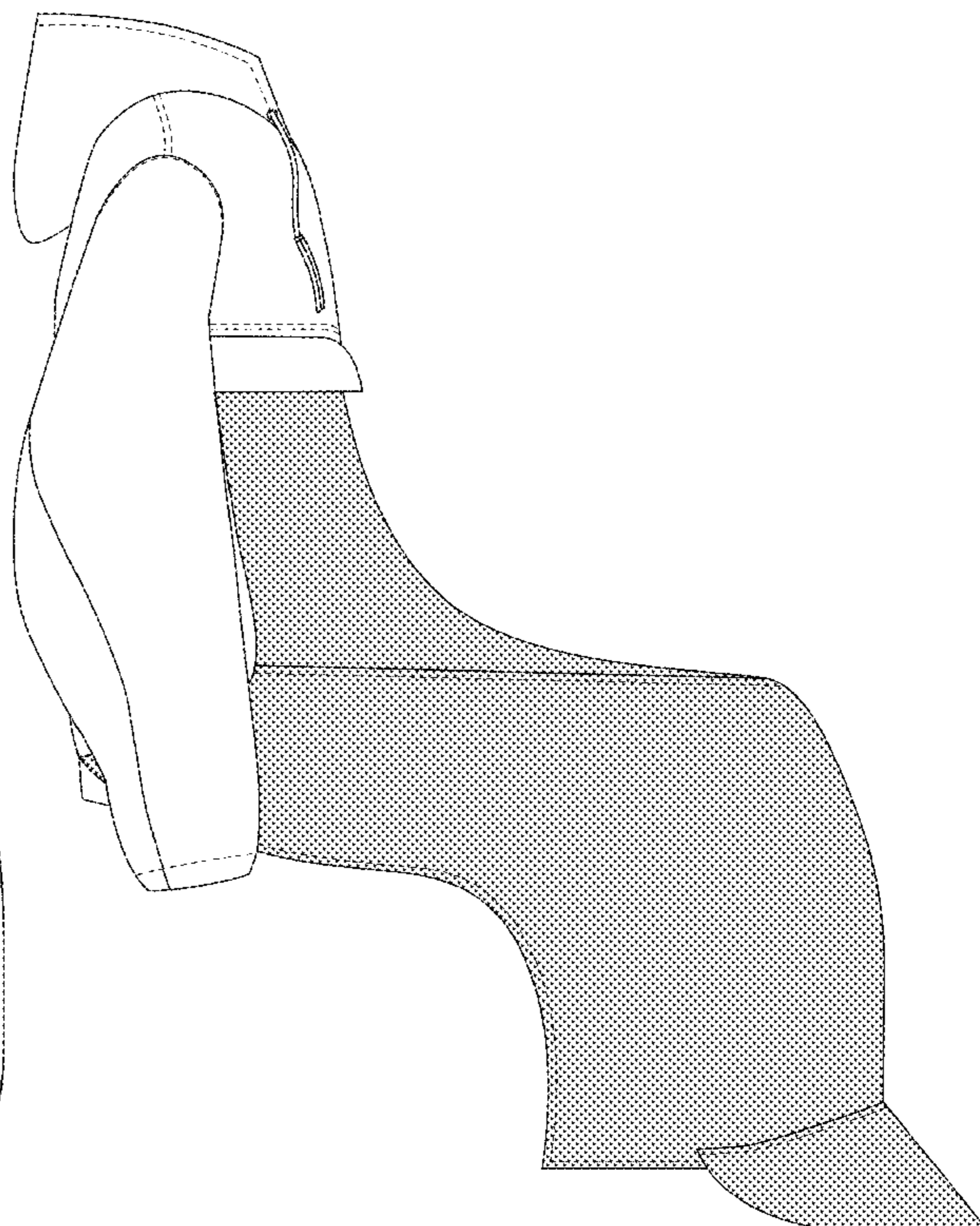
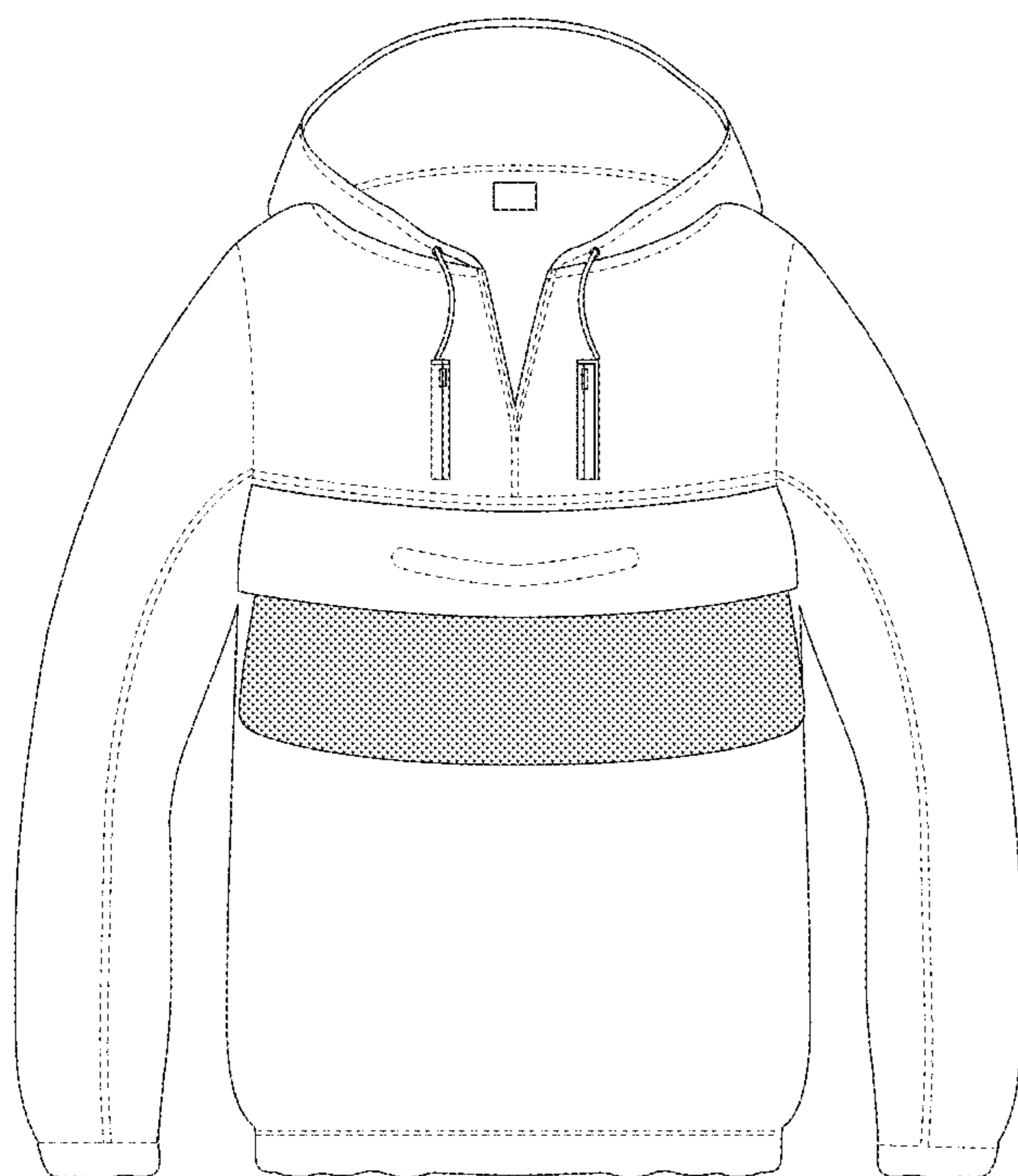
DESCRIPTION

FIG. 1 is a front view of a coat with apron in which an apron is rolled up and covered by a flap;
 FIG. 2 is a front view of the coat with apron of FIG. 1 in which the apron is rolled up and not covered by the flap which is lifted;
 FIG. 3 is a front view of the coat with apron of FIG. 1 in which the apron is unrolled and the flap is lifted;
 FIG. 4 is a side view of the coat with apron of FIG. 1; and,
 FIG. 5 is a side view of the coat with apron of FIG. 1 in which the apron is unrolled and the flap is not lifted.

The broken lines shown in the drawings depict stitching and portions of the coat with apron that form no part of the claimed design.

The solid gray shading represents a contrast in appearance.

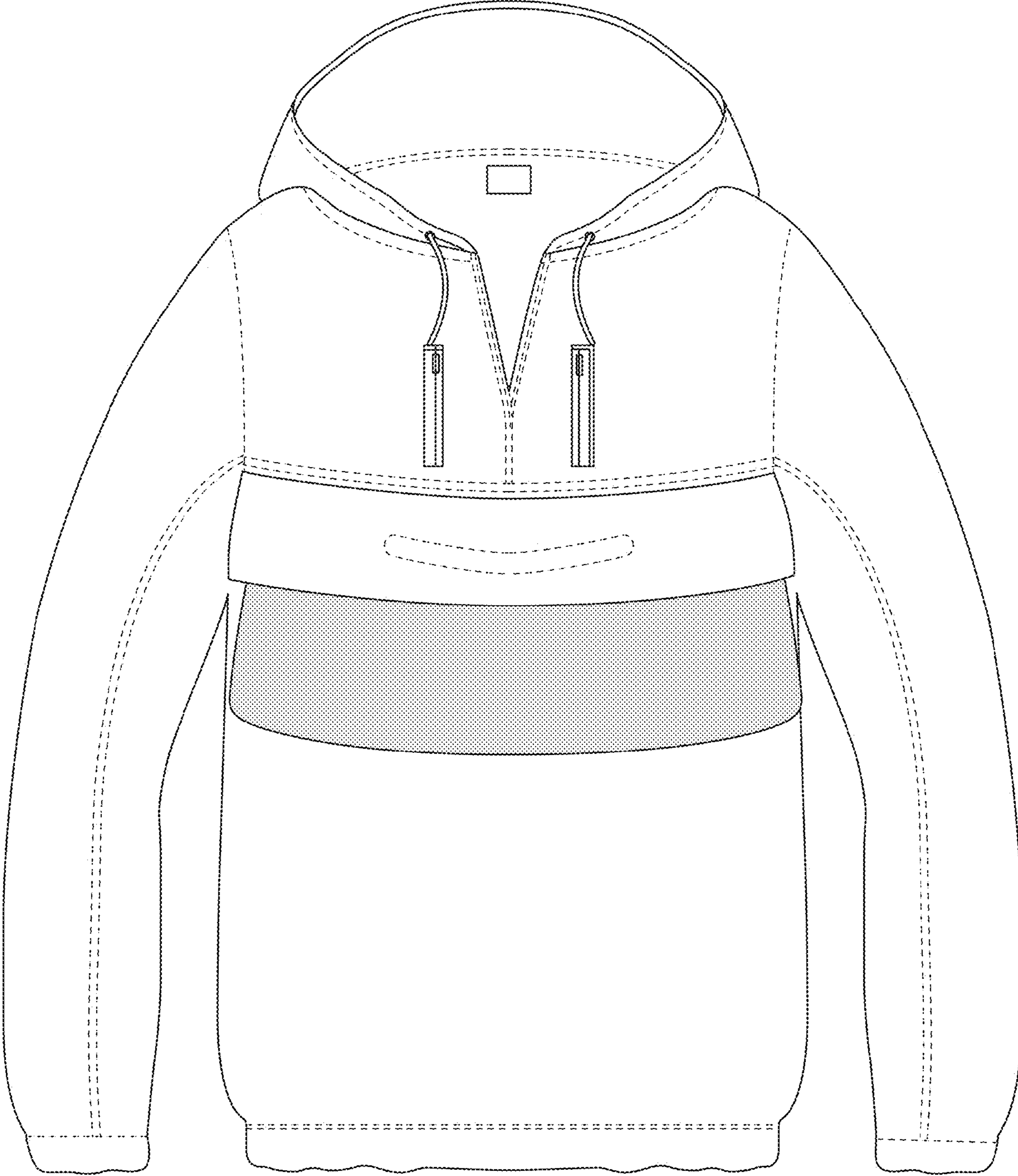

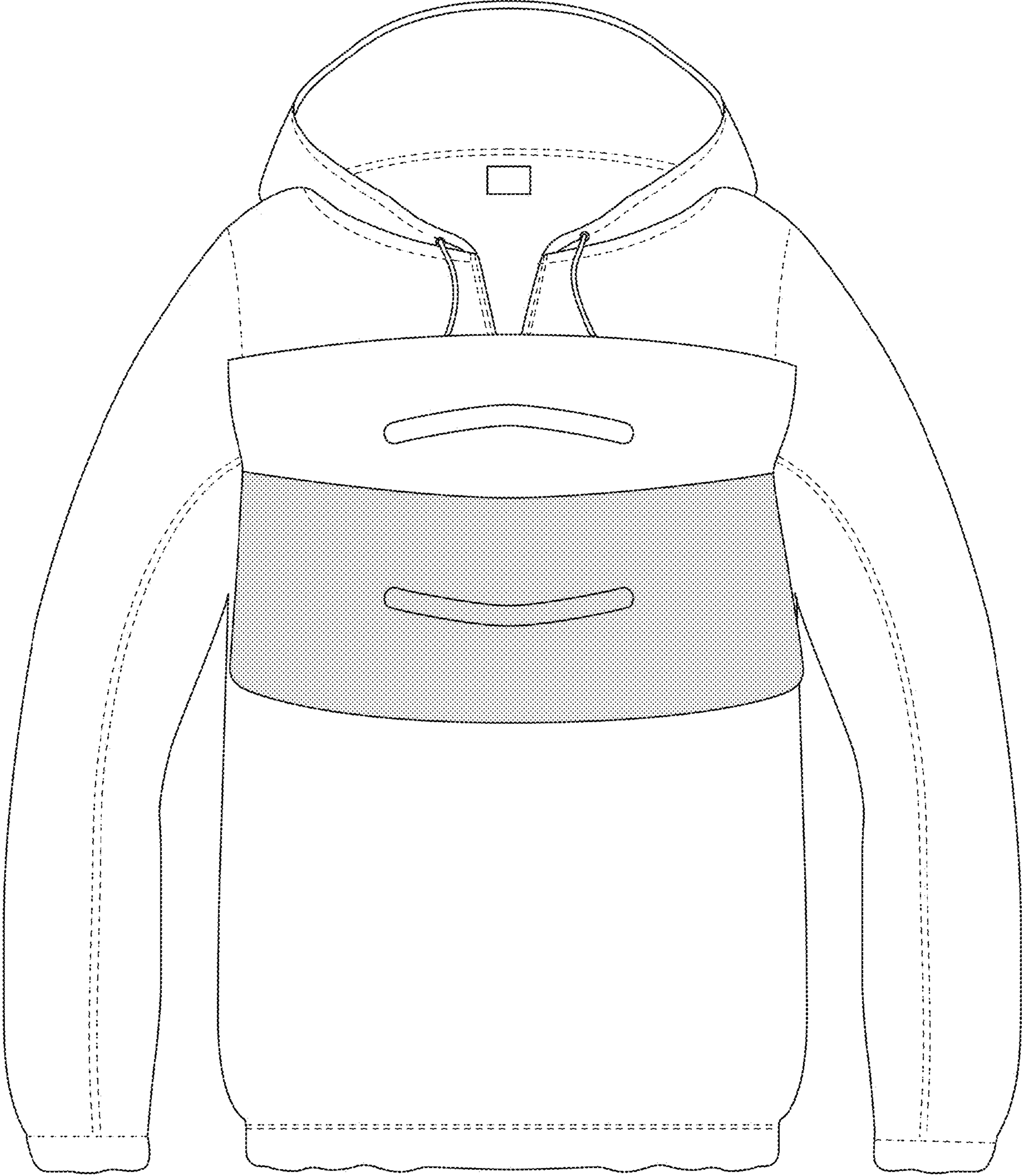

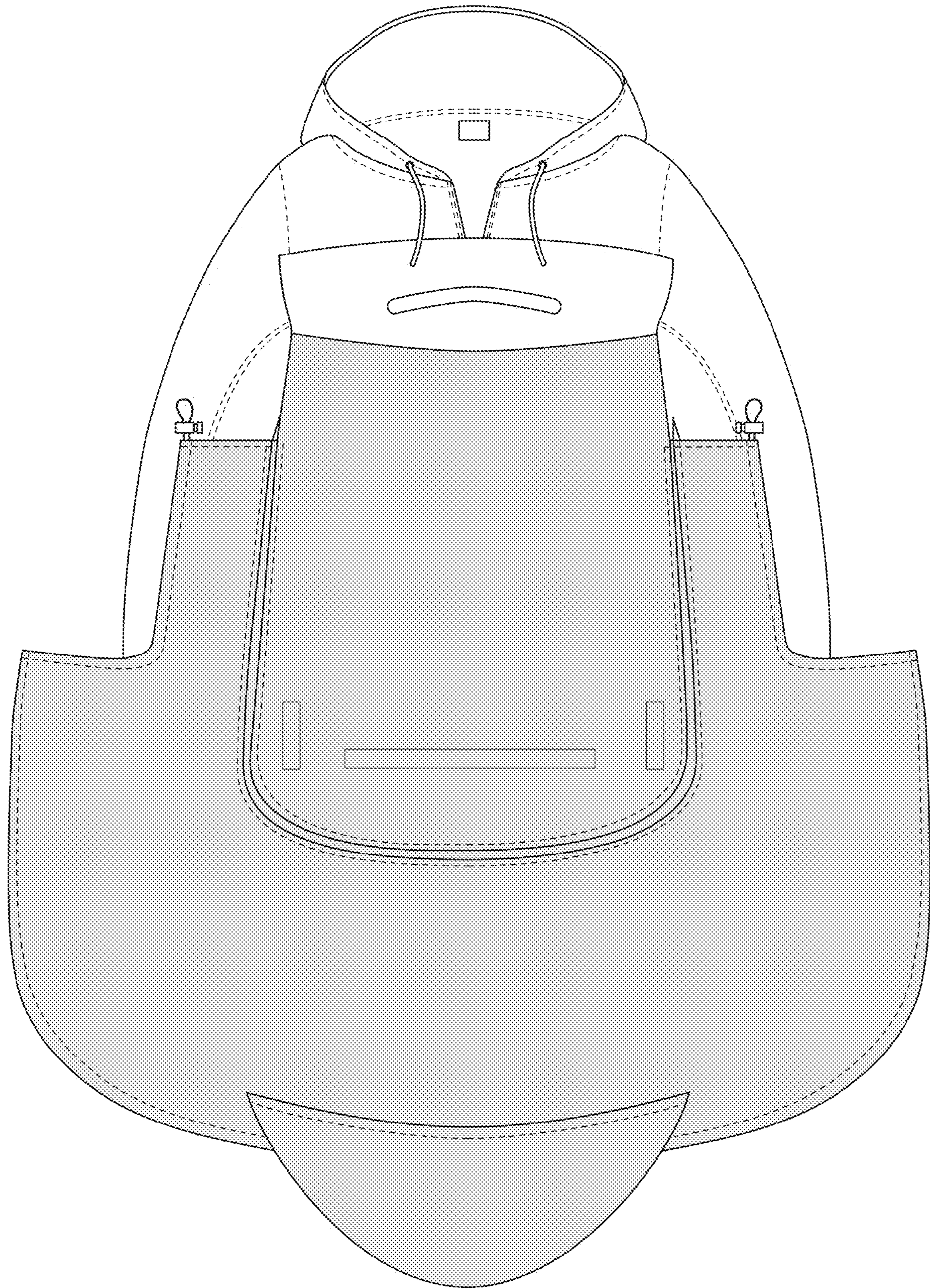

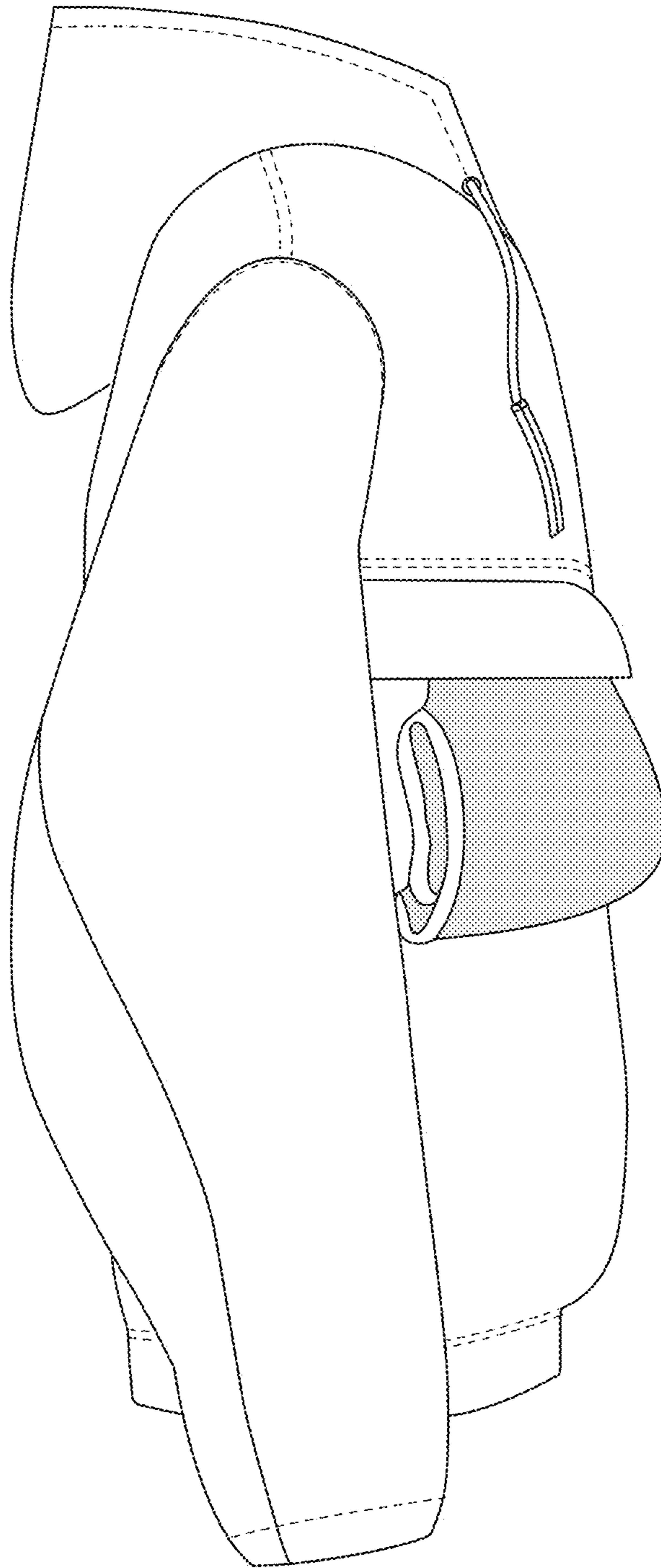

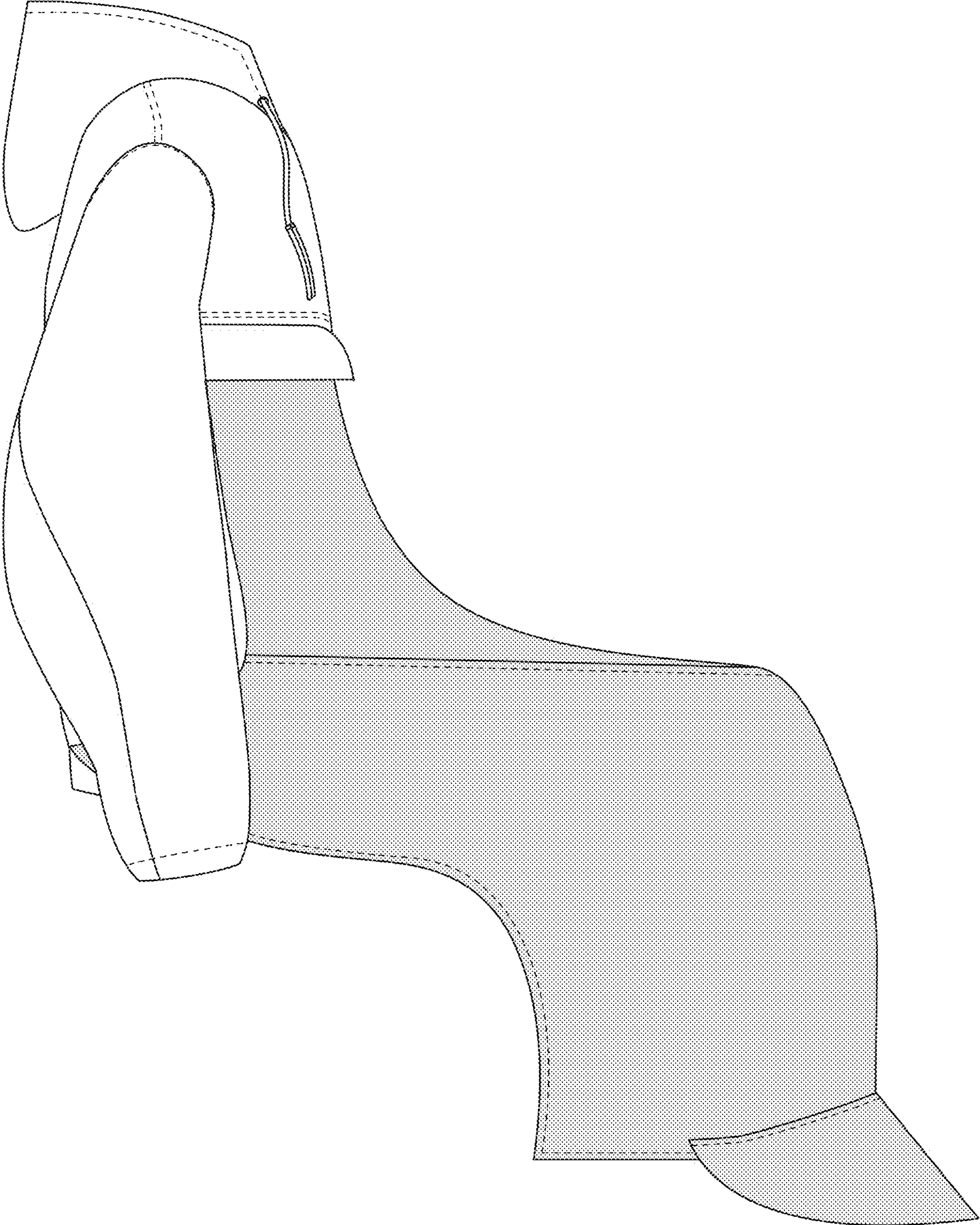
