DESCRIPTION

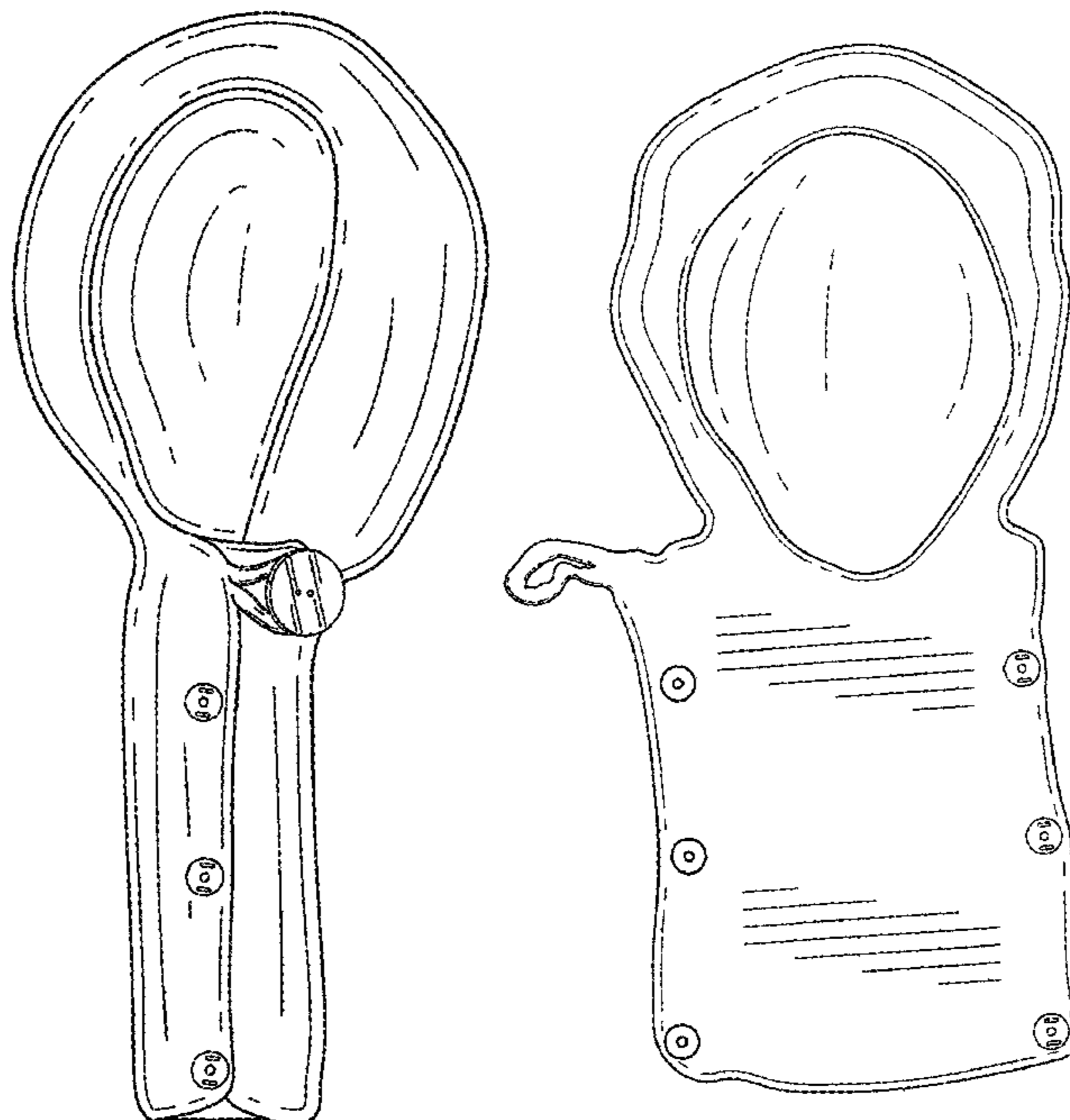
FIG. 1 is a top plan view of a hat shown in a closed configuration;

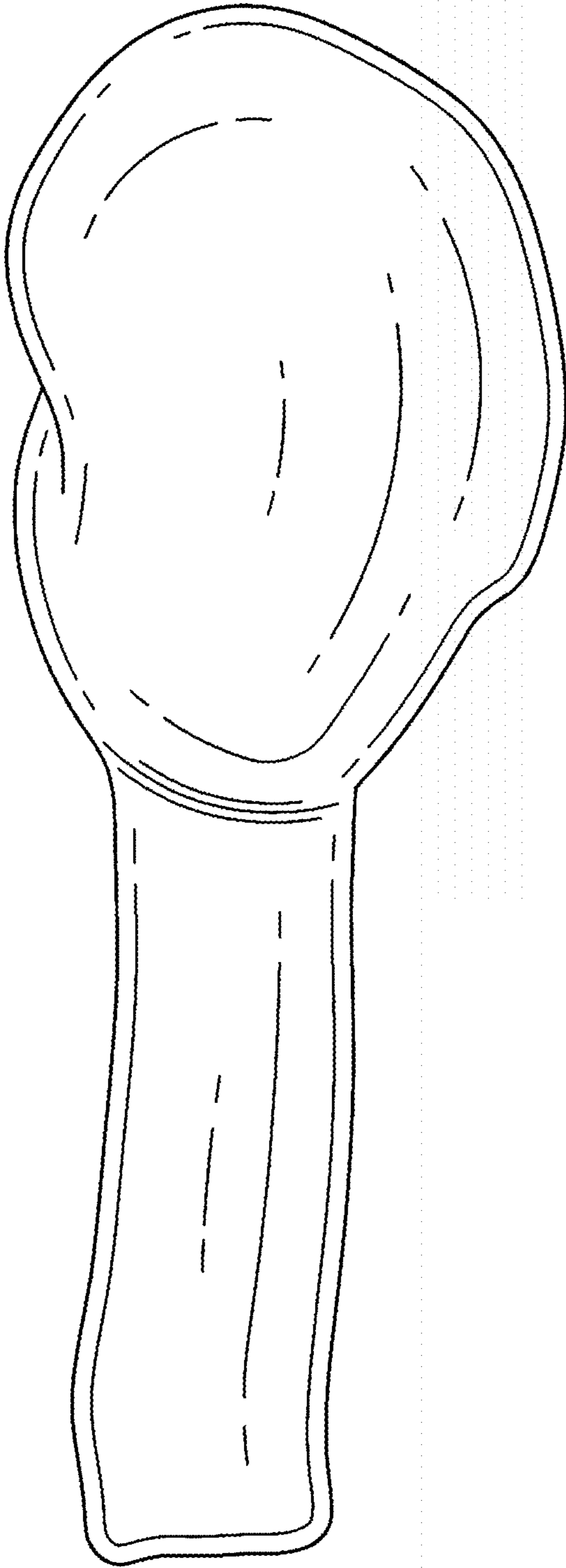

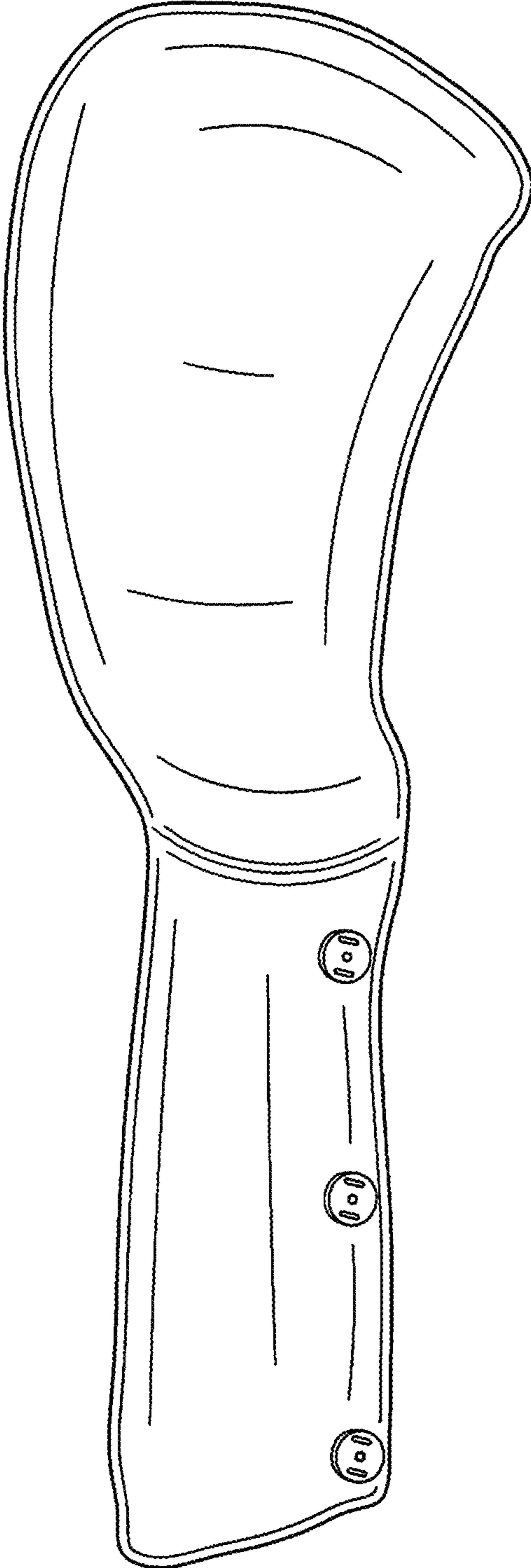

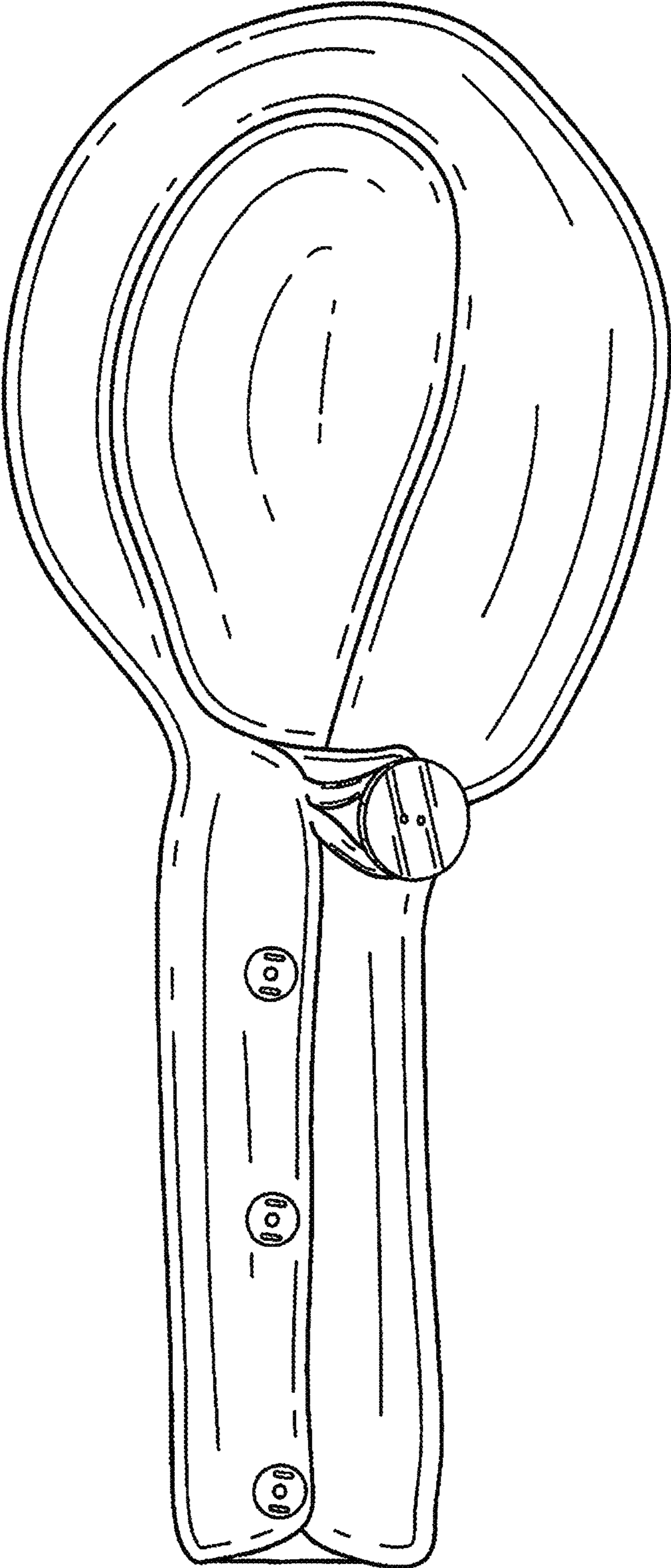

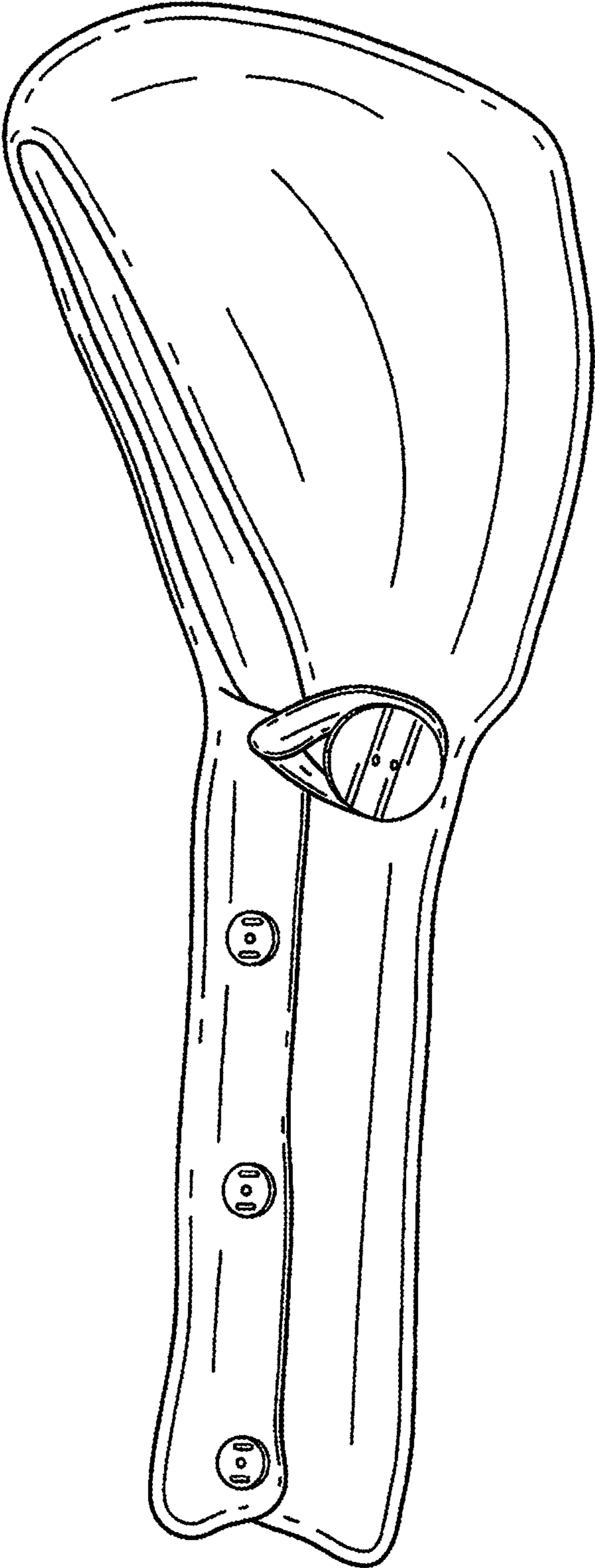

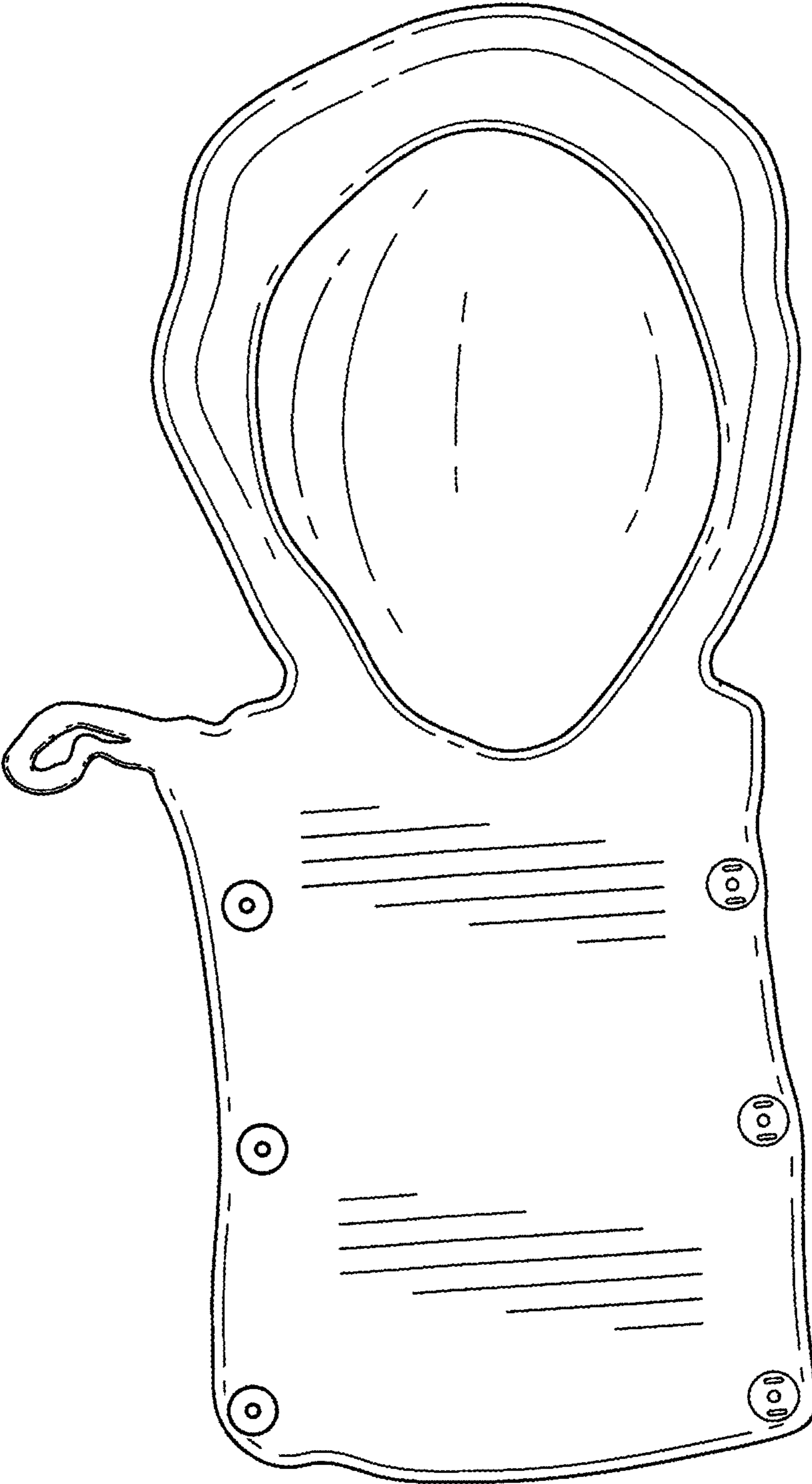

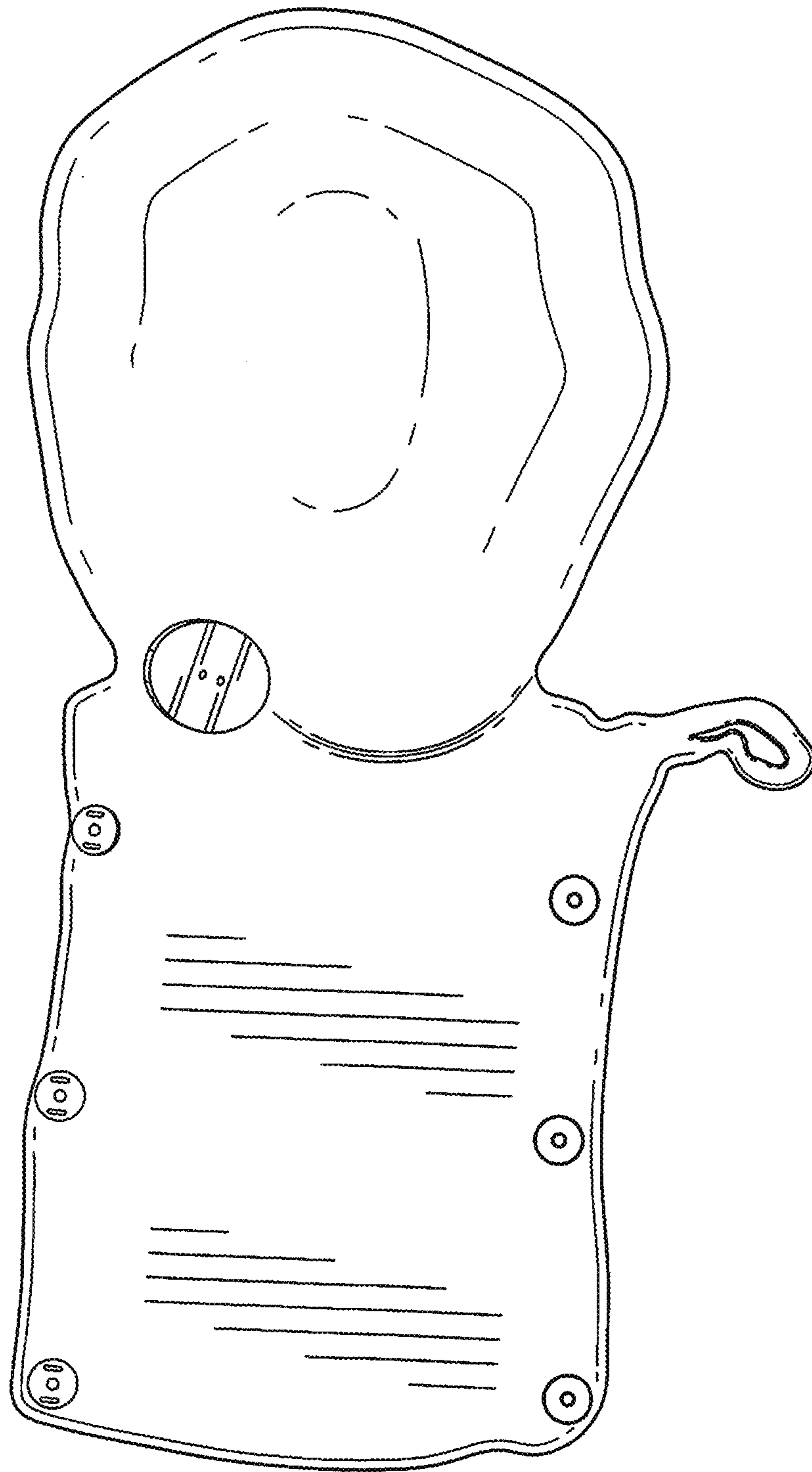
