The ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a first perspective view of the shoe showing my new design;

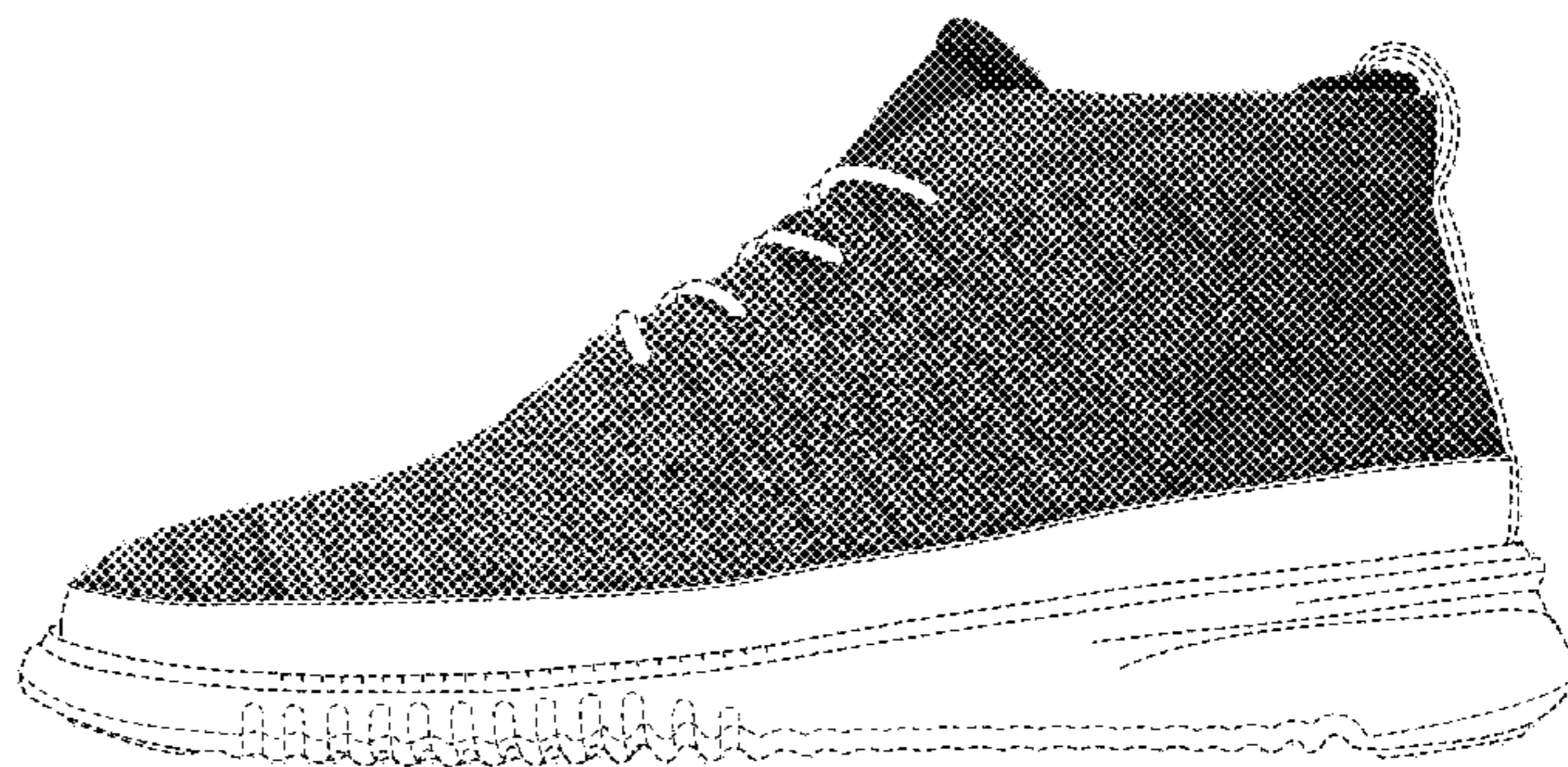

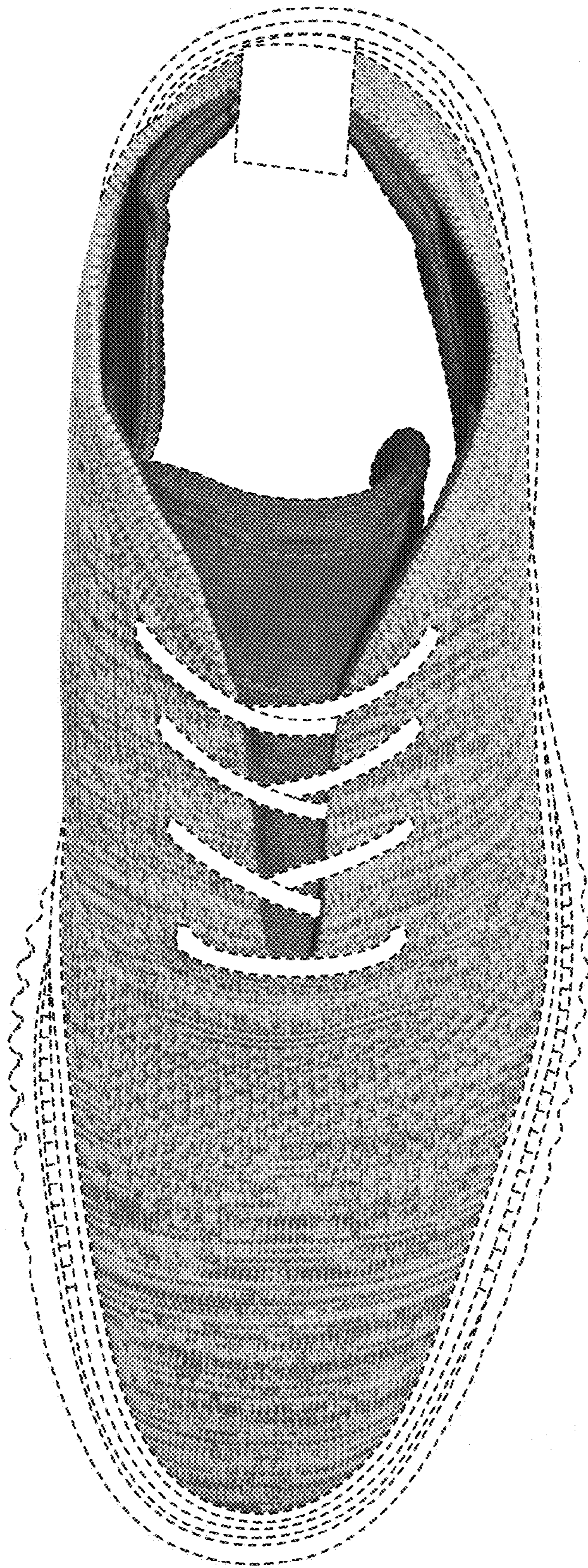

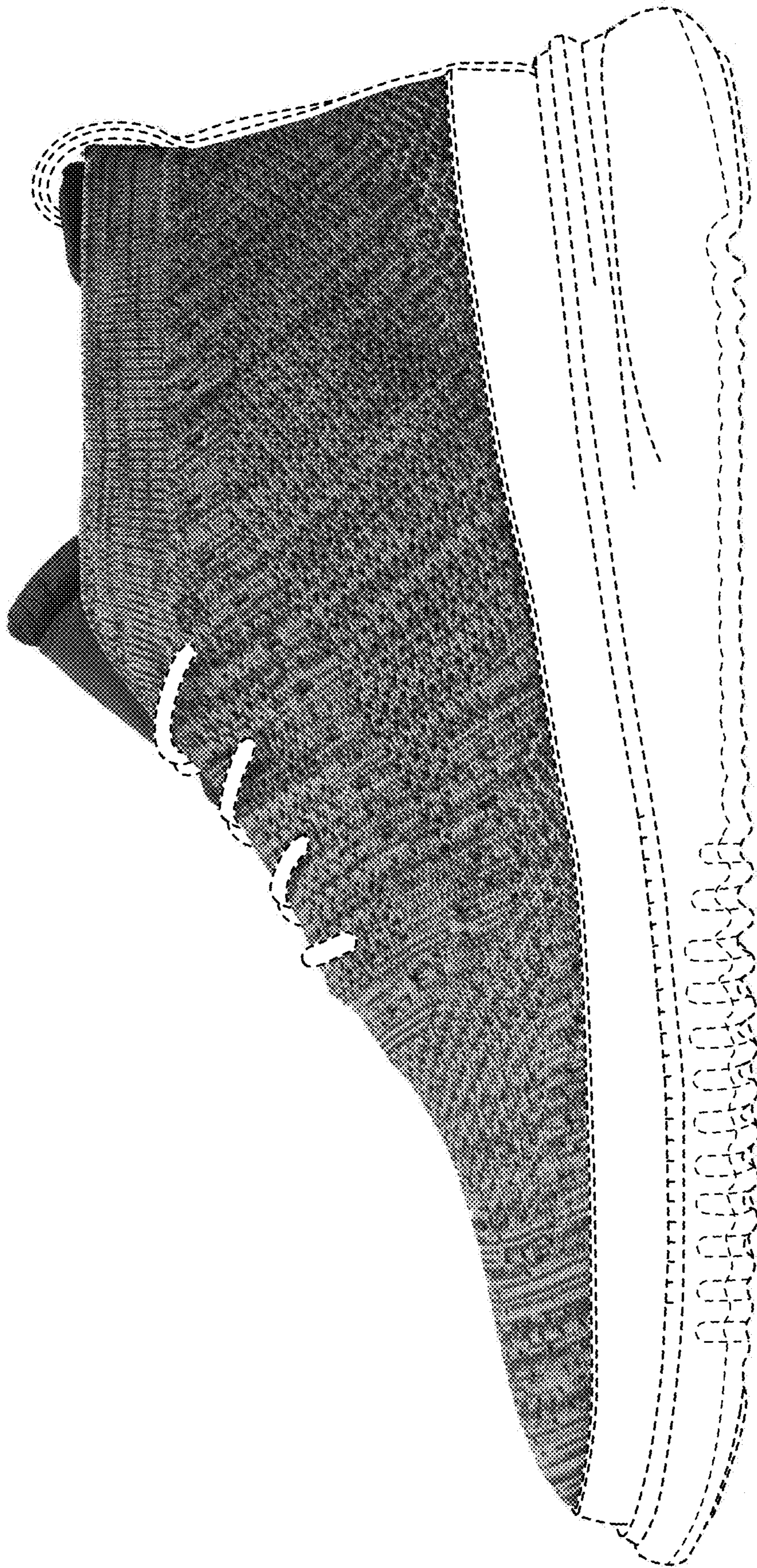

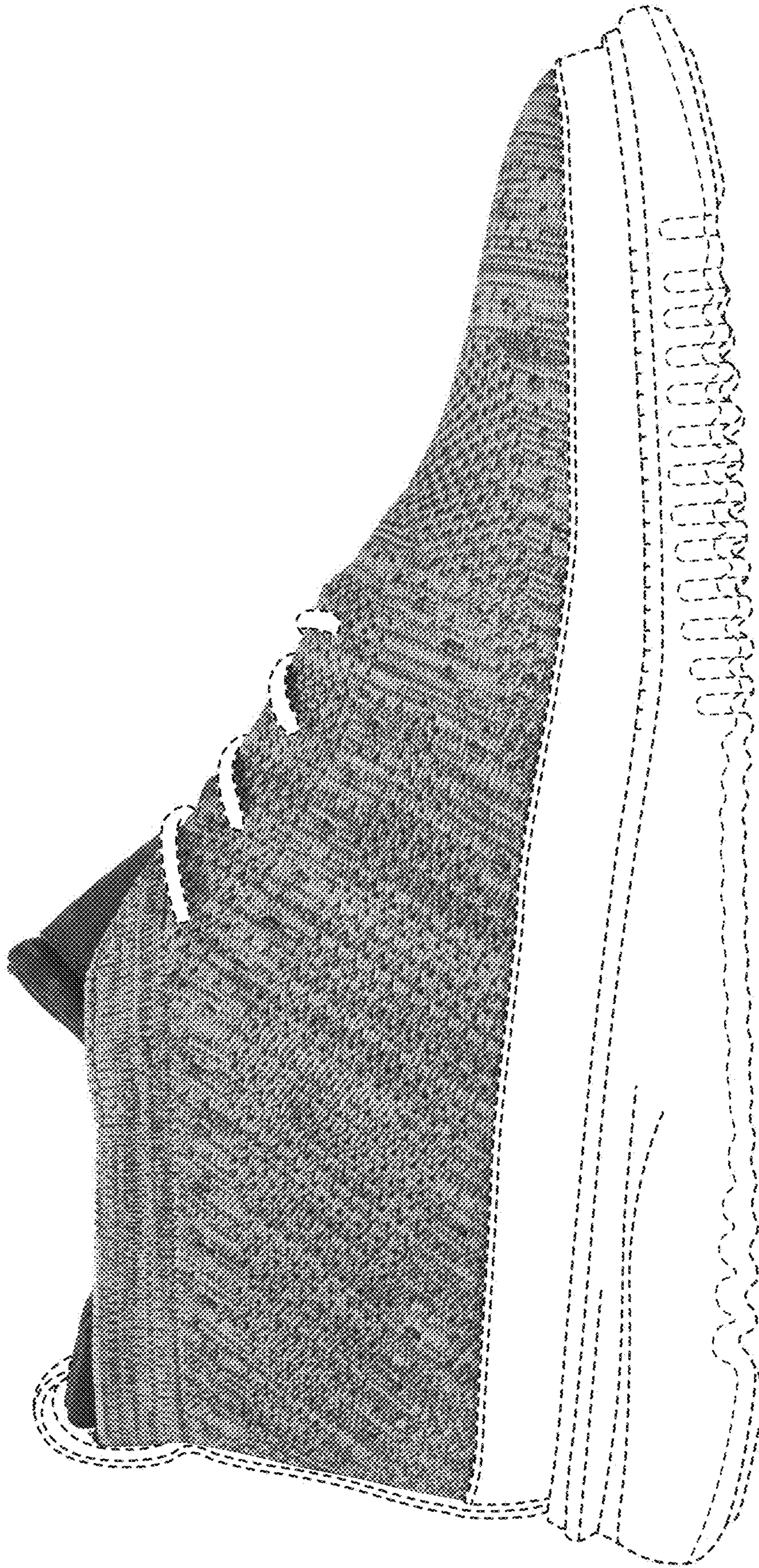

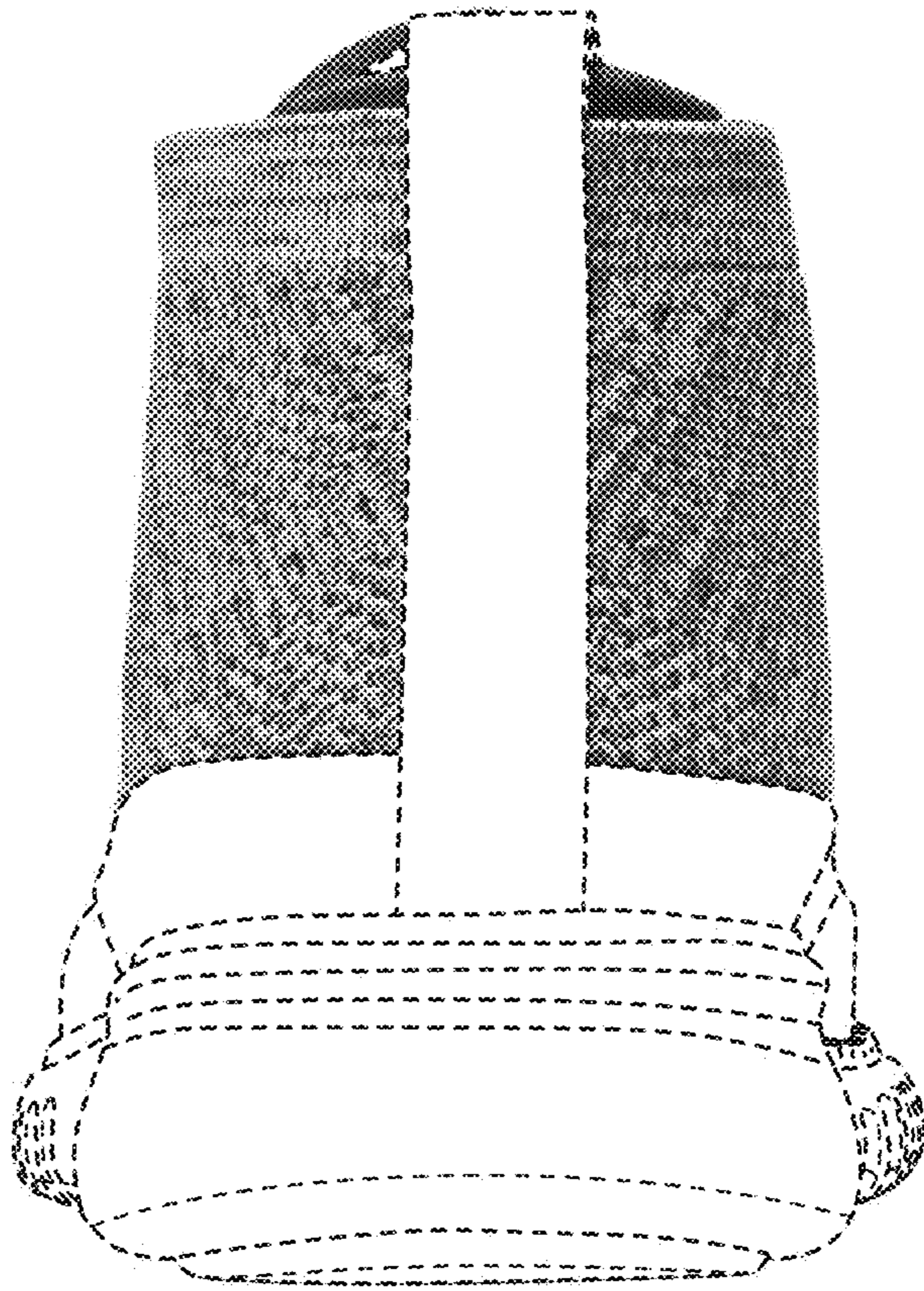

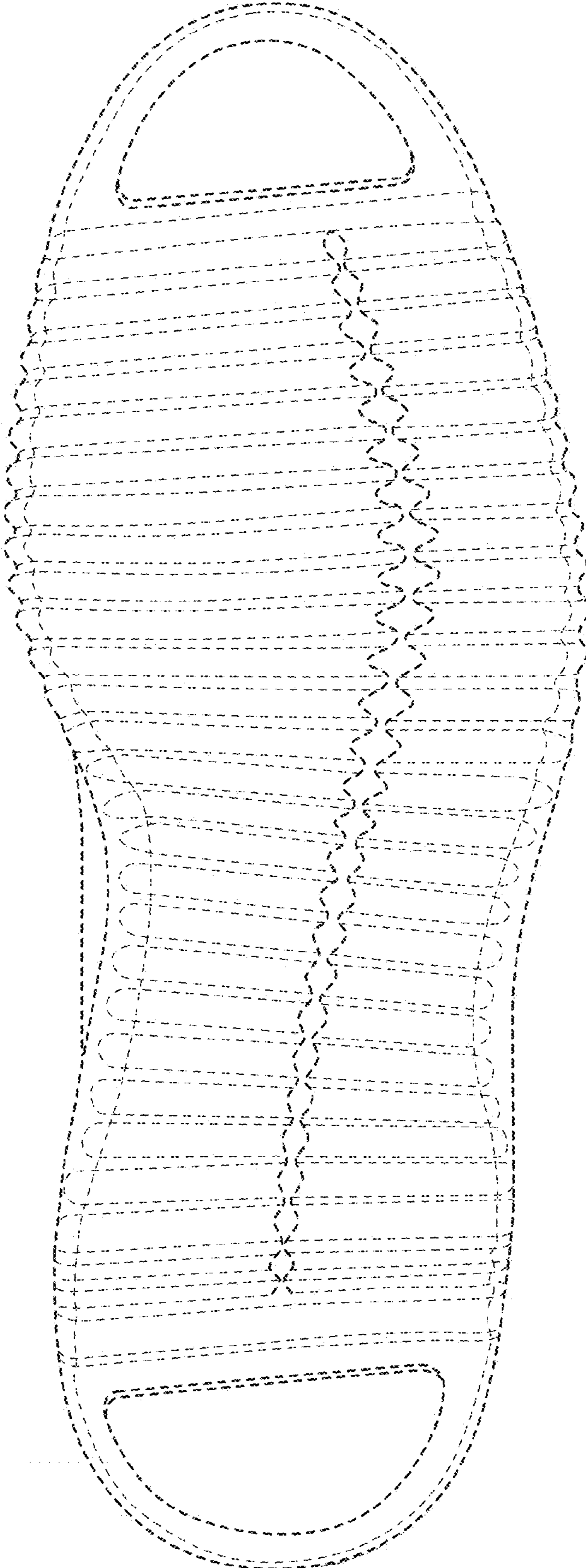

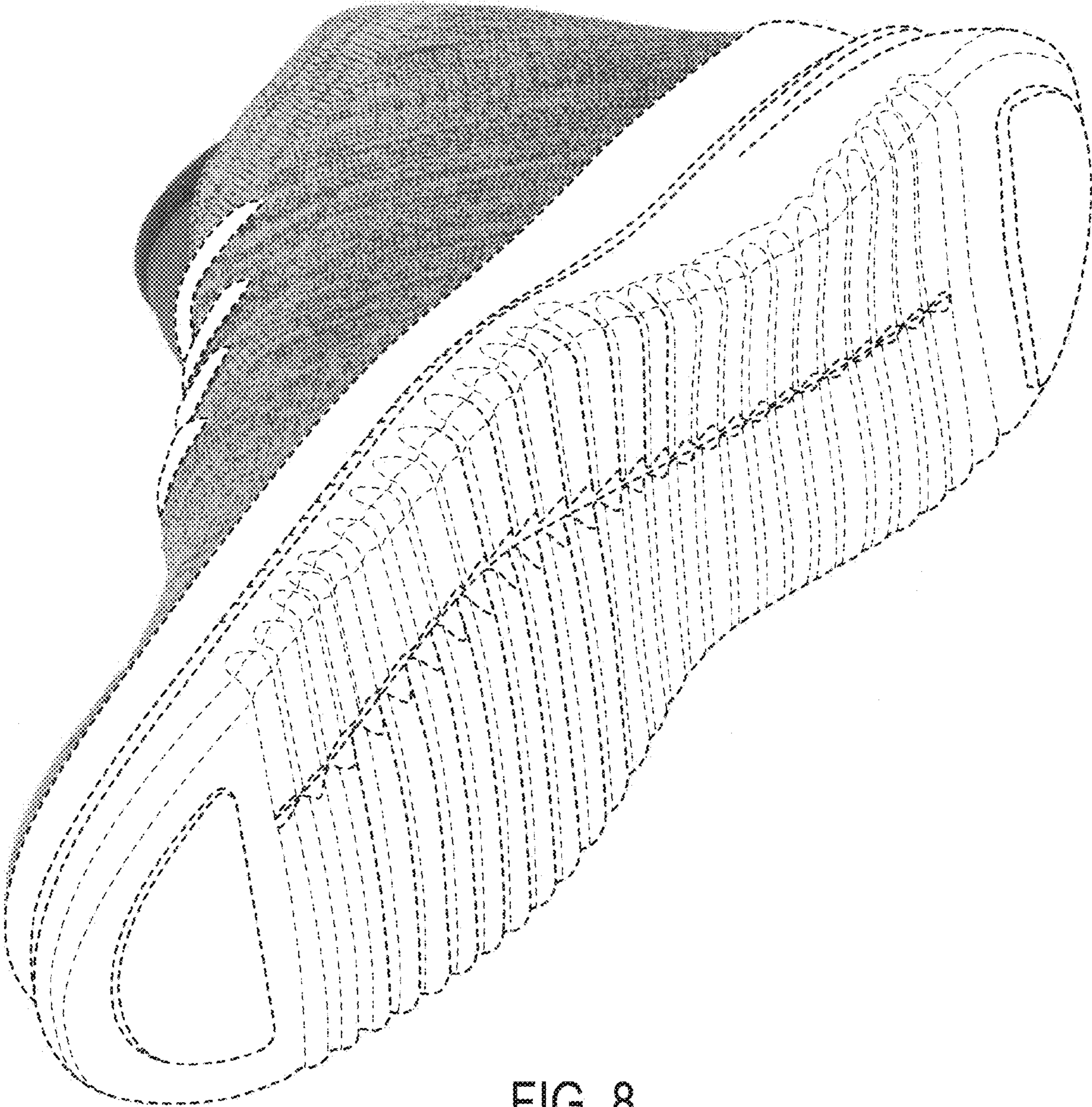
