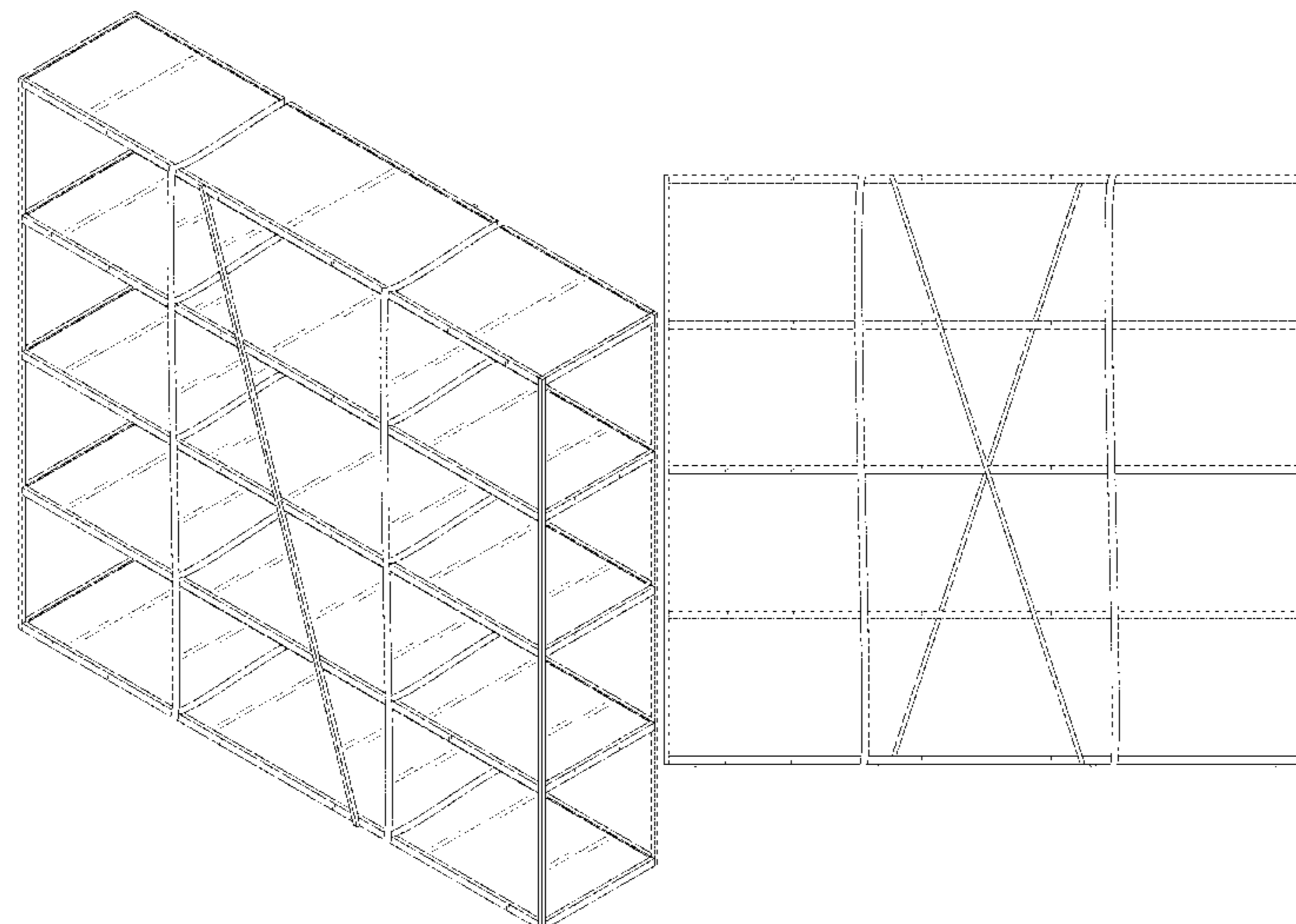
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front upper perspective view of shelving of applicant's design;  
FIG. 2 is a bottom perspective view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a first side elevational view thereof;  
FIG. 6 is a second side elevational view thereof, the second side elevational view being opposite the first side elevational view;  
FIG. 7 is a top plan view thereof; and,  
FIG. 8 is a bottom plan view thereof.

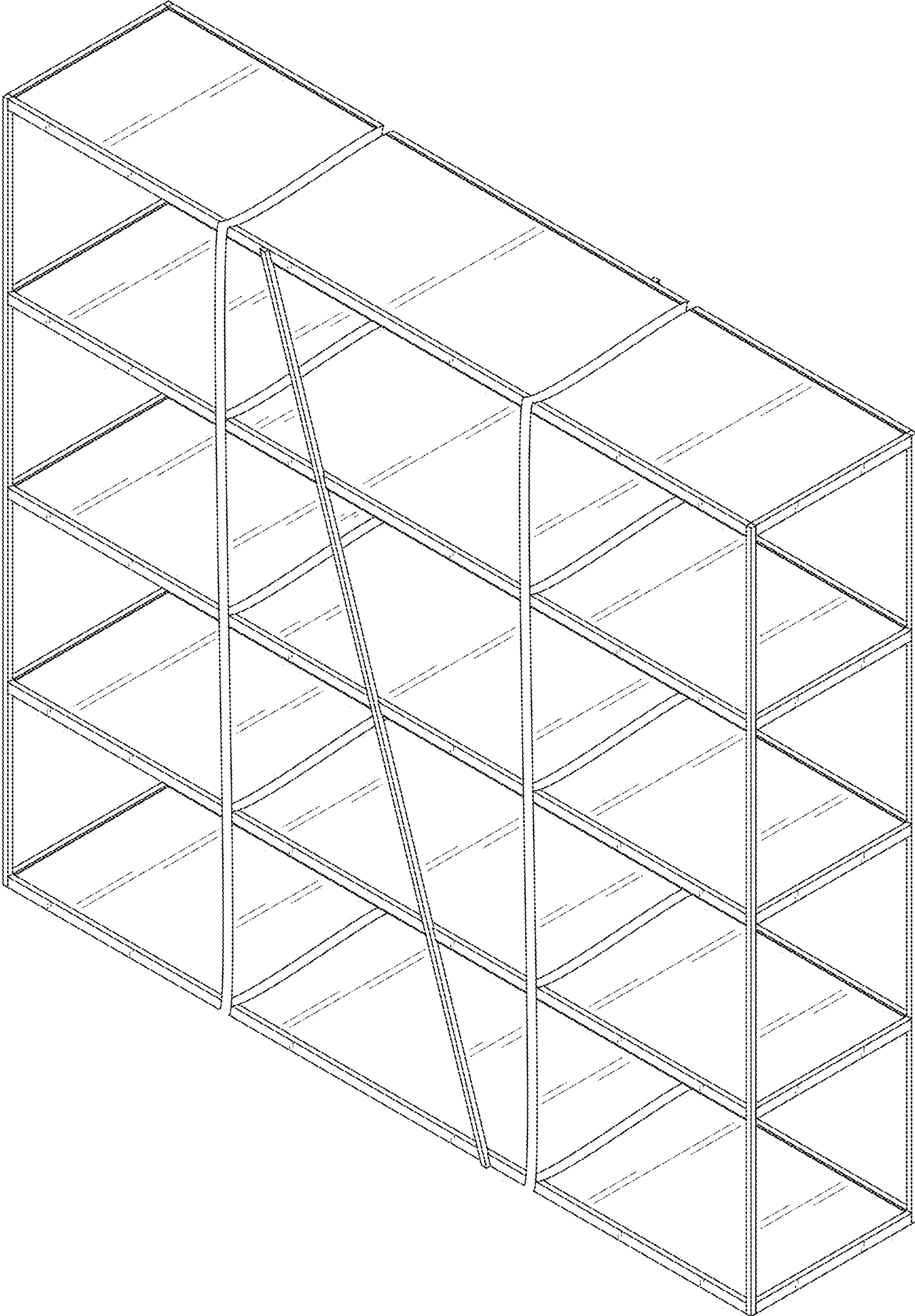

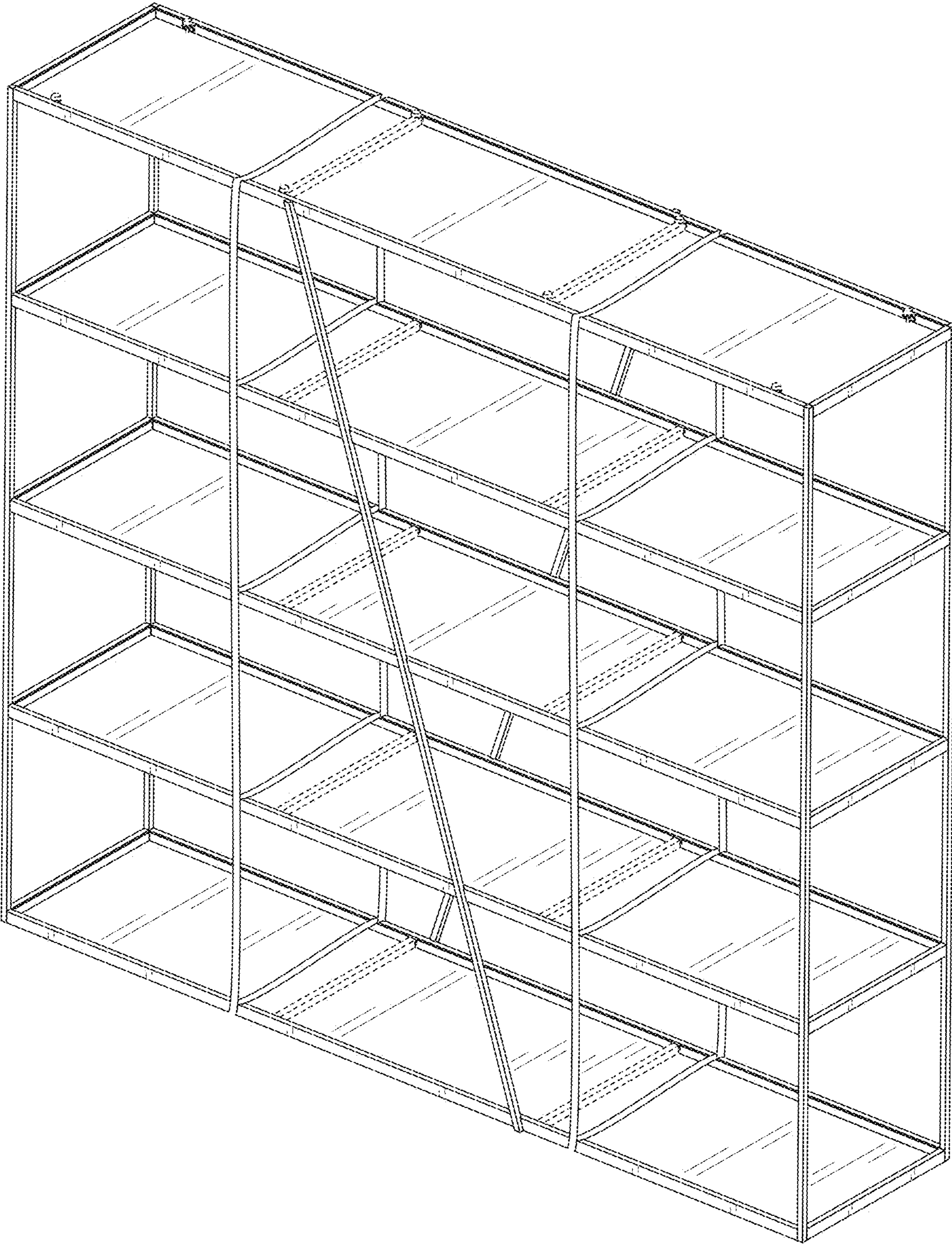

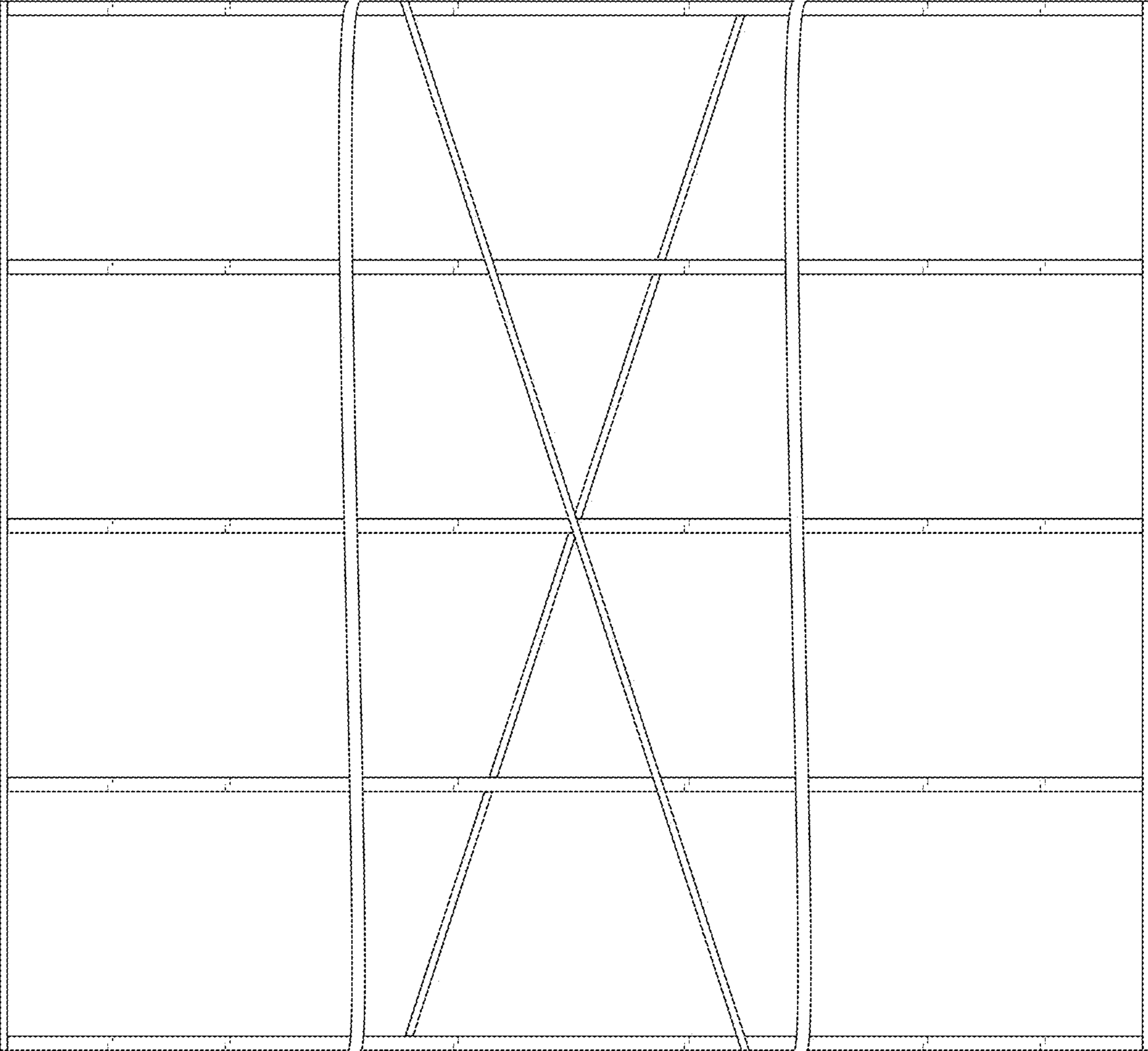

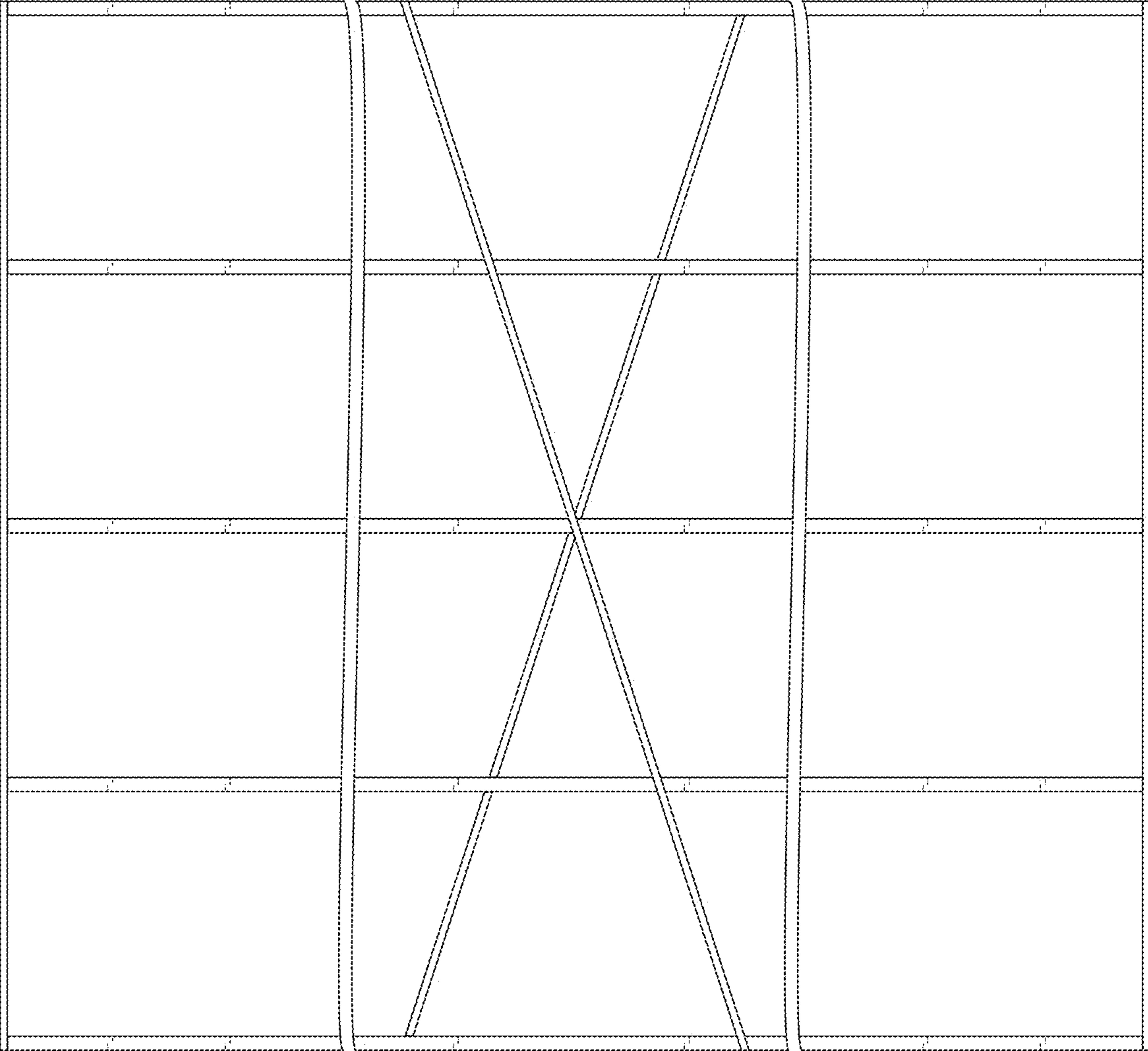

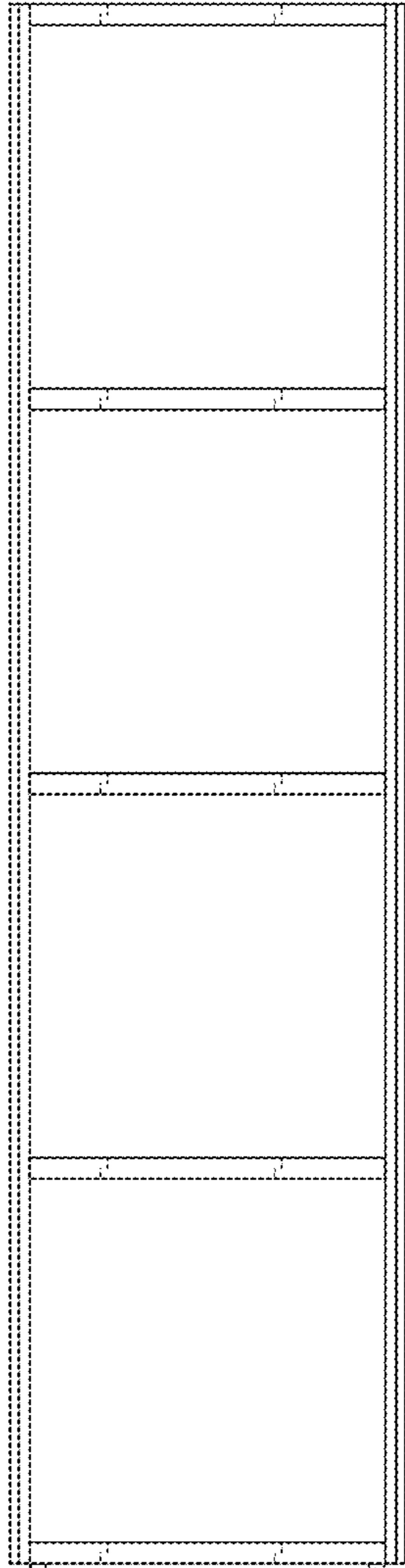

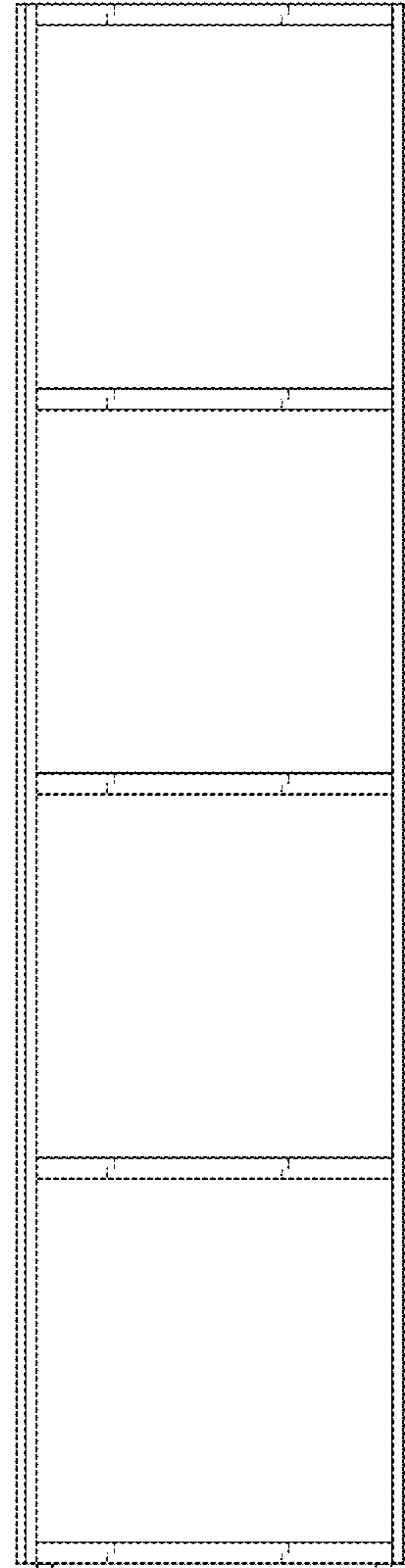

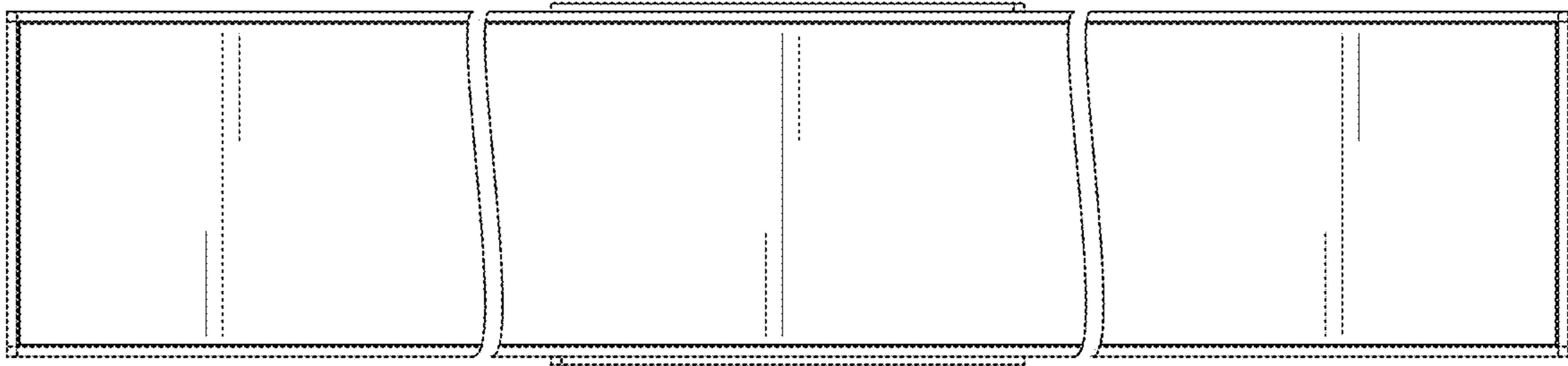

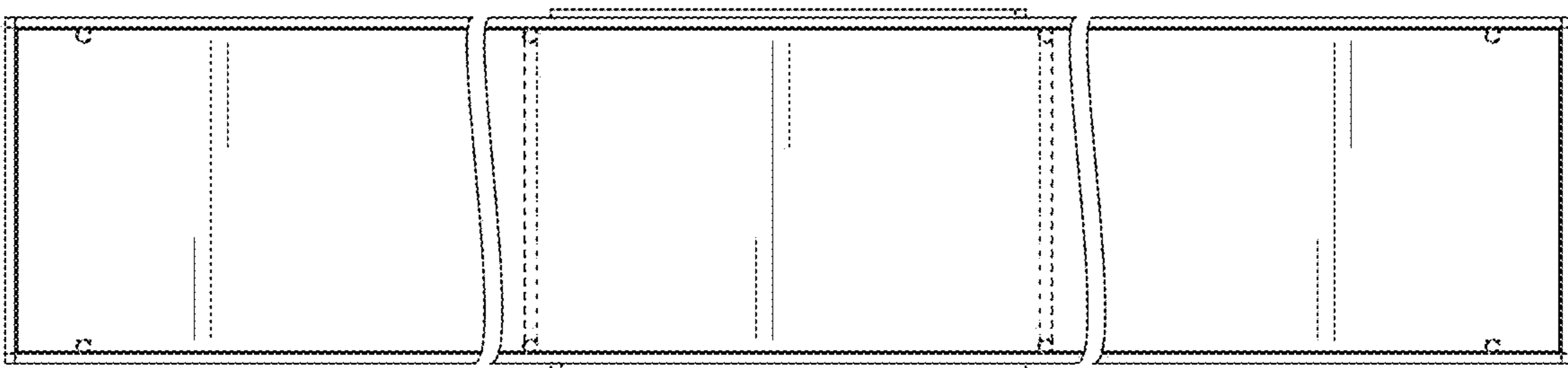
